FIG. 5 is a left side elevation view thereof.

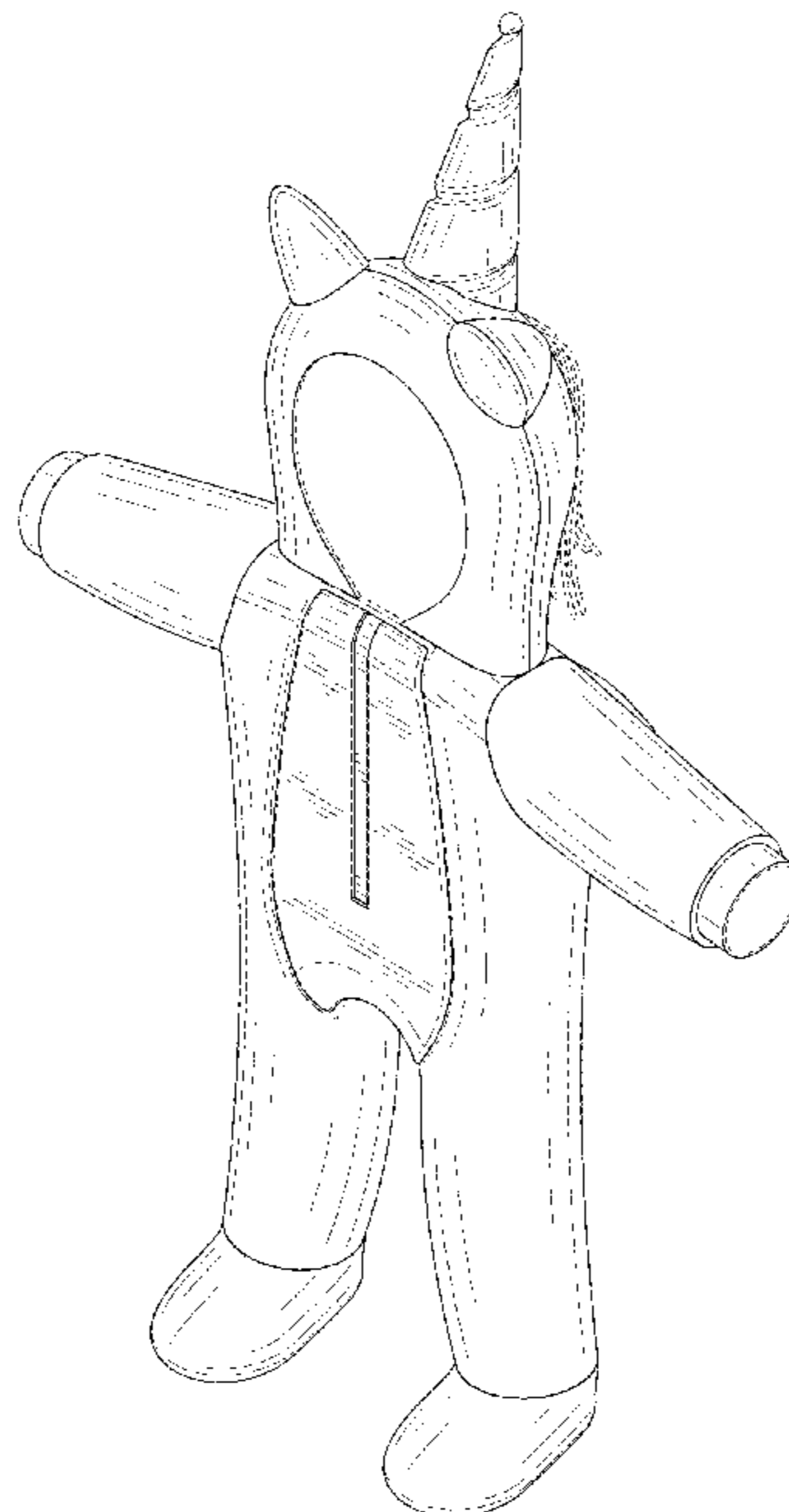
FIG. 6 is a right side elevation view thereof.

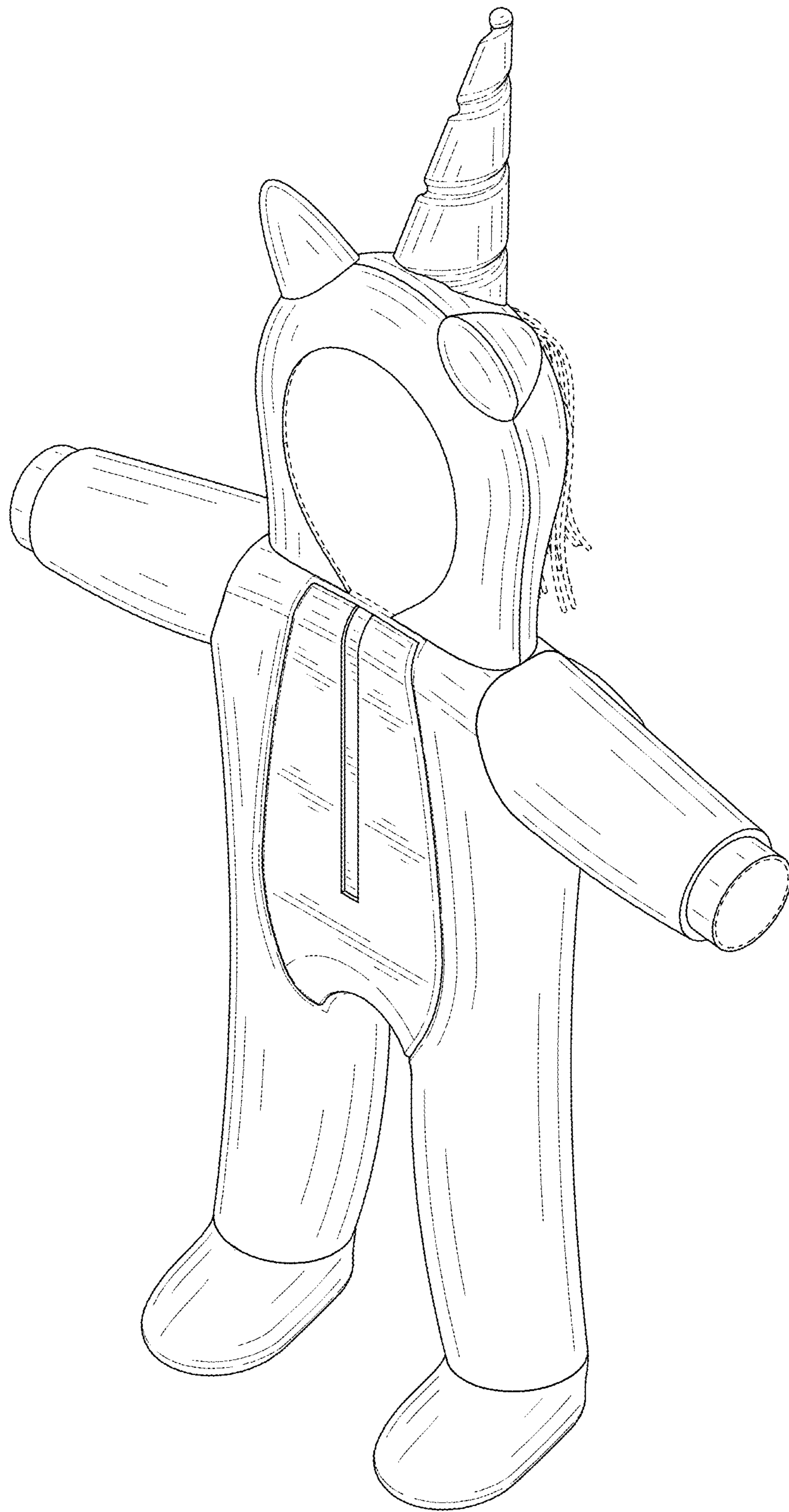

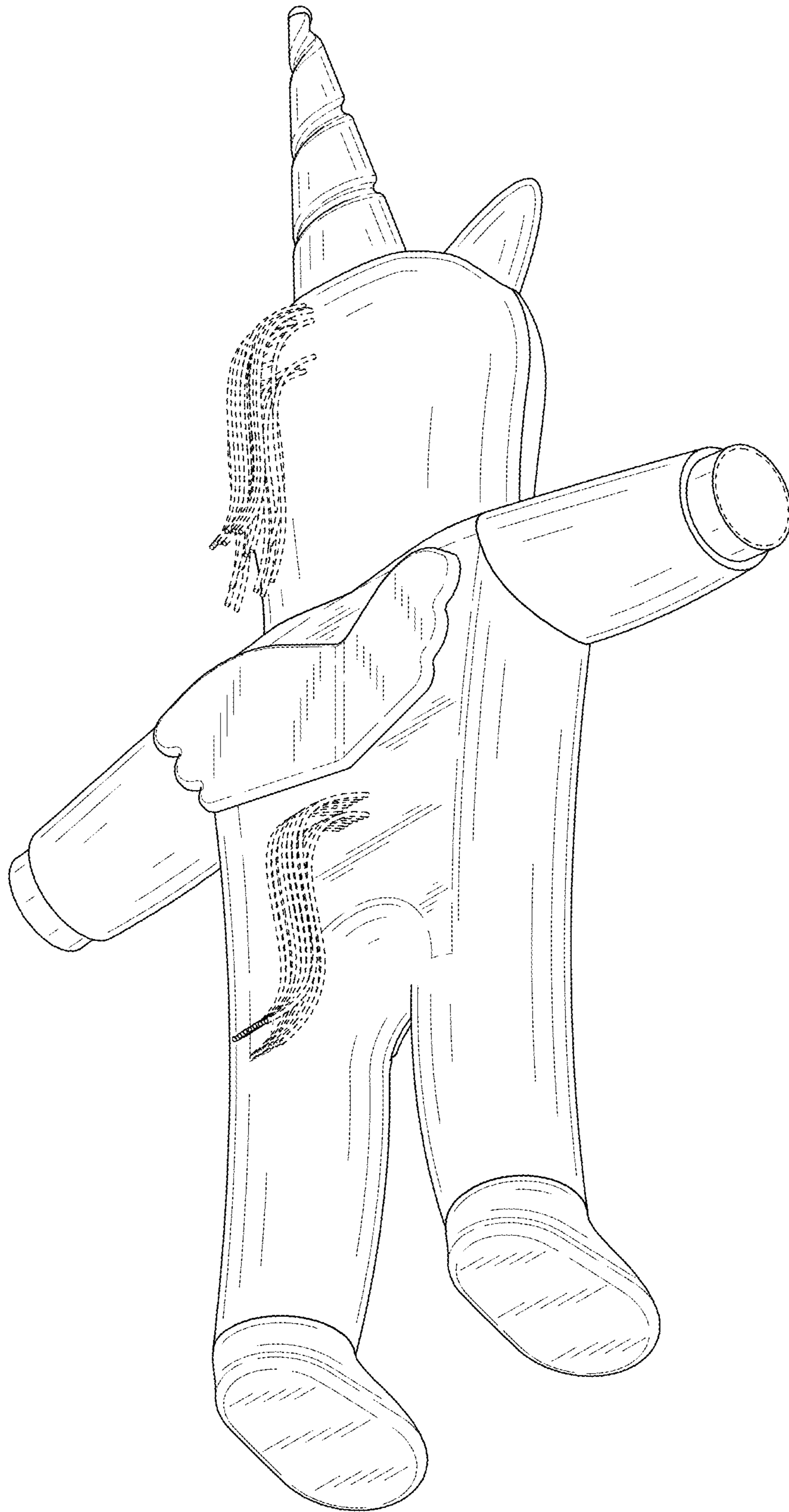

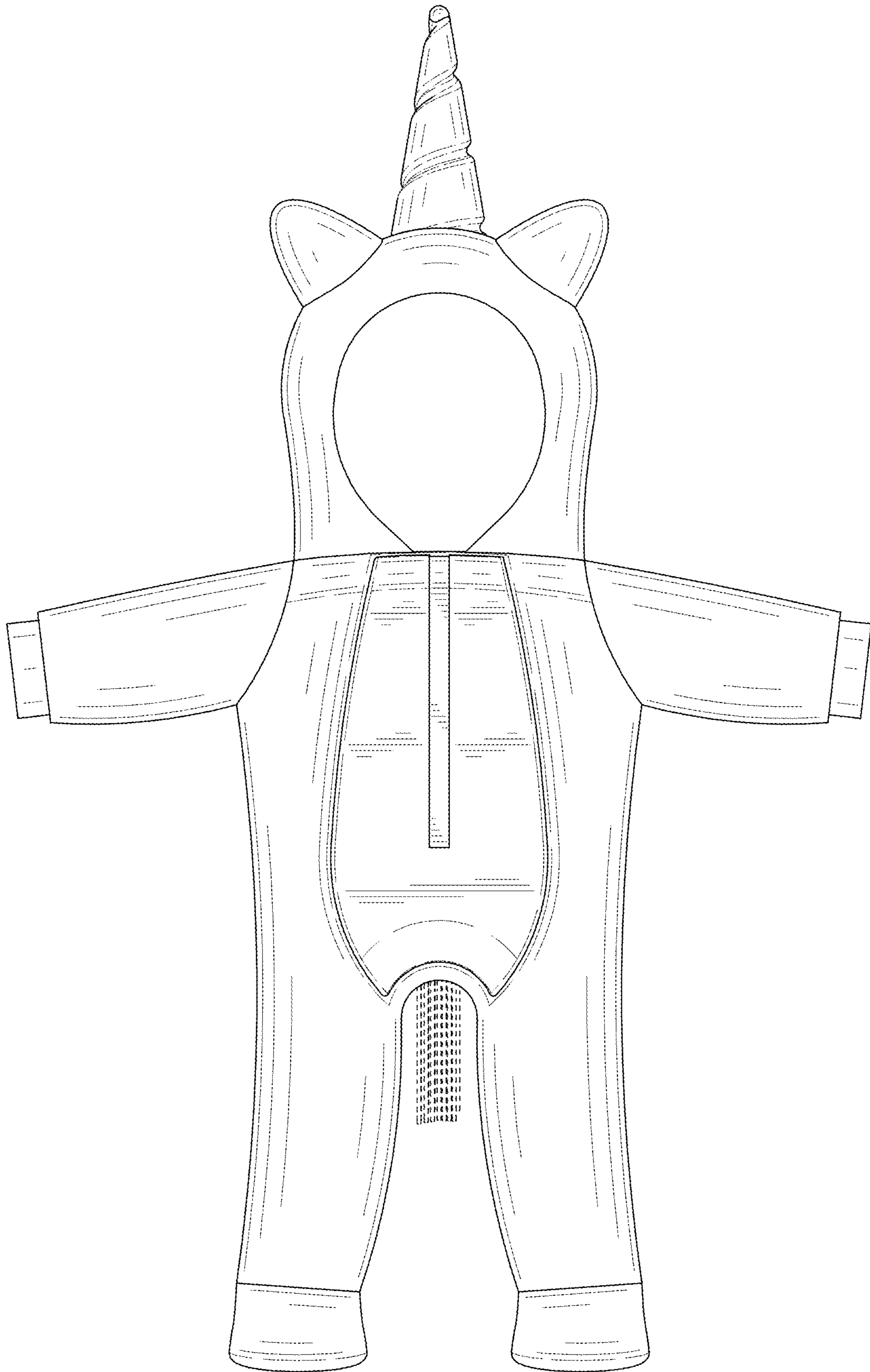

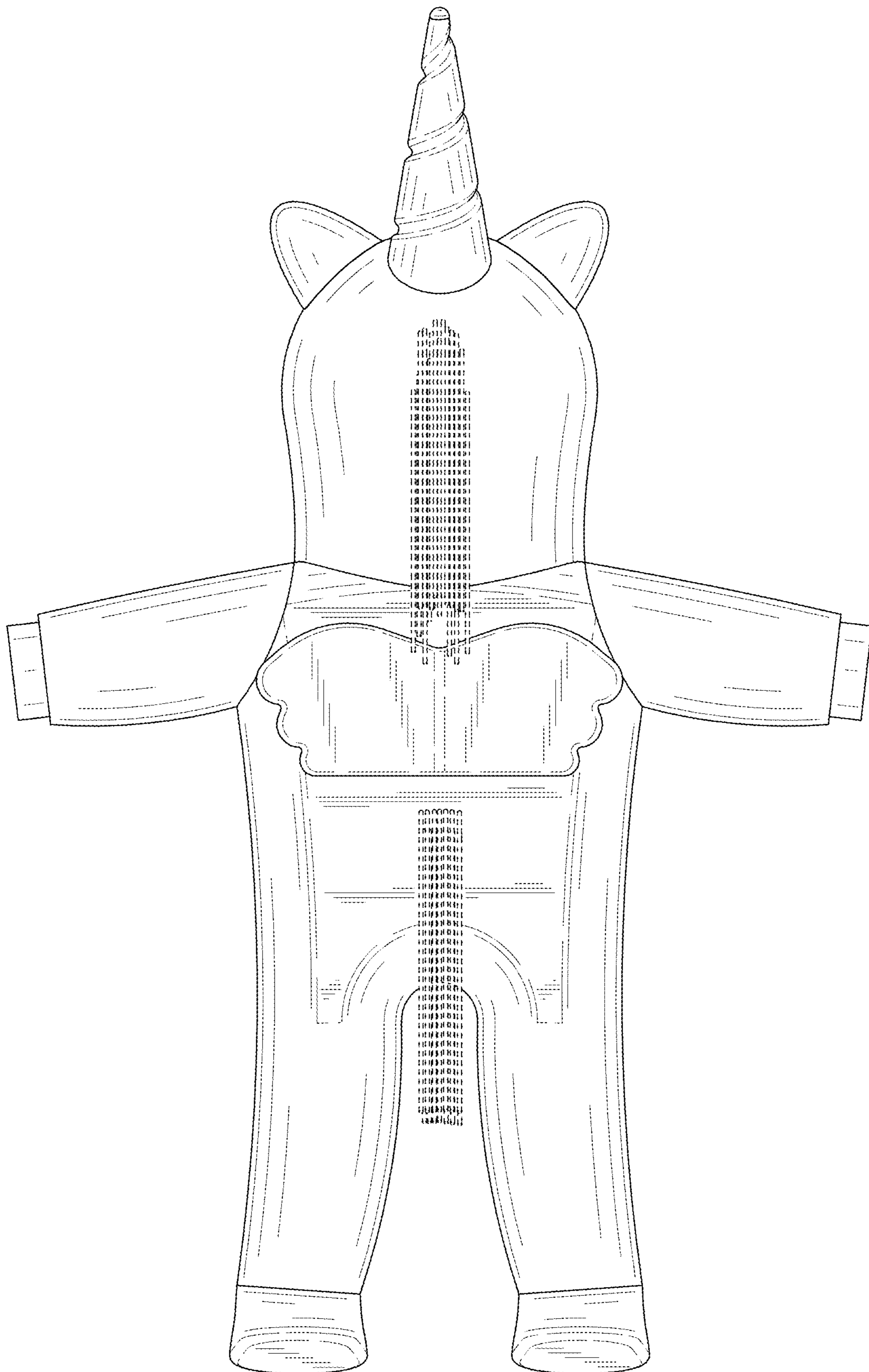

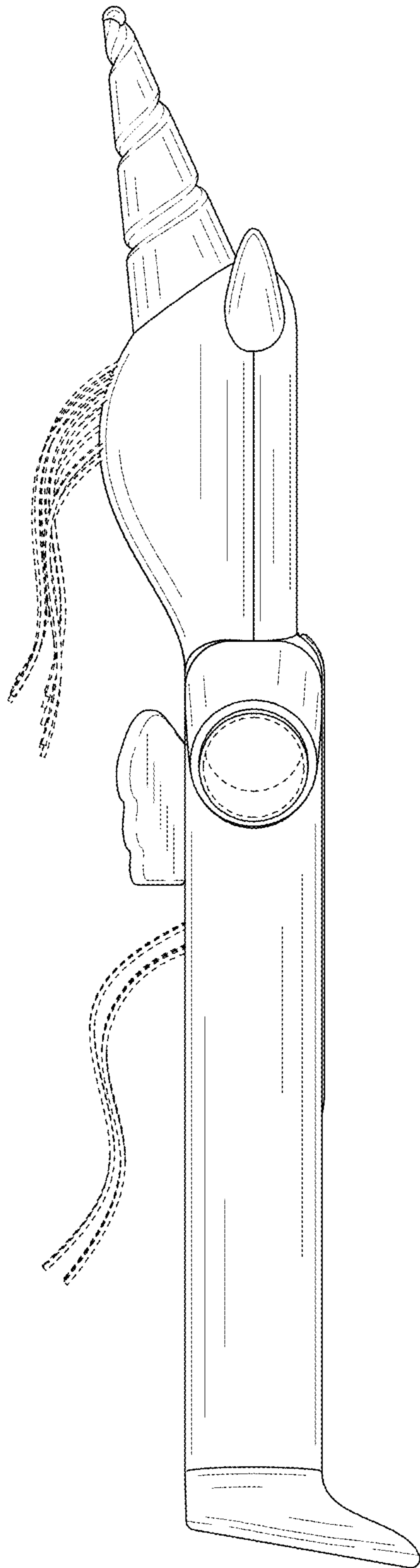

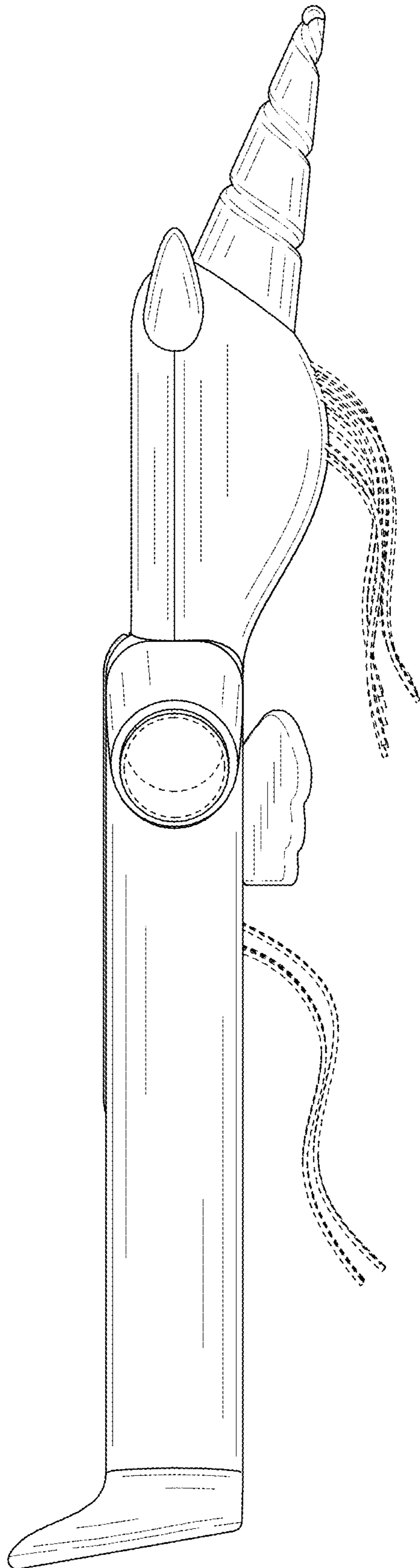

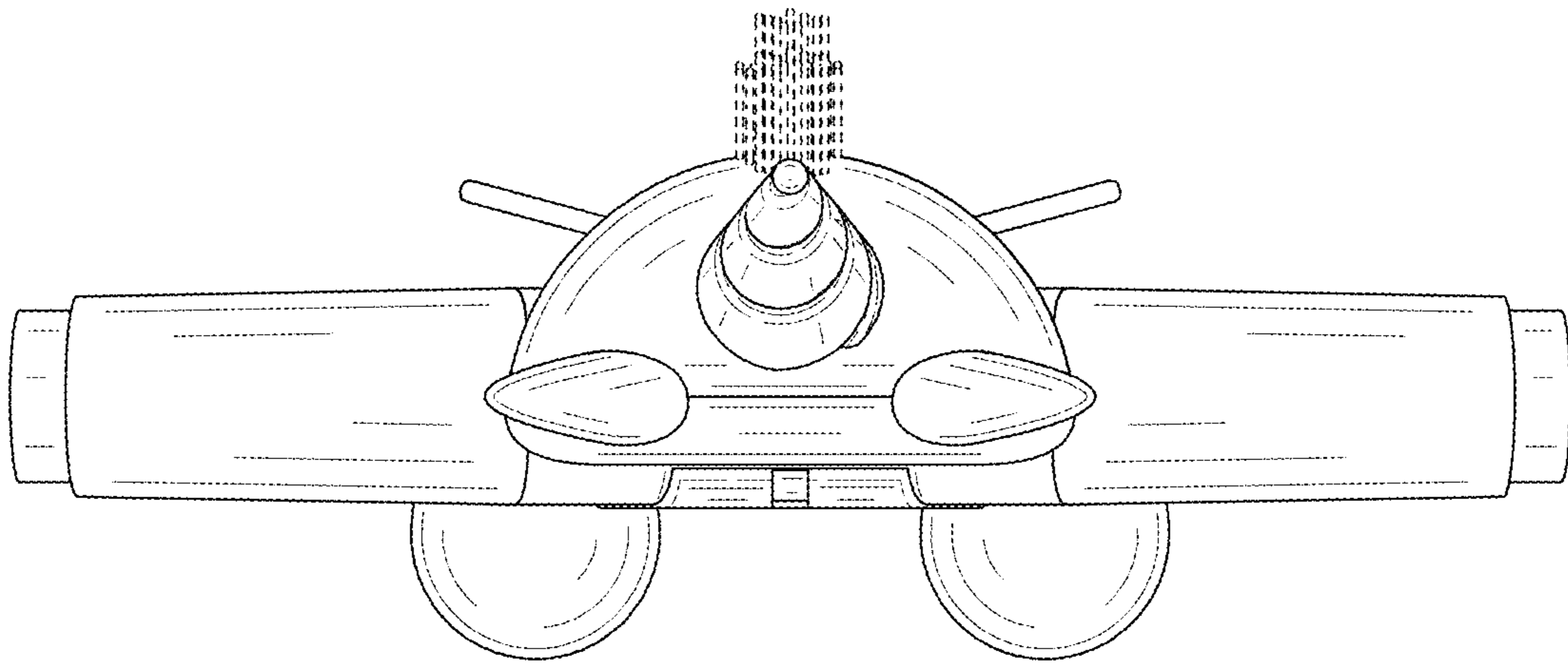

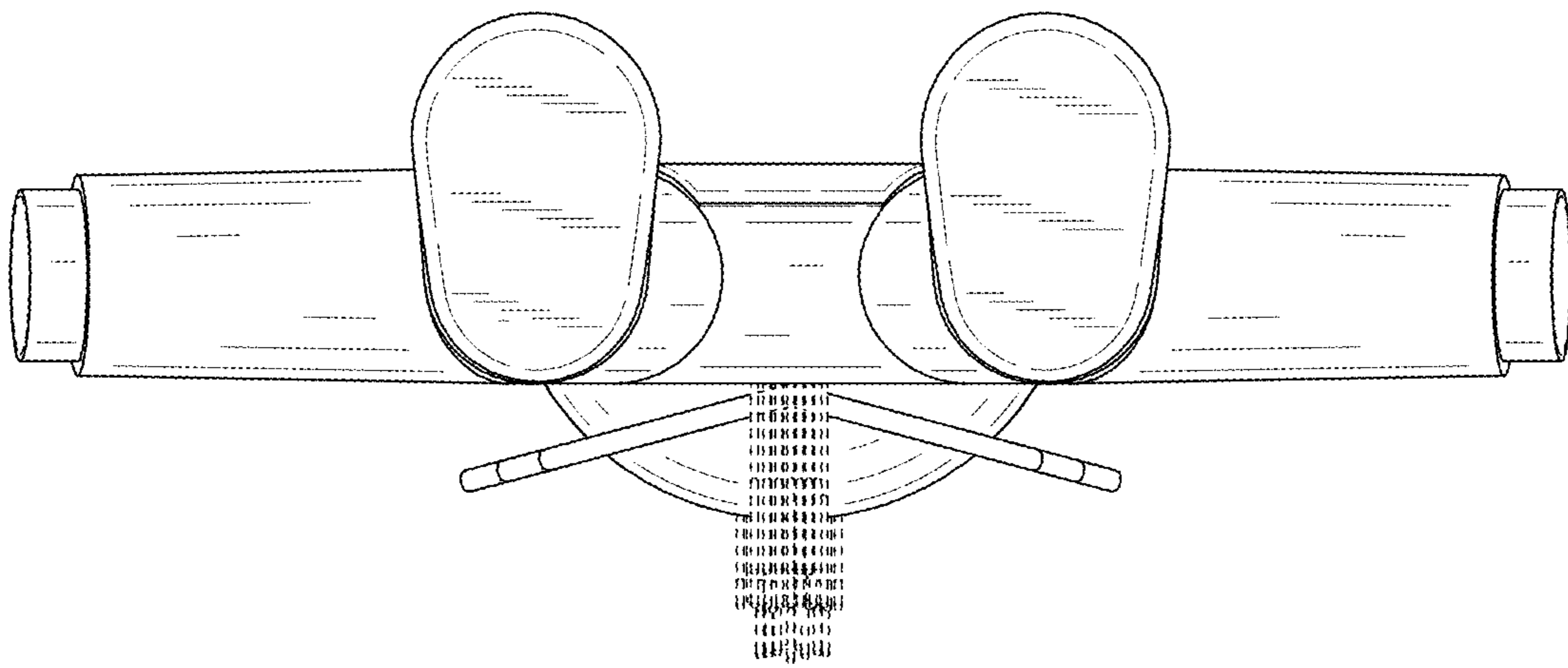
