(57) **CLAIM**

I claim the ornamental design for a bucket carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bucket carrier showing my new design;

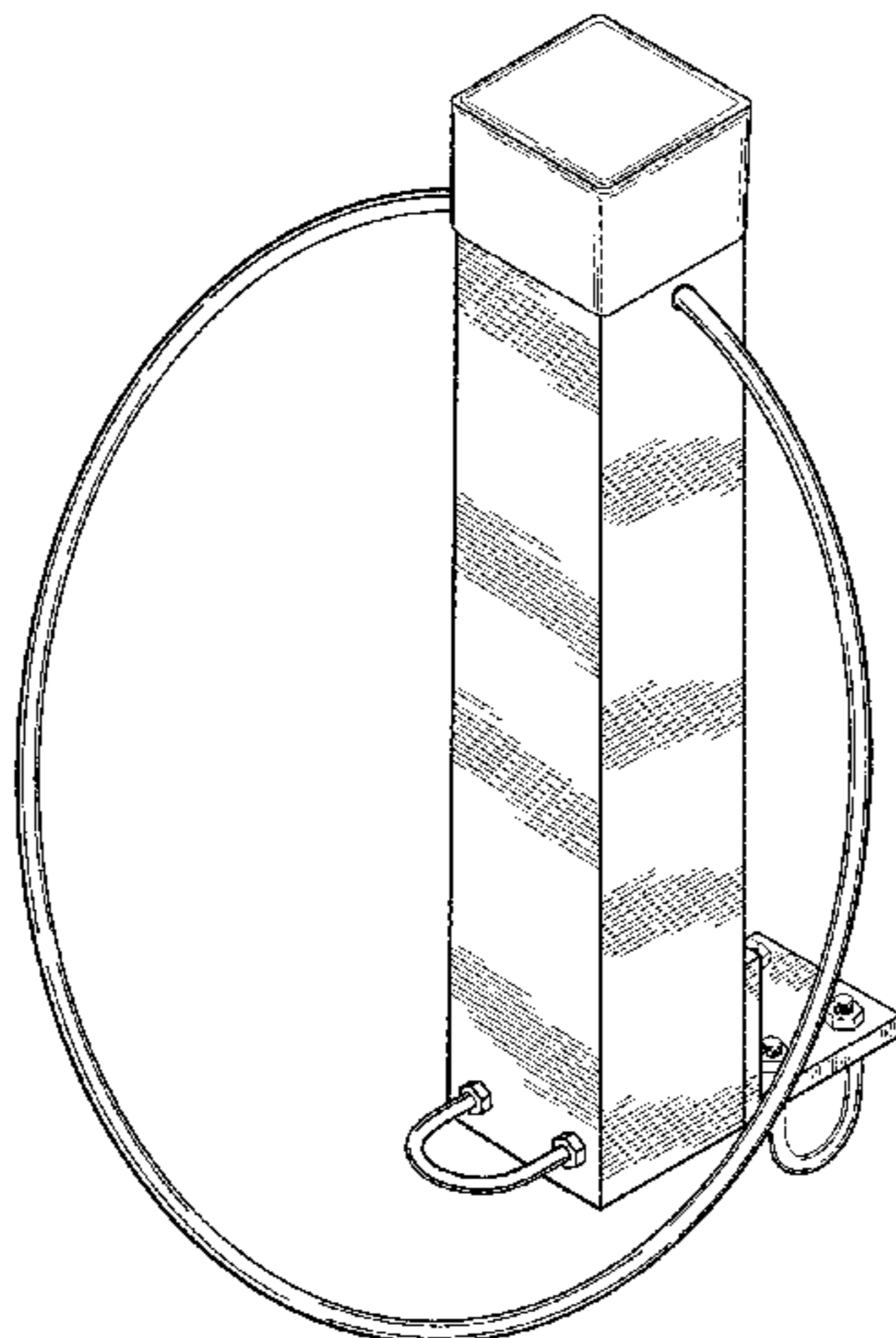


FIG. 32 is a rear elevational view thereof;

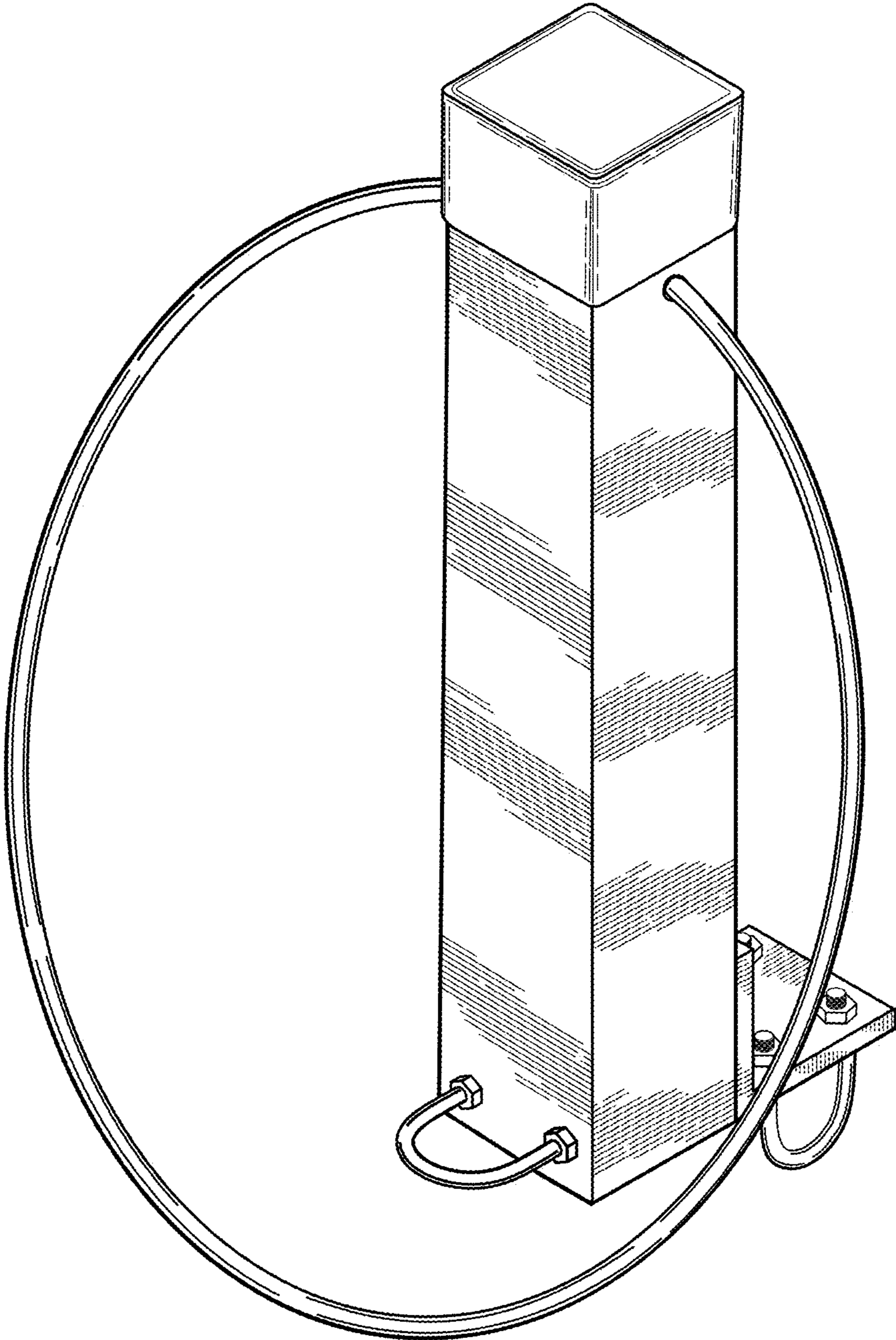

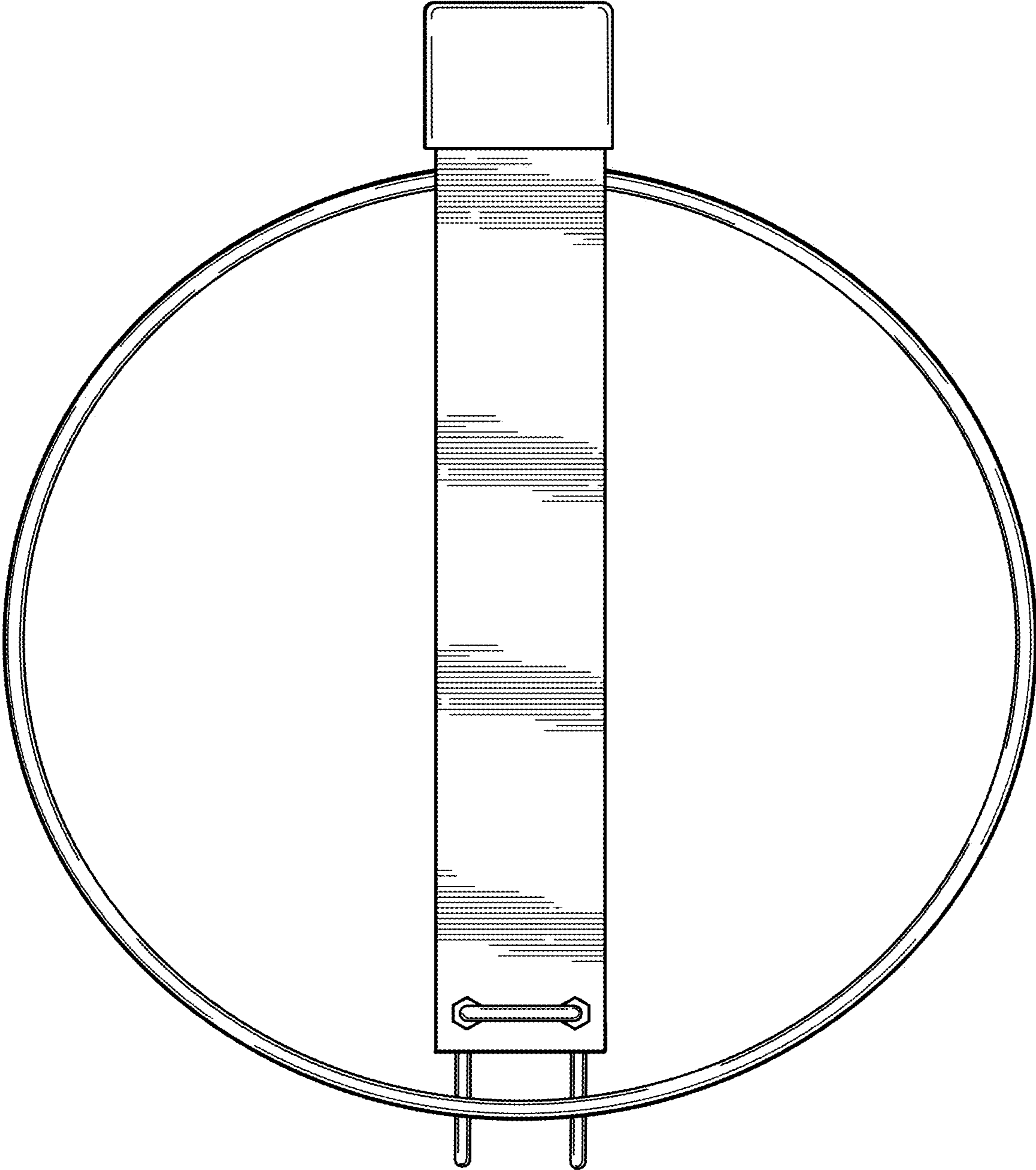

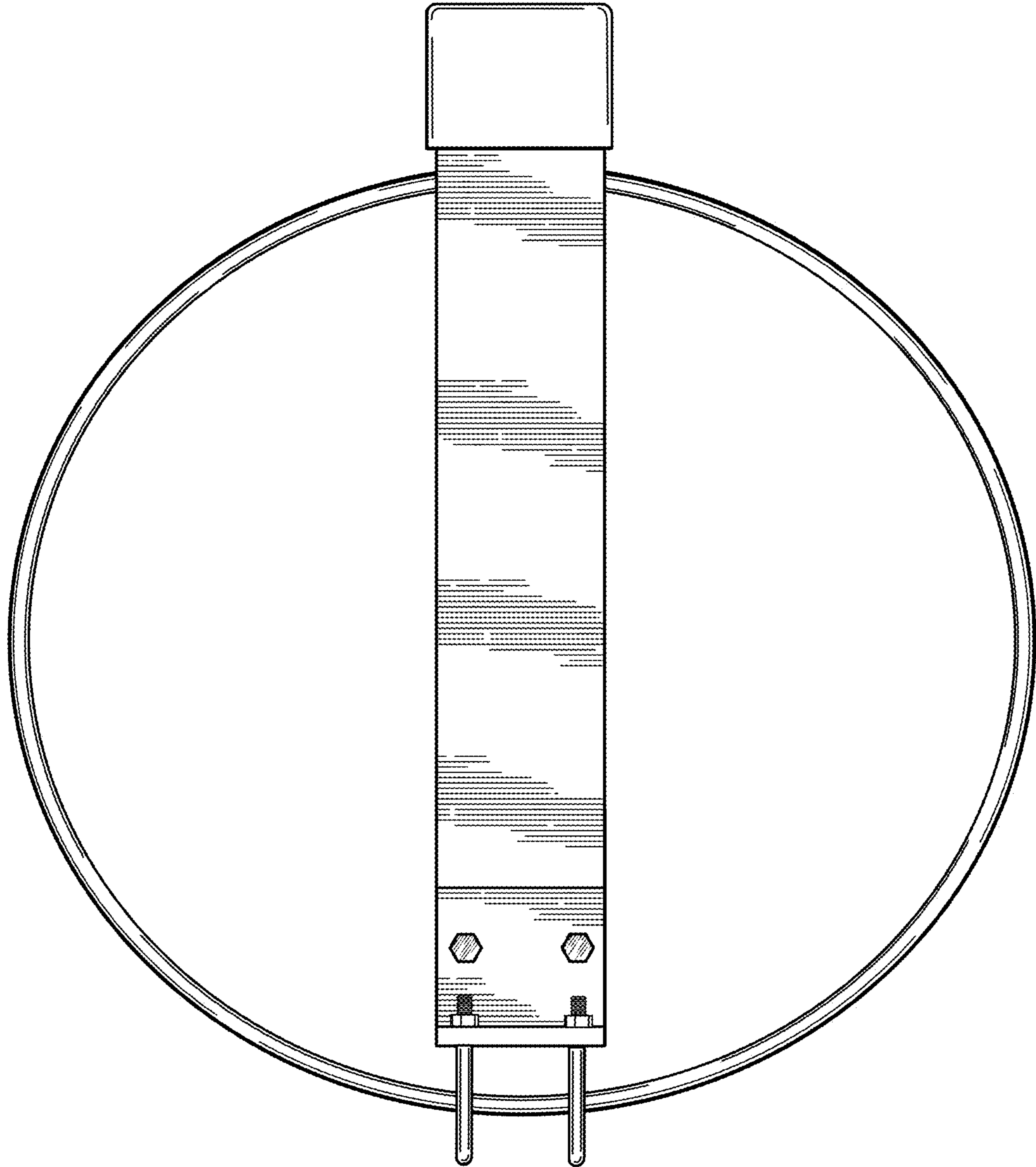

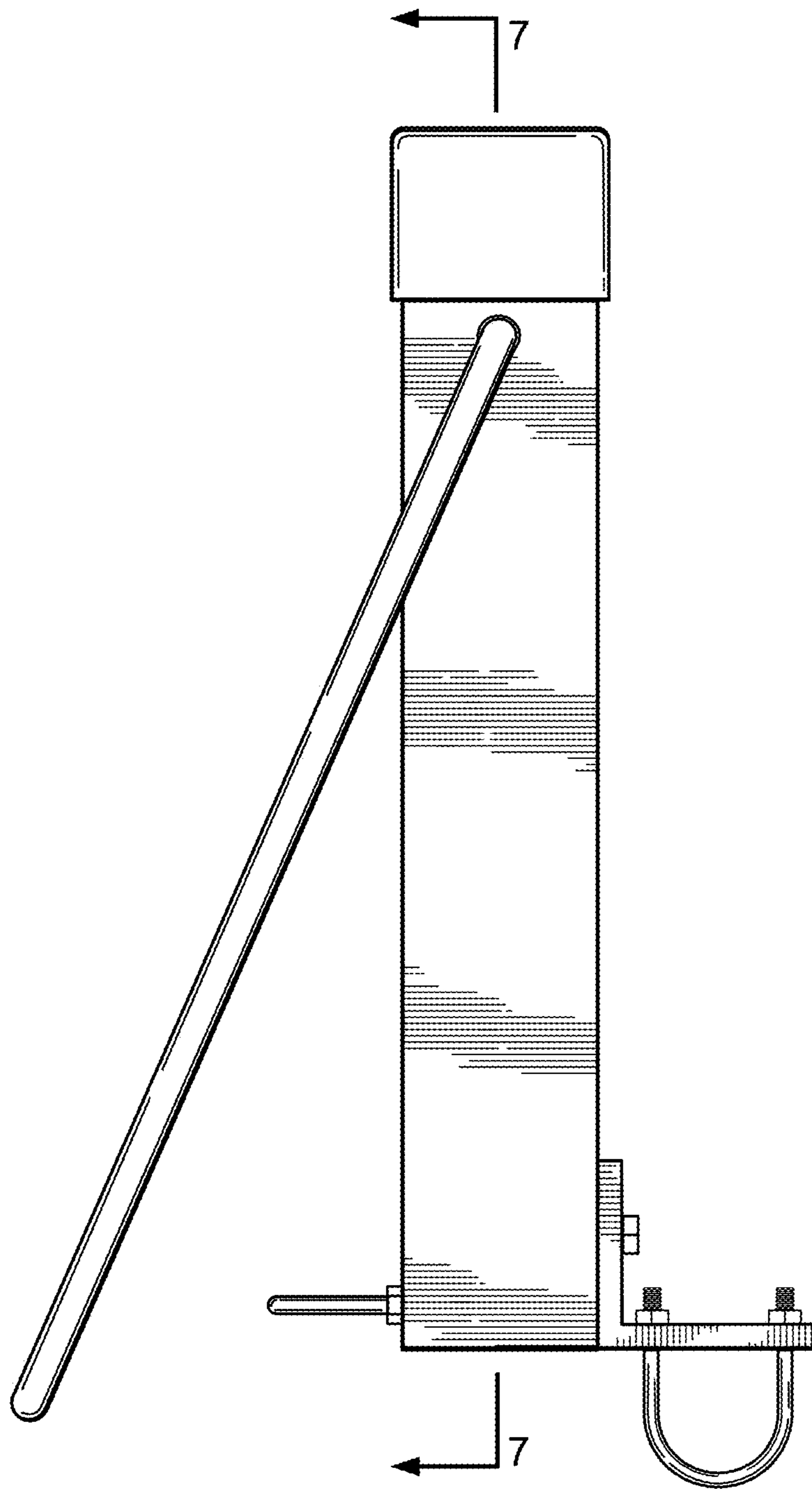

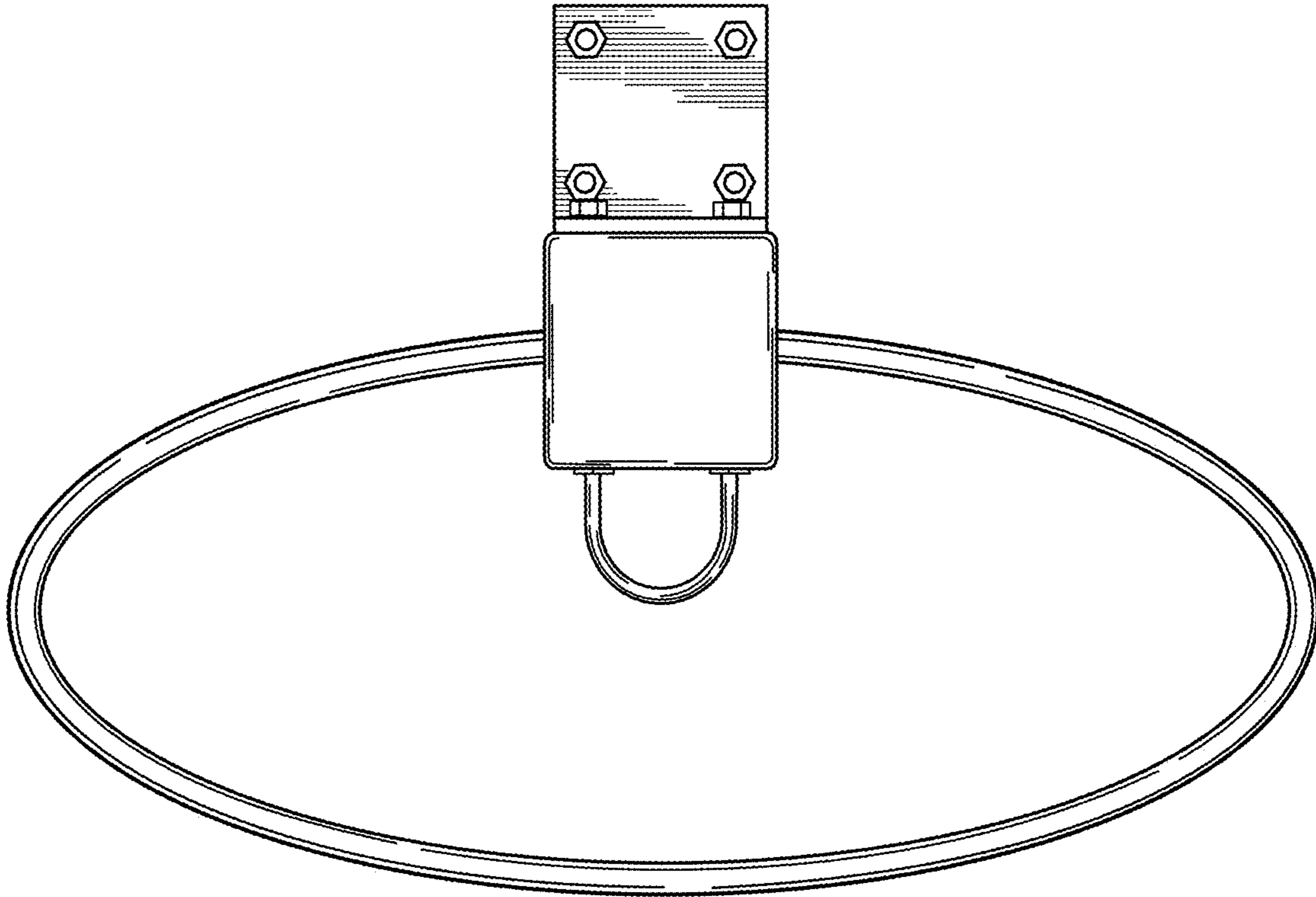

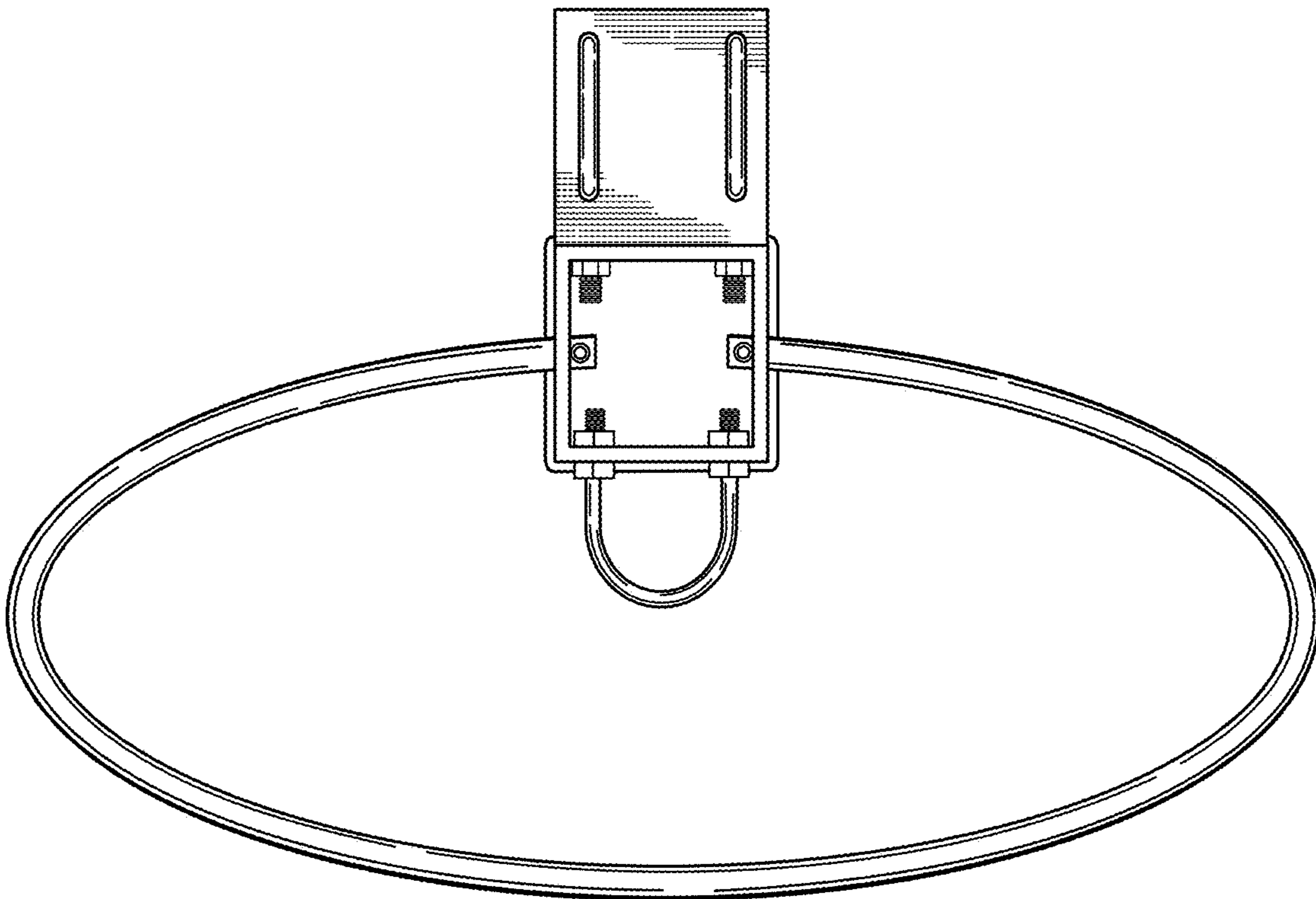

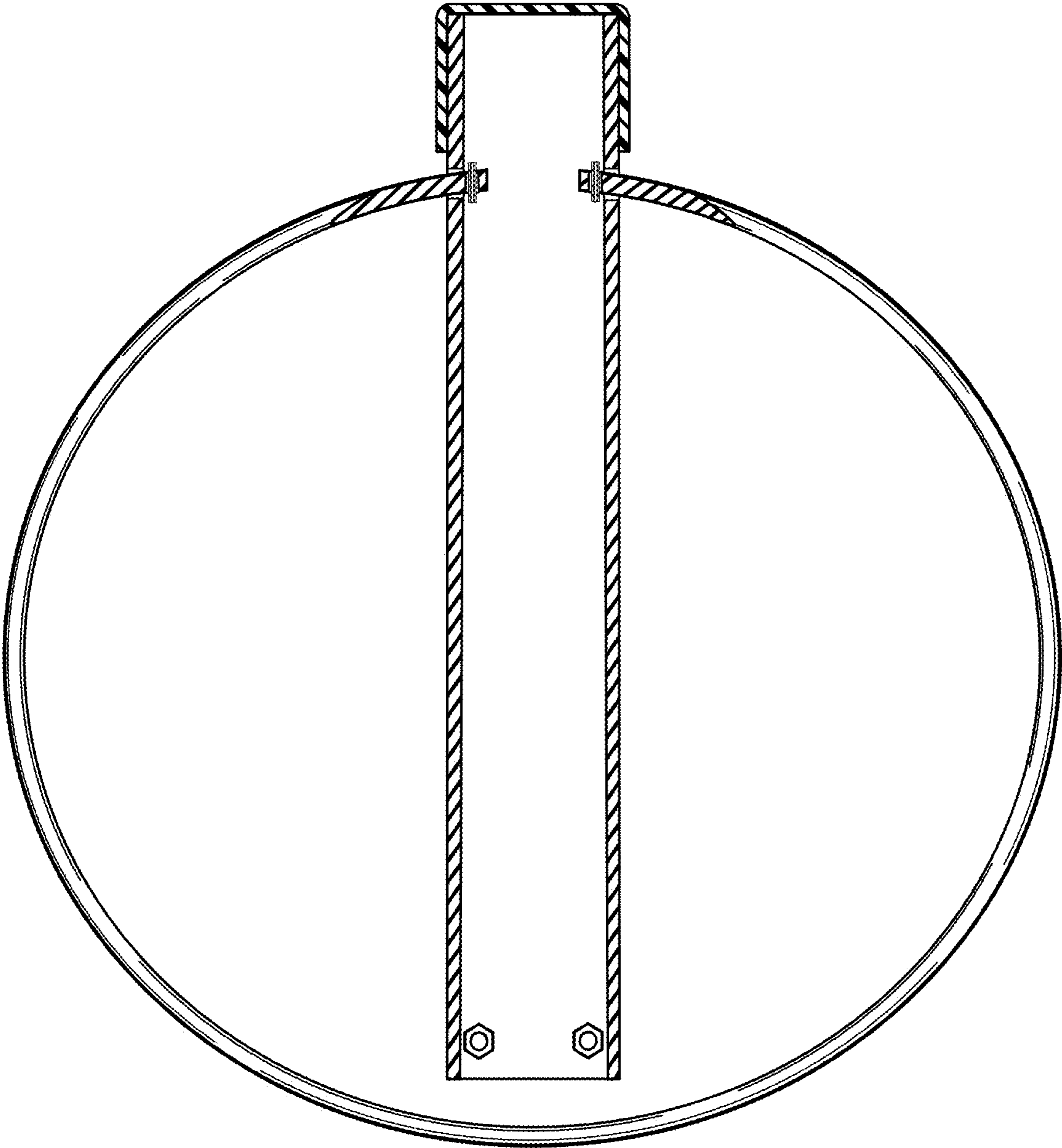

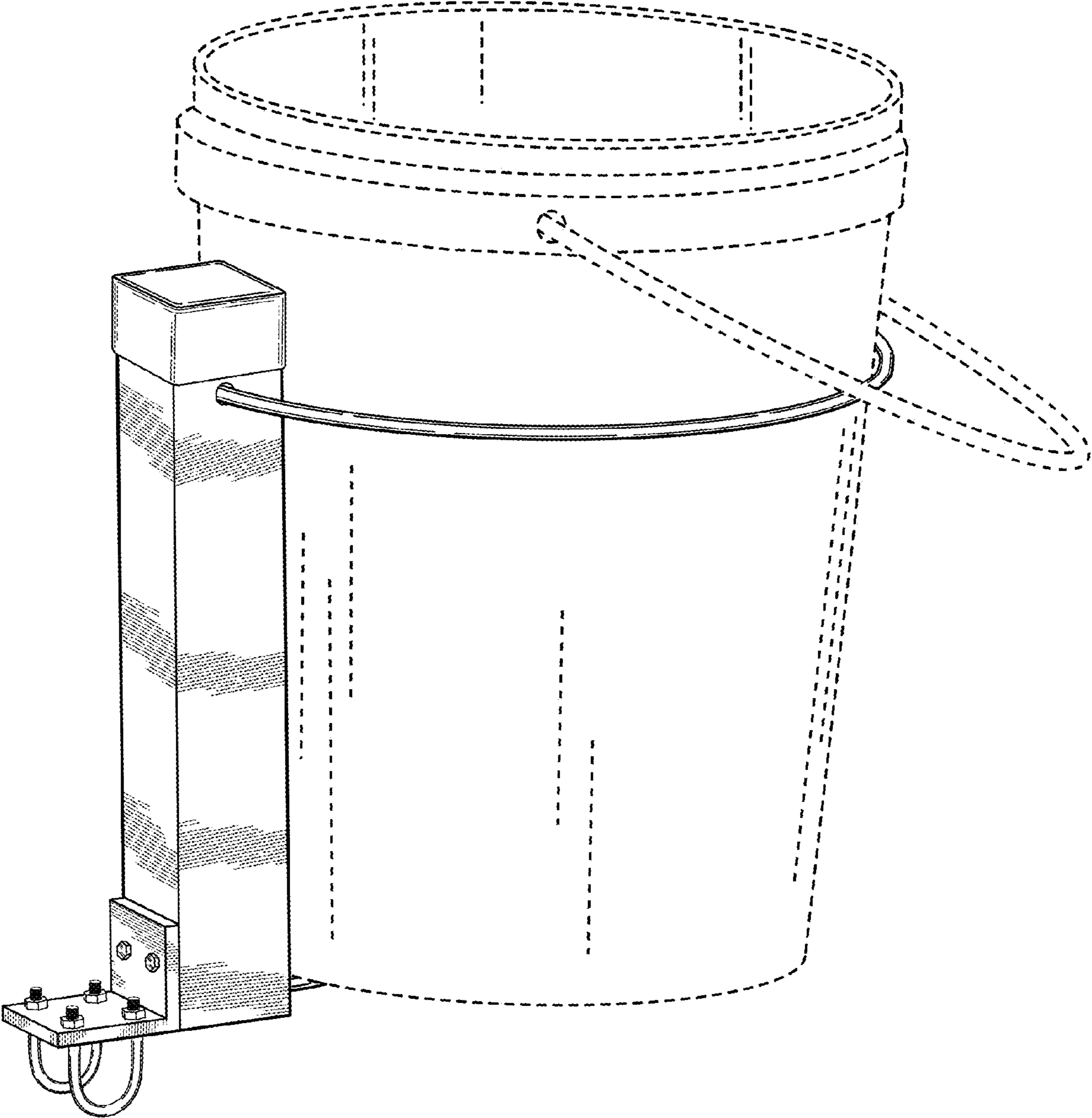

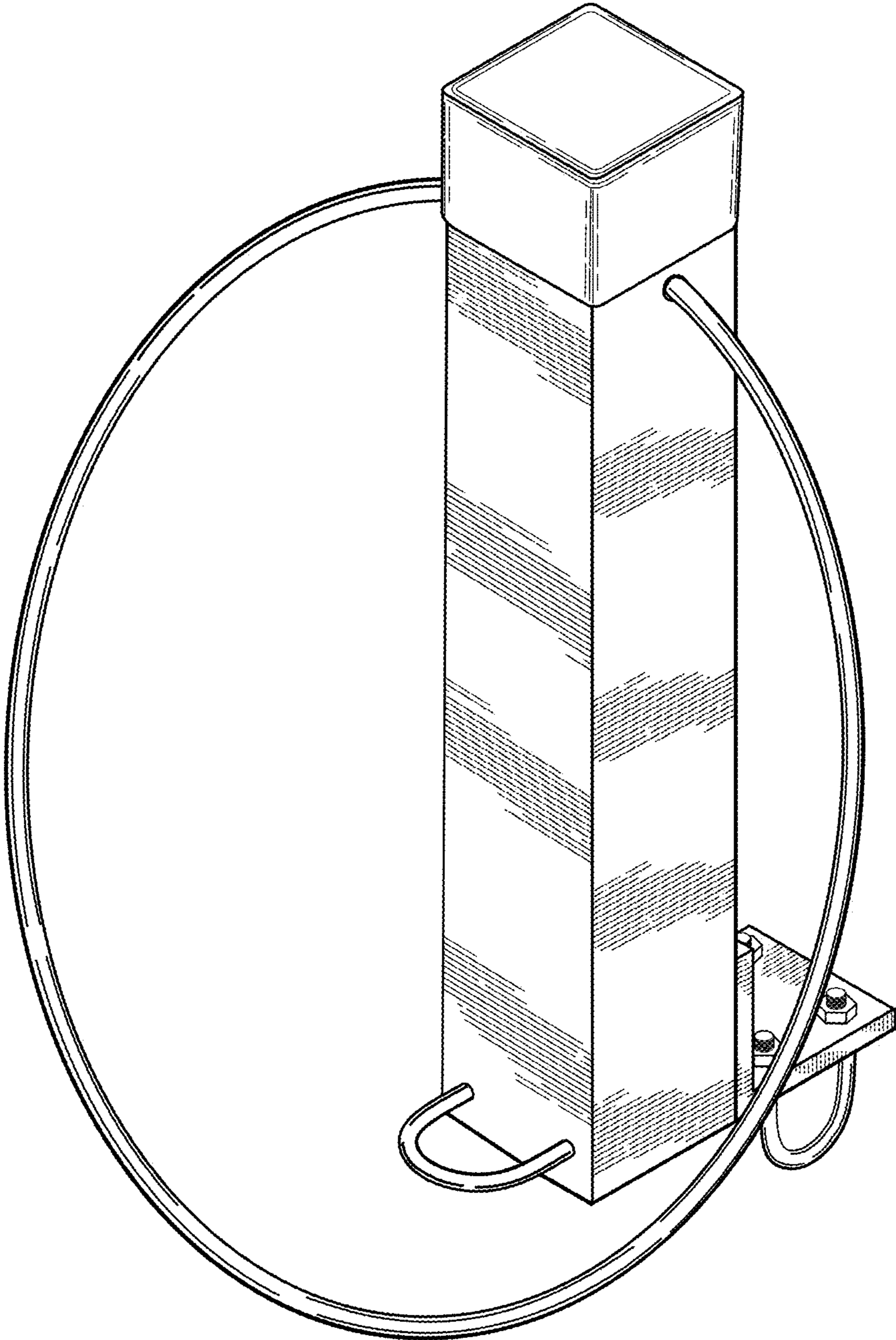

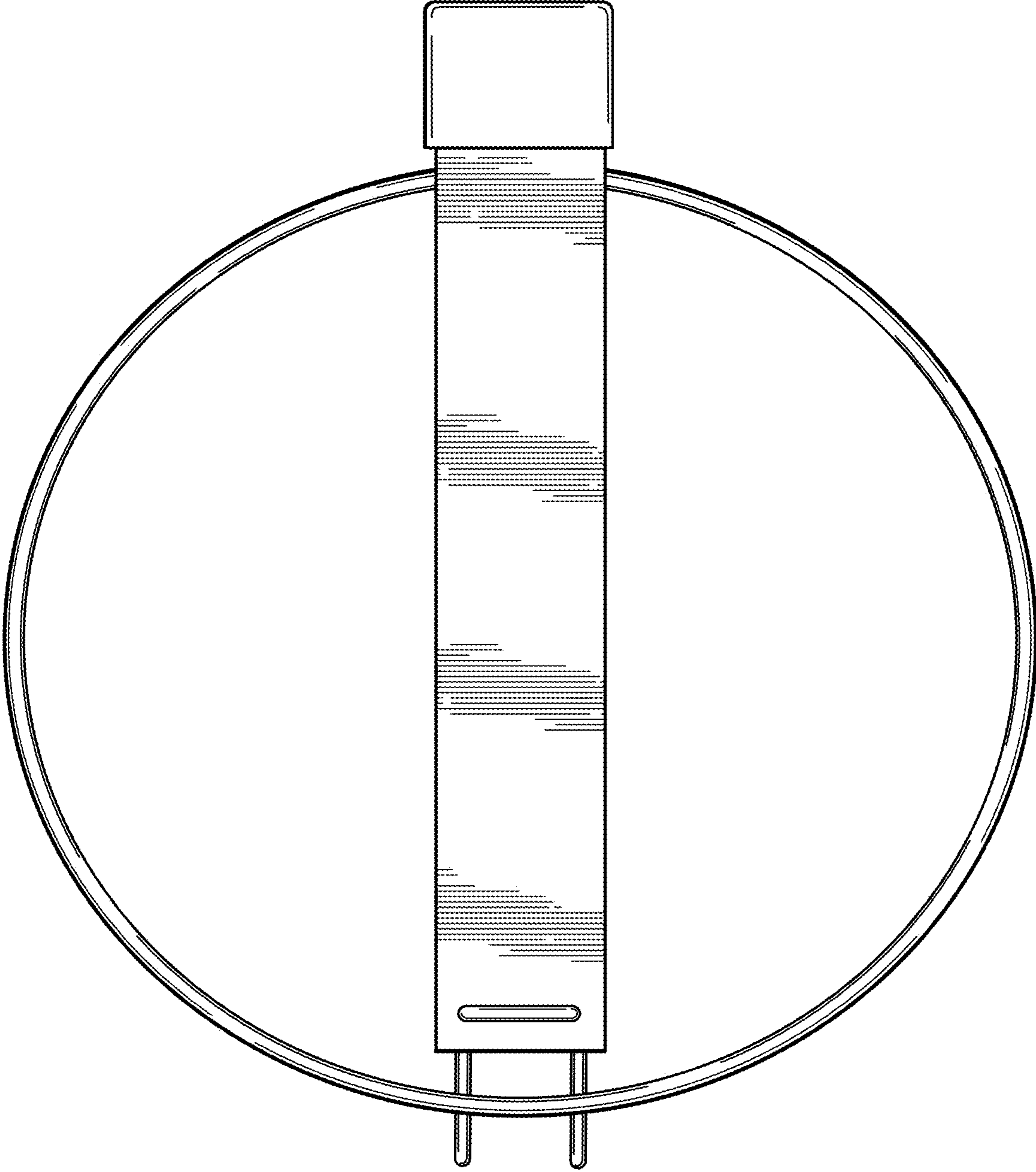

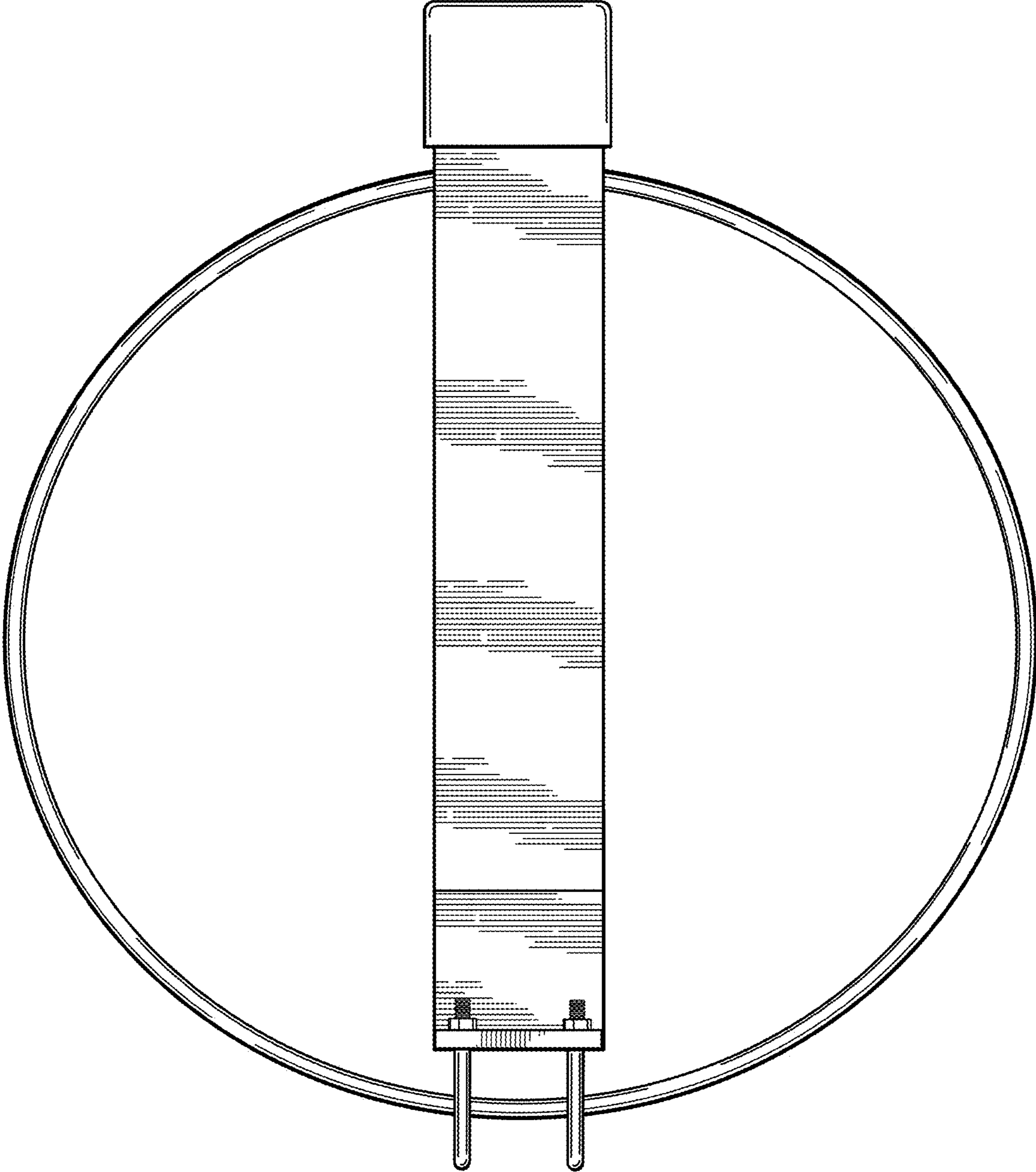

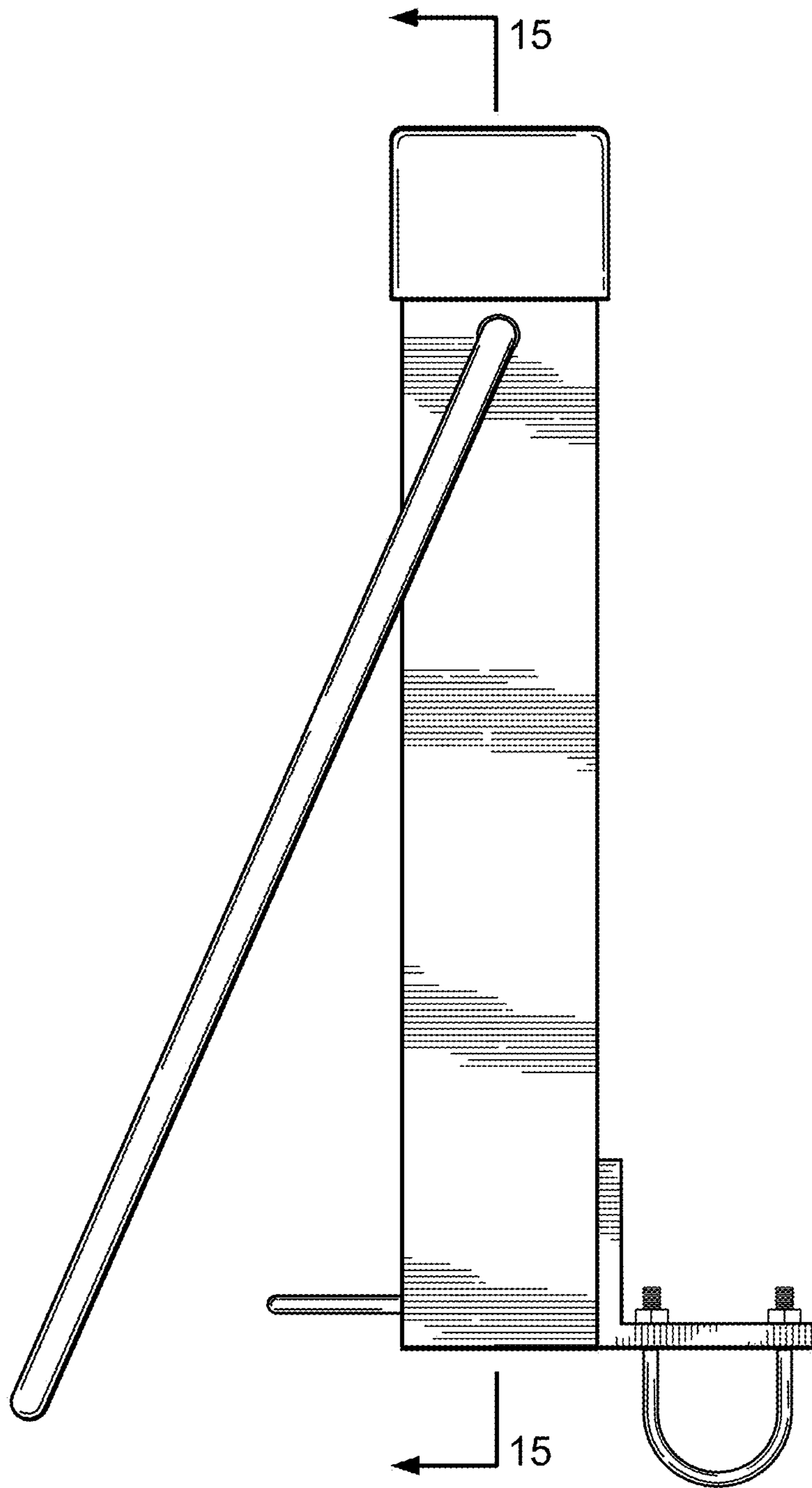

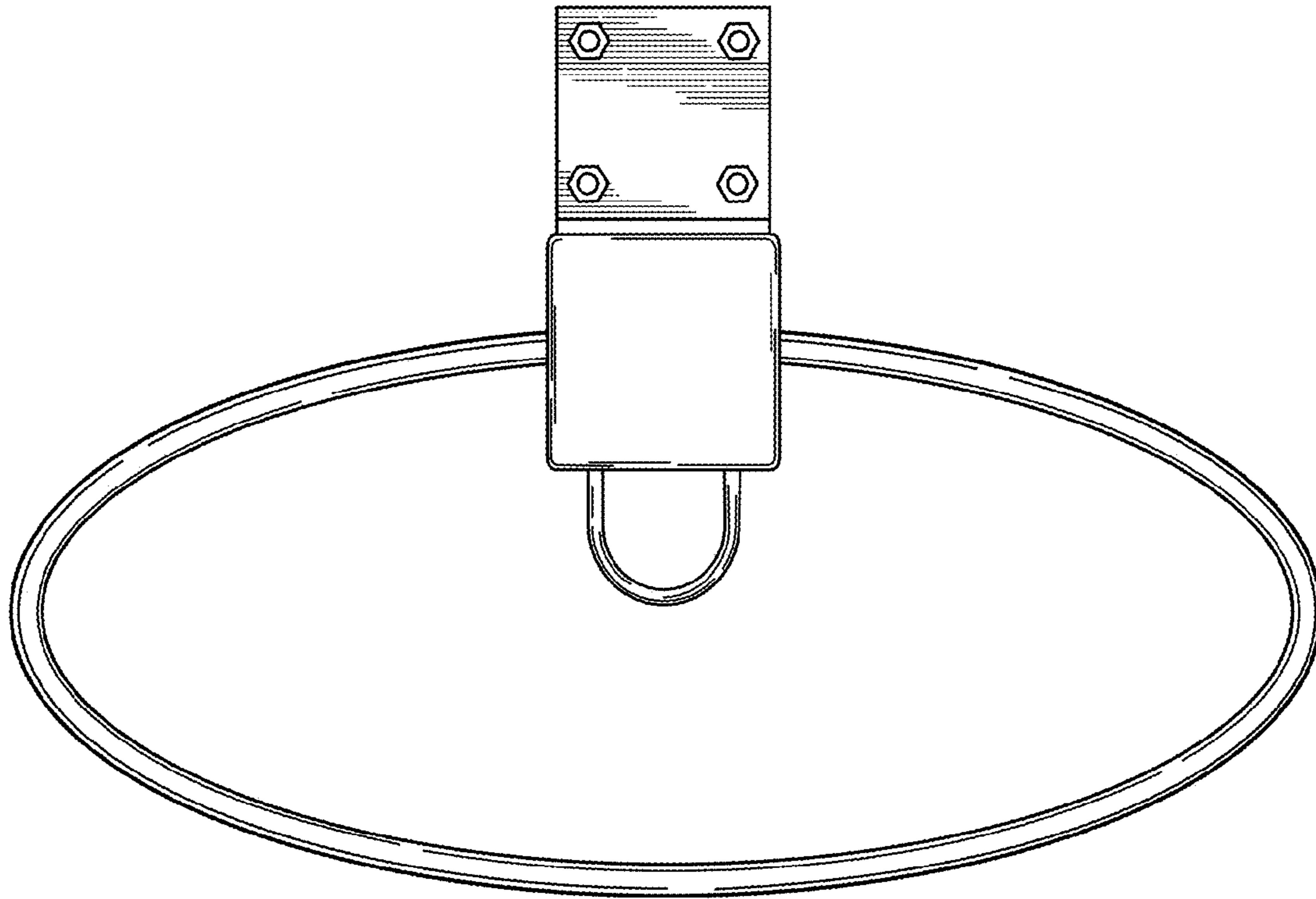

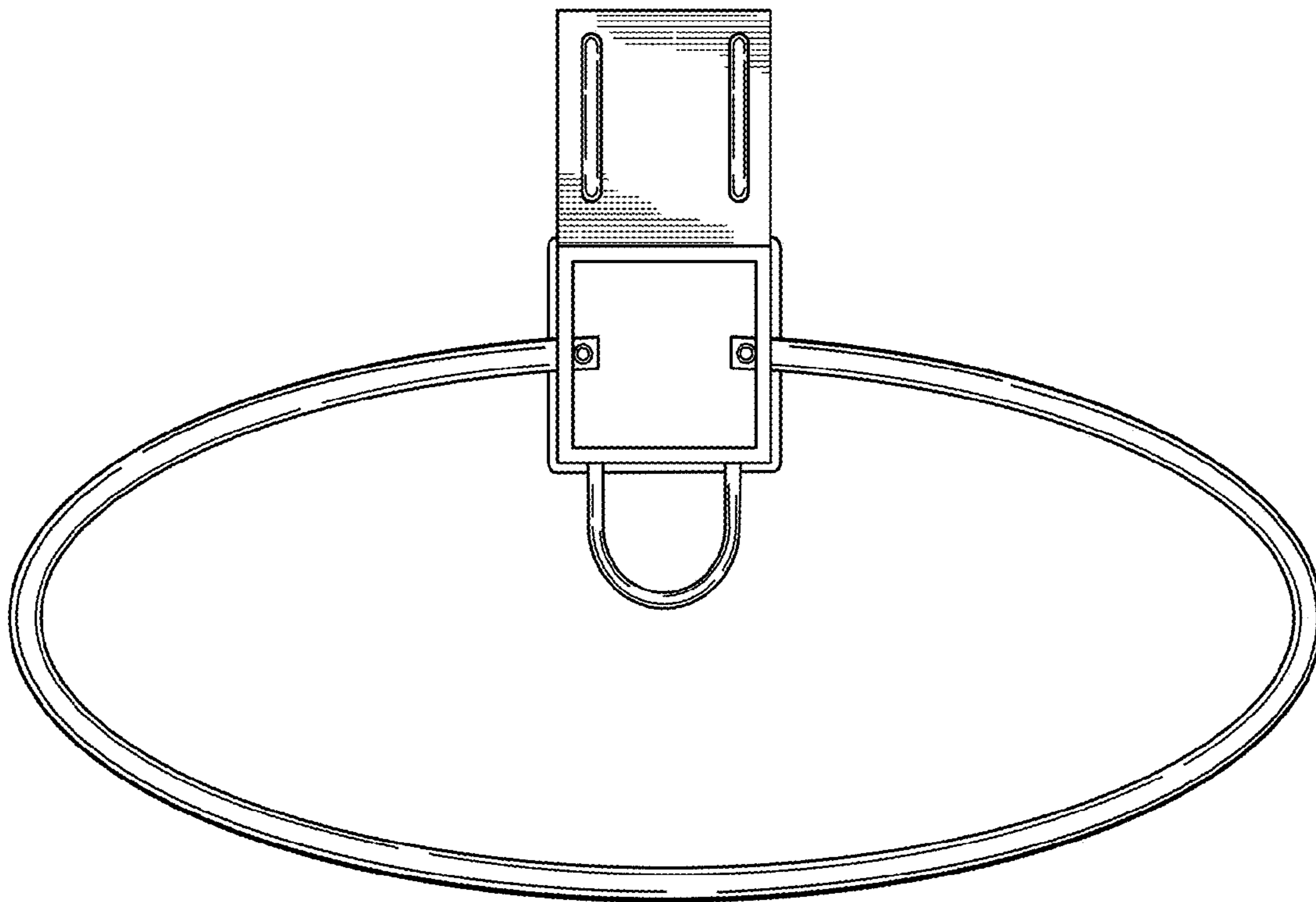

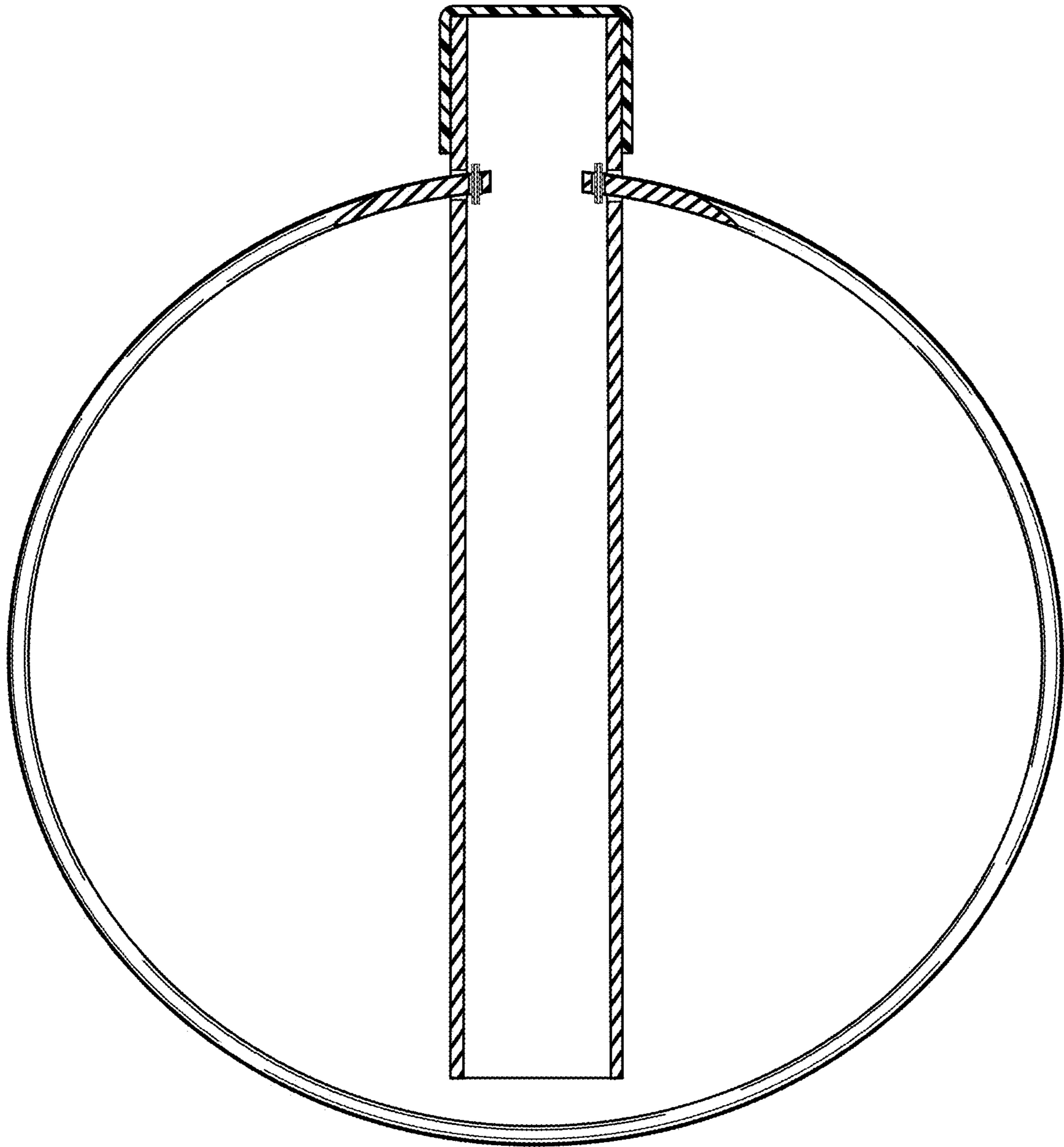

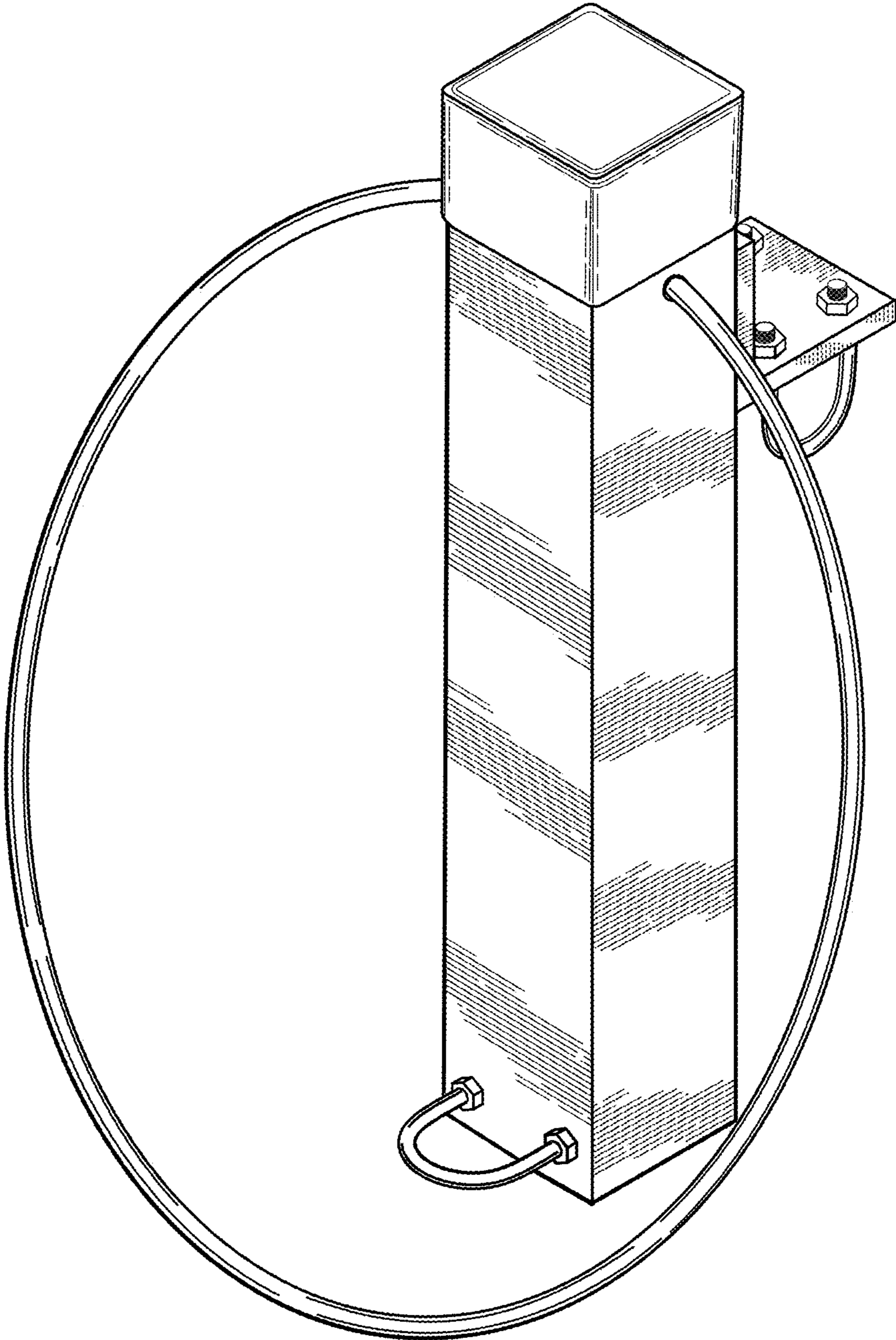

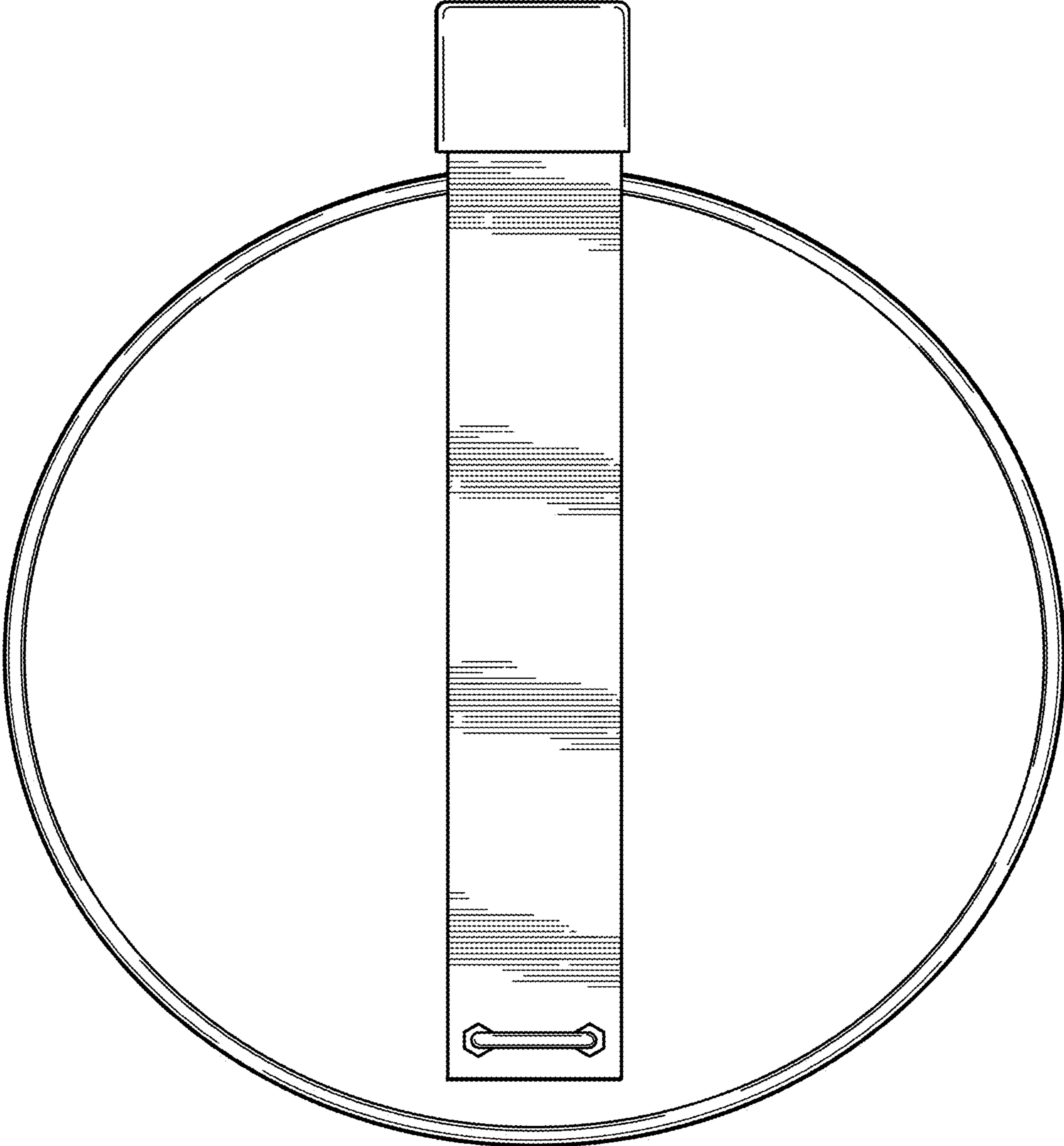

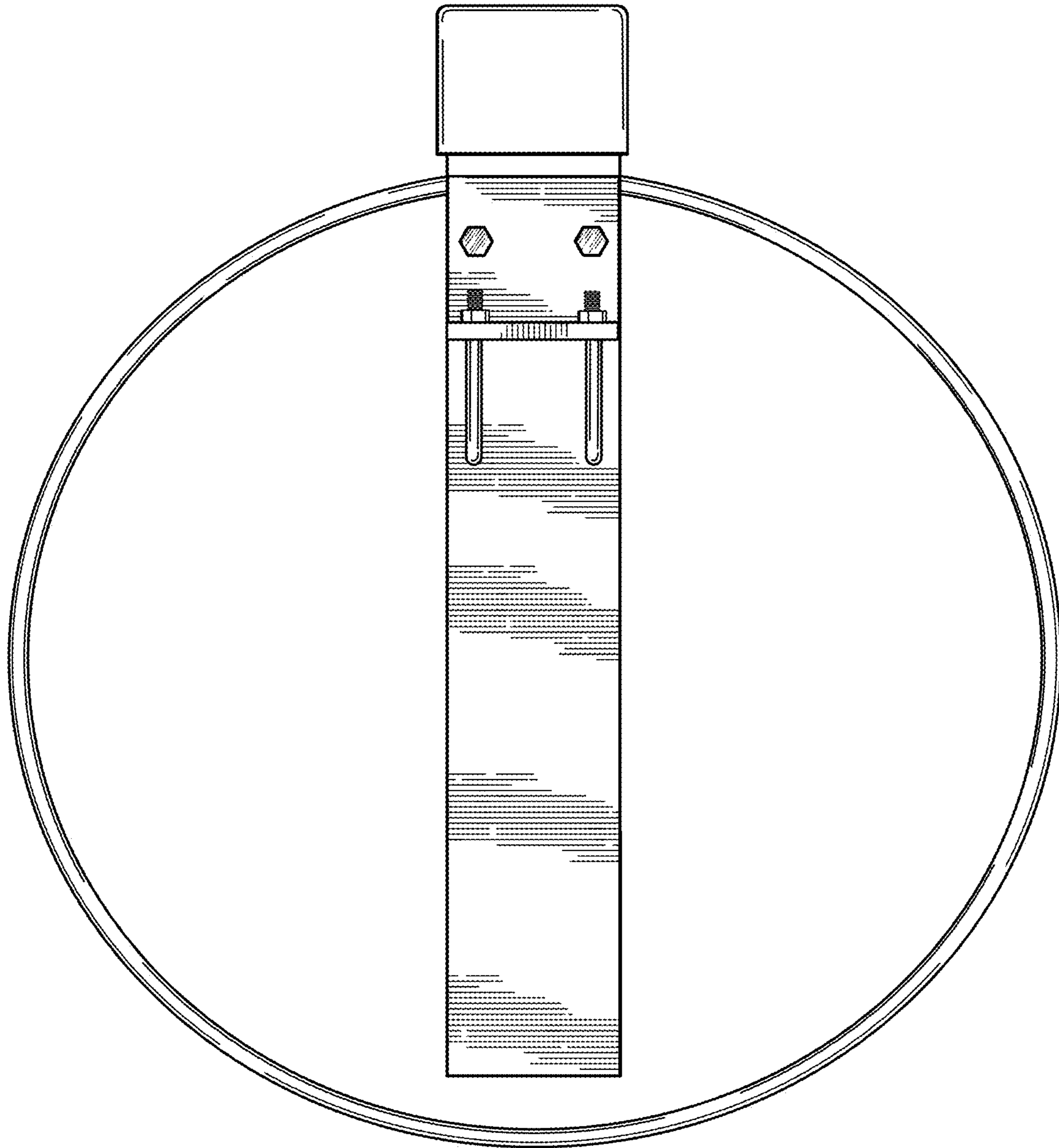

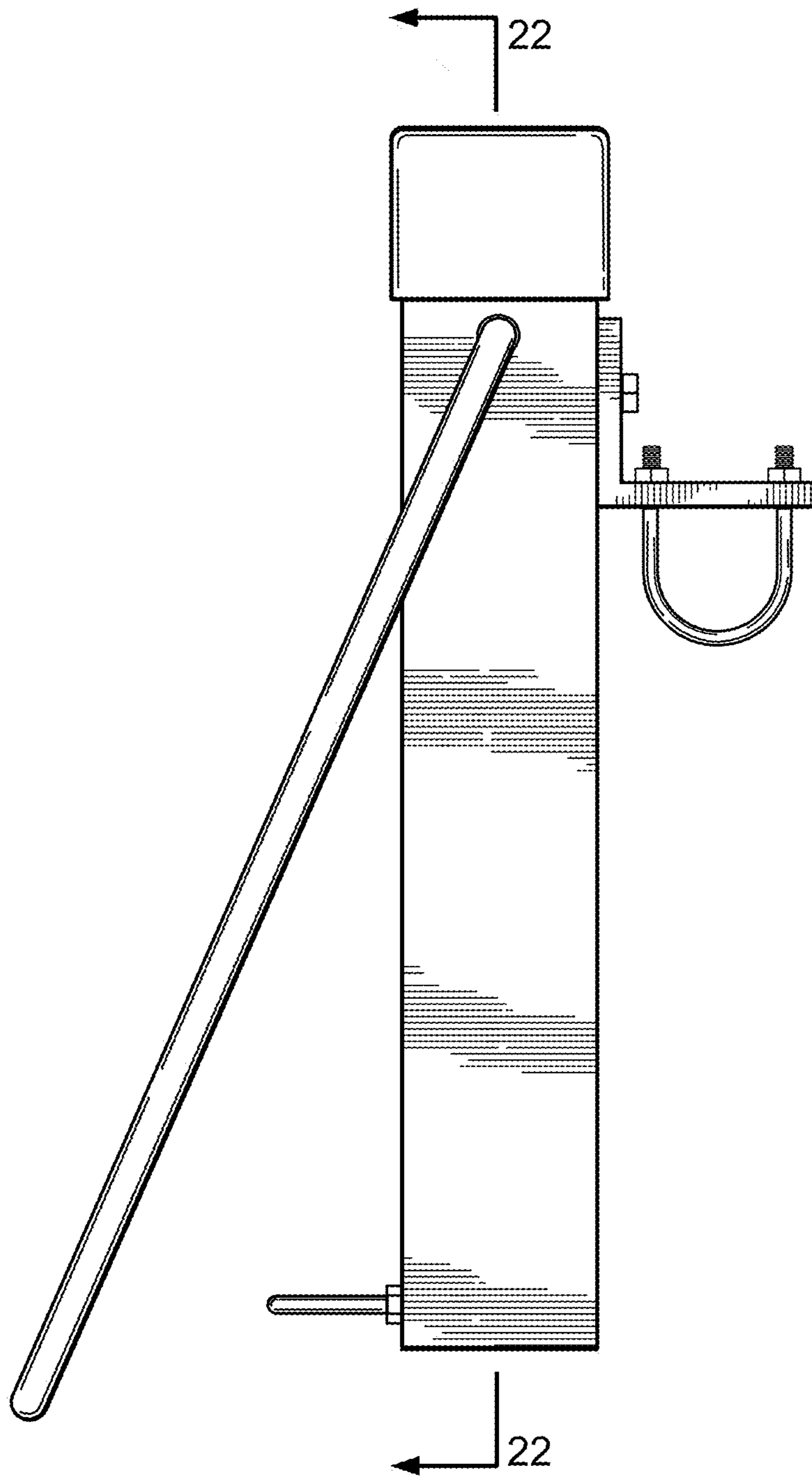

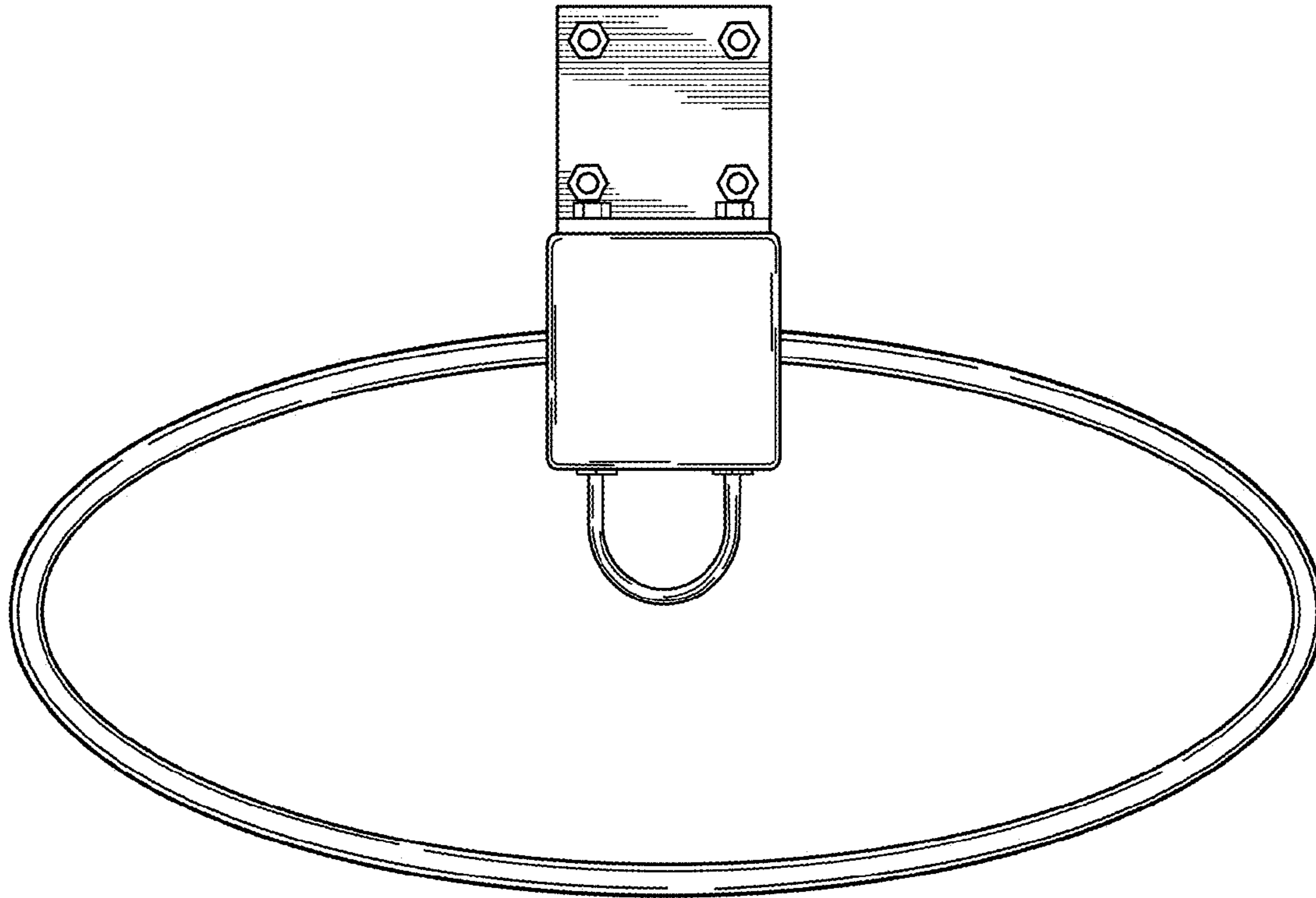

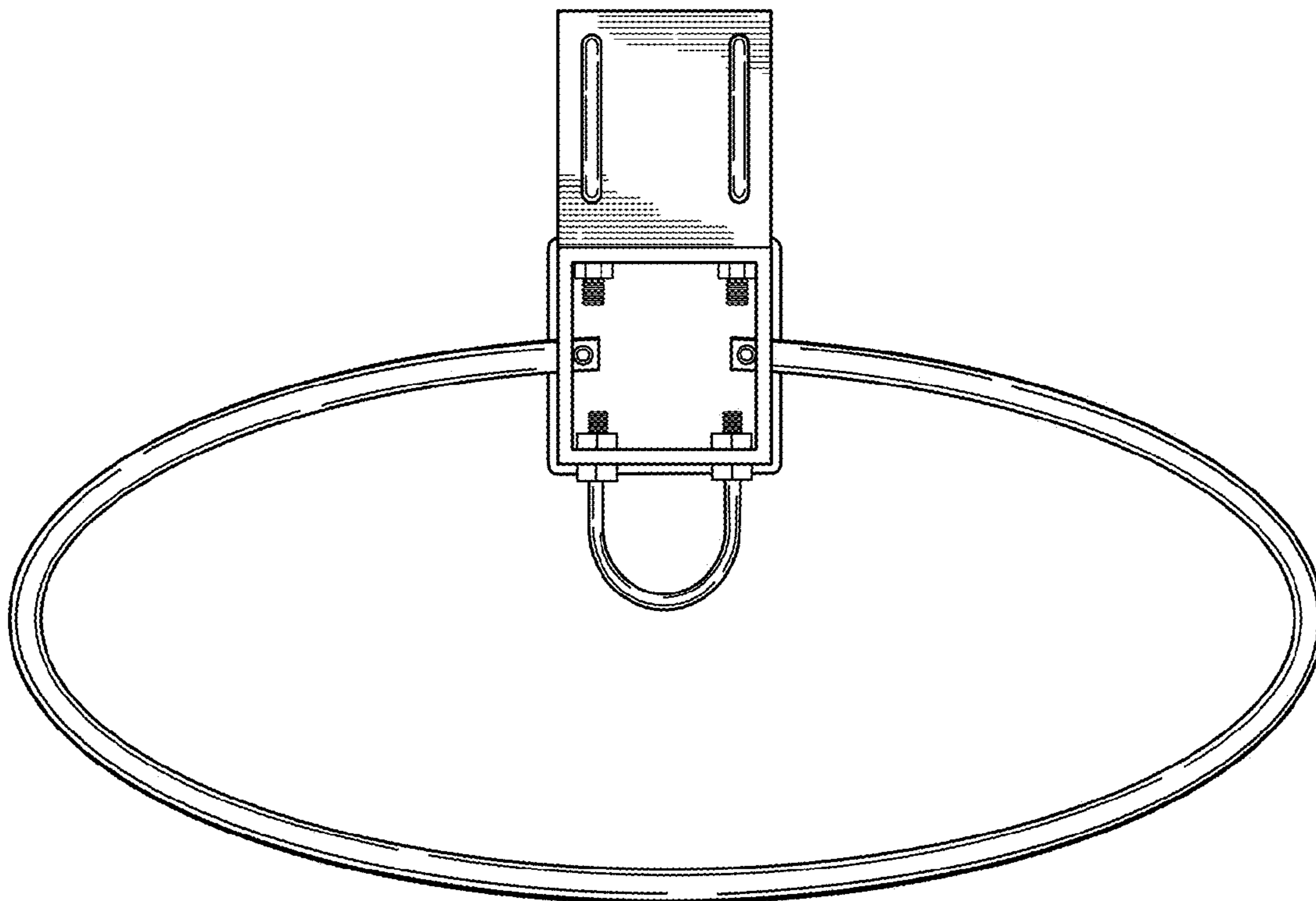

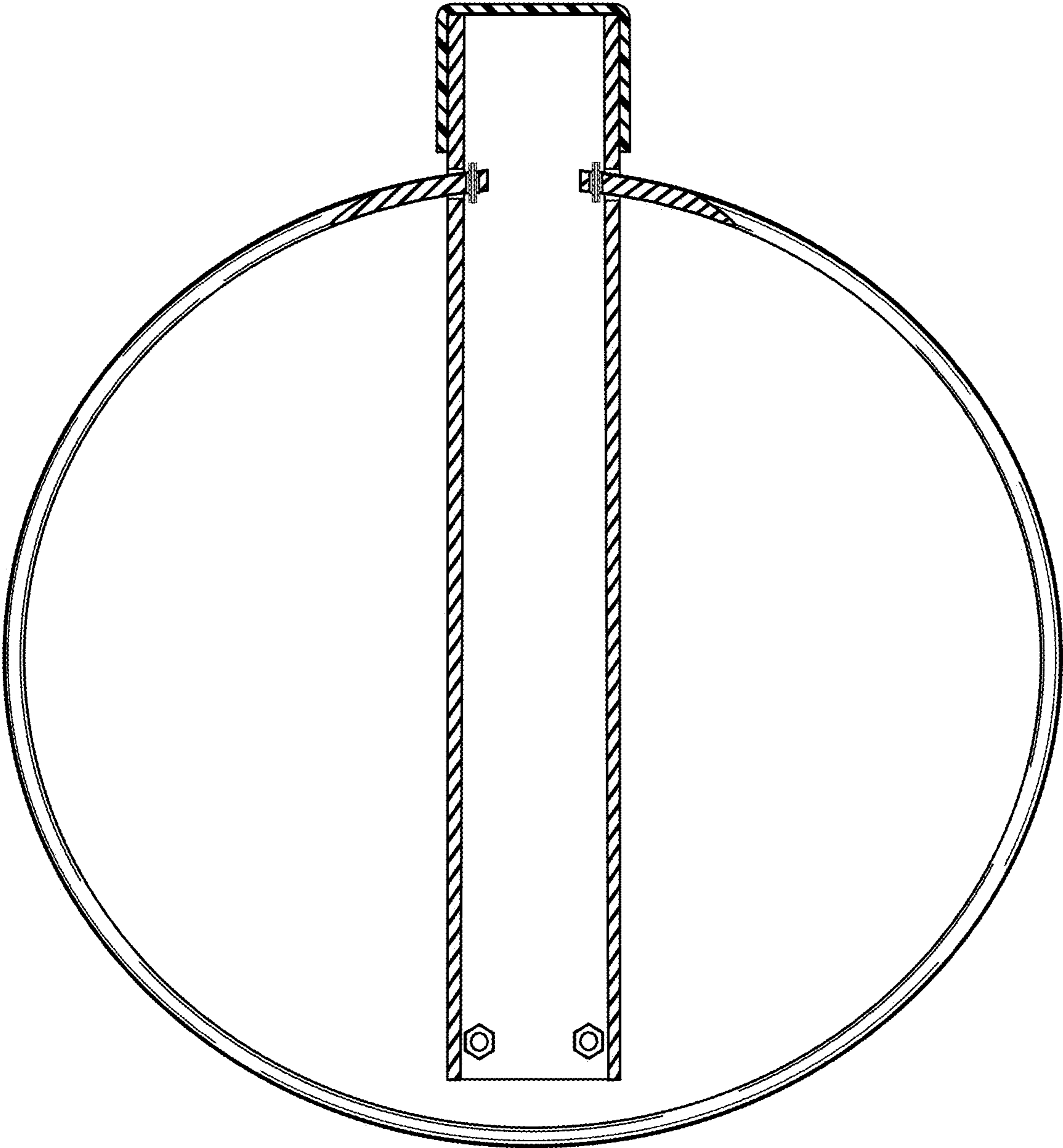

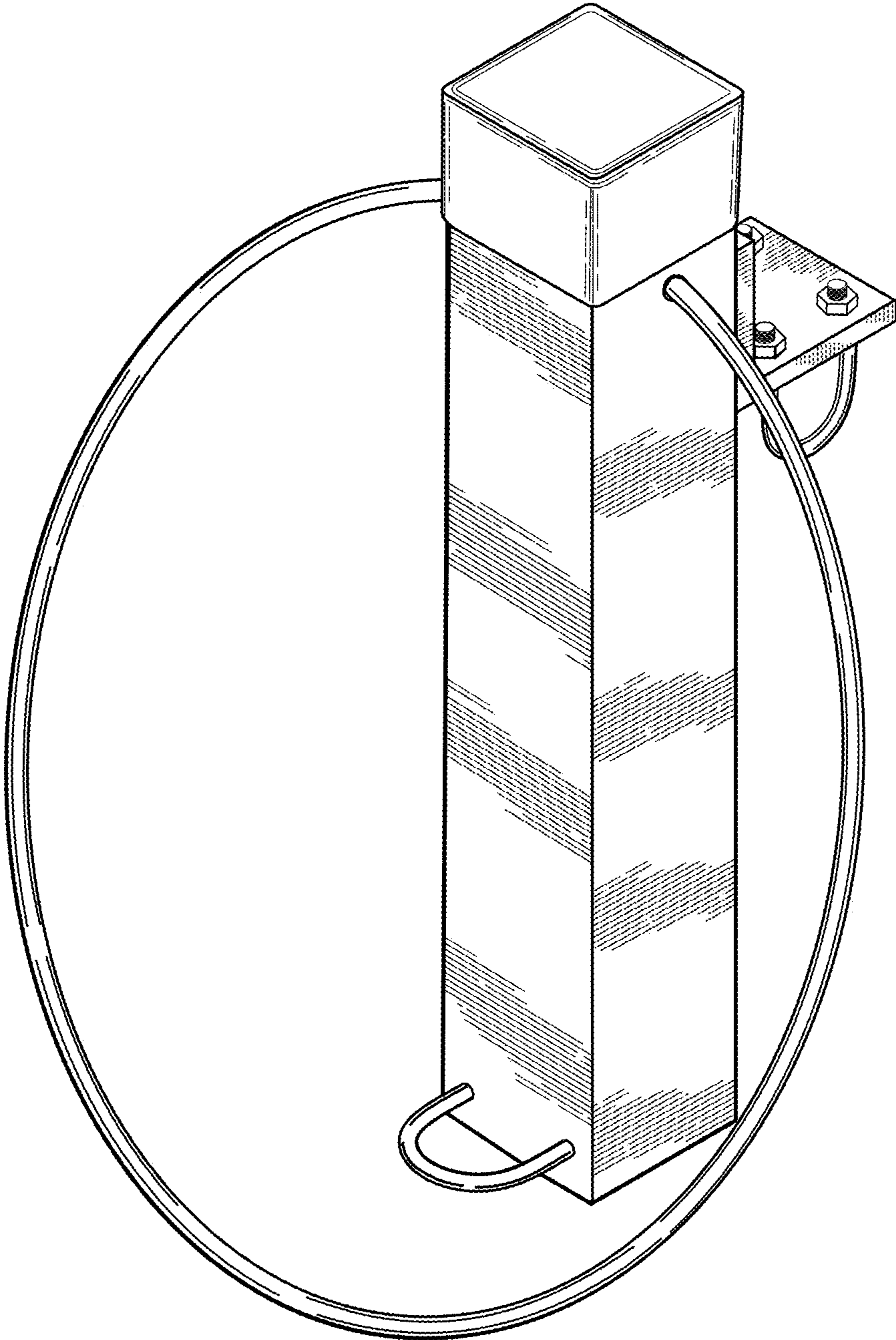

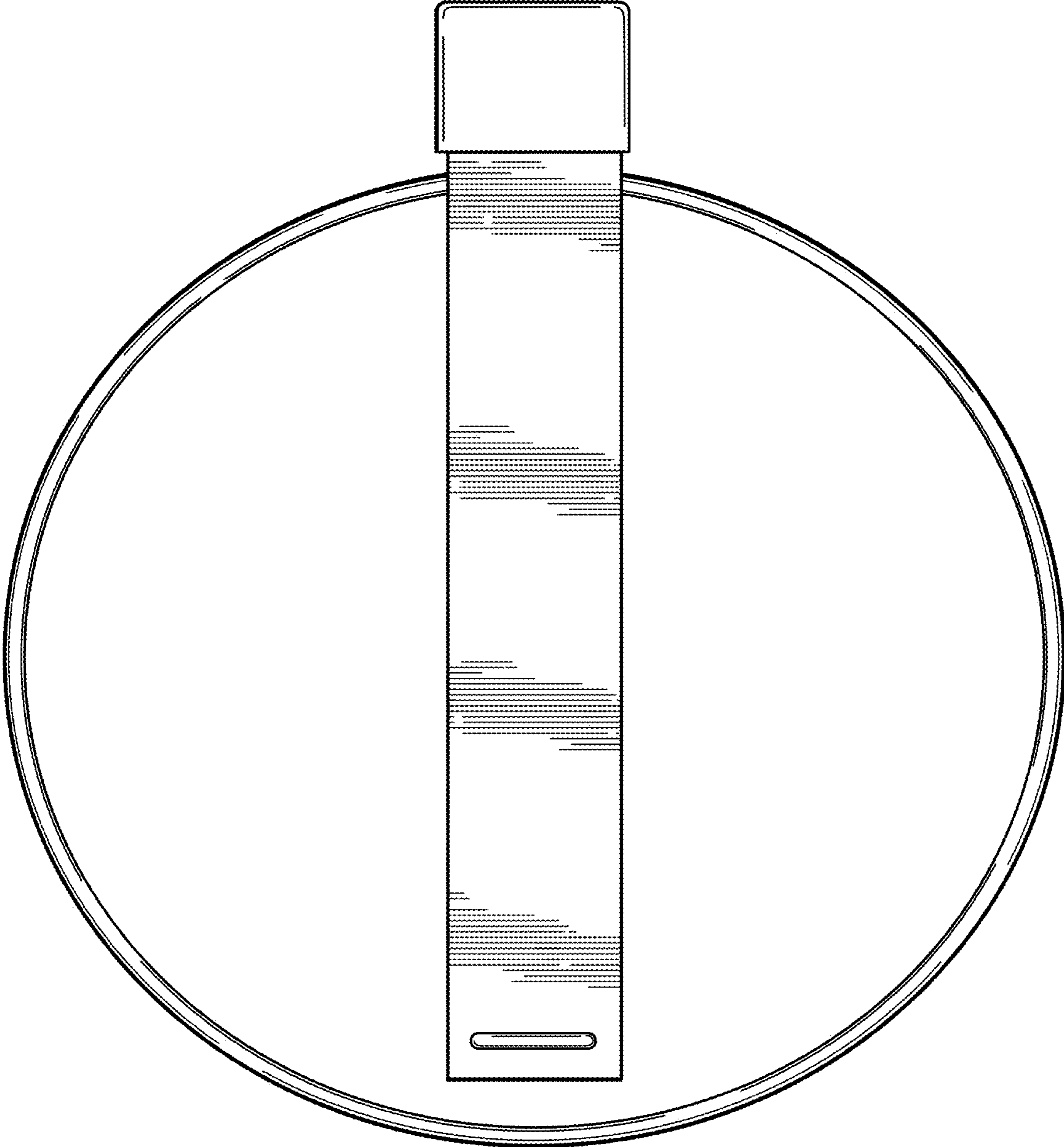

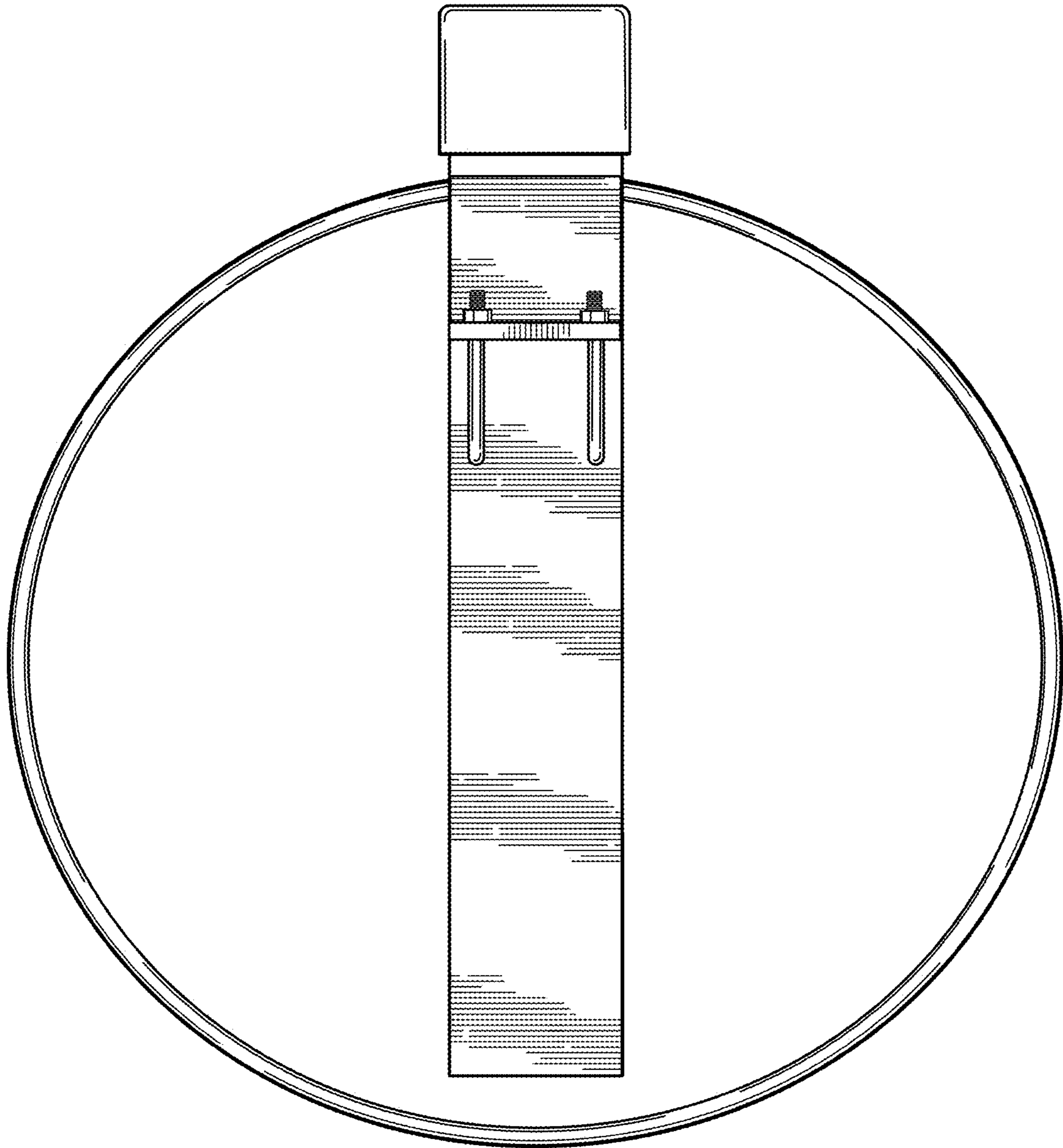

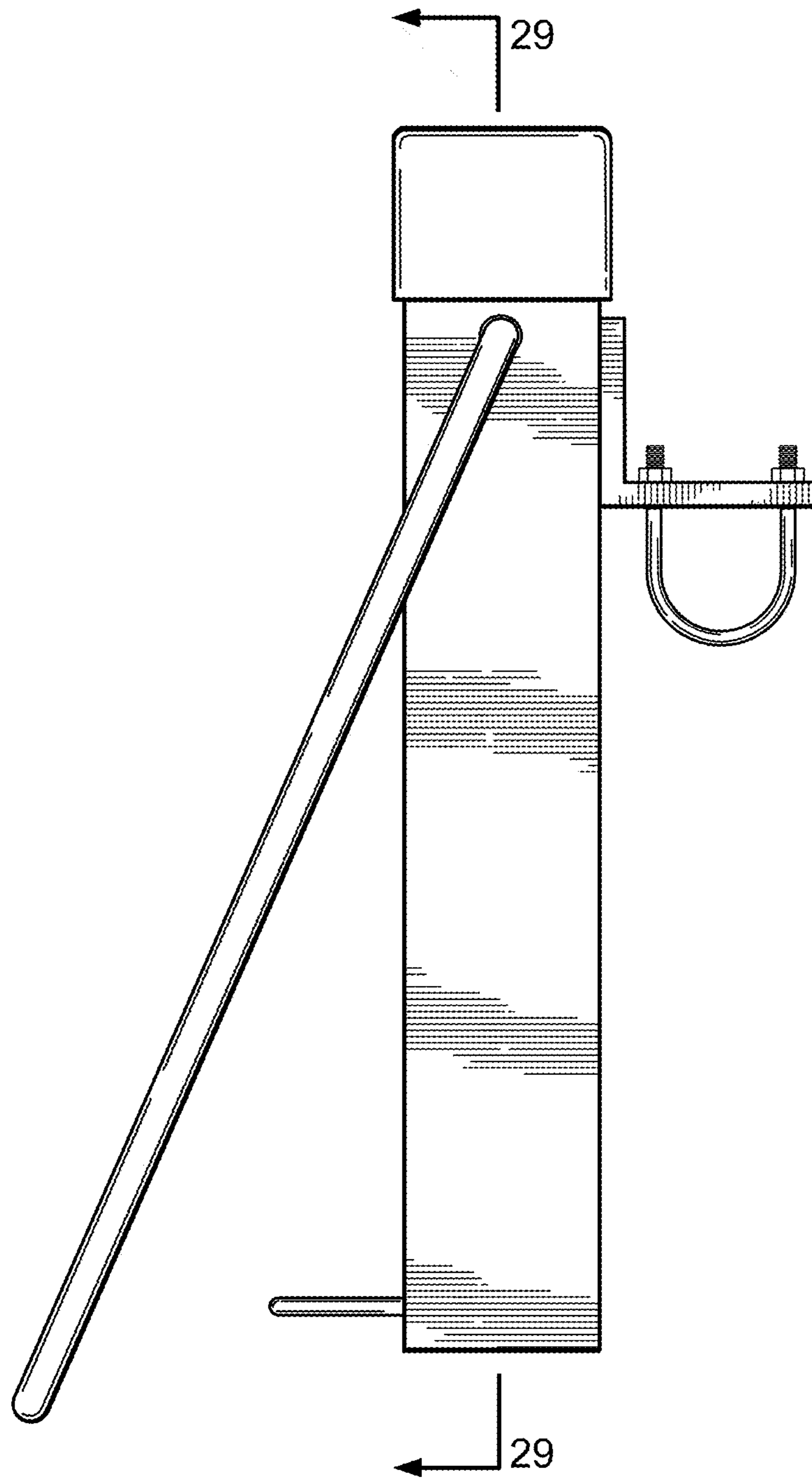

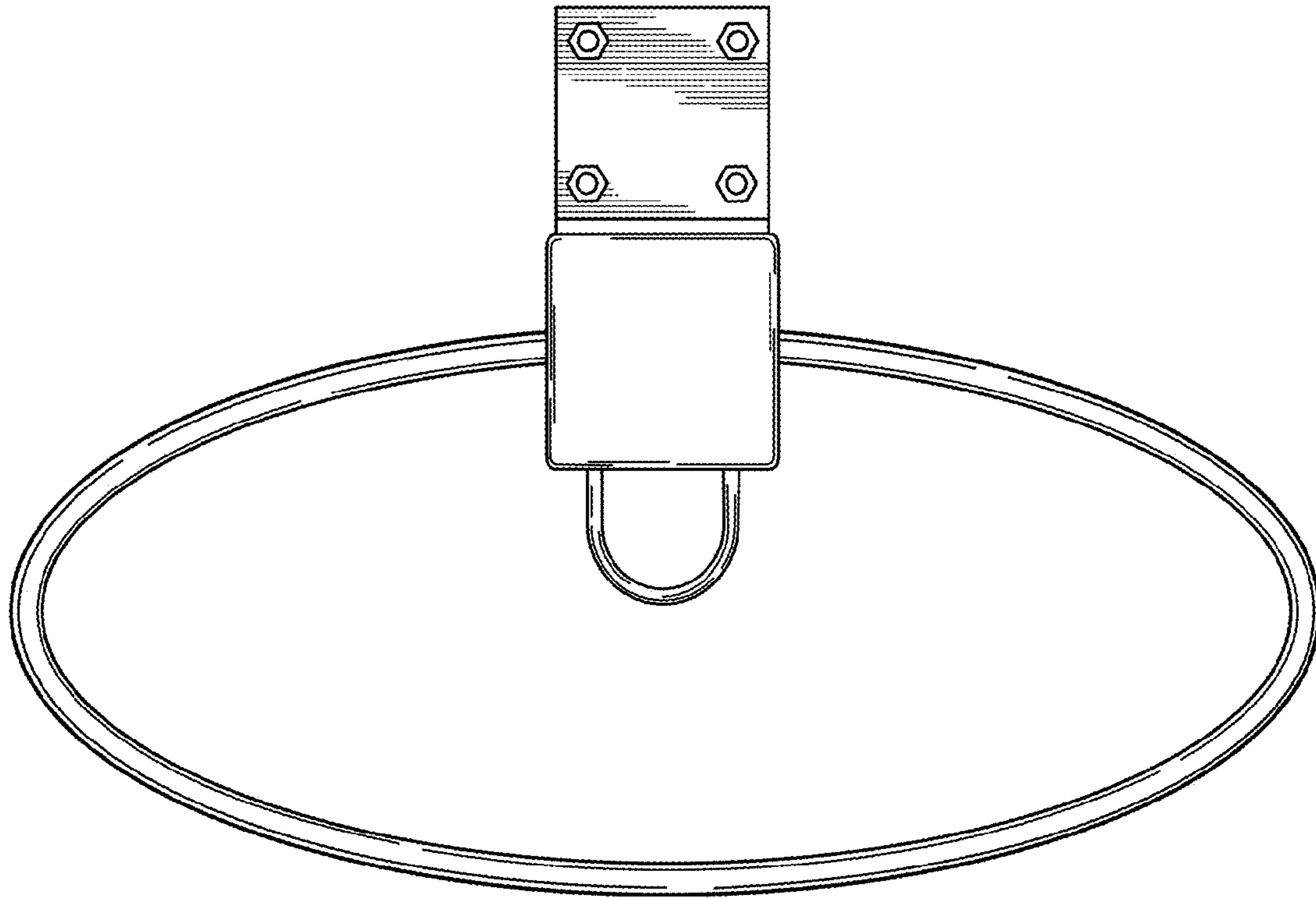

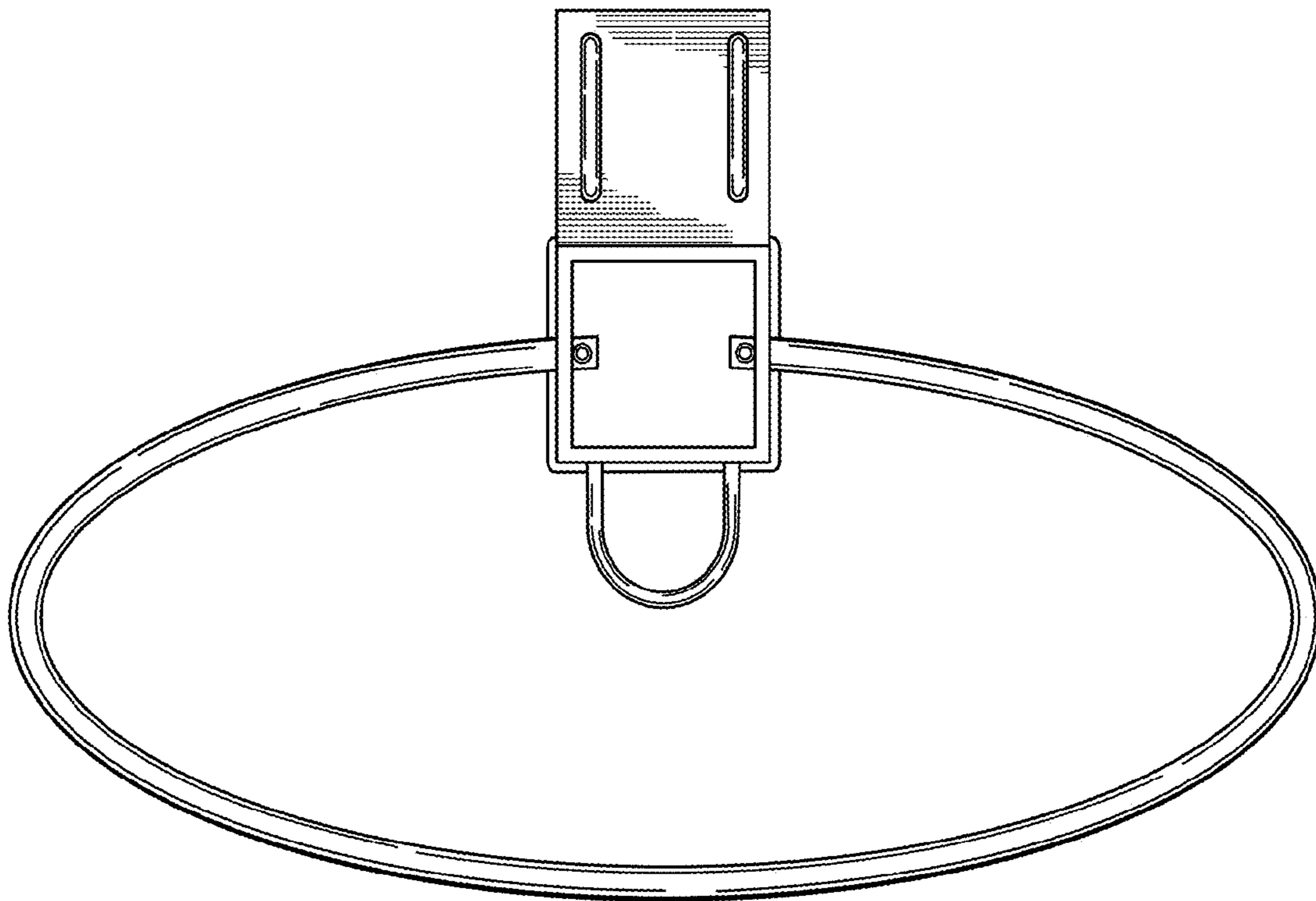

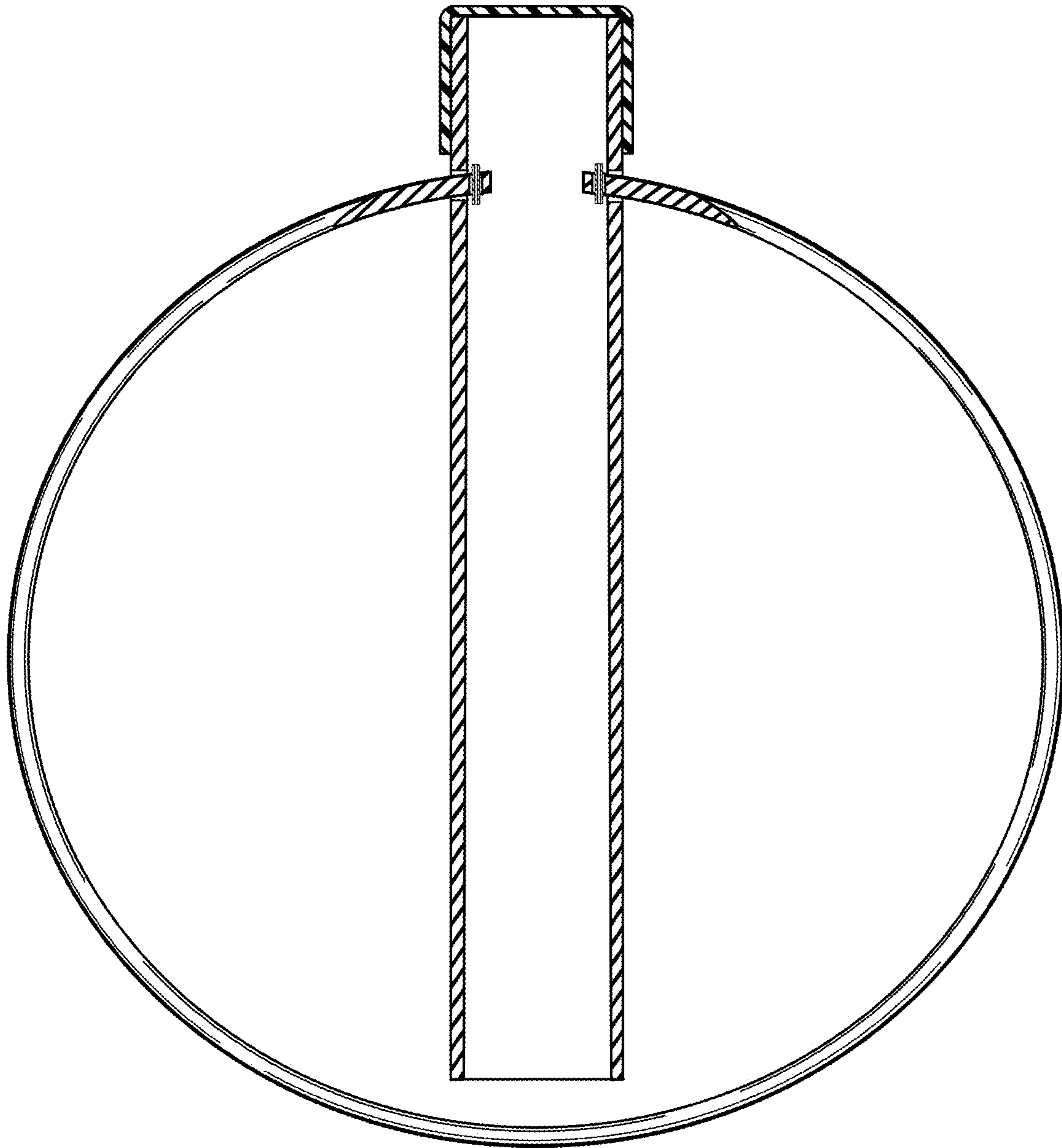

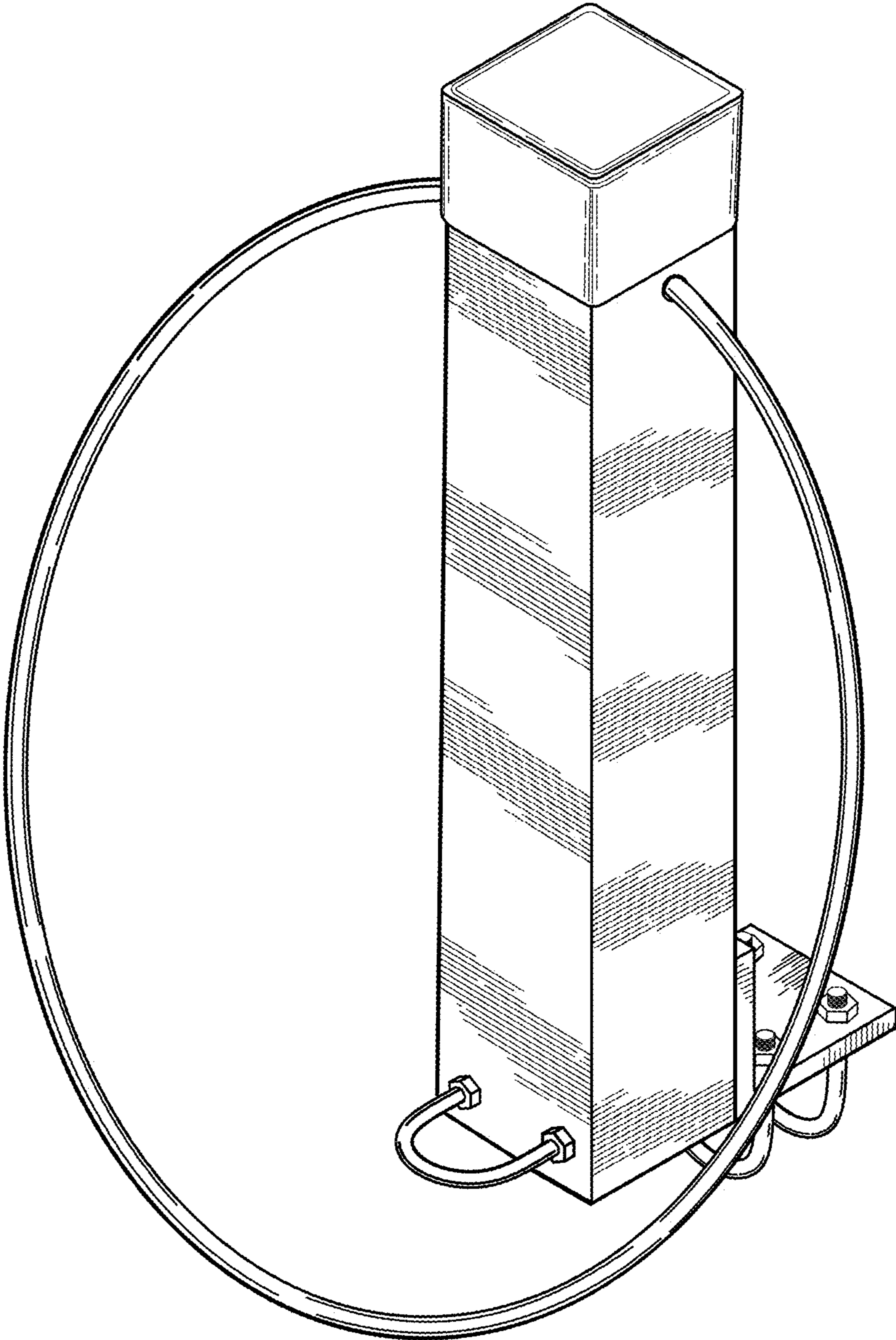

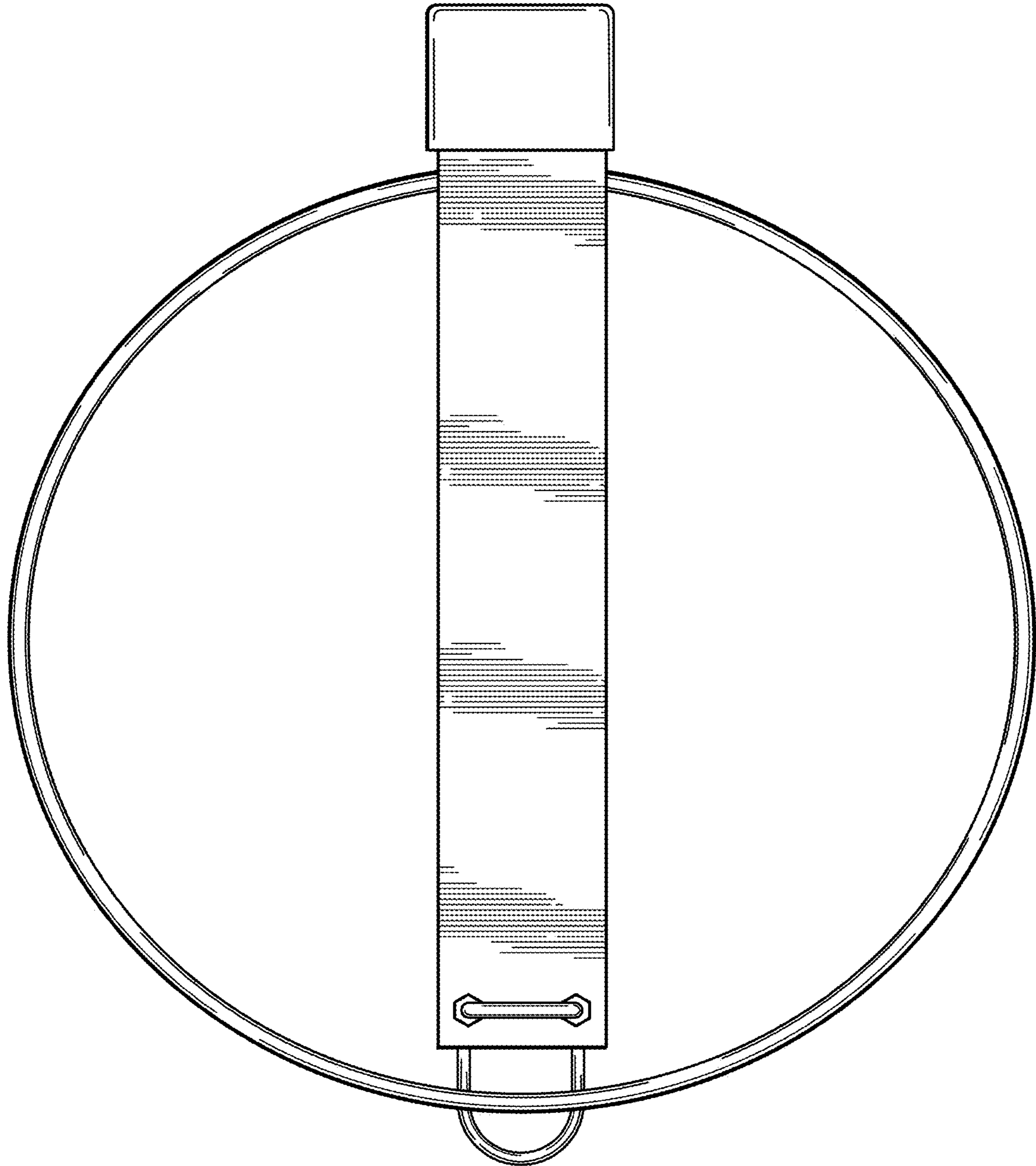

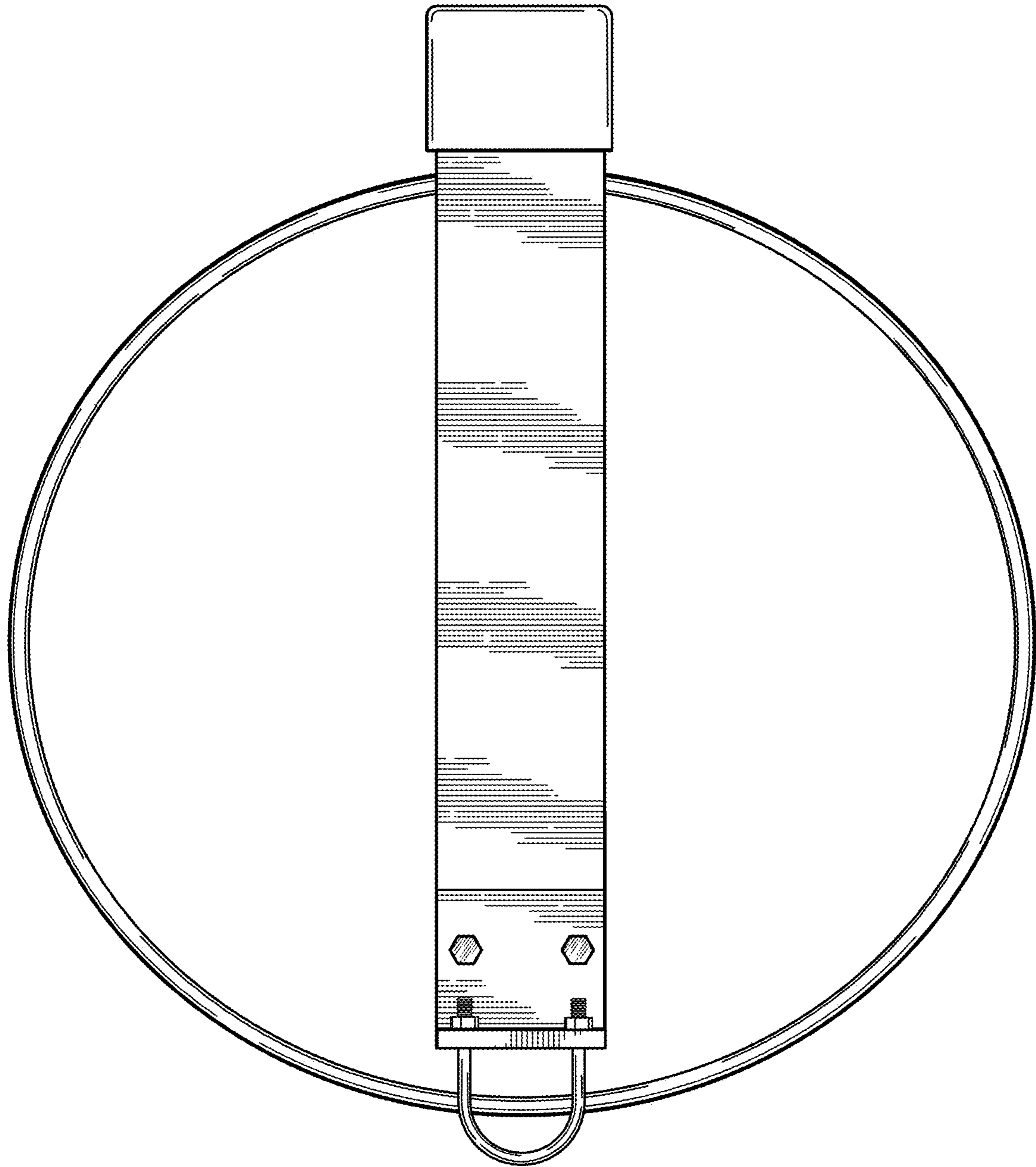

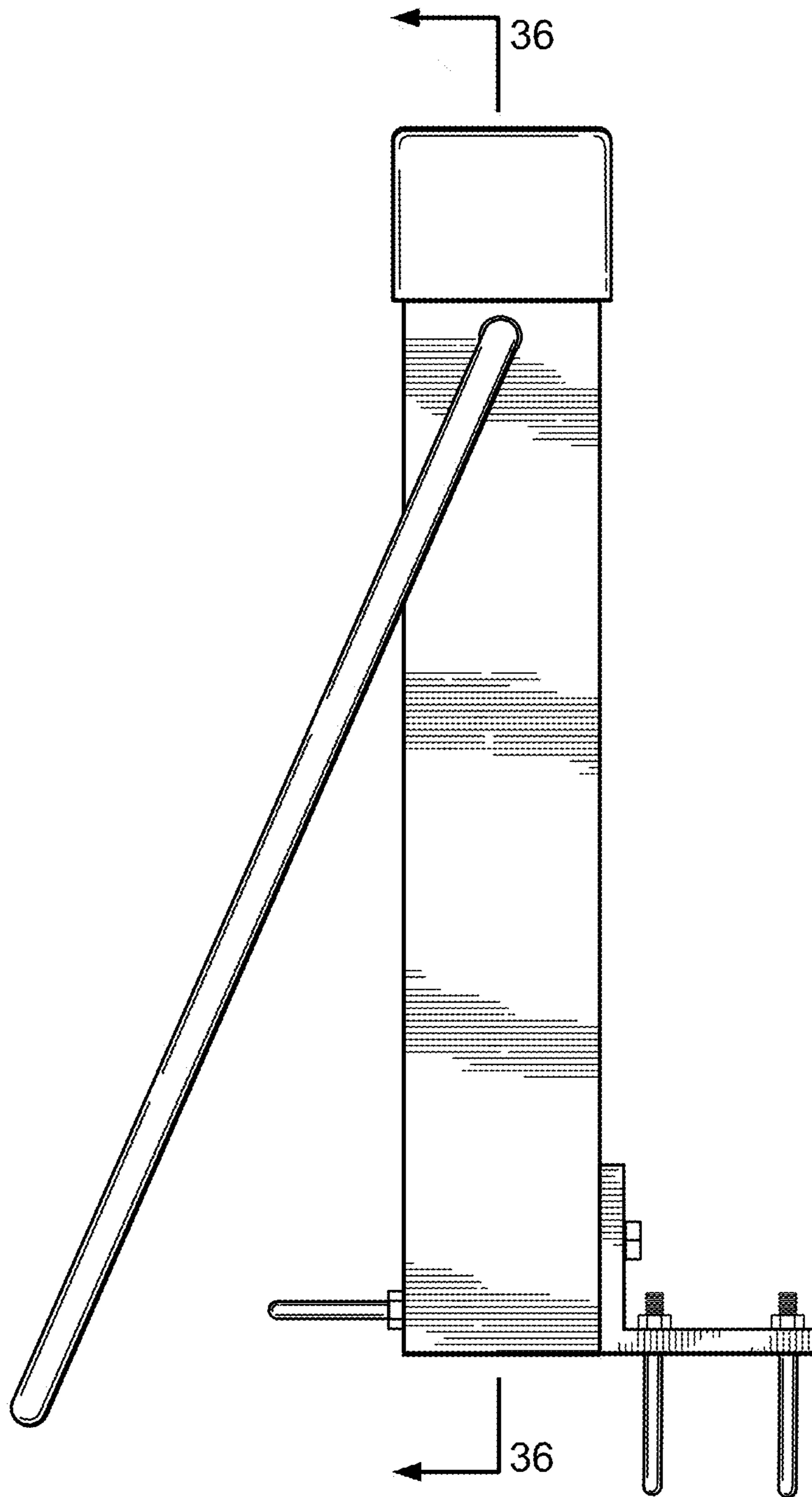

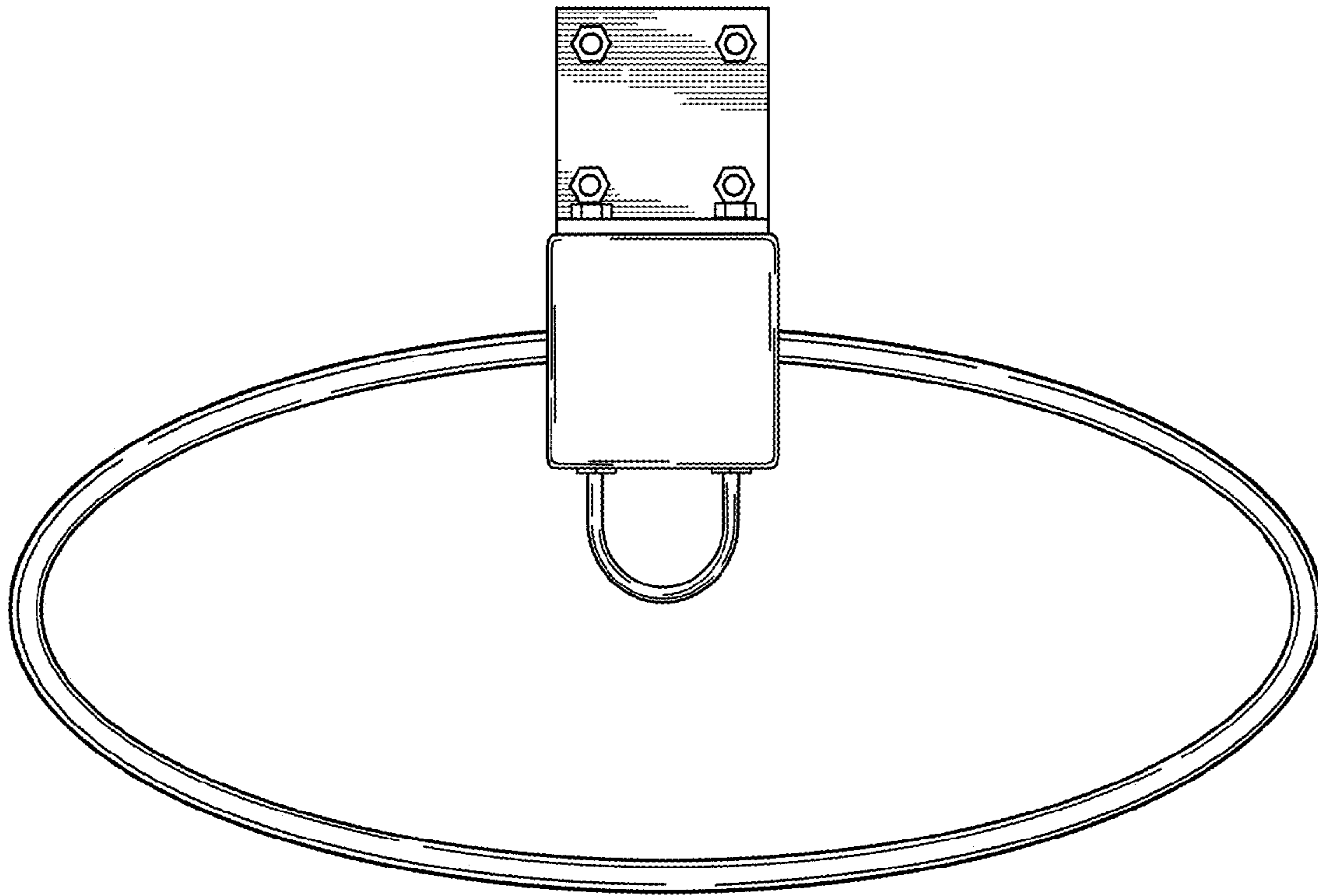

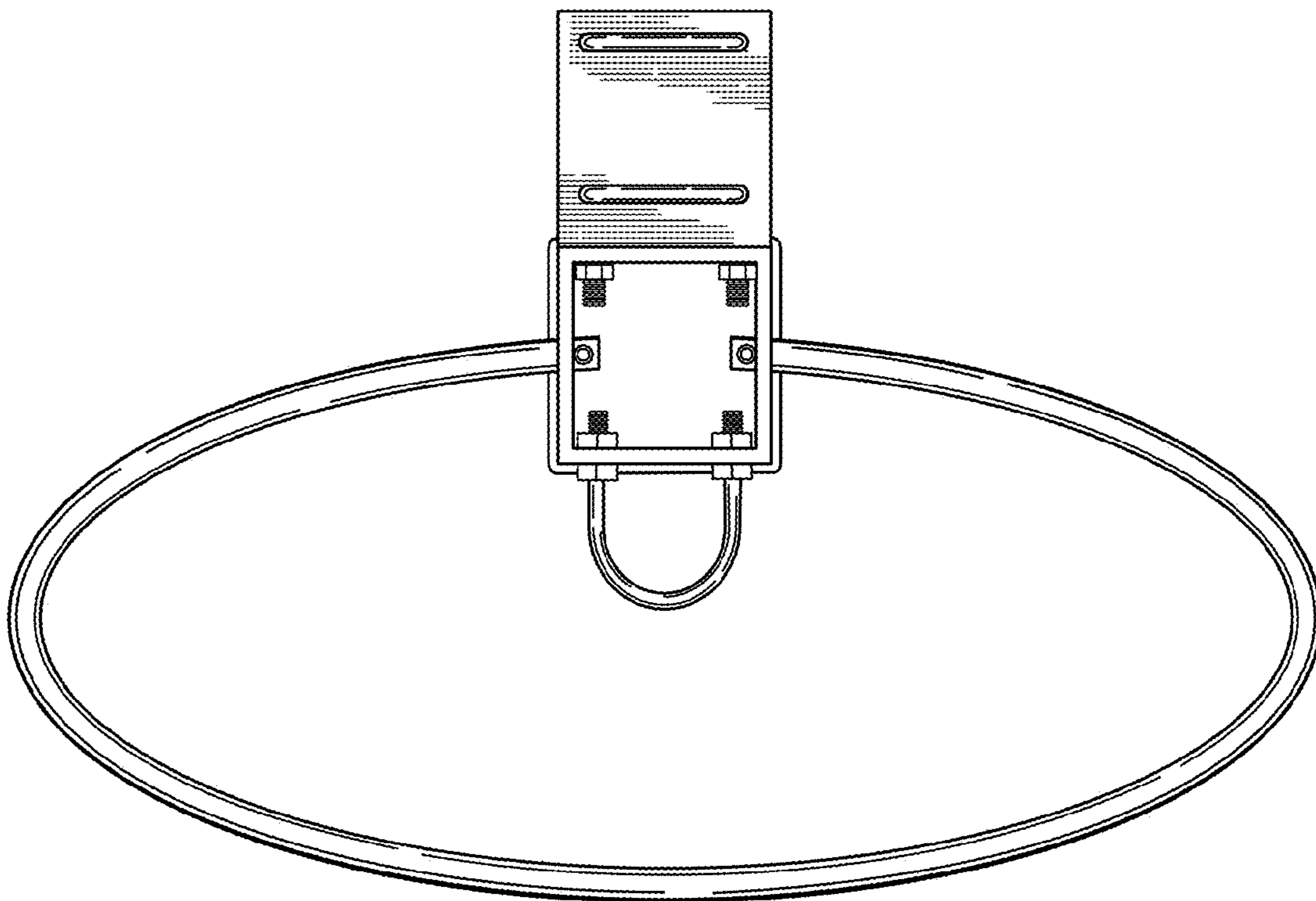

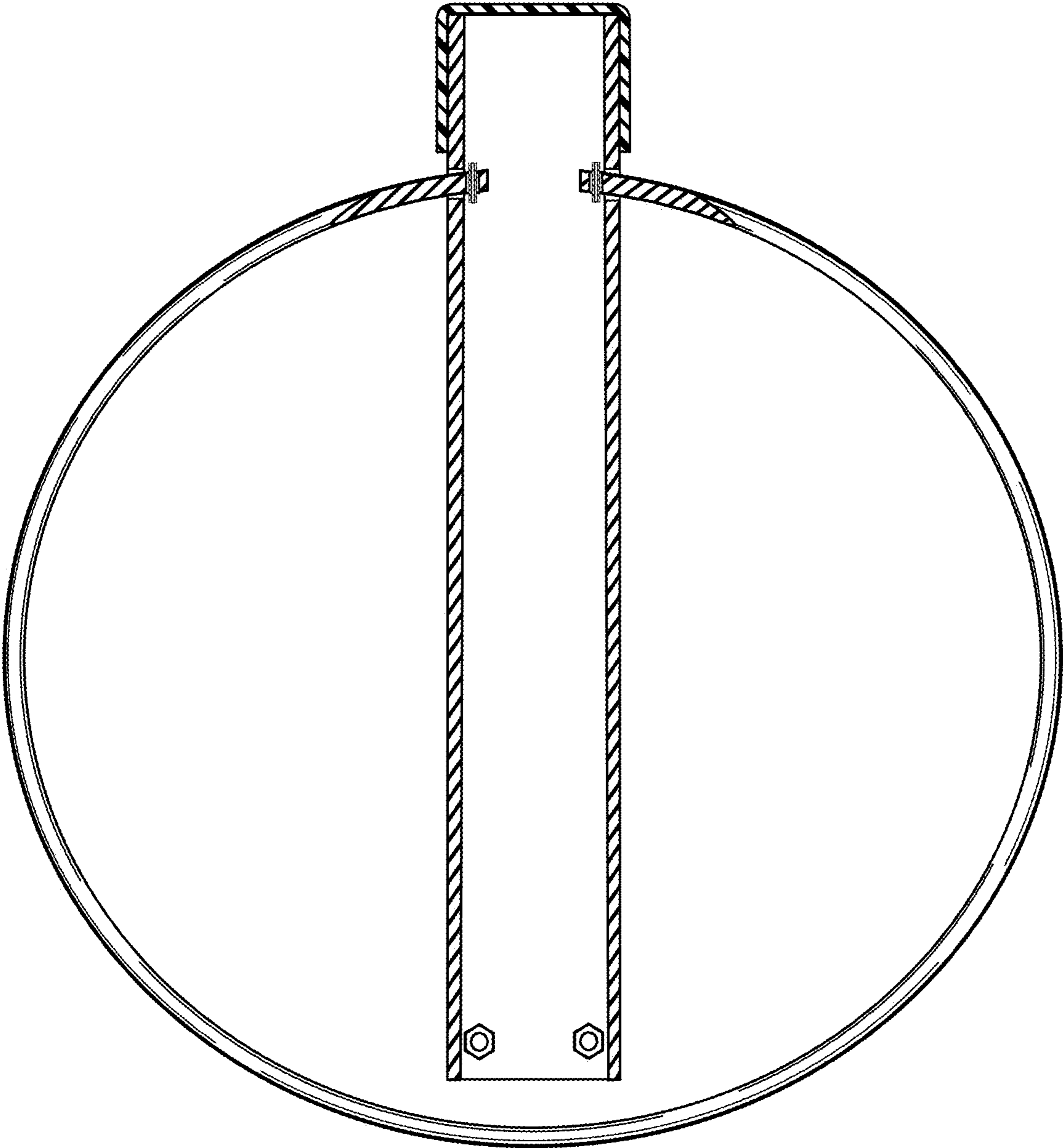

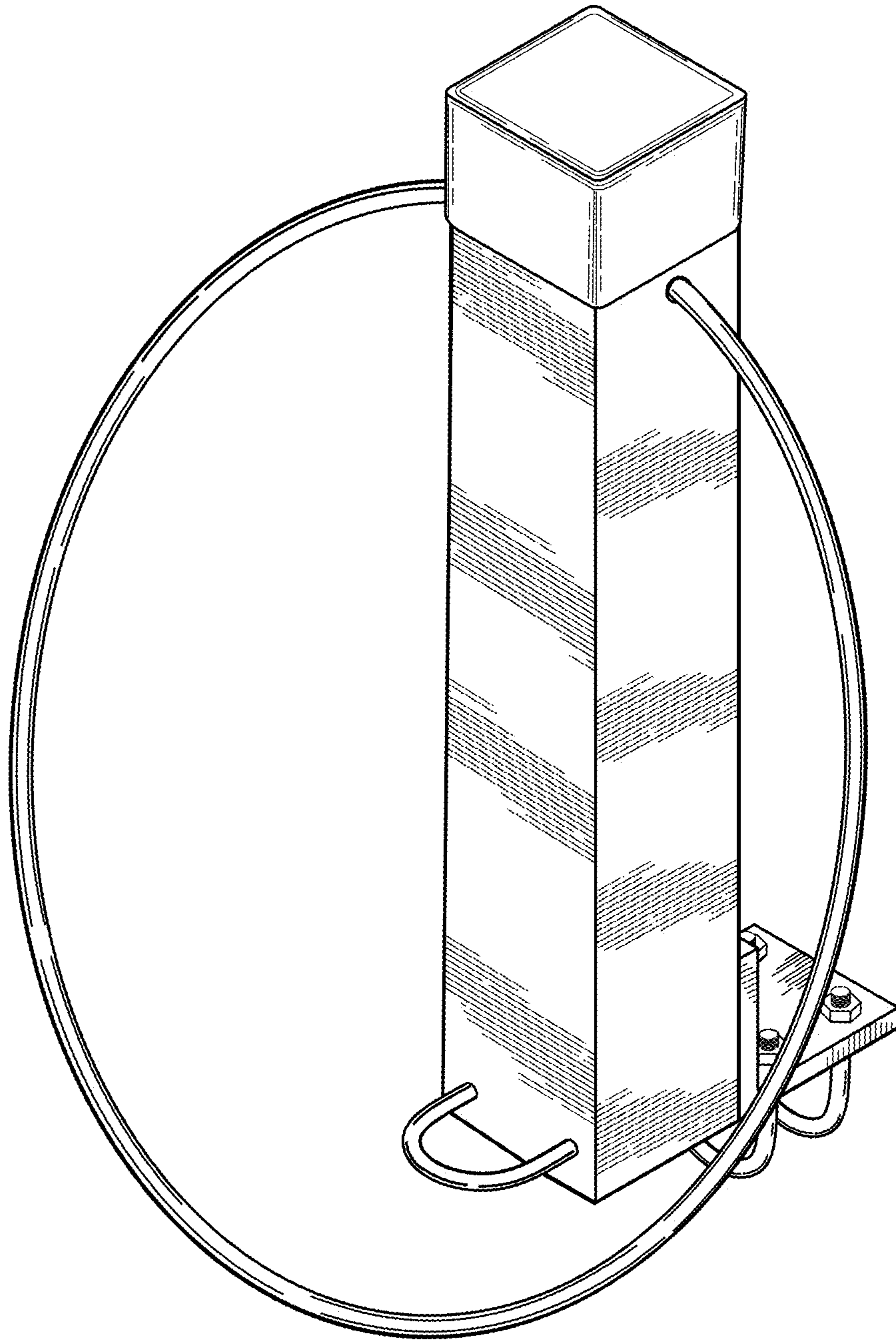

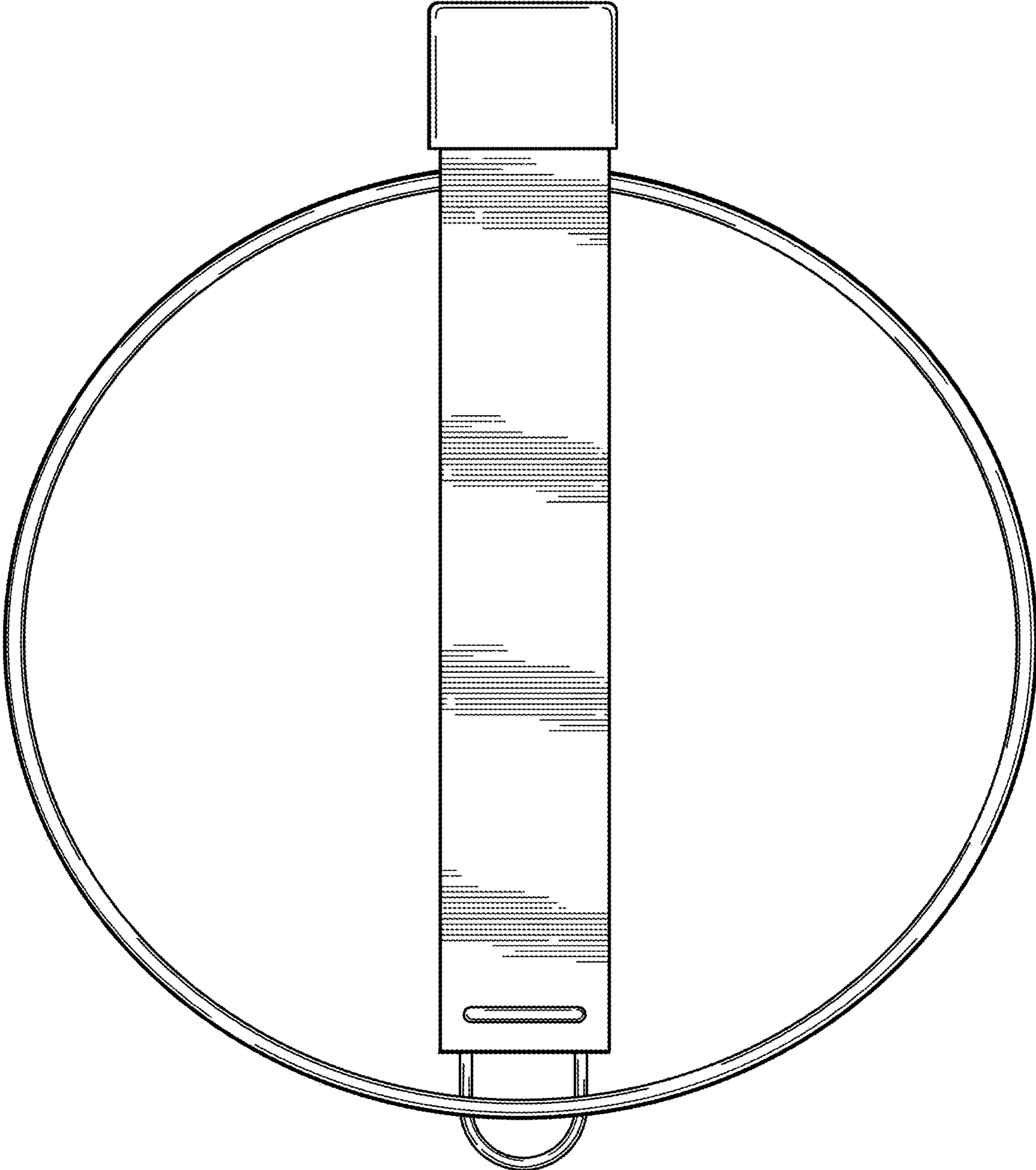

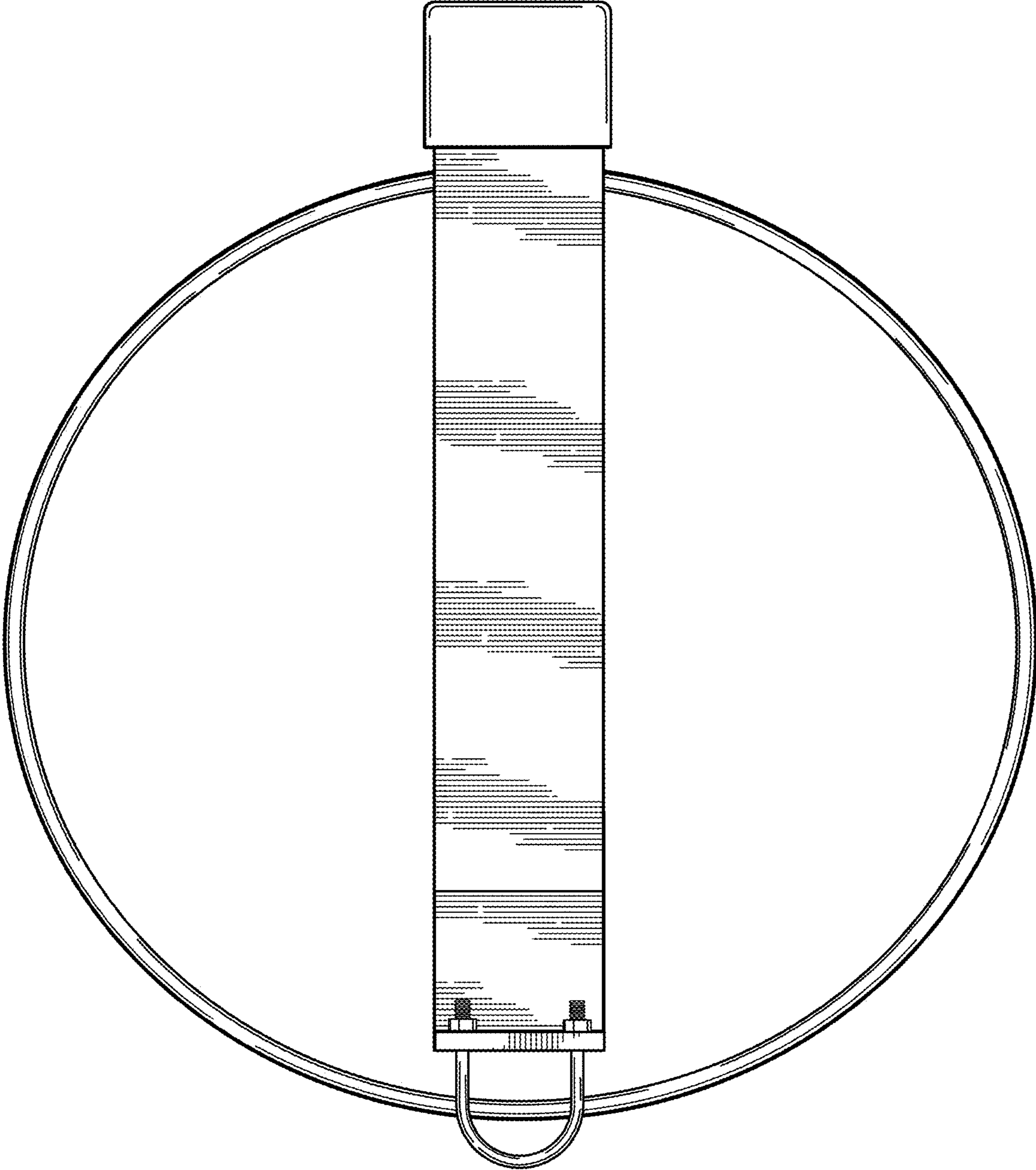

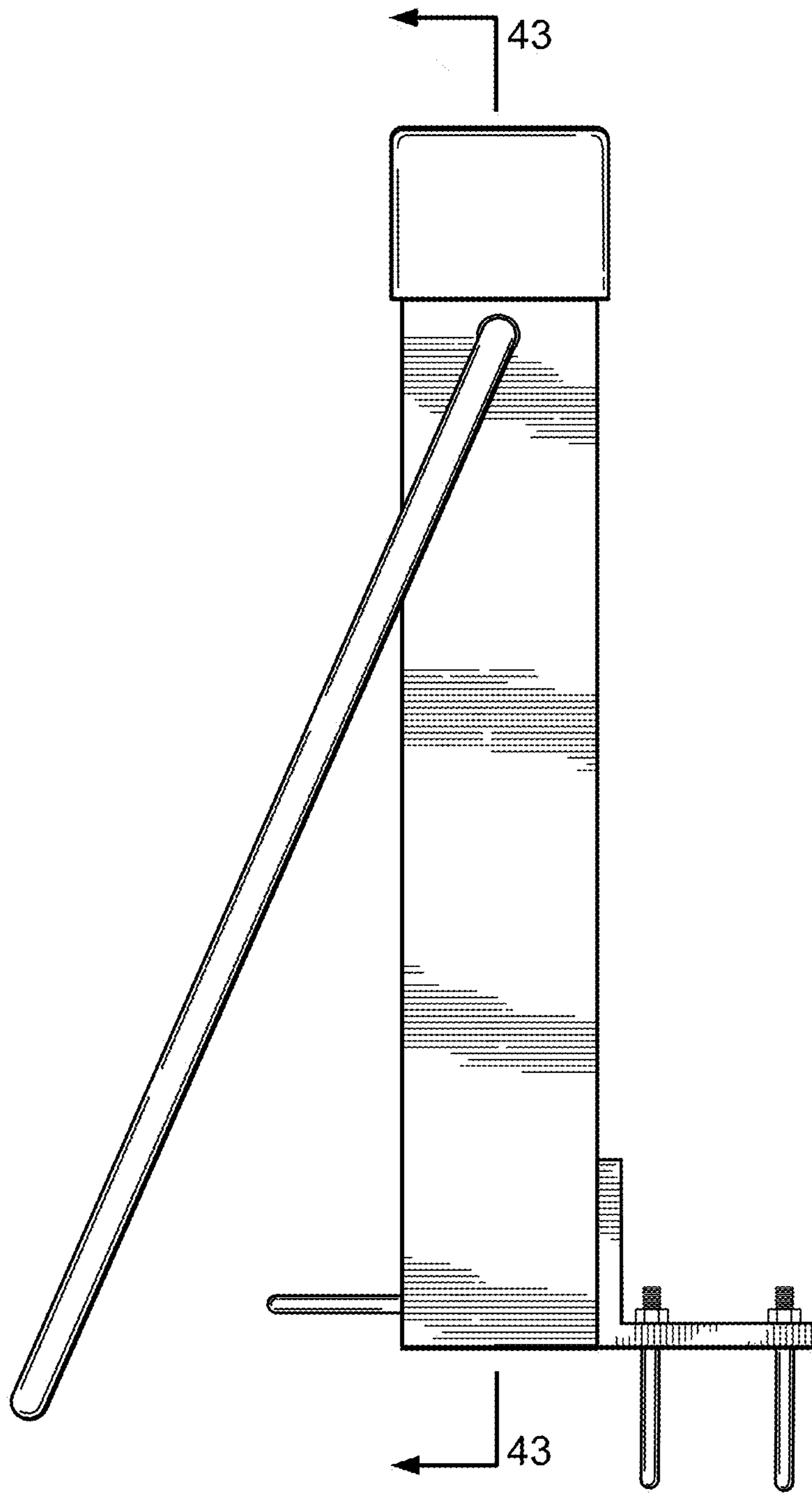

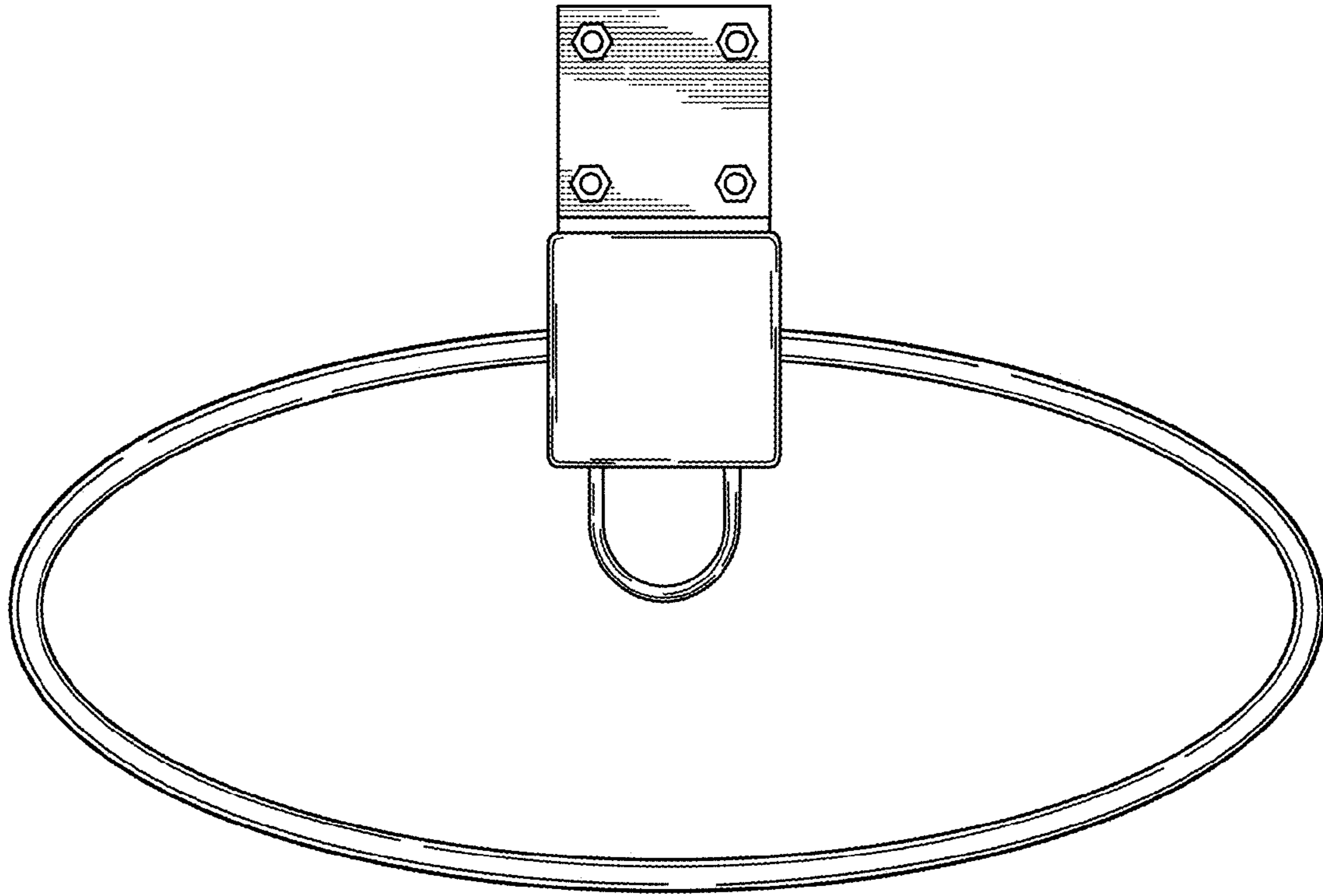

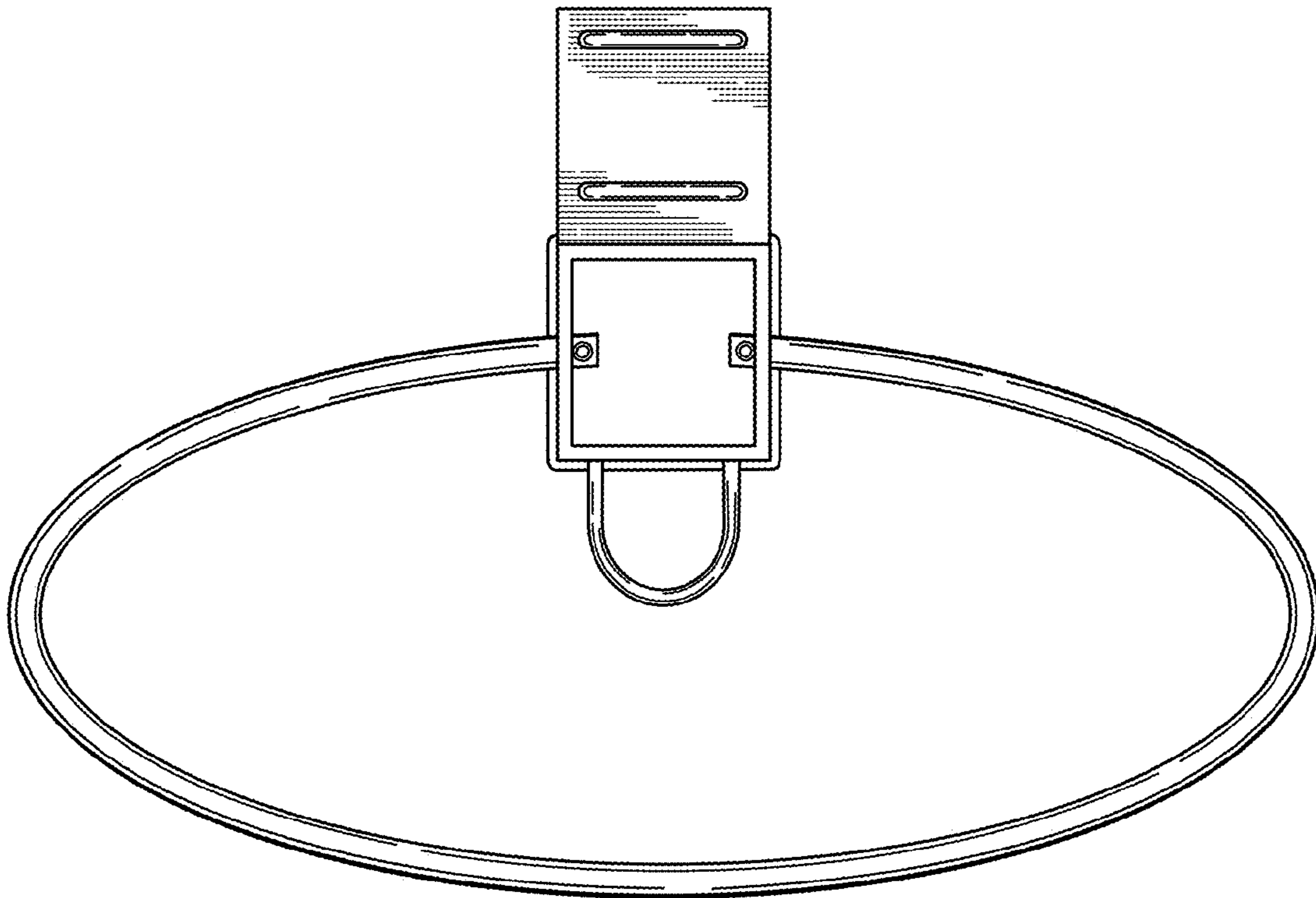

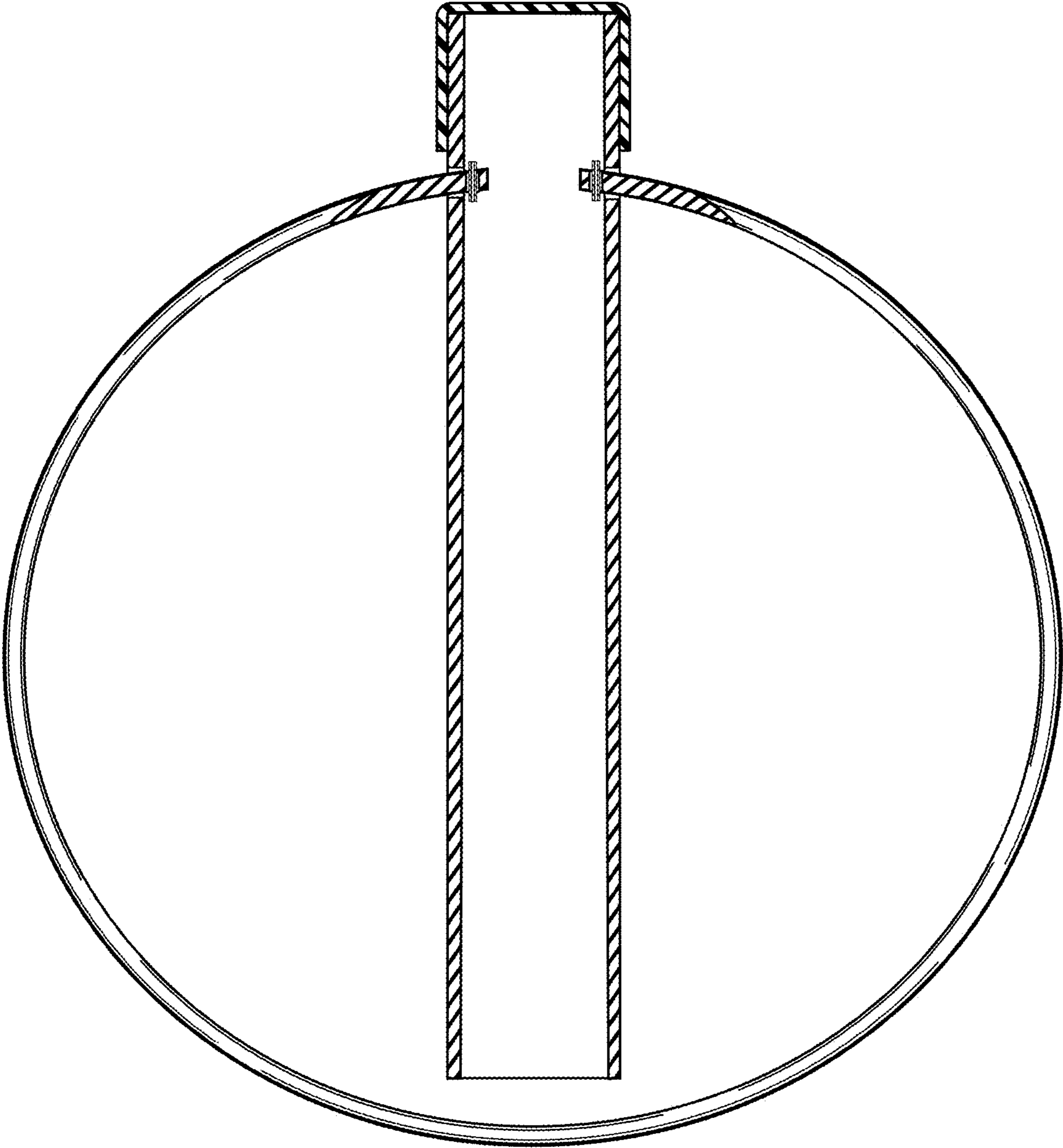

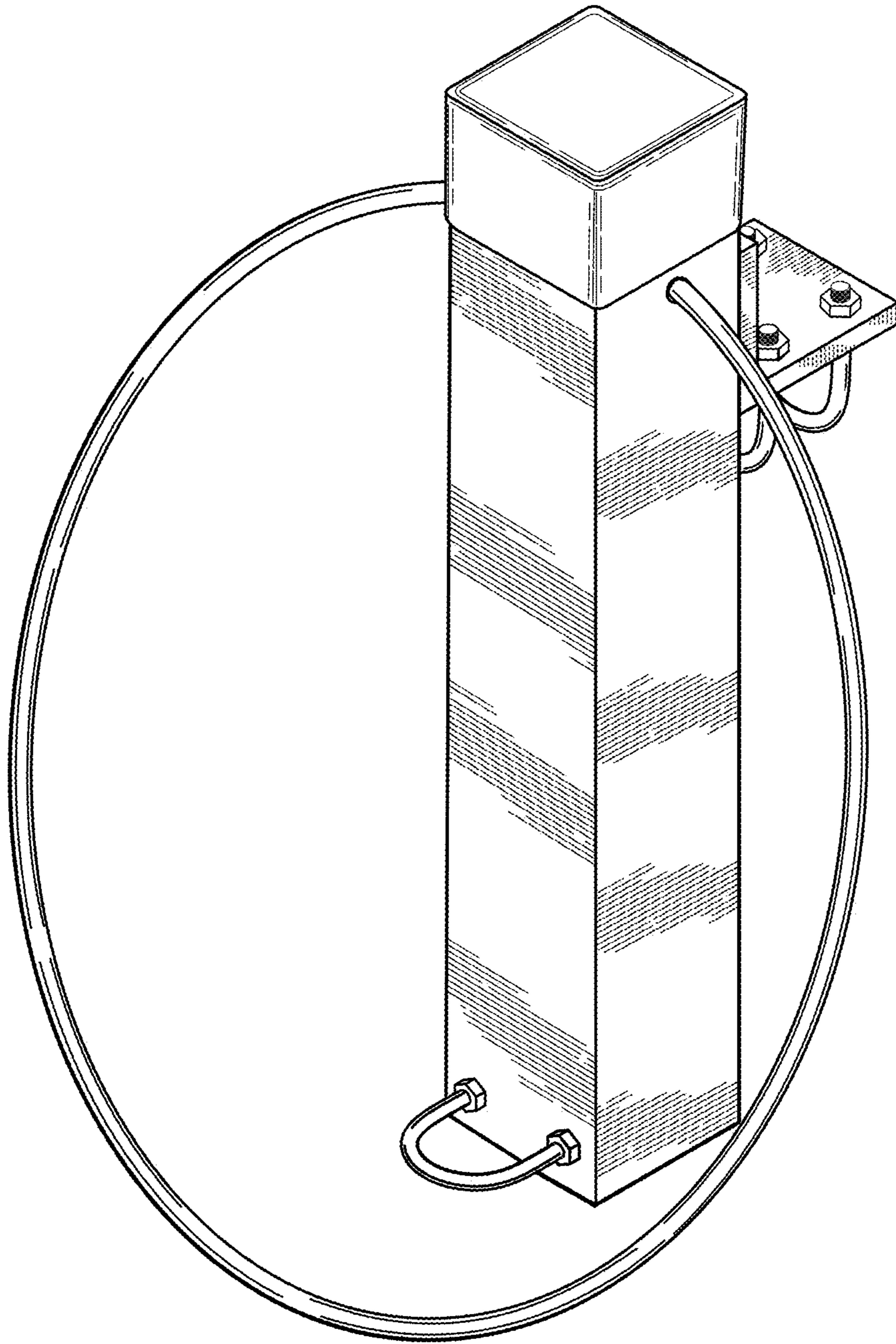

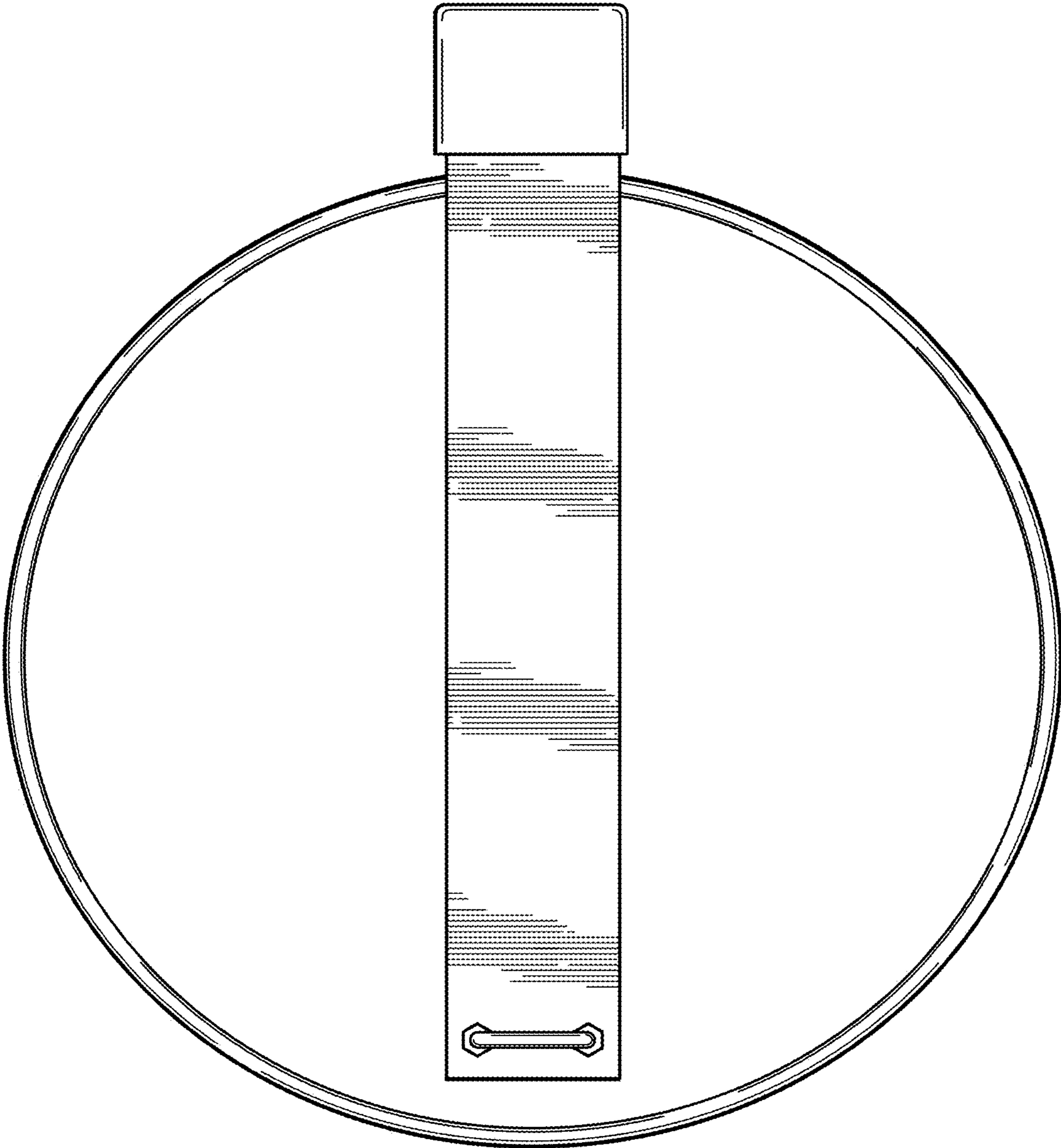

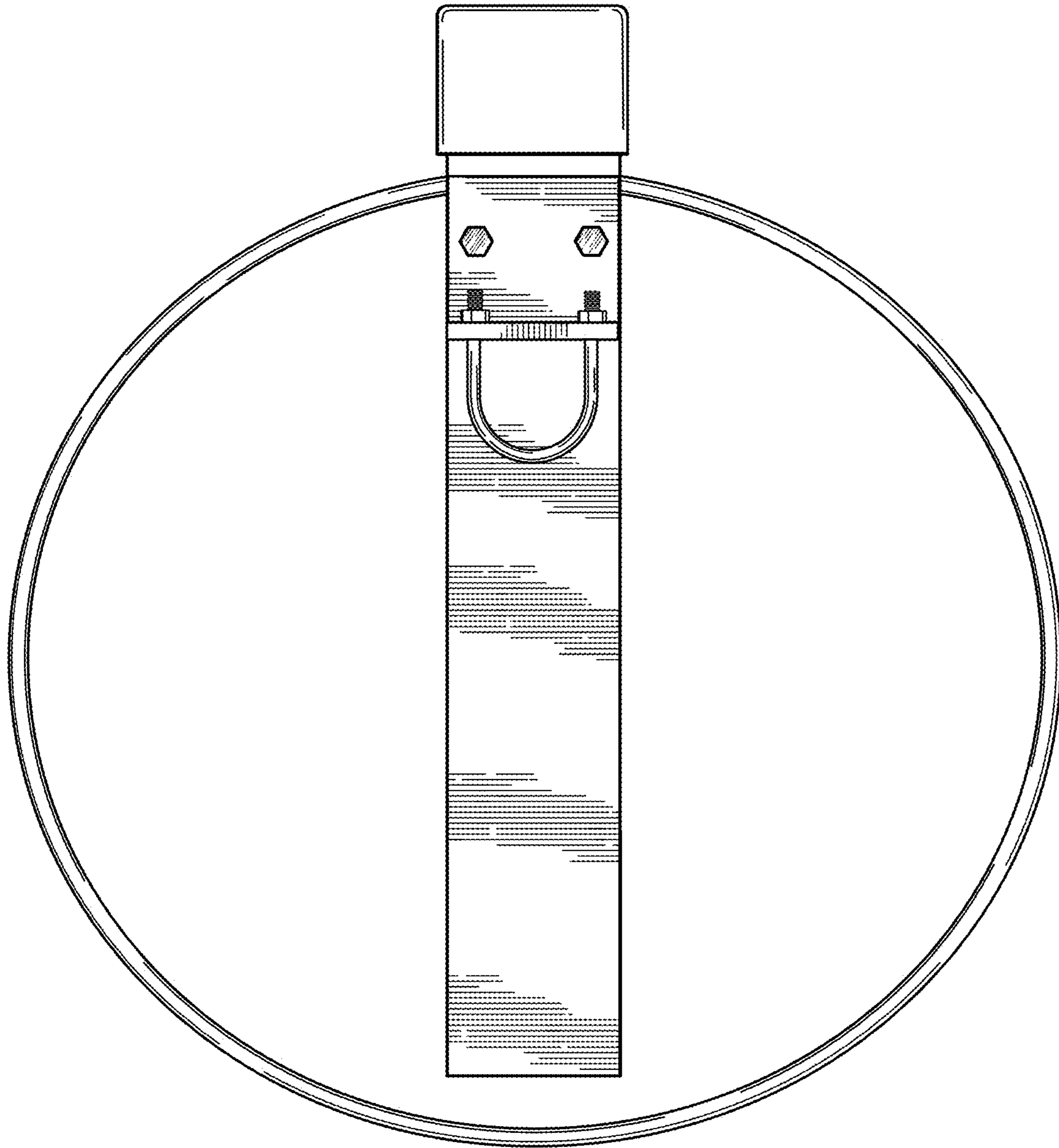

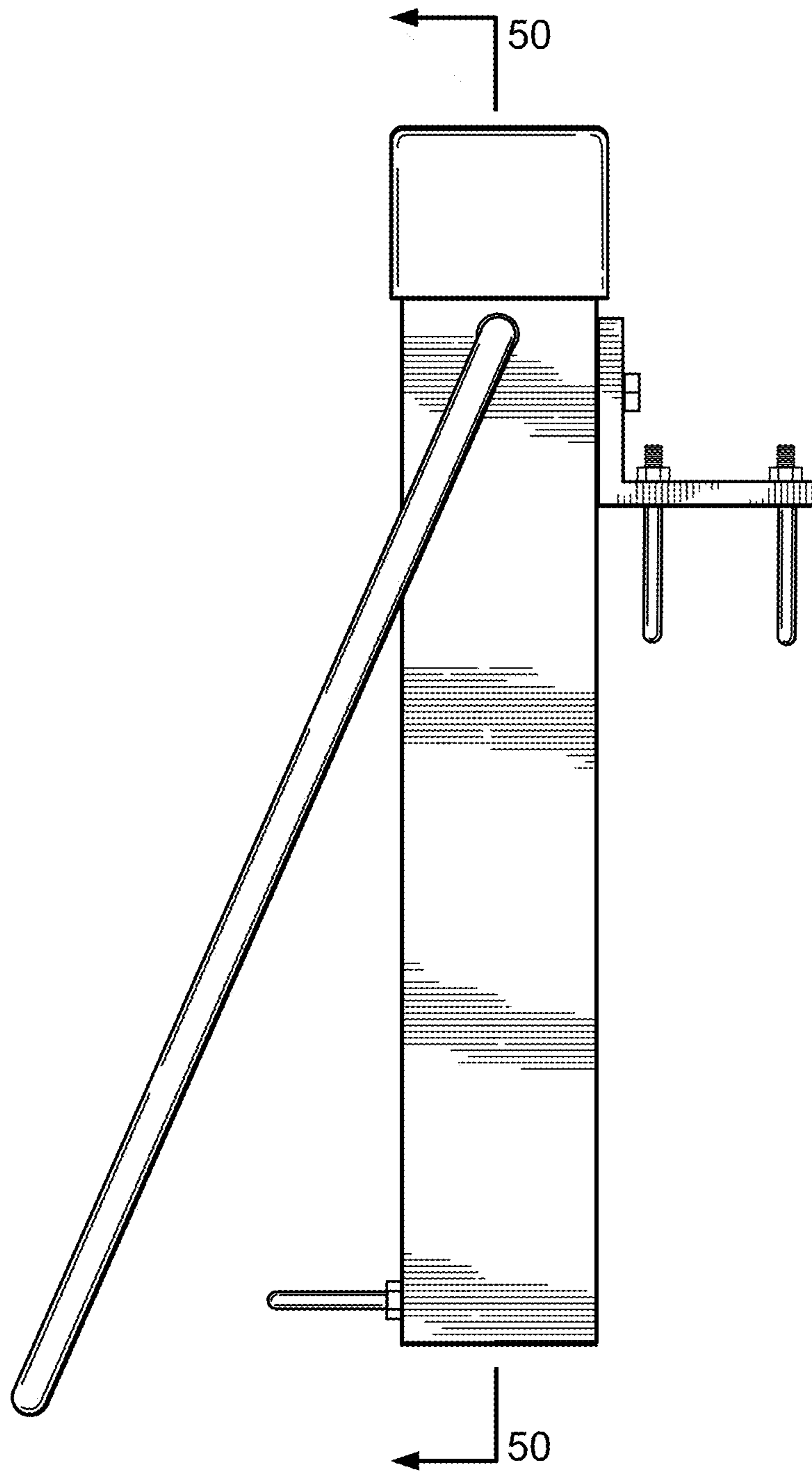

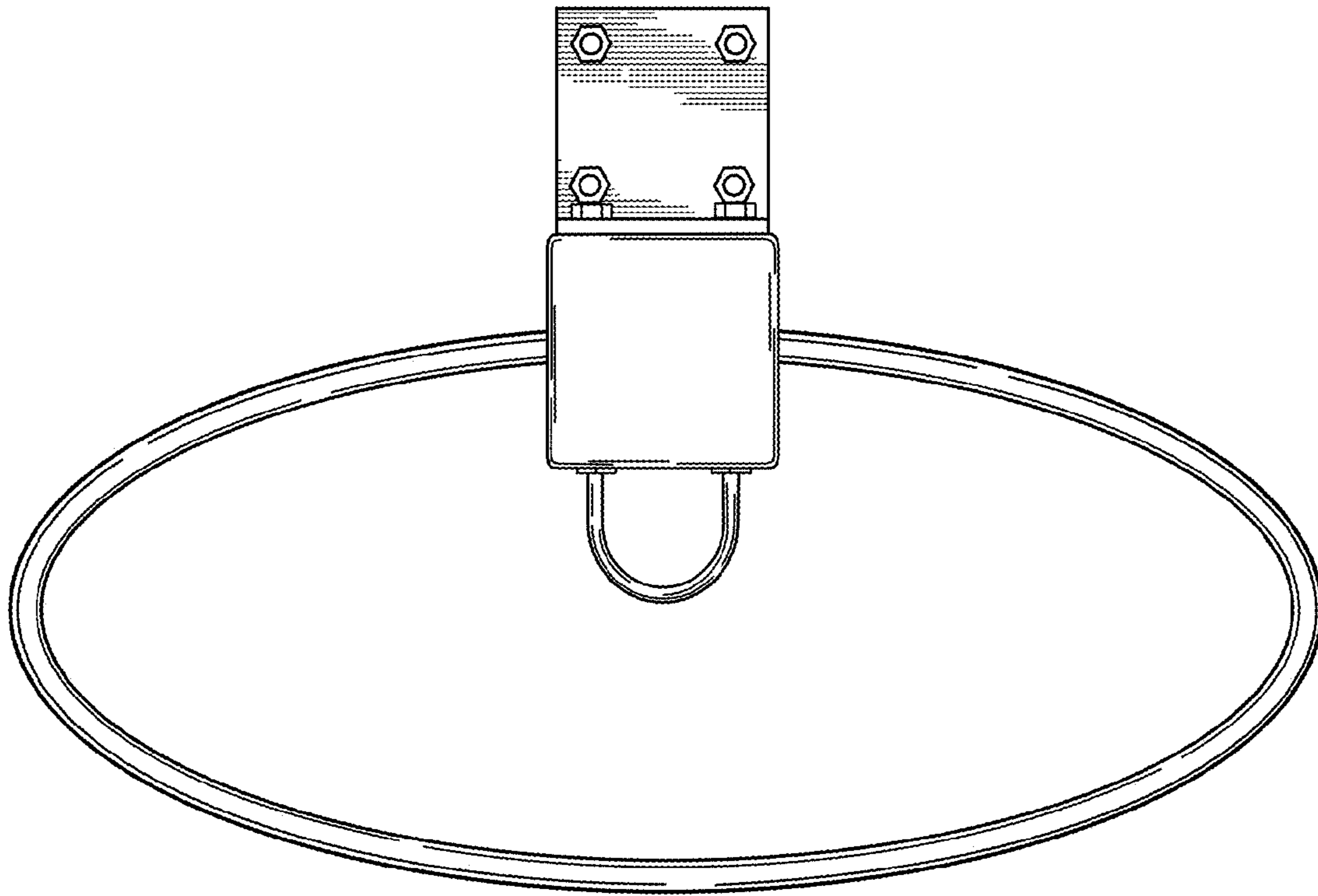

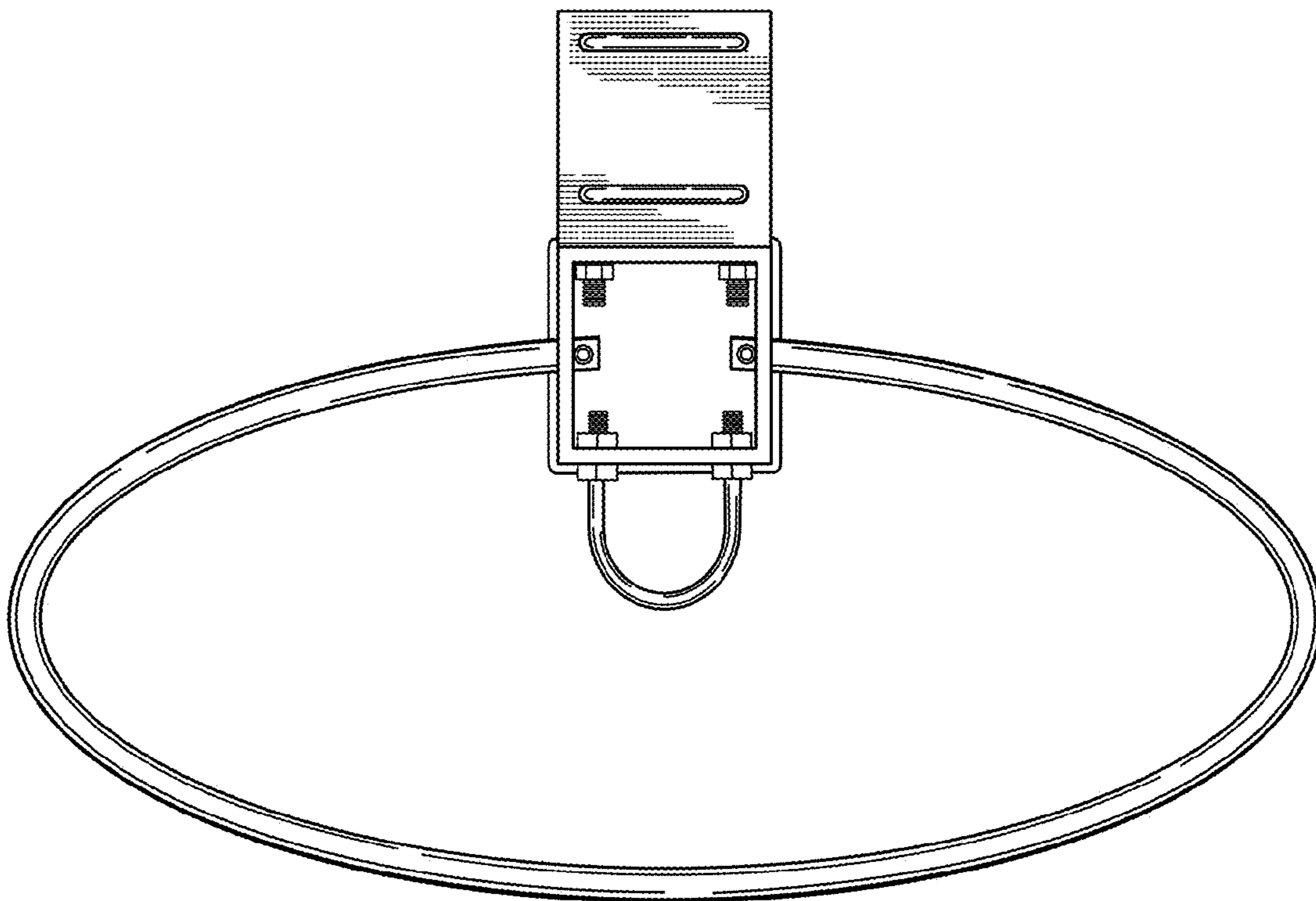

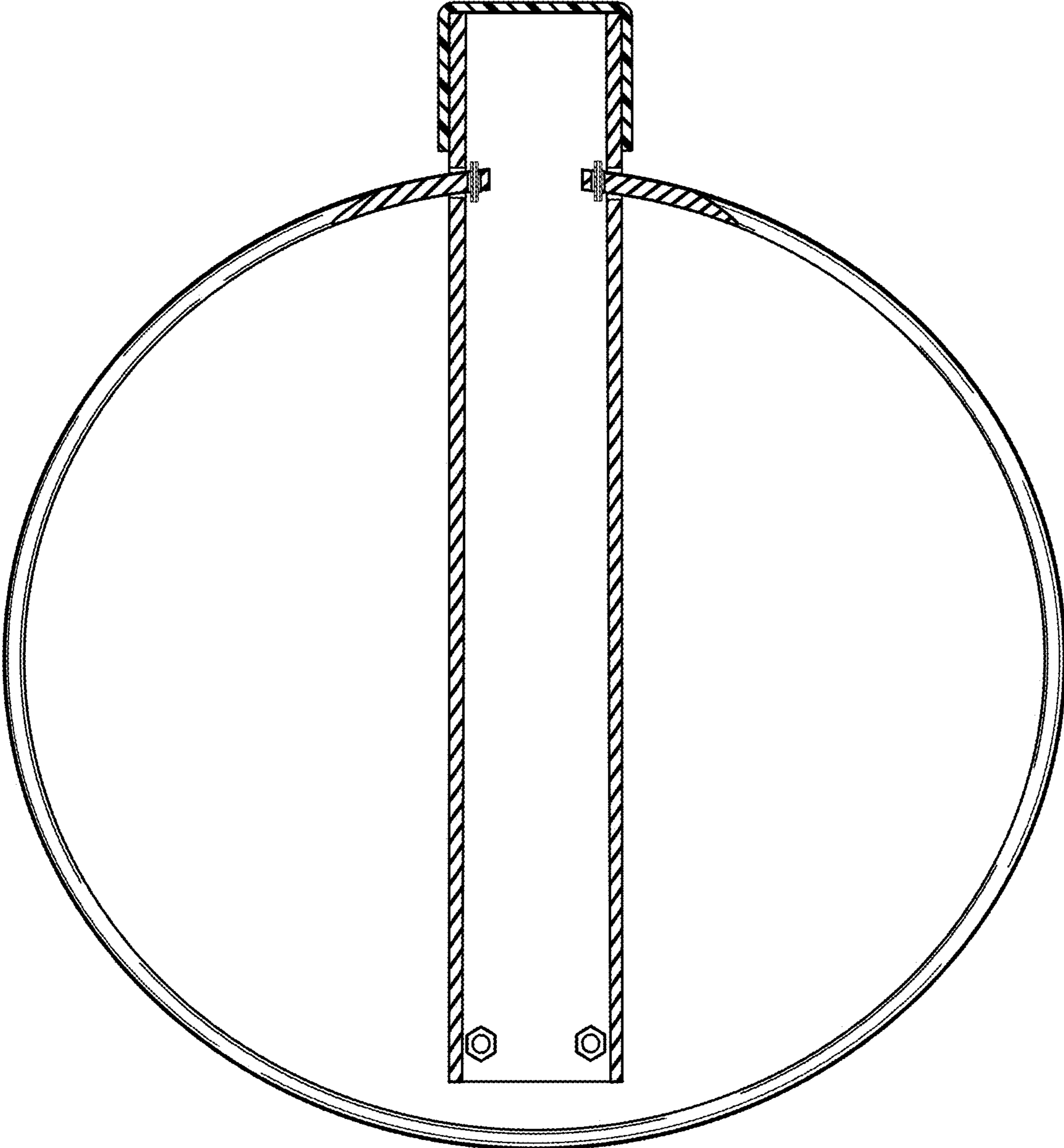

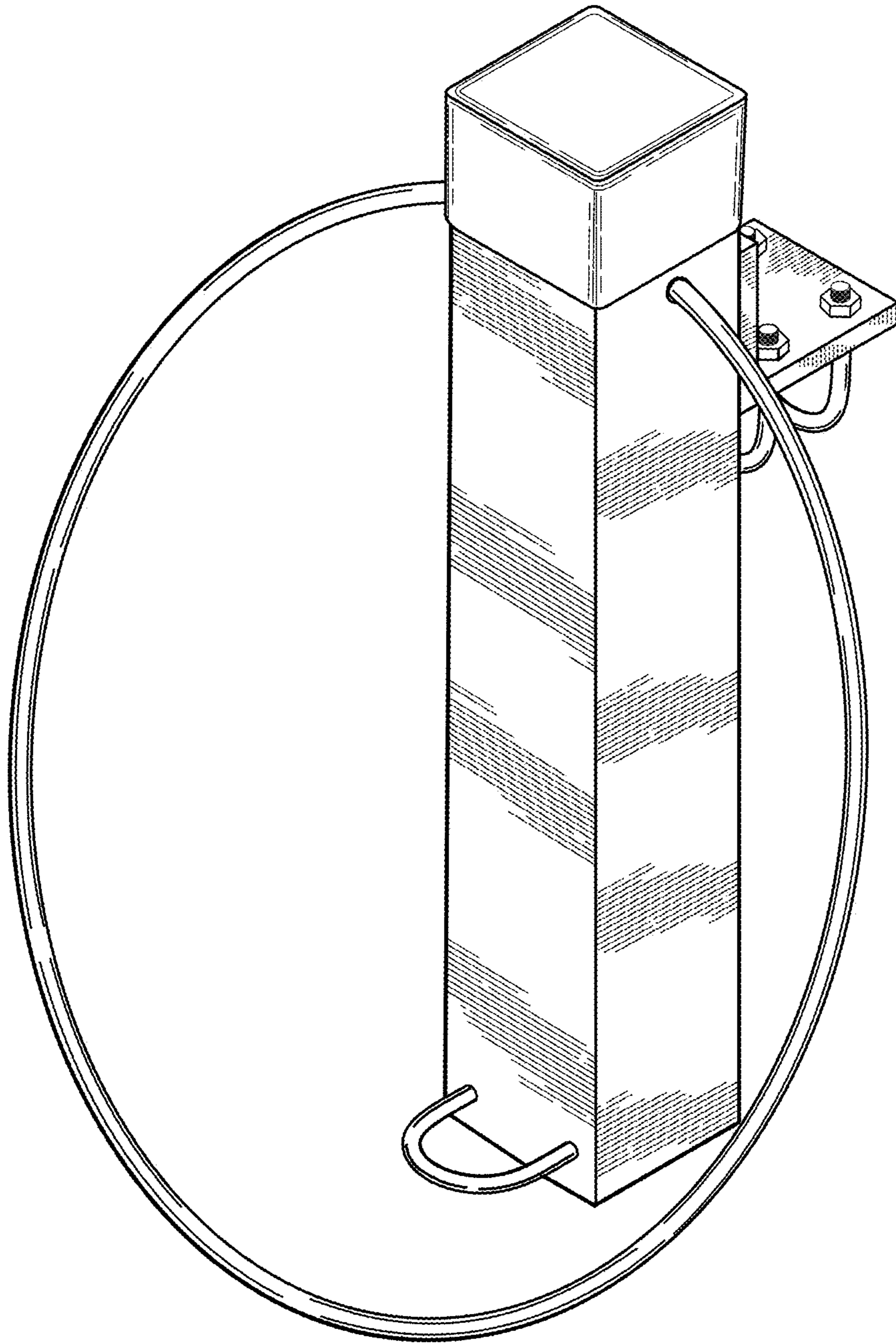

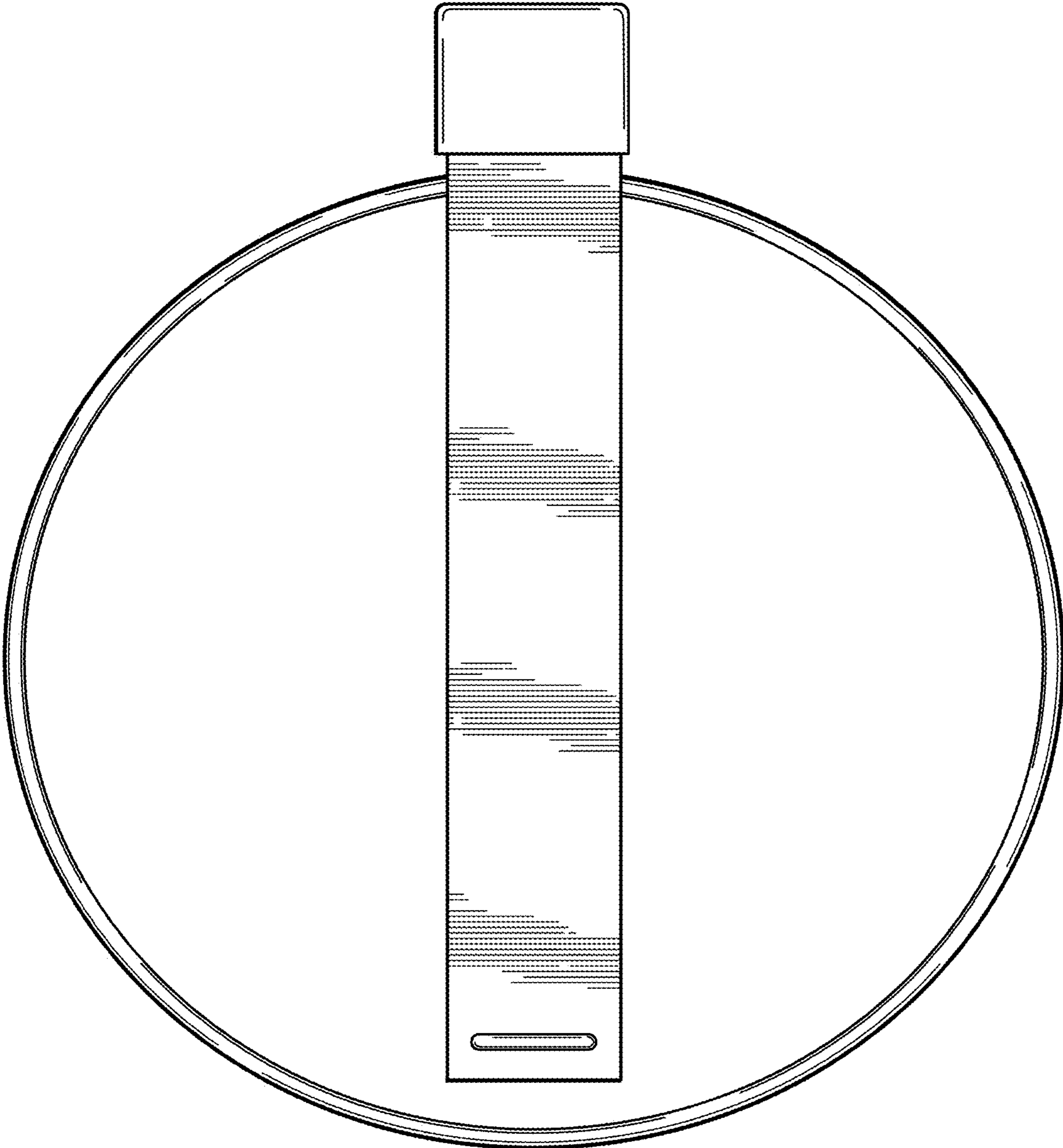

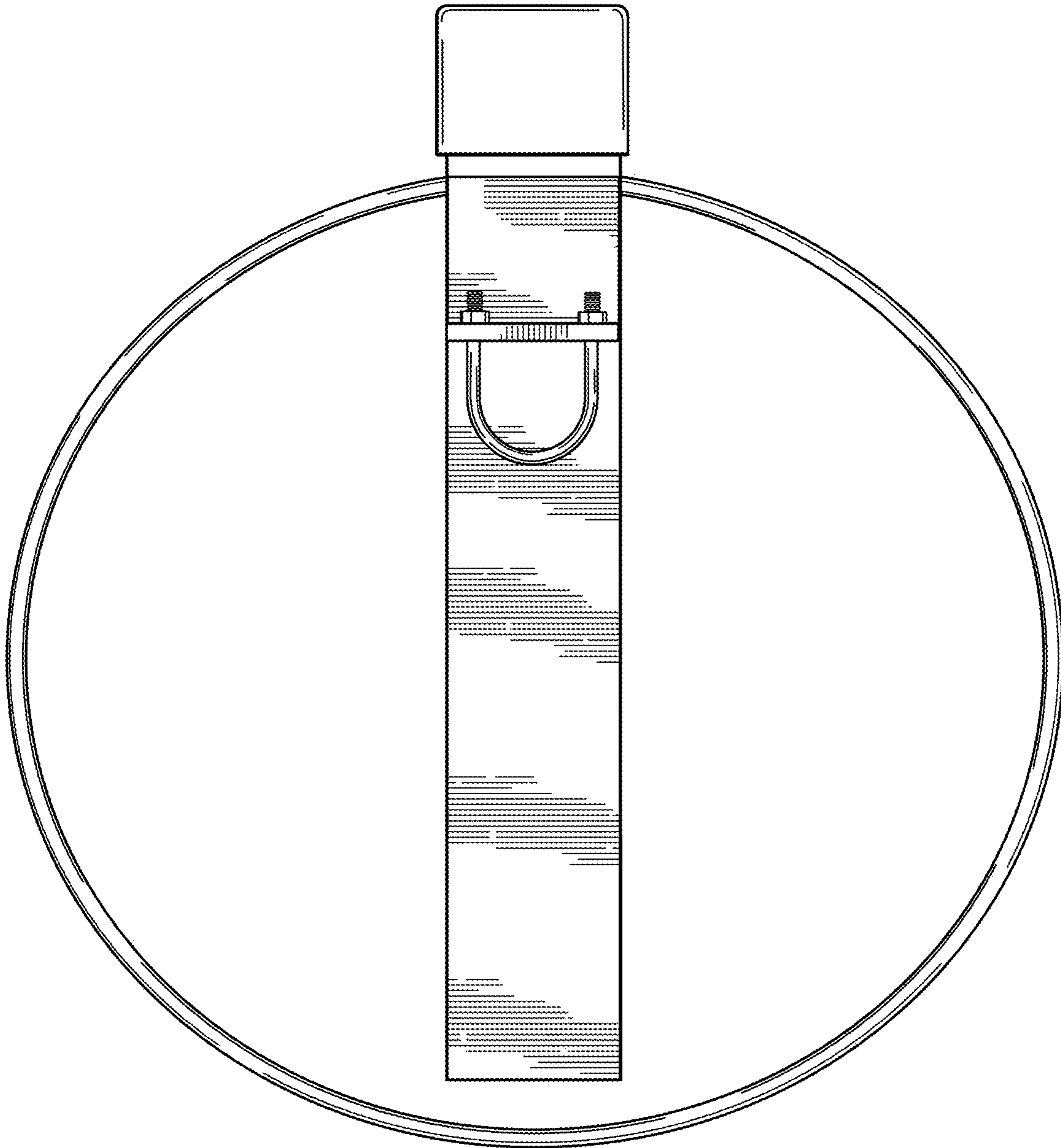

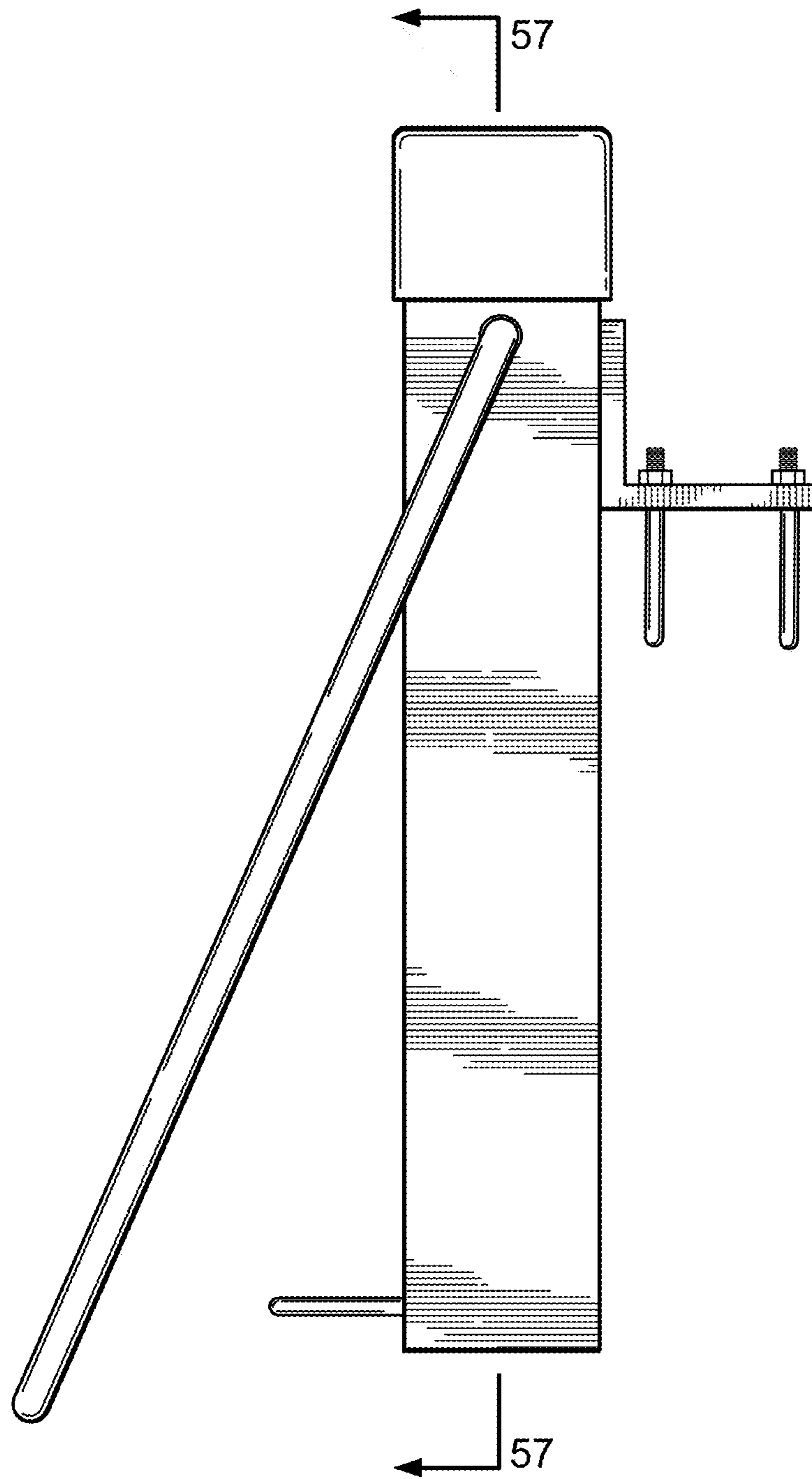

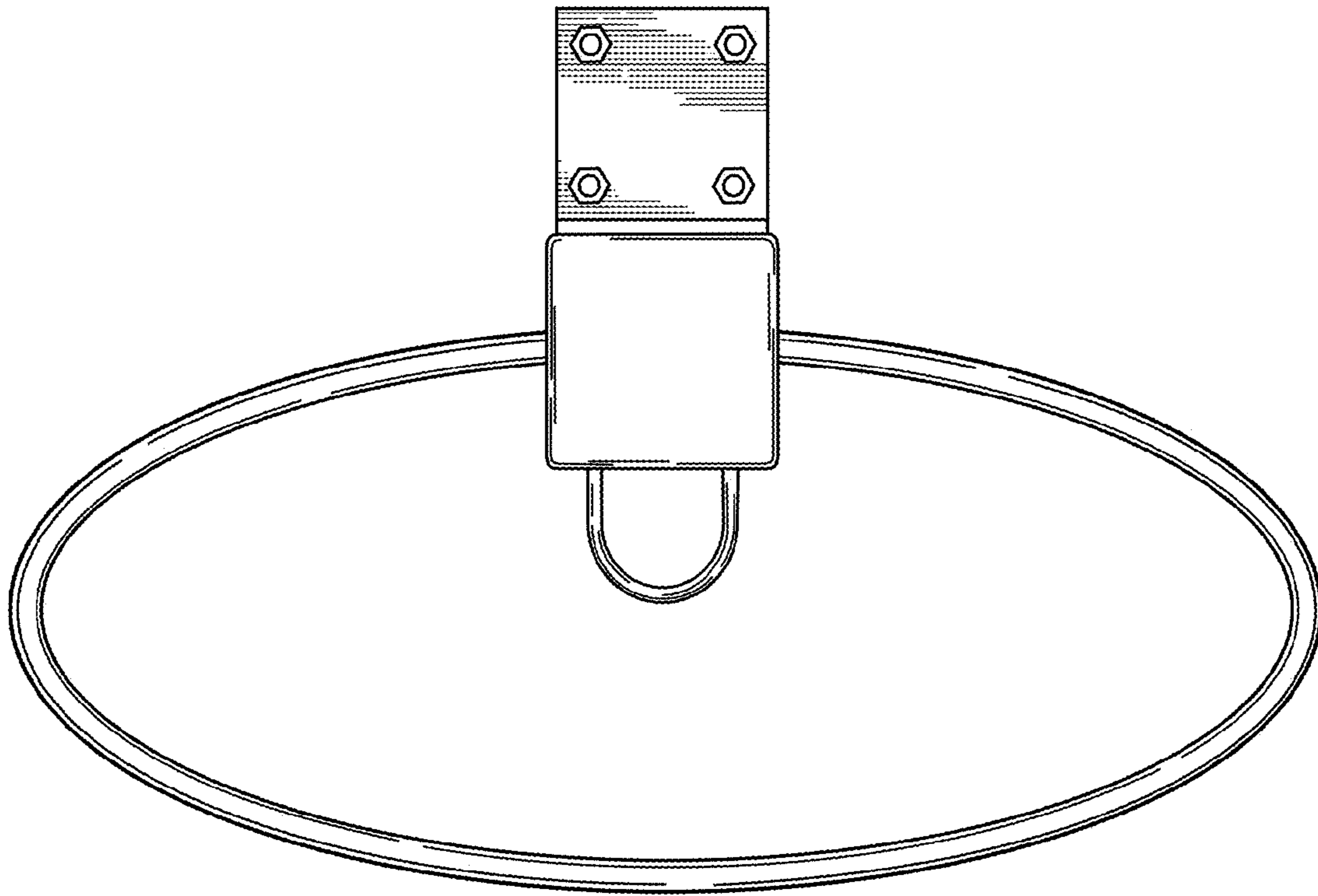

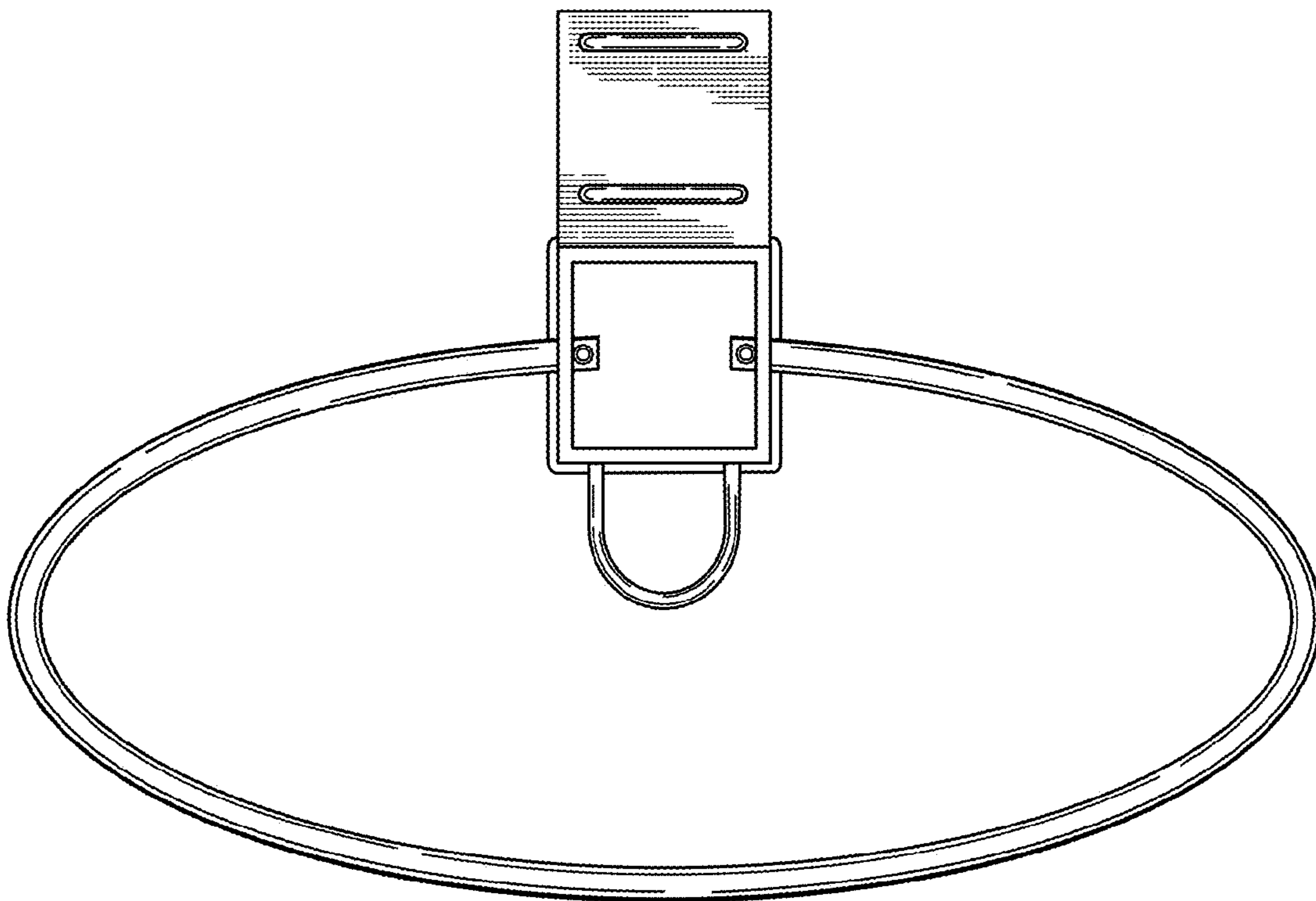

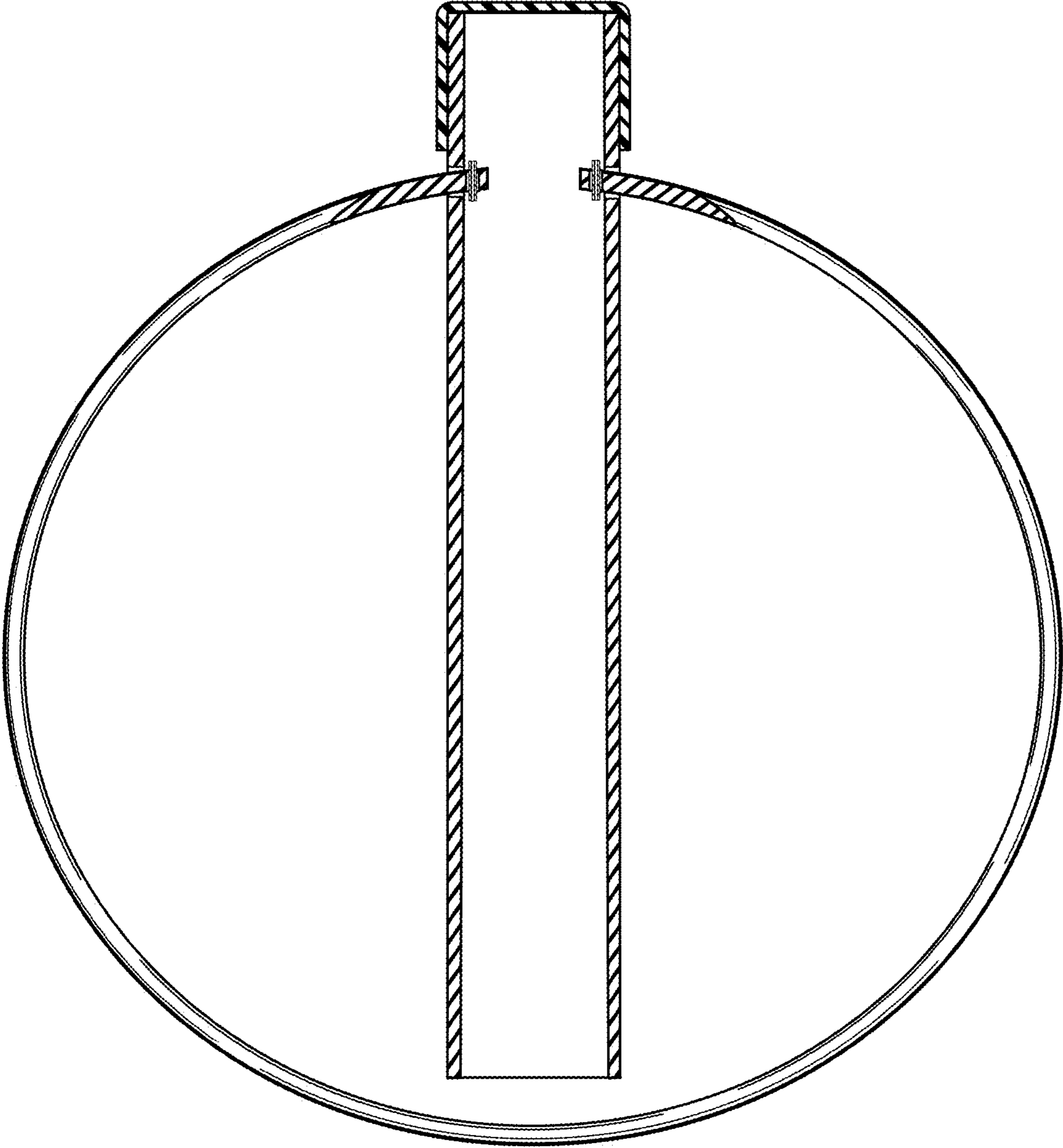
