The ornamental design for an animal game call, as shown and described.

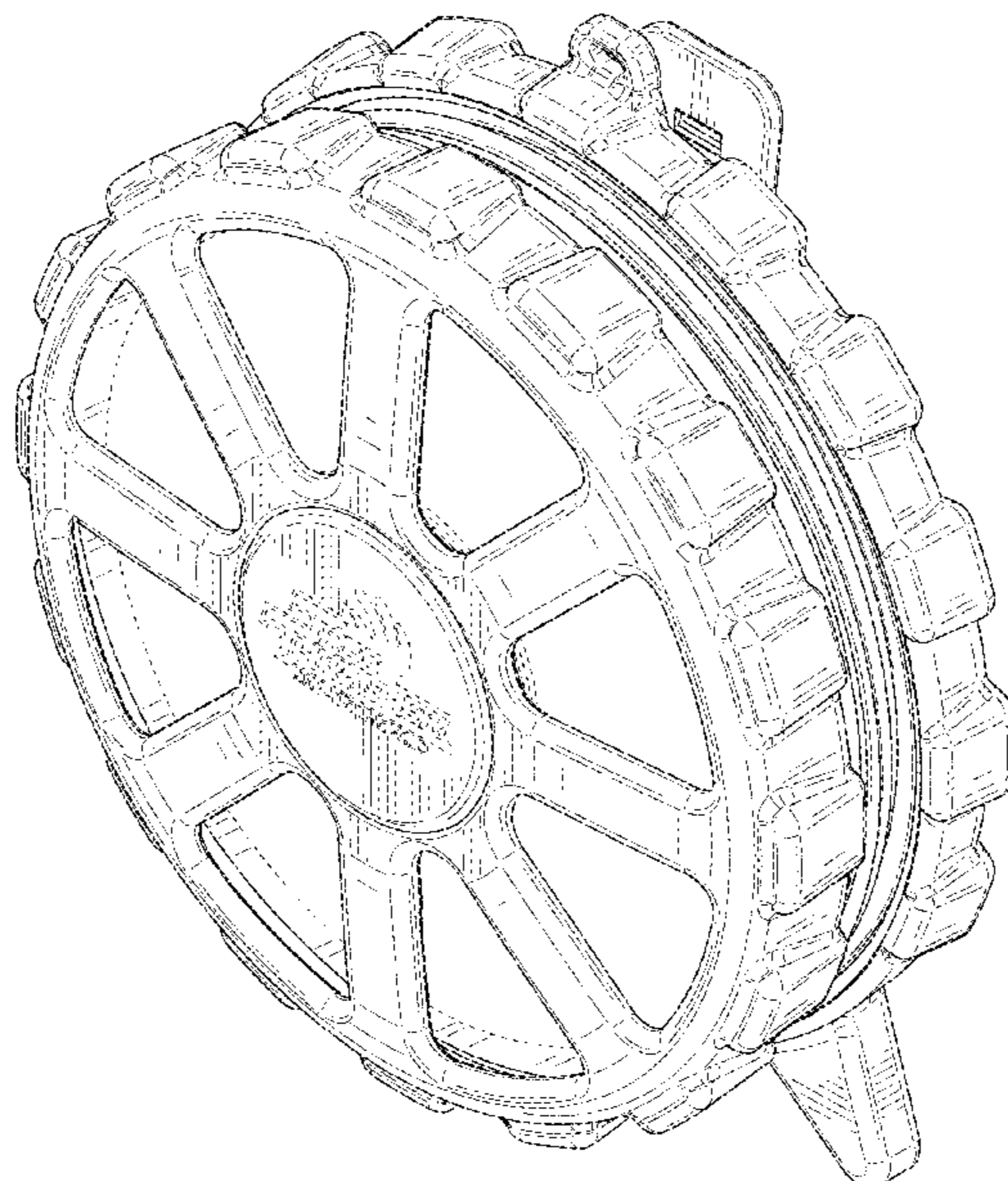
**DESCRIPTION**

FIG. 1 is a front perspective view of an animal game call according to our design;

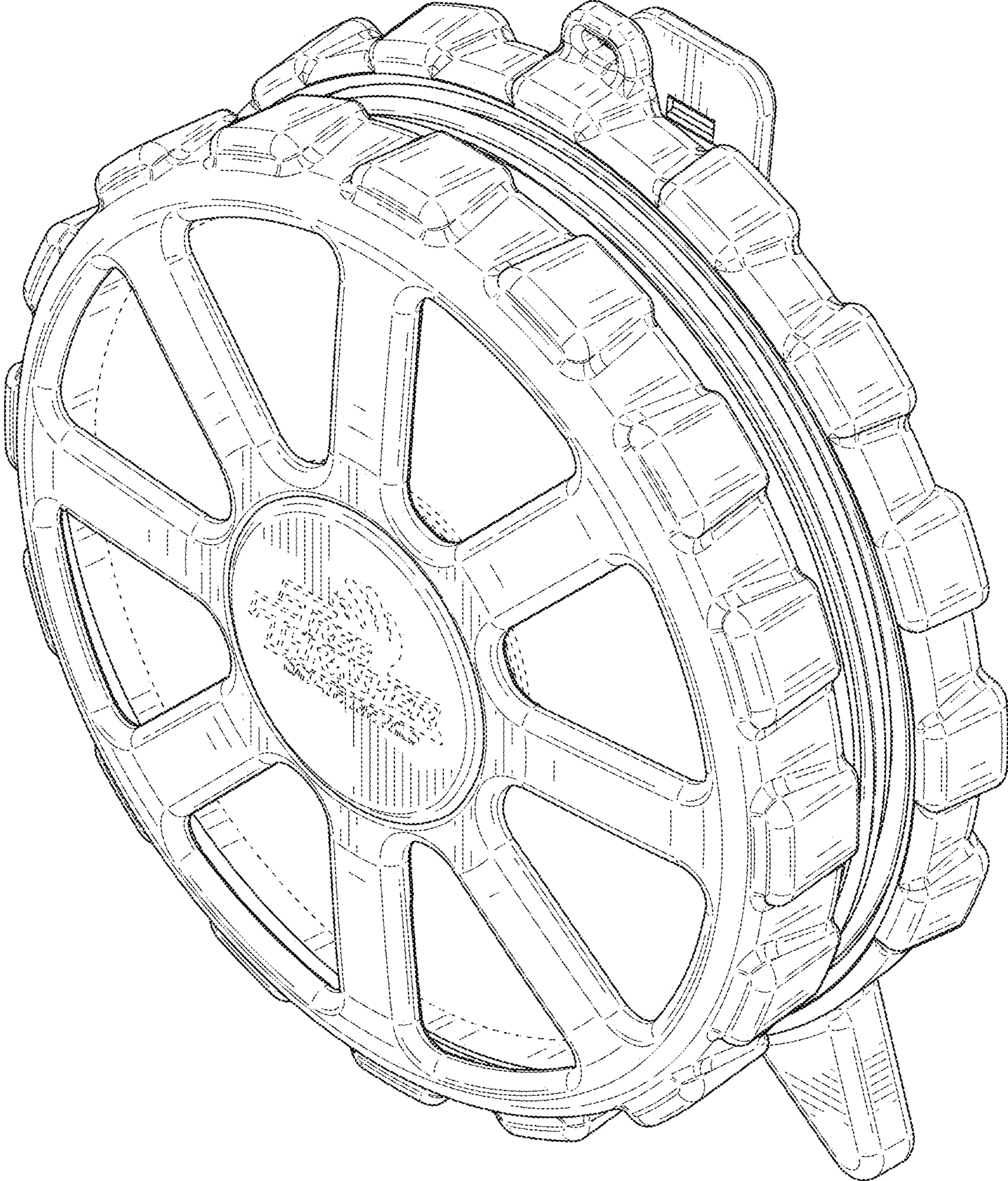

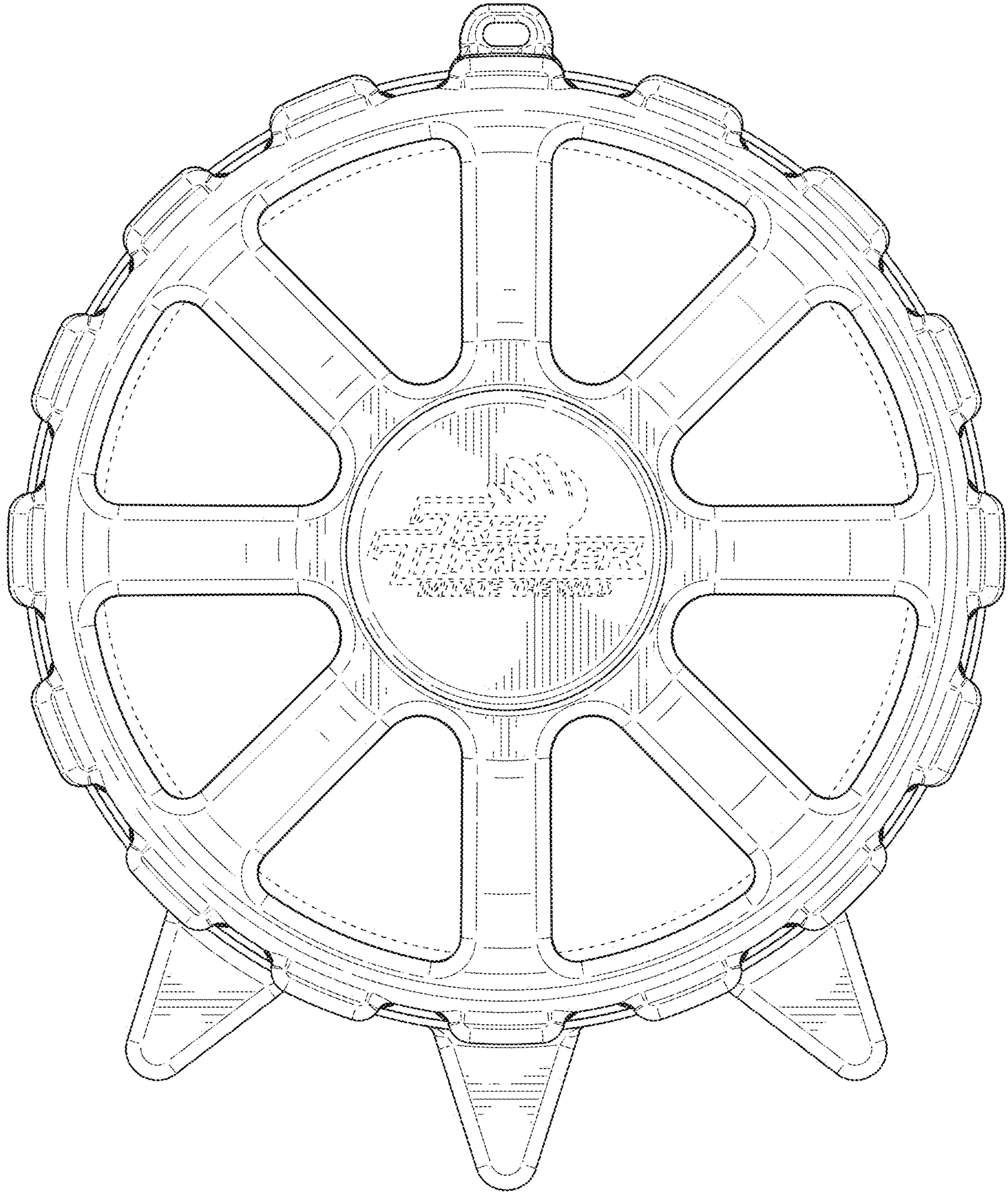

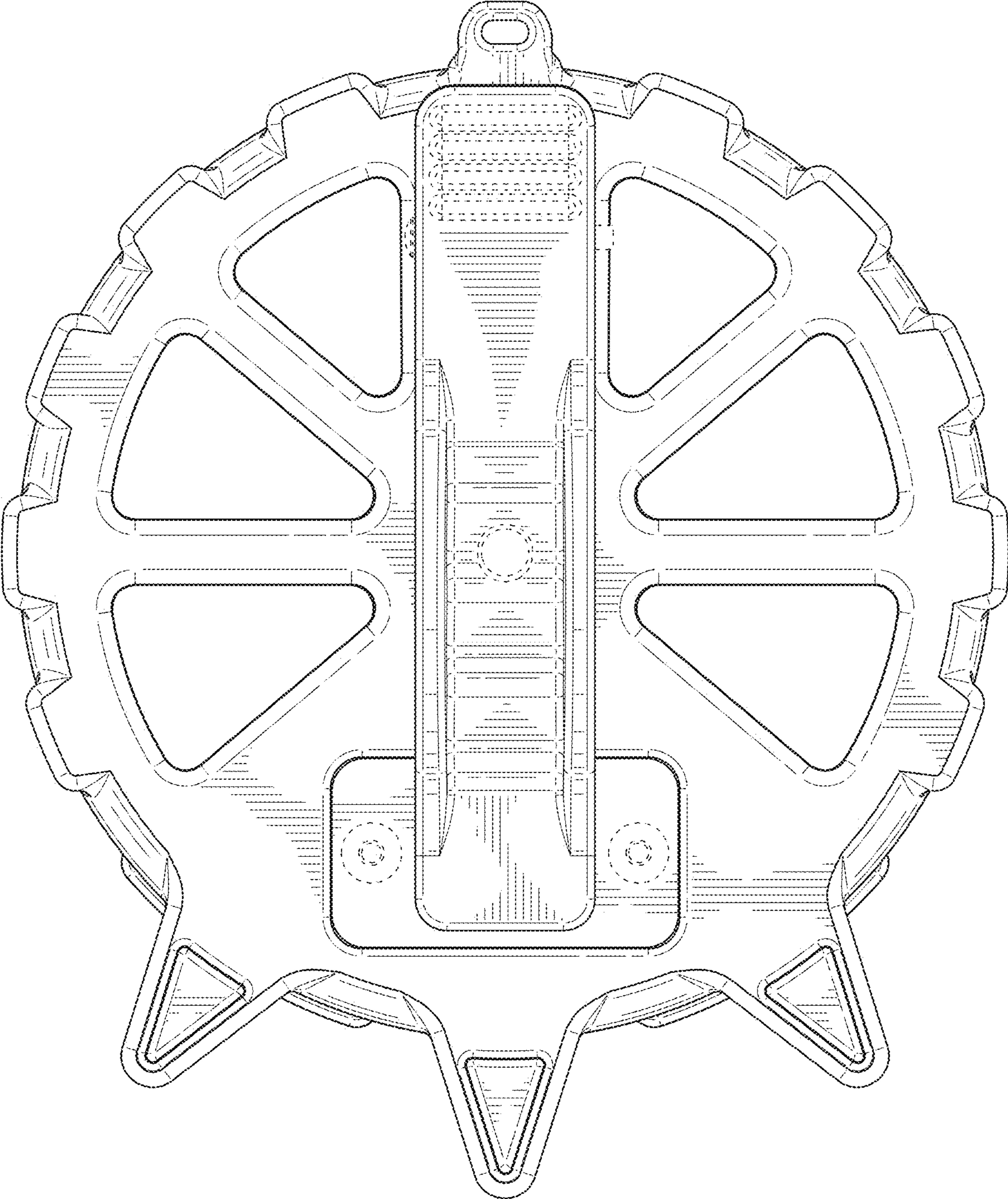

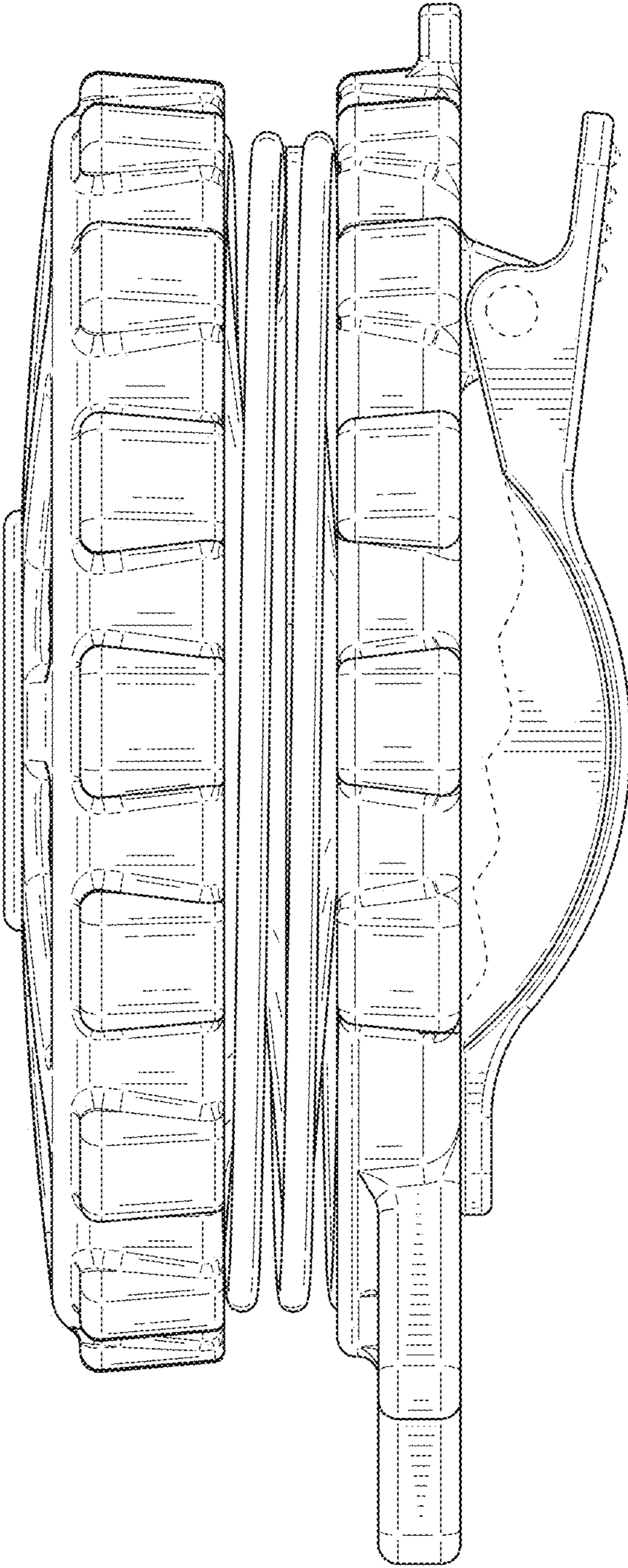

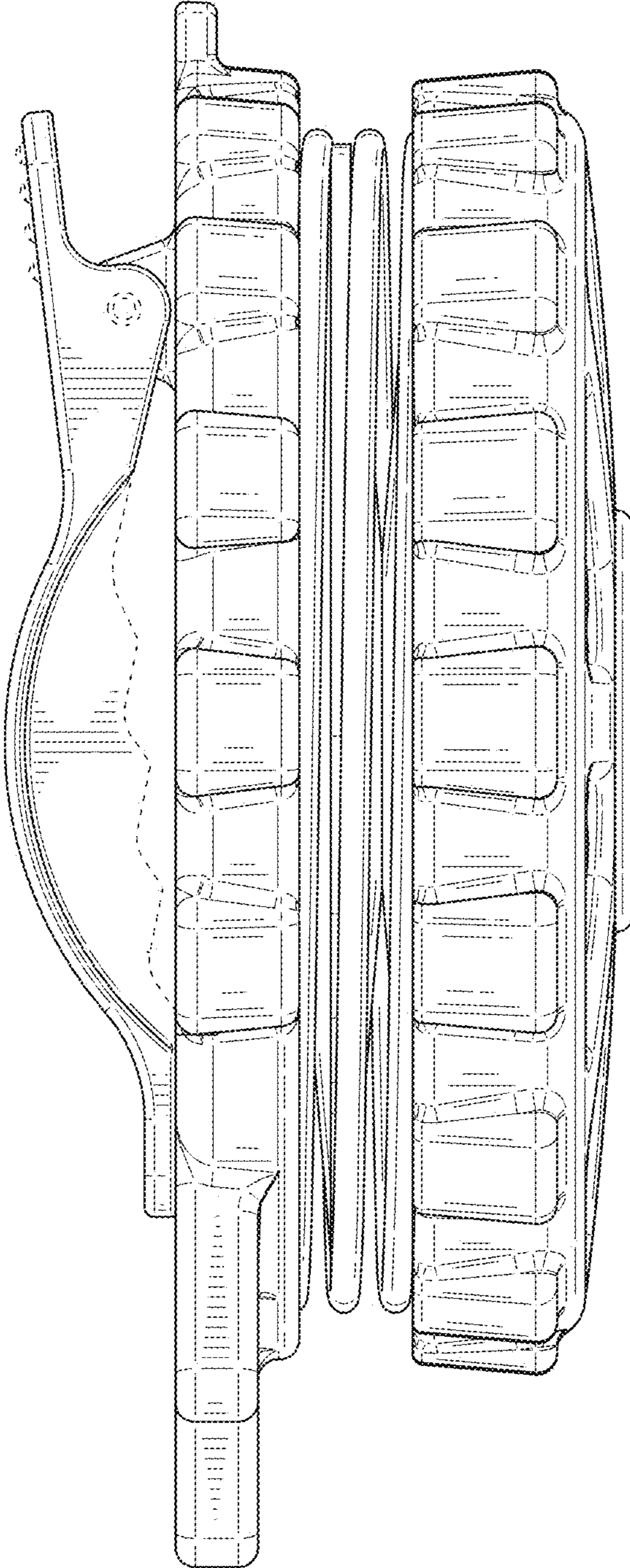

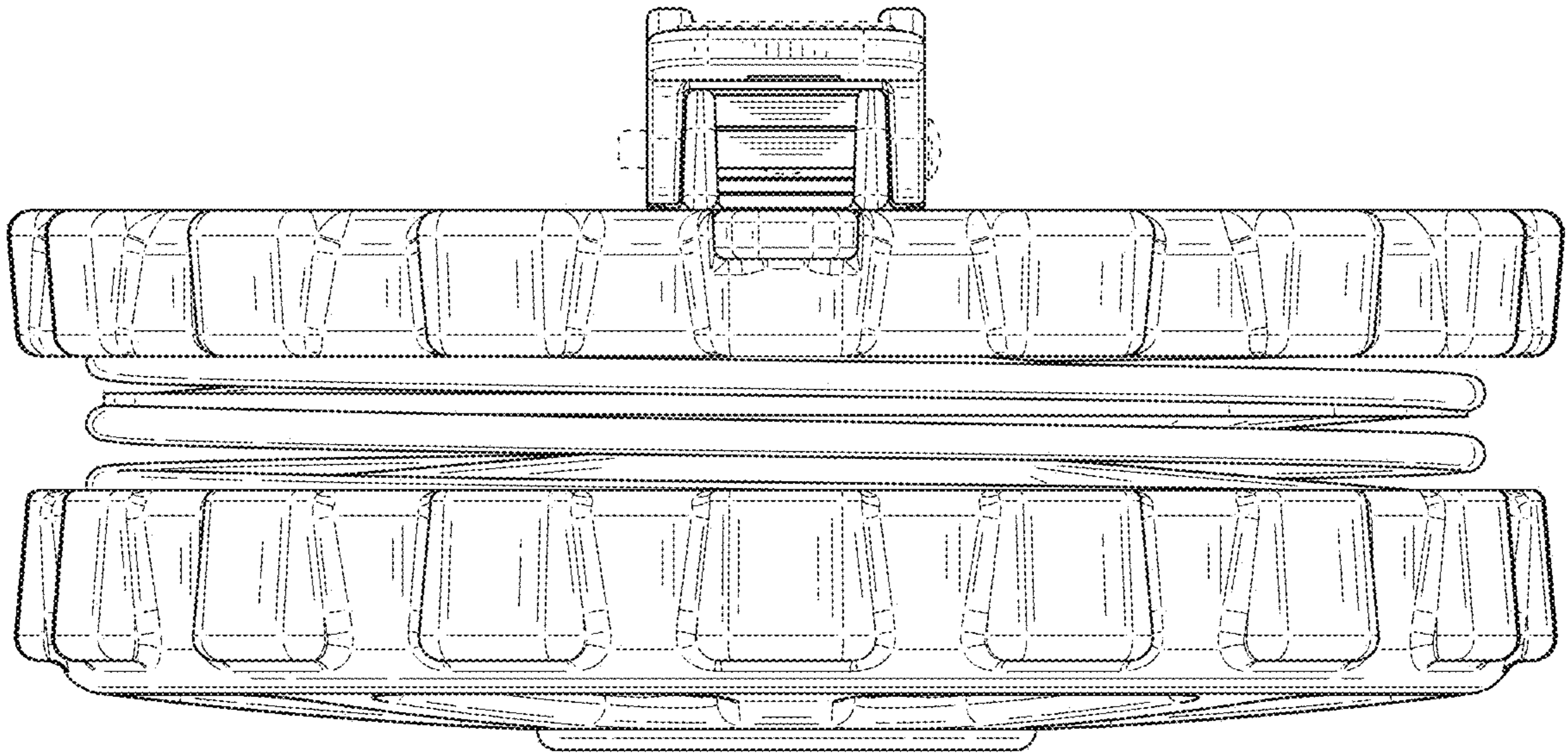

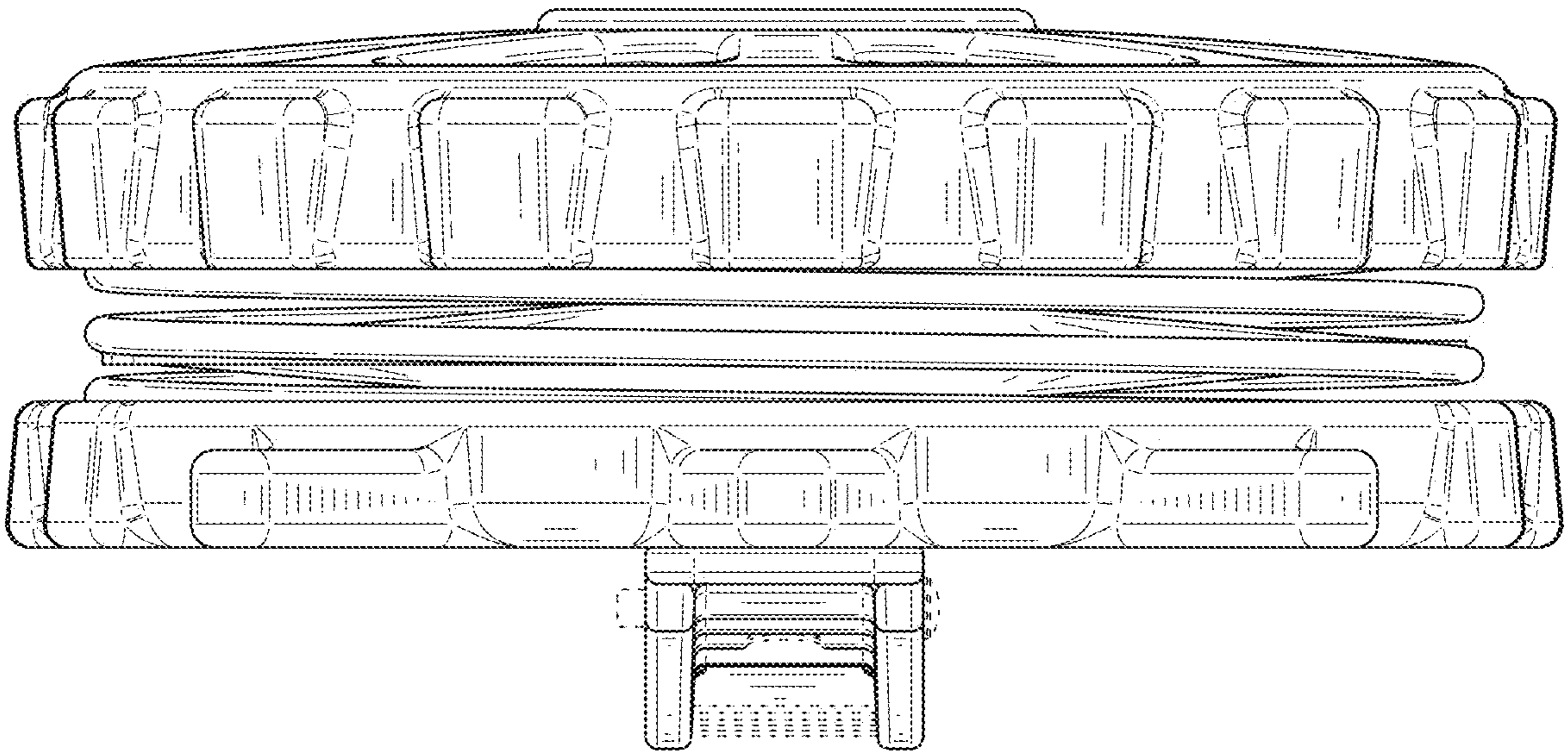
