(57) **CLAIM**

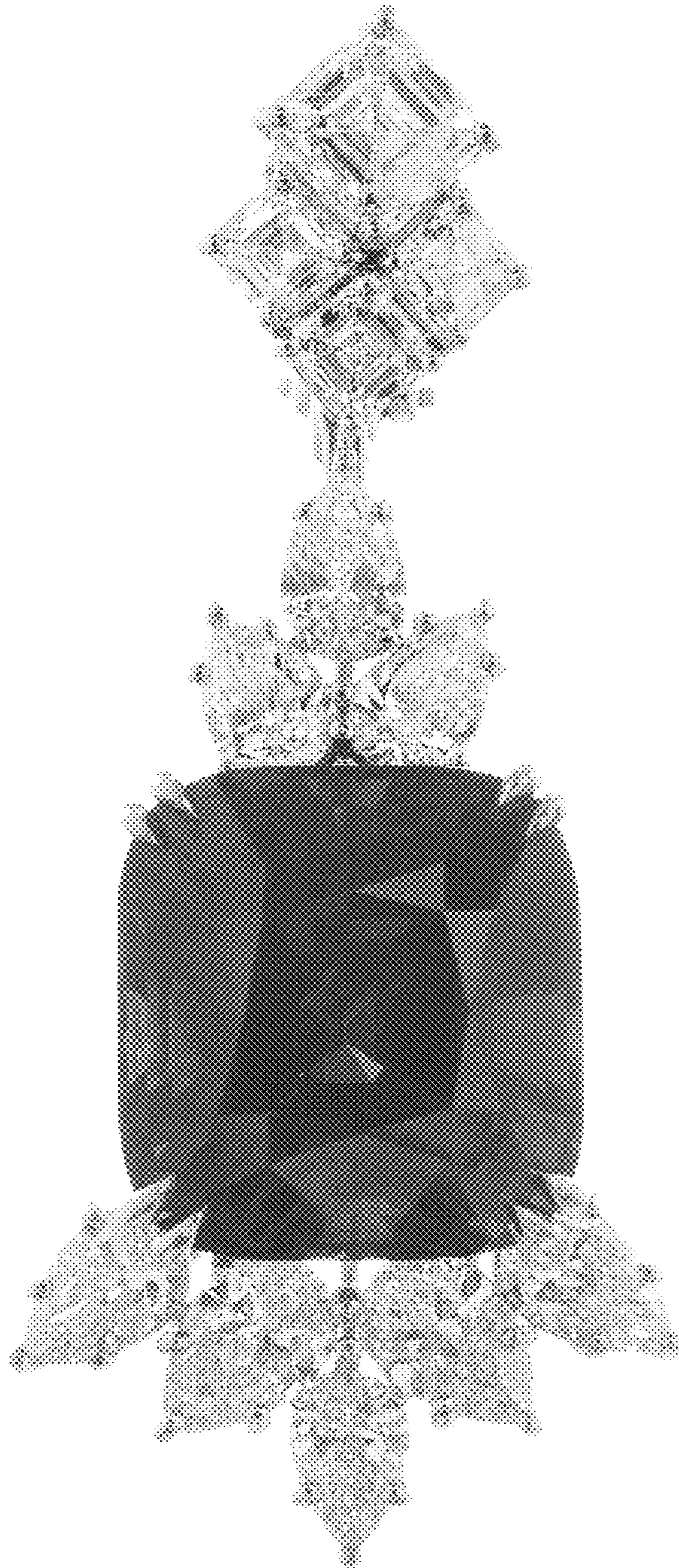
The ornamental design for an earring, as shown and described.

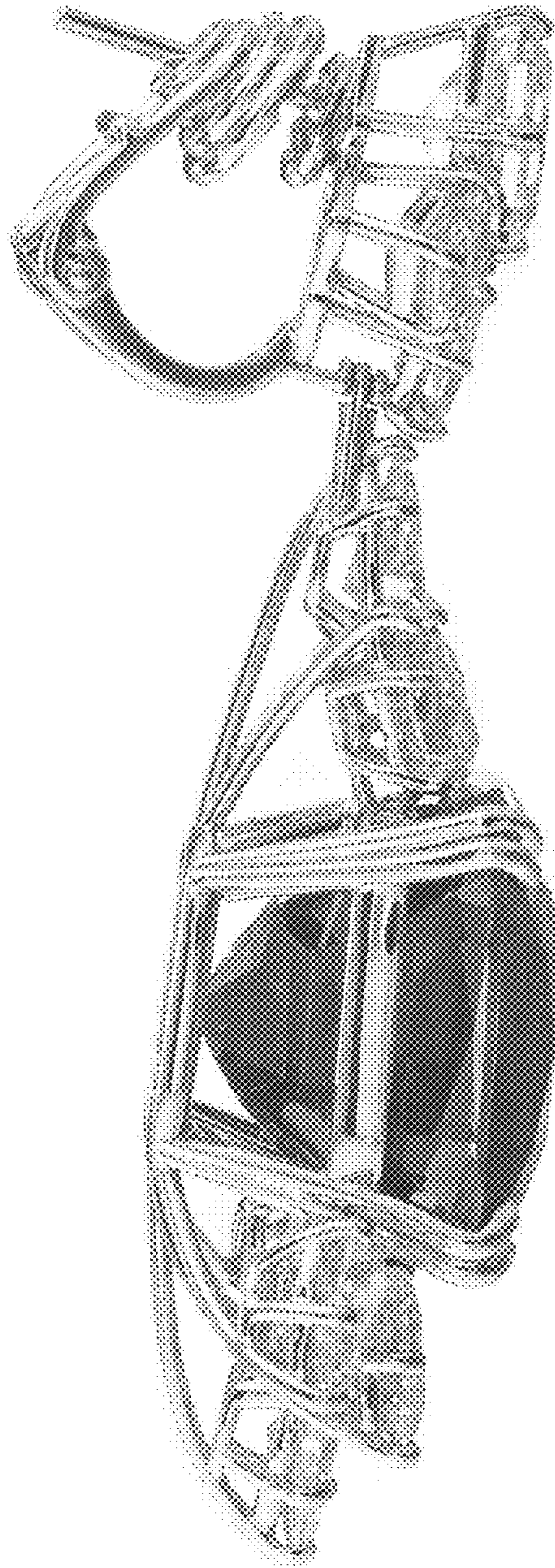
