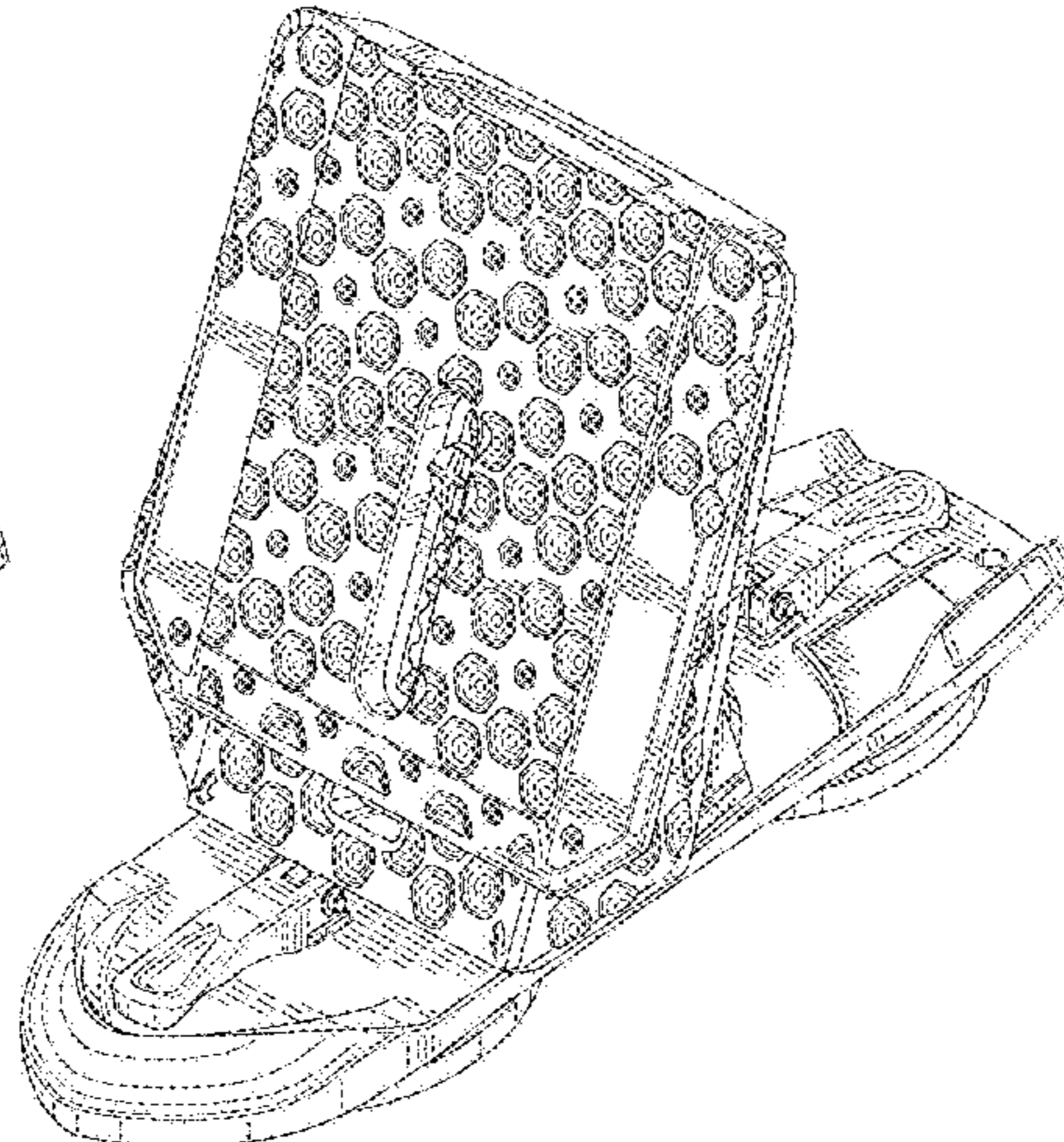
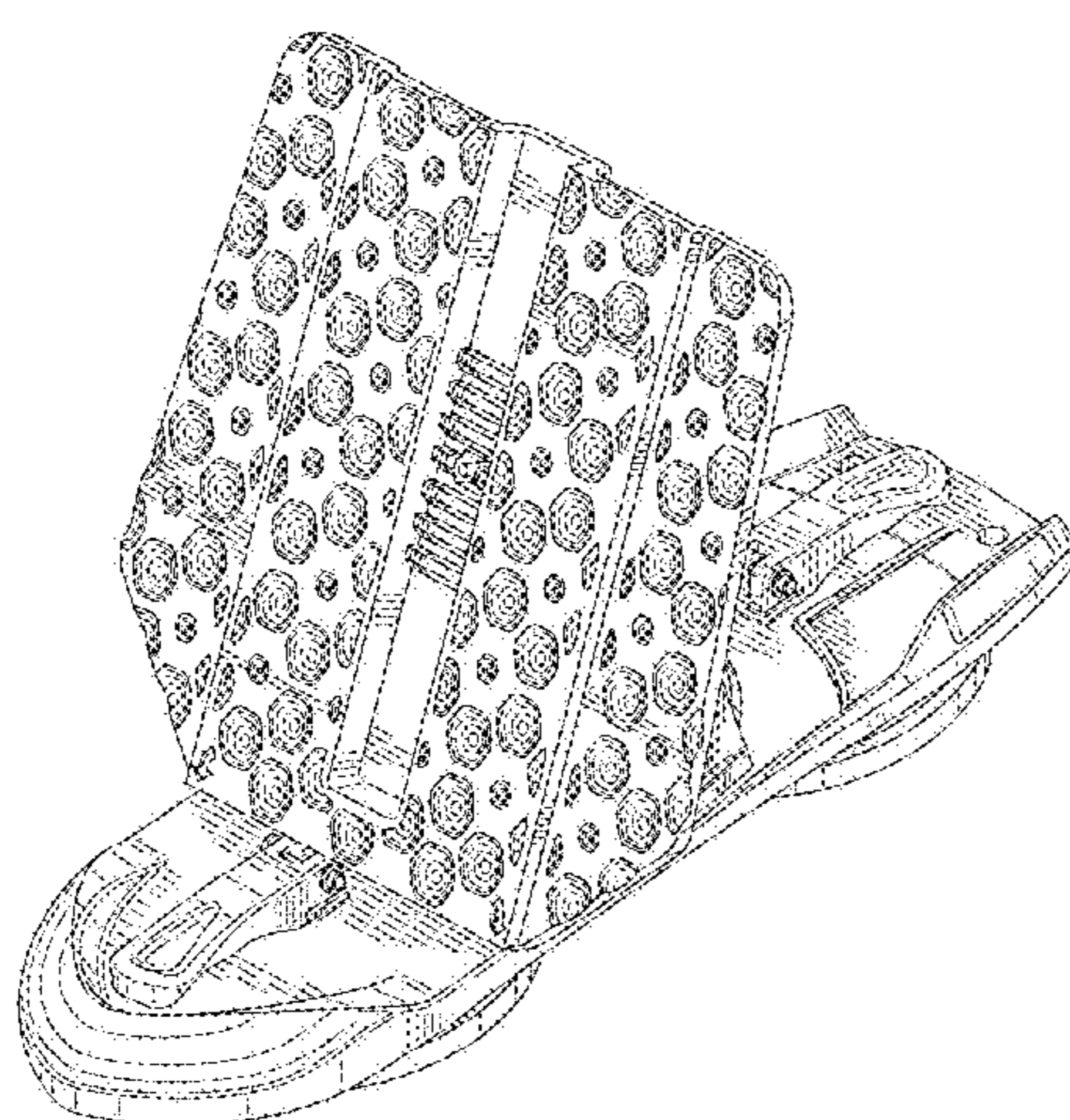

(57) CLAIM

We claim the ornamental design of an adjustable water flow deflection device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a base plate and a base deflector of the adjustable water flow deflection device of the present invention.

FIG. 2 is a left, side view of the adjustable water flow deflection device depicted in FIG. 1.

FIG. 3 is a right, side view of the adjustable water flow deflection device depicted in FIG. 1.

FIG. 4 is a top view of the adjustable water flow deflection device depicted in FIG. 1.

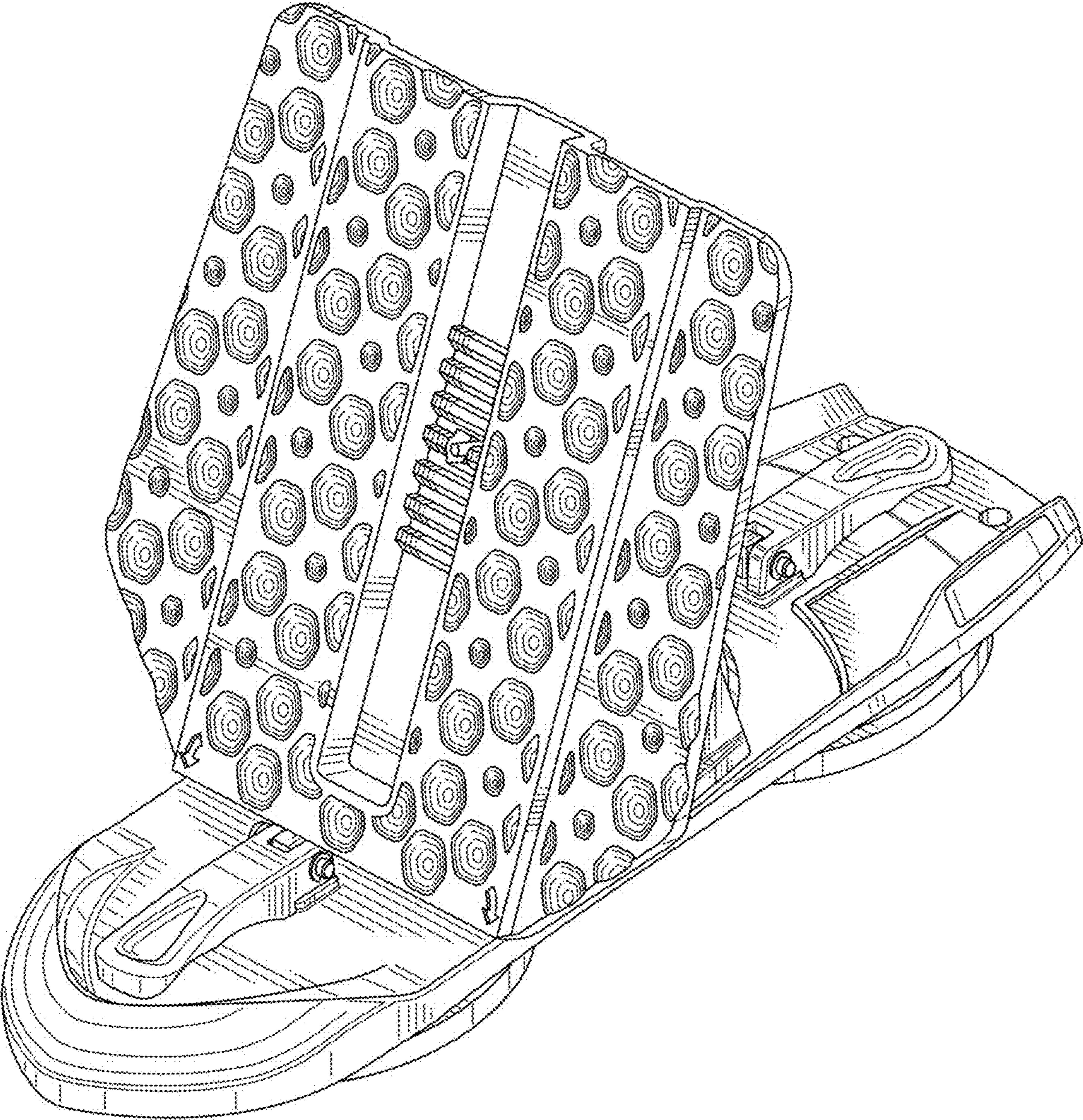

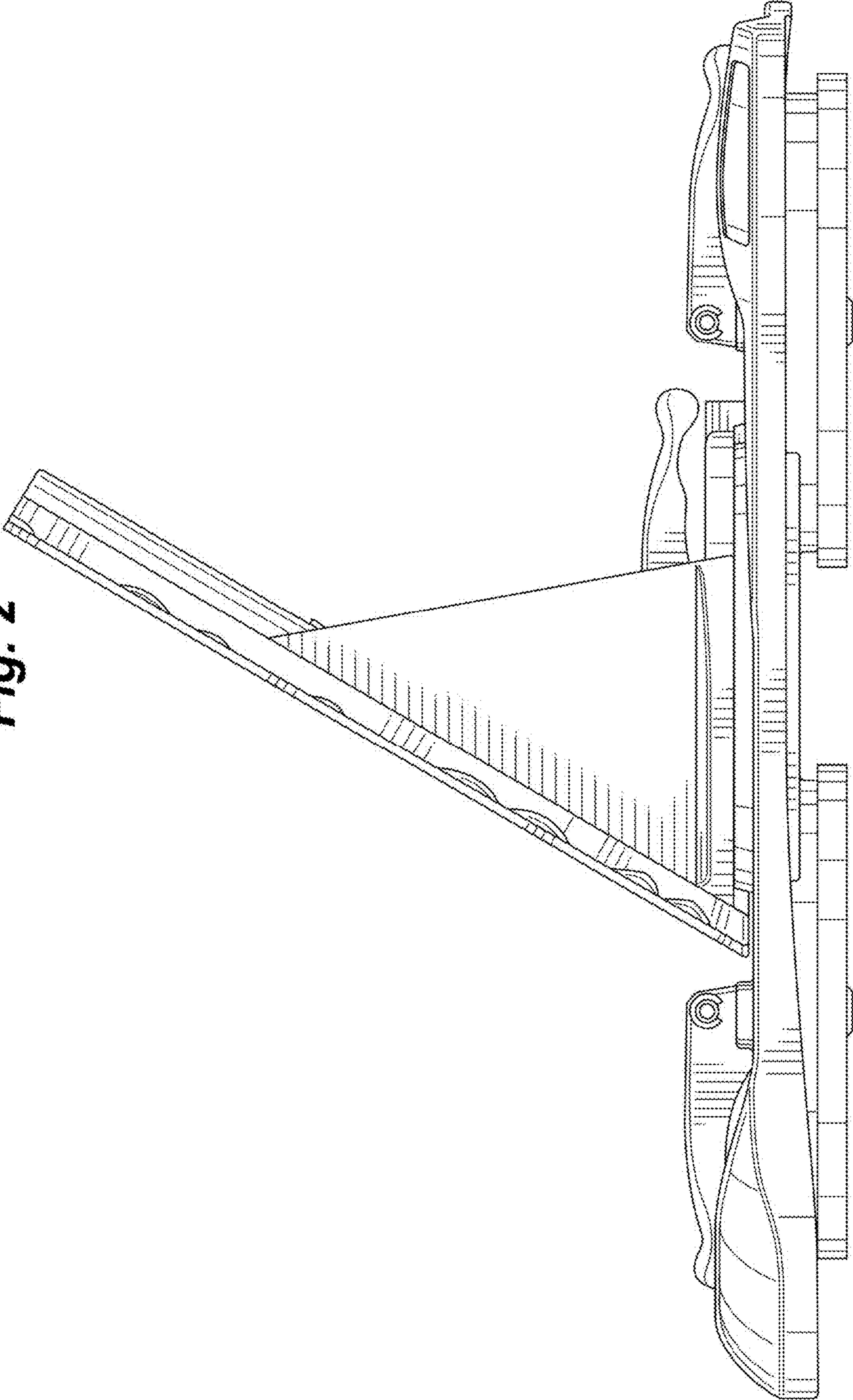
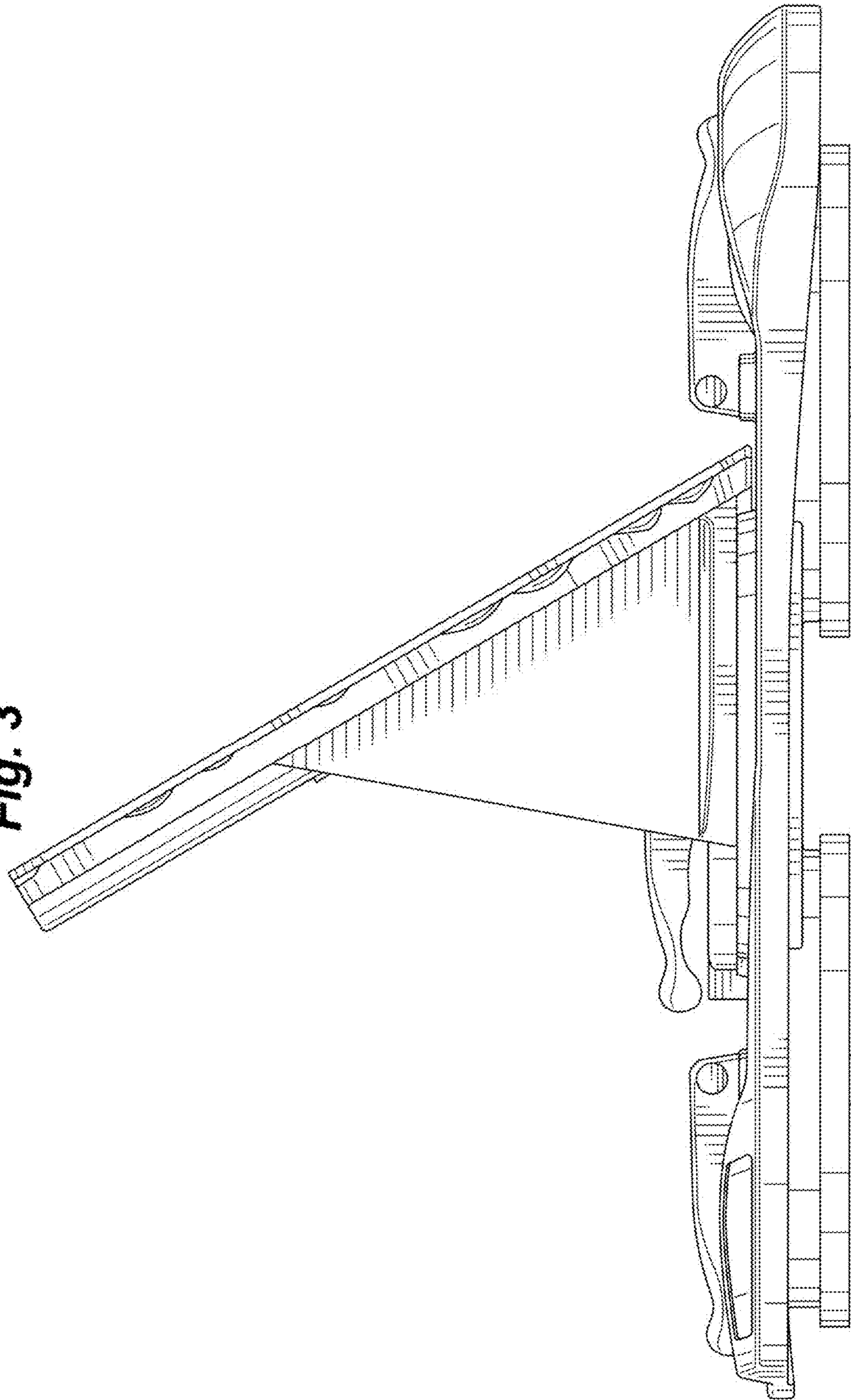

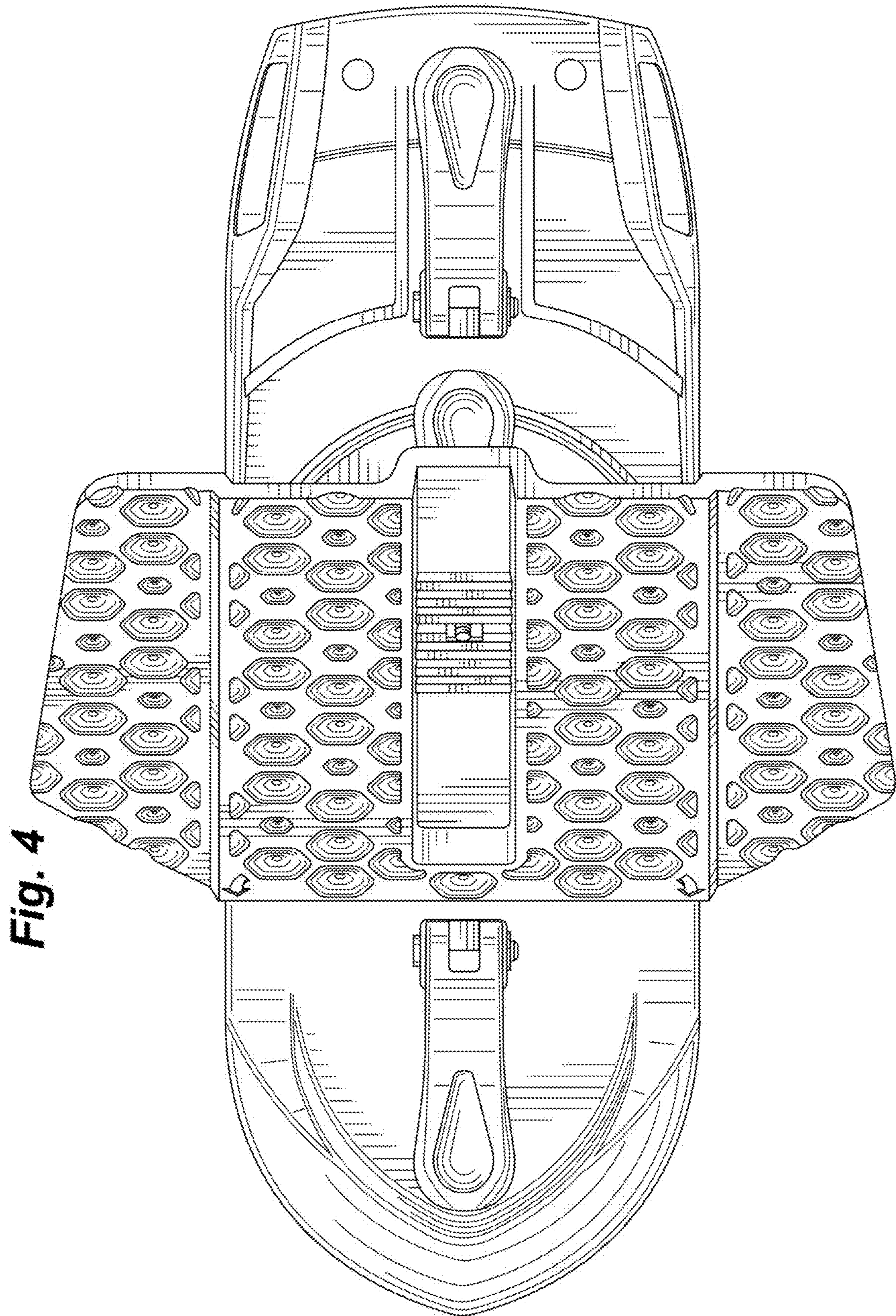

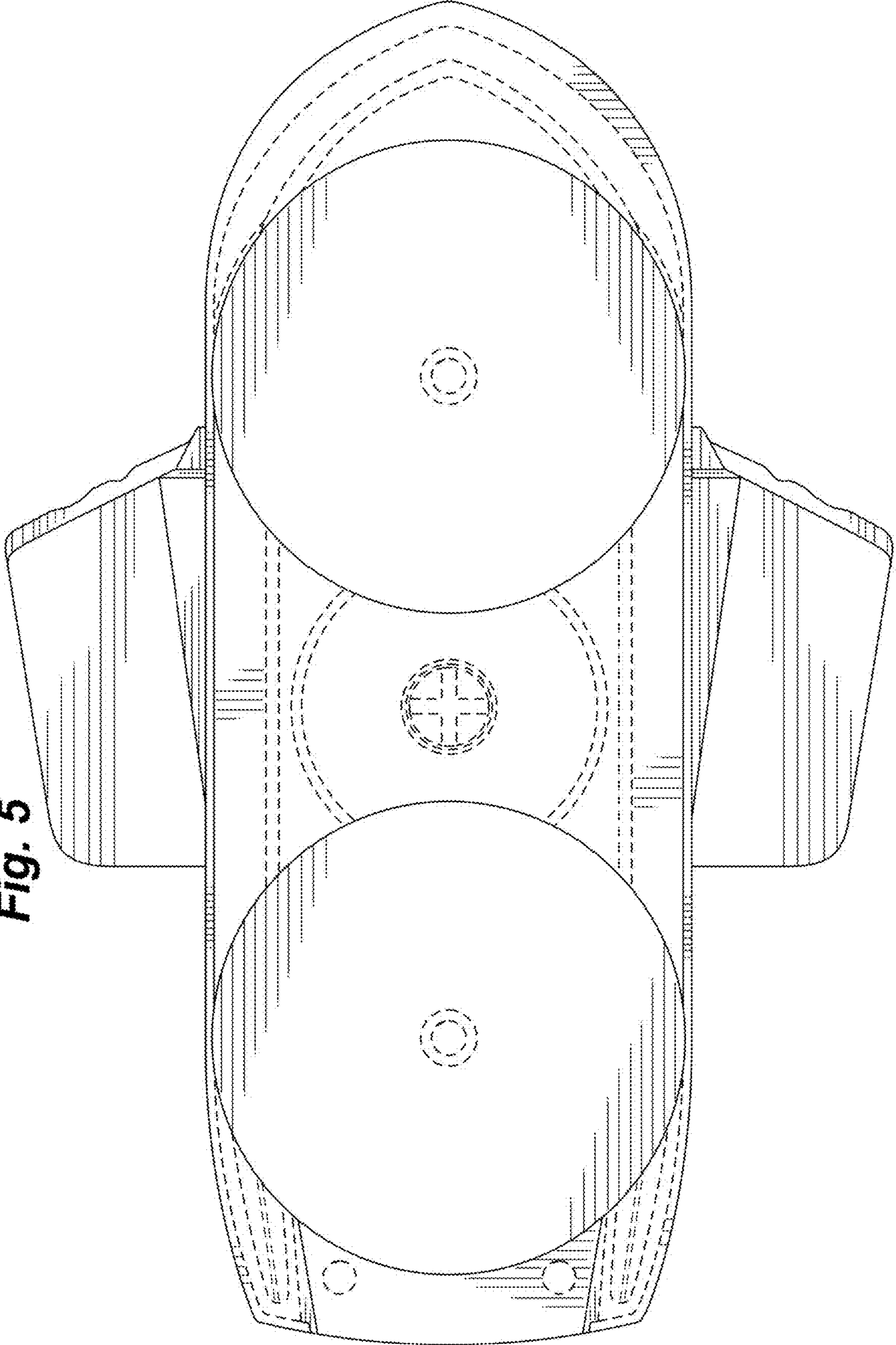

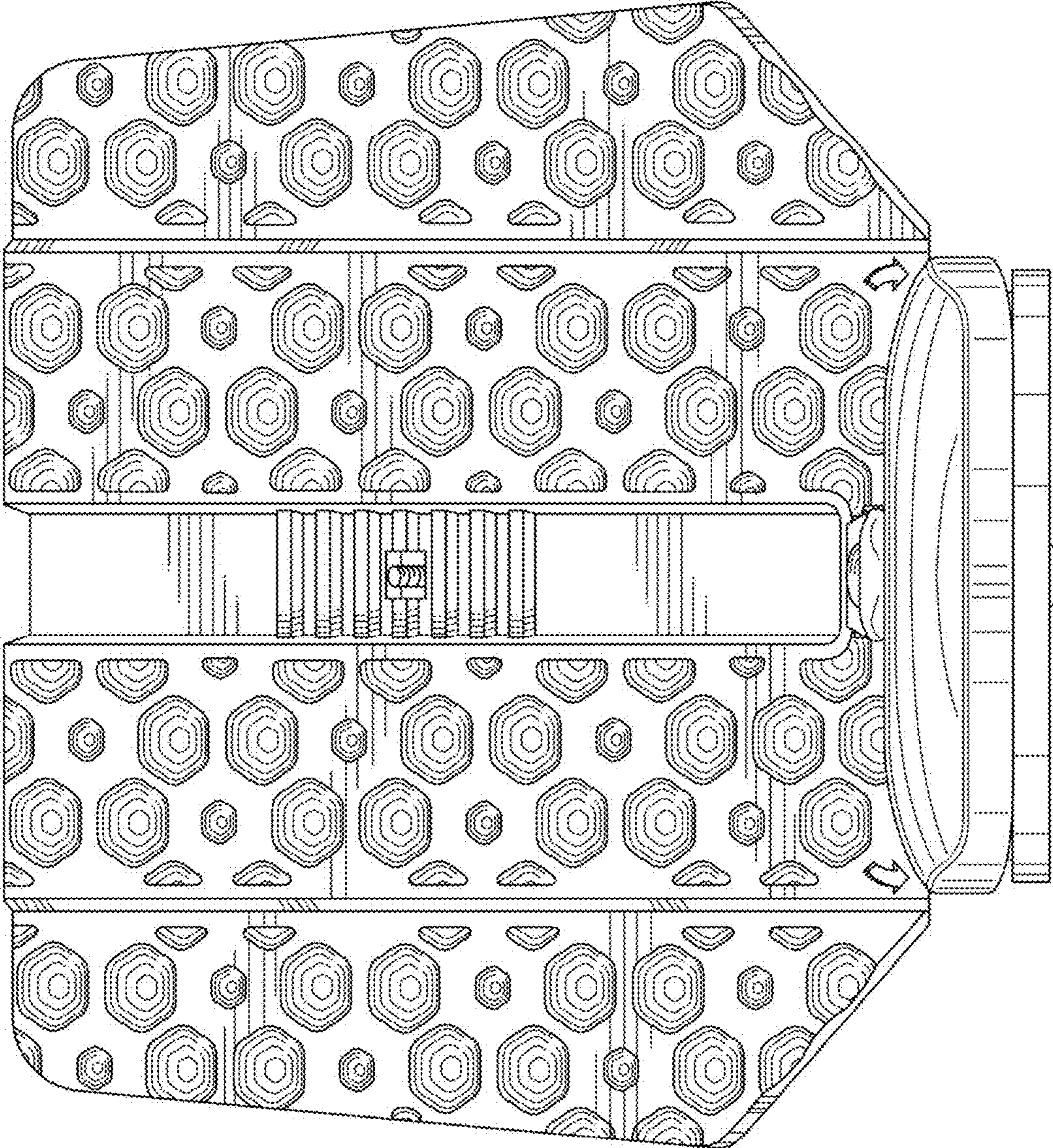

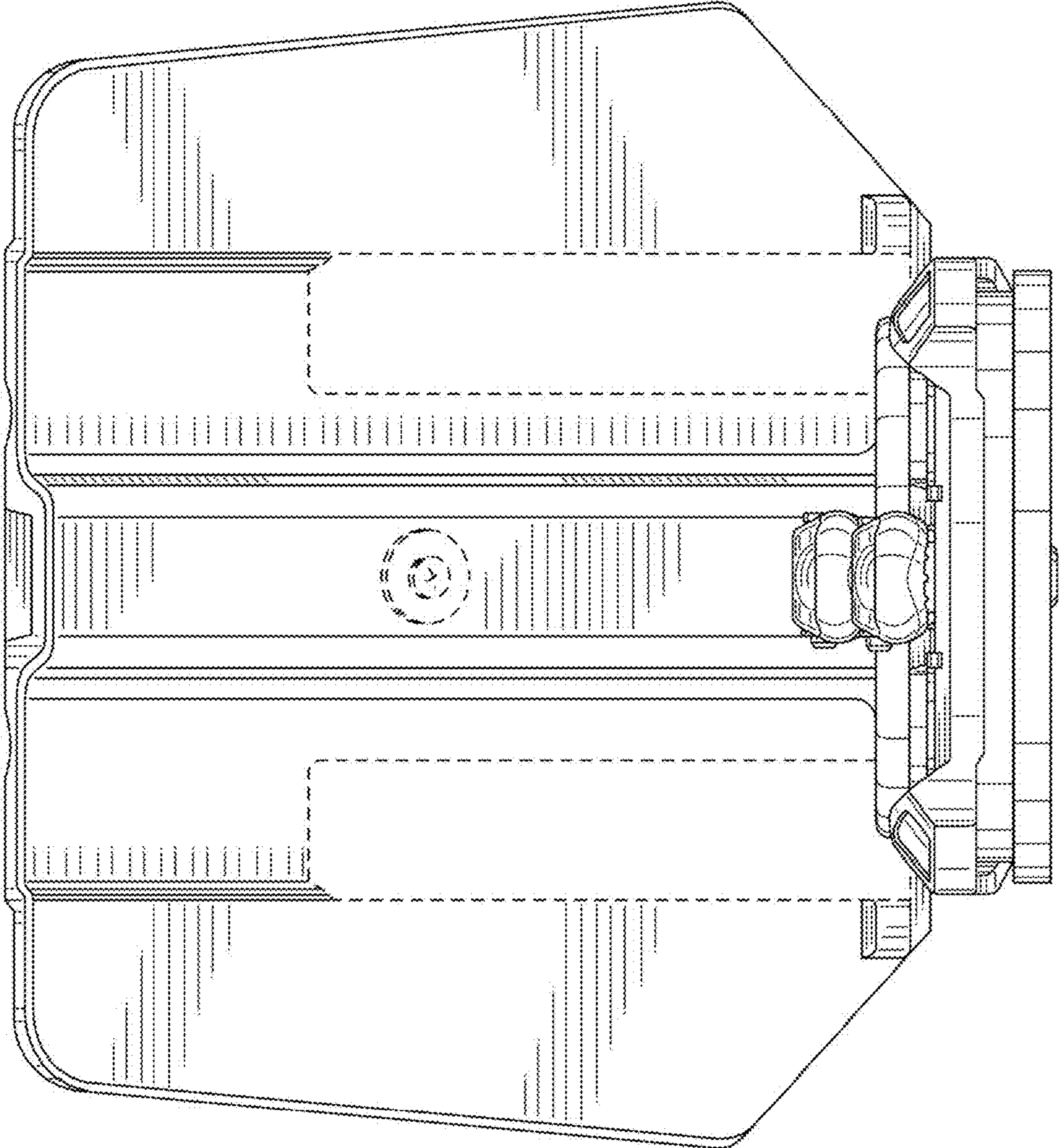

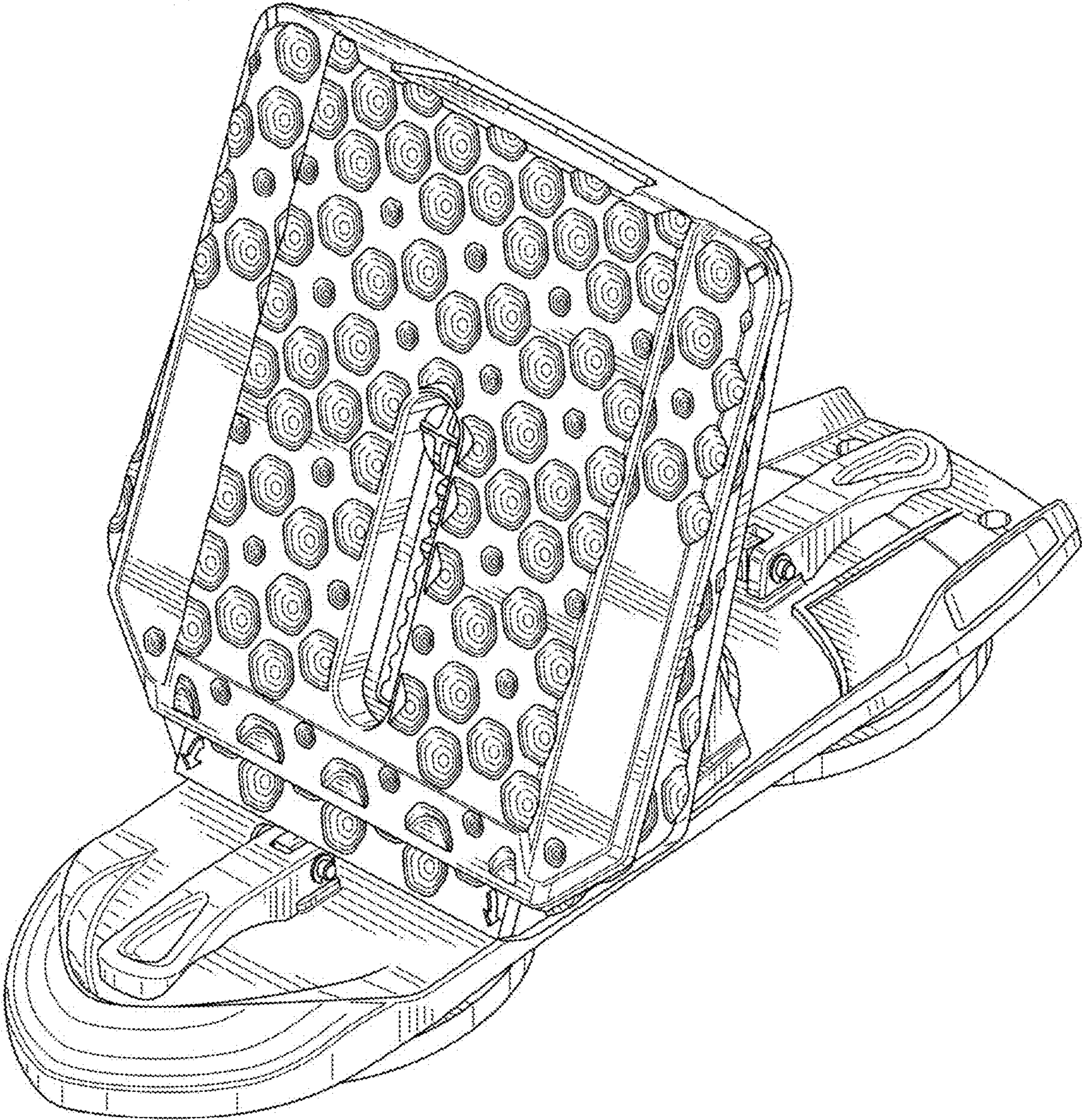

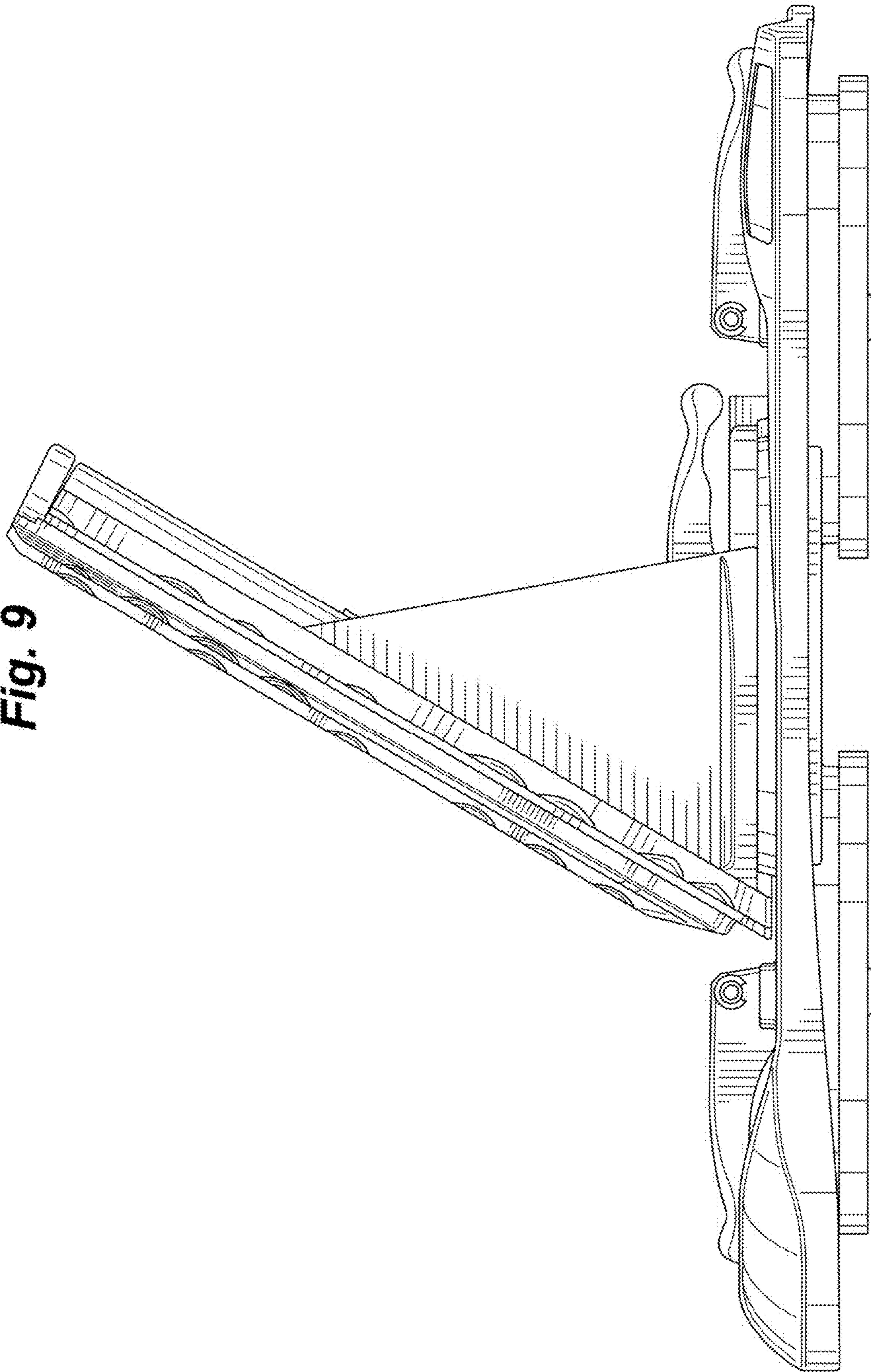

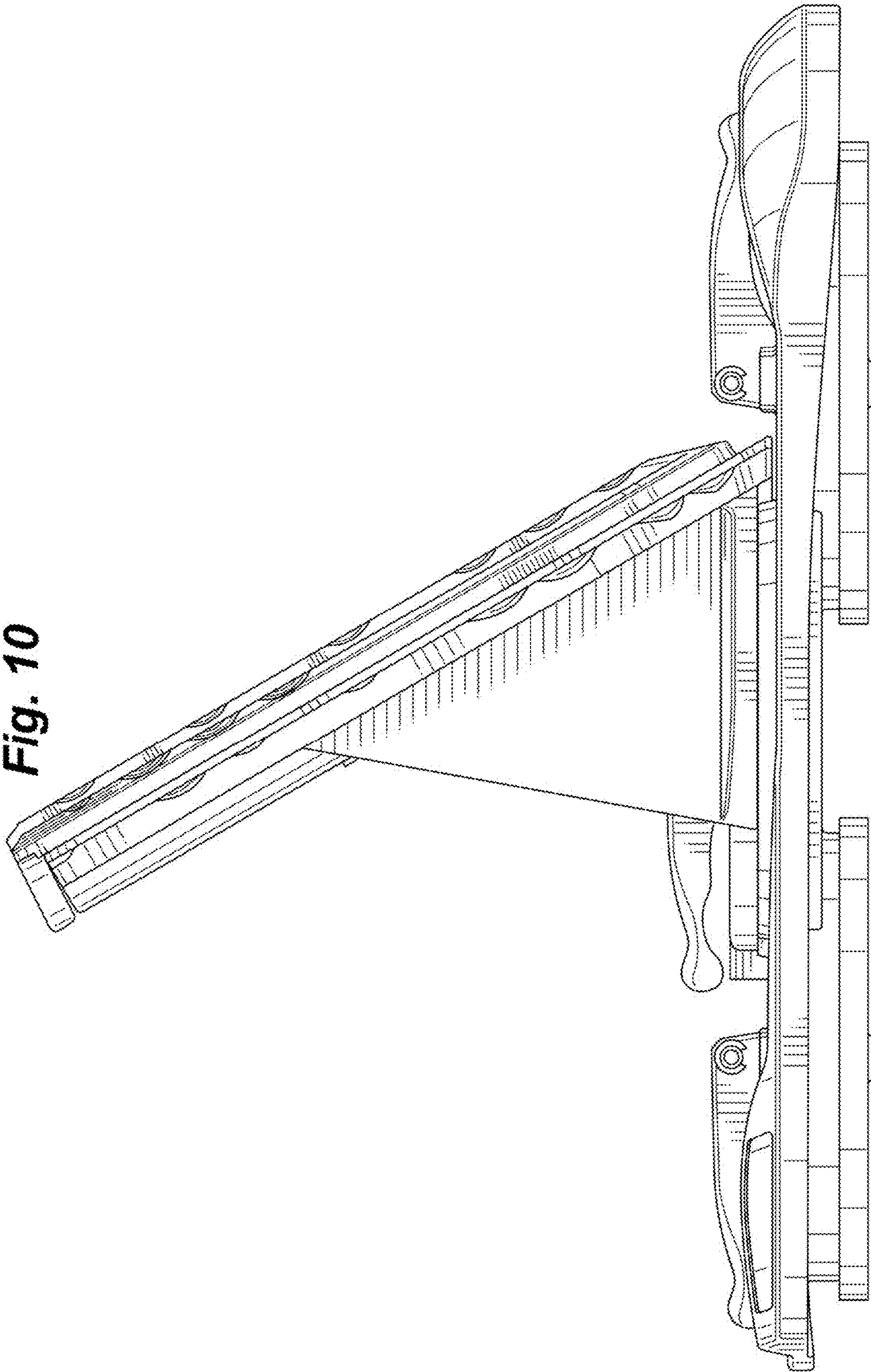

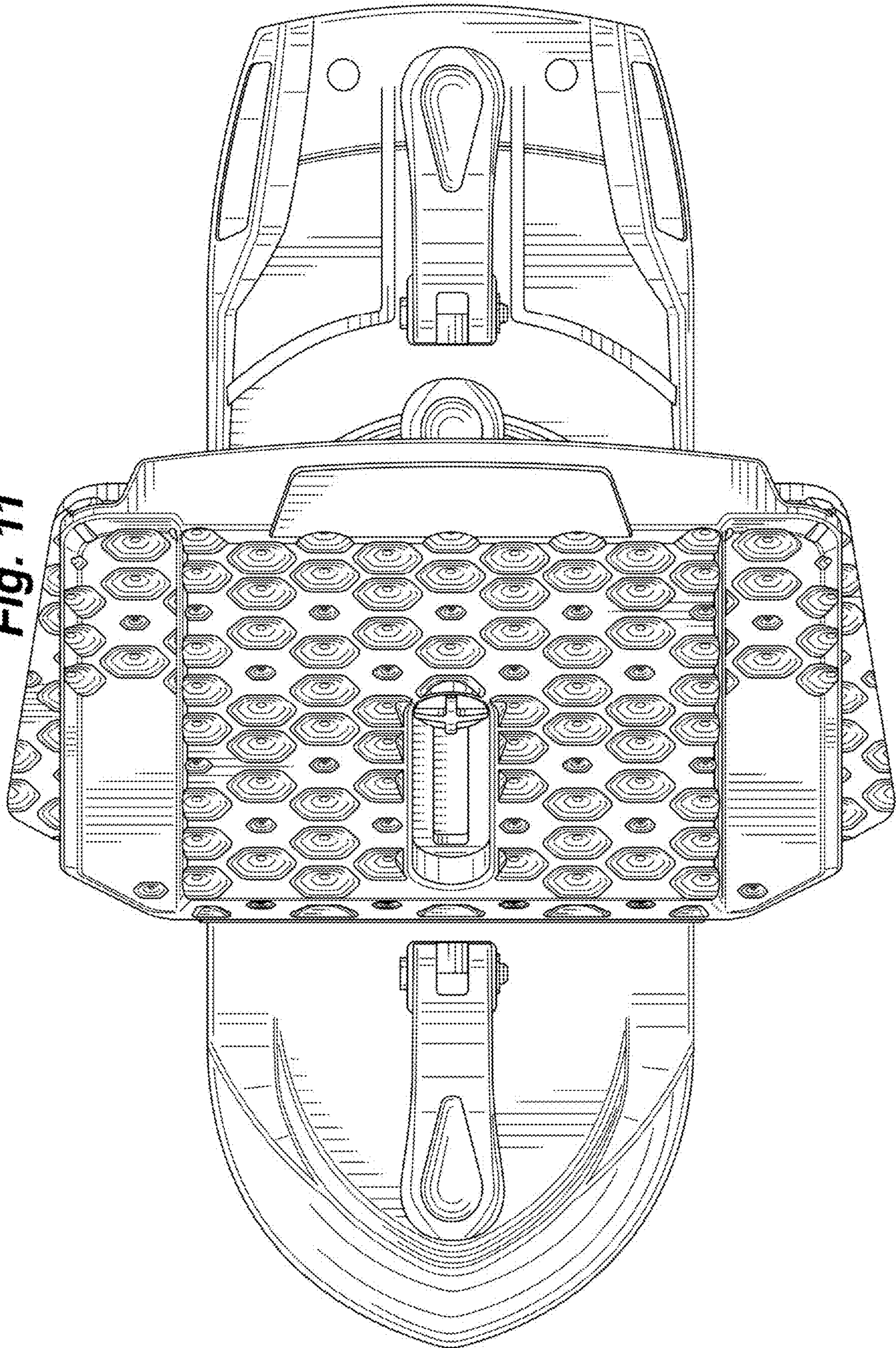

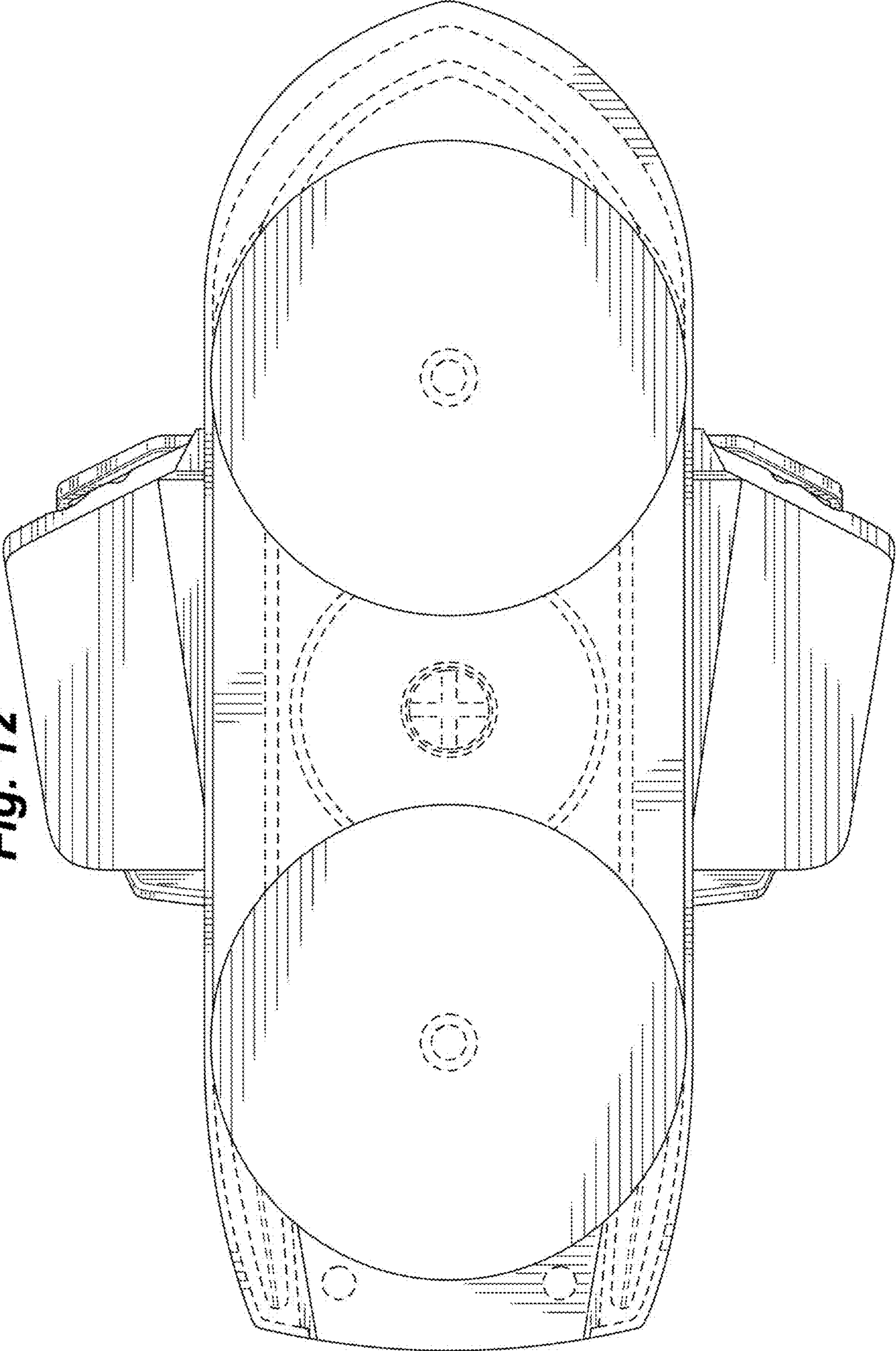

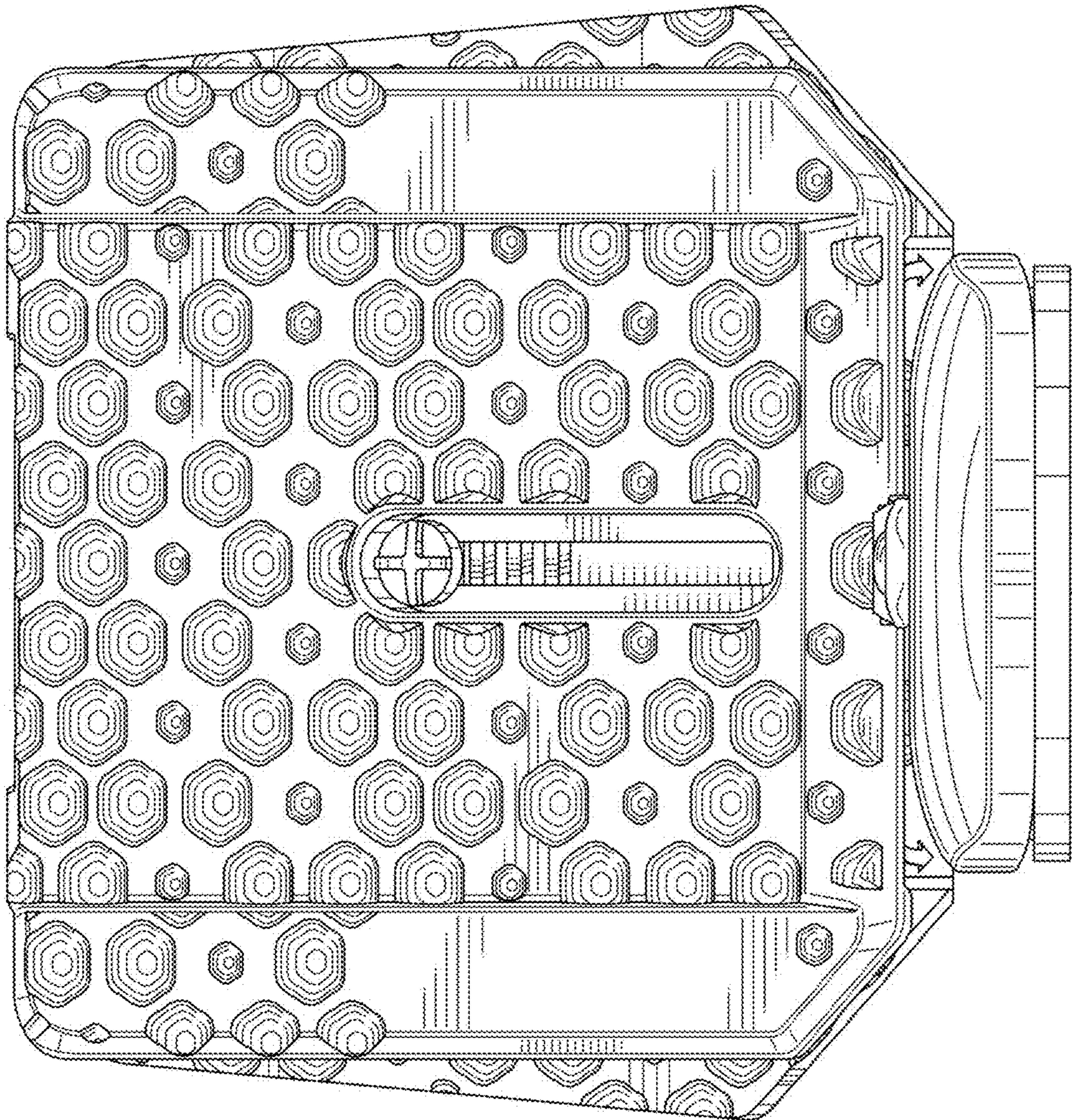

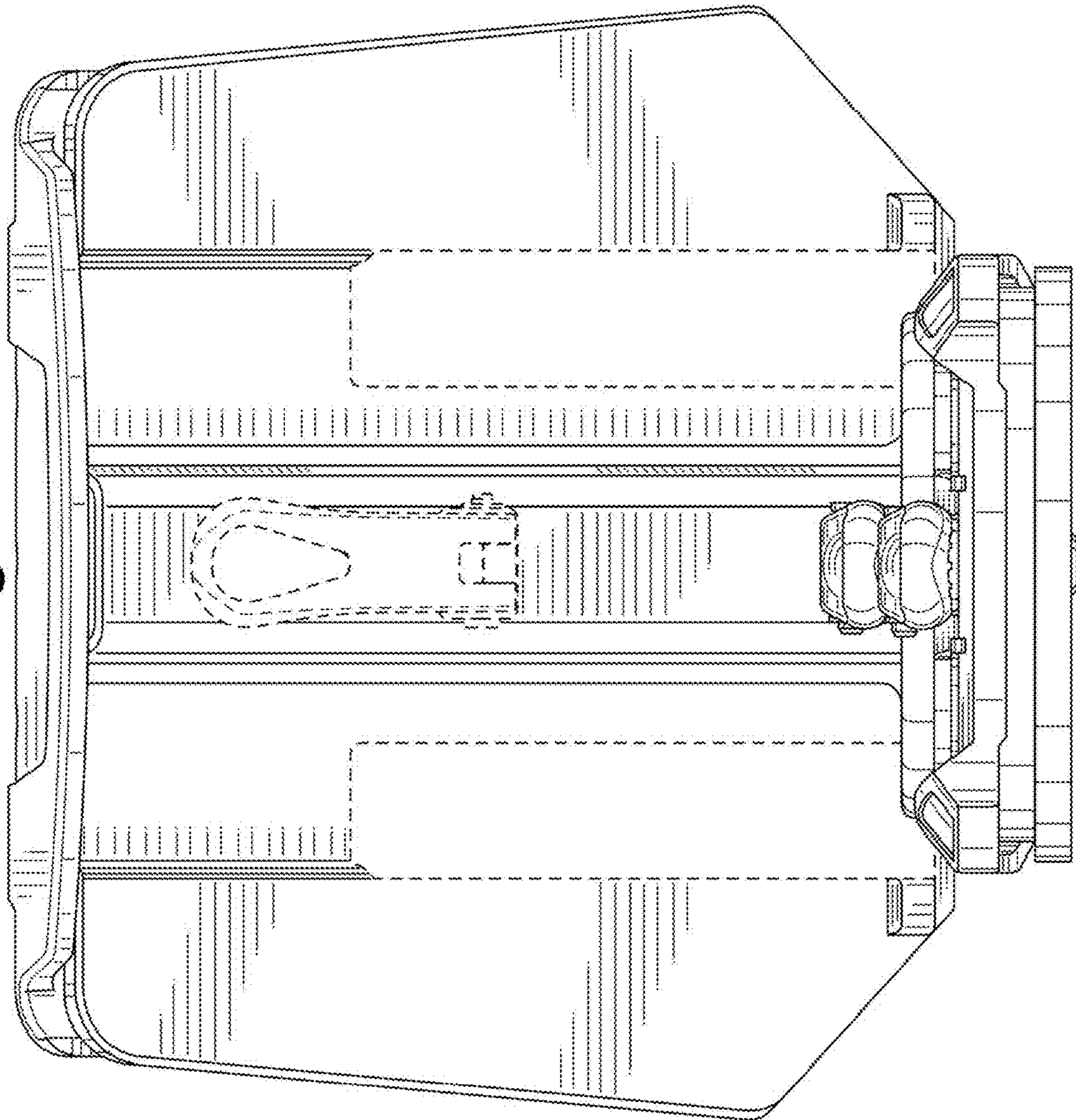
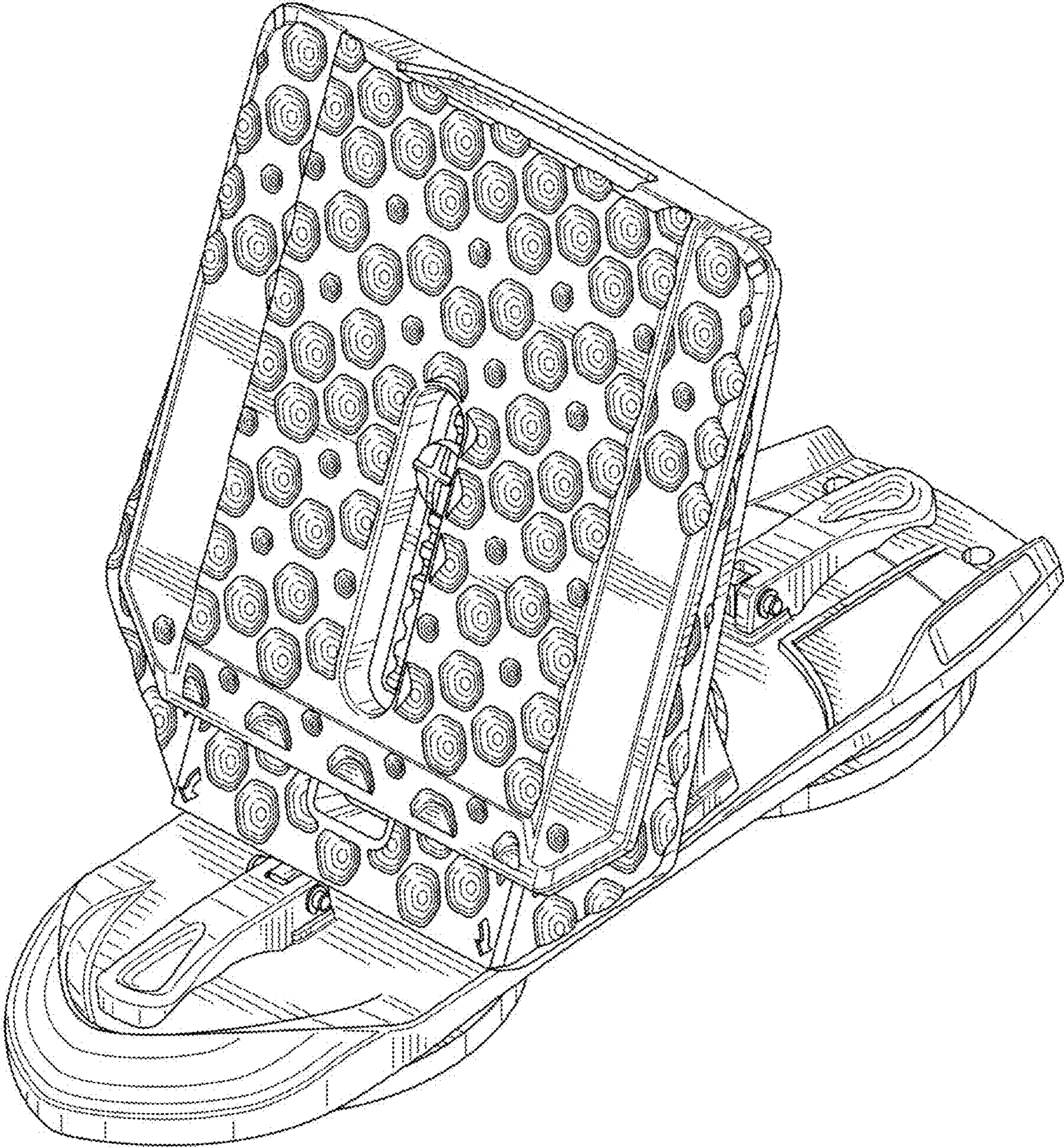

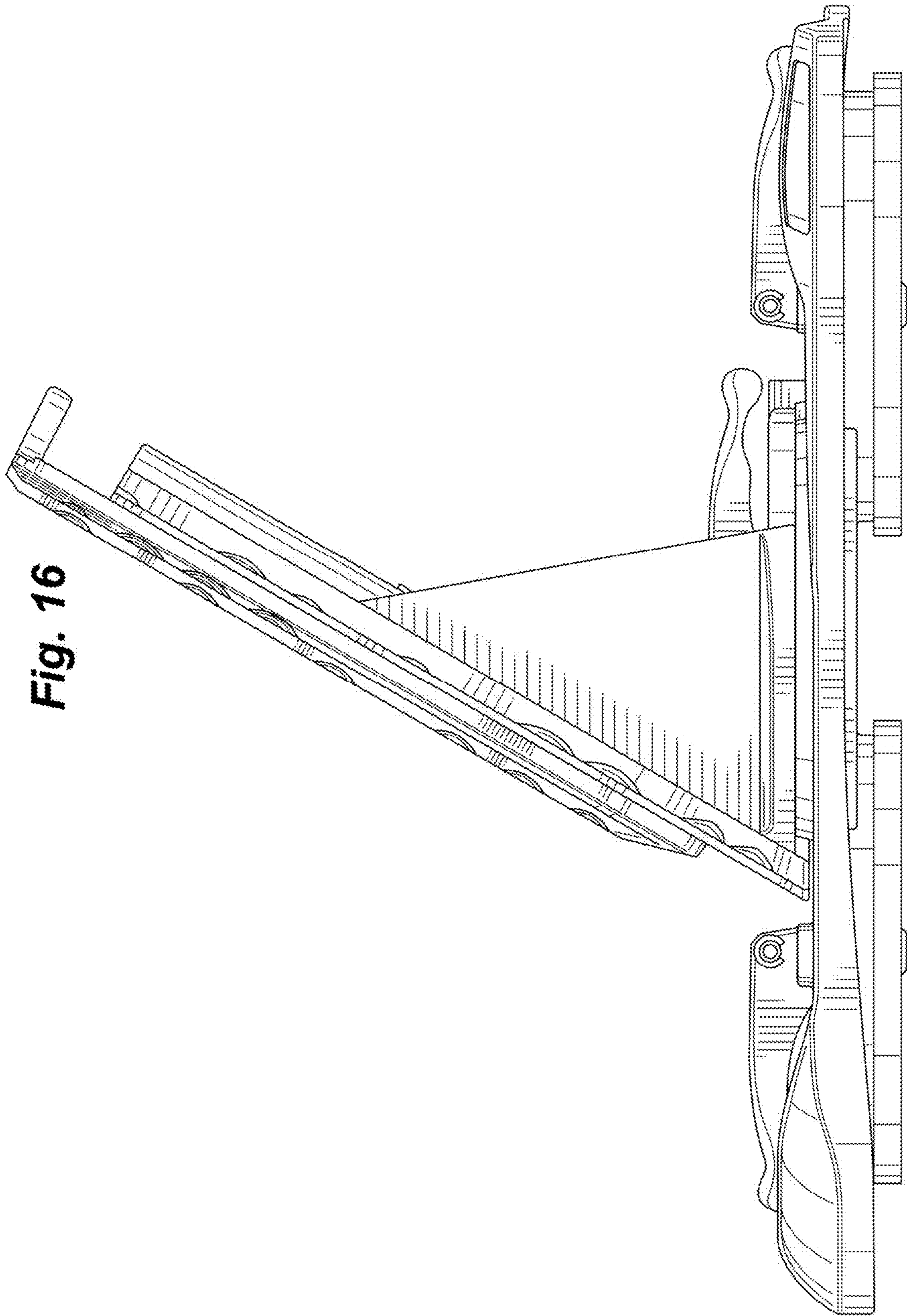

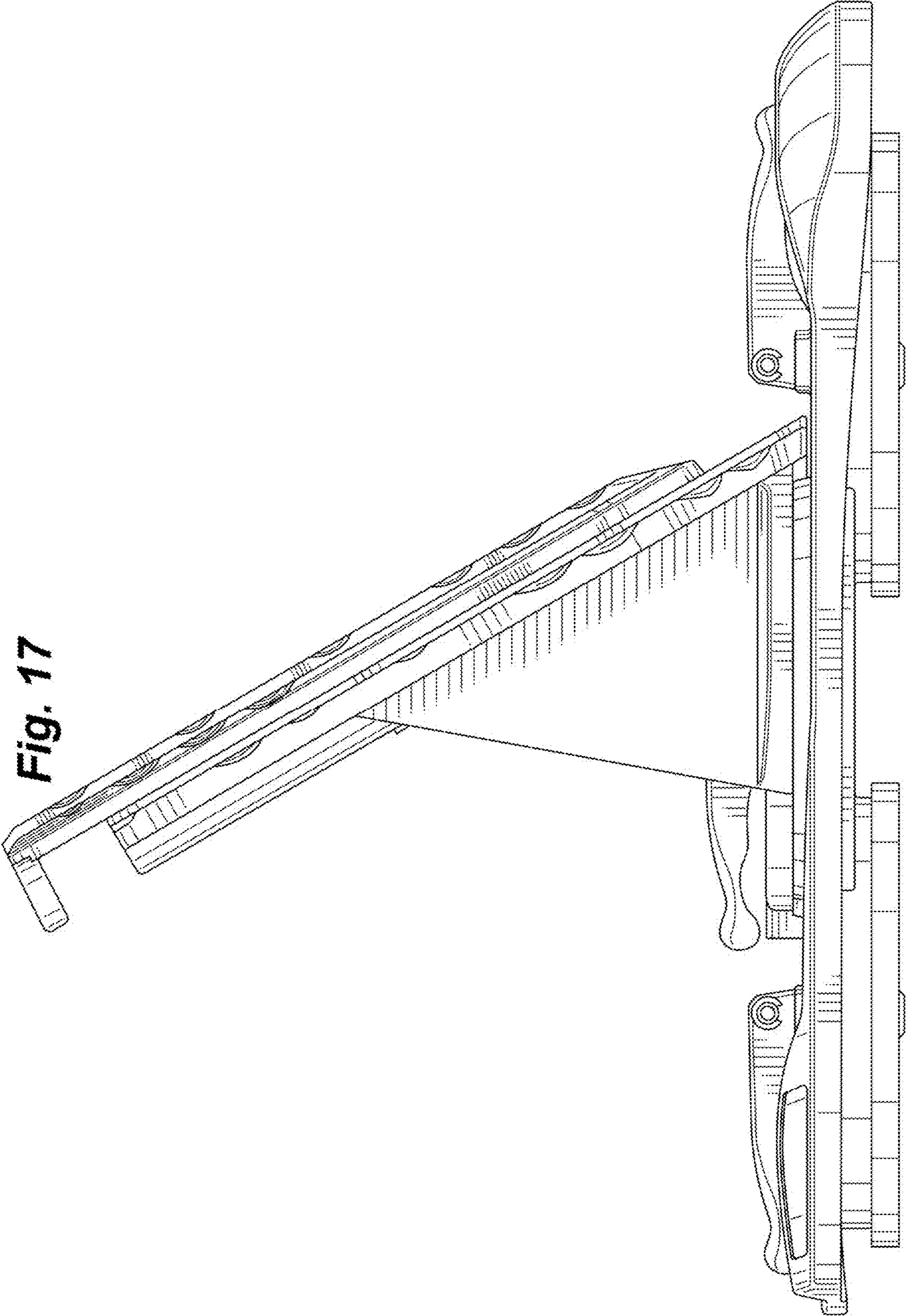

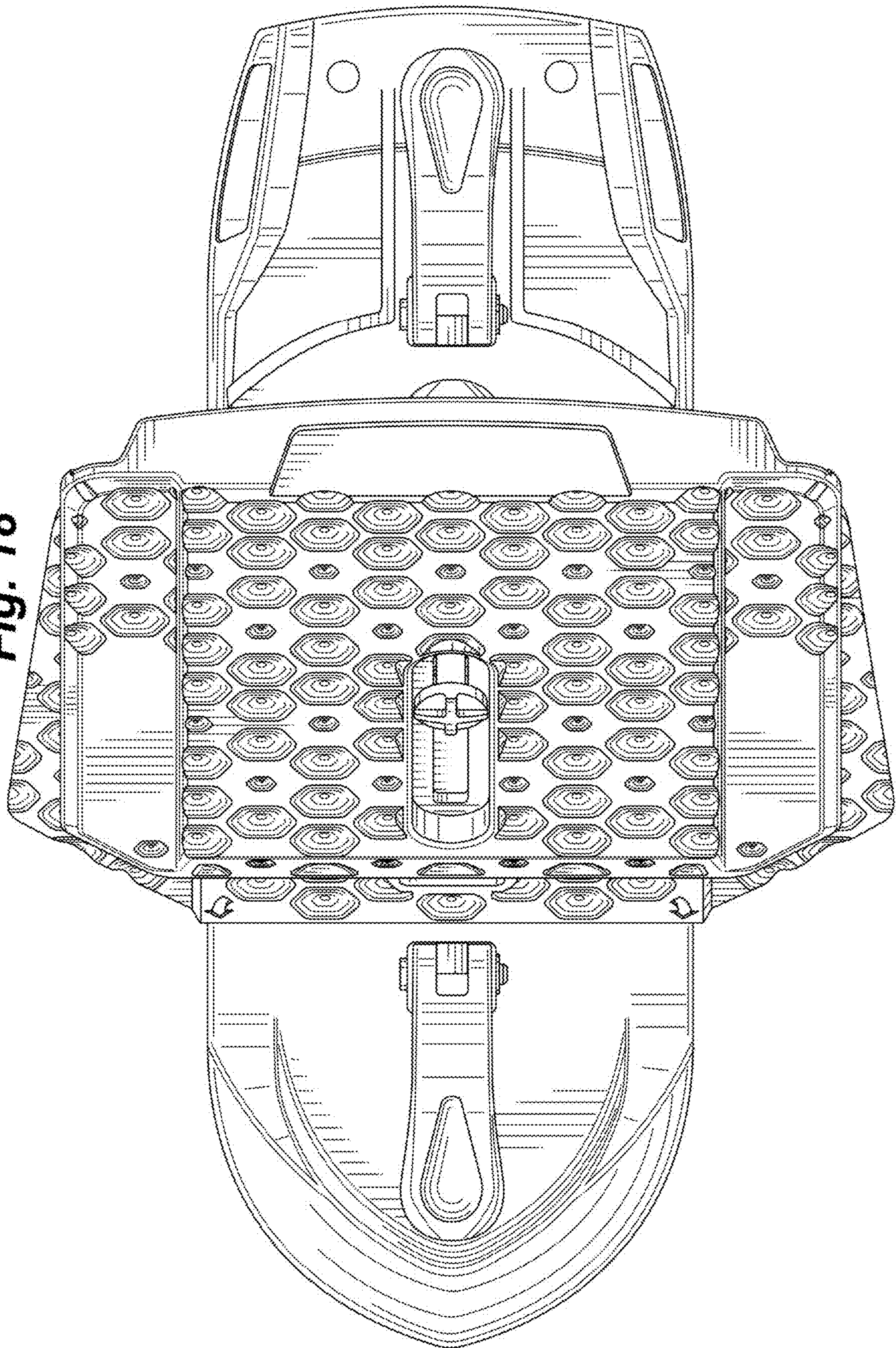
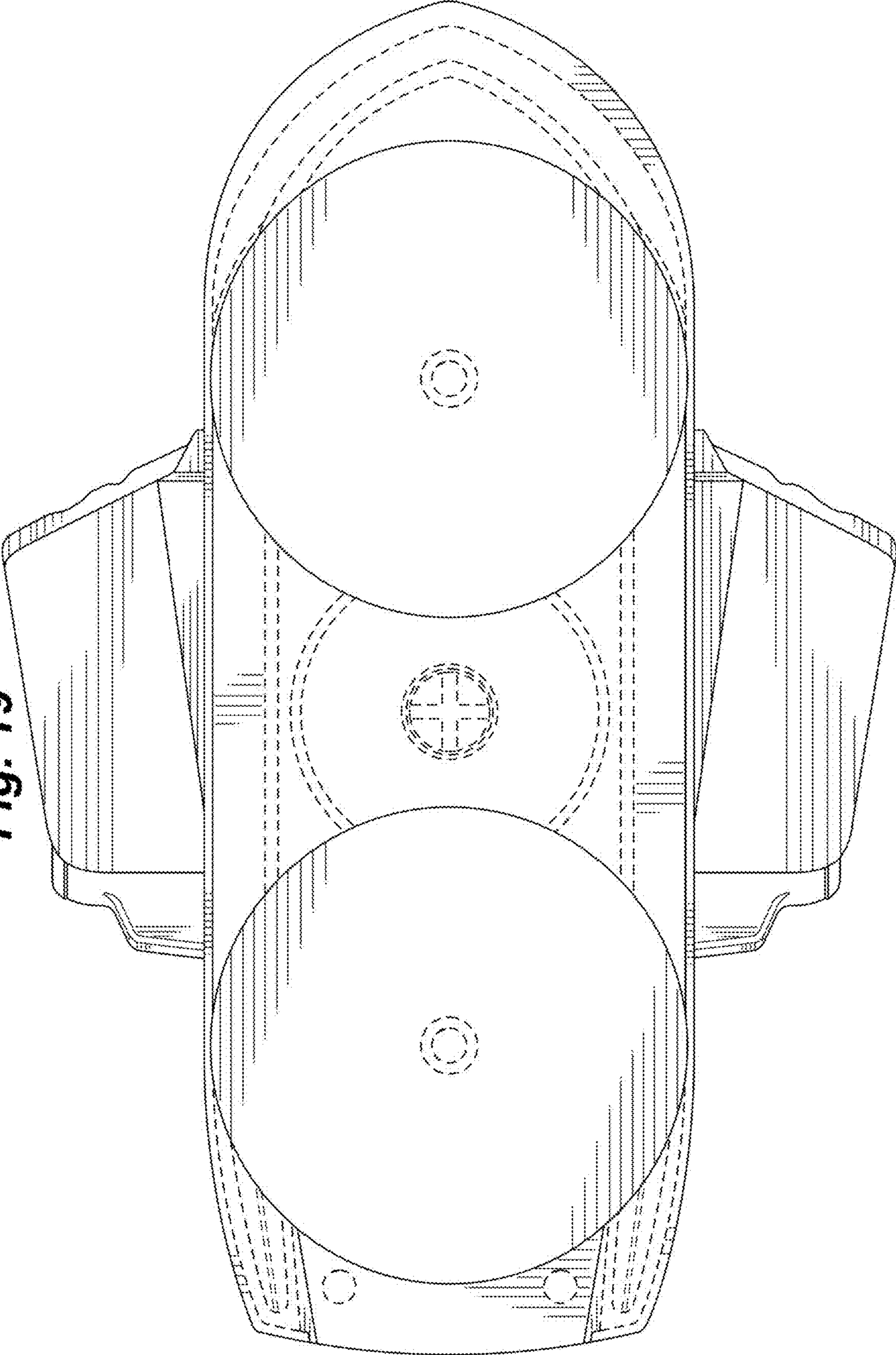

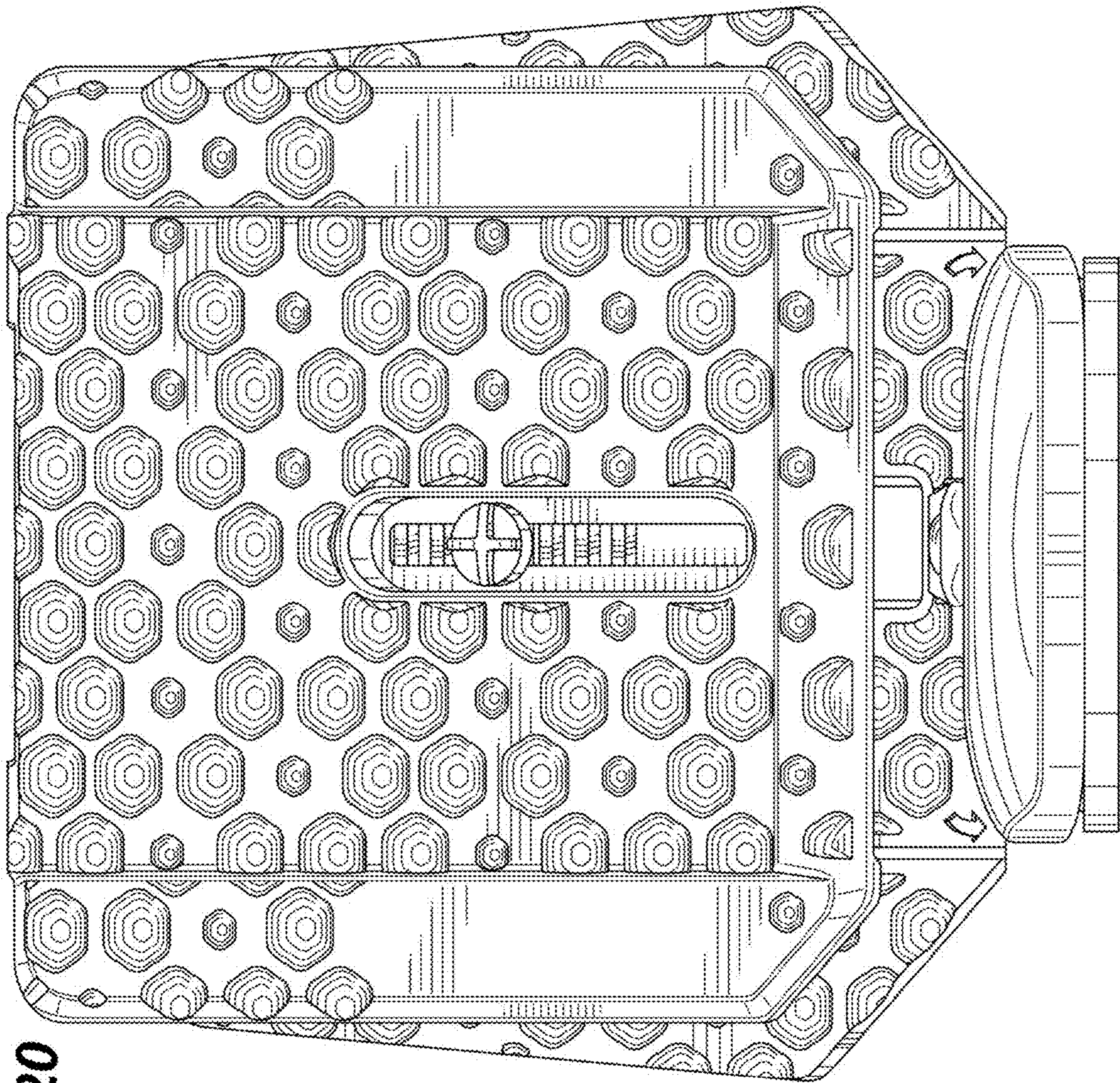

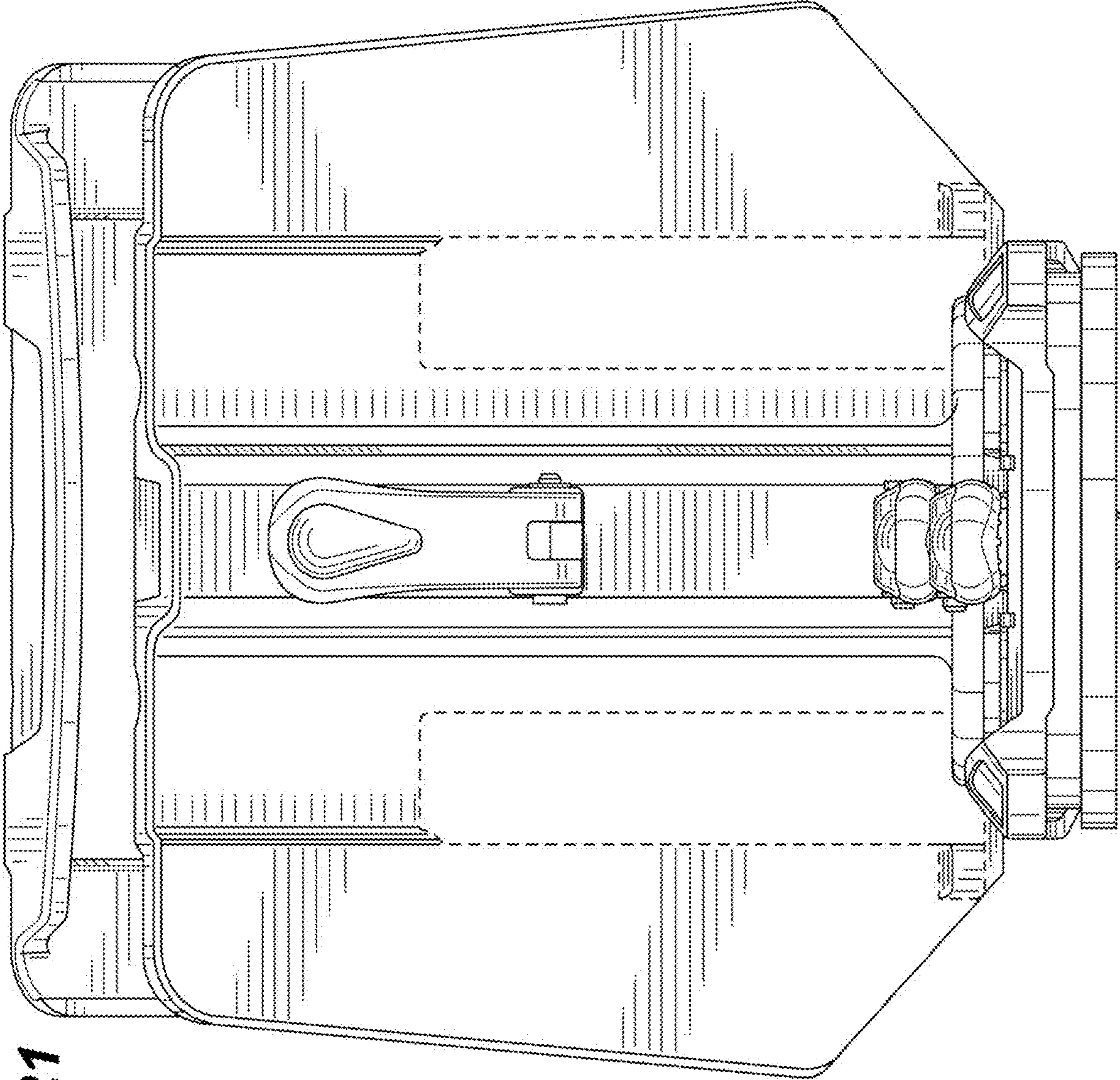
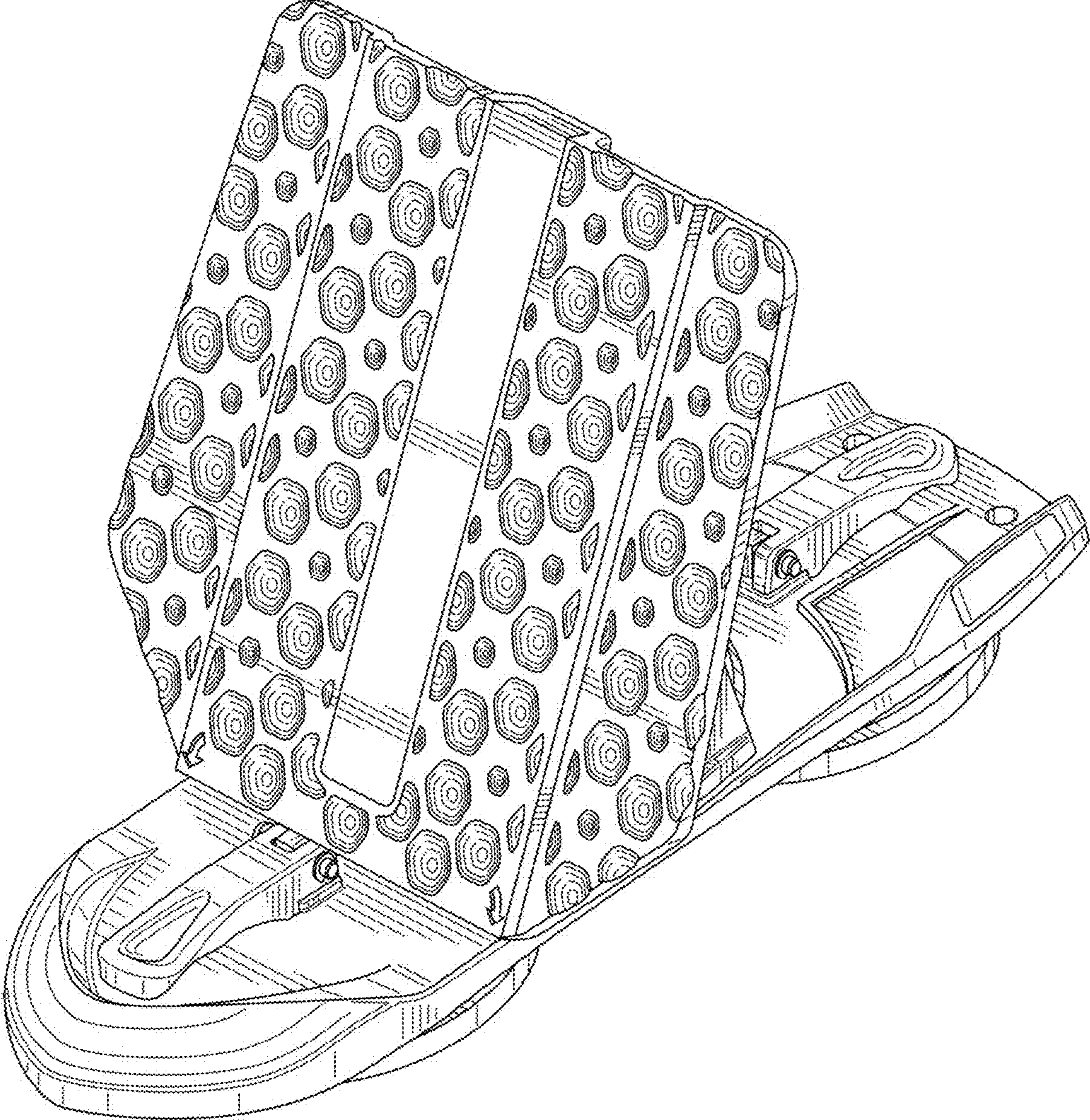

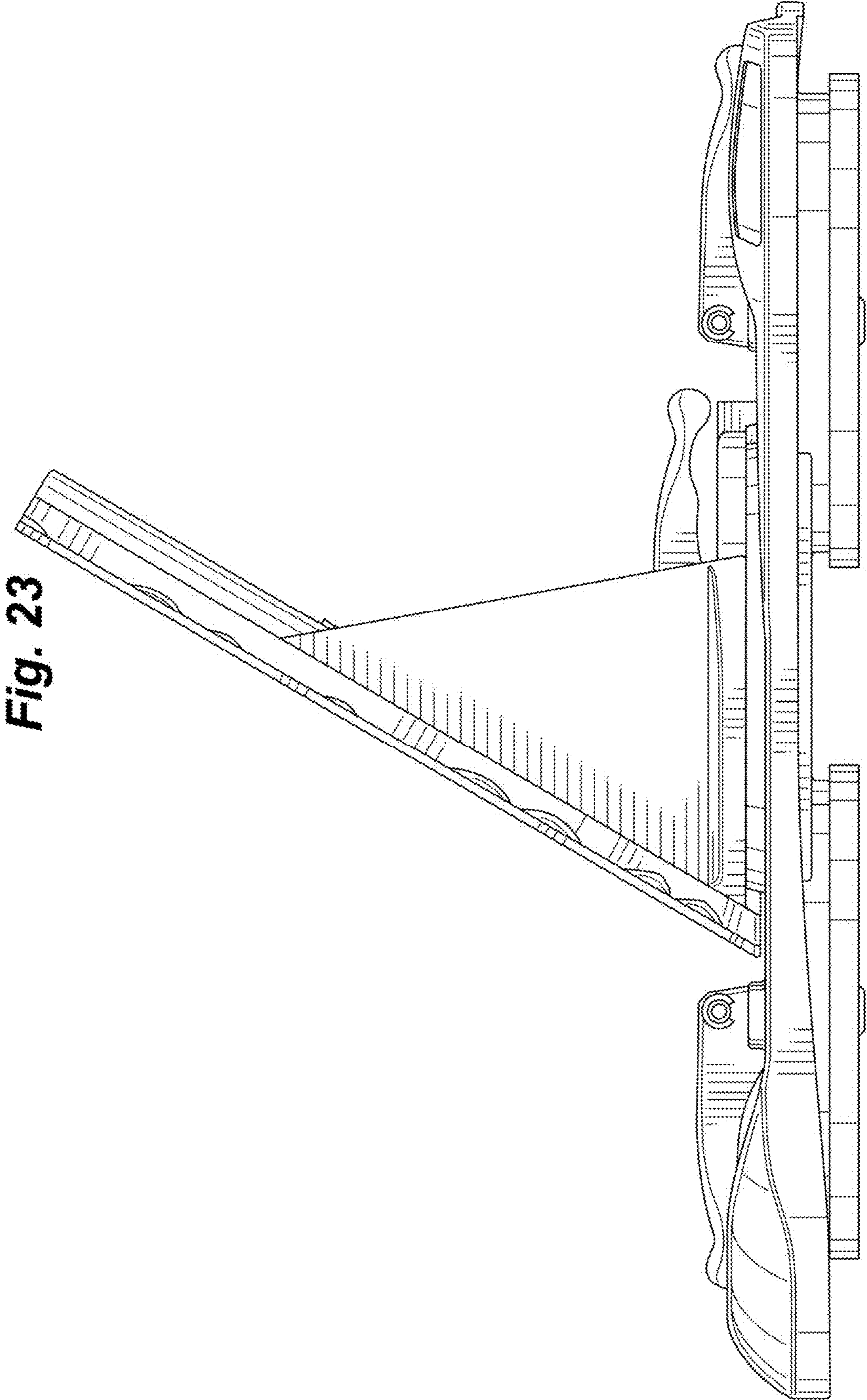

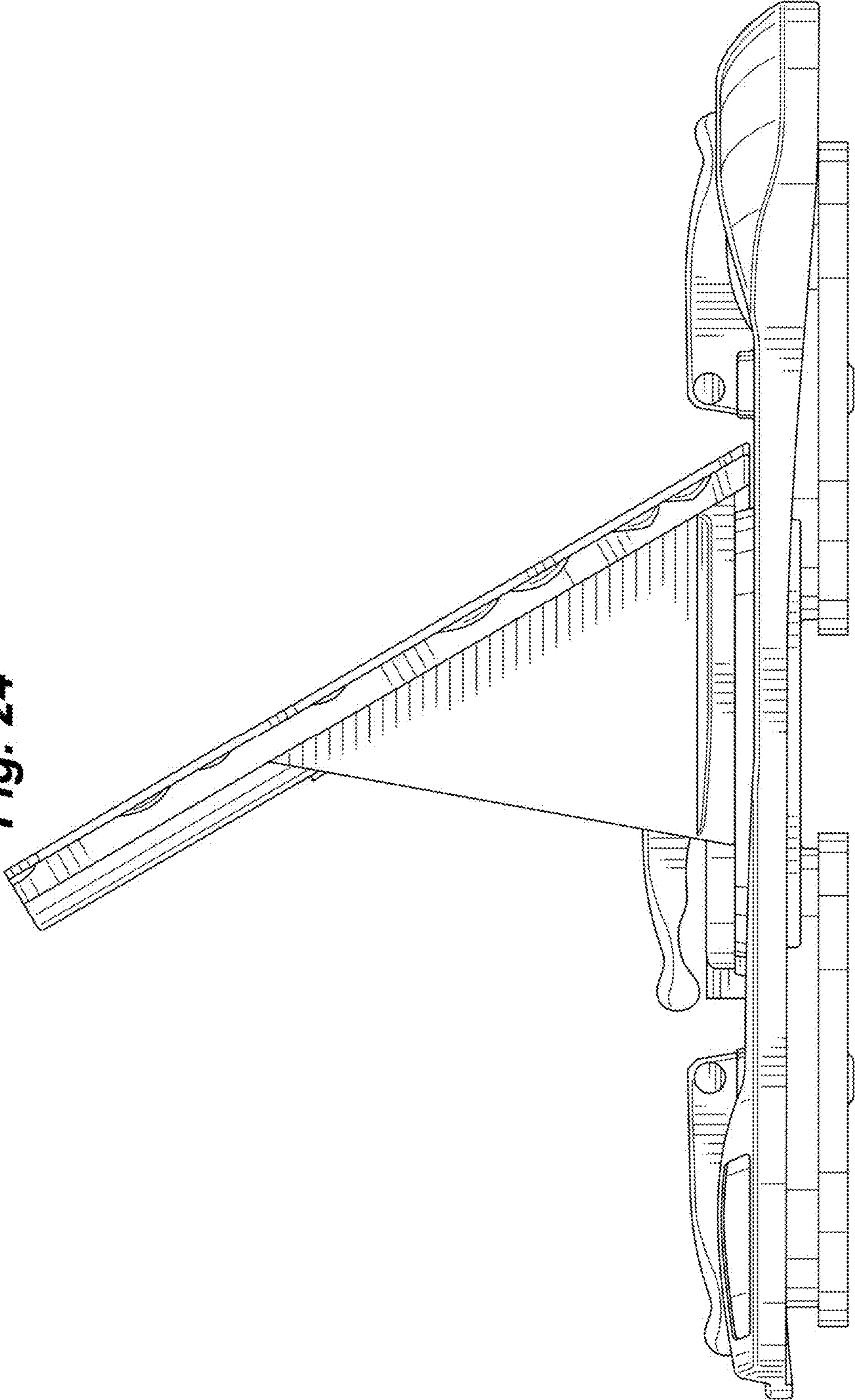

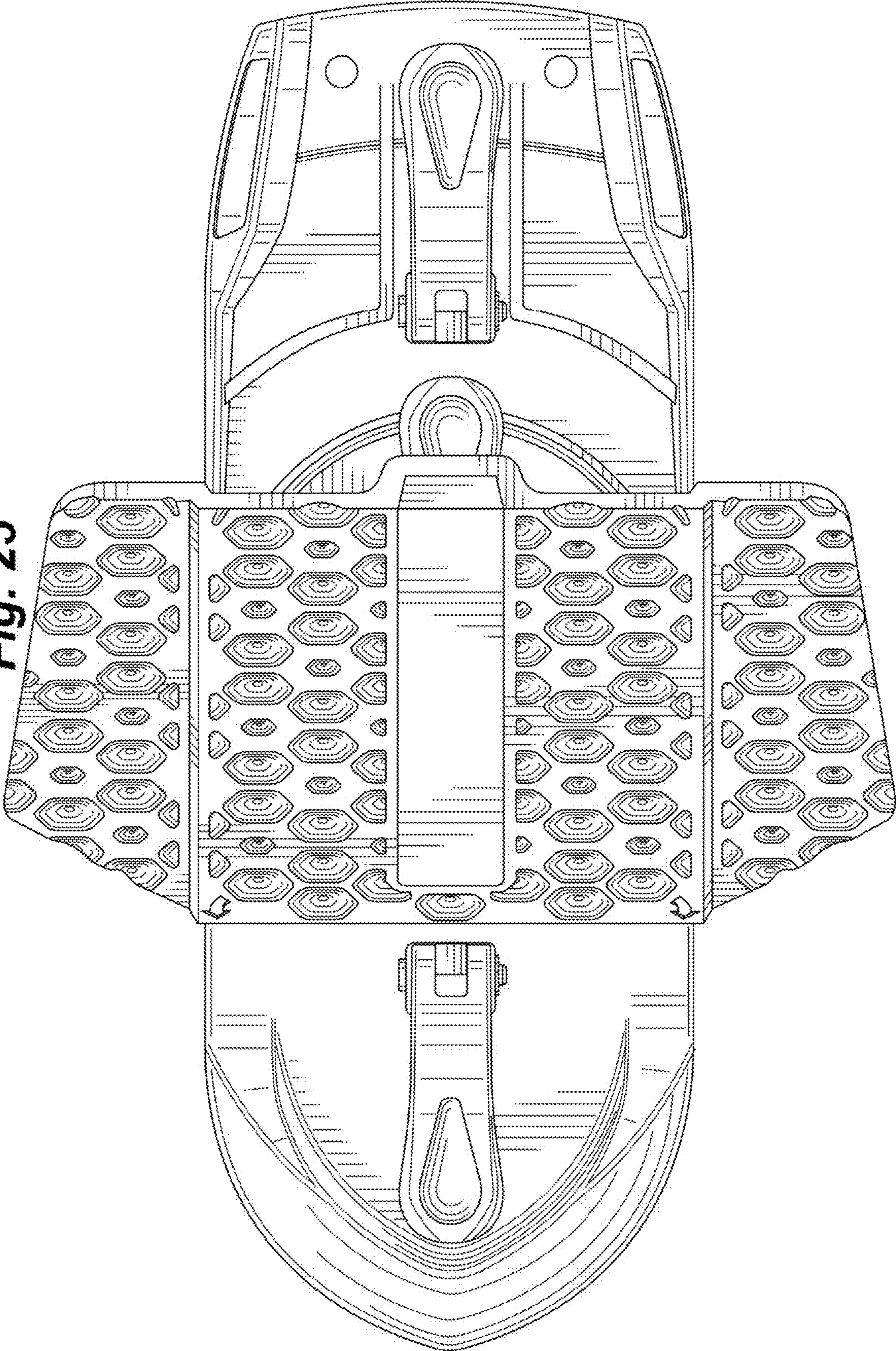

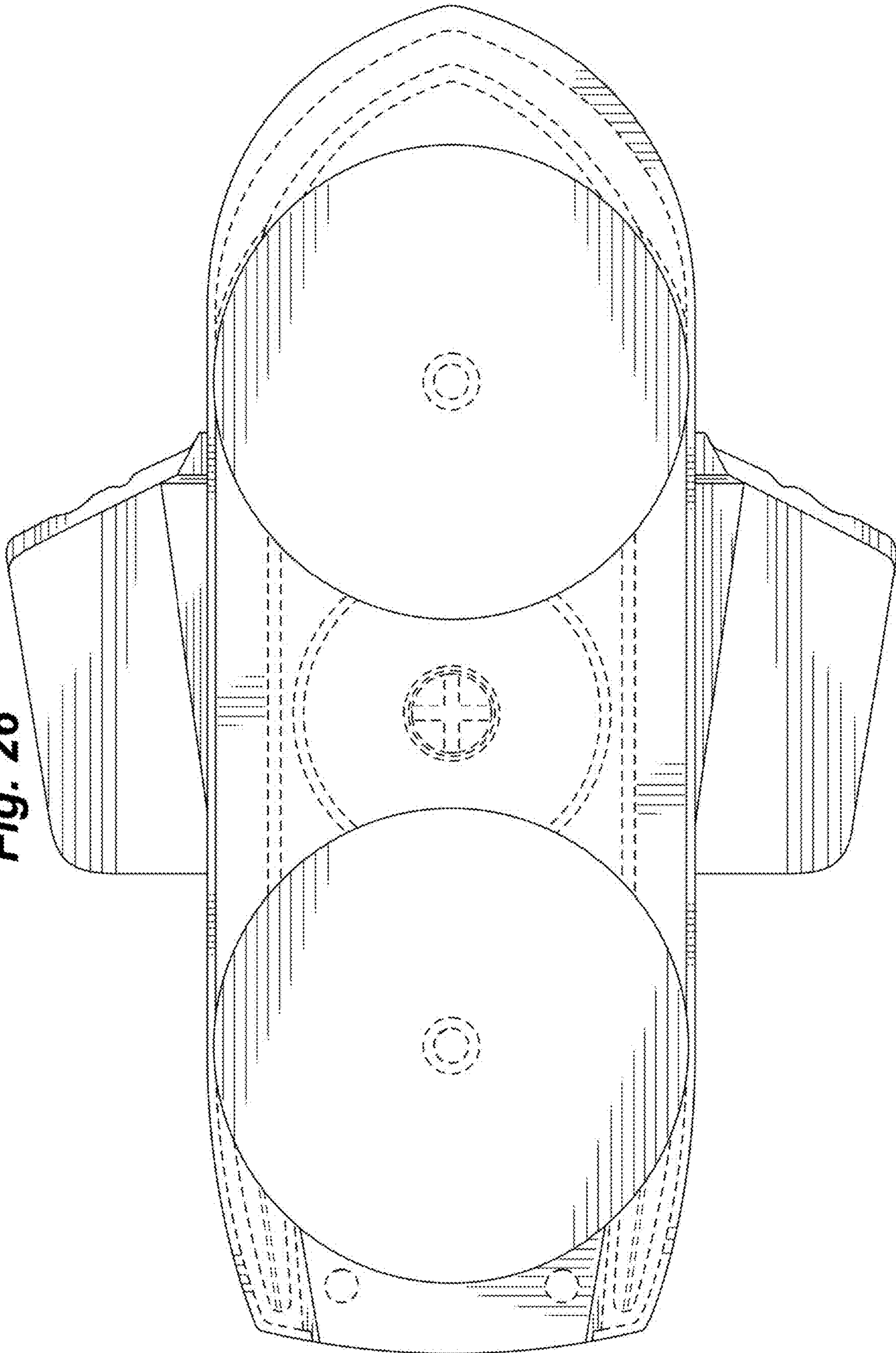

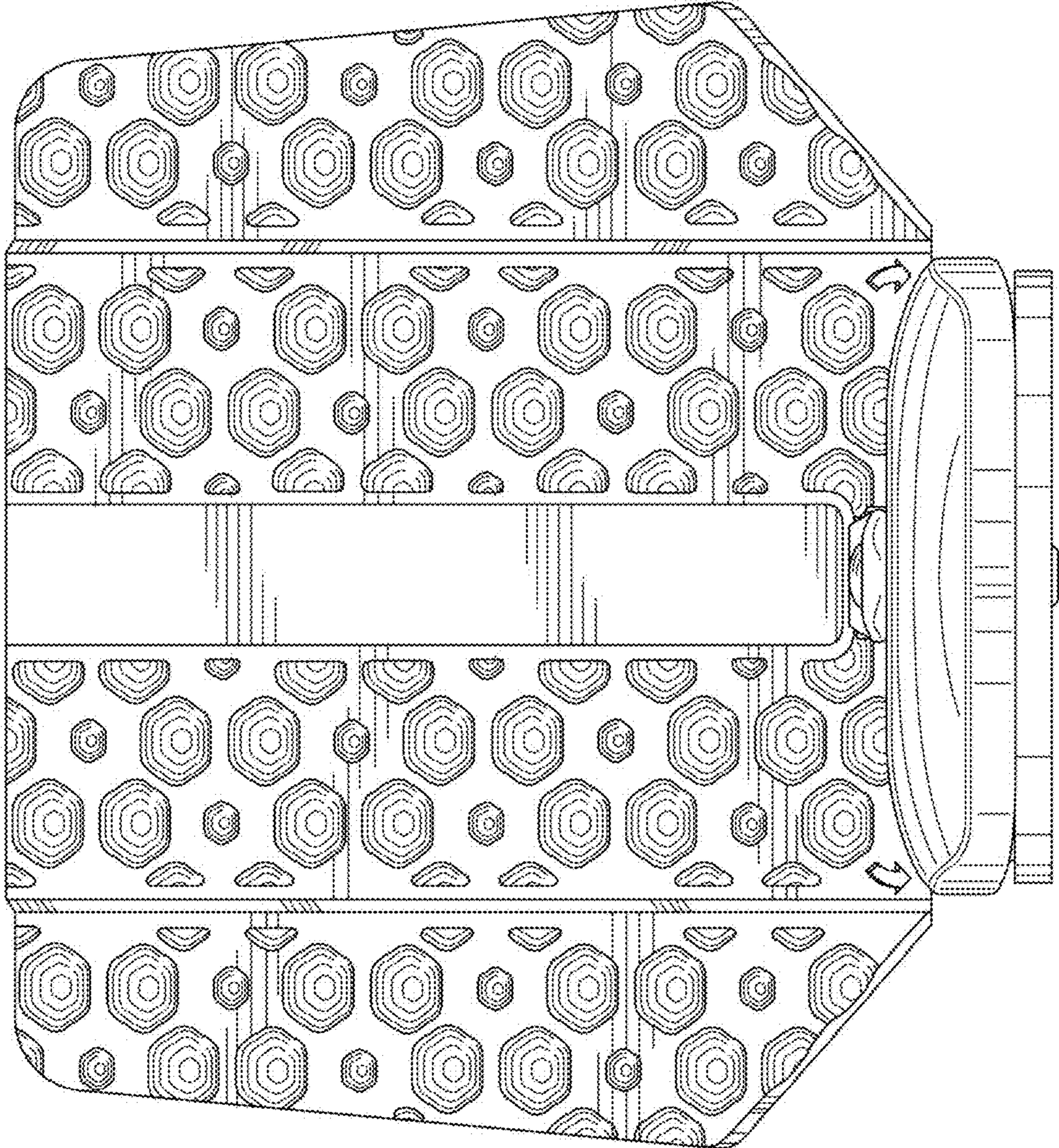
