The broken lines in the figures depict portions of the multifunction adapter that form no part of the claimed design.

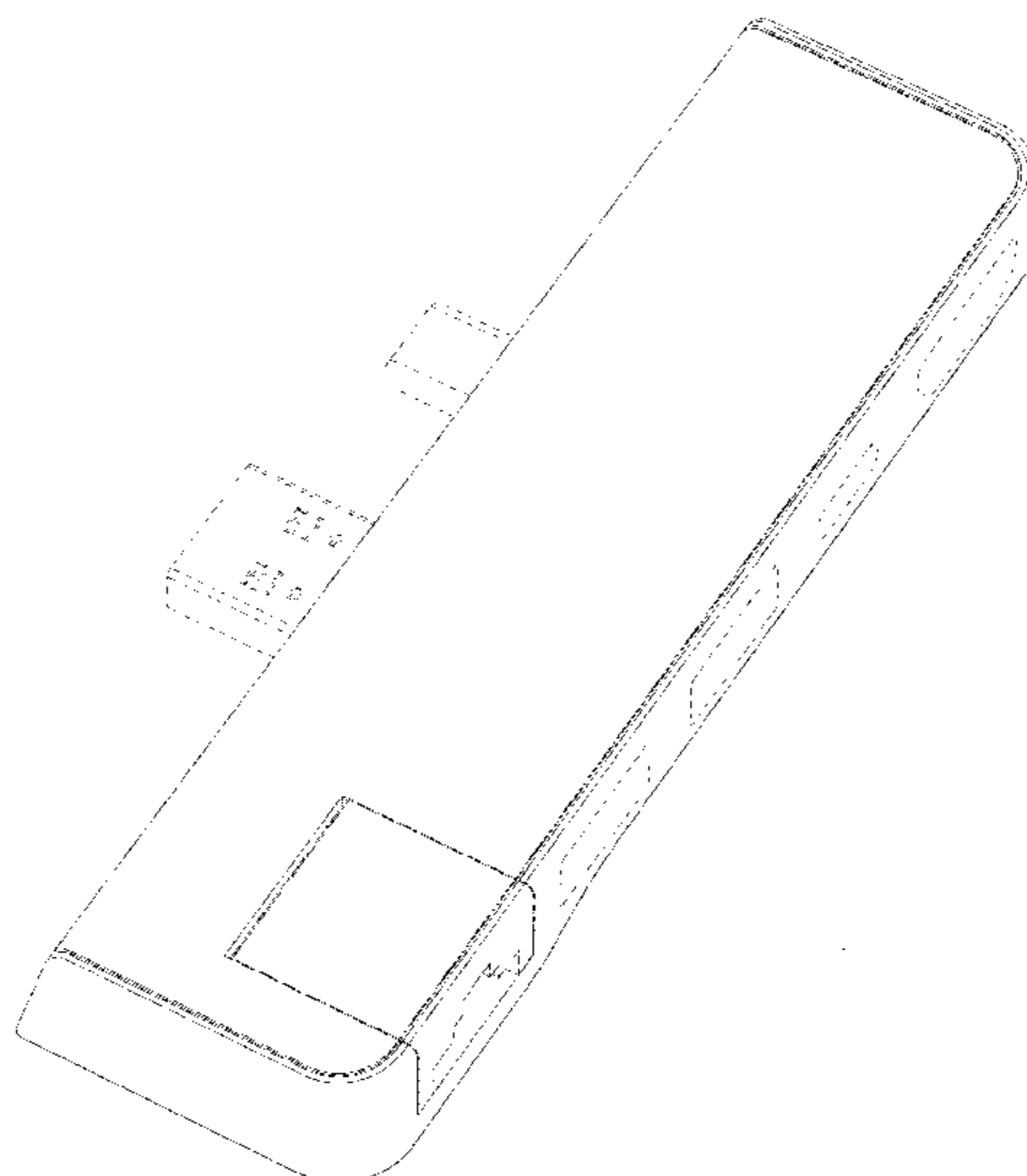

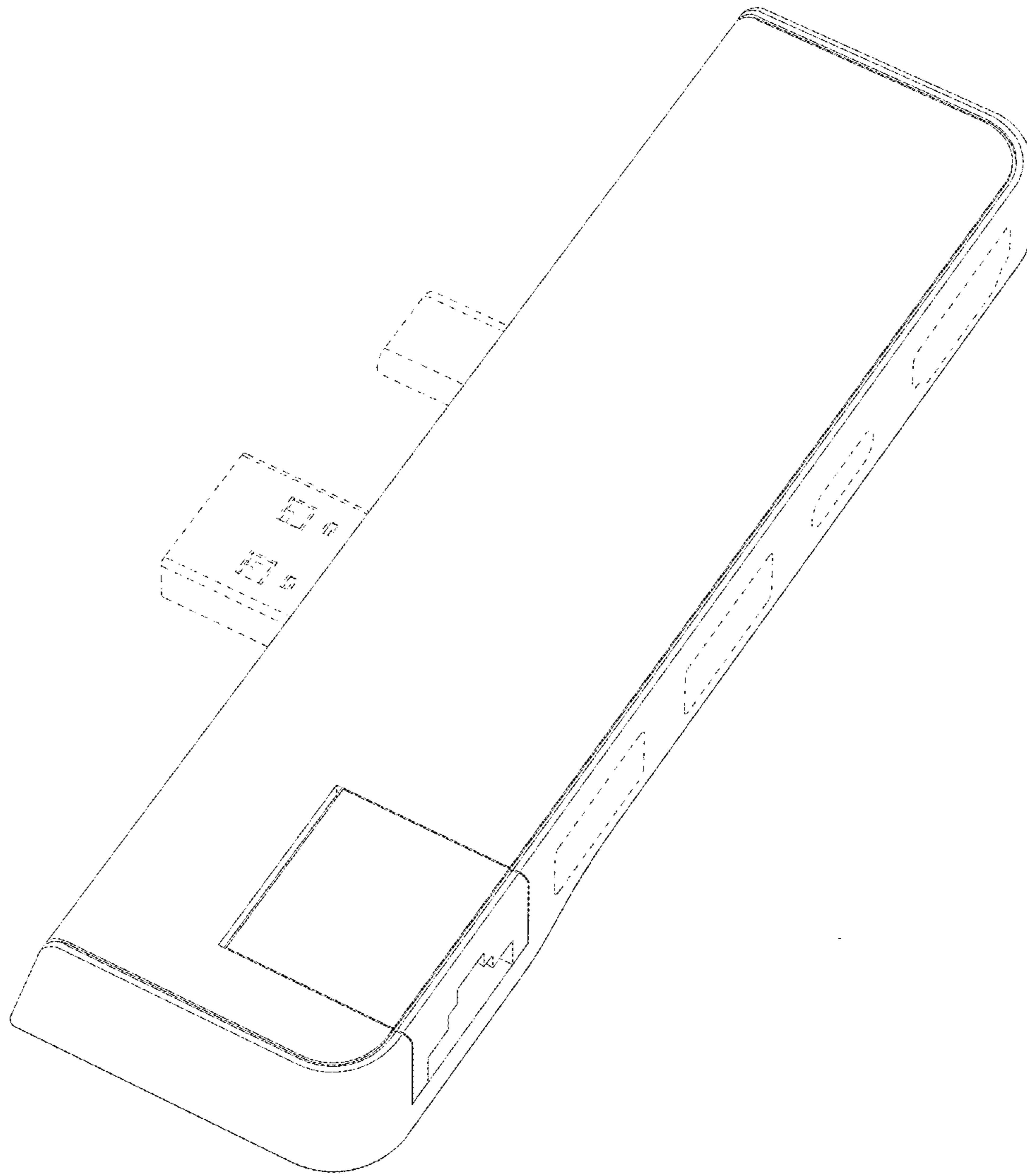

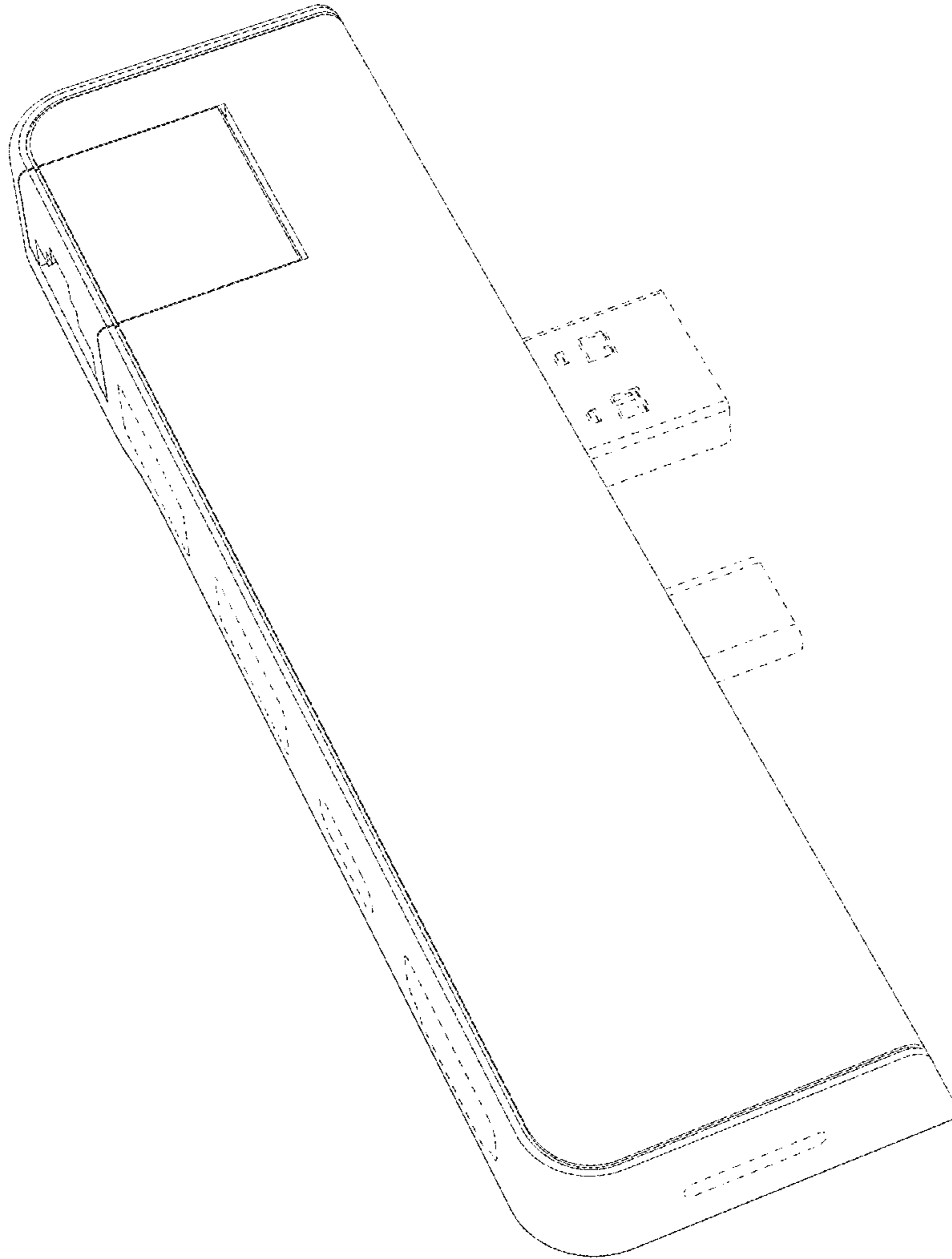

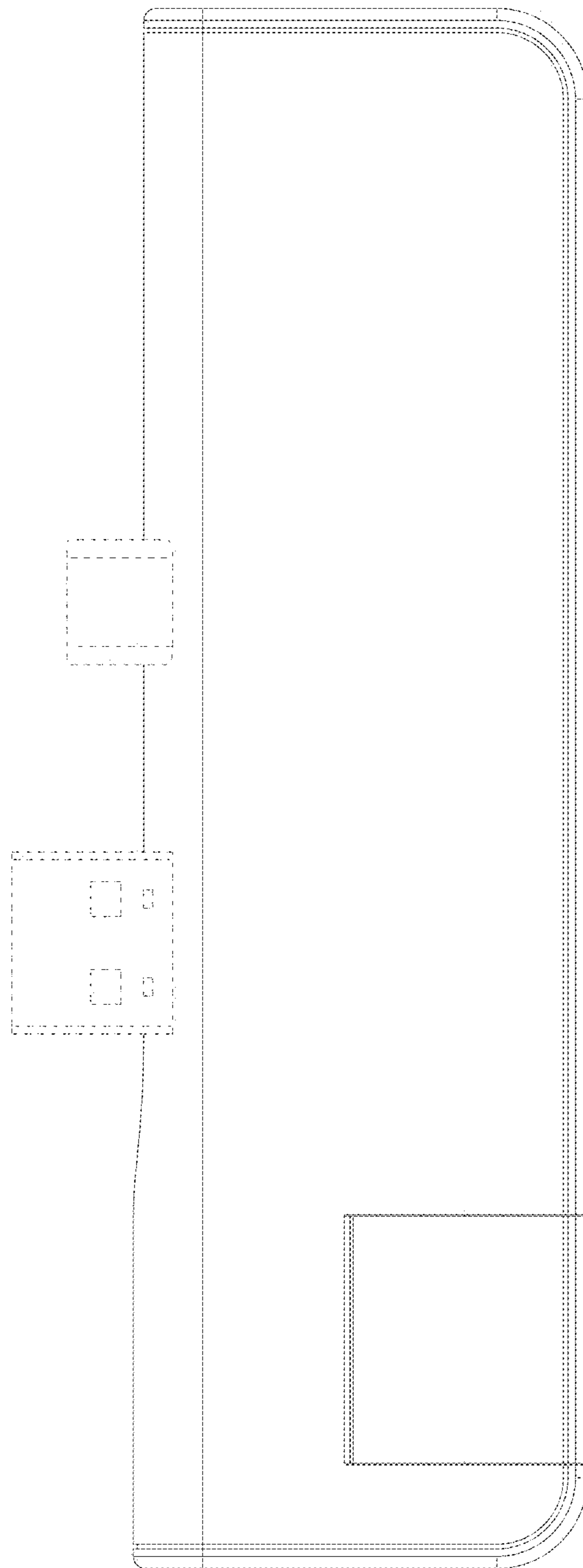

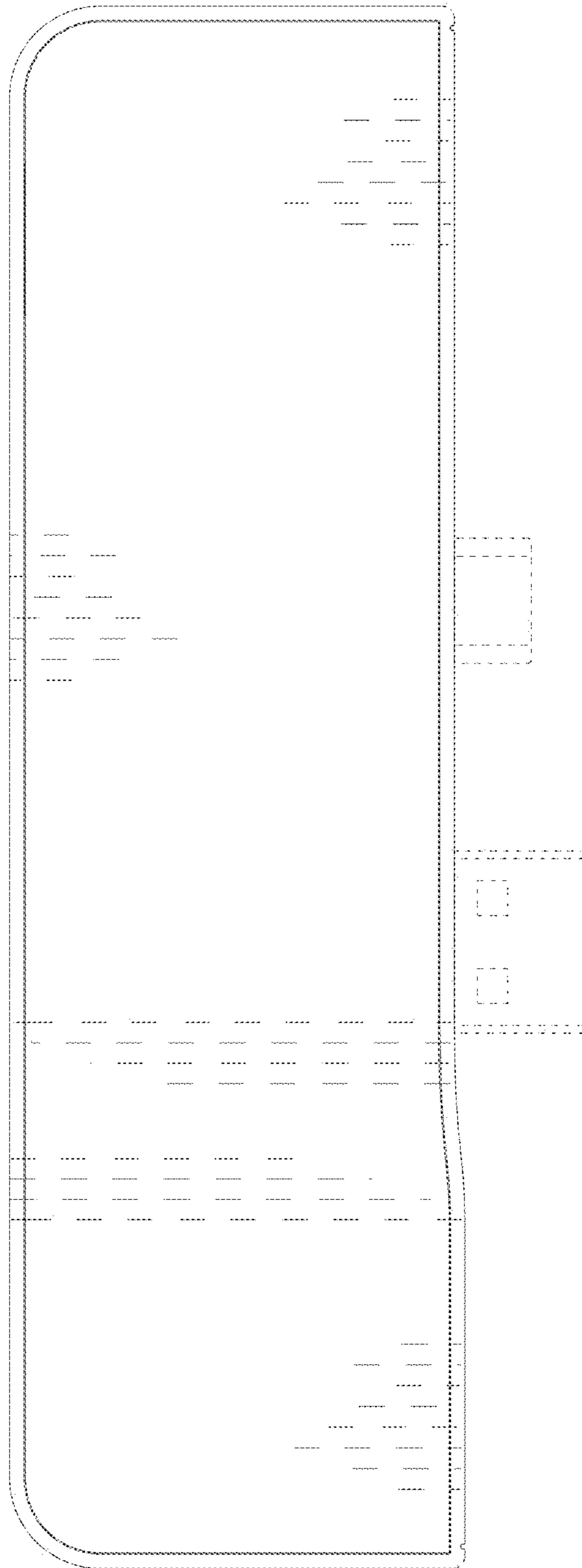

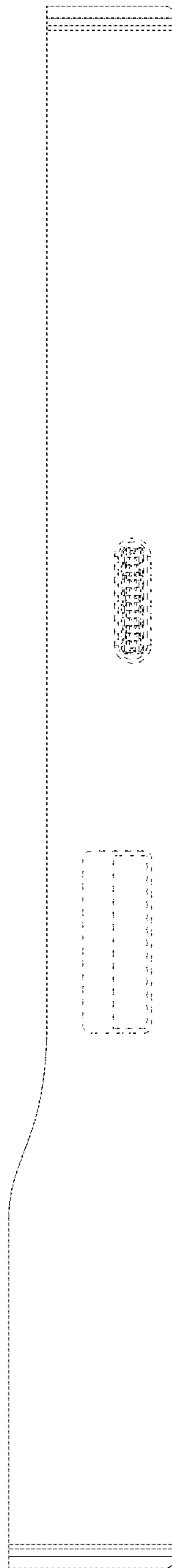

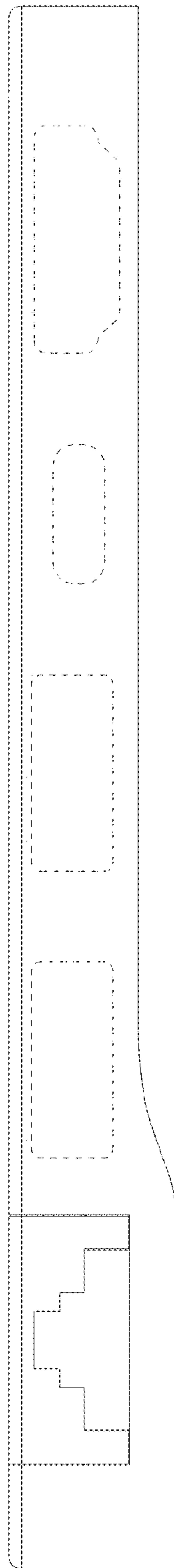

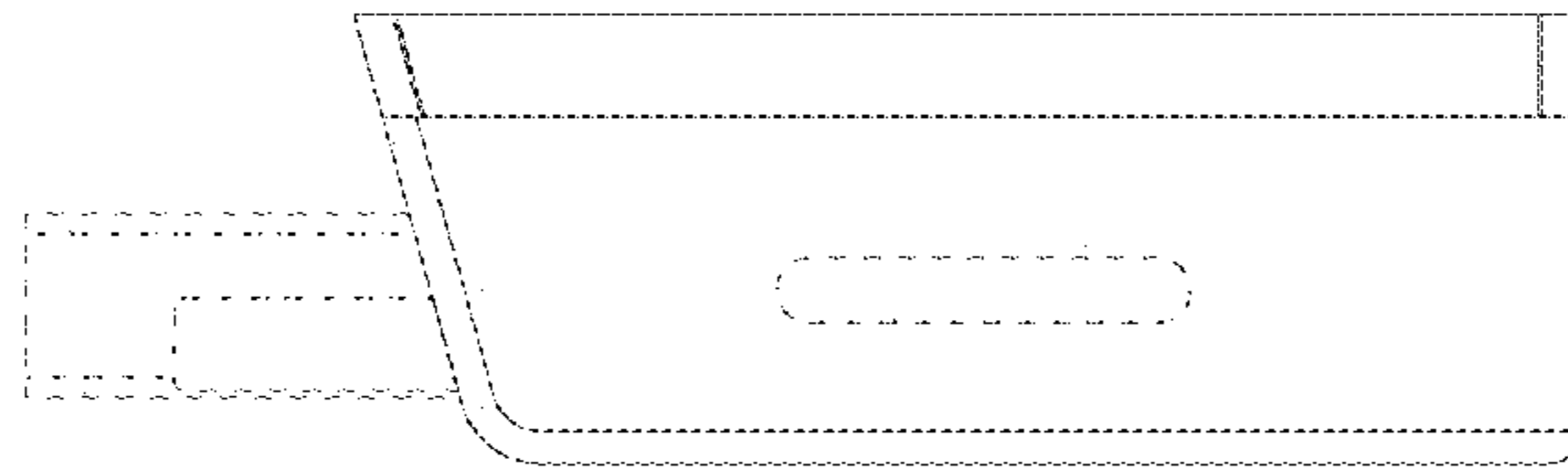

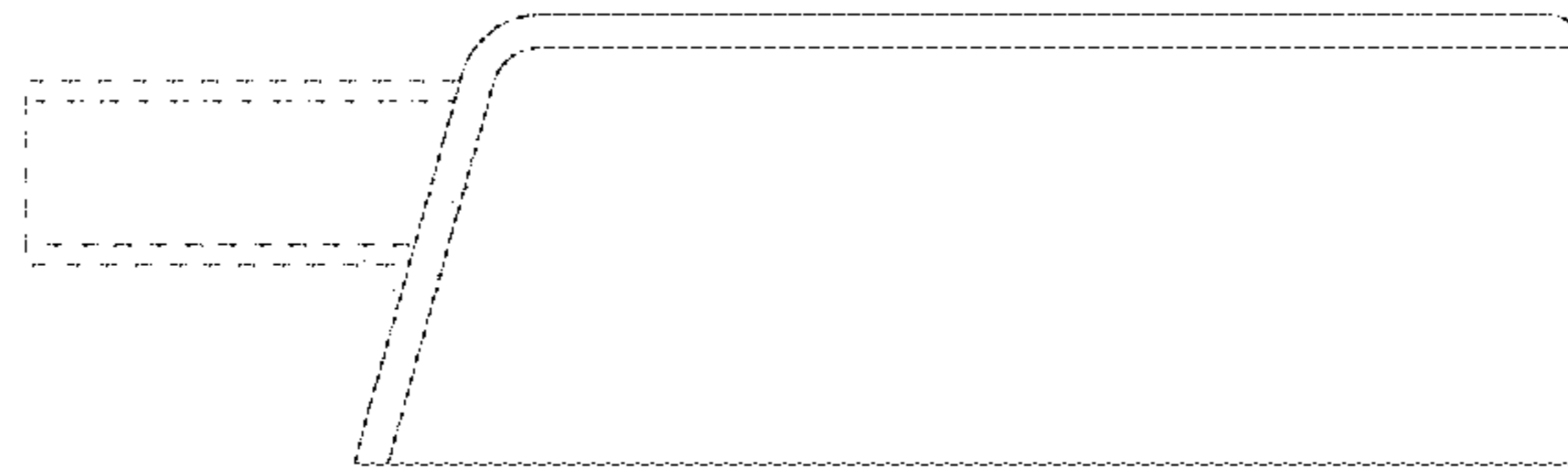

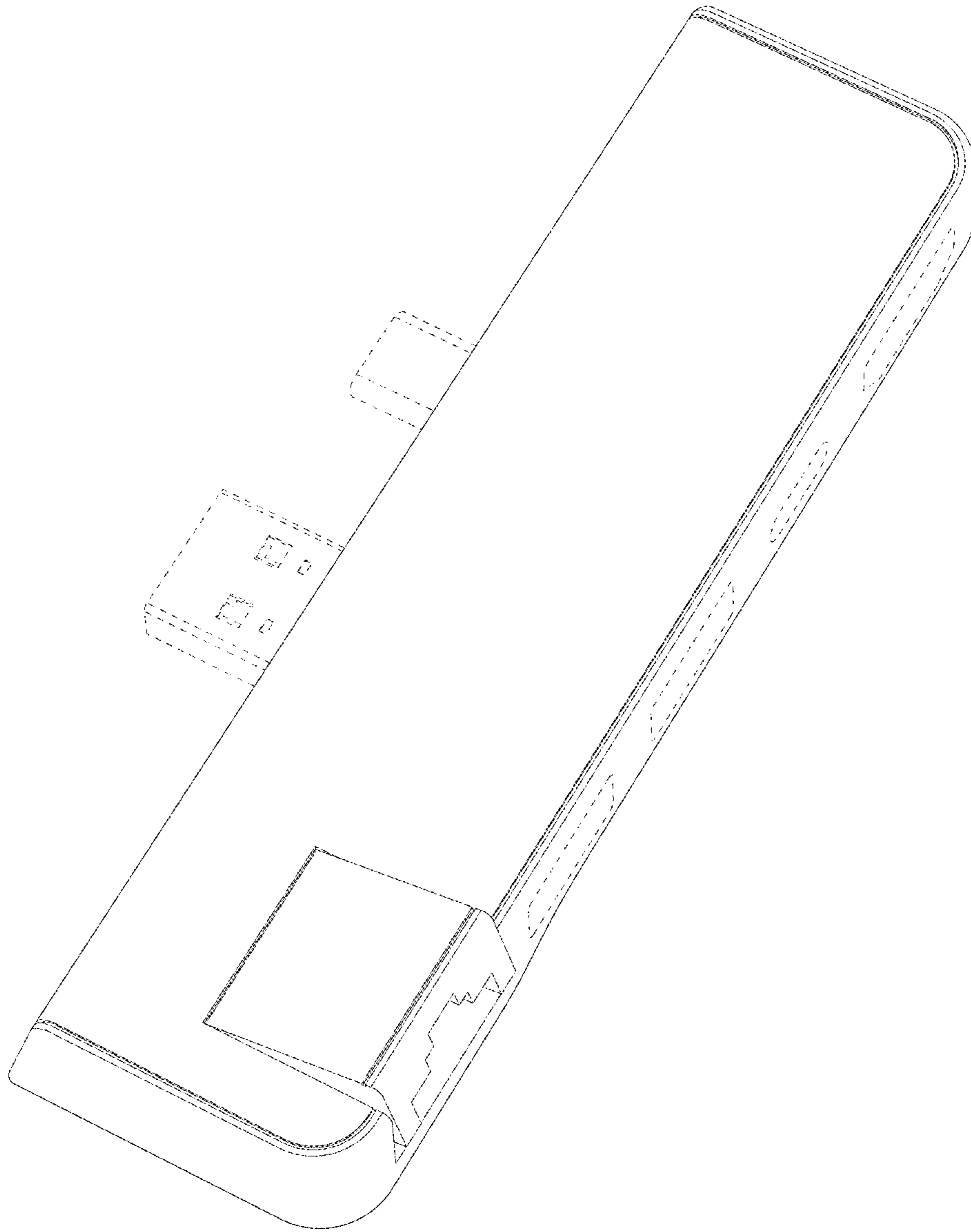
