The ornamental design for a tablet PC, as shown and described.

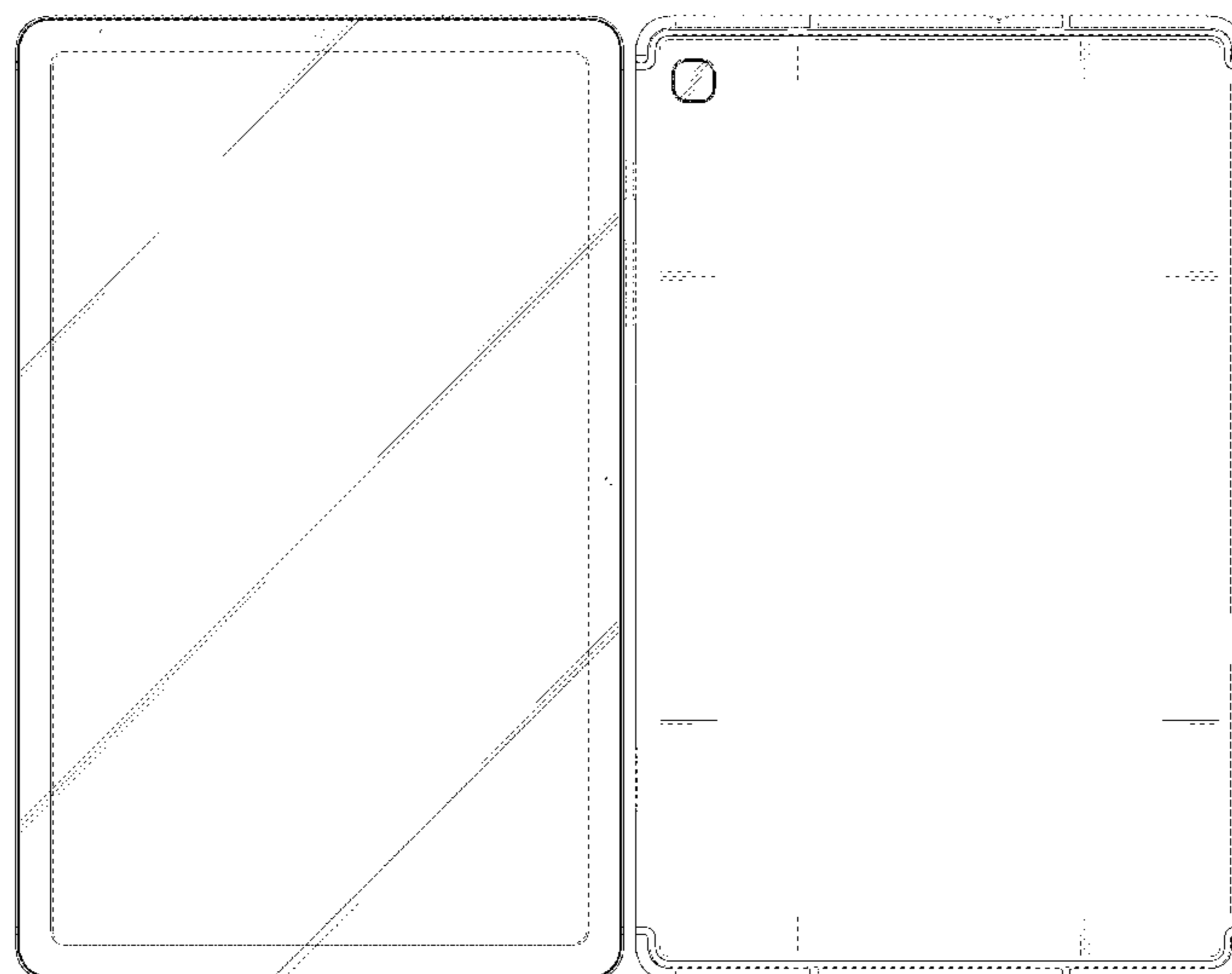
DESCRIPTION

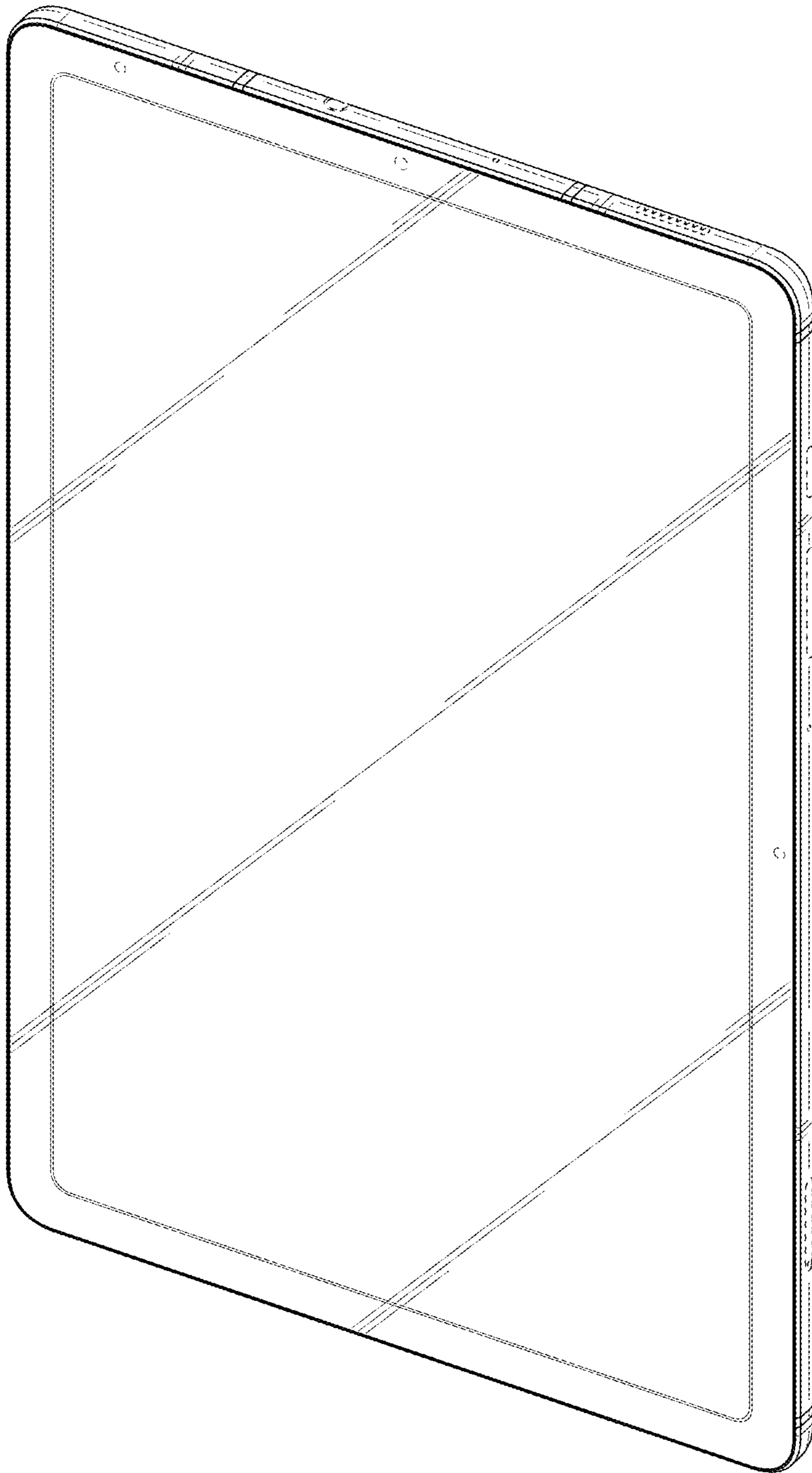

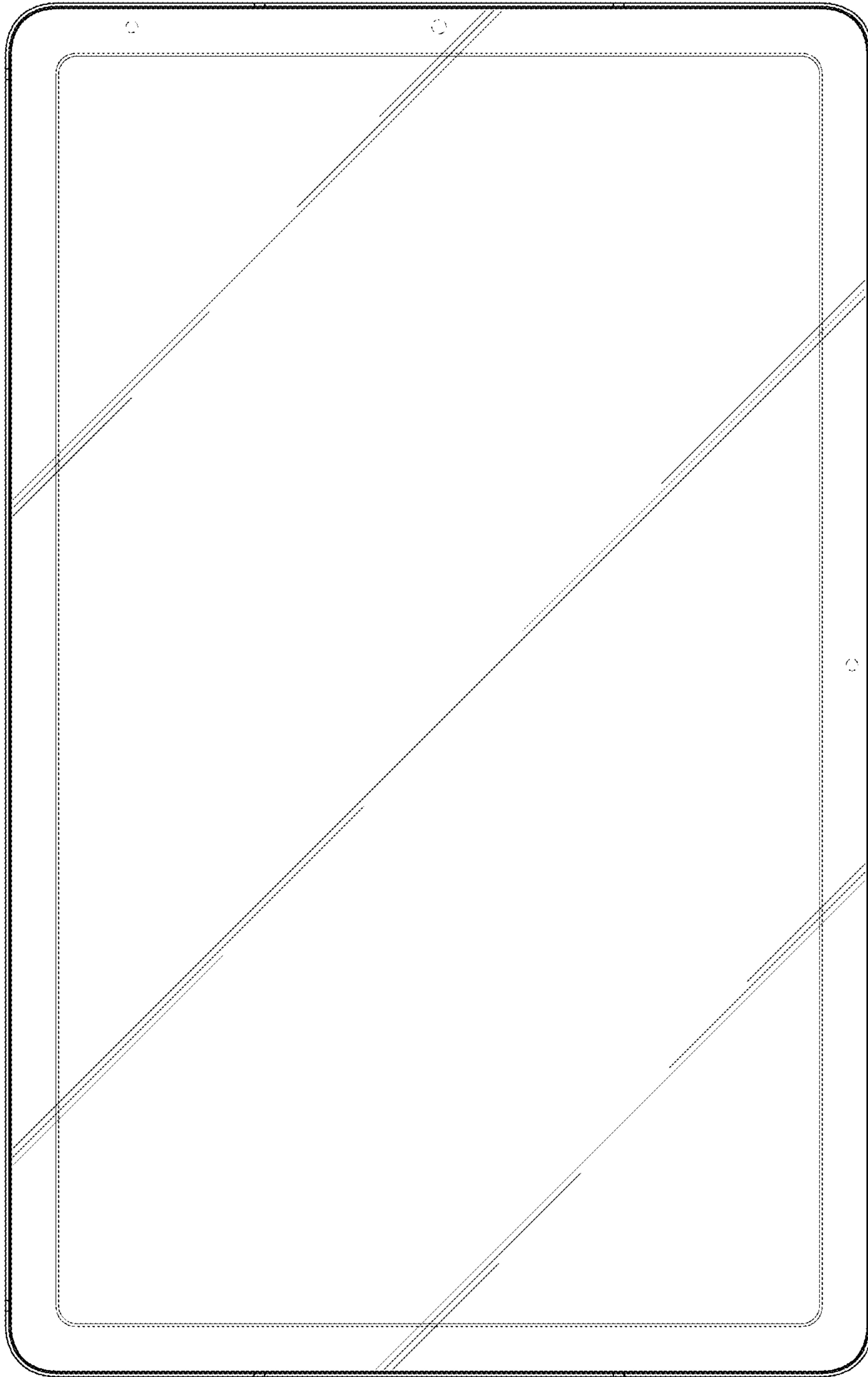

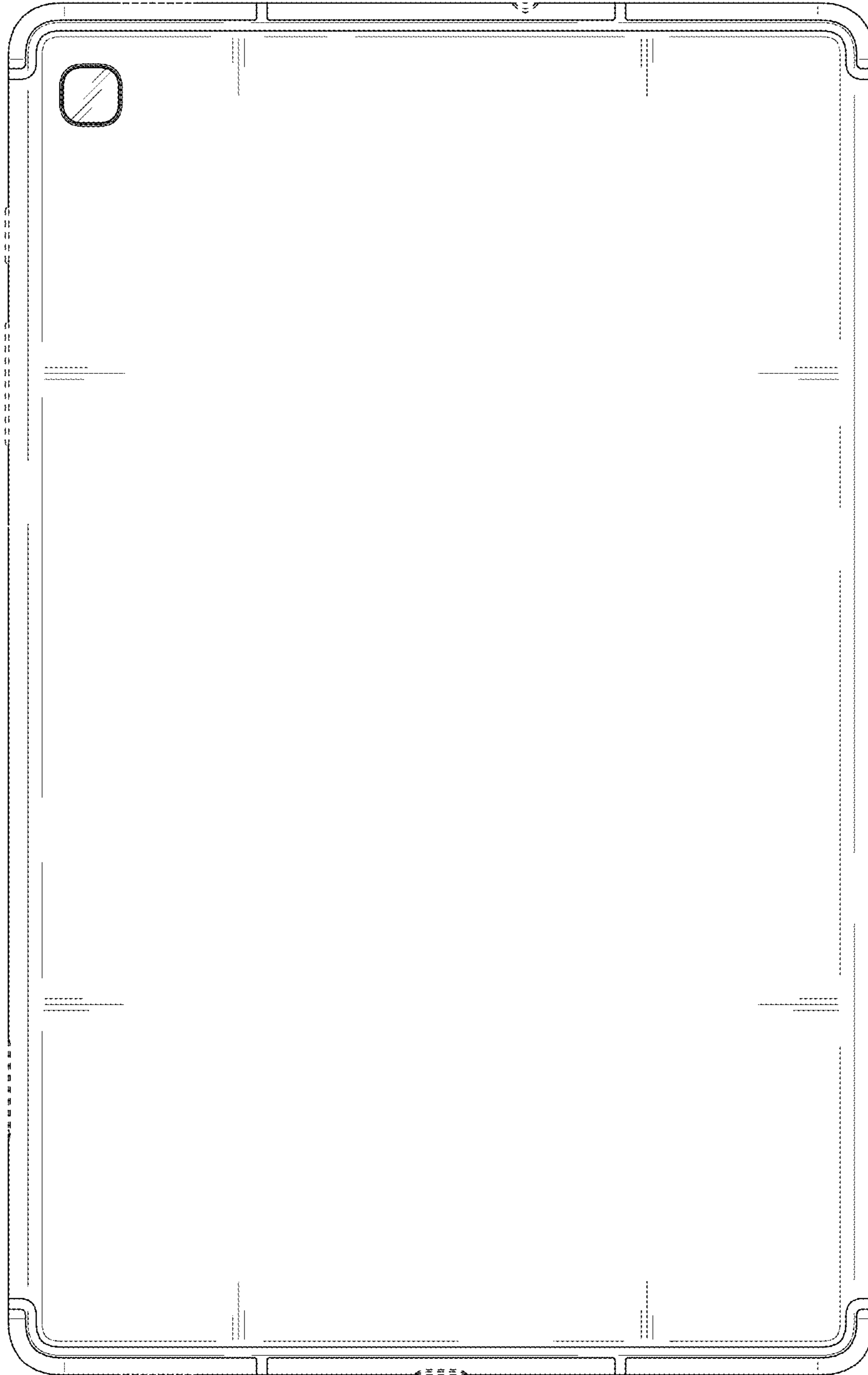

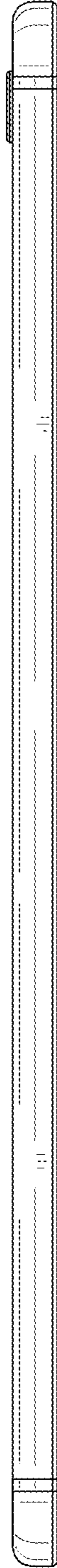

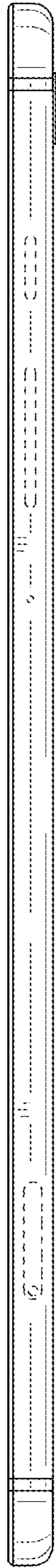

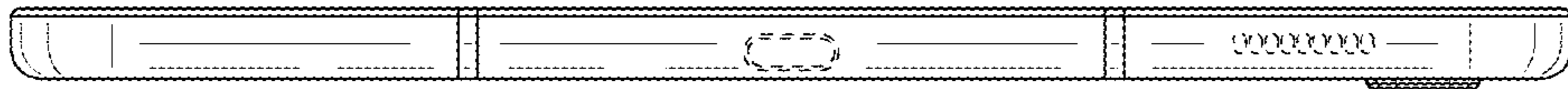
