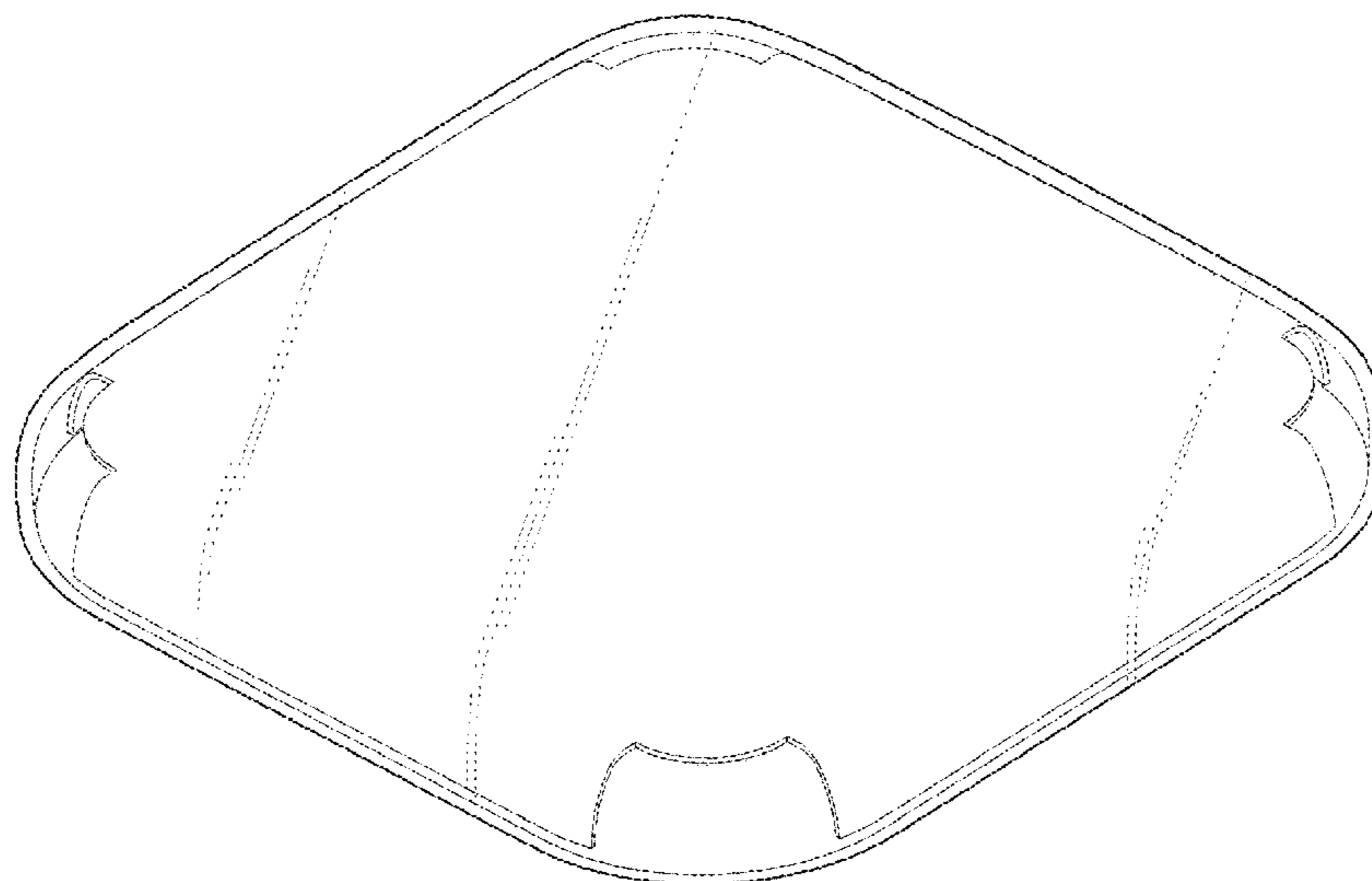
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a display module;  
FIG. 2 is a front view thereof, with the rear view being a mirror image of the front view;

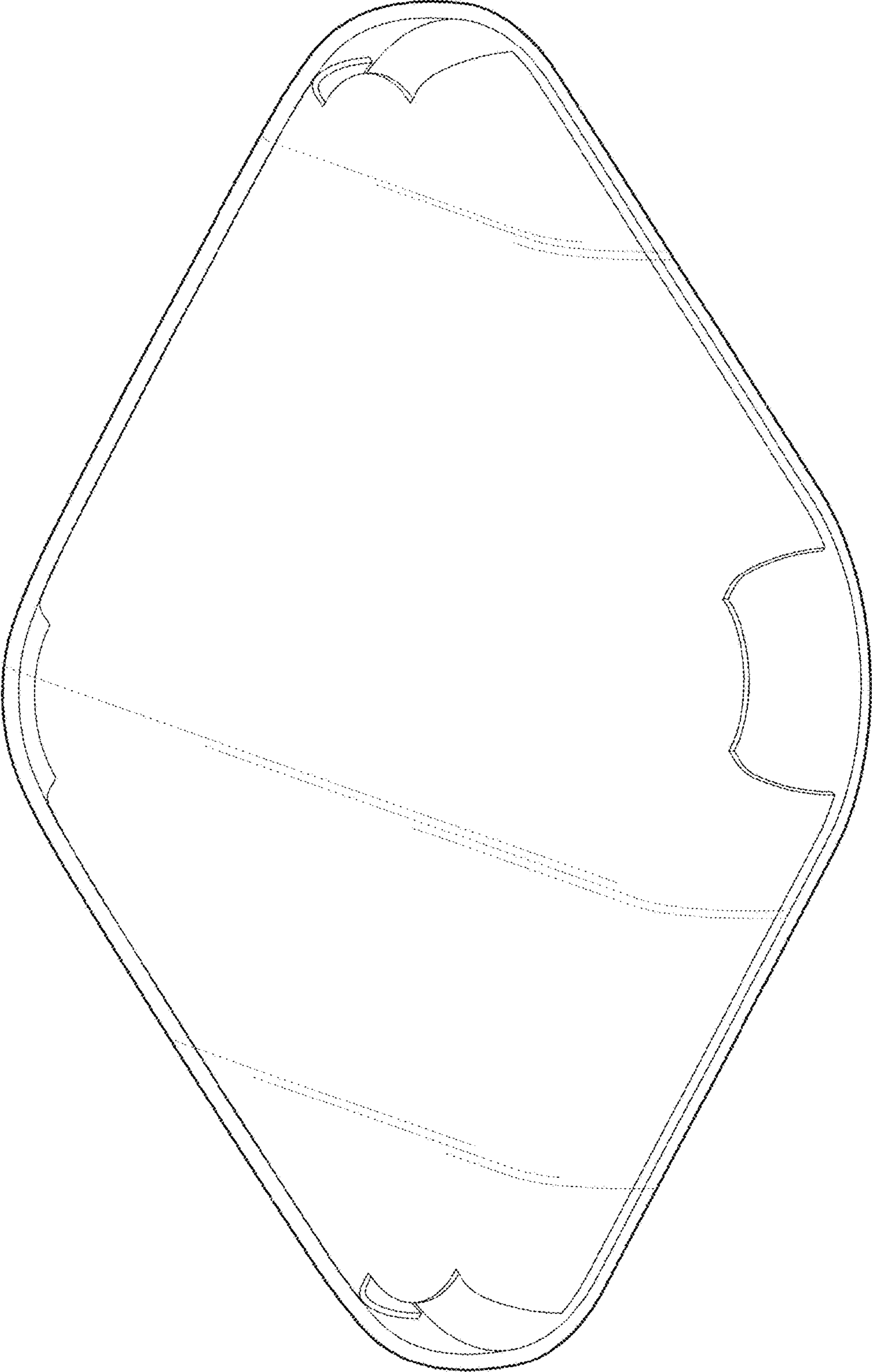

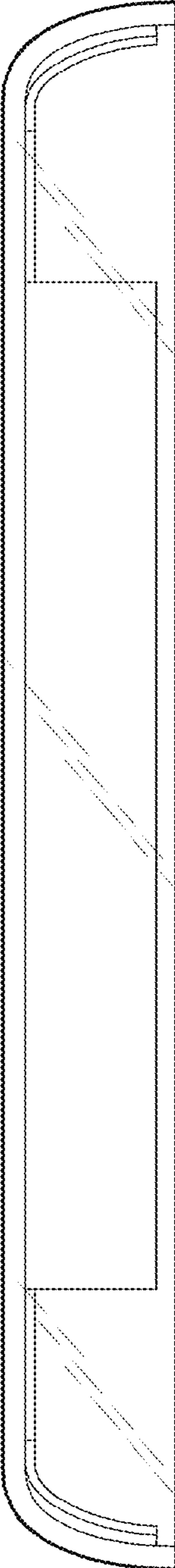
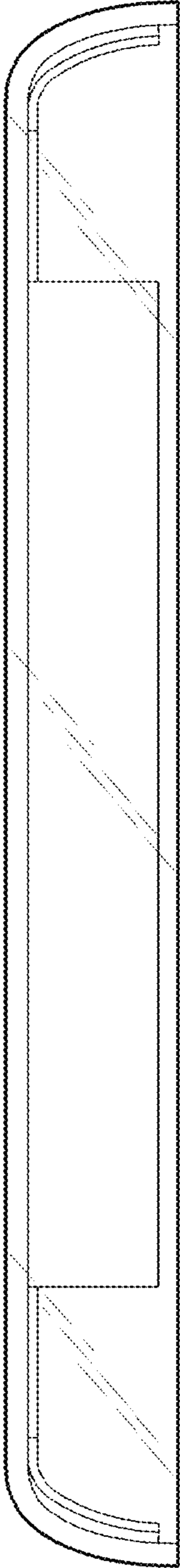

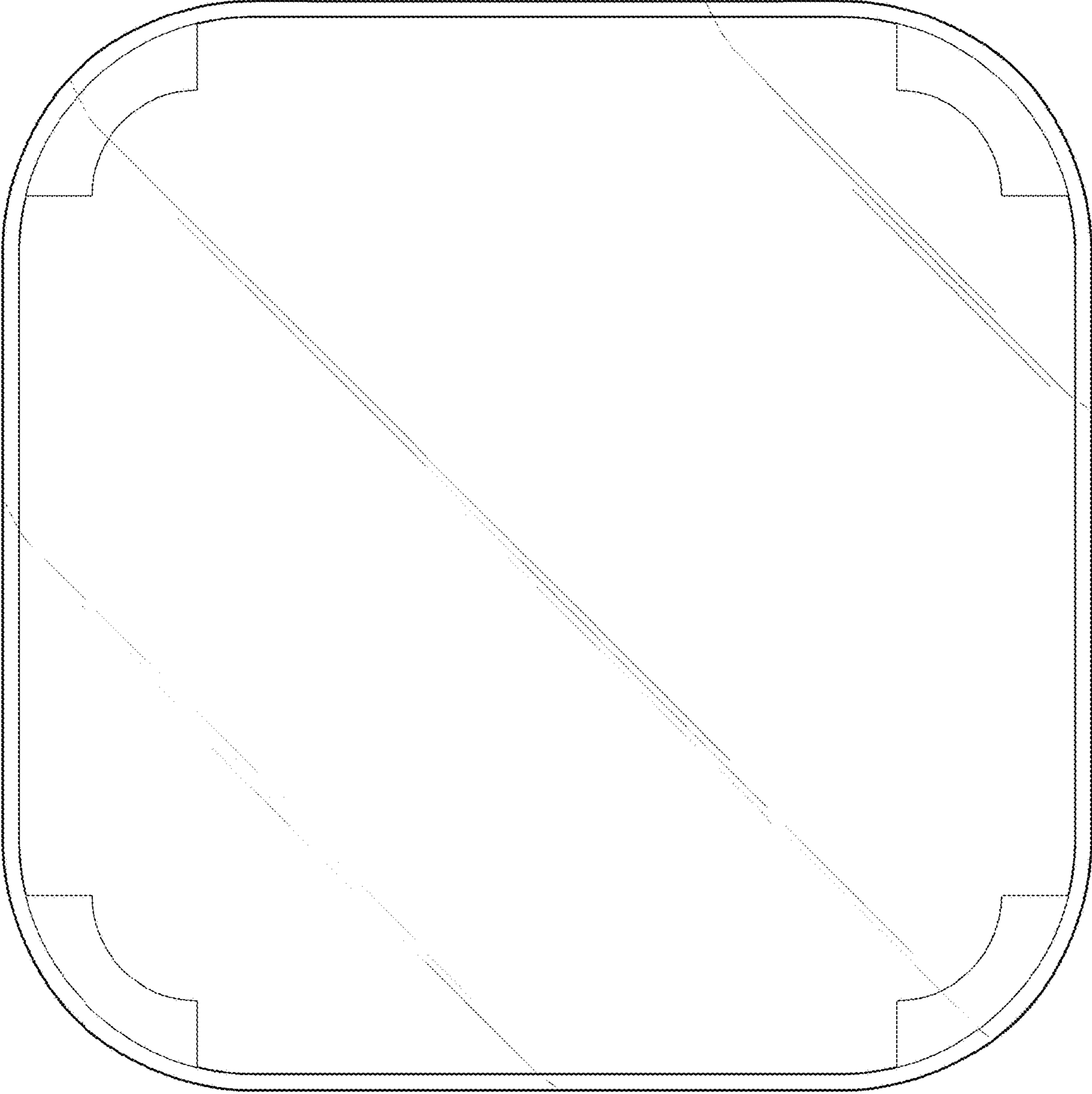

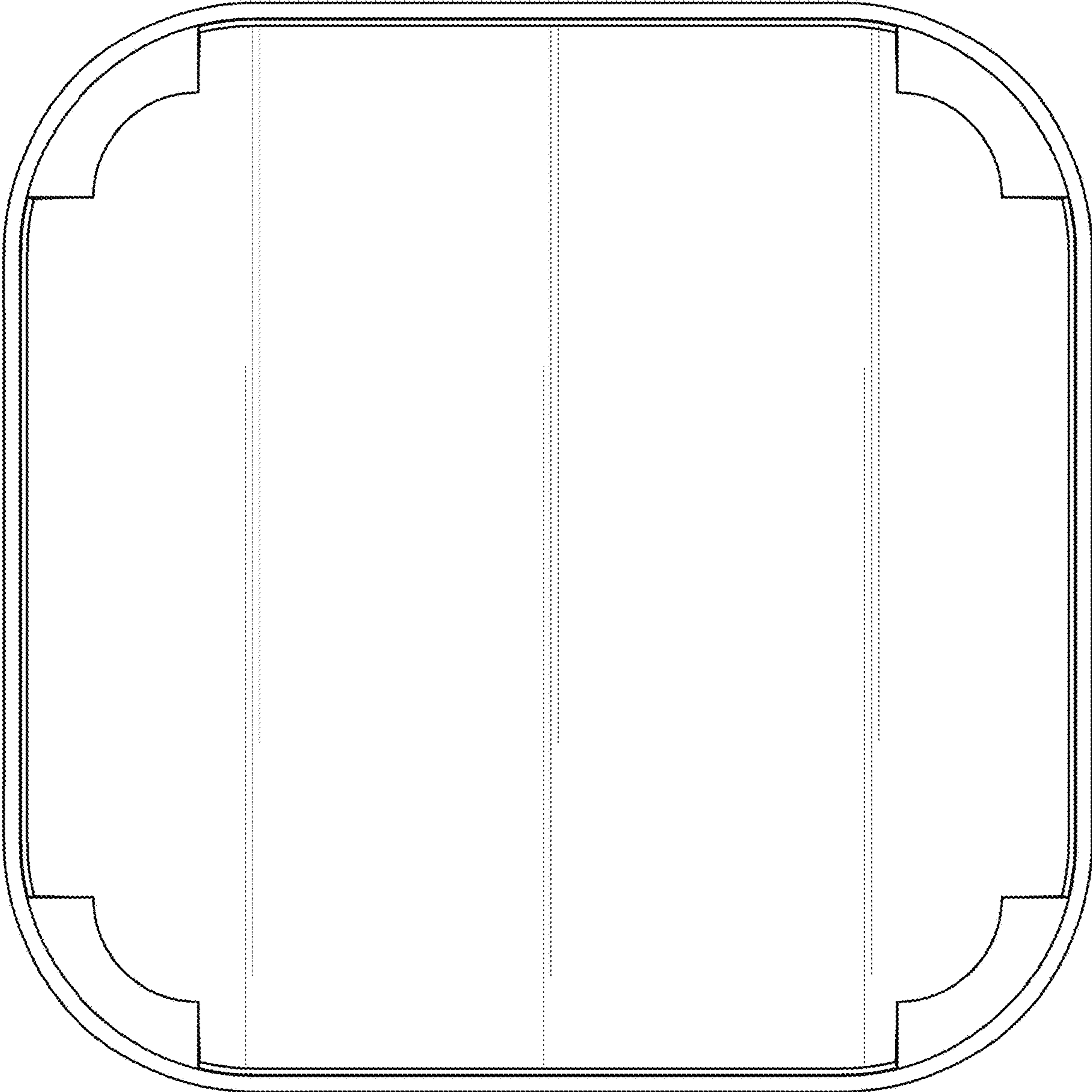
