FIG. 3 is a third image thereof;

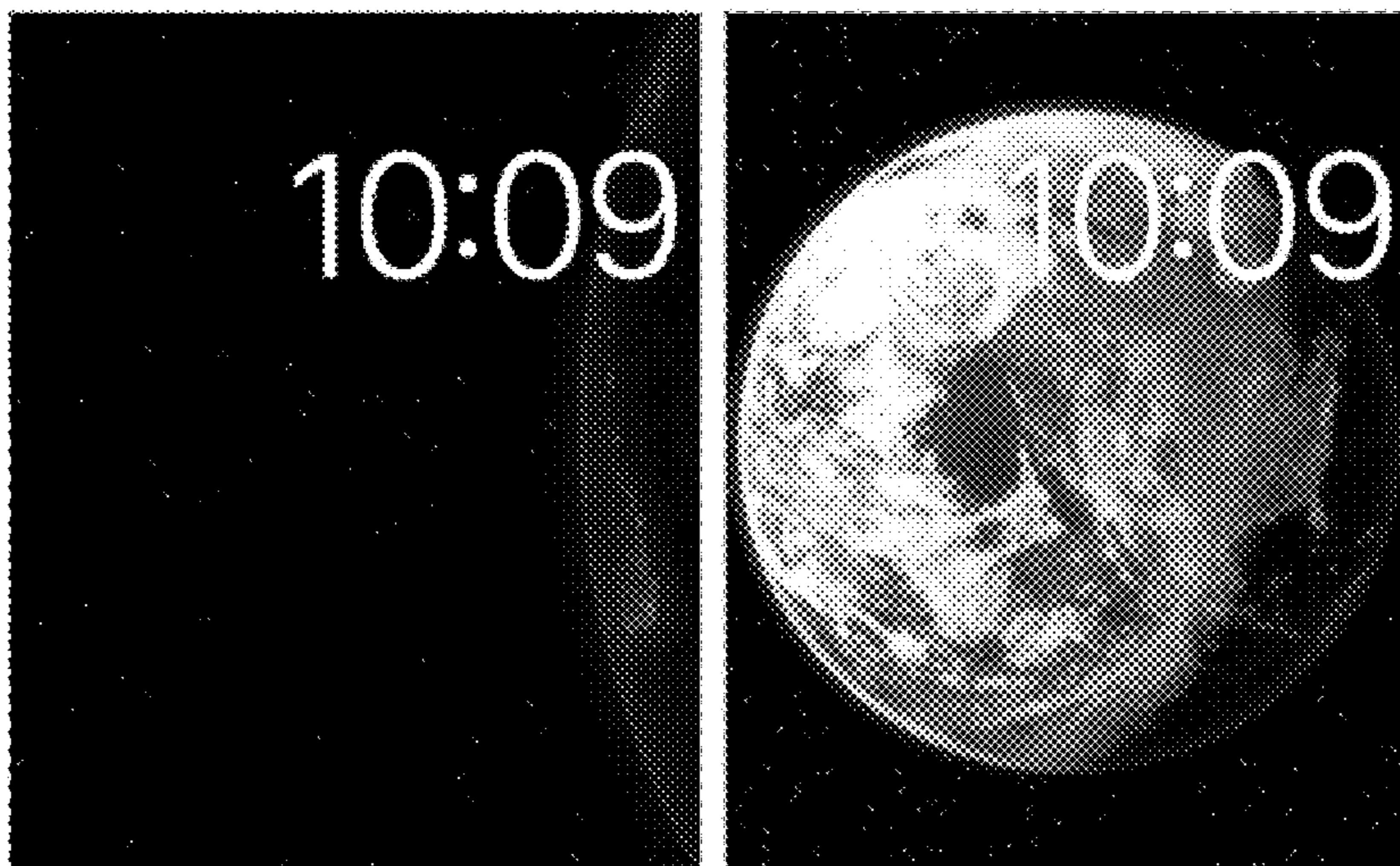
FIG. 4 is a fourth image thereof; and,

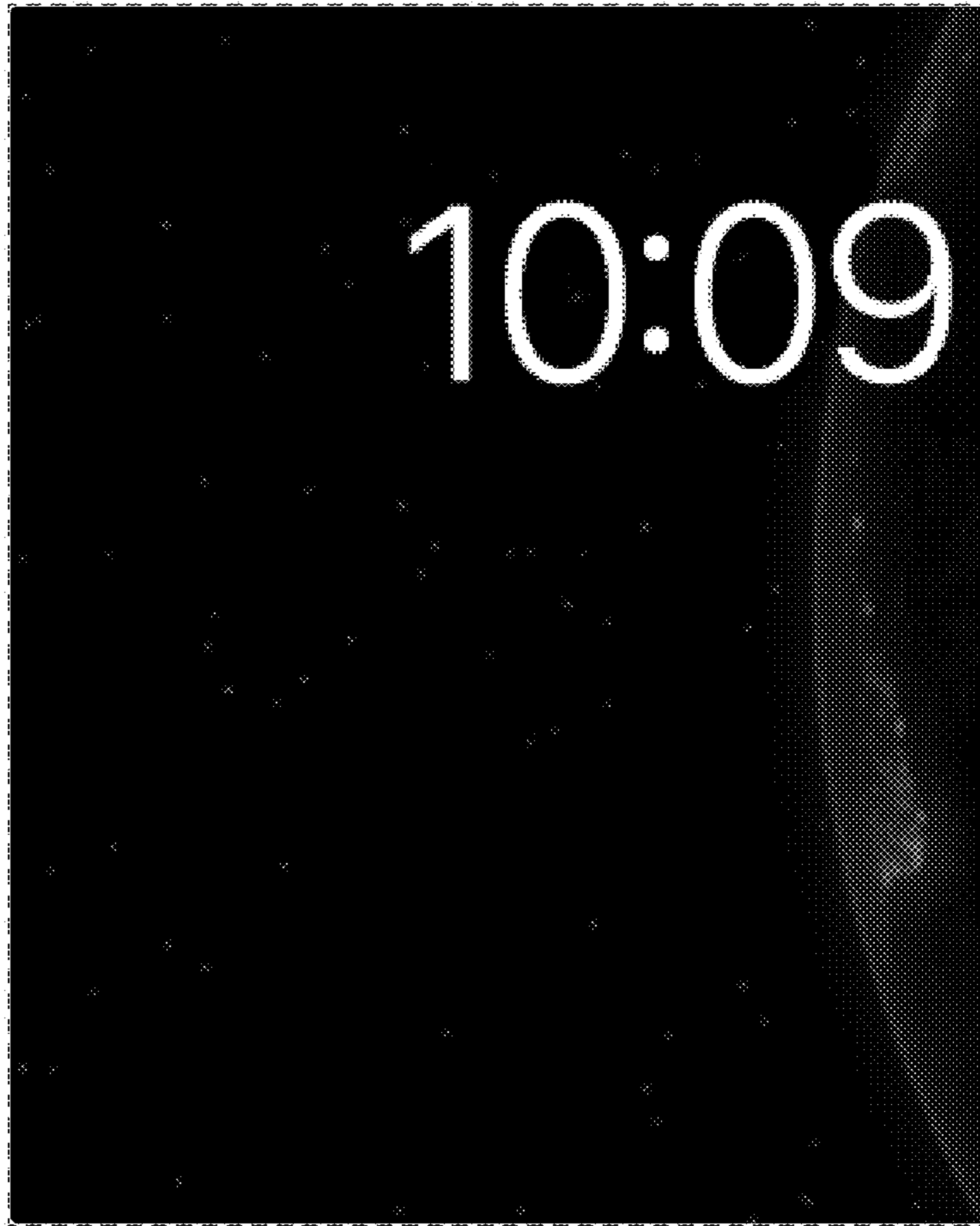

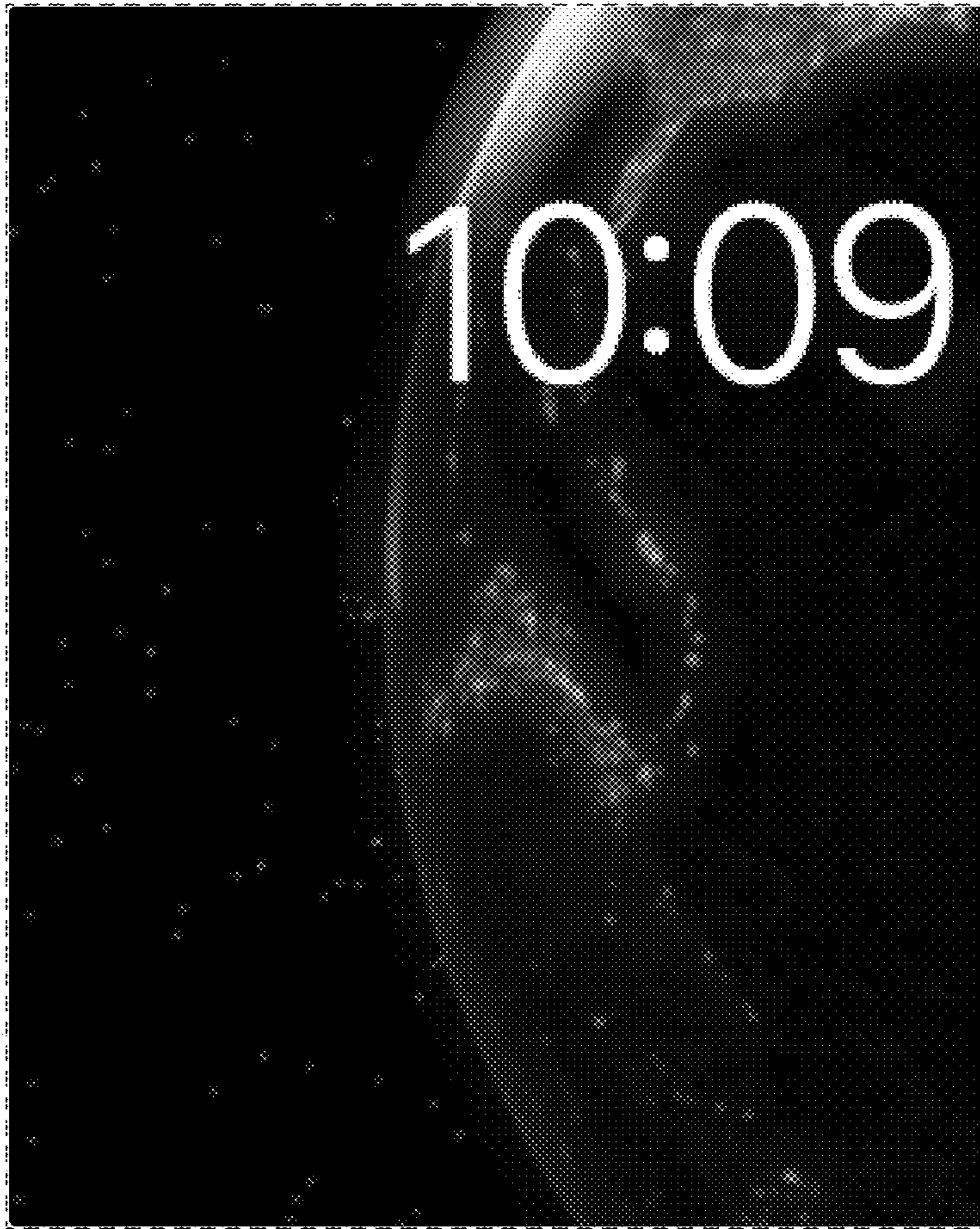

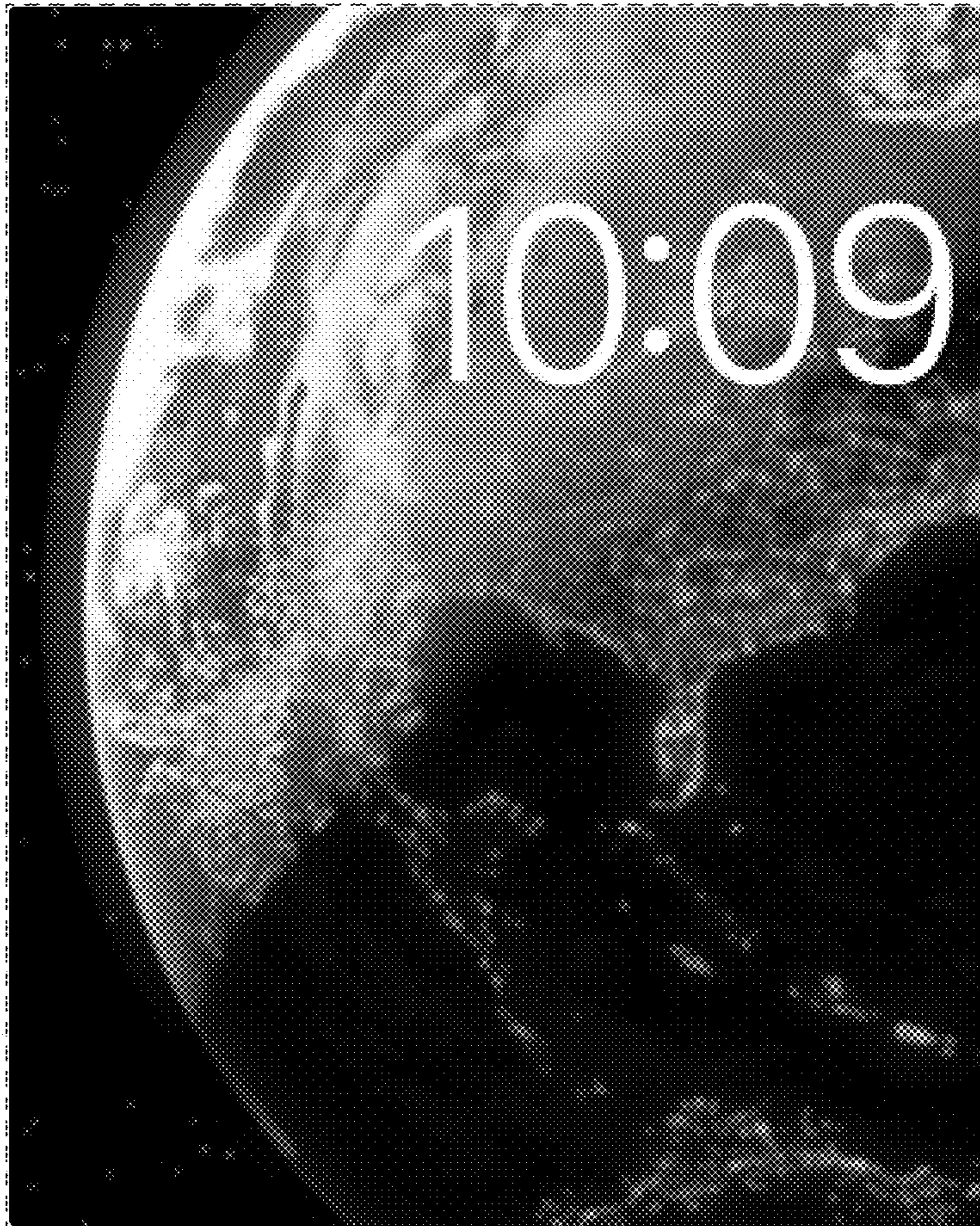
