FIG. 8 is a front view of an eighth embodiment of a display screen or portion thereof with a set of icons showing our new design.

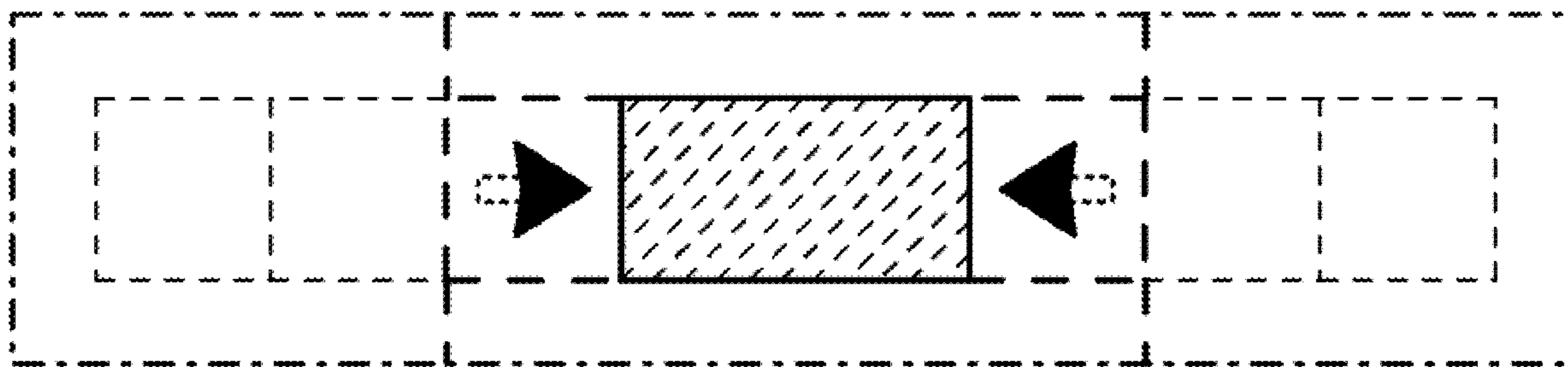
FIG. 9 is a front view of a ninth embodiment of a display screen or portion thereof with a set of icons showing our new design.

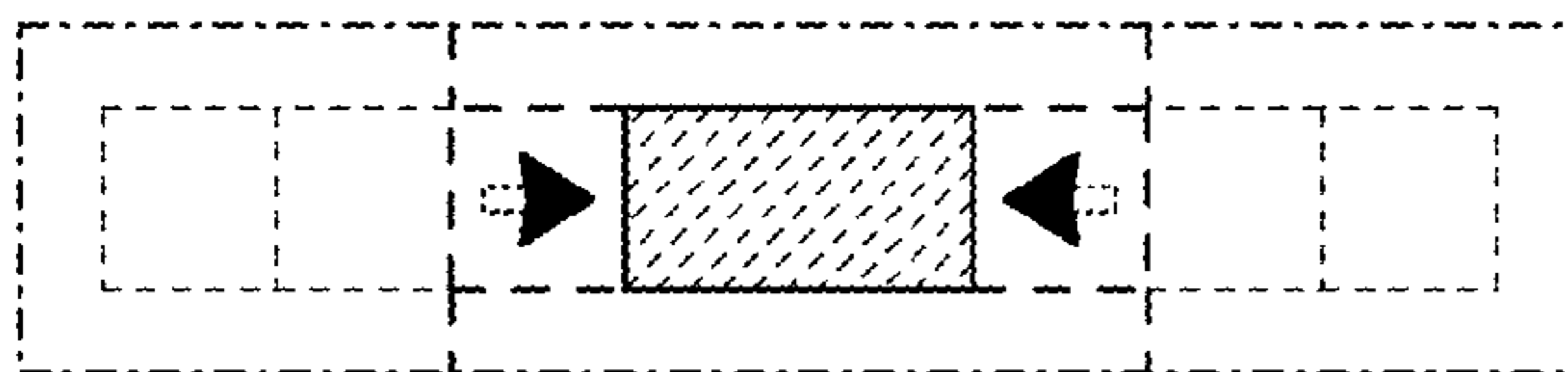

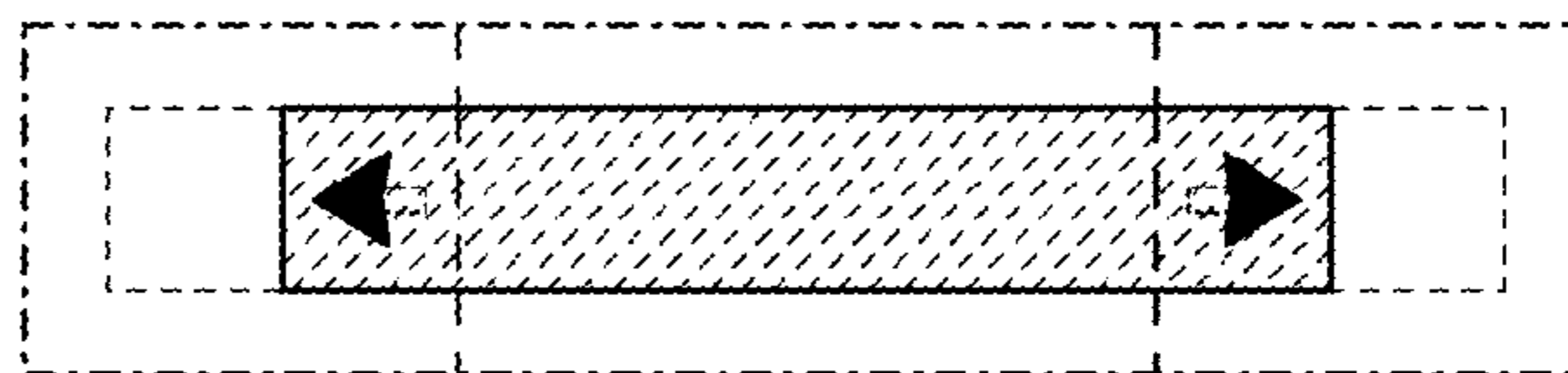

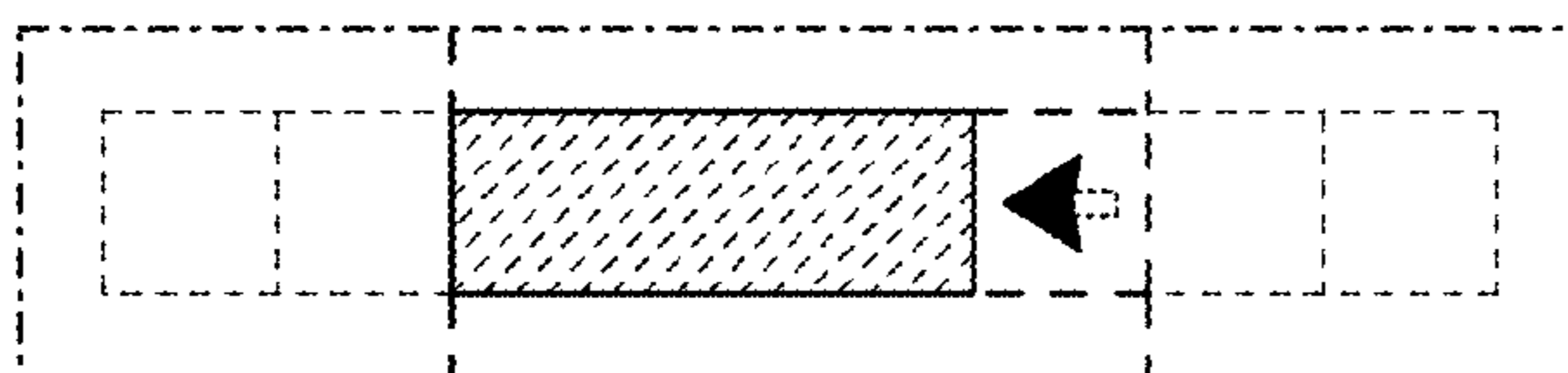

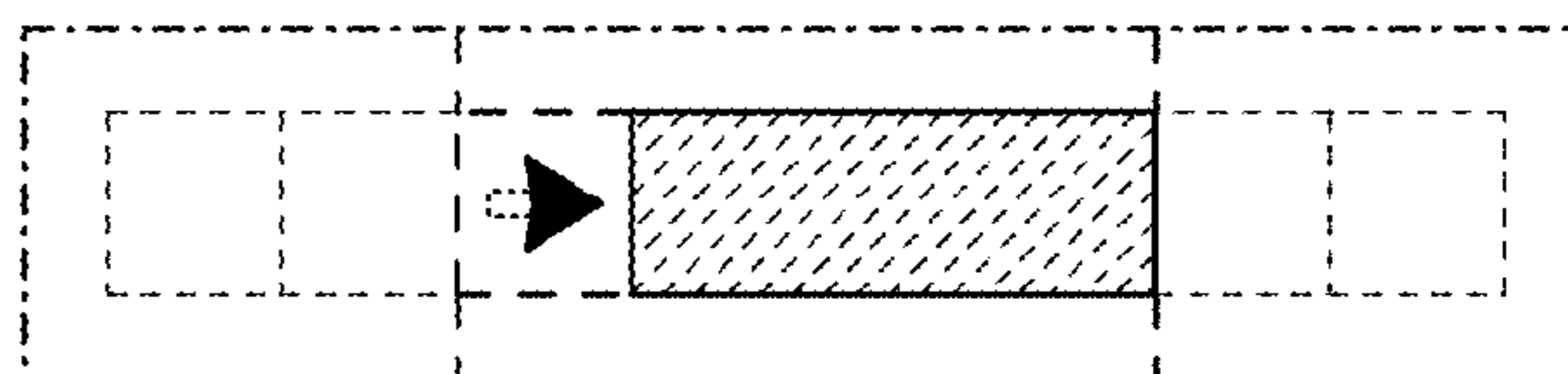

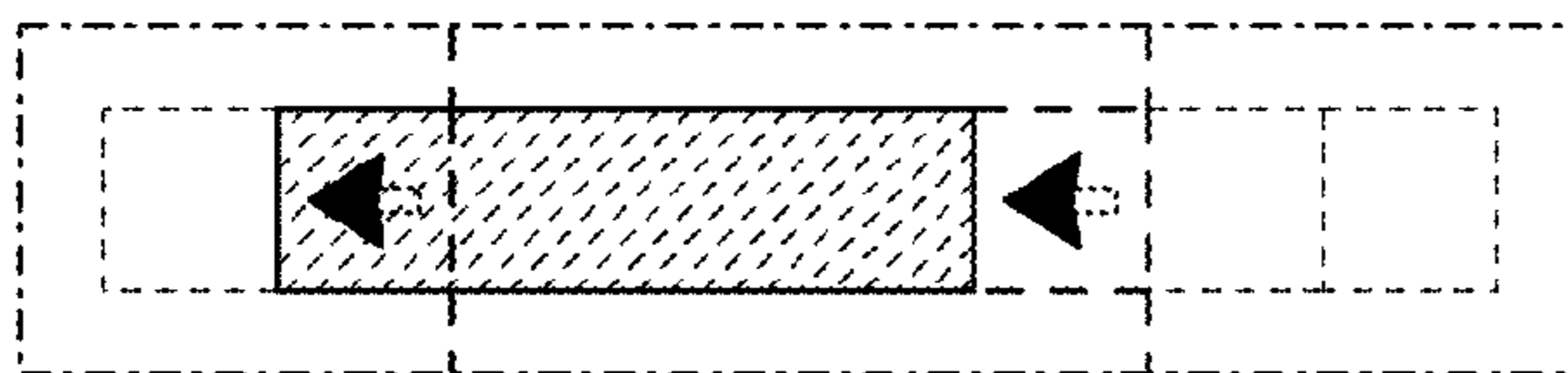

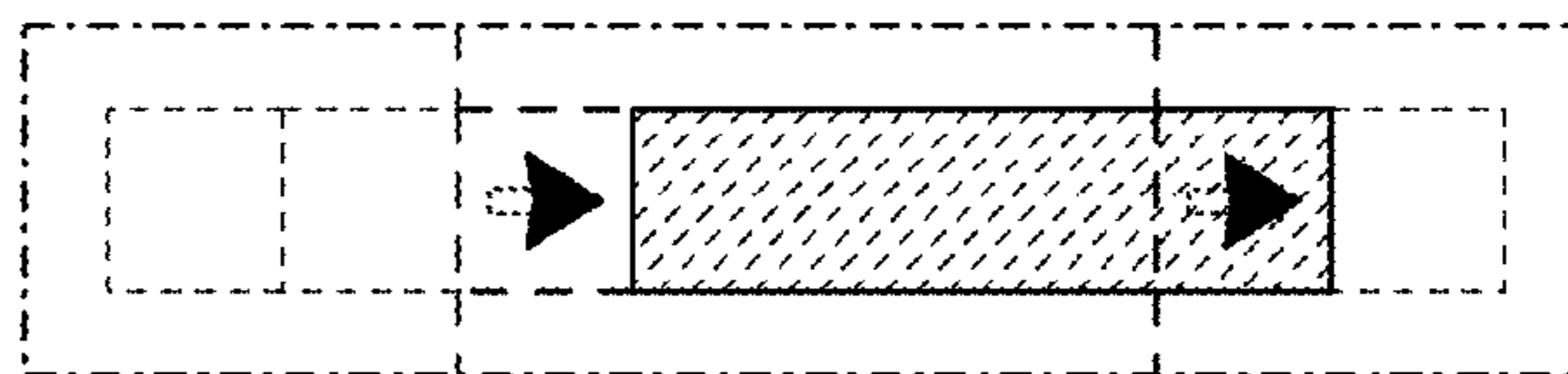

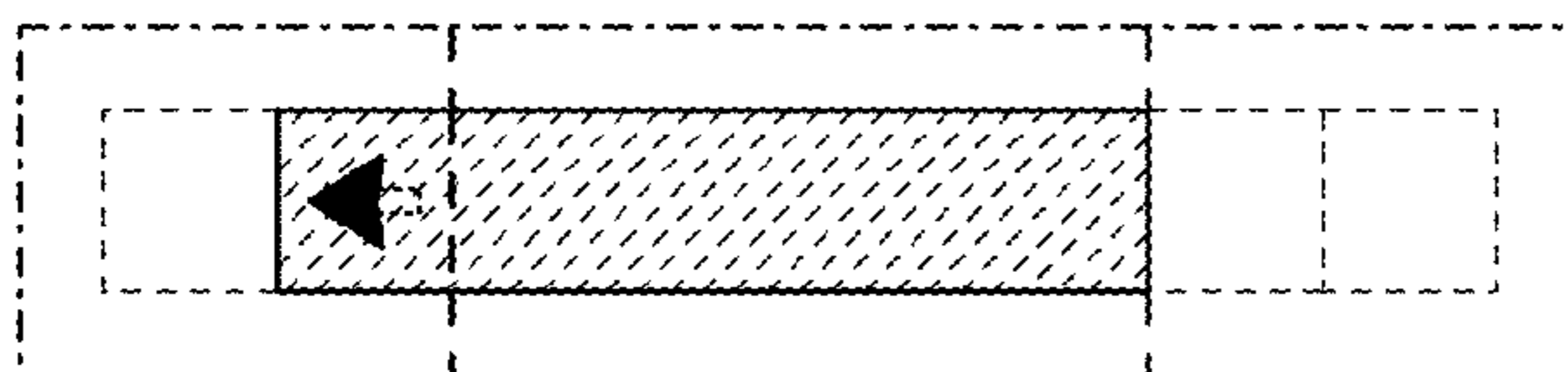

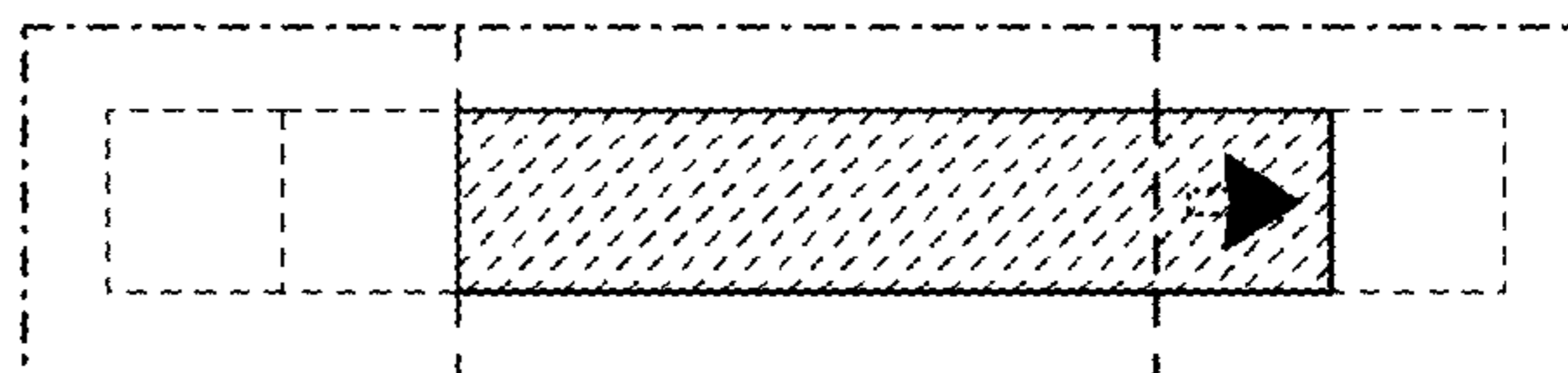

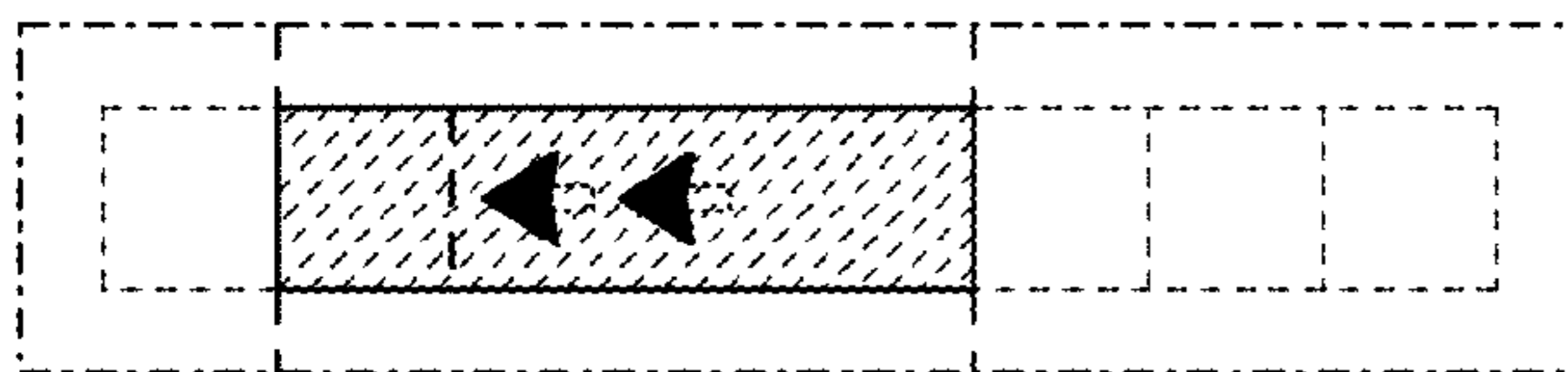

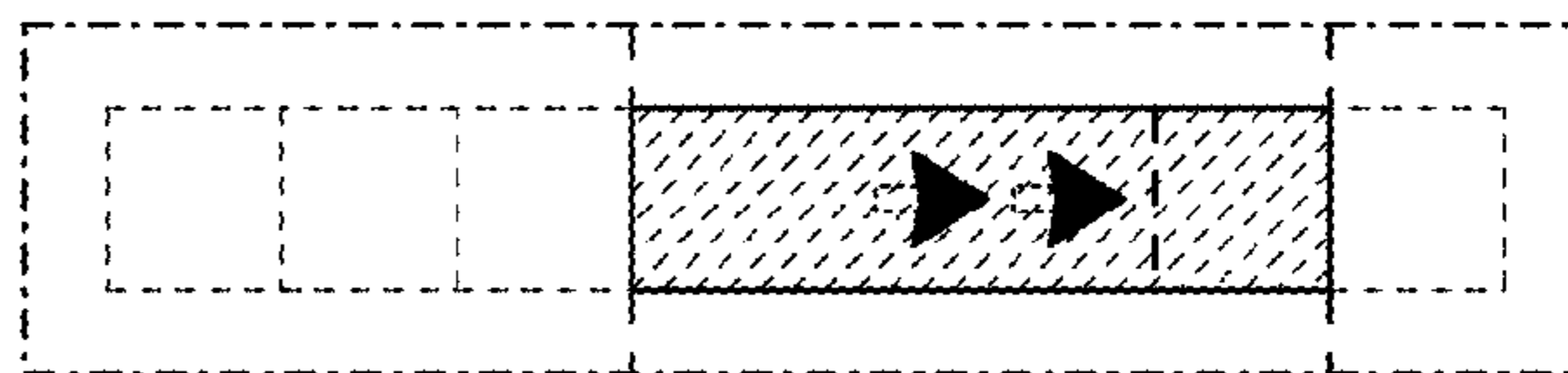

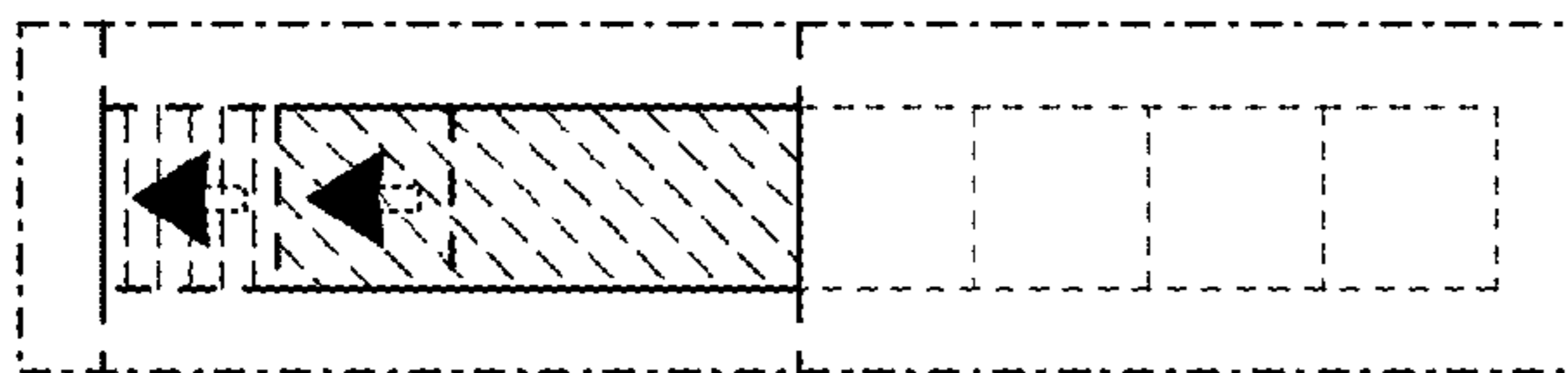

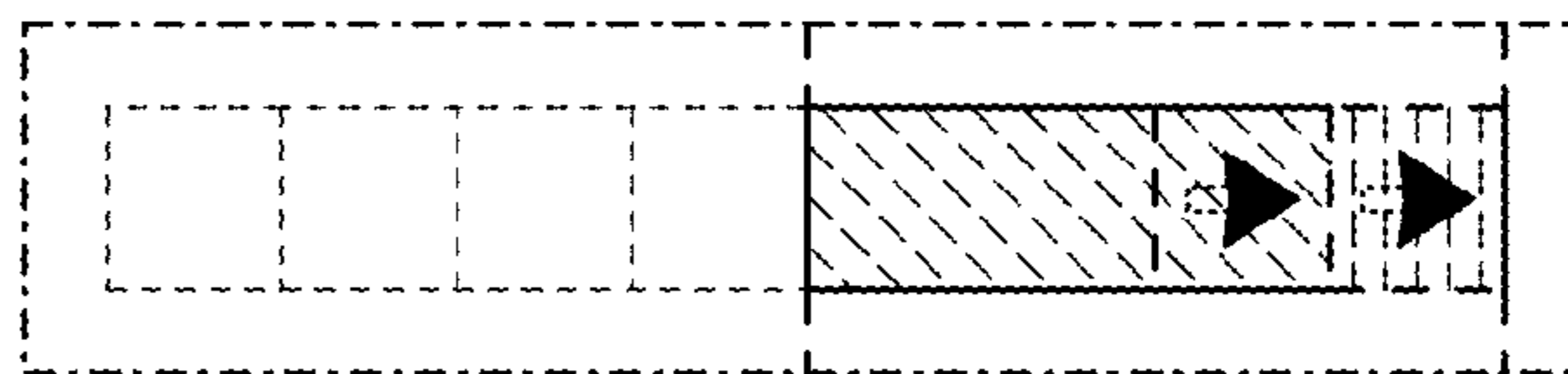

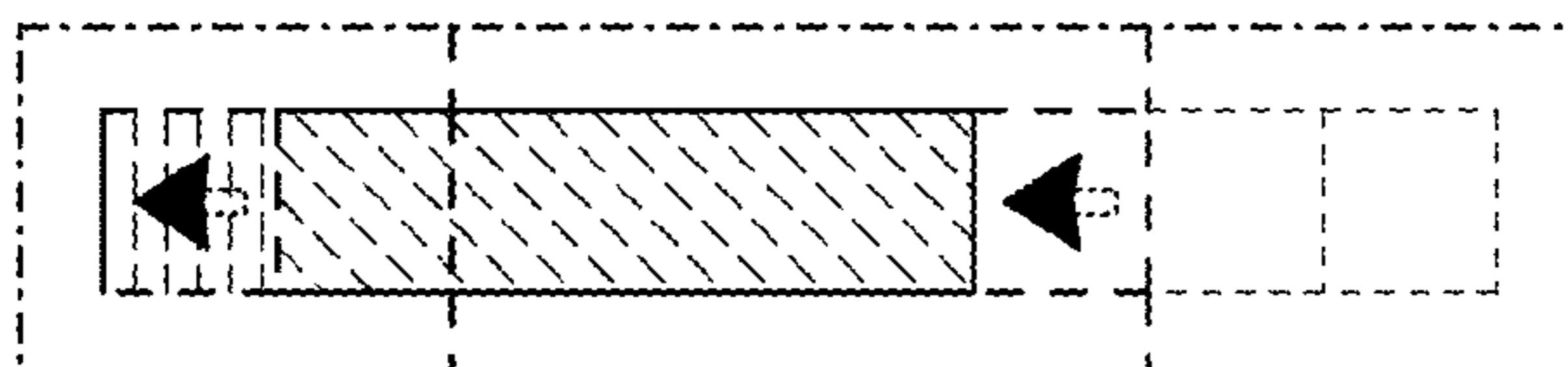

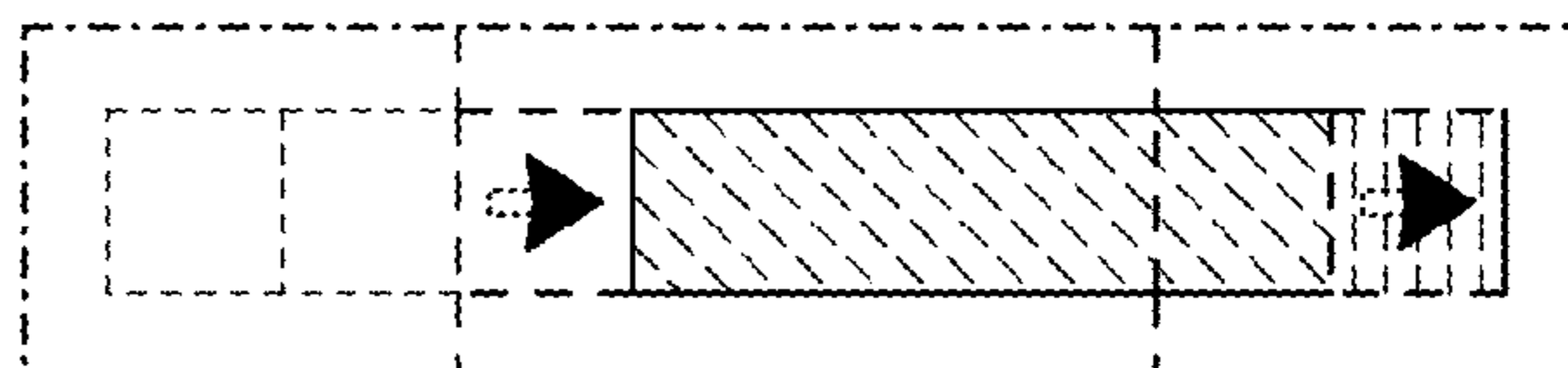

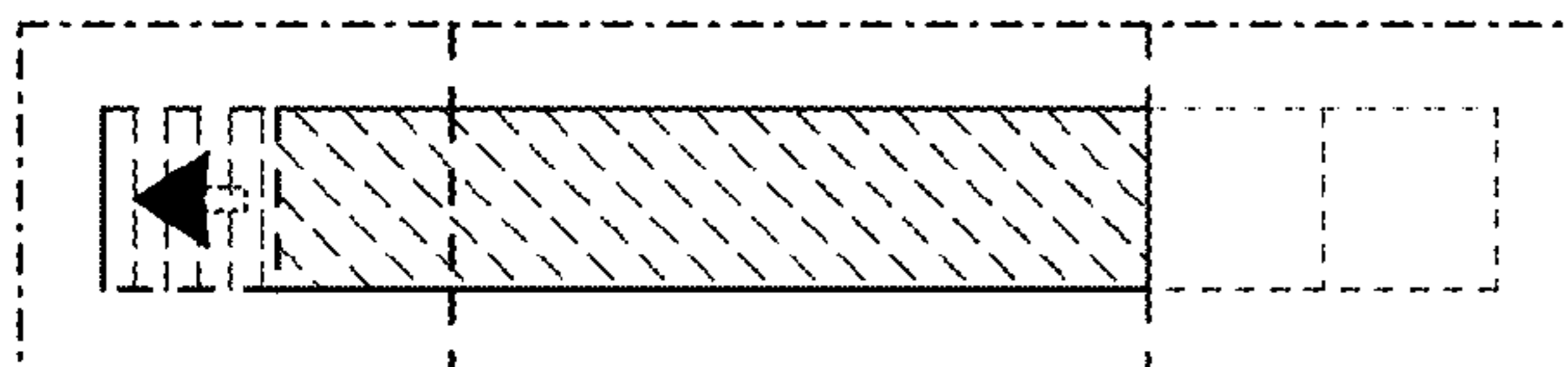

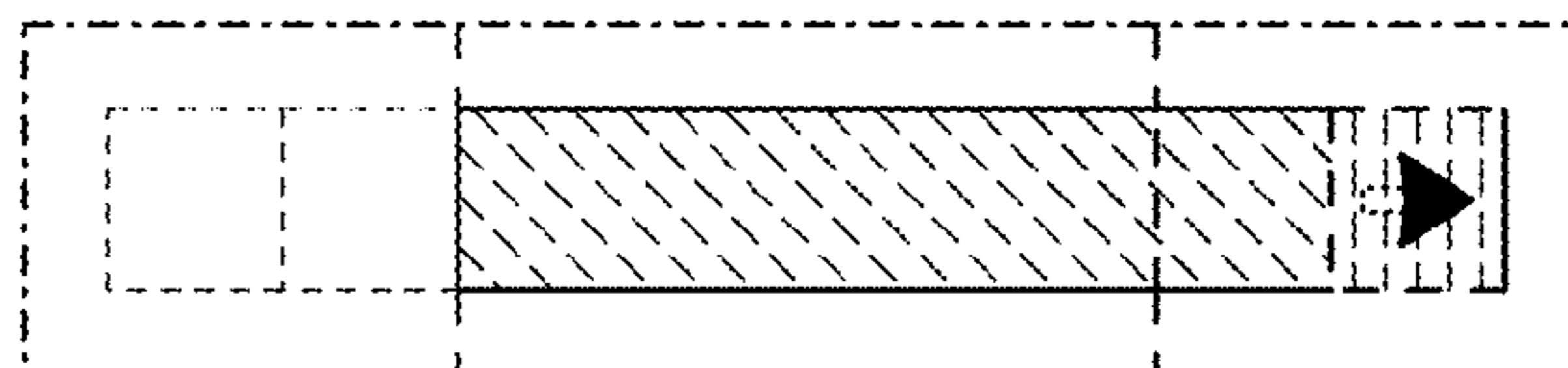

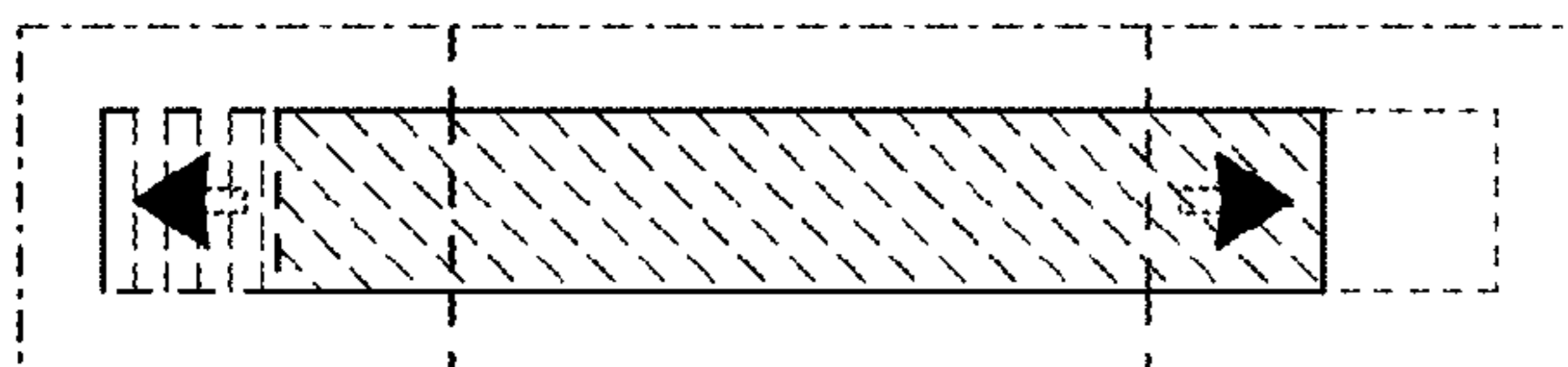

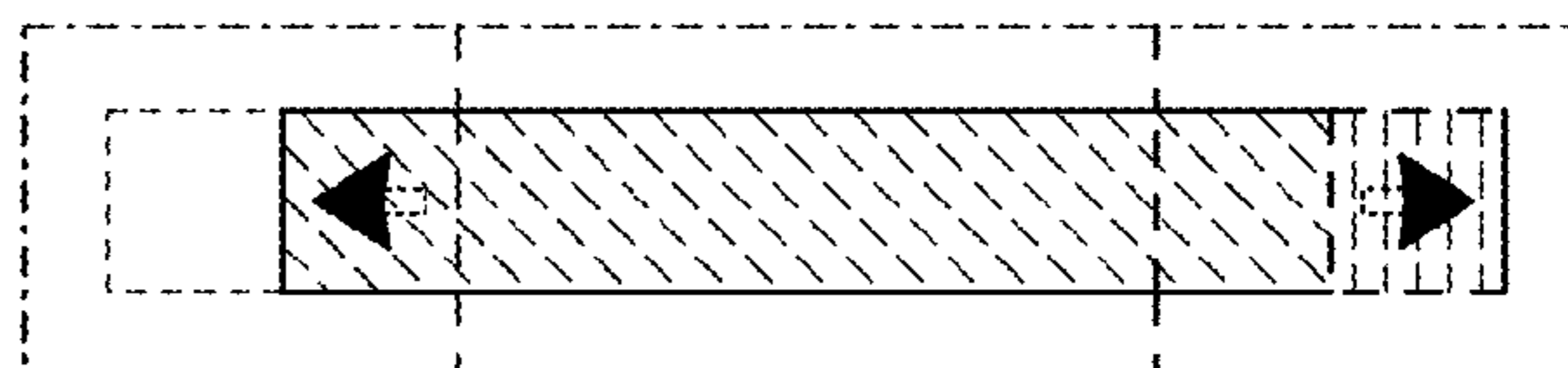

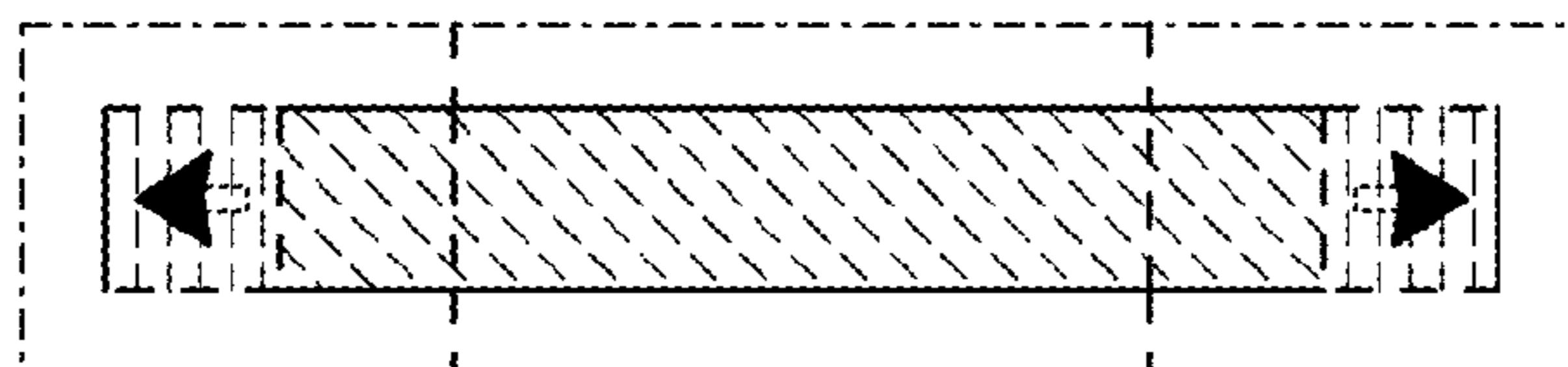
