(57) **CLAIM**

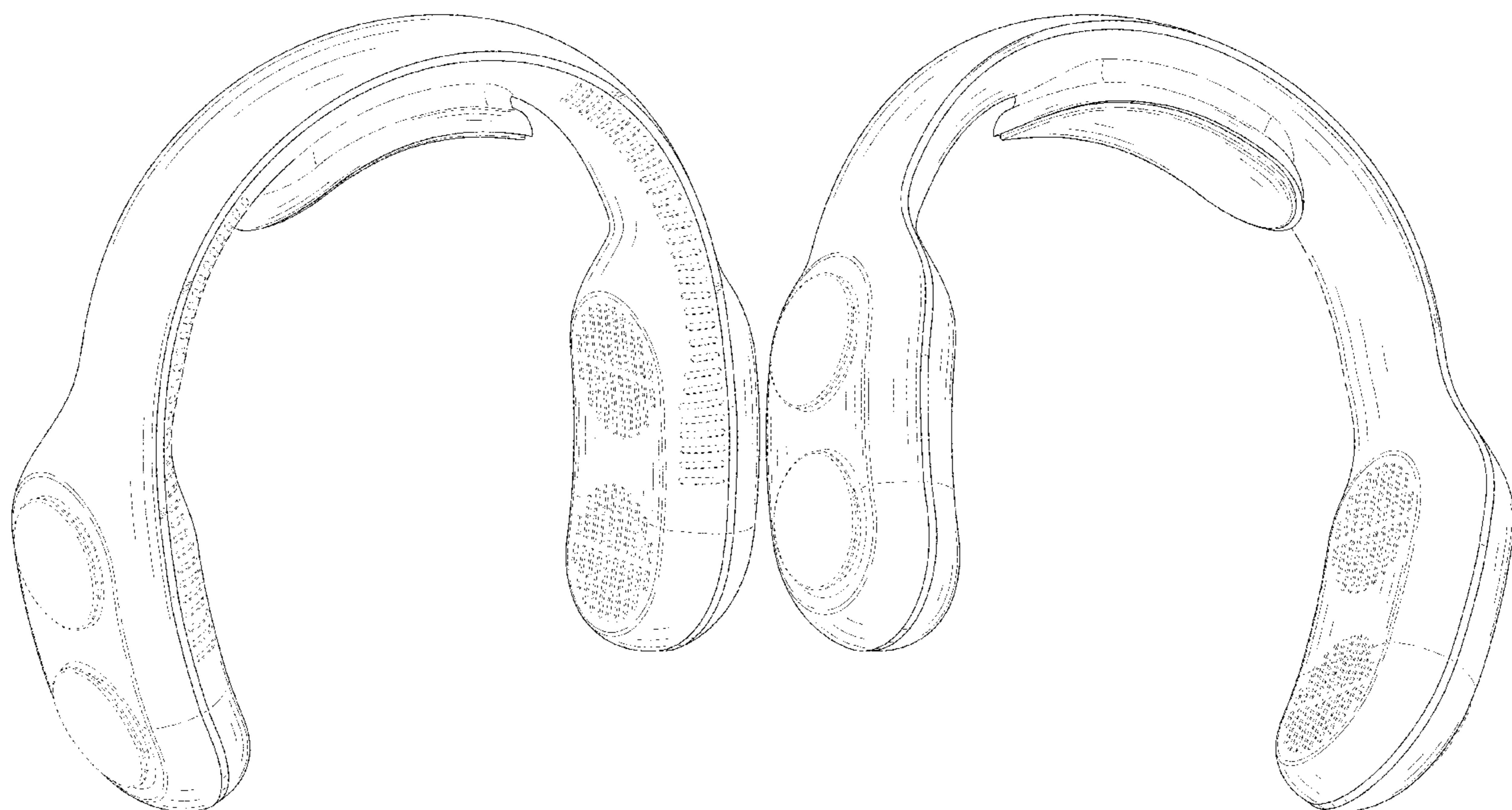
The ornamental design for a neck band type fan, as shown and described.

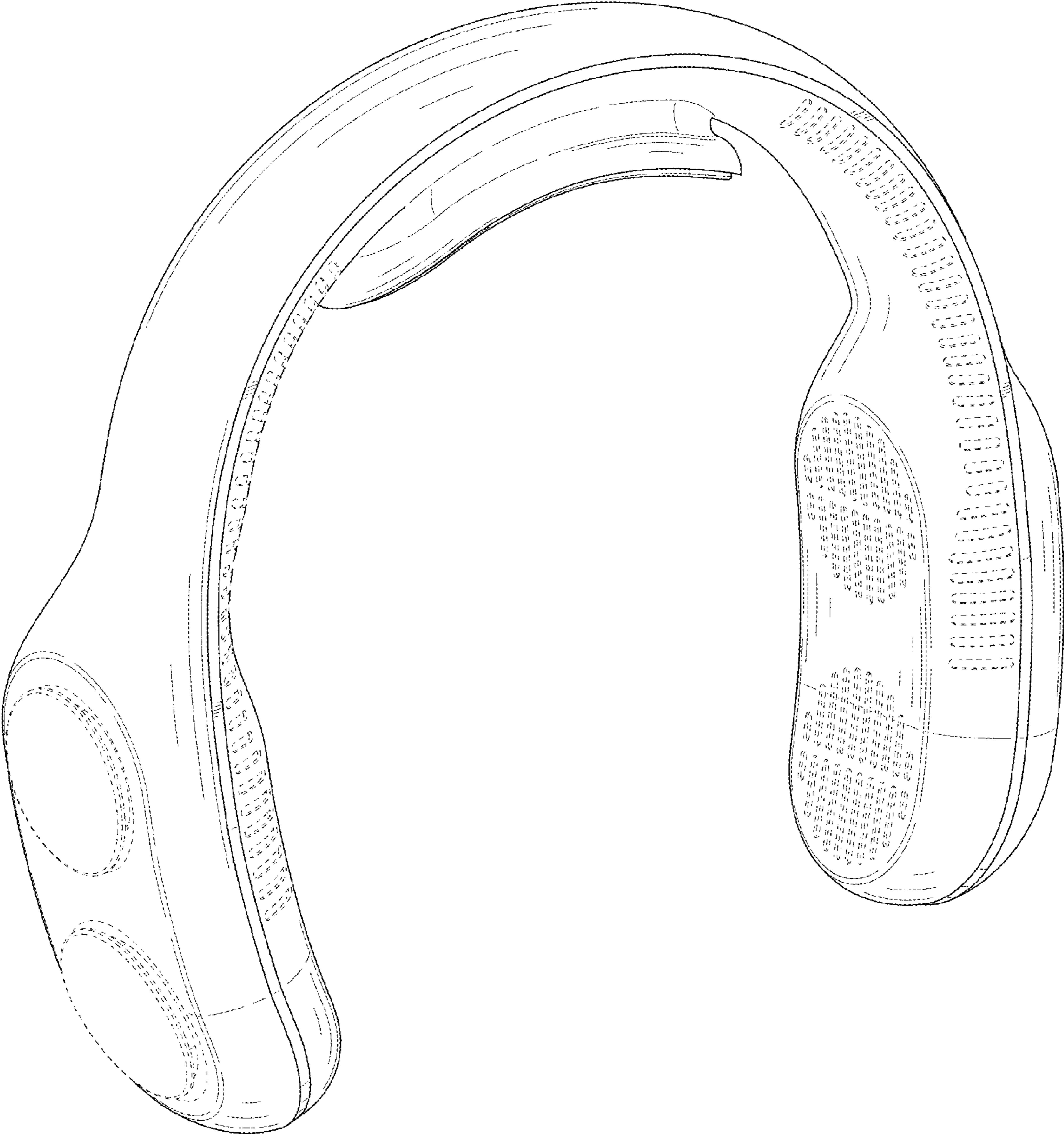

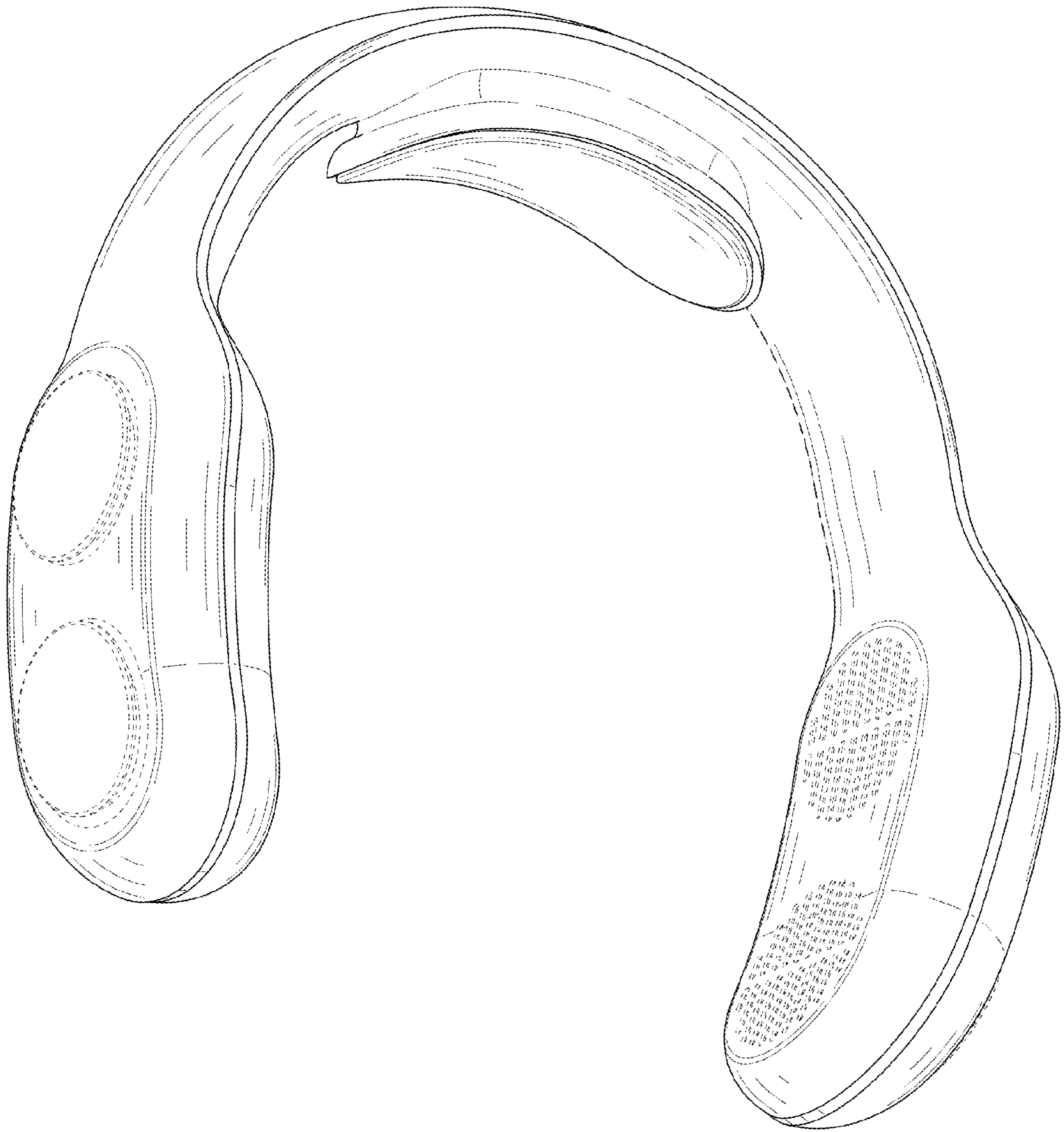

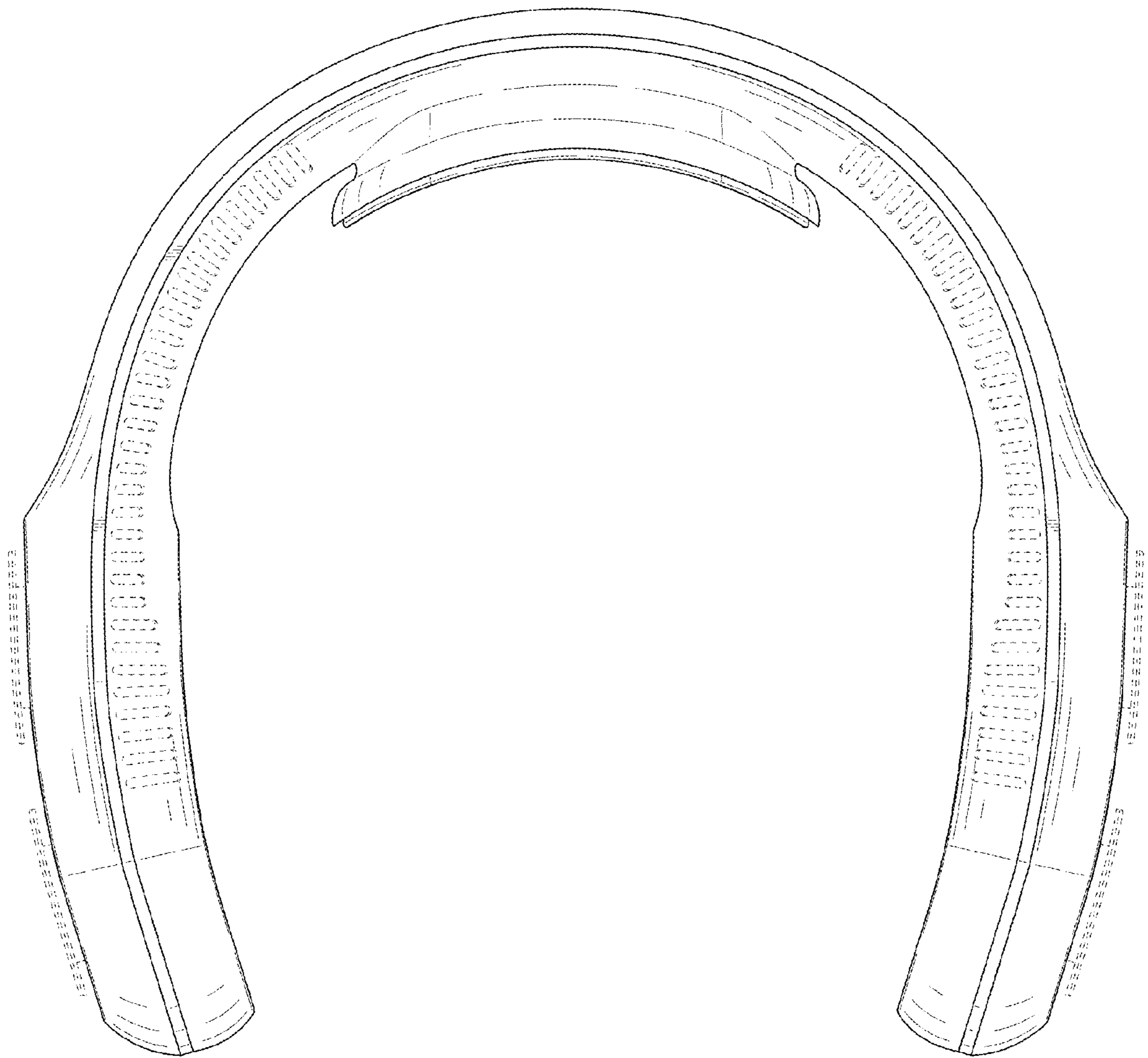

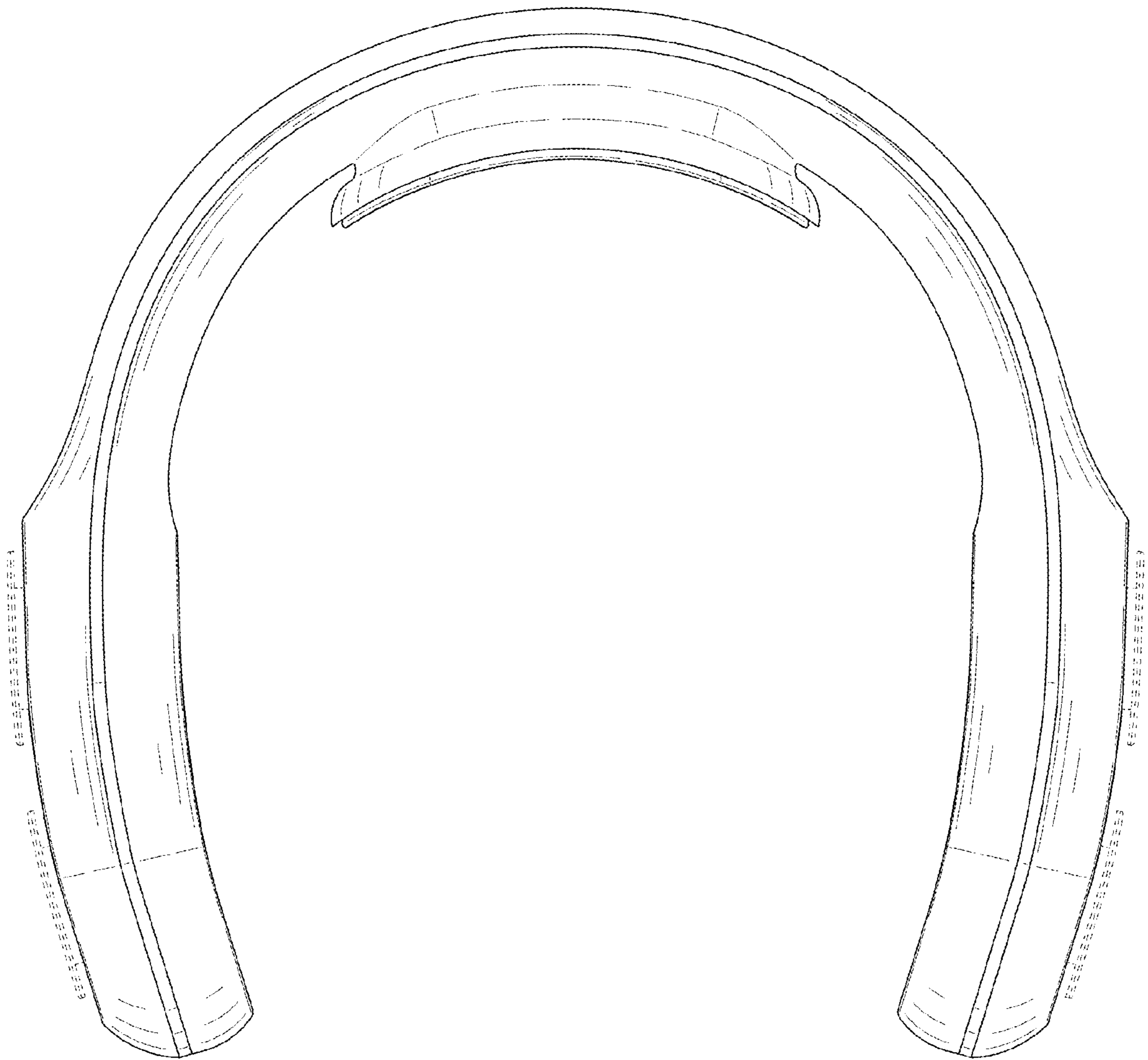

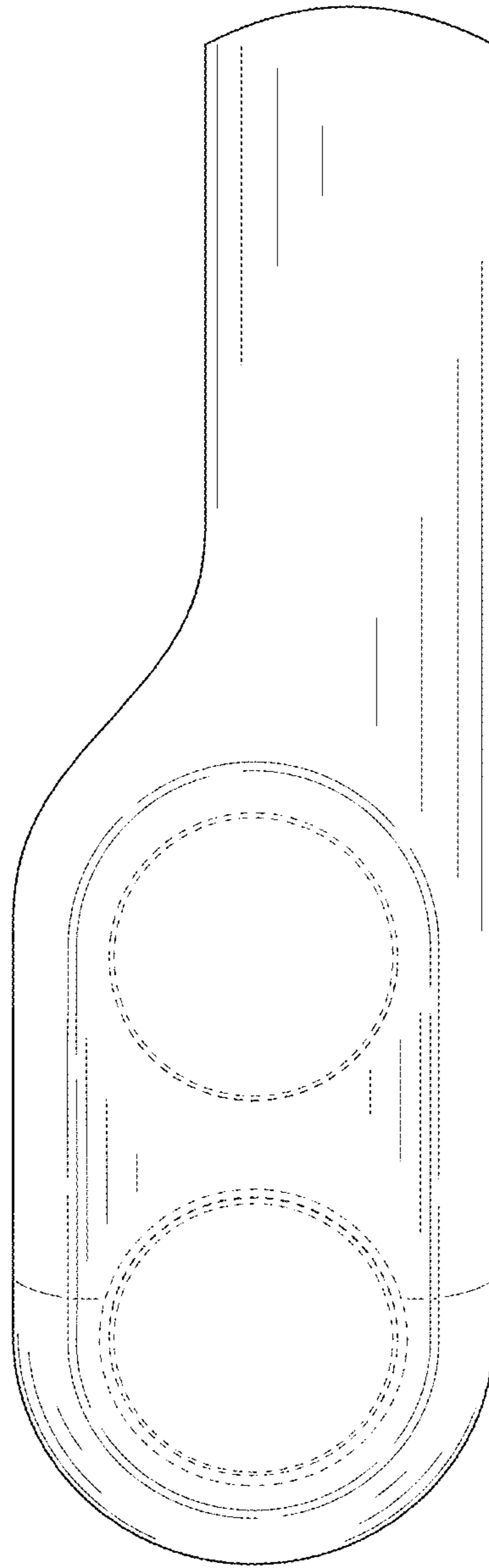

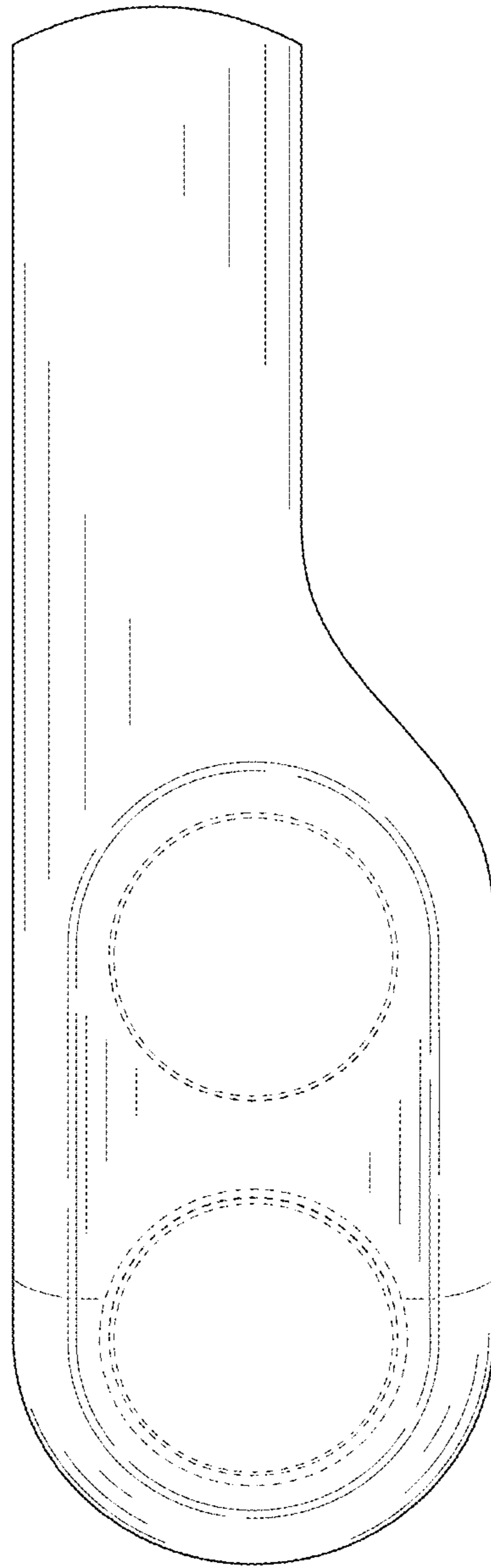

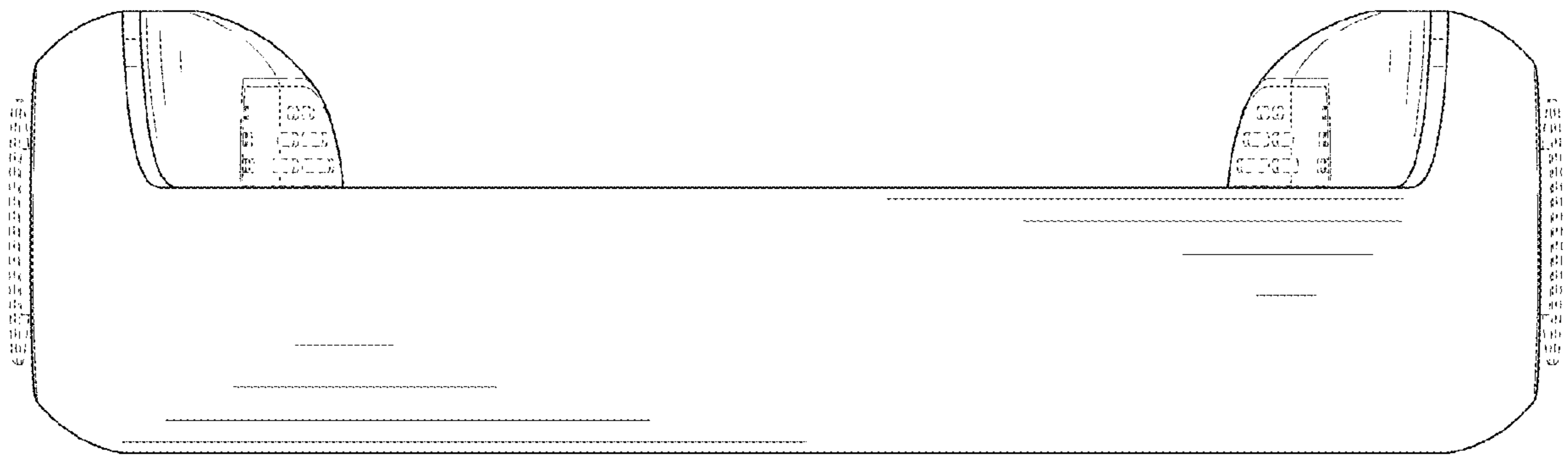

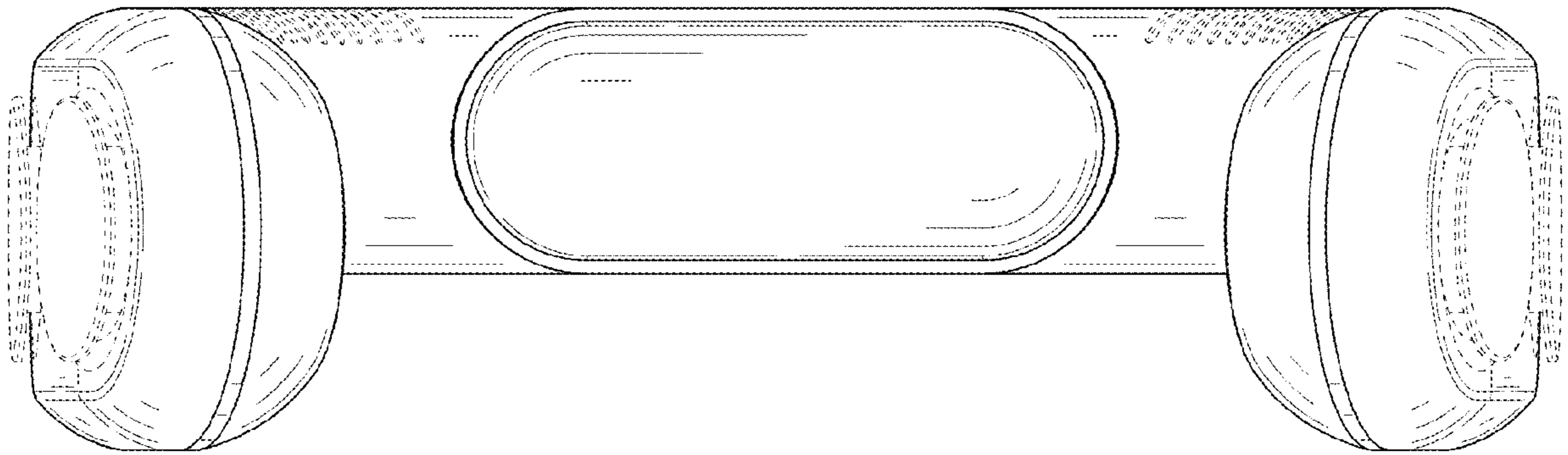
