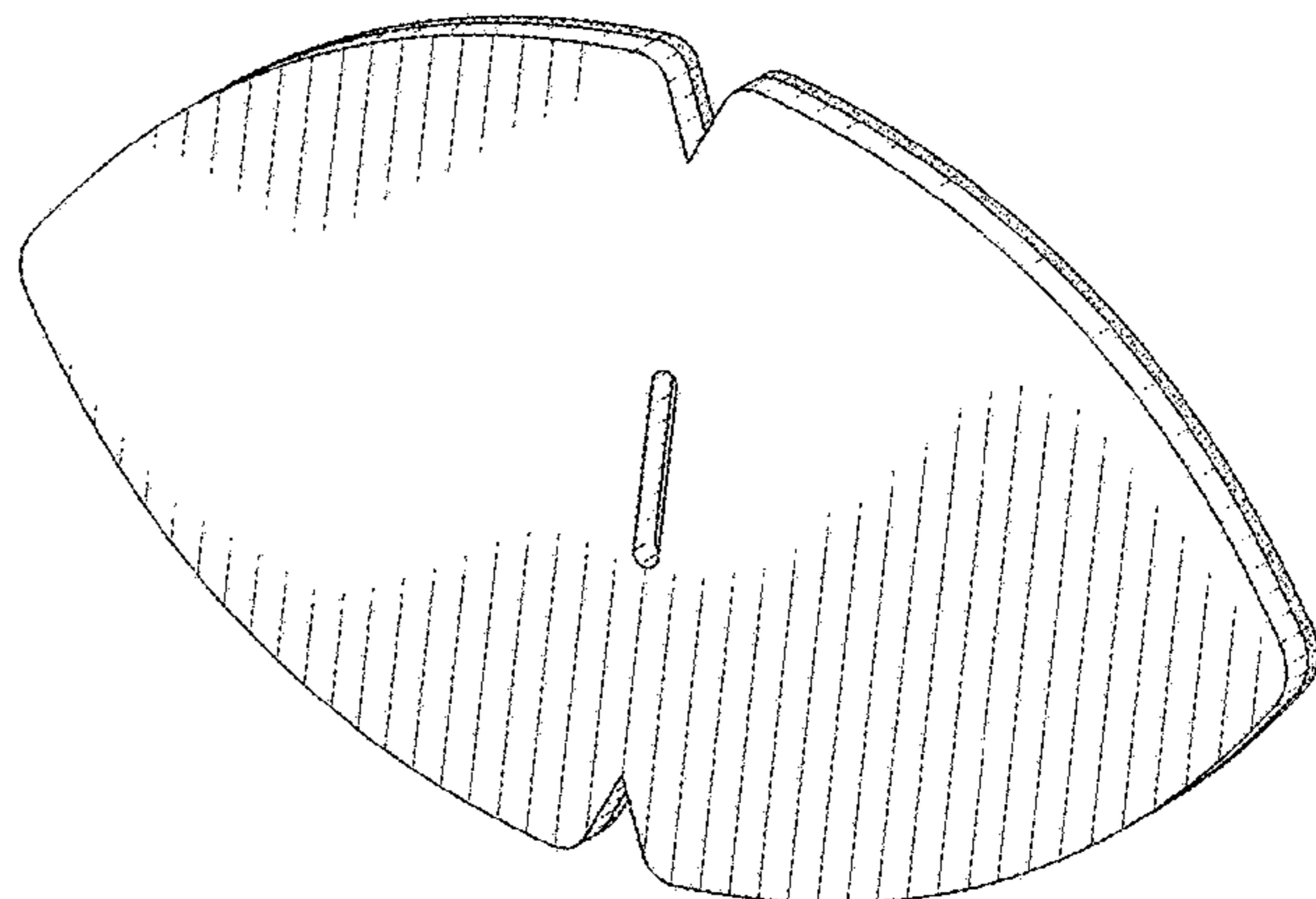
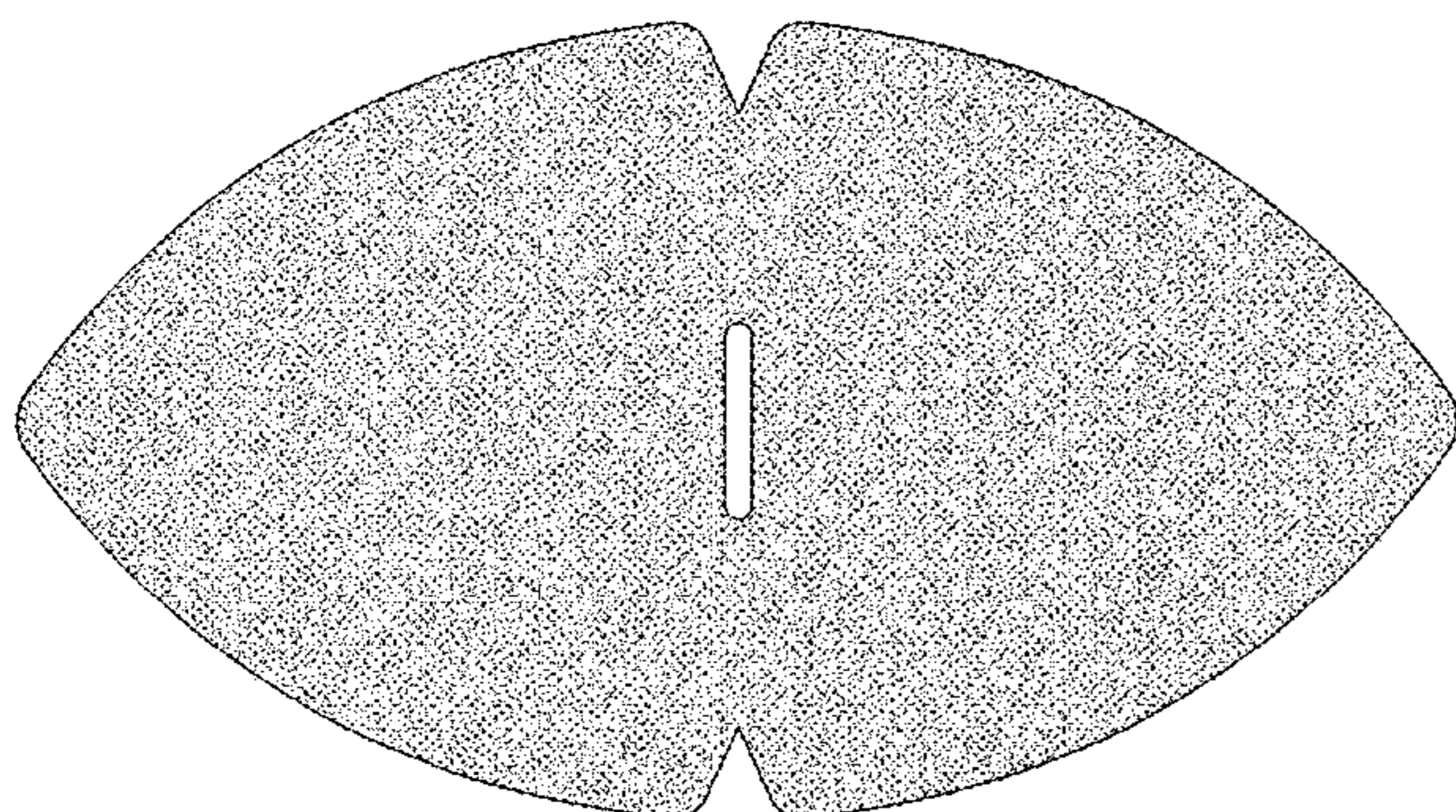
(57) **CLAIM**

I claim the ornamental design for a lip tape, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the lip tape;  
FIG. 2 is a rear view of the lip tape;  
FIG. 3 is a top view of the lip tape, the bottom view being a mirror image;  
FIG. 4 is a right side view of the lip tape, the left side view being a mirror image; and,  
FIG. 5 is a perspective view of the lip tape.

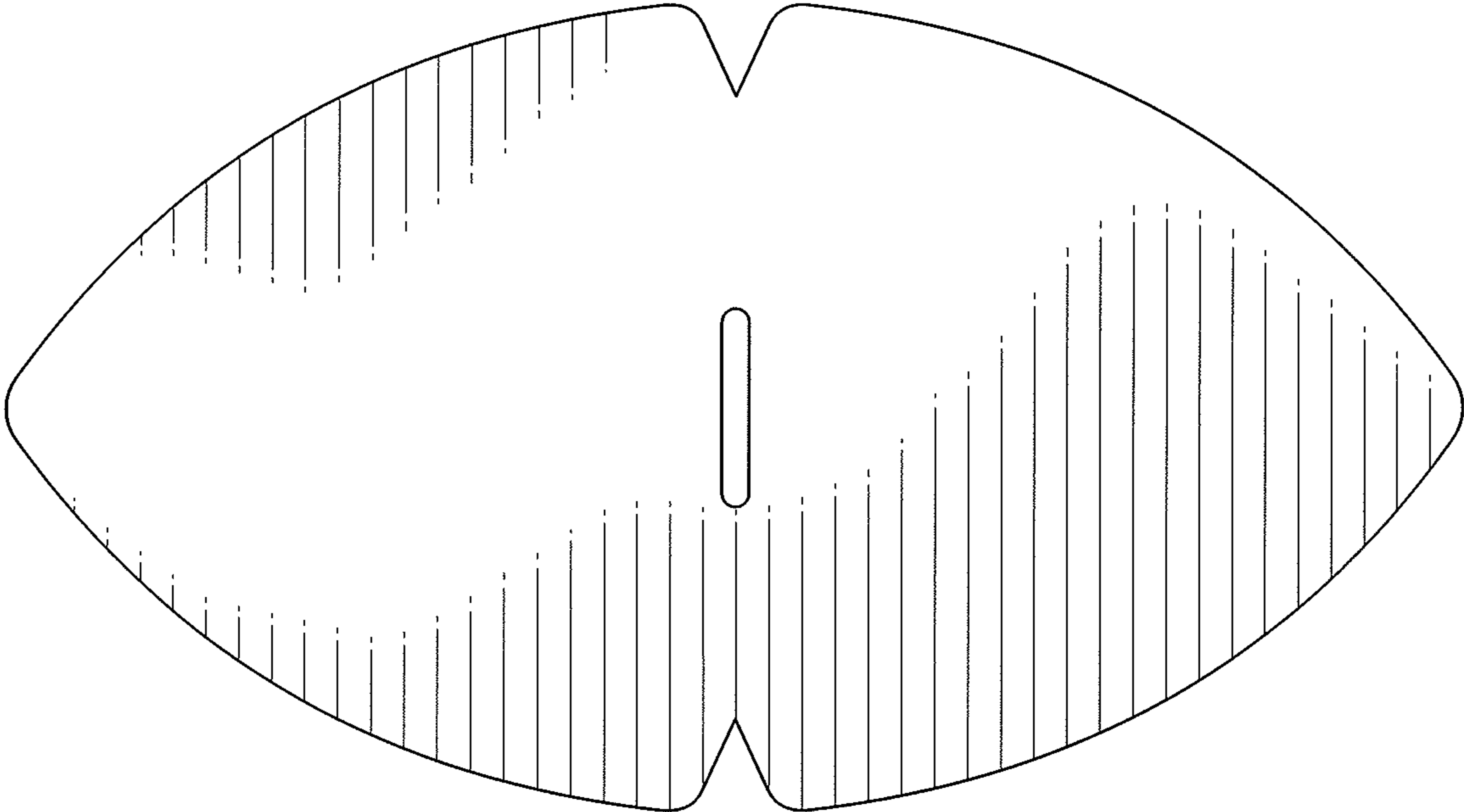

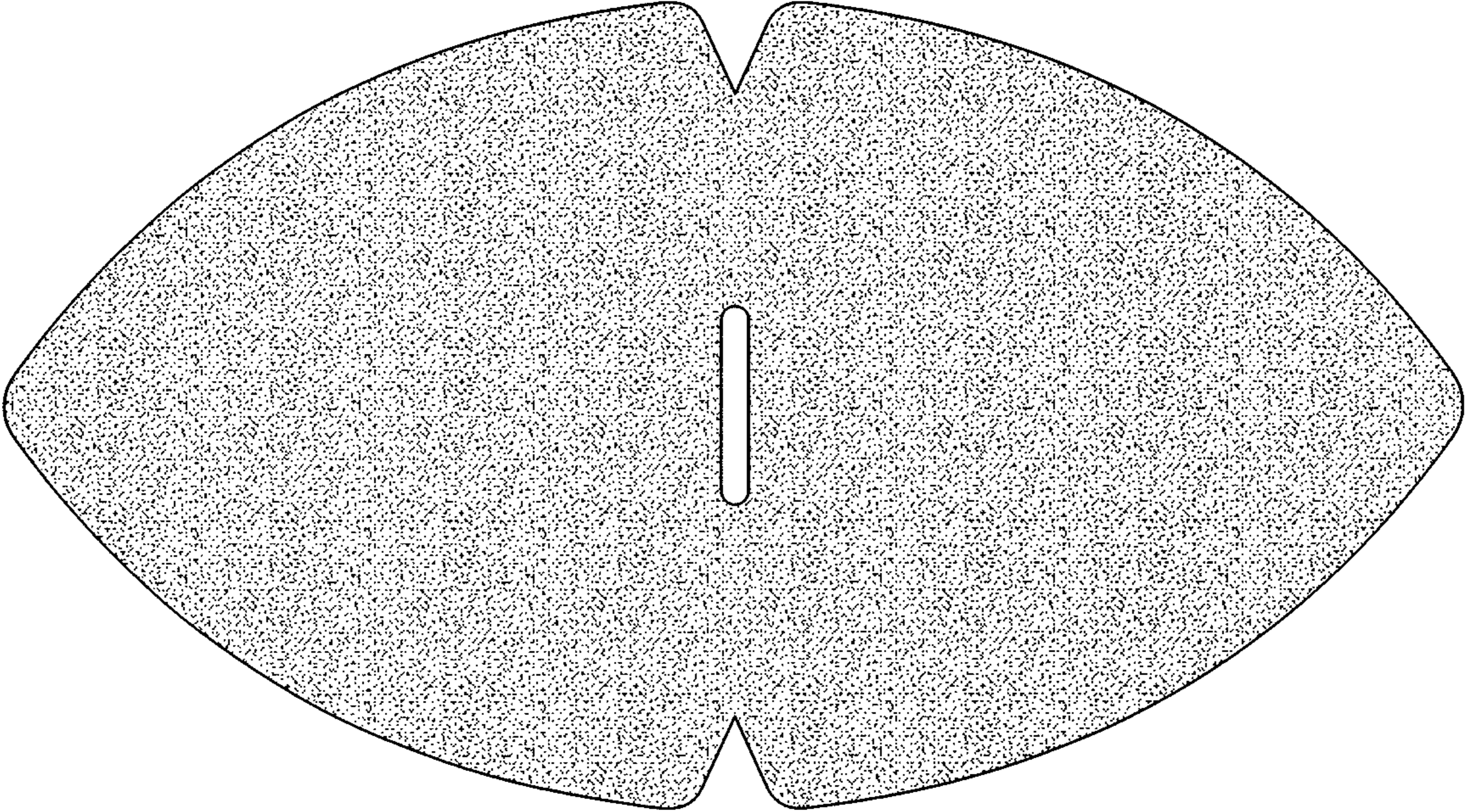

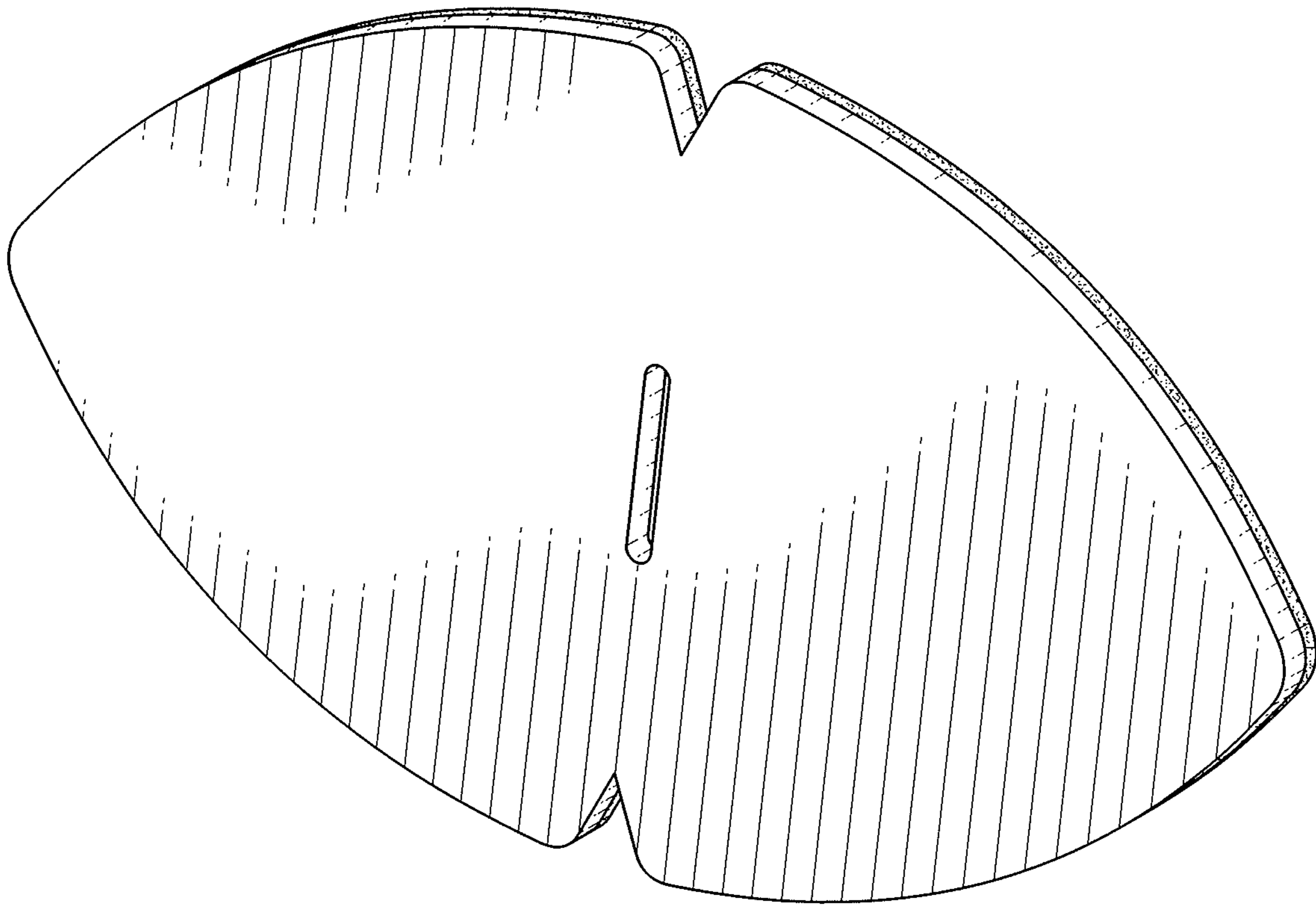
