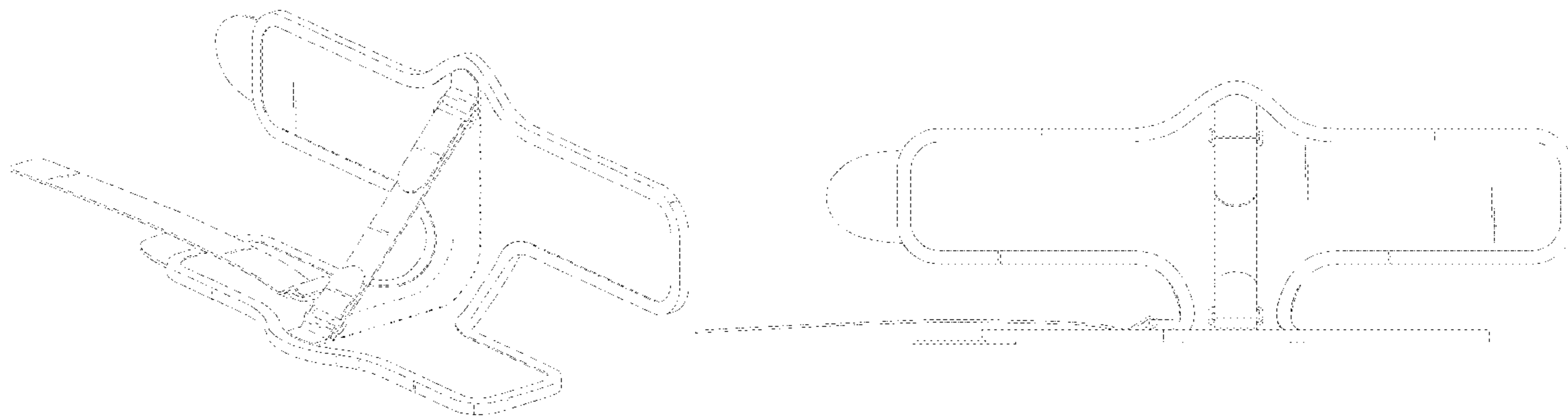
(57) **CLAIM**

The ornamental design for a plantar fasciitis night splint, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a plantar fasciitis night splint showing the claimed design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a rear elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines illustrate portions of the plantar fasciitis night splint that form no part of the claimed design.

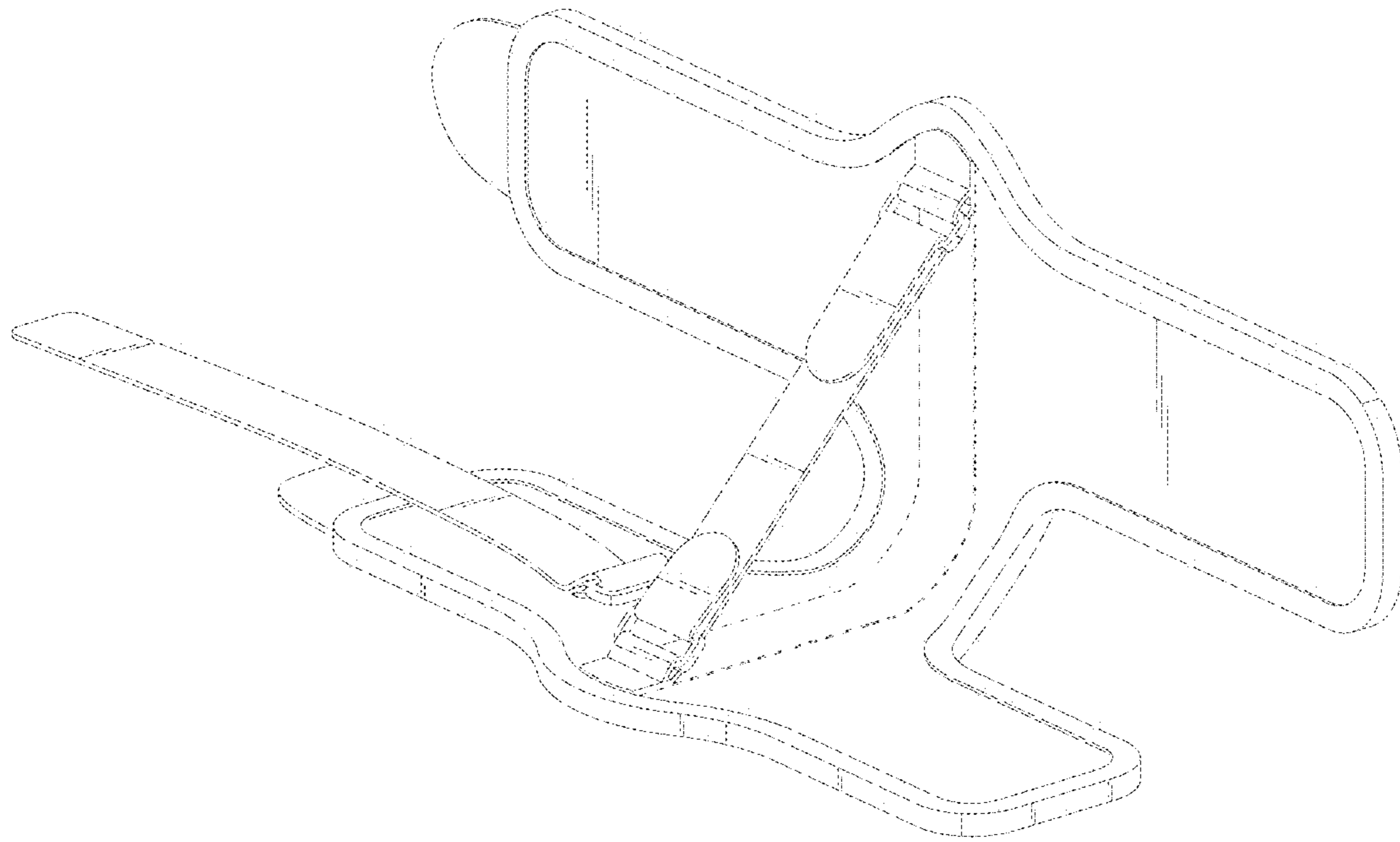

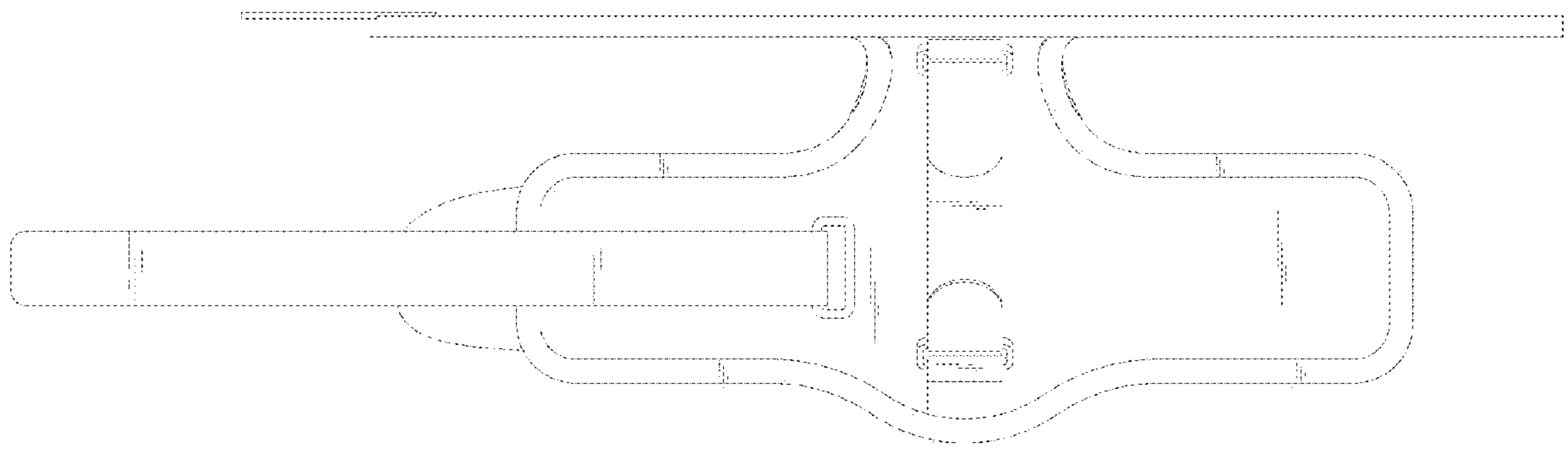

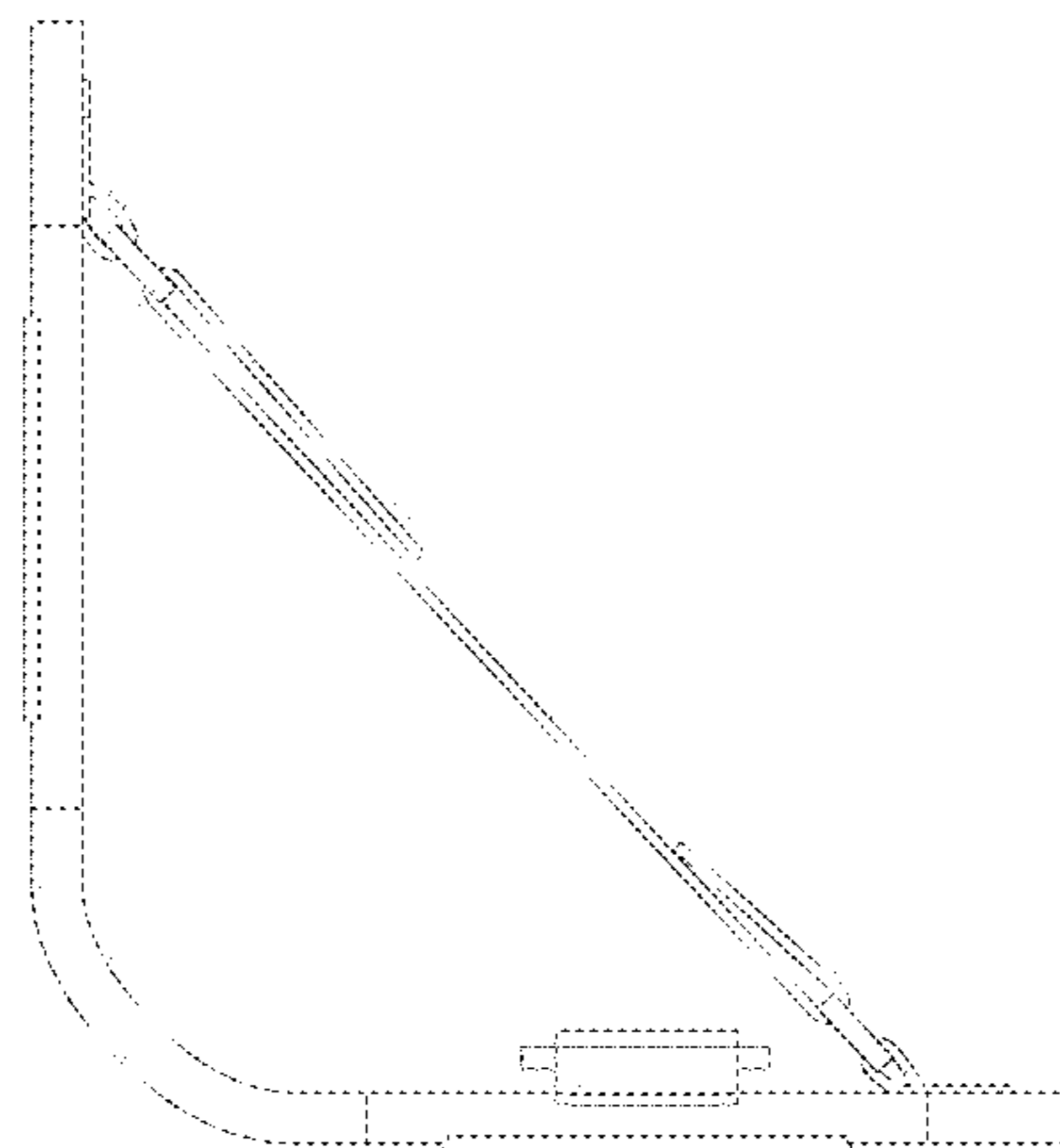

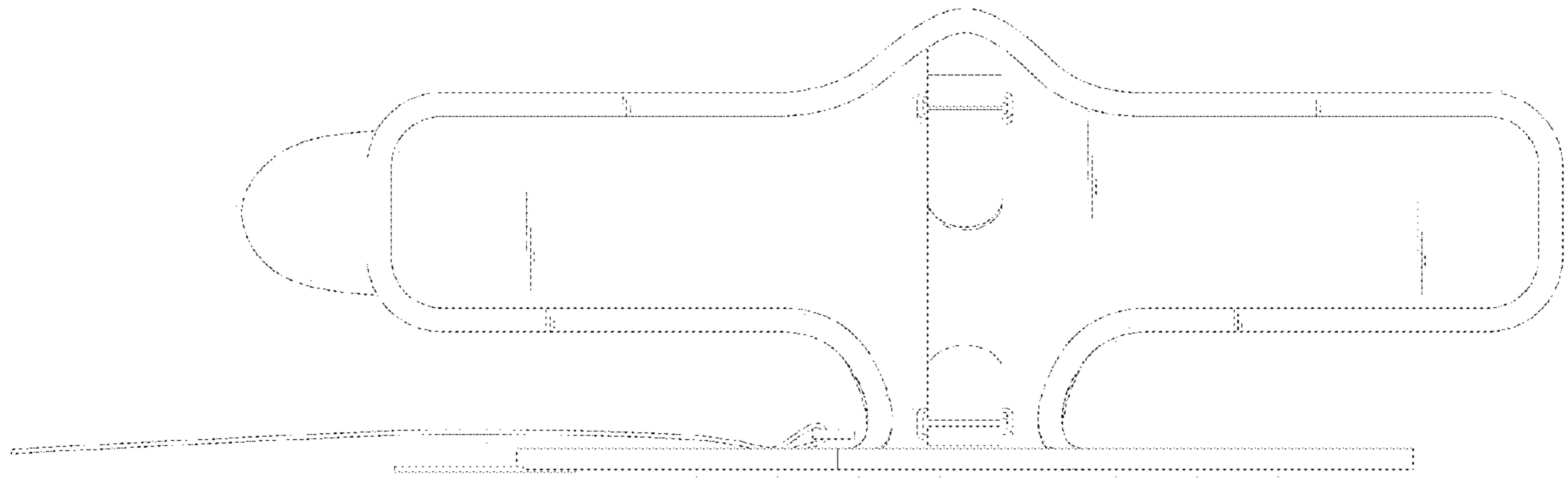

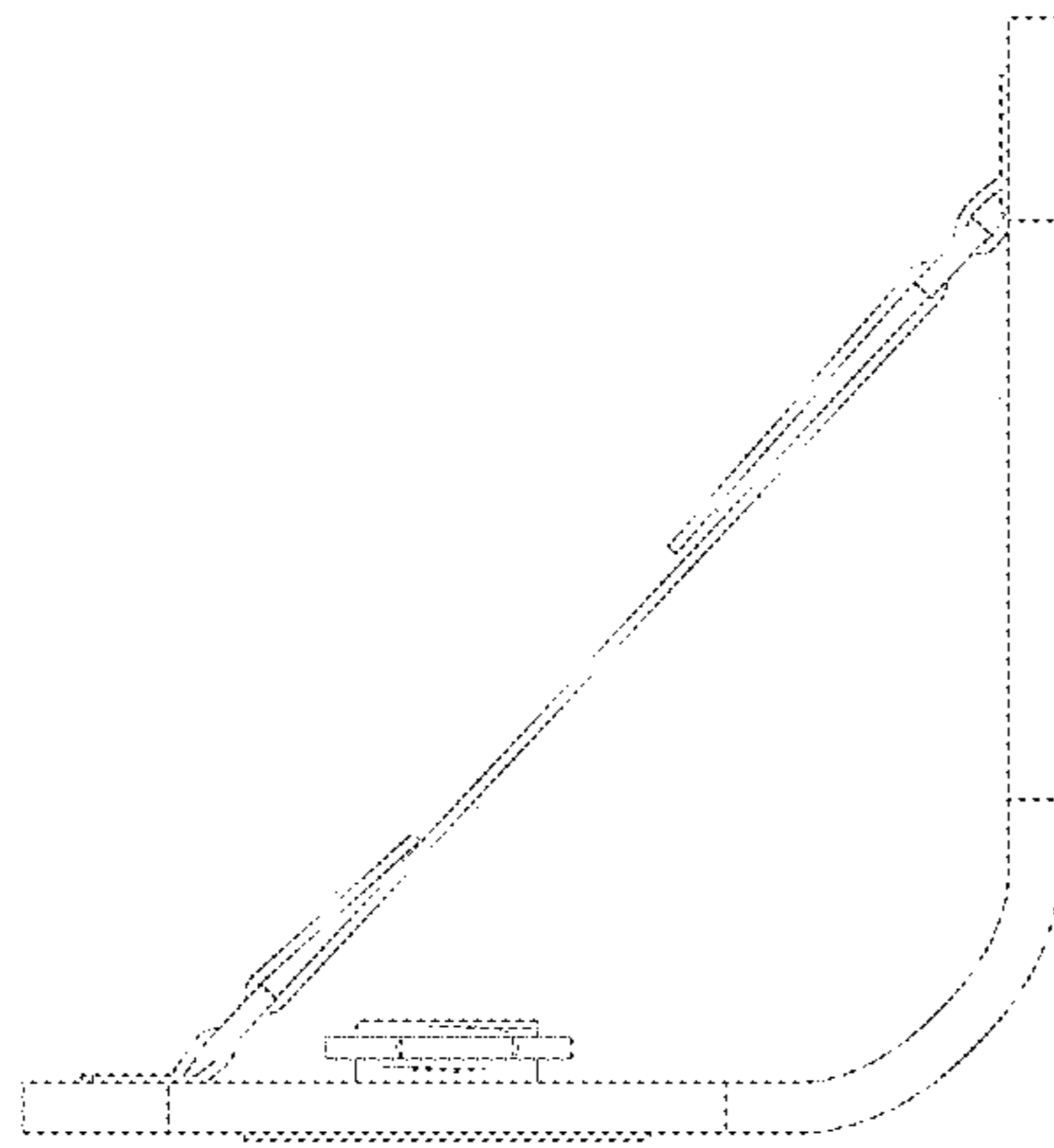

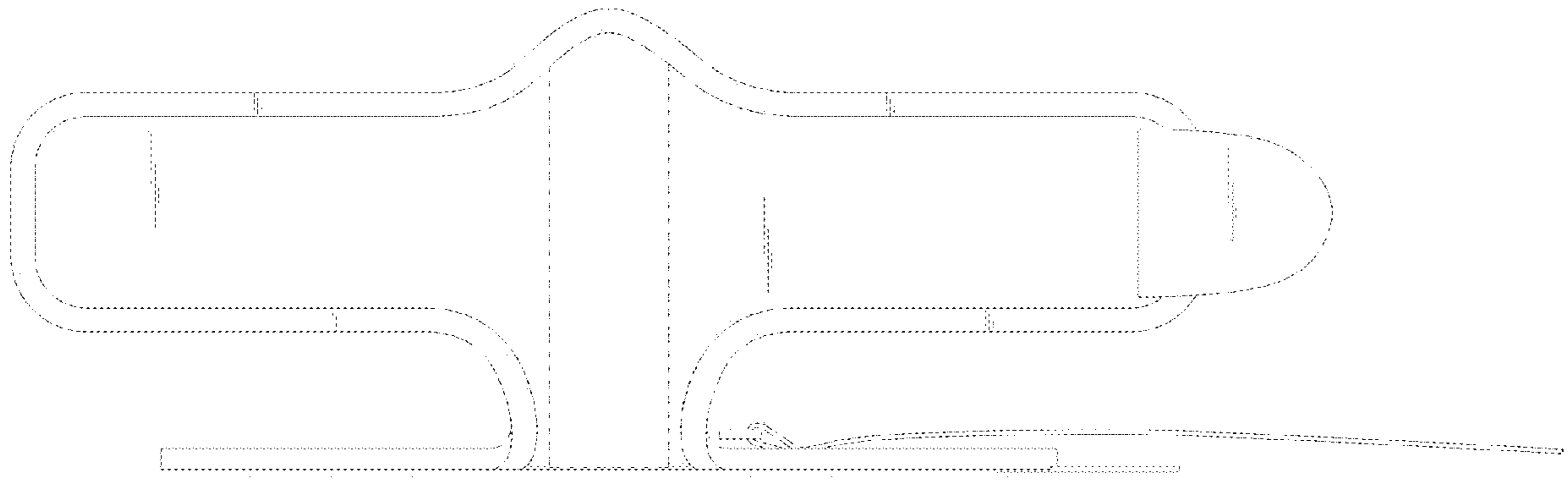

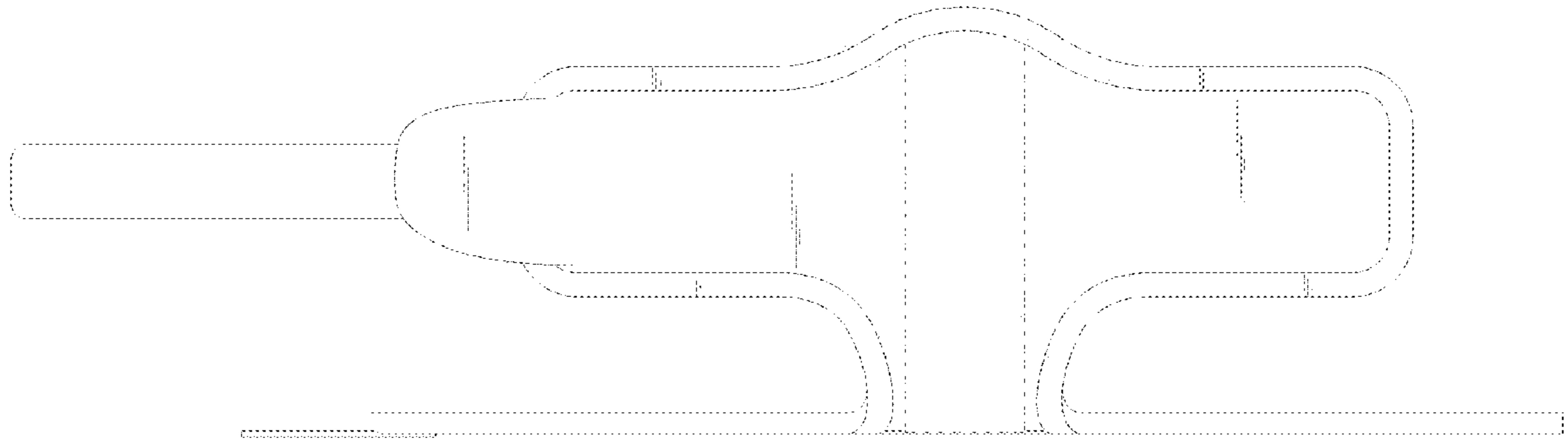
