The ornamental design for an automobile headlight, as shown and described.

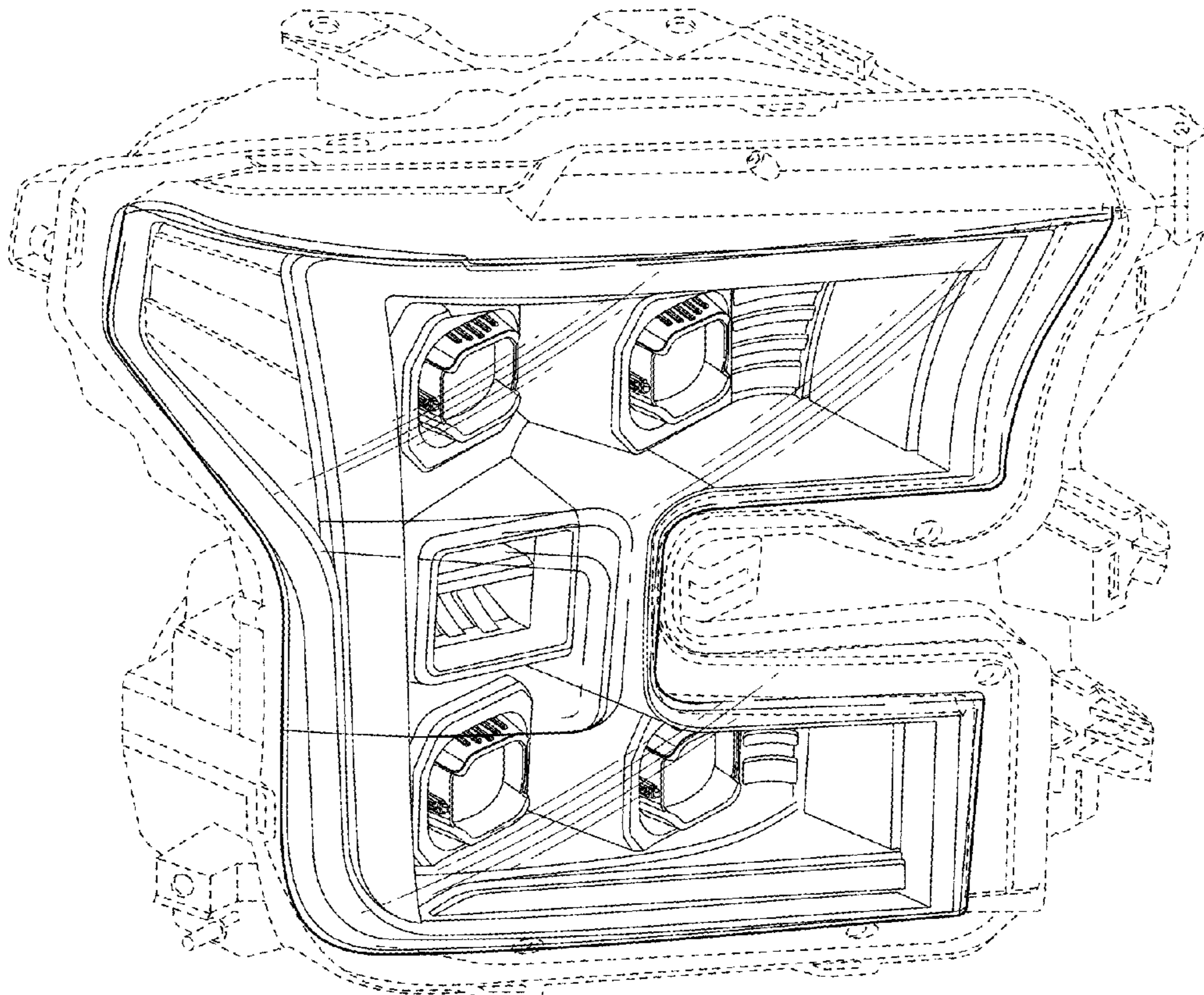
DESCRIPTION

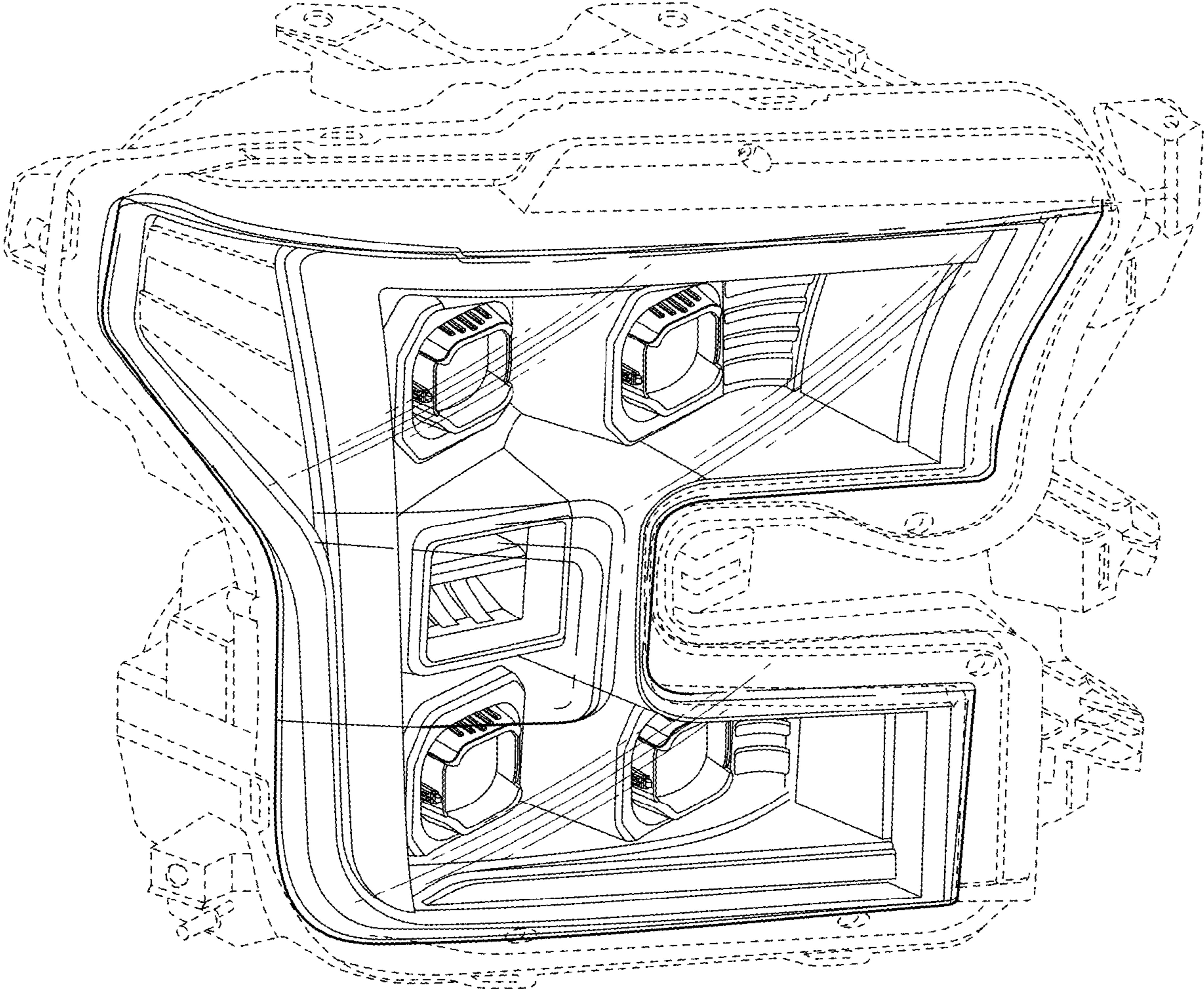

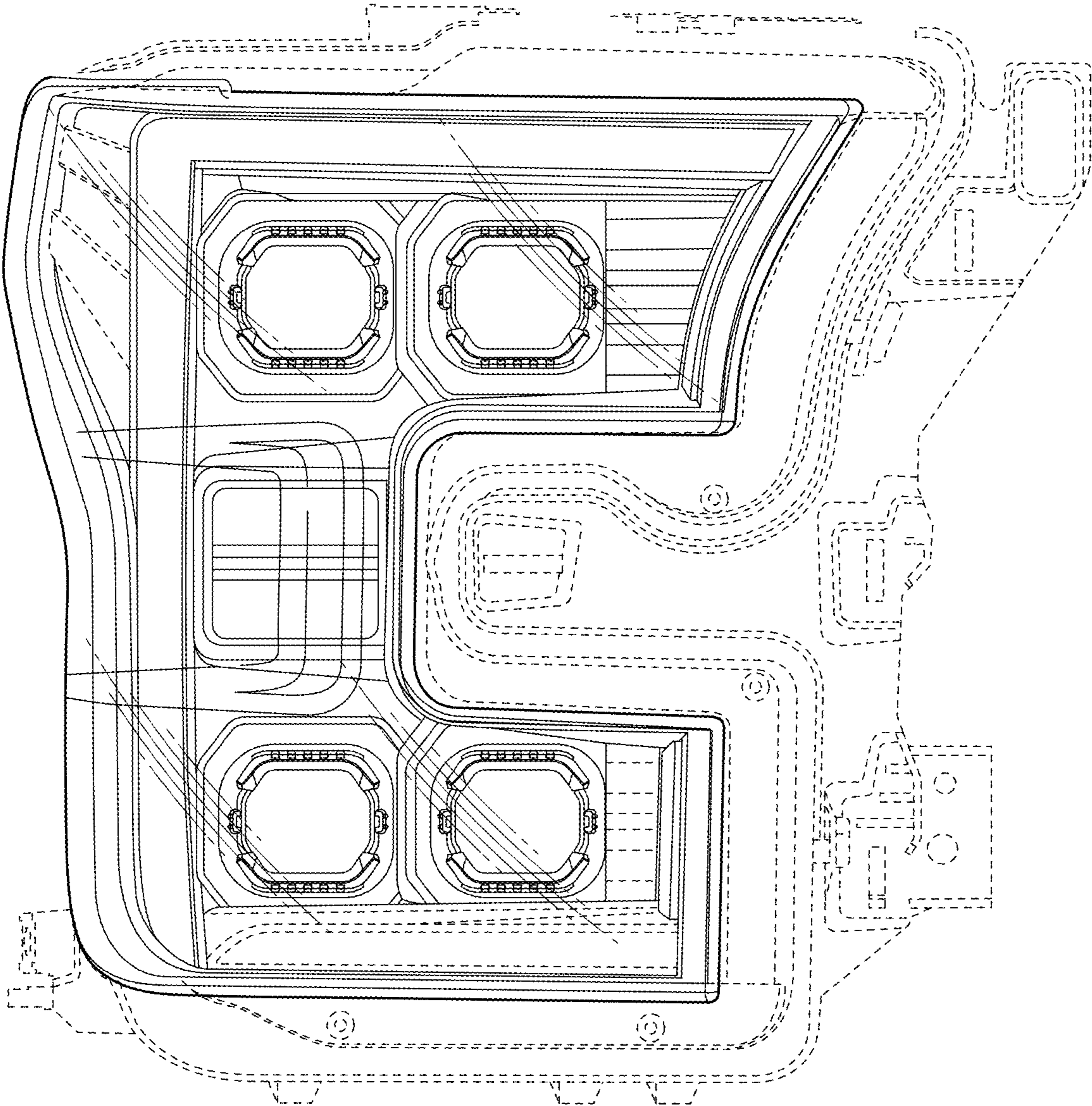

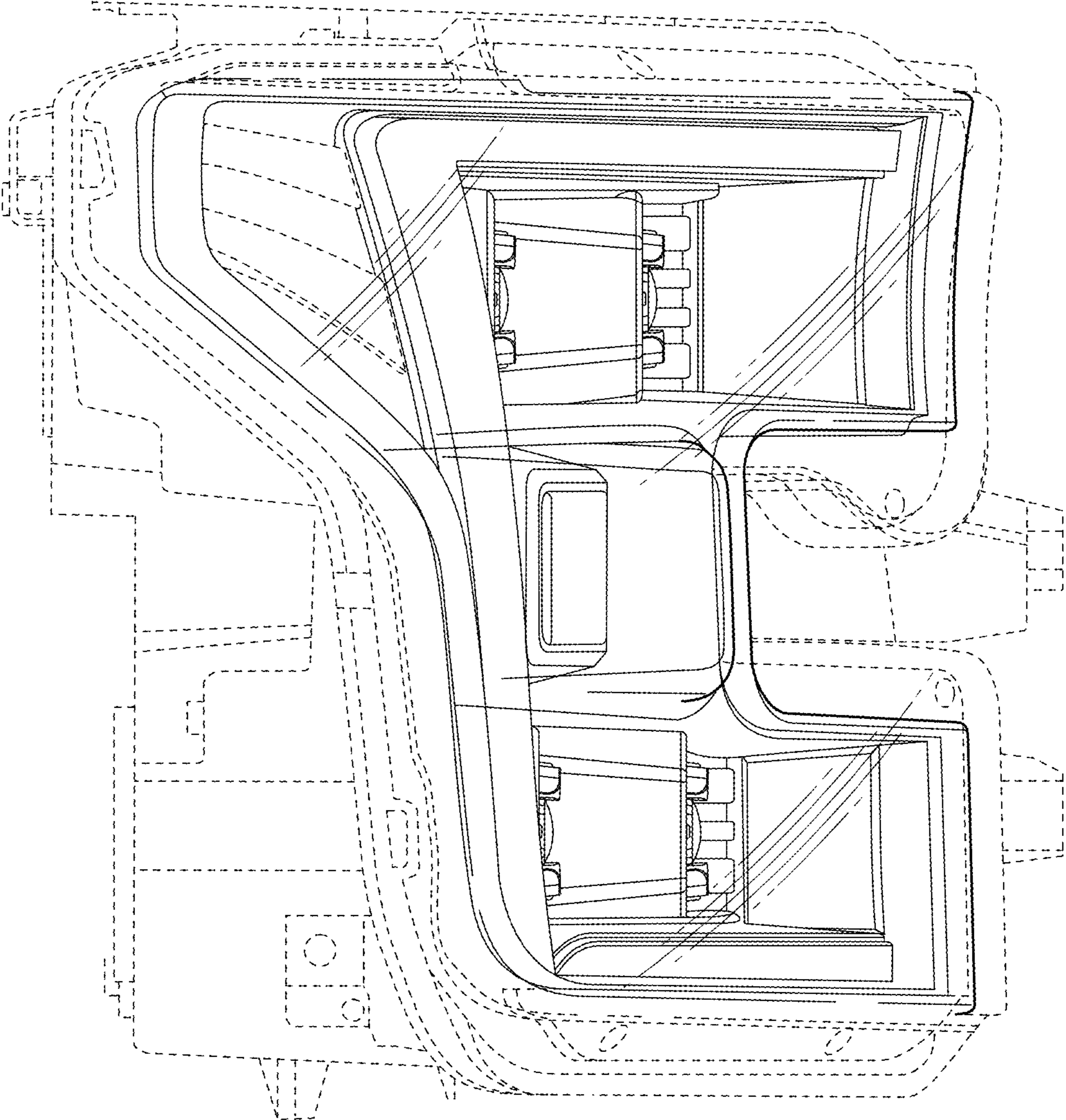

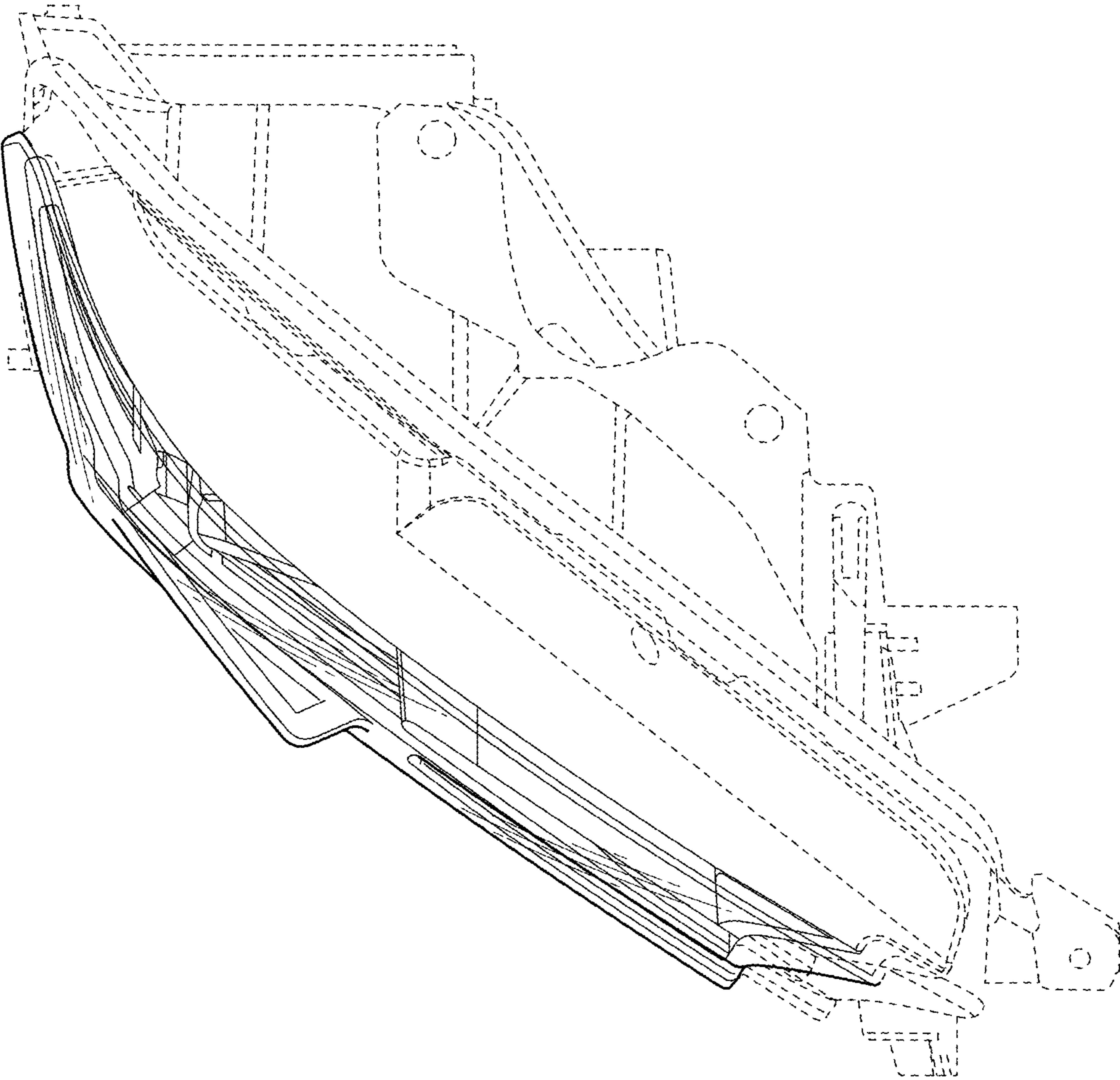
