FIG. 7 is a top view thereof.

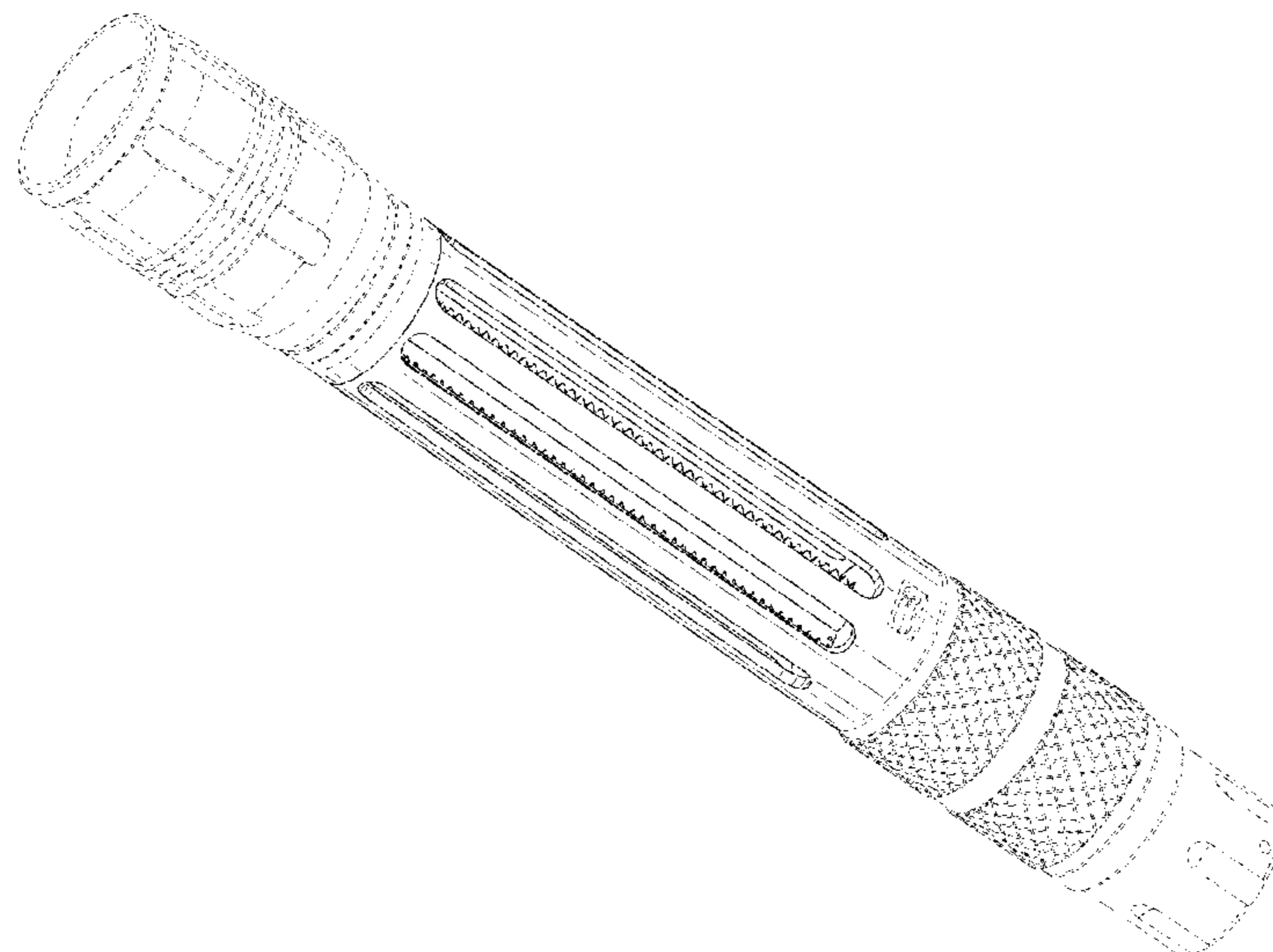
The broken lines shown in the figures show portions of the

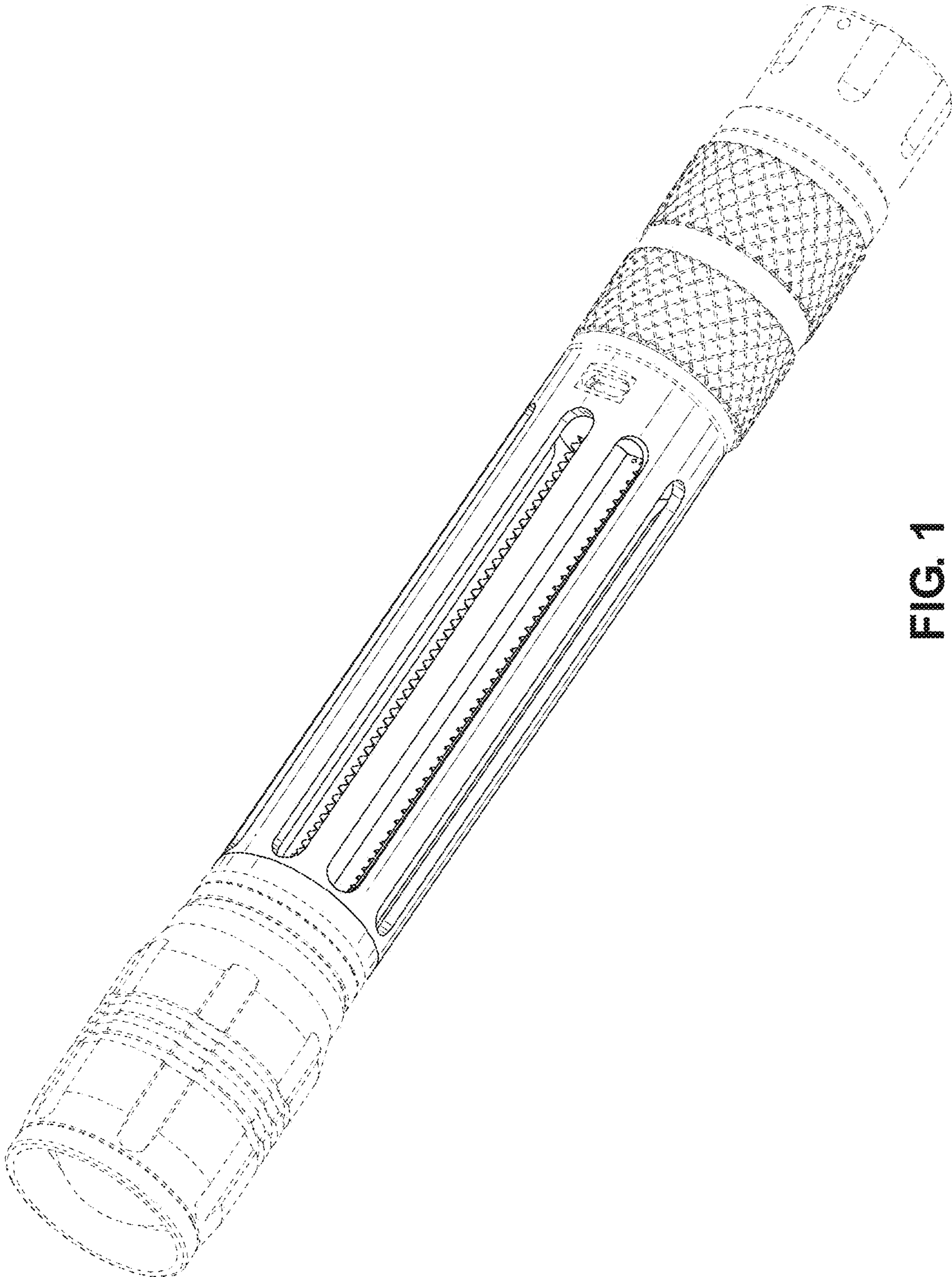

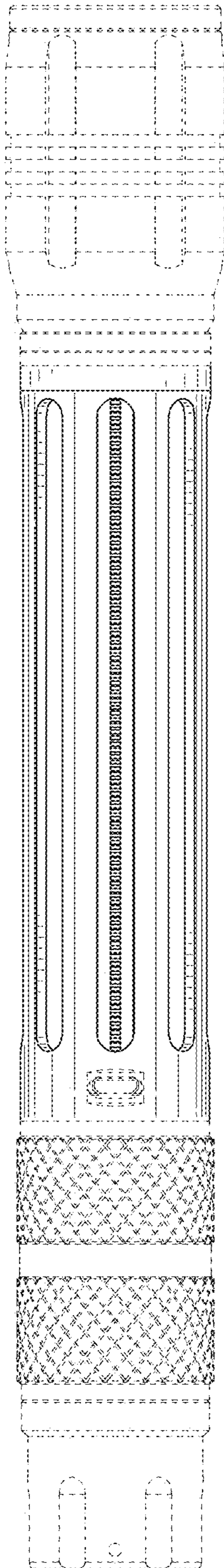

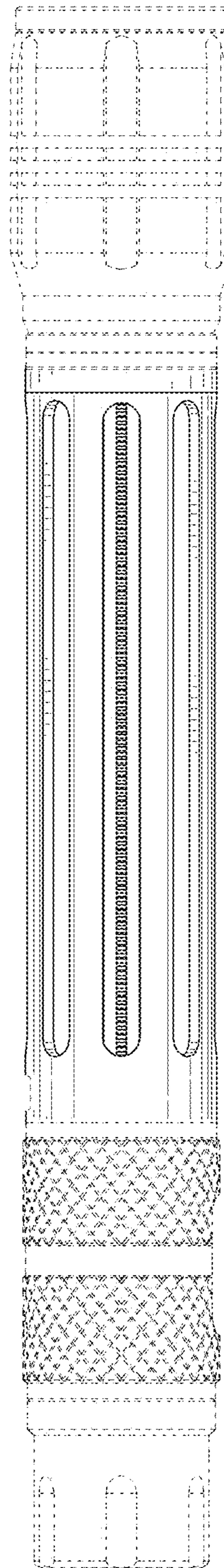

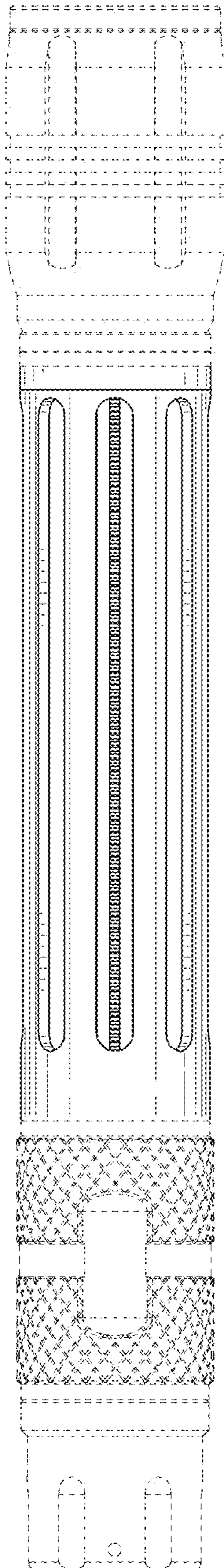

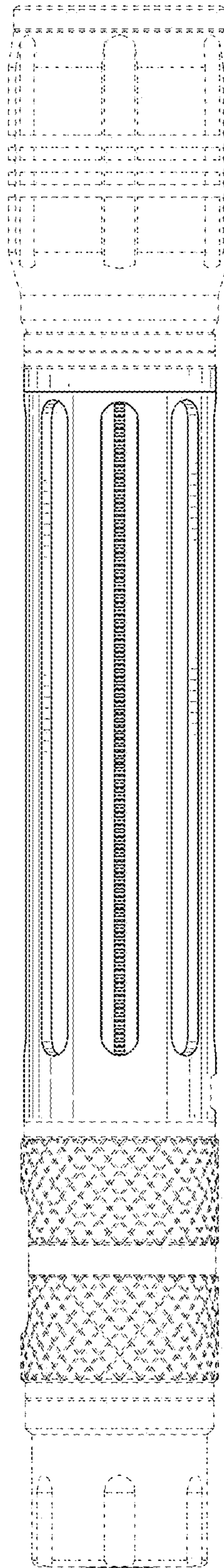

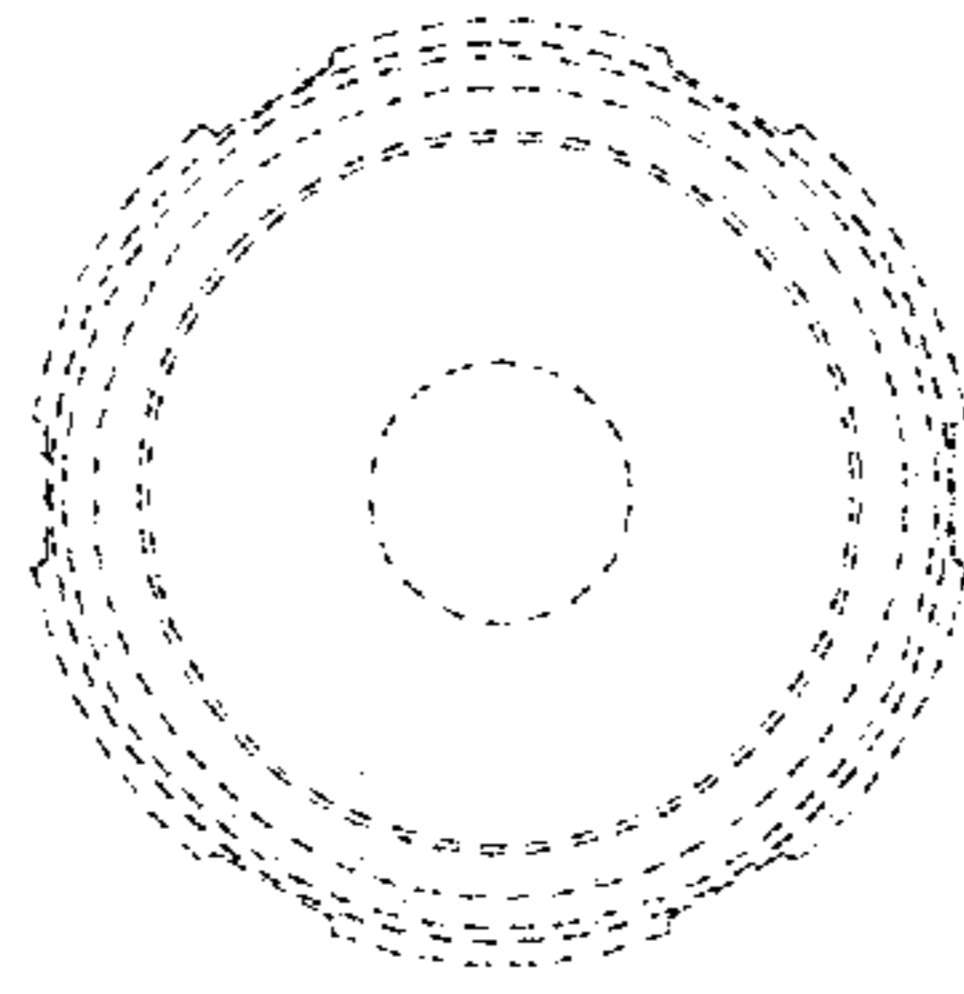

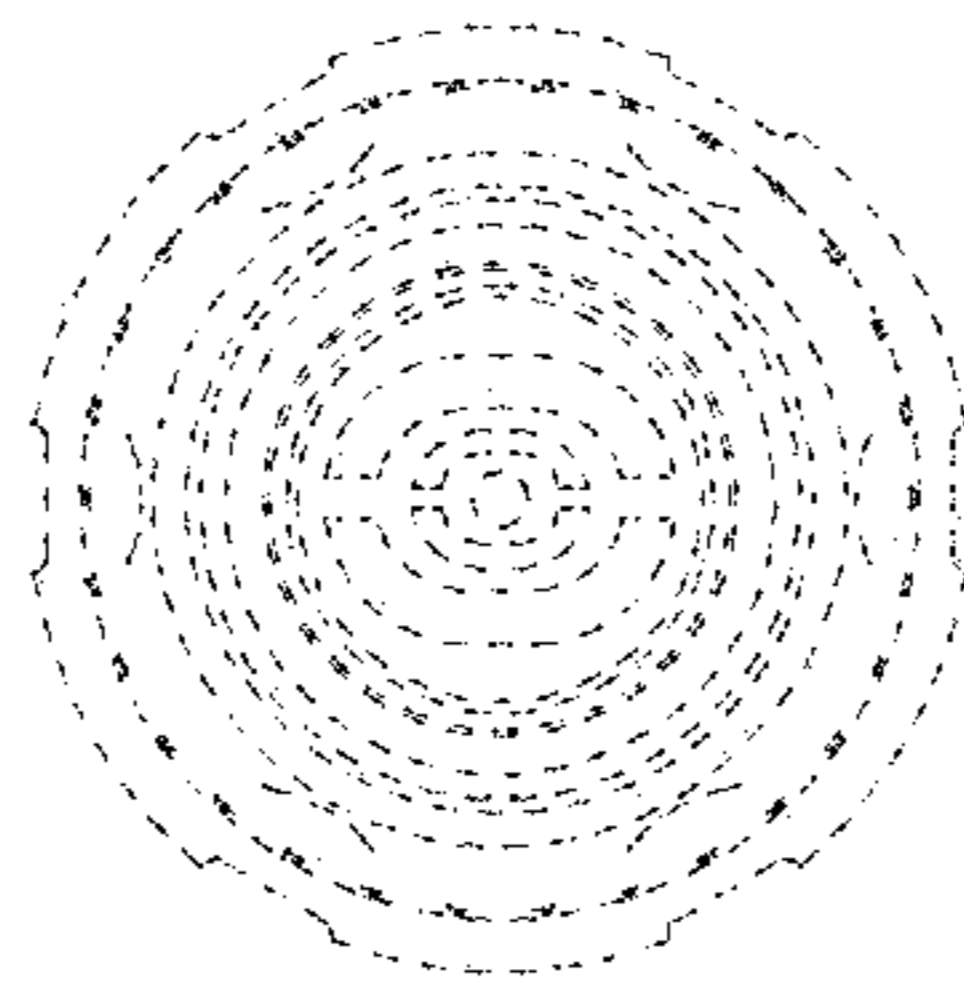
