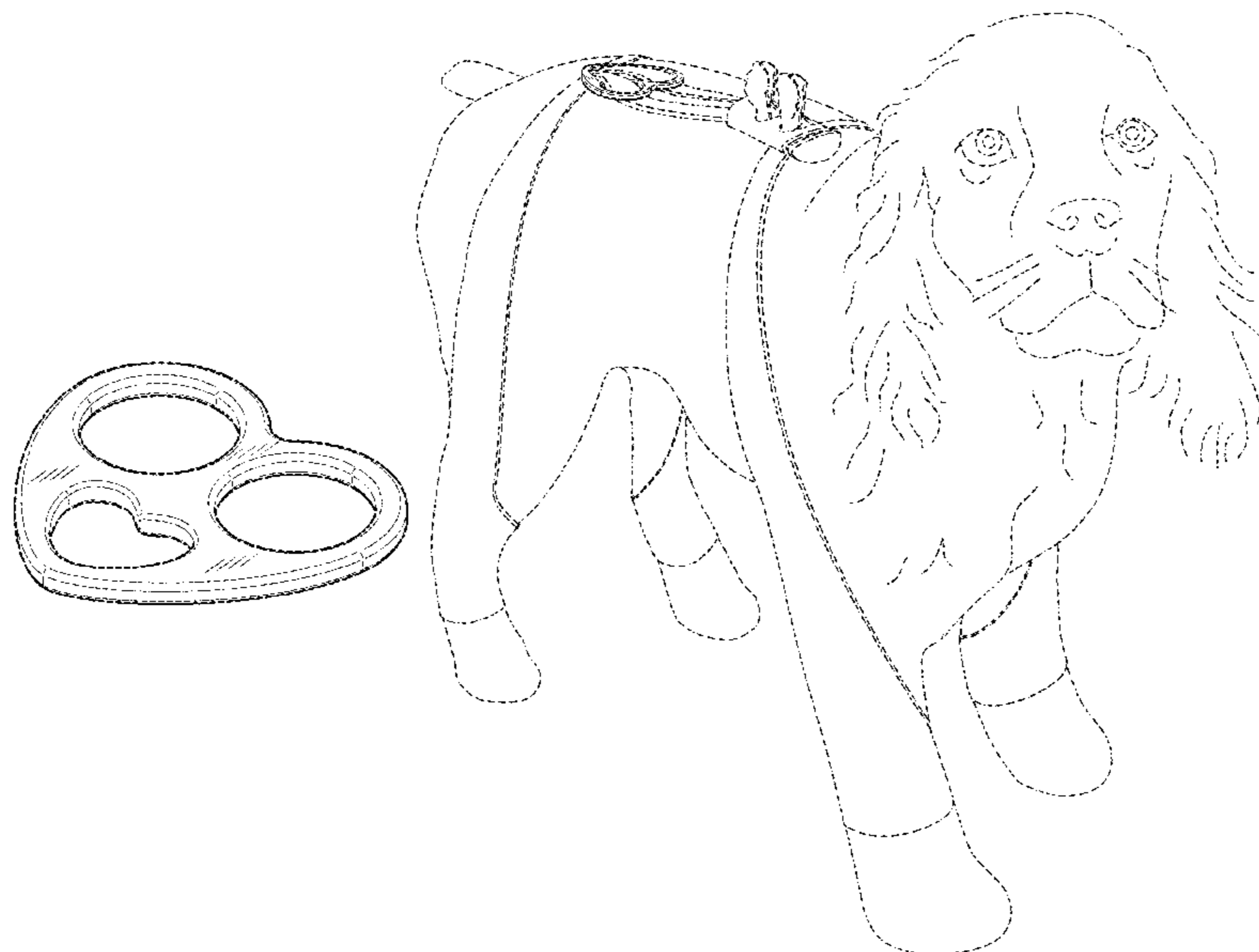
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a connector showing my new design;  
FIG. 2 is a front elevation view thereof, the back elevation view being the same;  
FIG. 3 is a right side elevation view thereof, the left side elevation view being the same;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a perspective view of a connector, shown within an environment of use; and,  
FIG. 7 is another perspective view thereof.

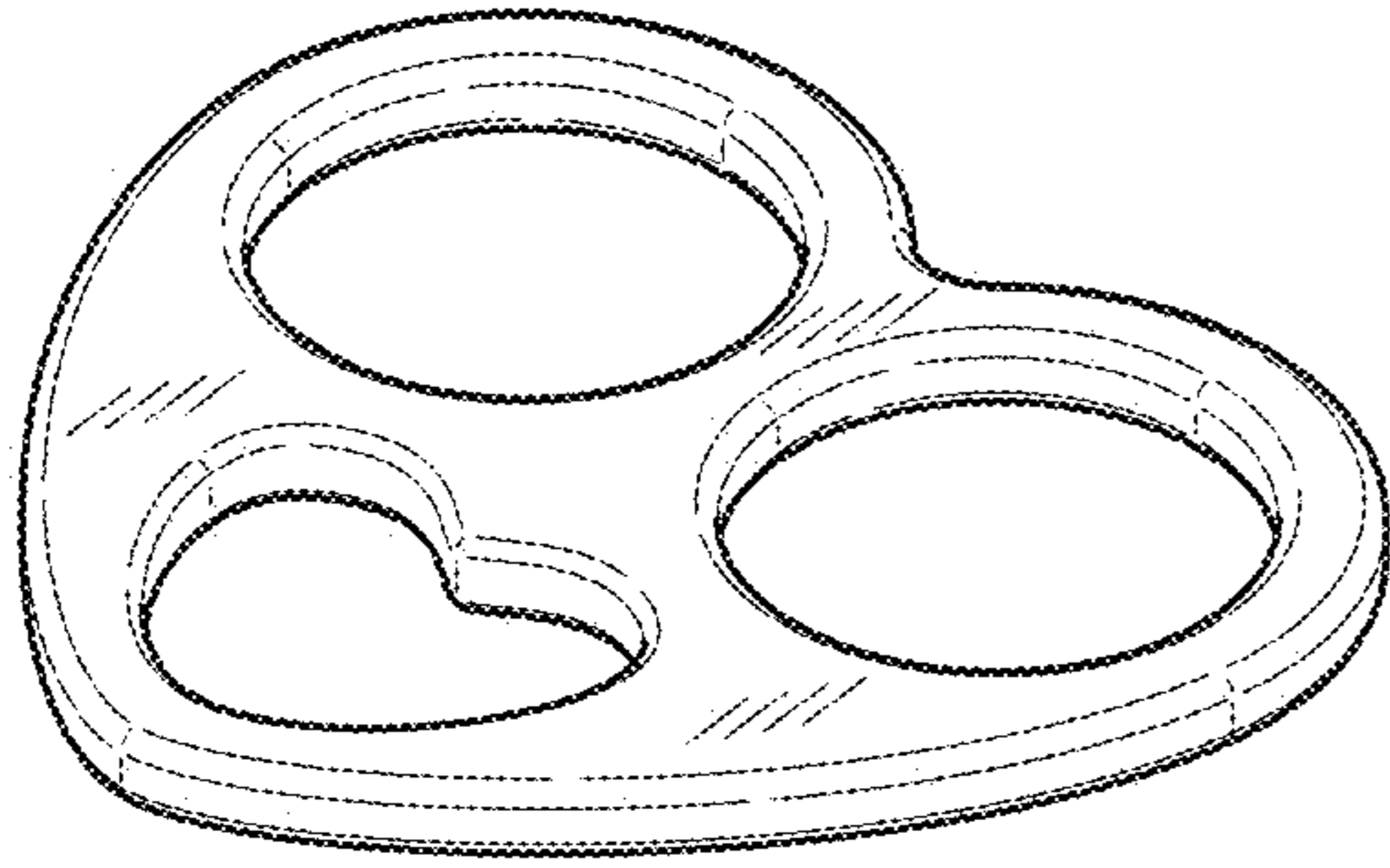

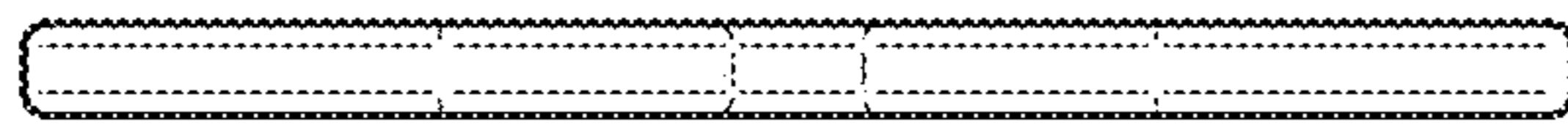

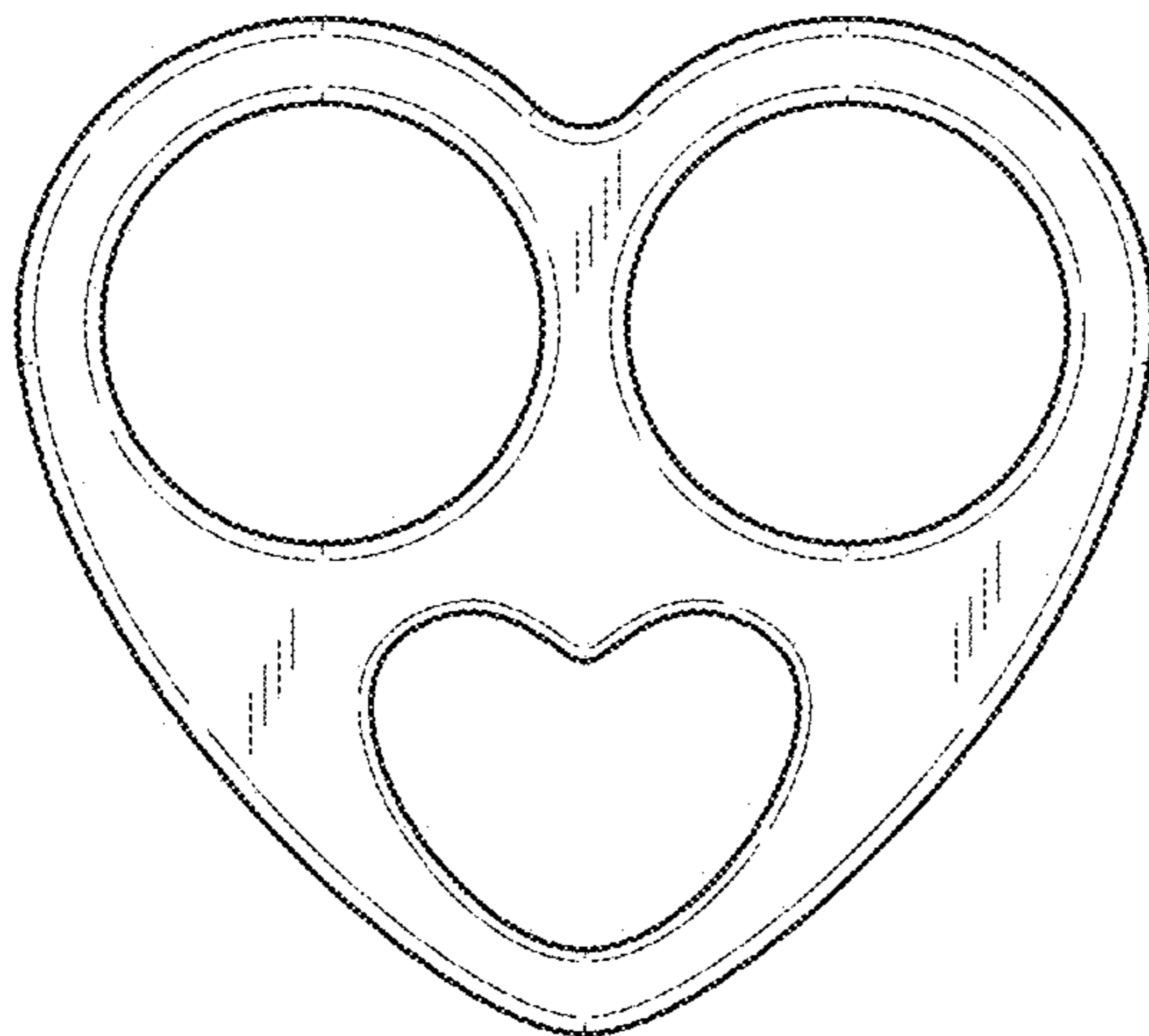

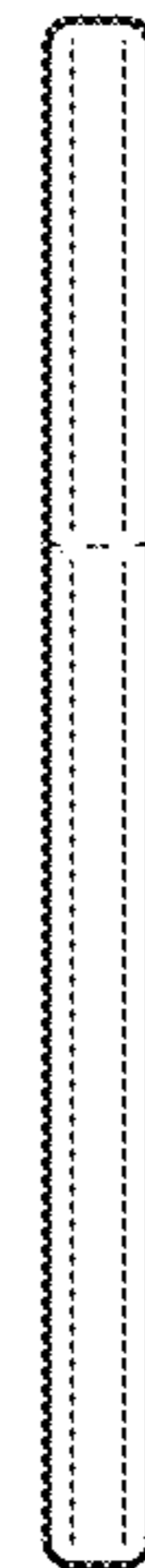

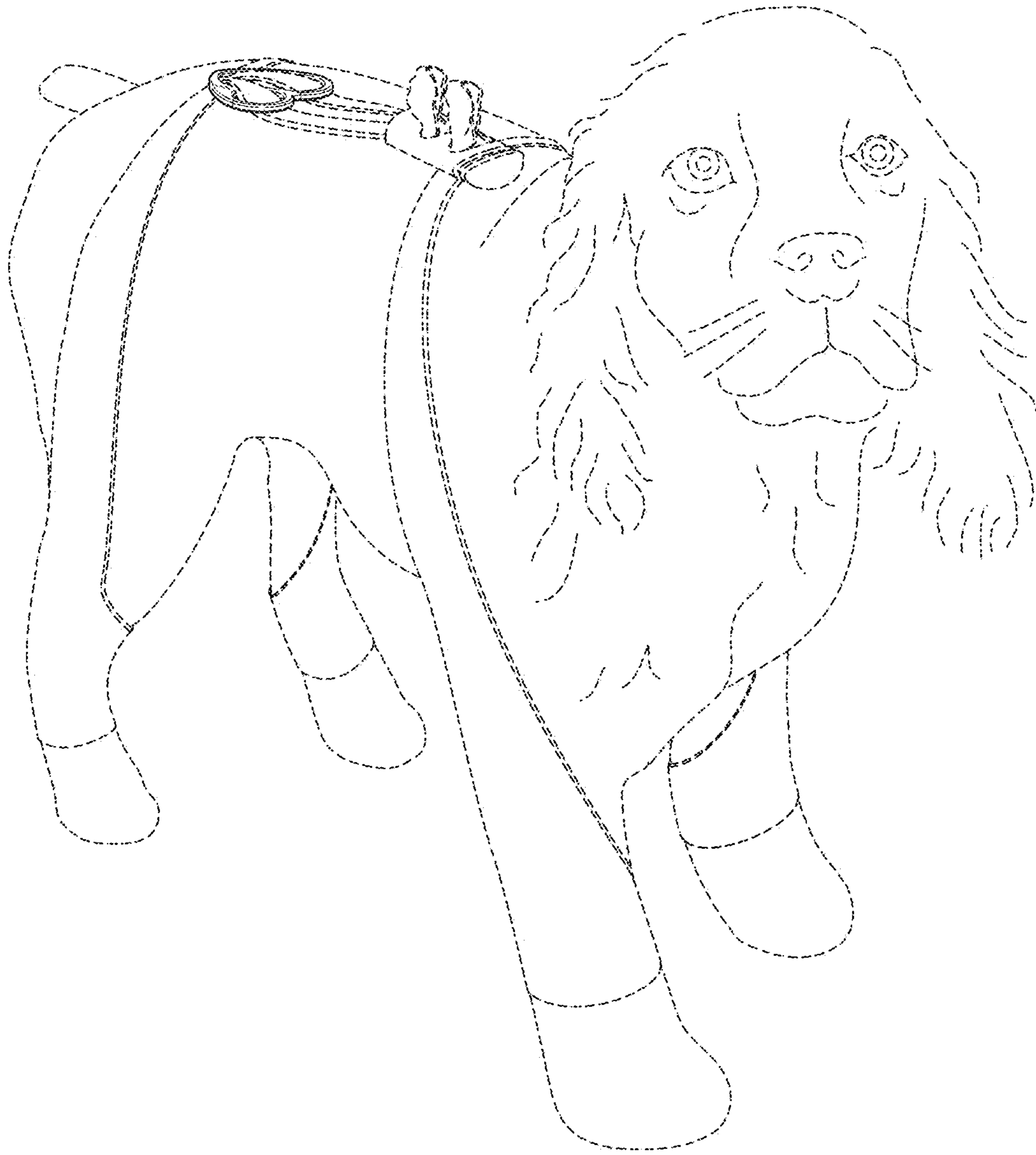

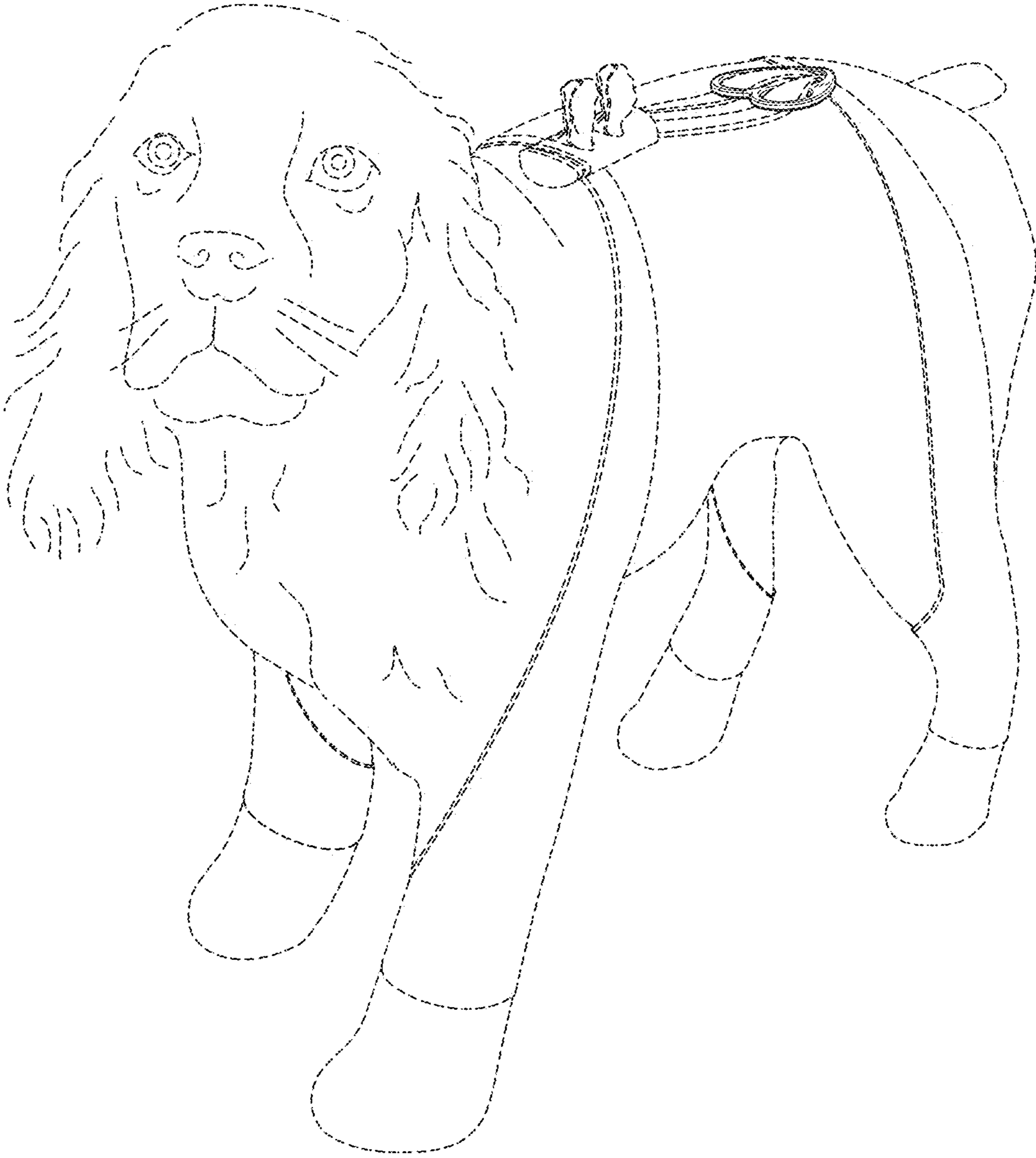
