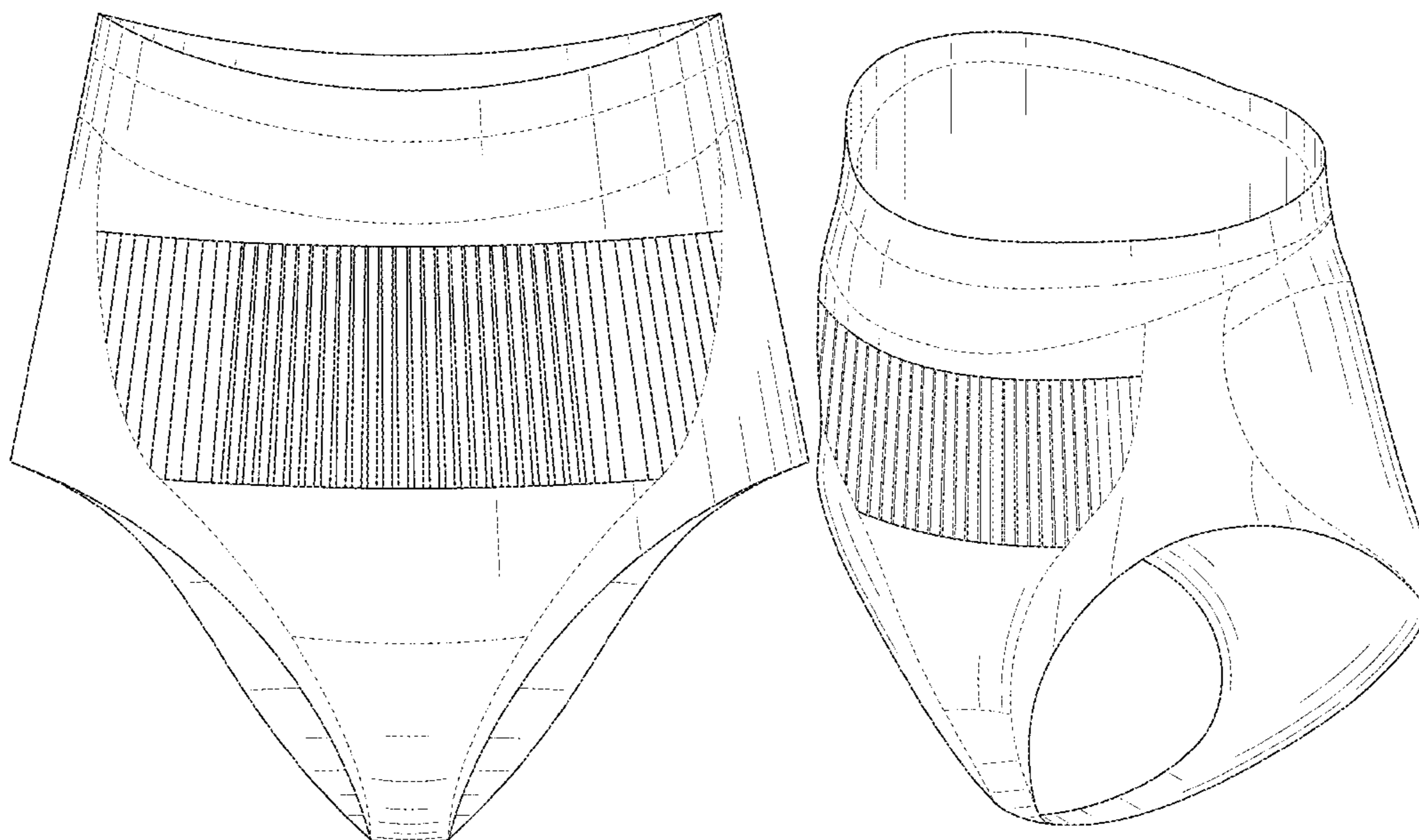
(57) **CLAIM**

The ornamental design for a panty, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a panty according to our new design;
FIG. 2 is a front bottom perspective view thereof;
FIG. 3 is a right side perspective view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side perspective view thereof; and,
FIG. 6 is a front top perspective view thereof.
The broken lines in the drawings depict stitching lines of the panty that form no part of the claimed design.

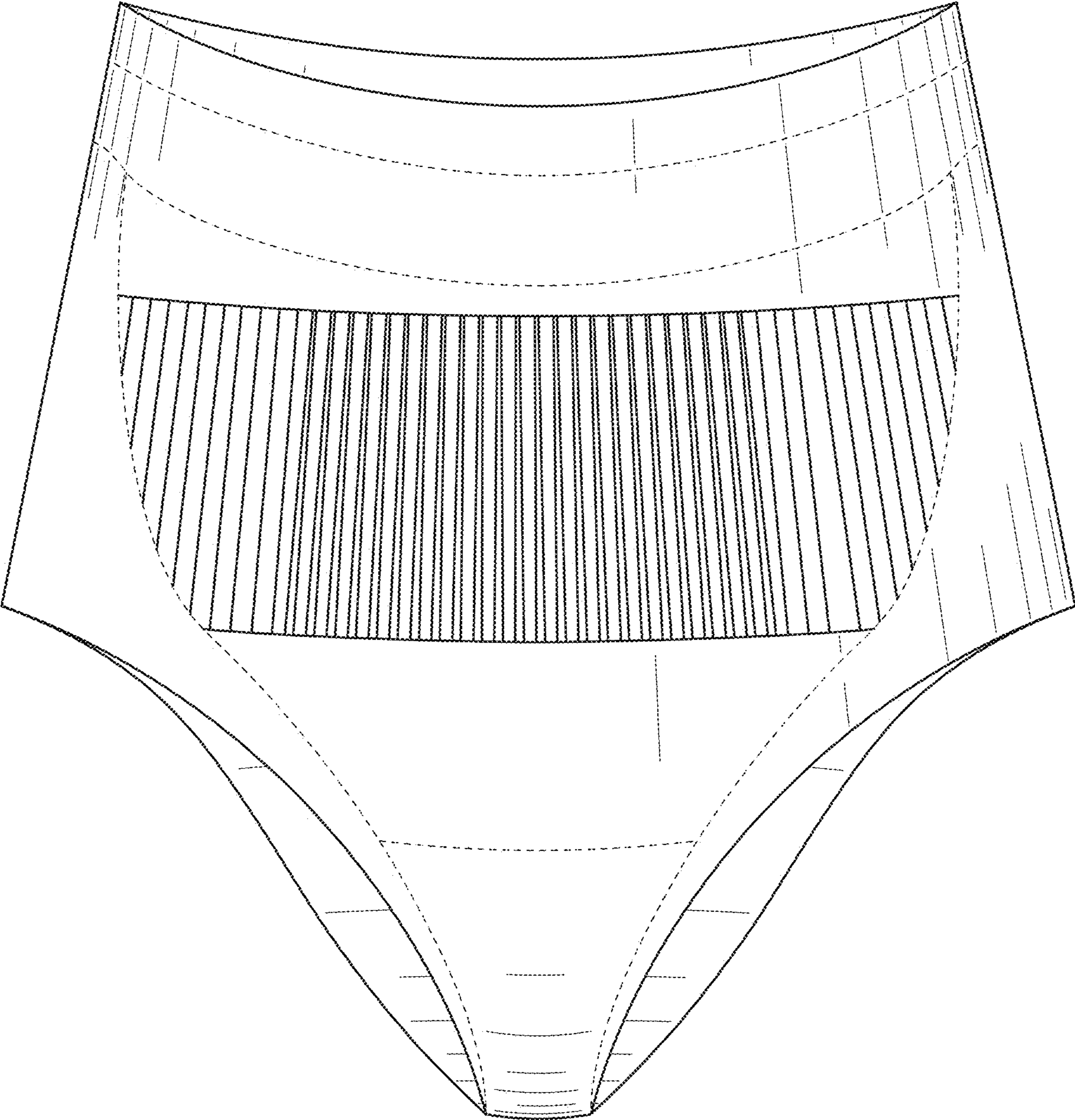

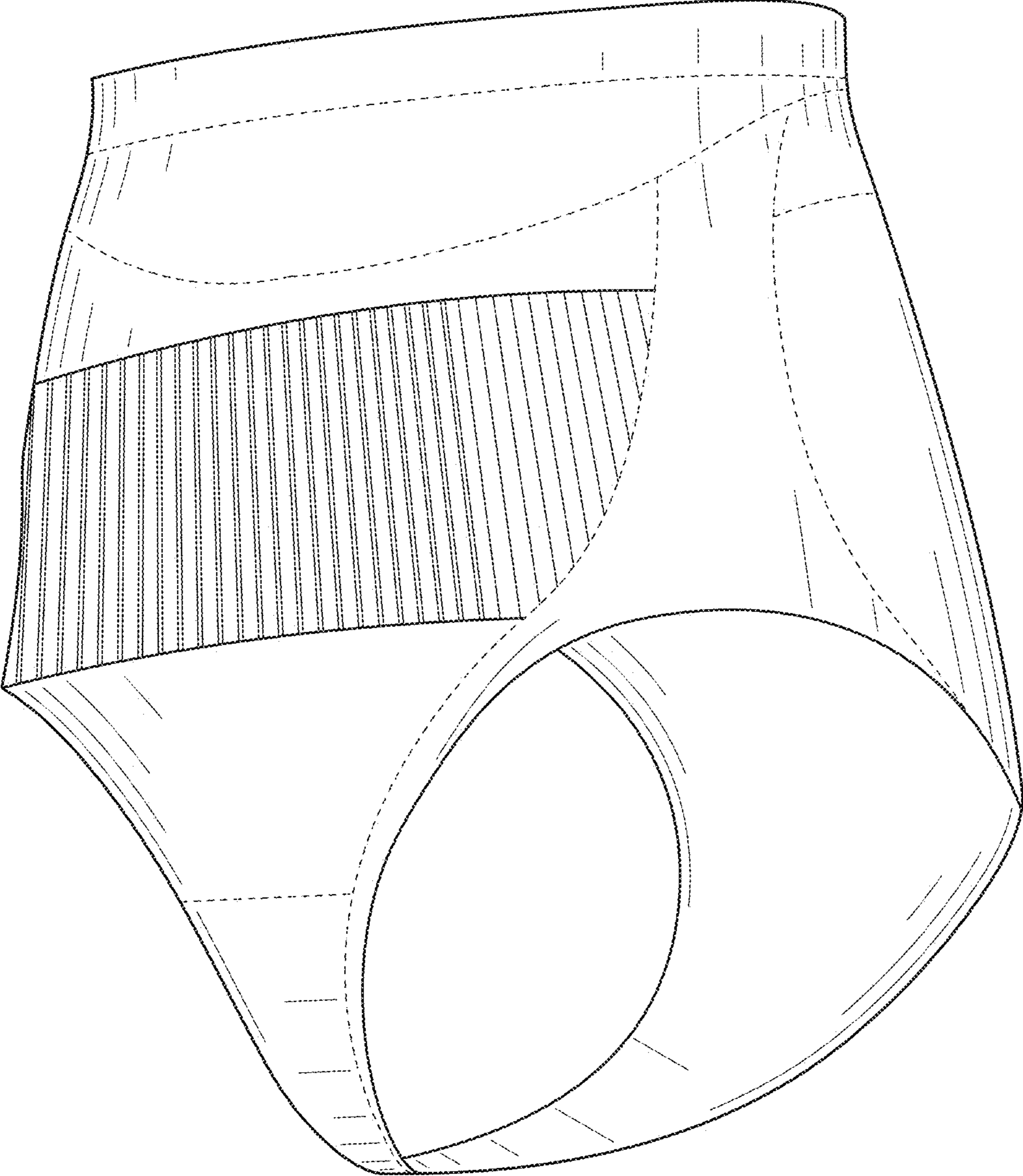

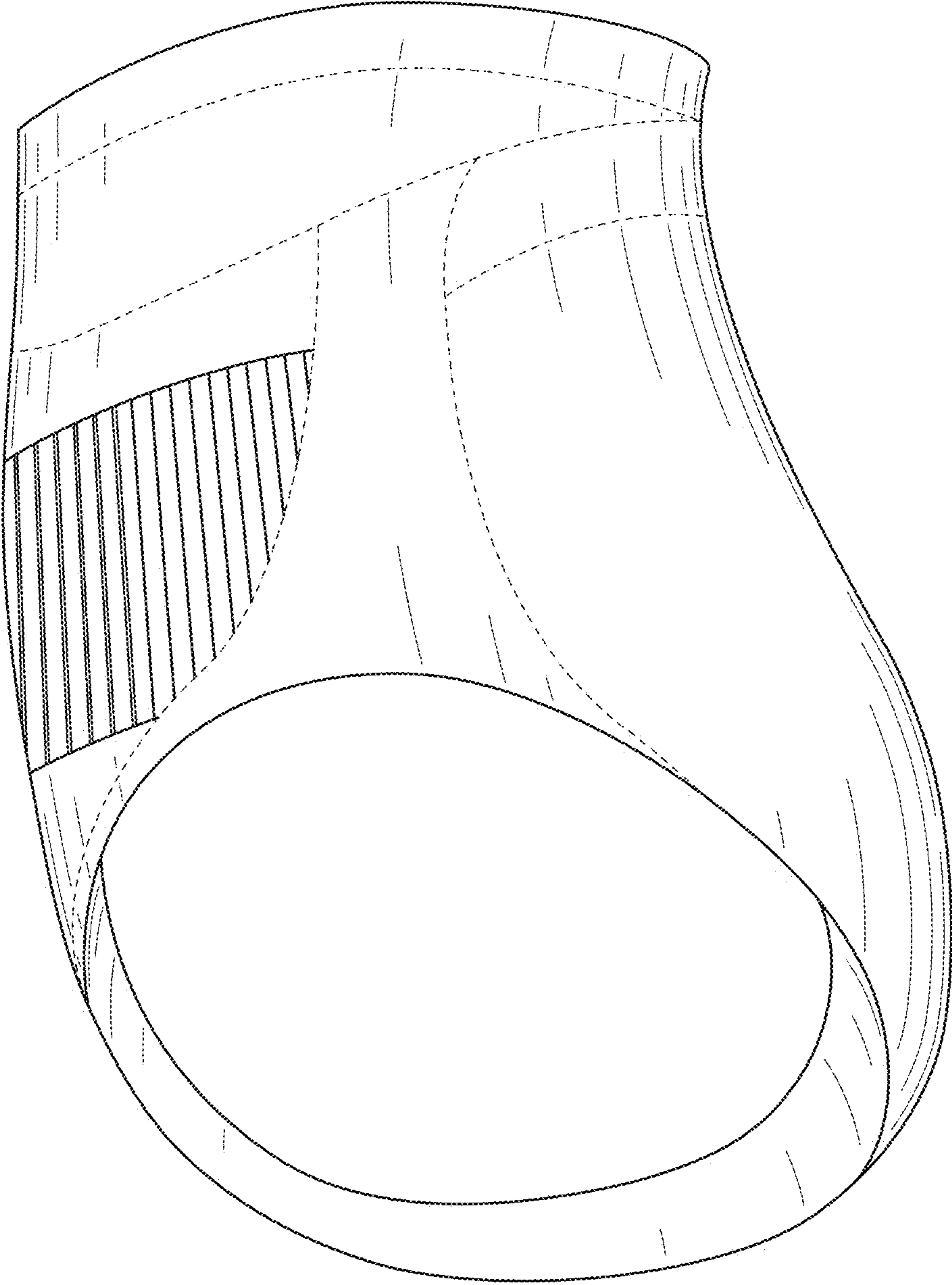

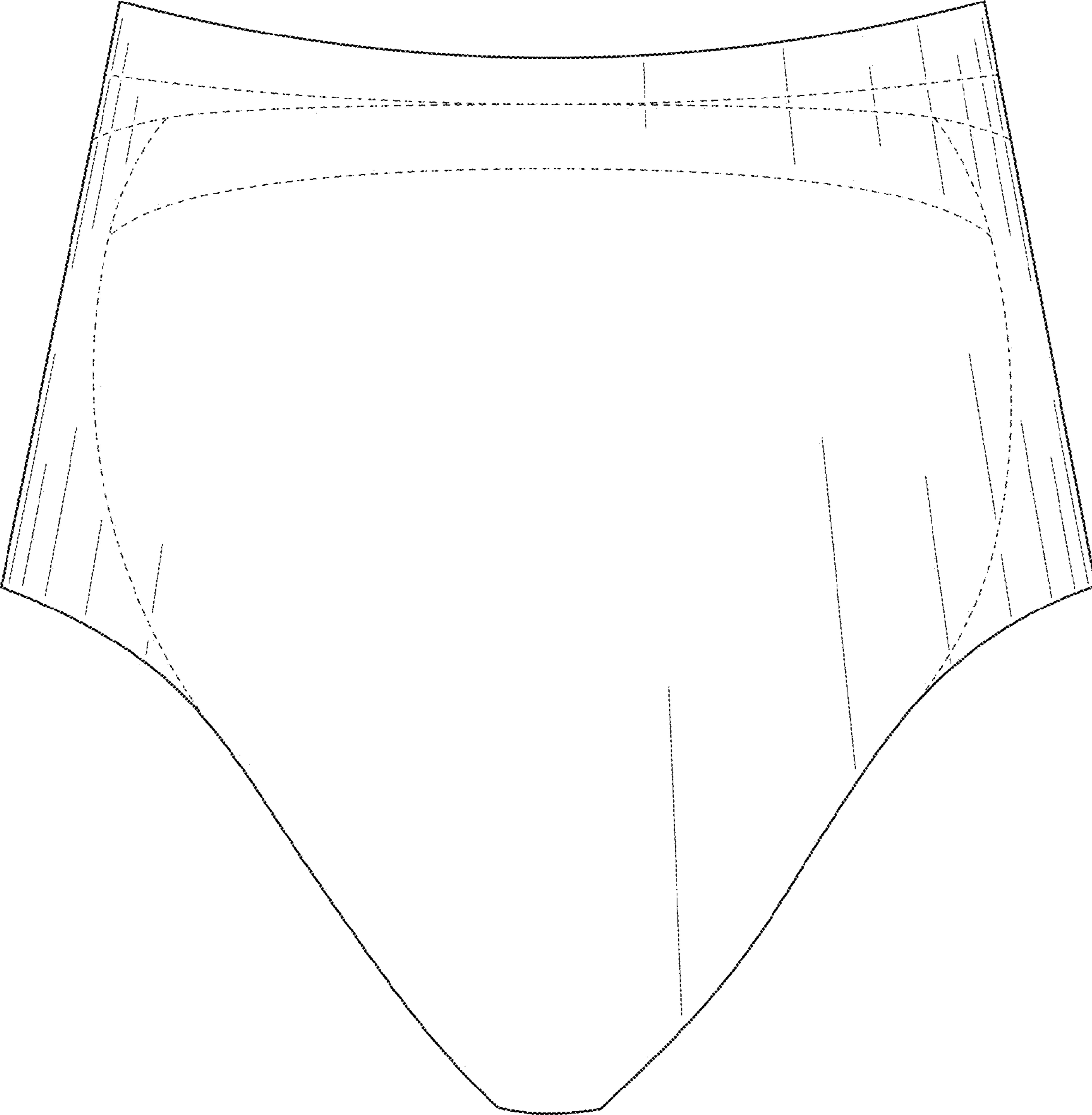

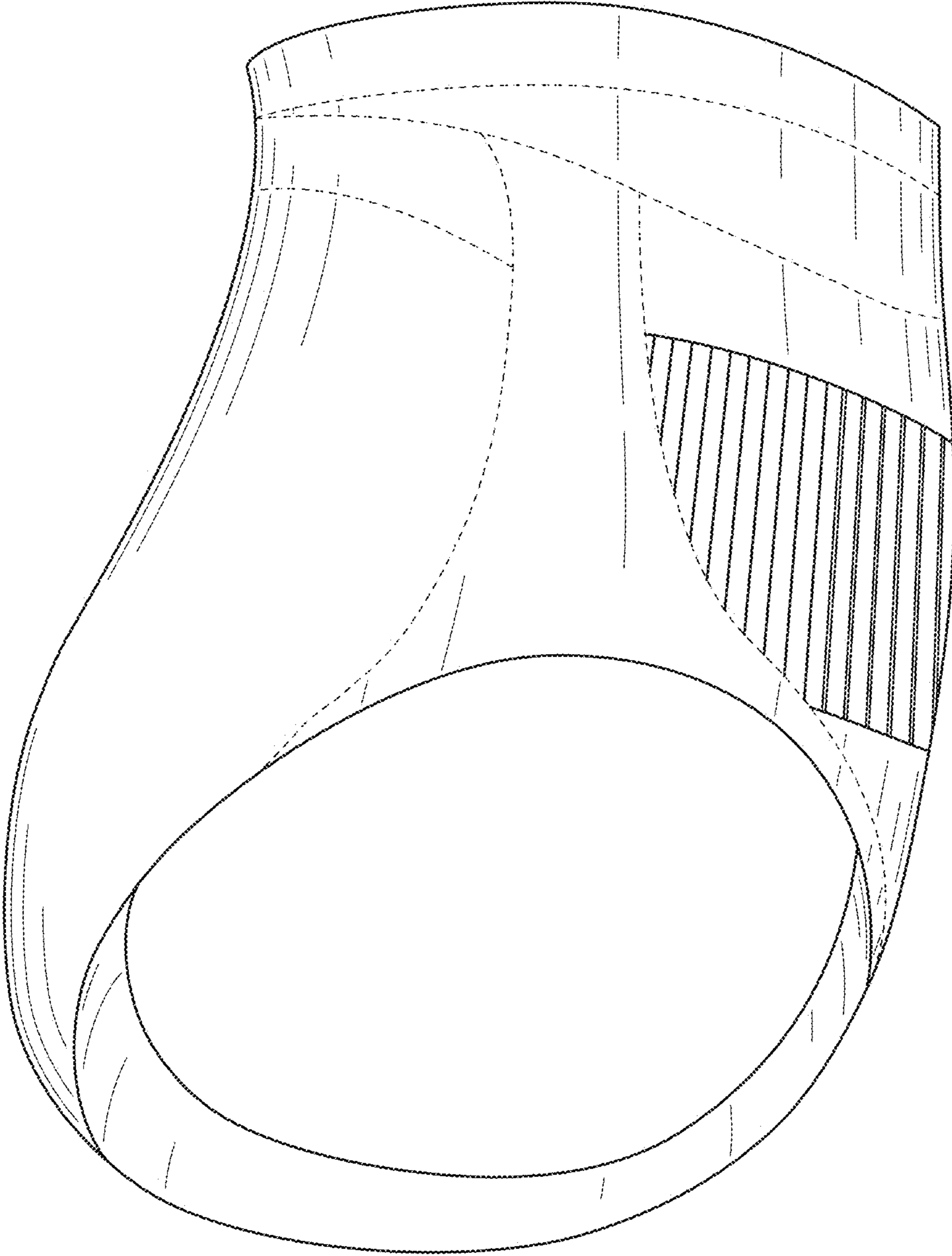

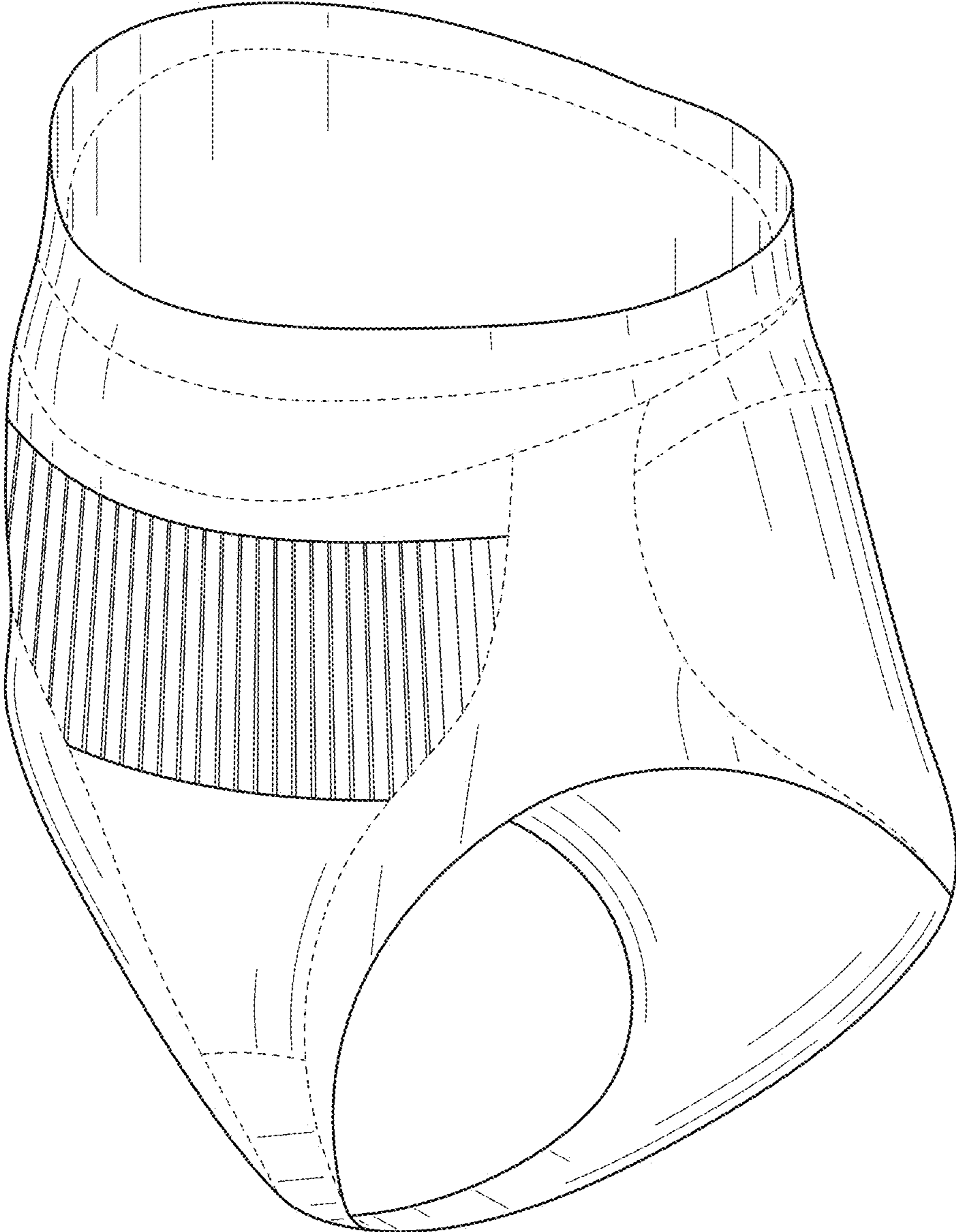
