DESCRIPTION

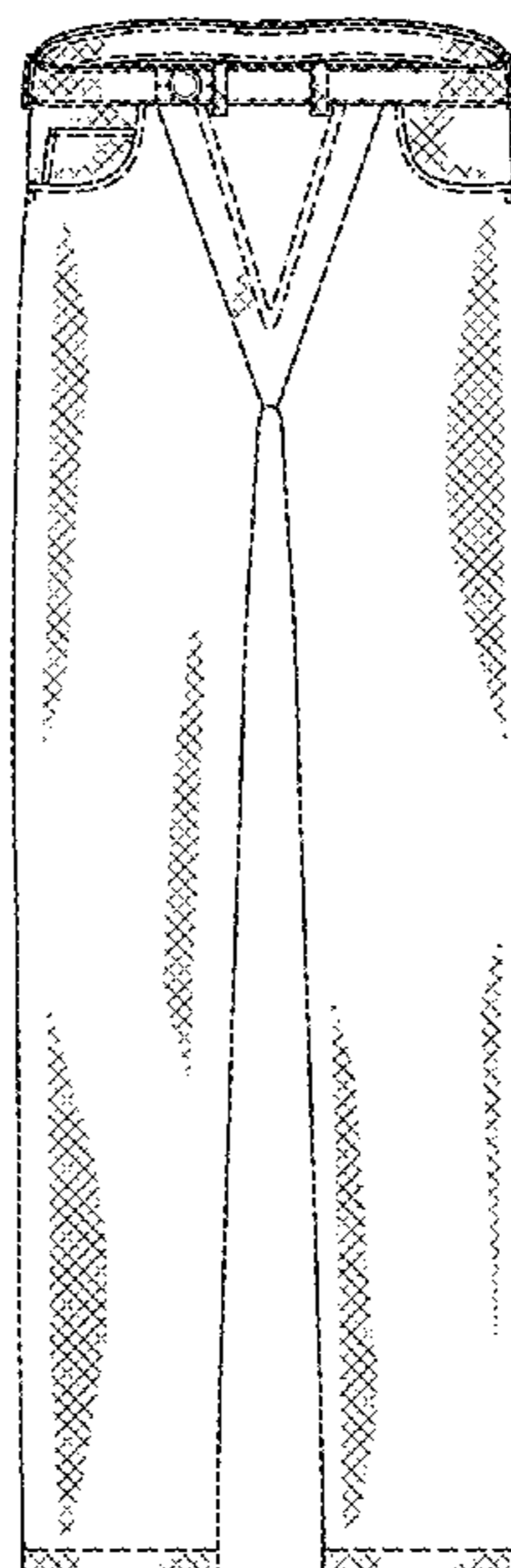
FIG. 1 is a front view of a pants garment showing my new design;

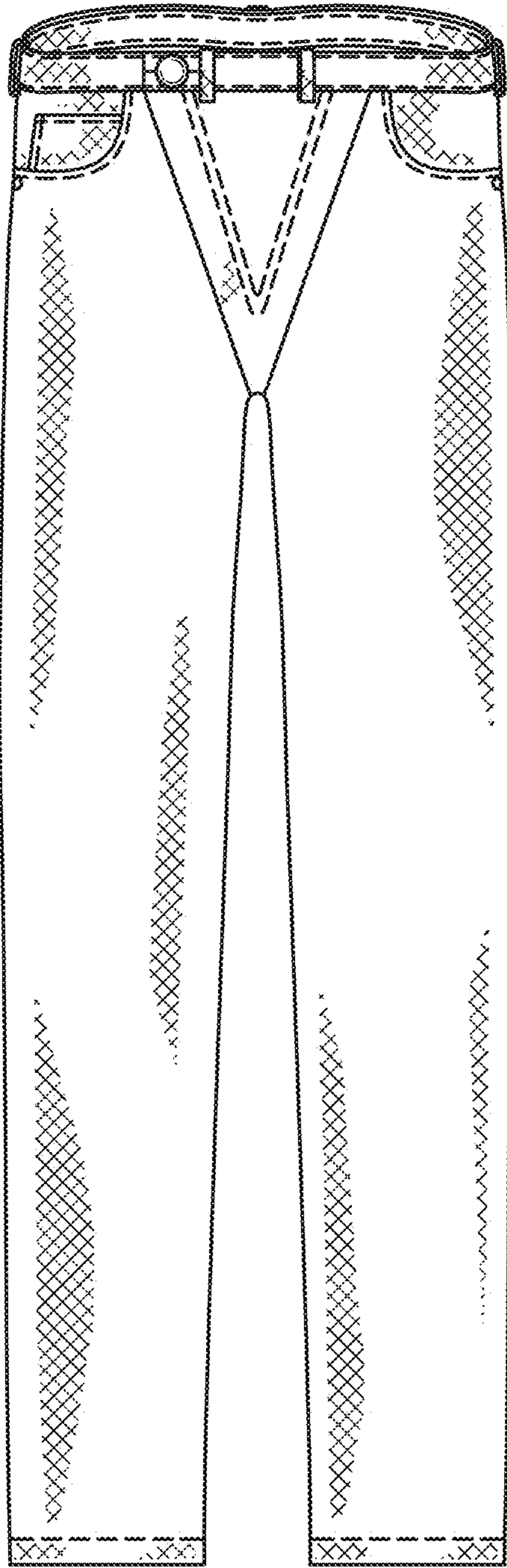

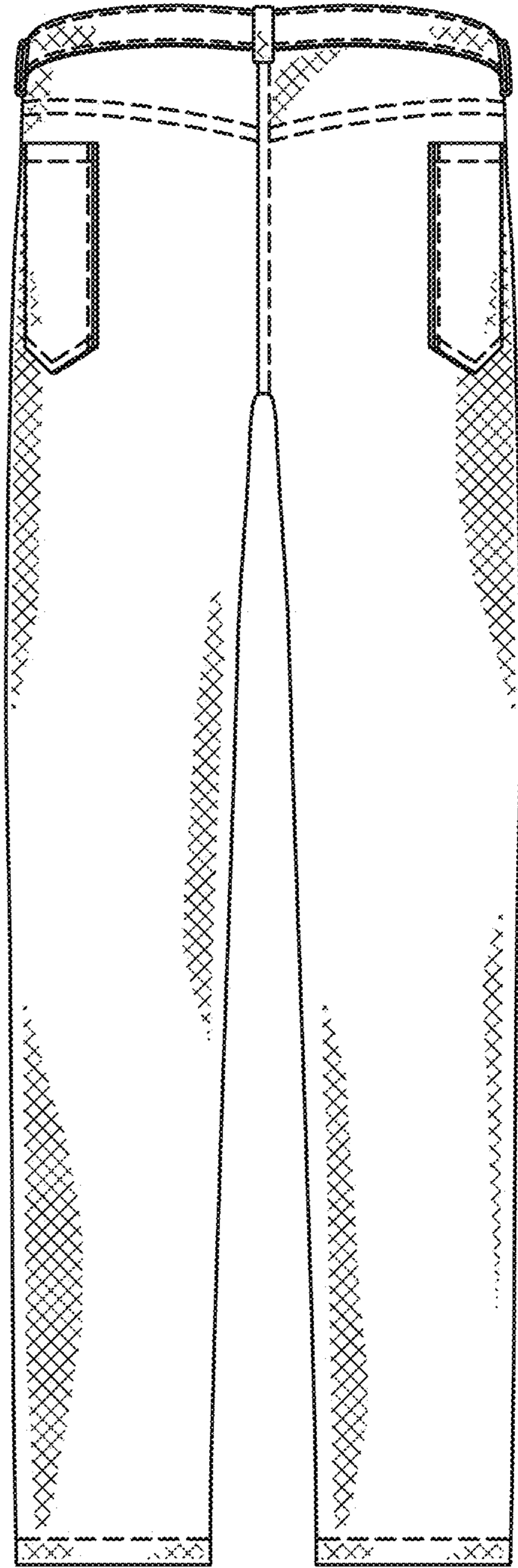

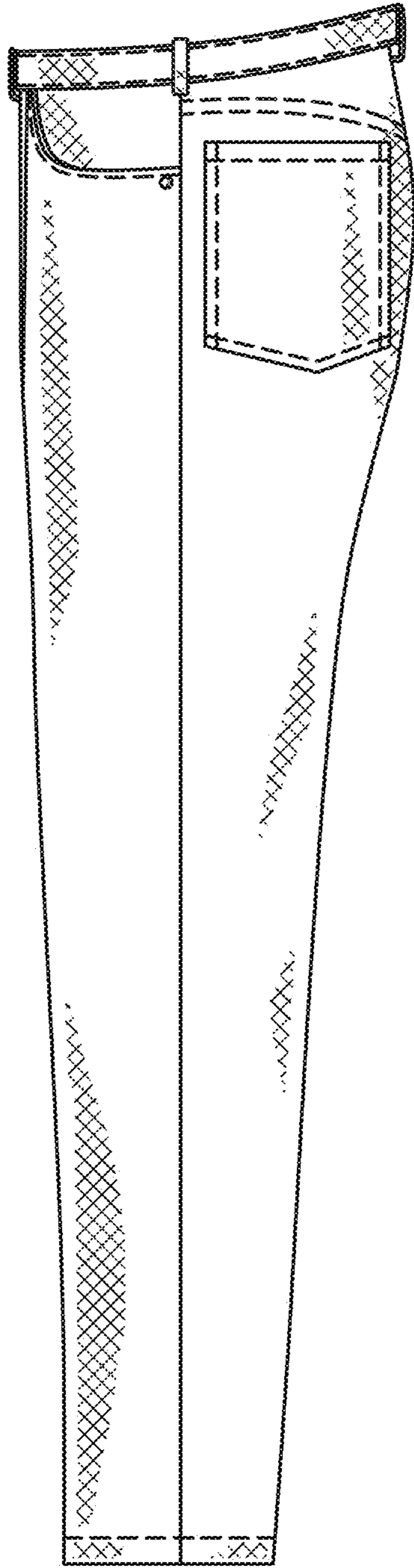

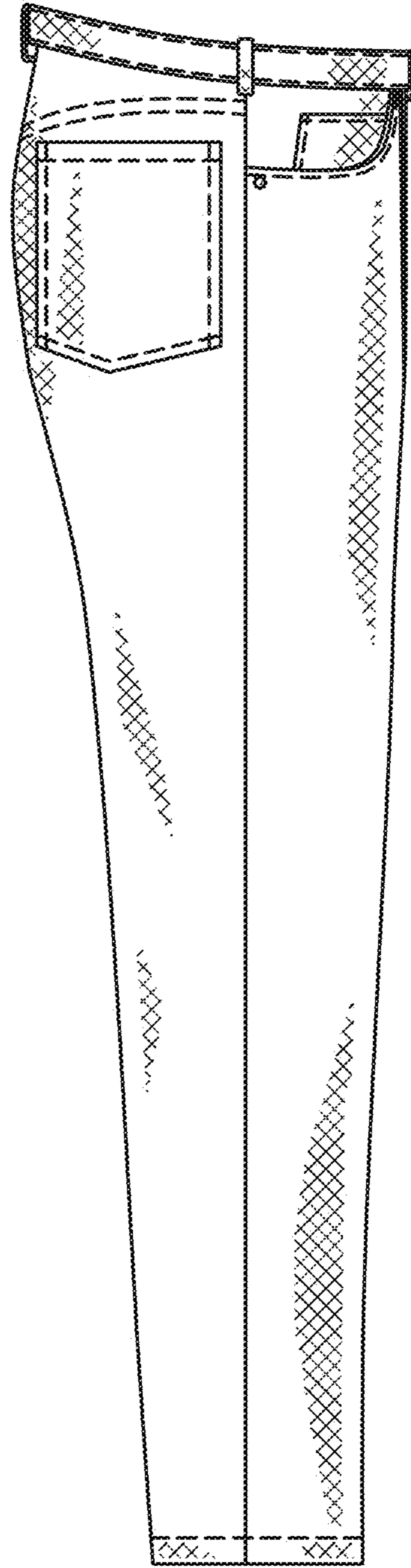

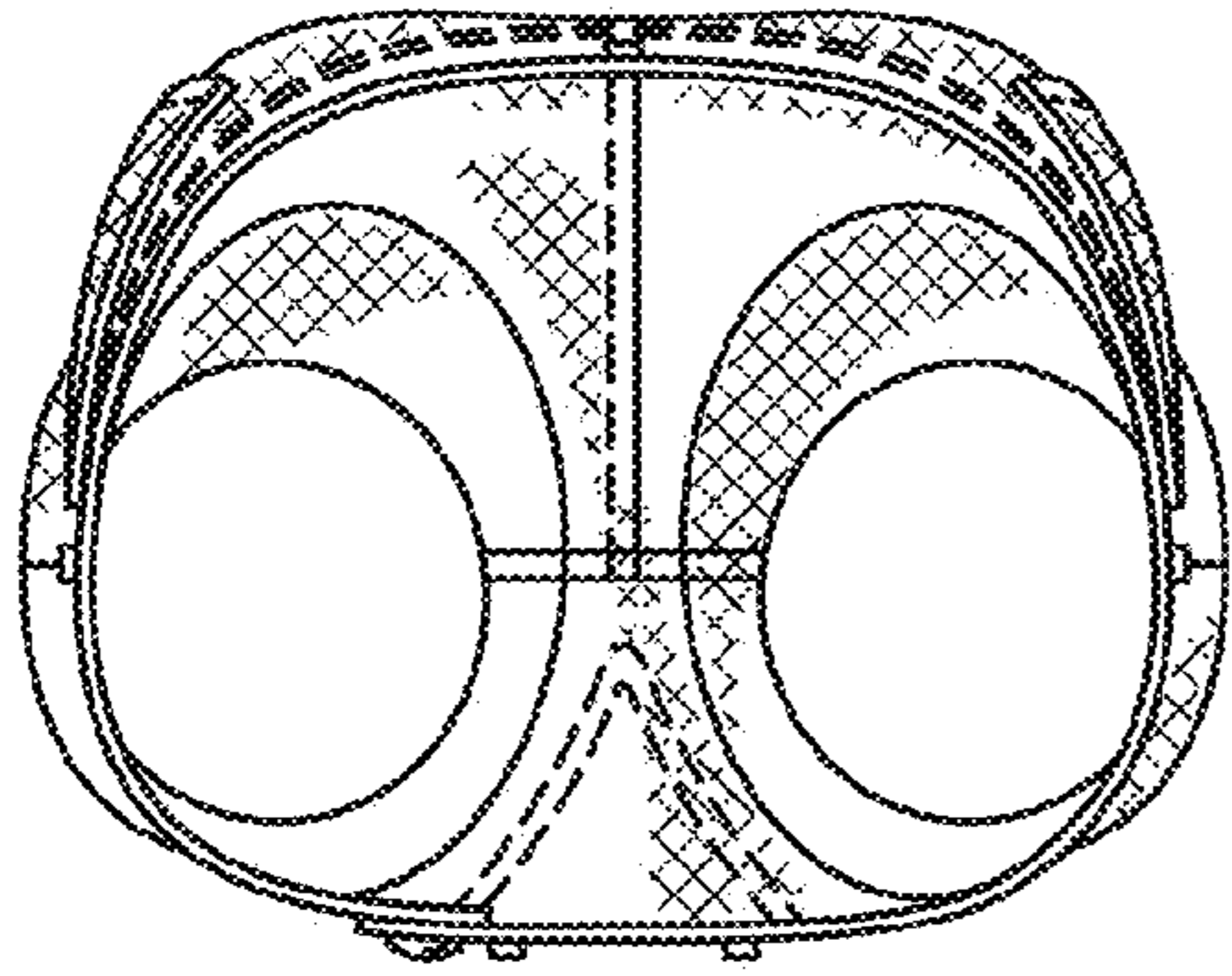

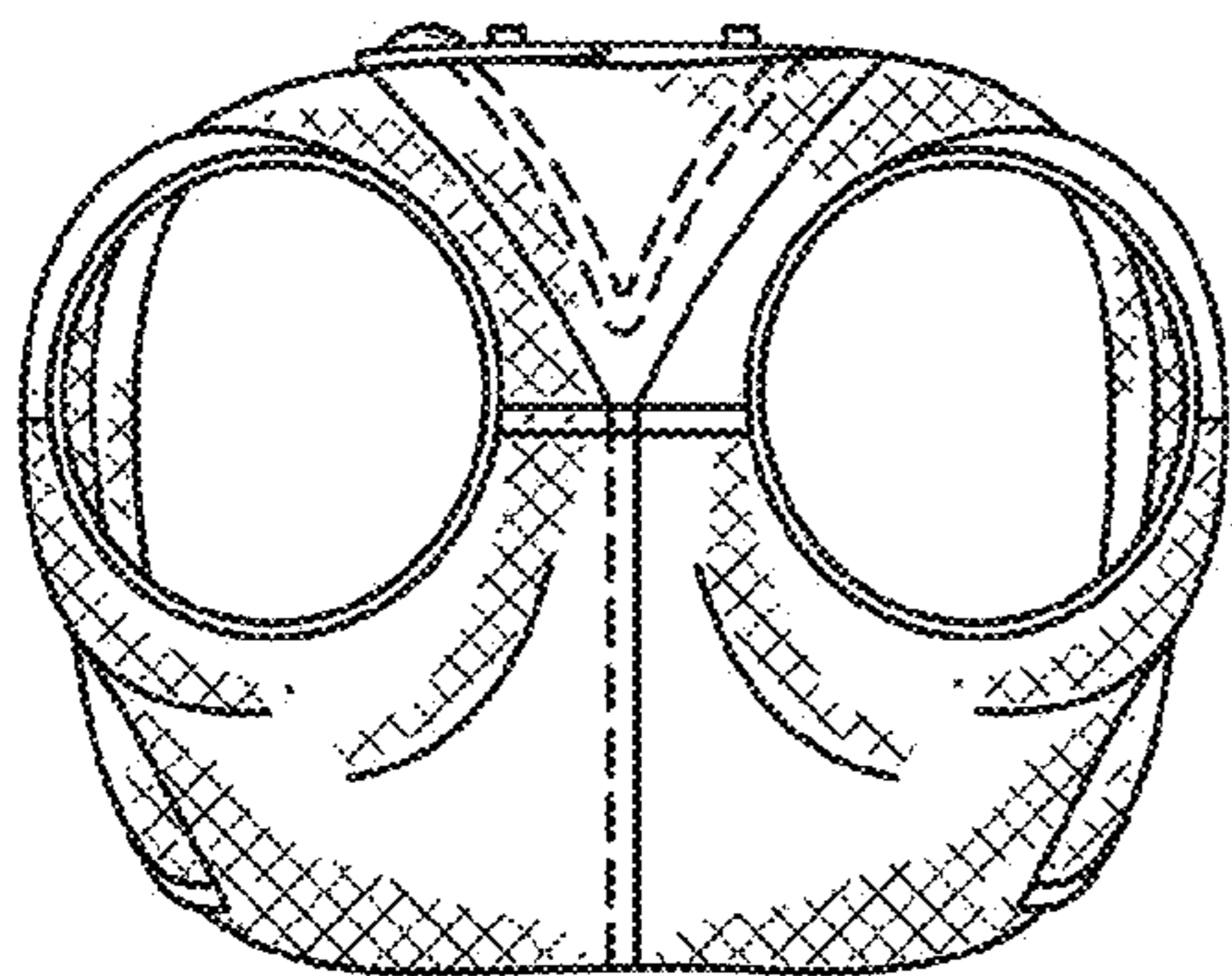
