(57) **CLAIM**

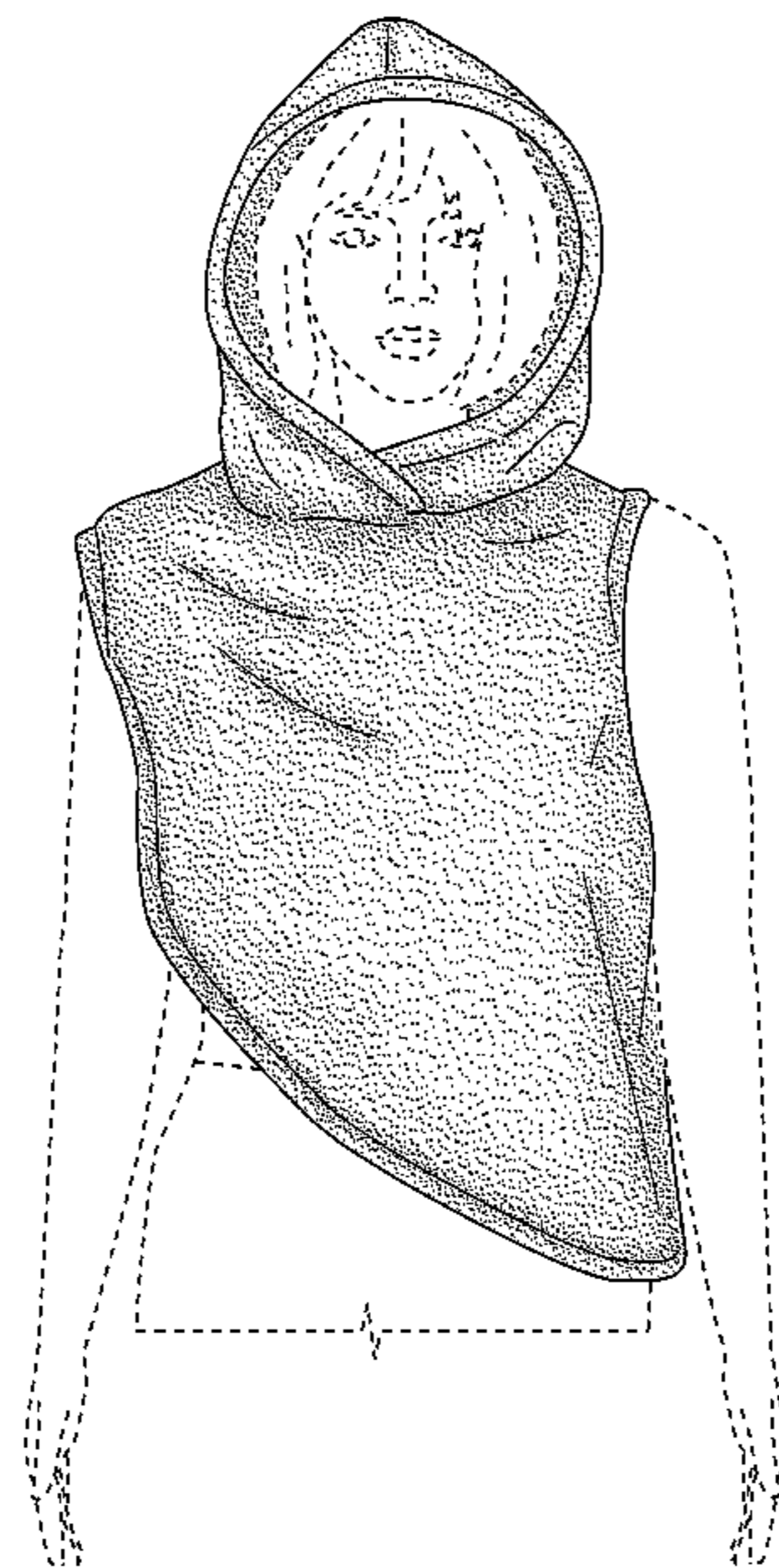
The ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 shows a front perspective view of a hooded garment worn over a wearer's left shoulder;

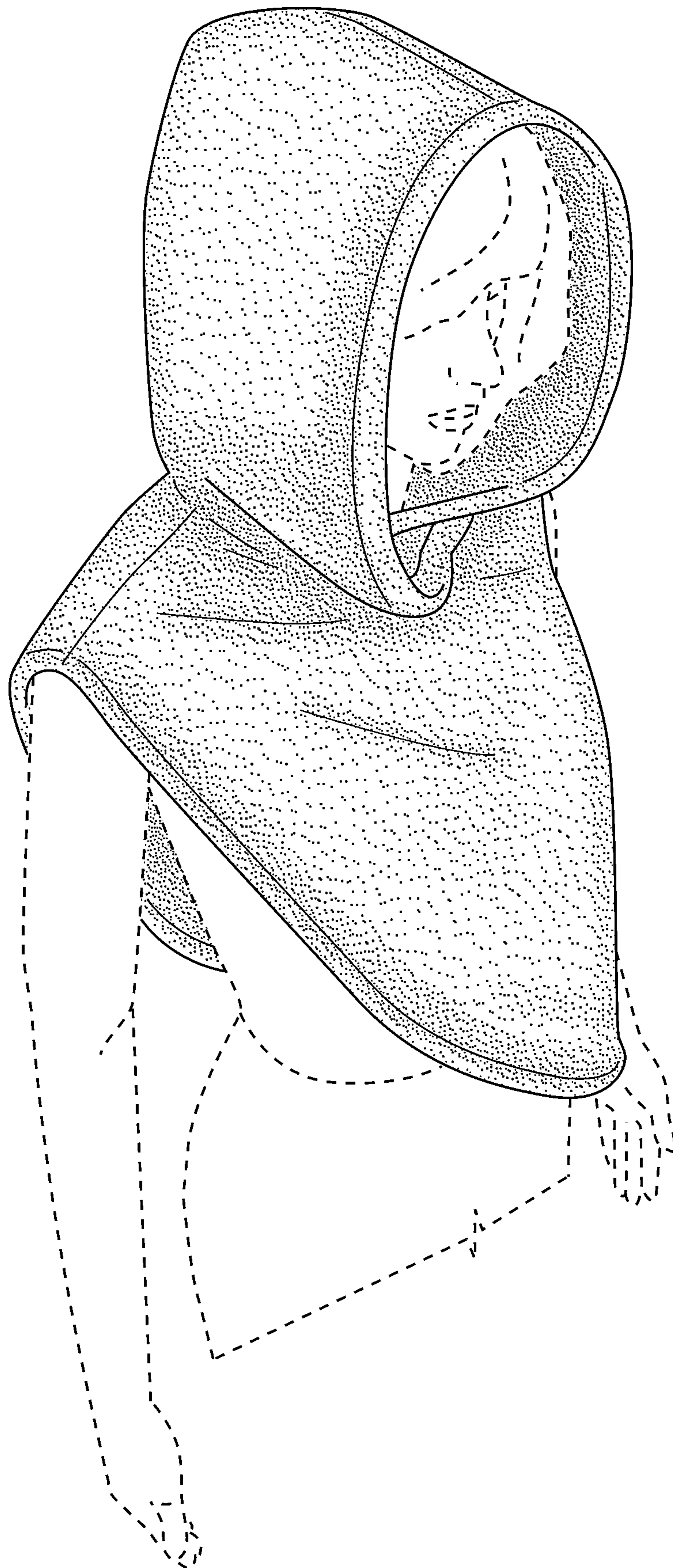

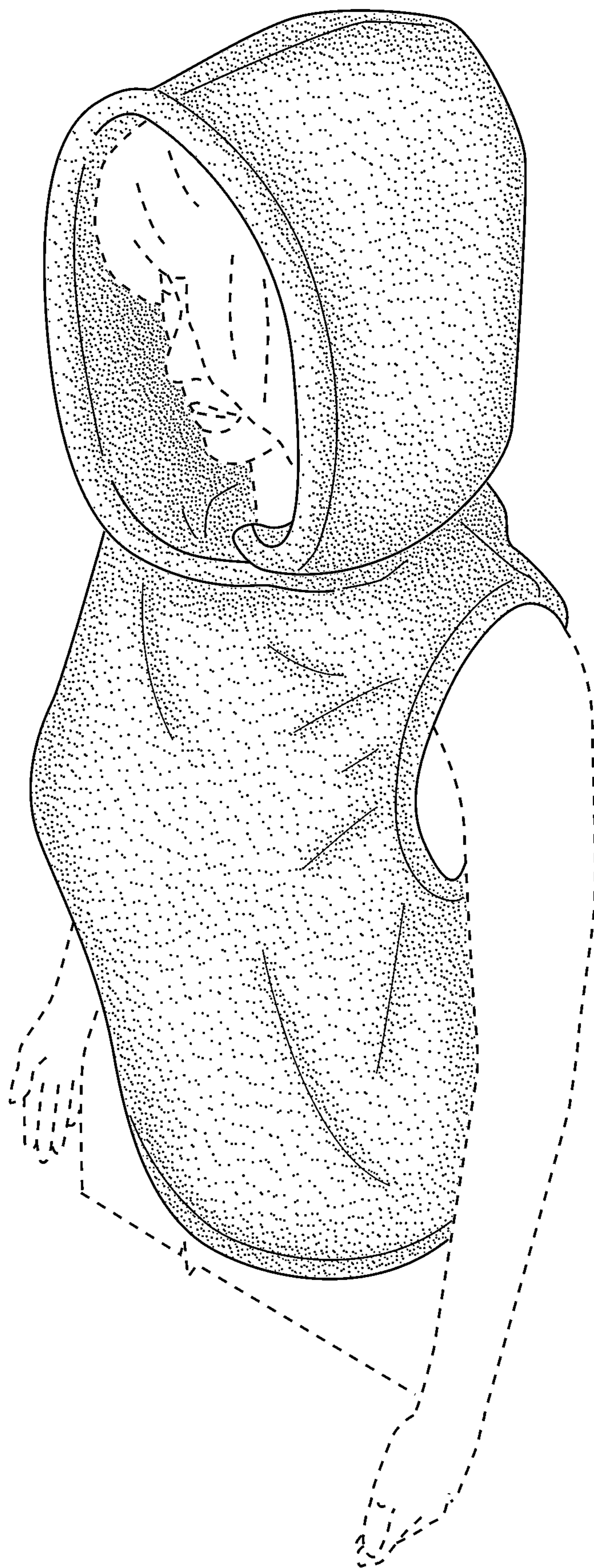

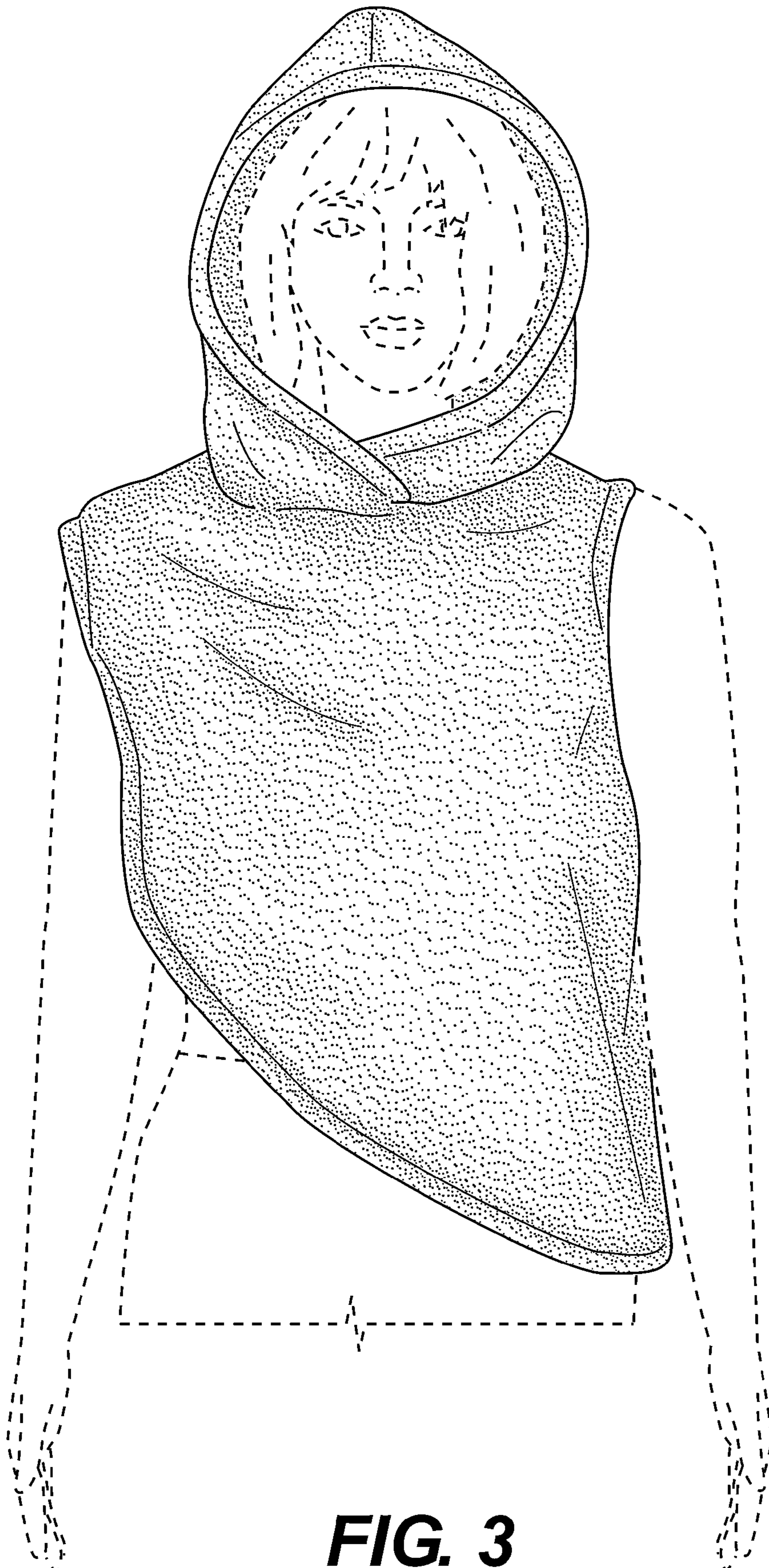

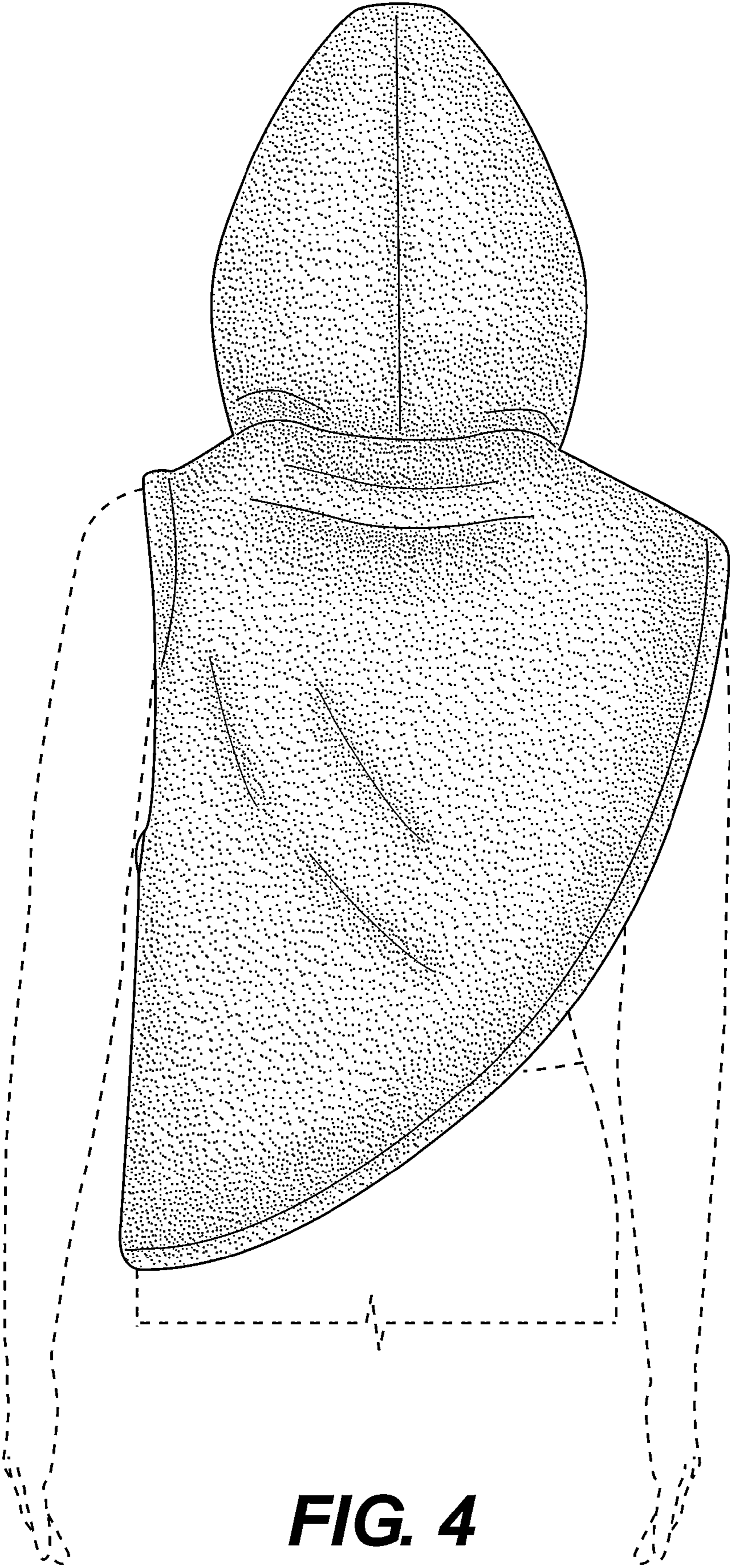

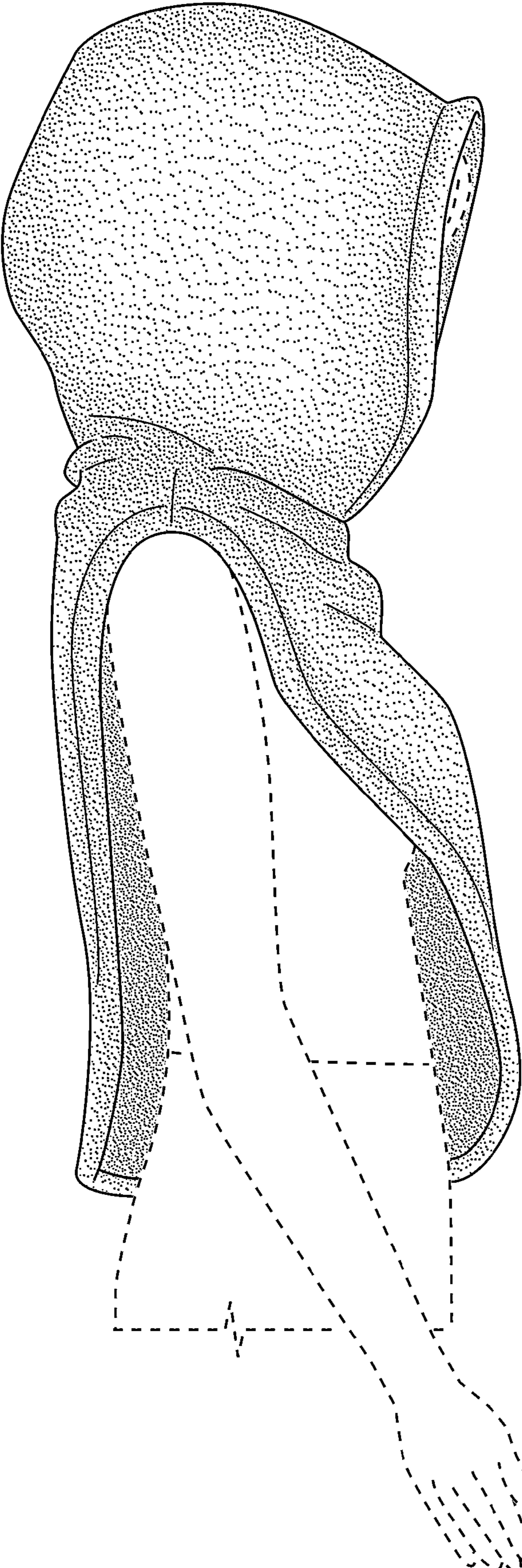

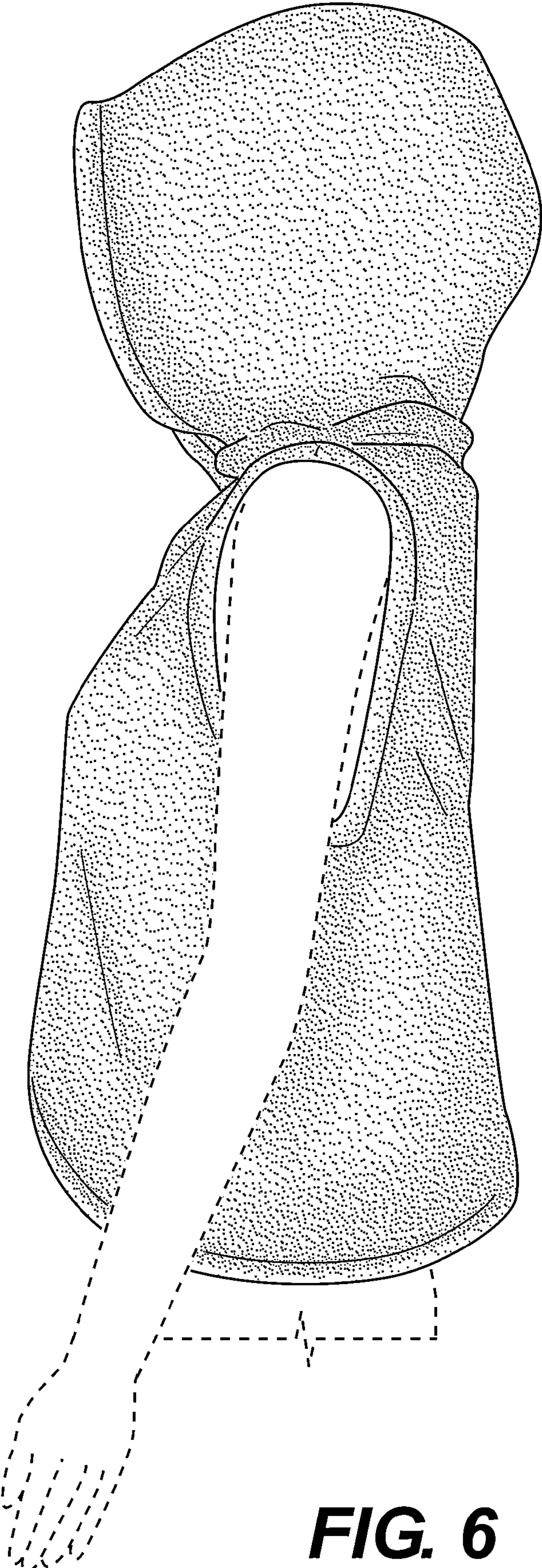

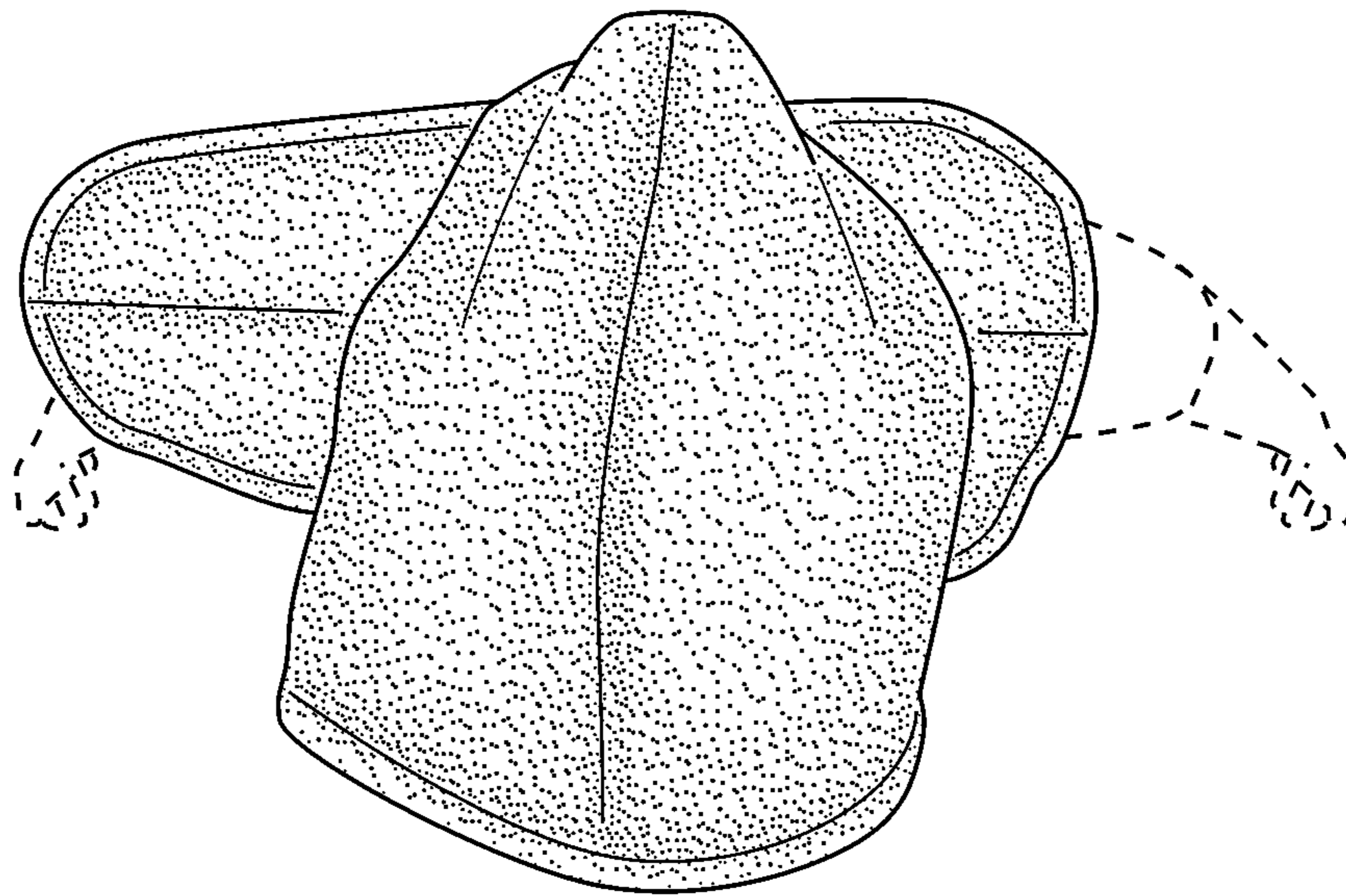

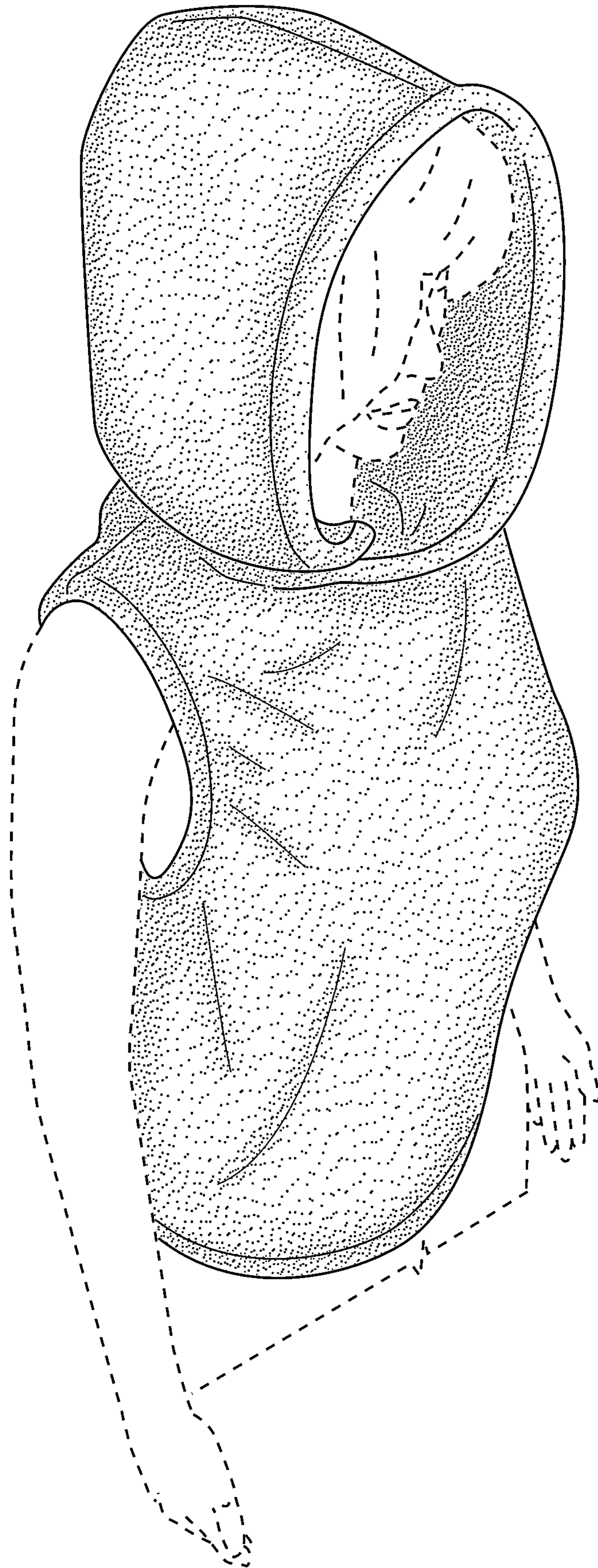

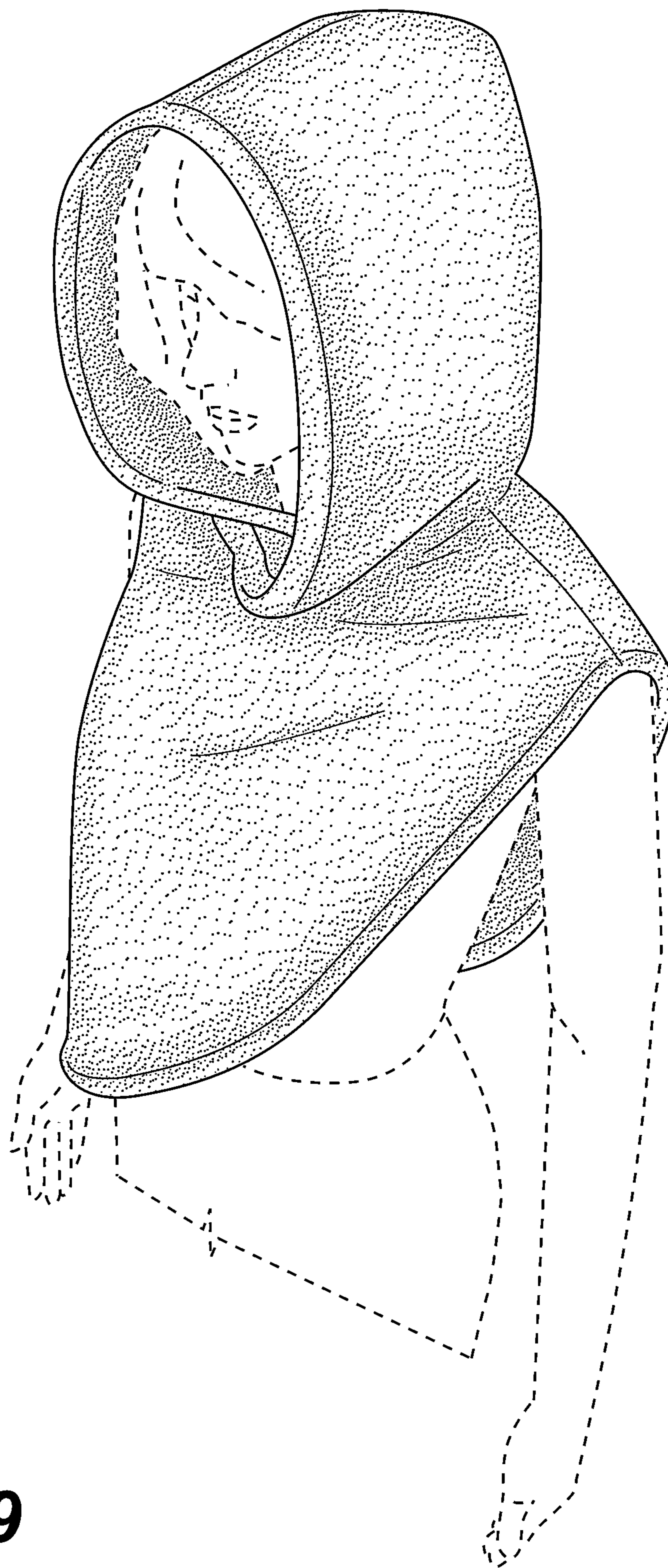

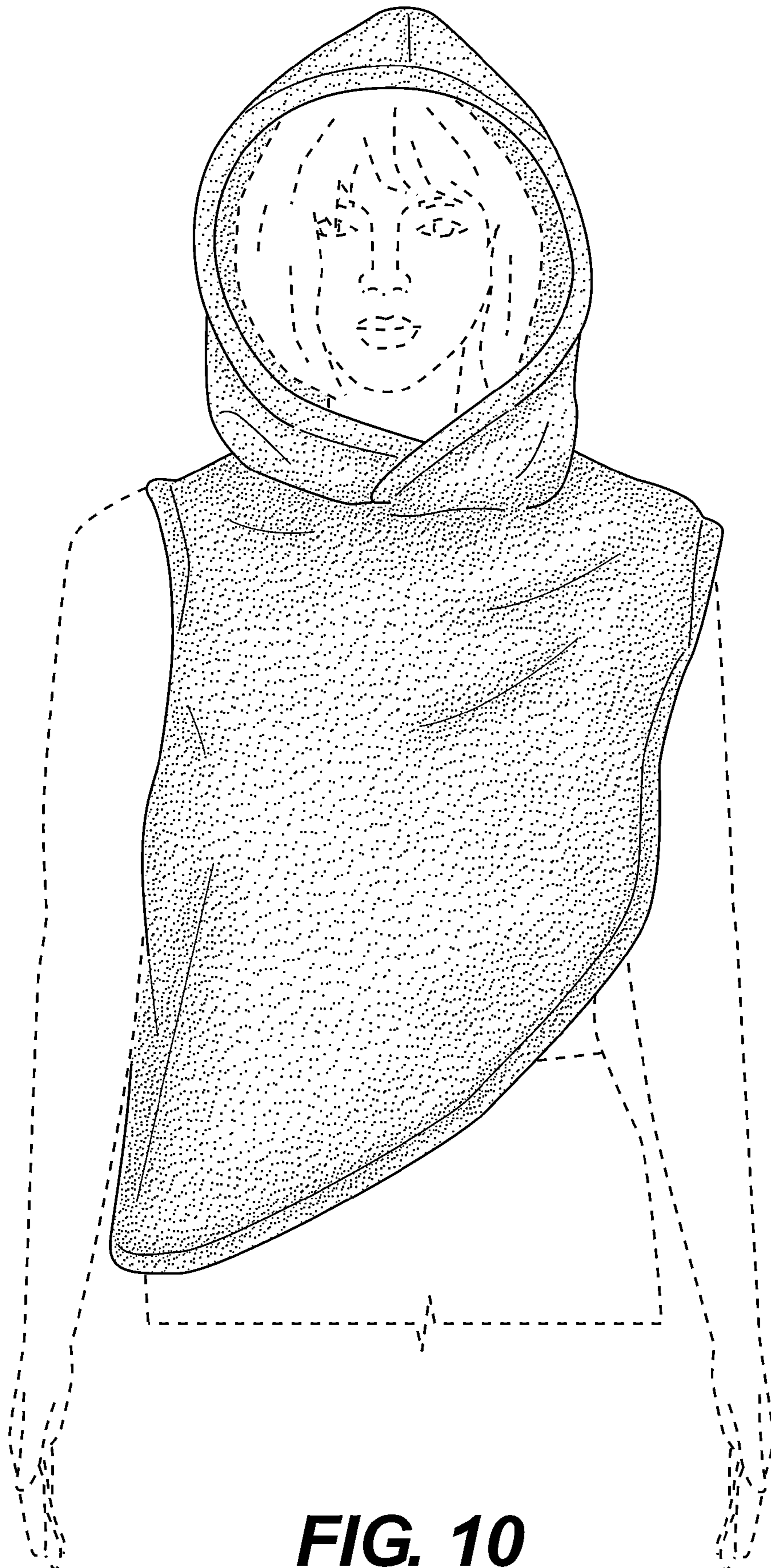

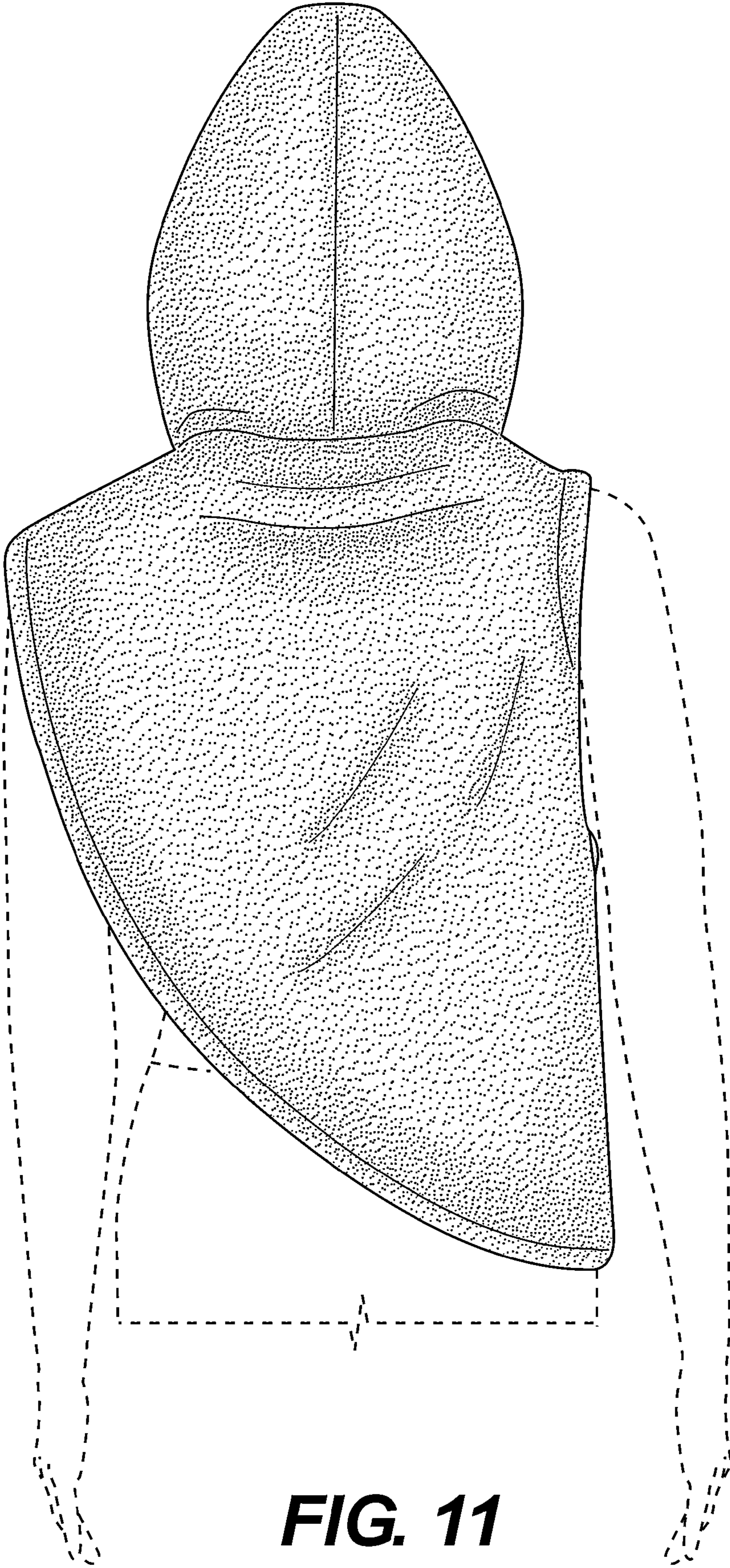

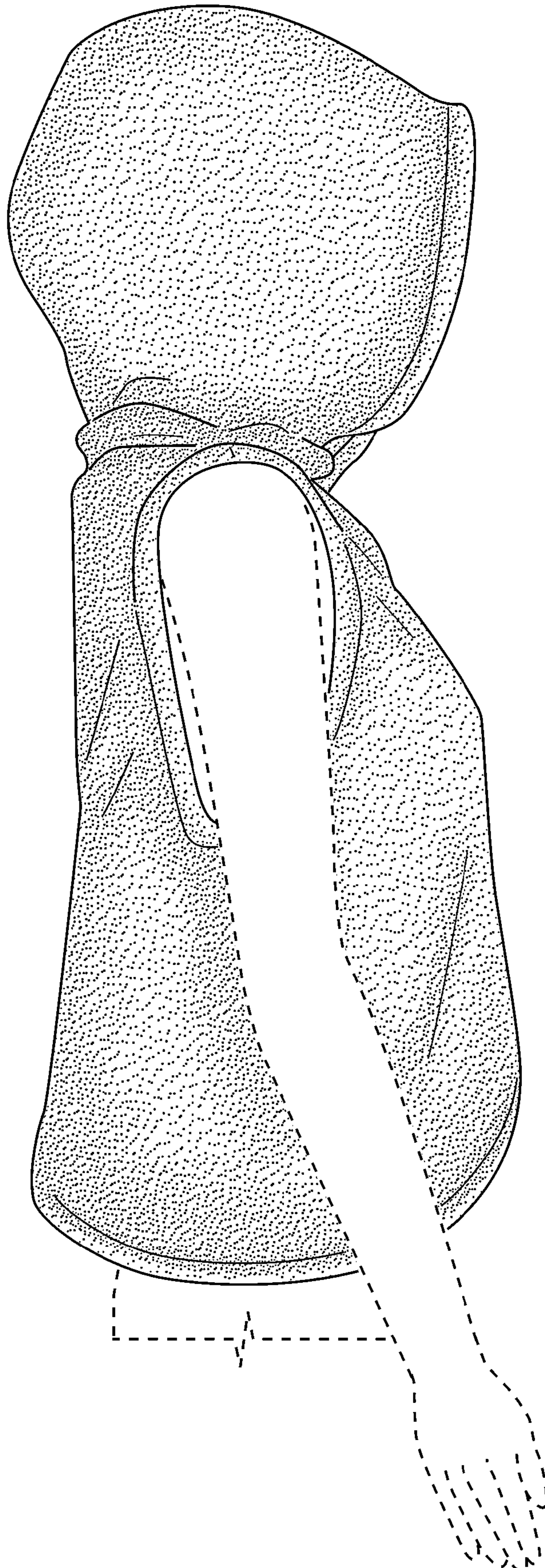

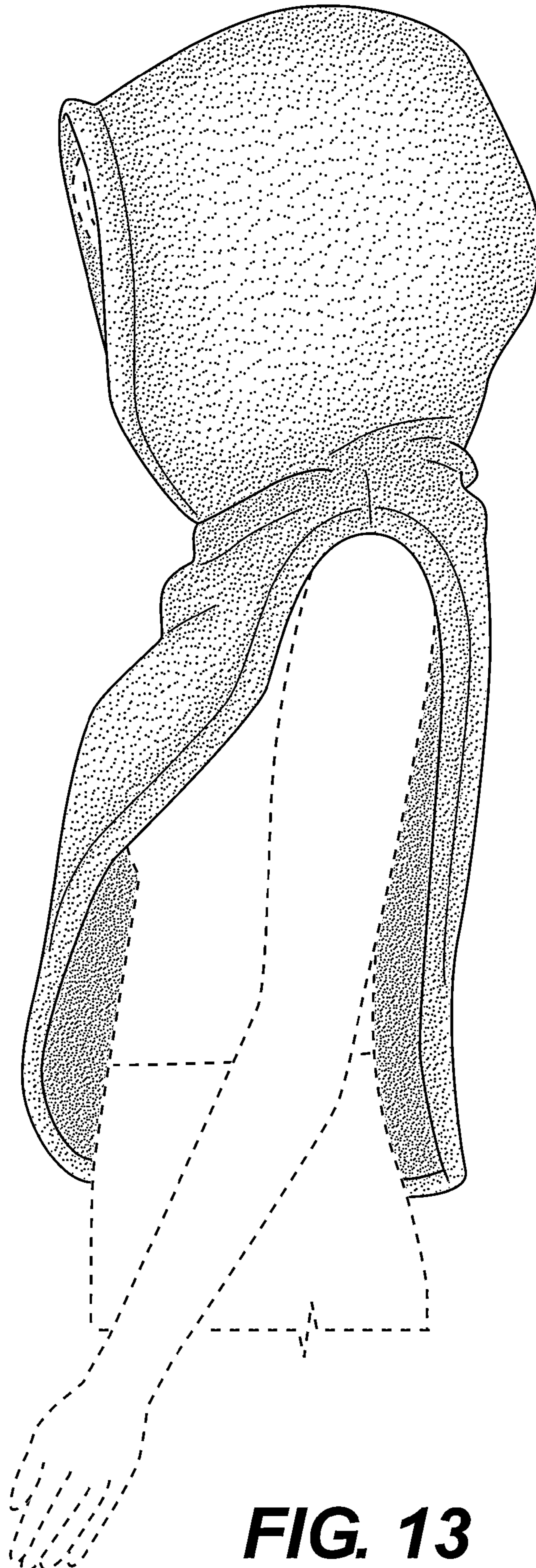

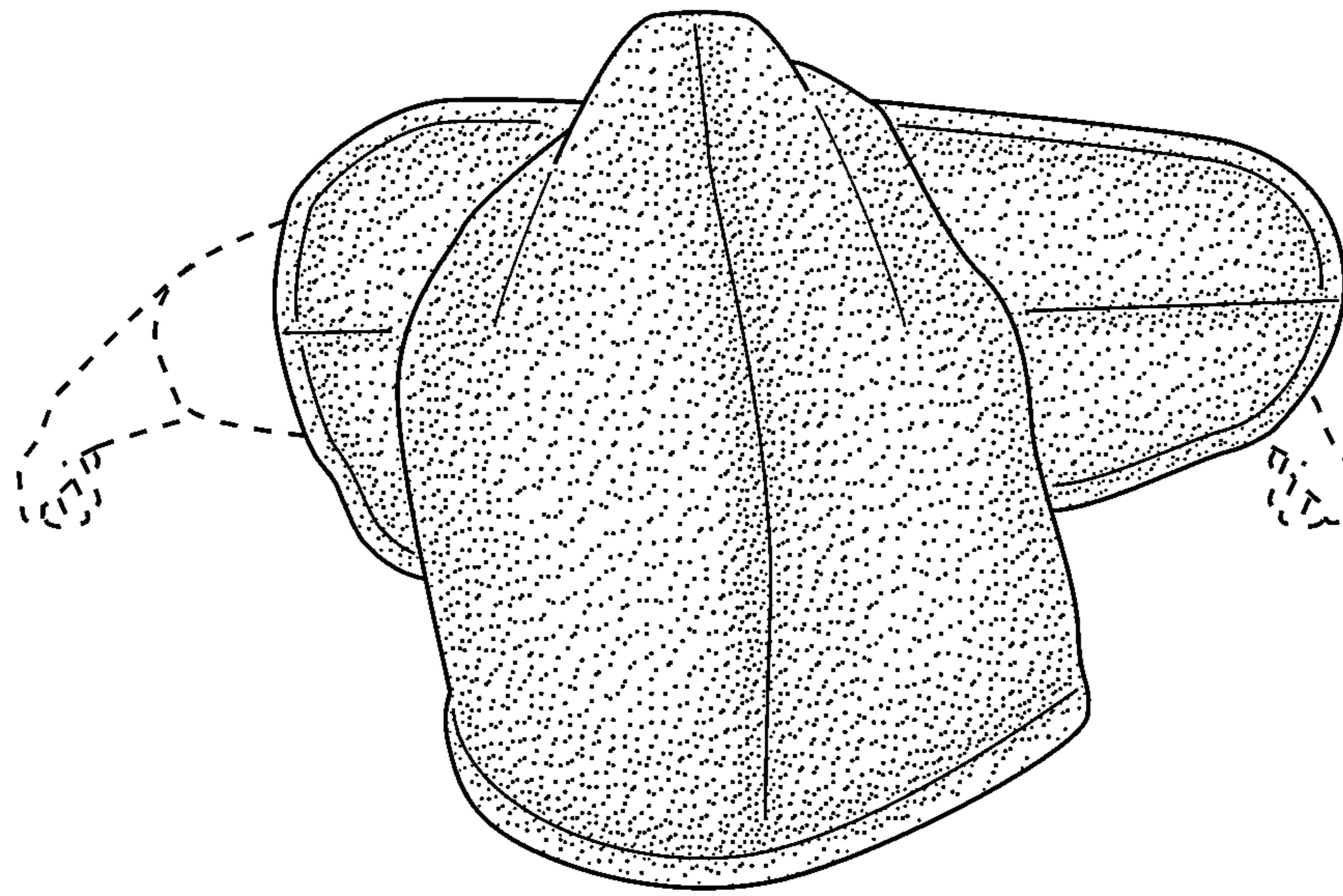
