DESCRIPTION

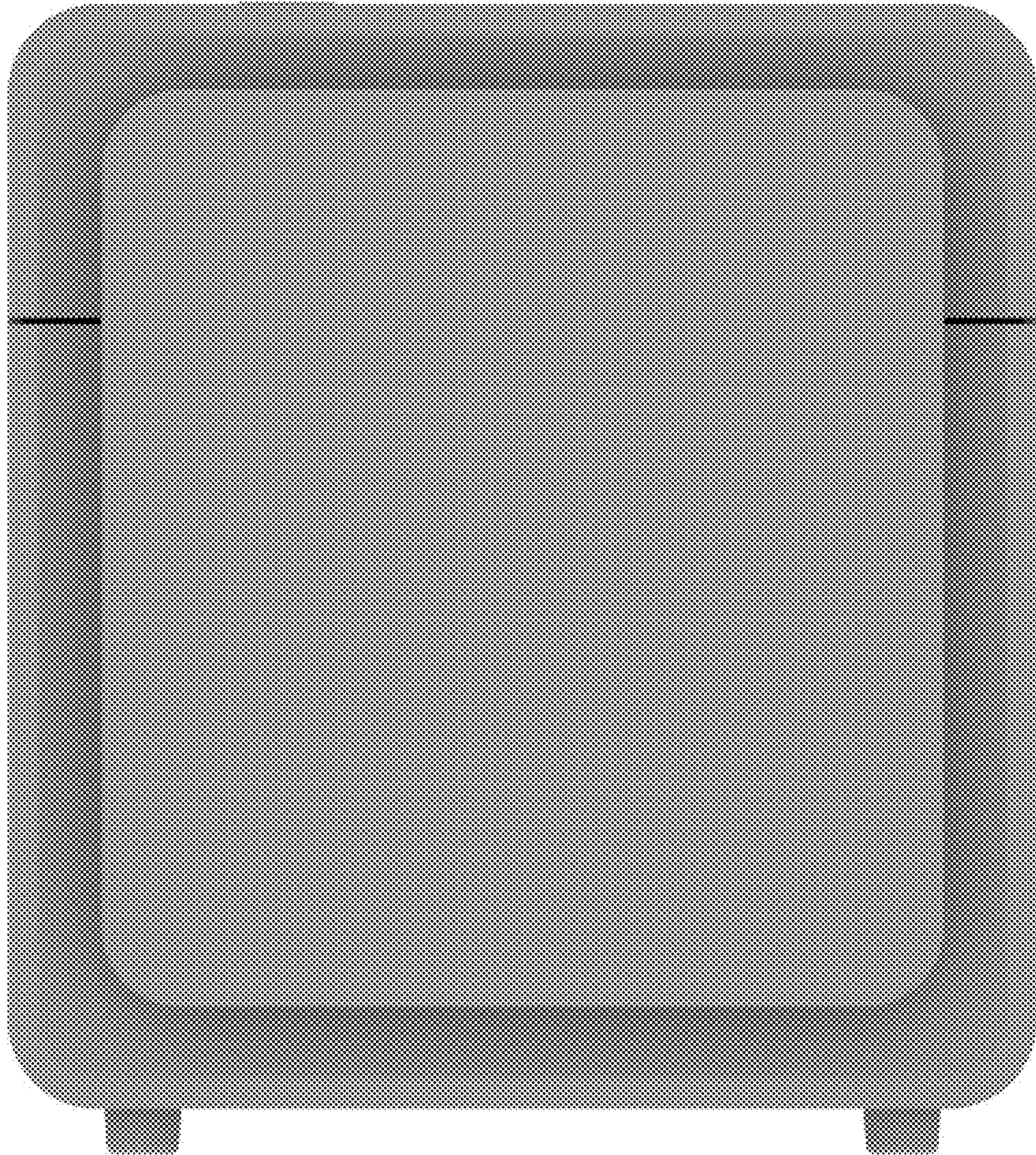

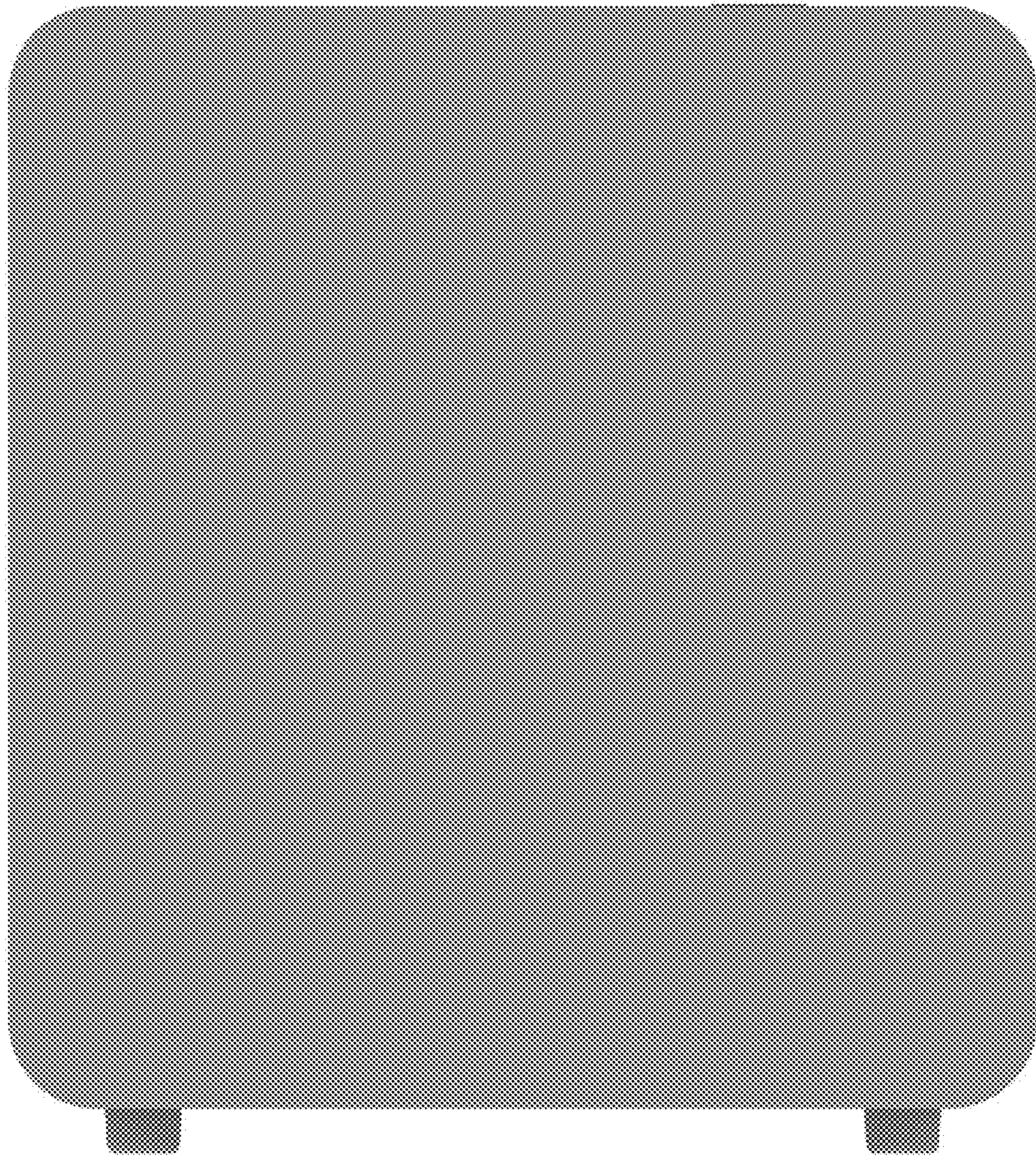

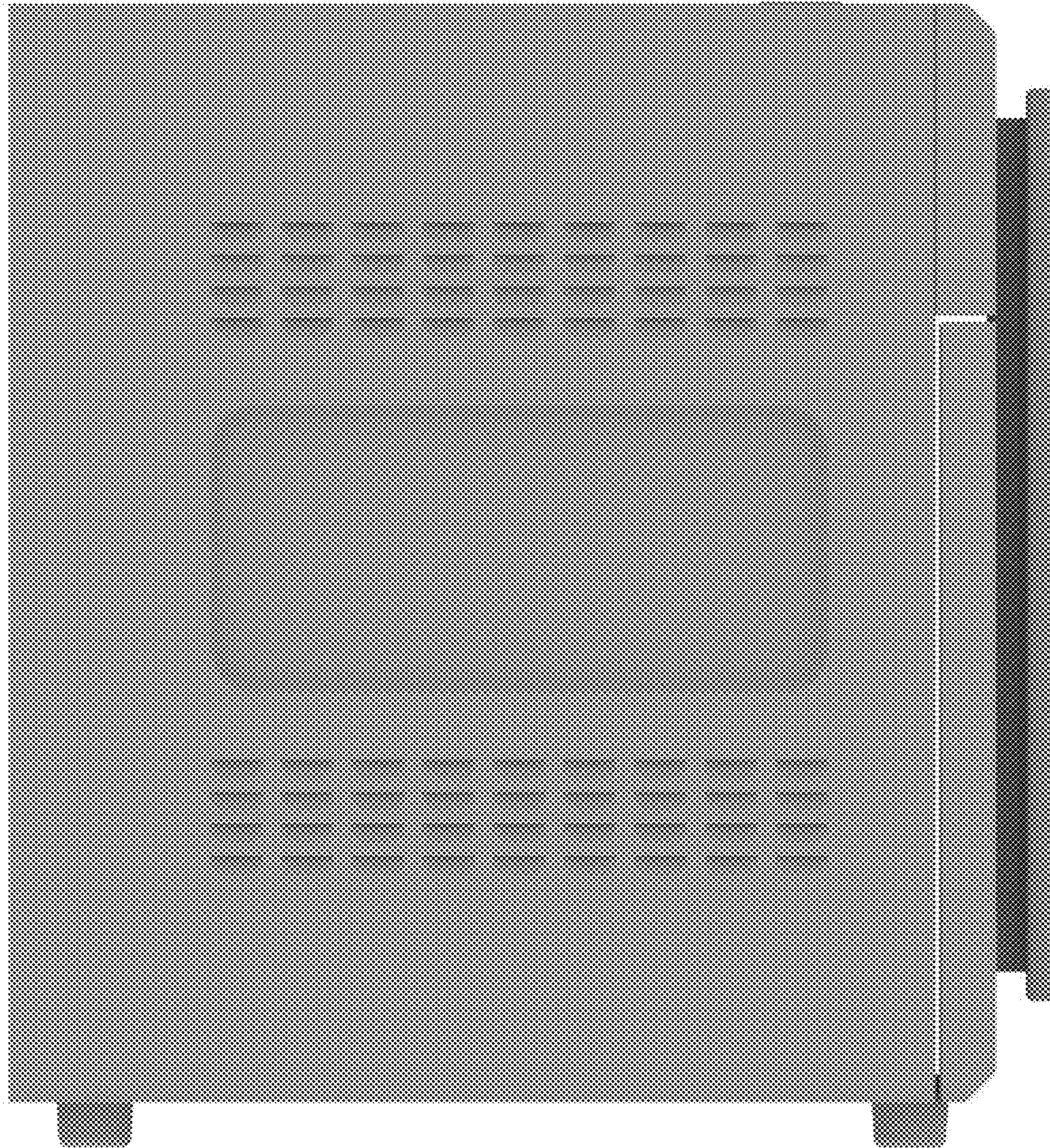

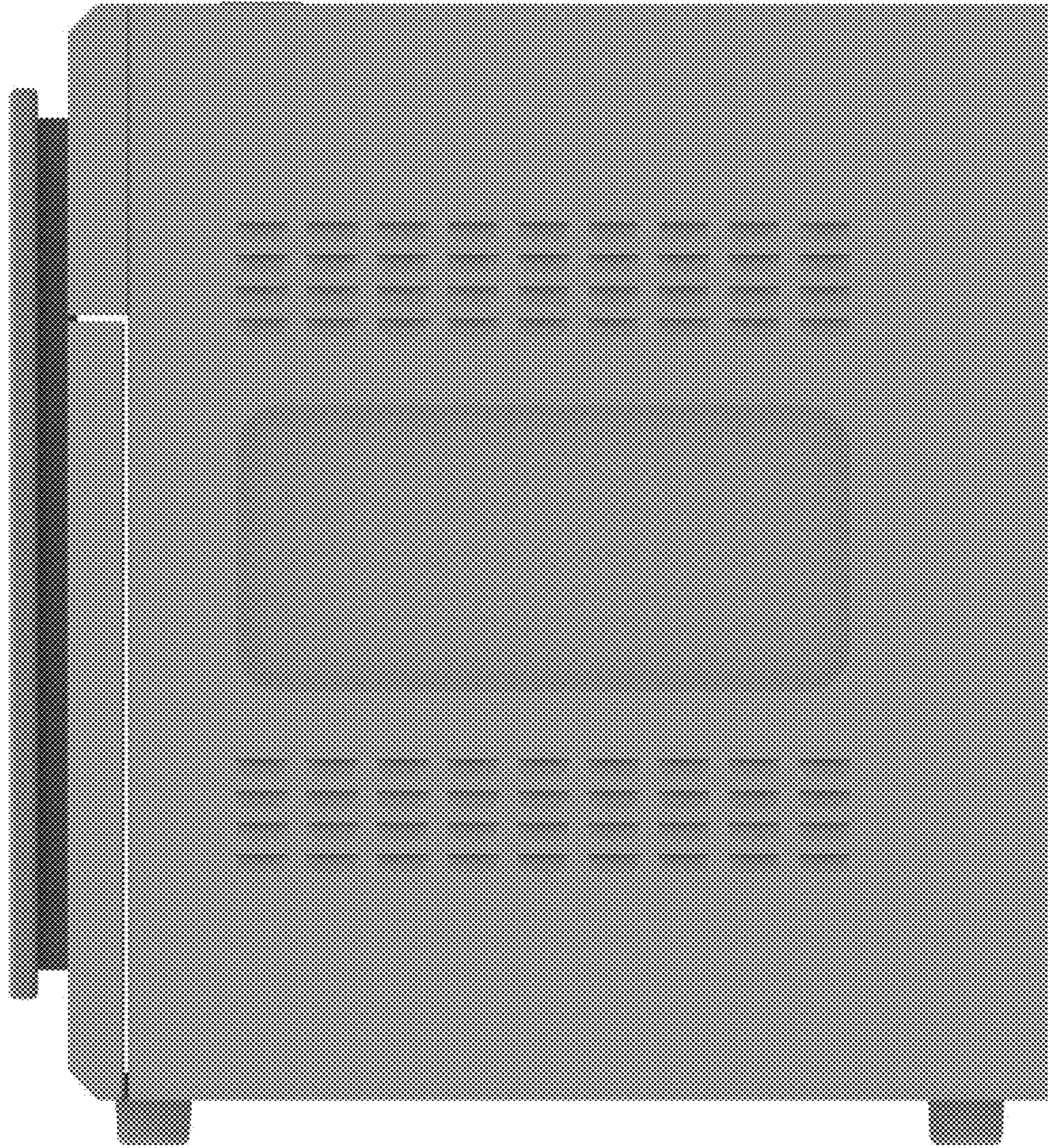

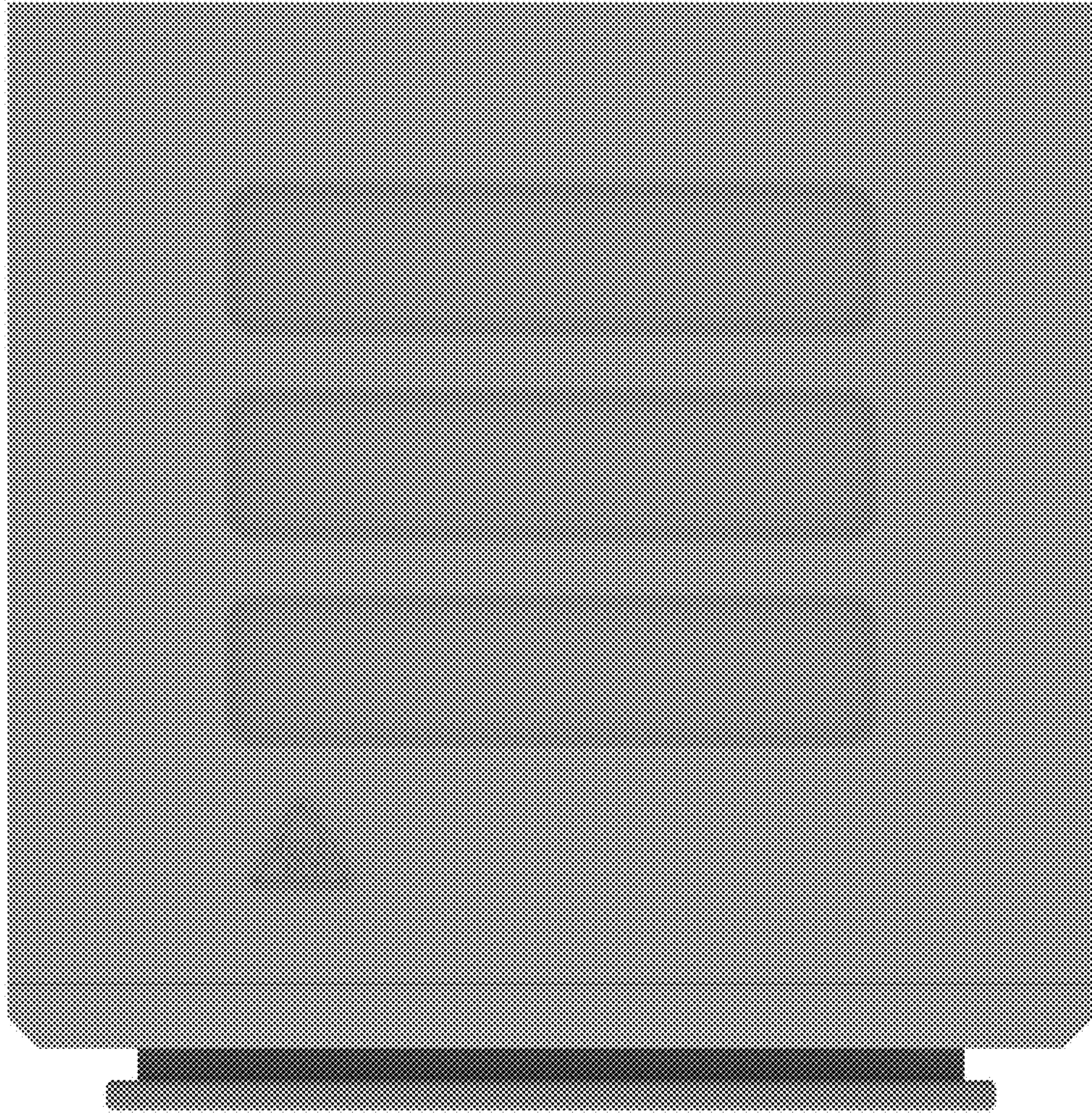

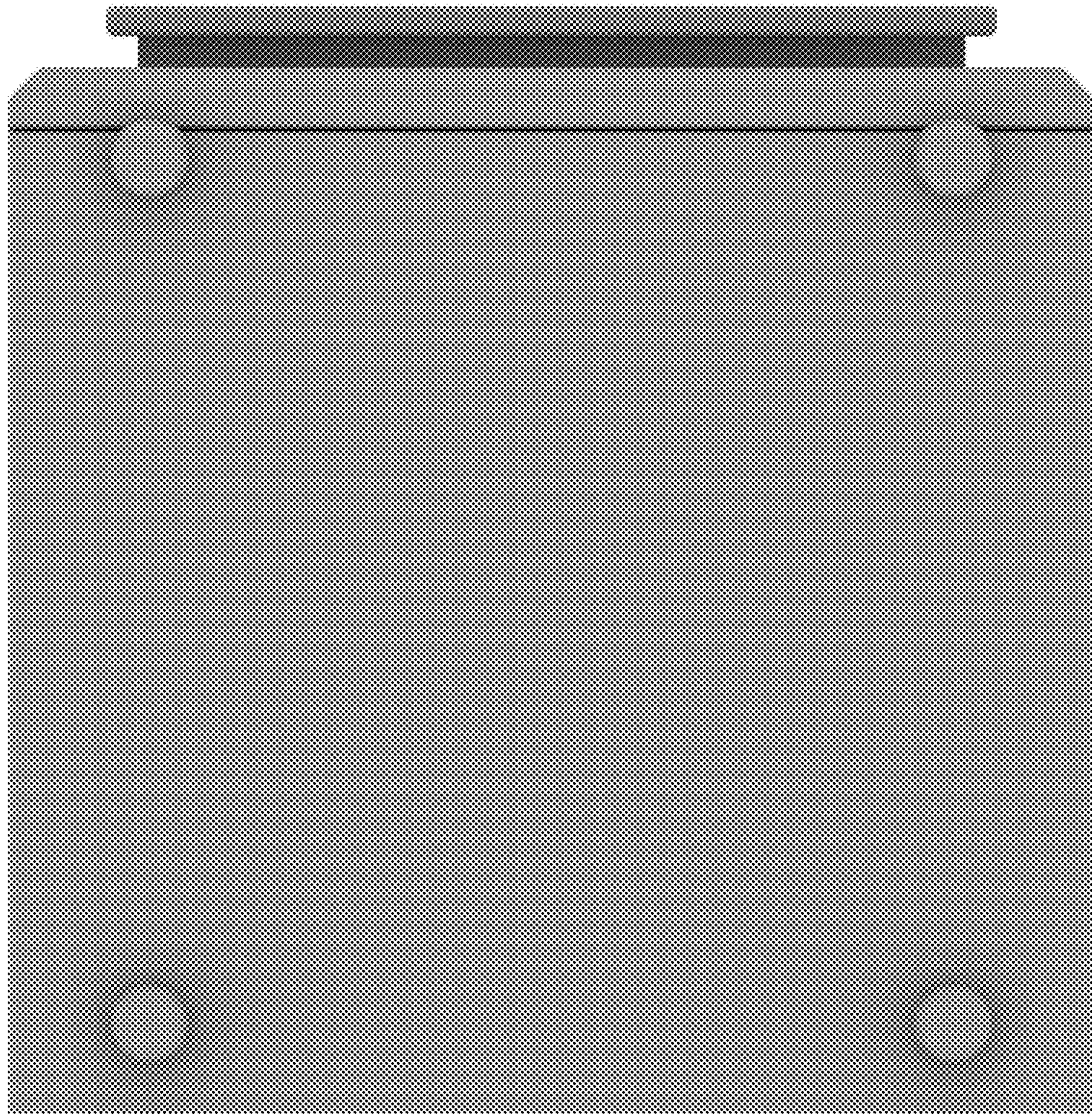
