I claim the ornamental design for a chef's hat knife block, as shown and described.

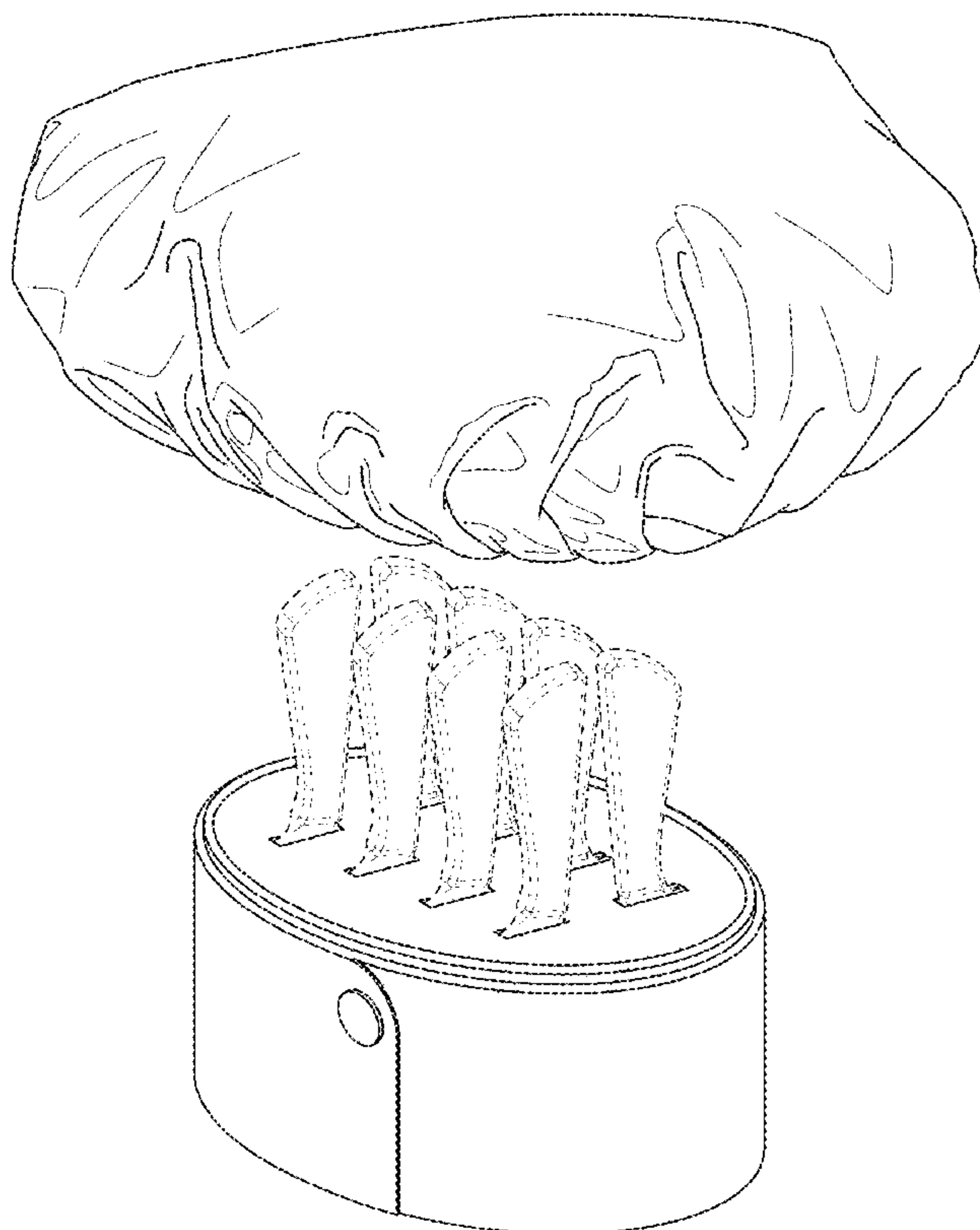
DESCRIPTION

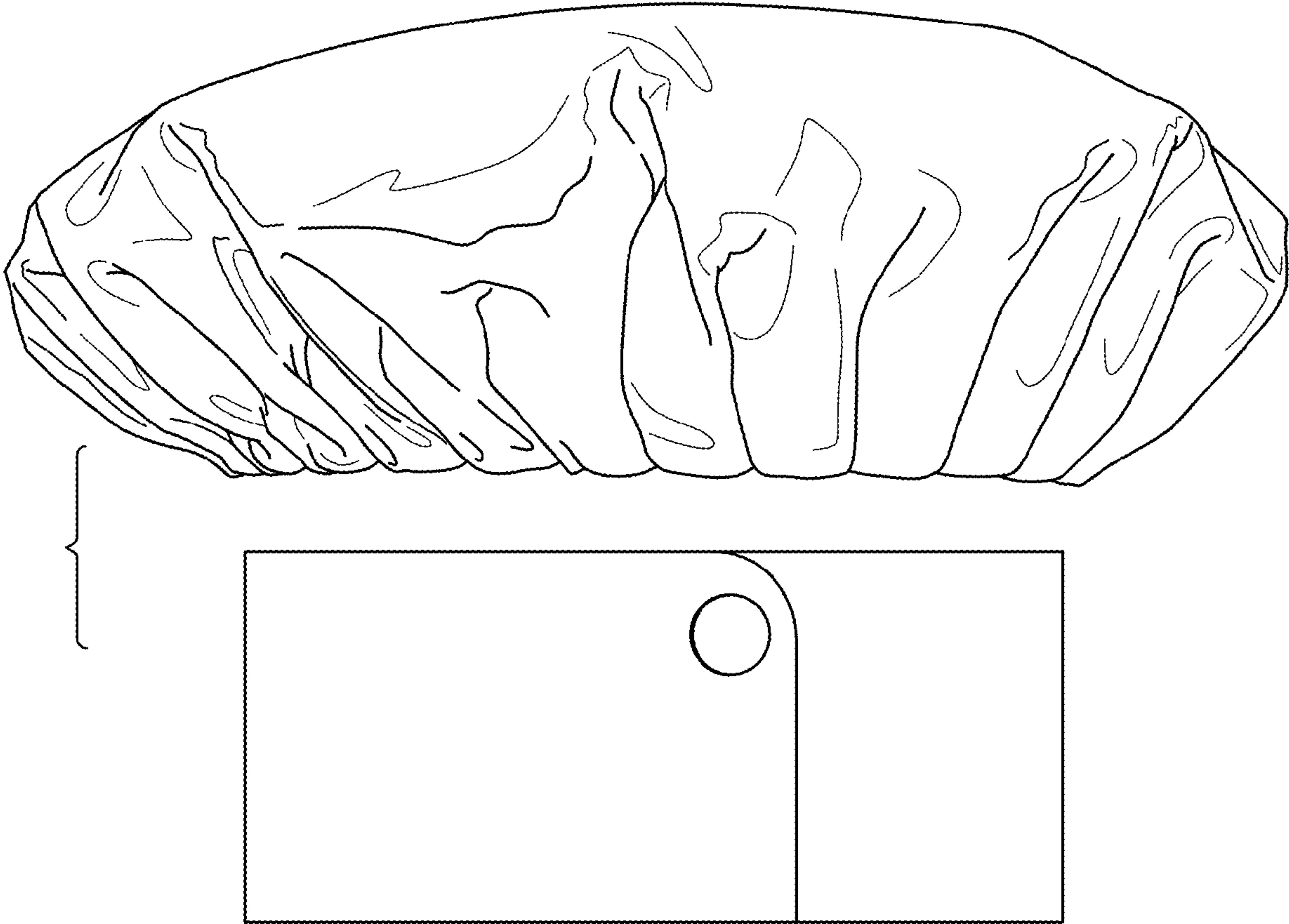

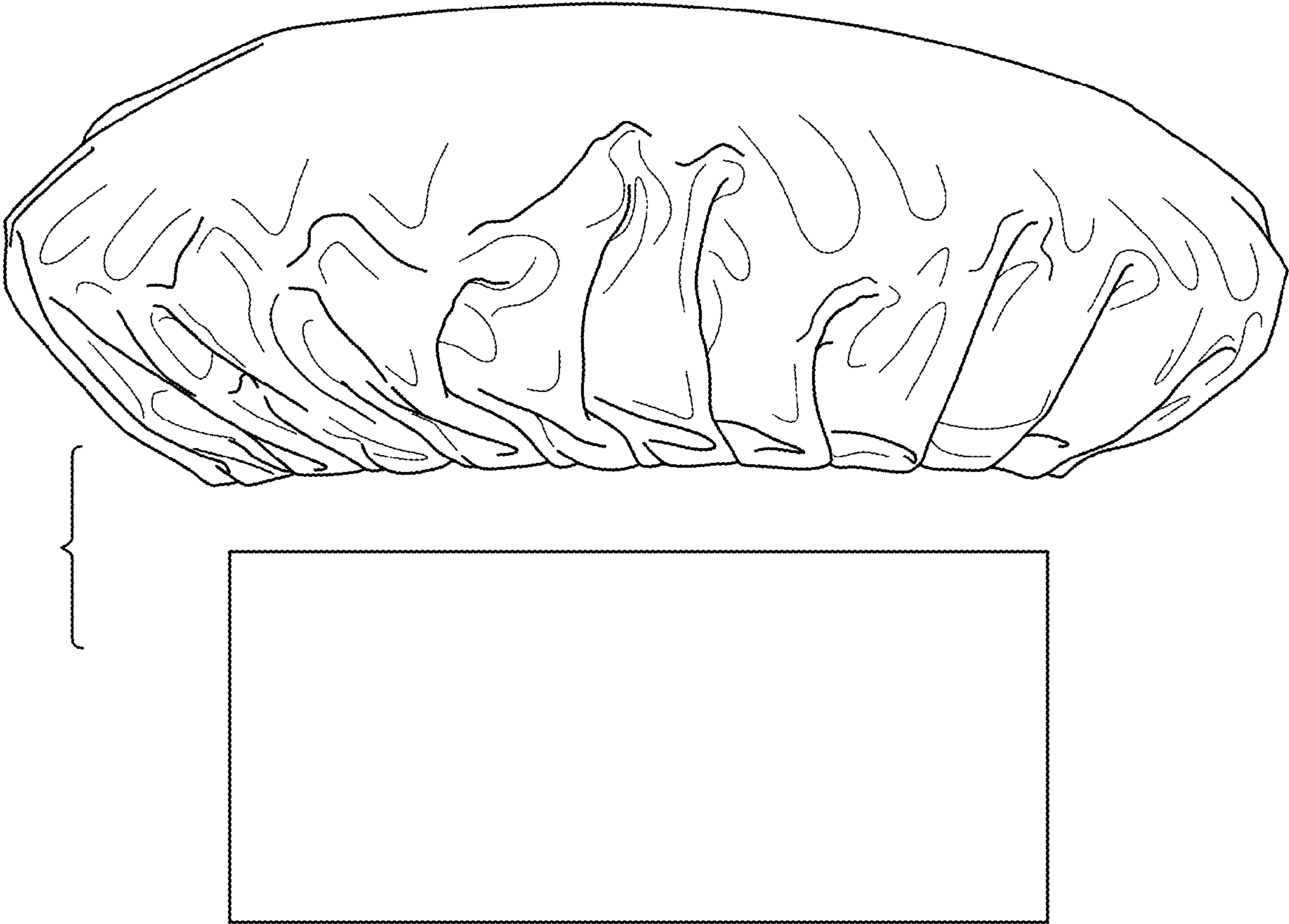

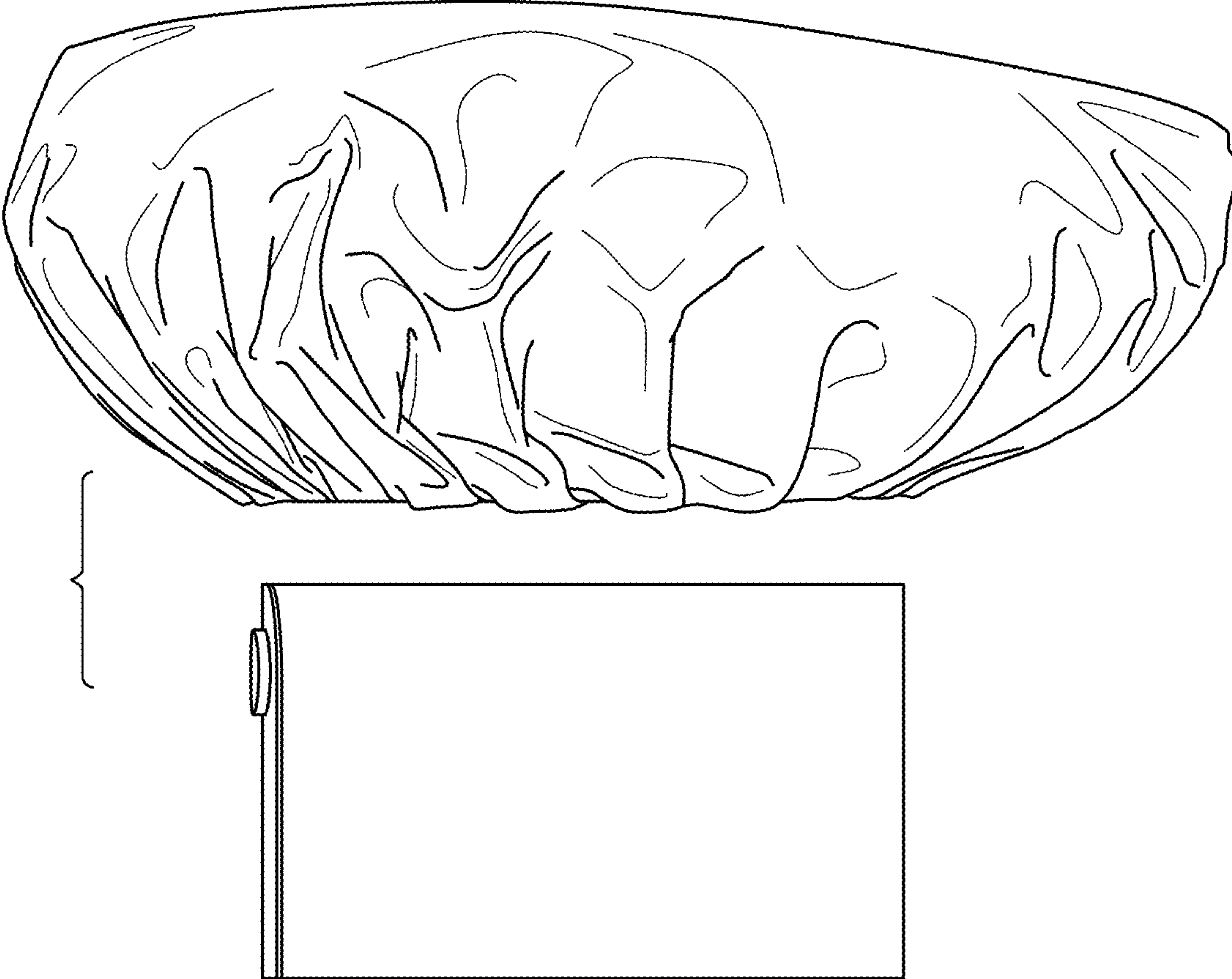

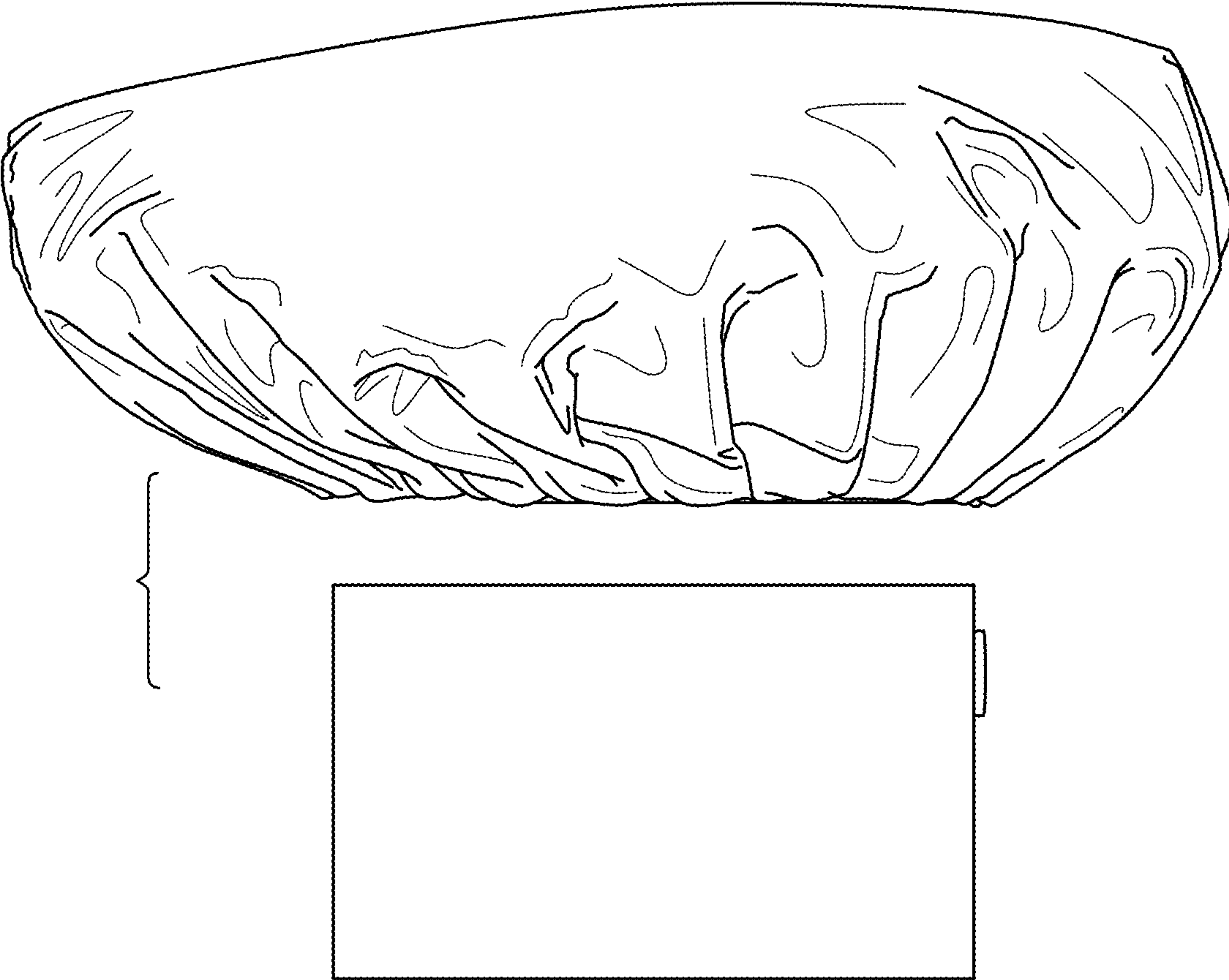

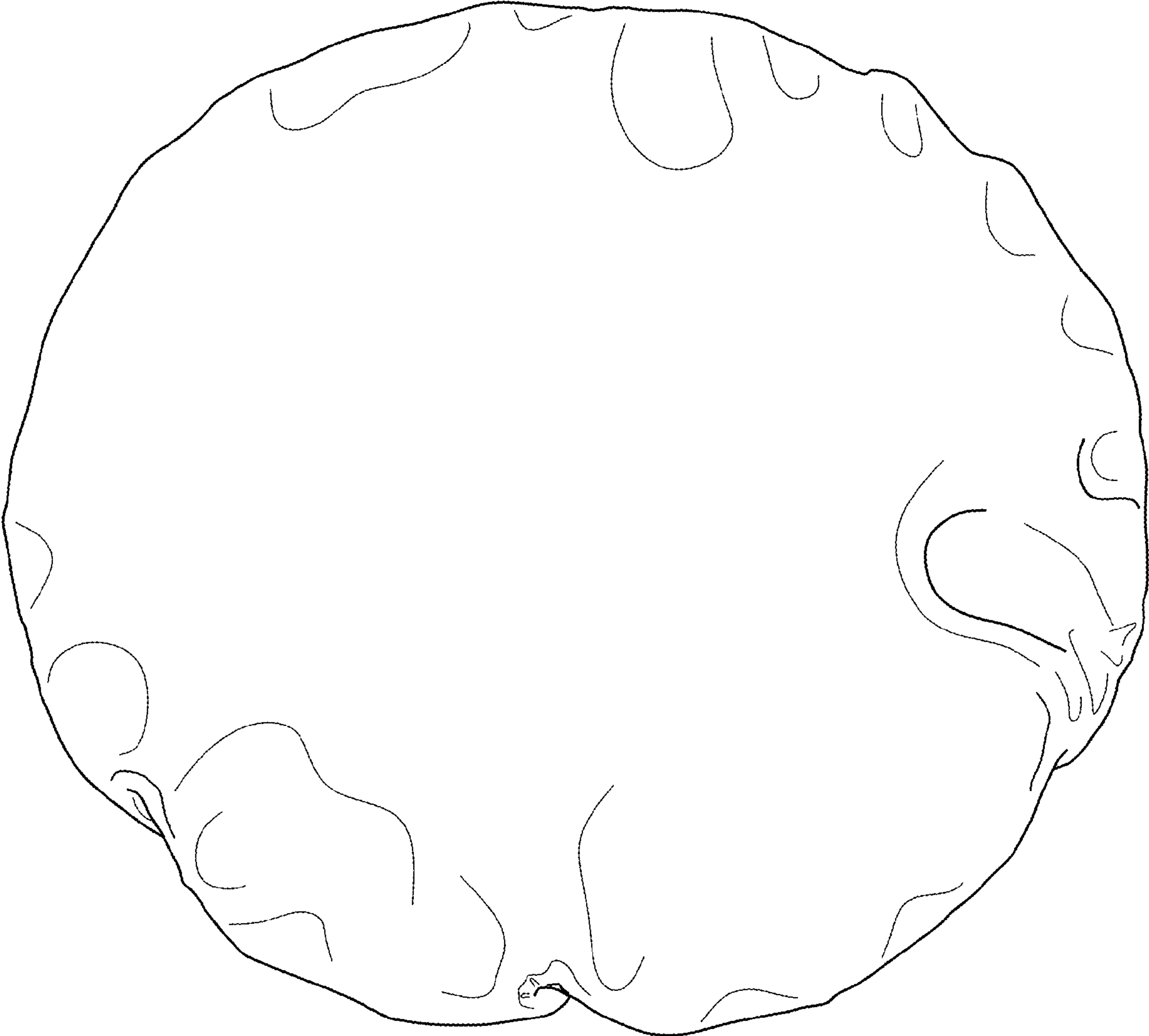

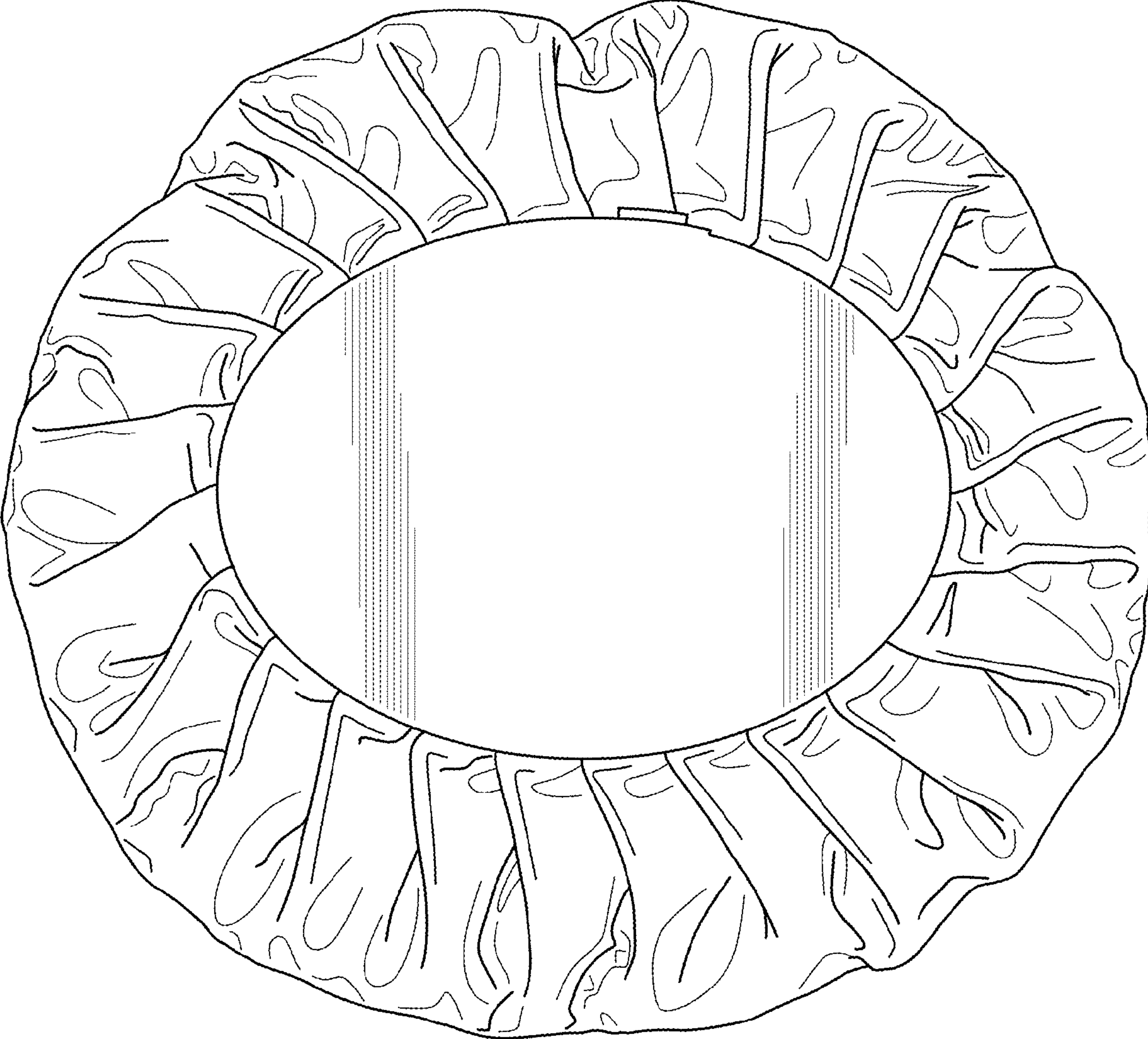

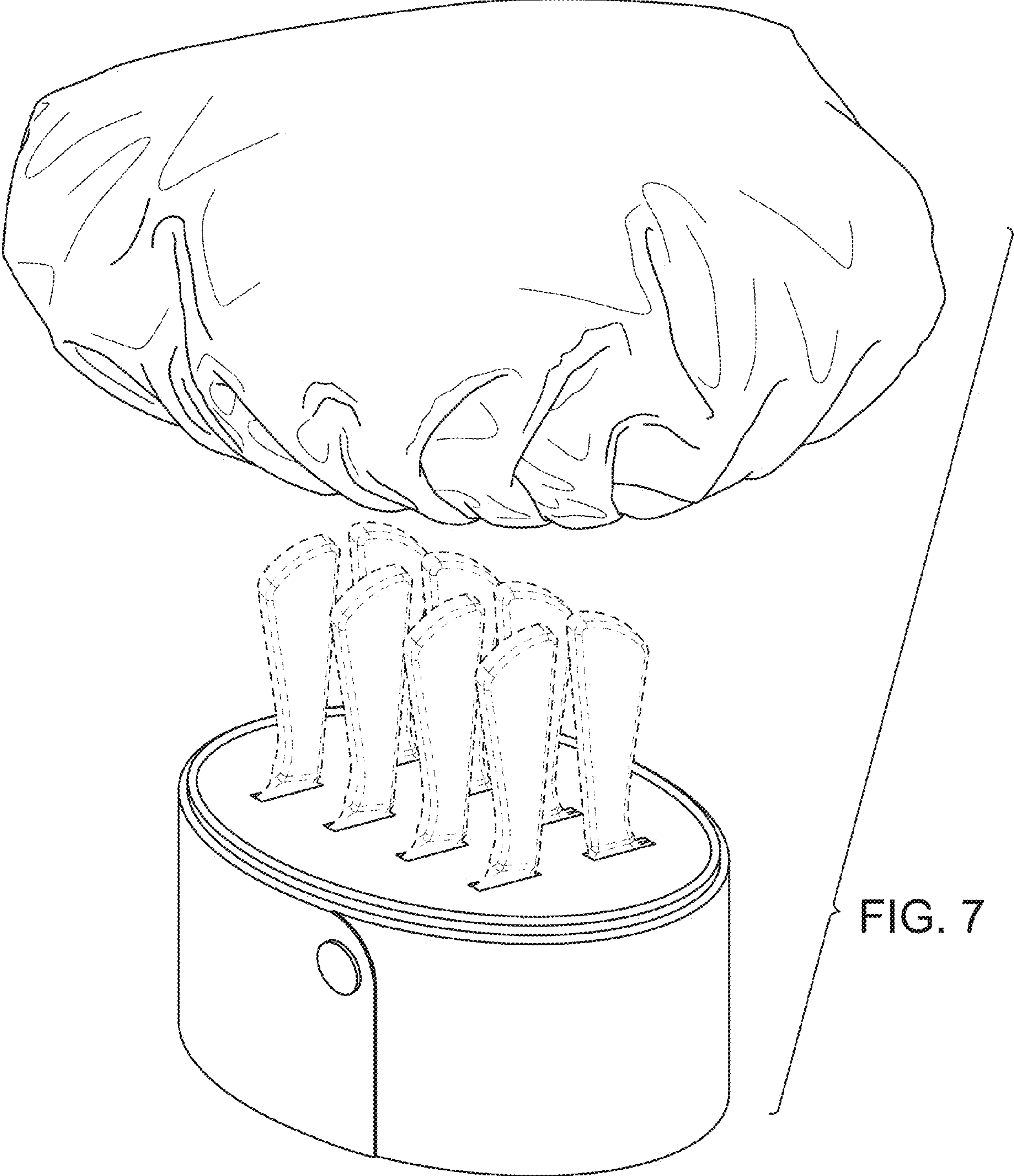

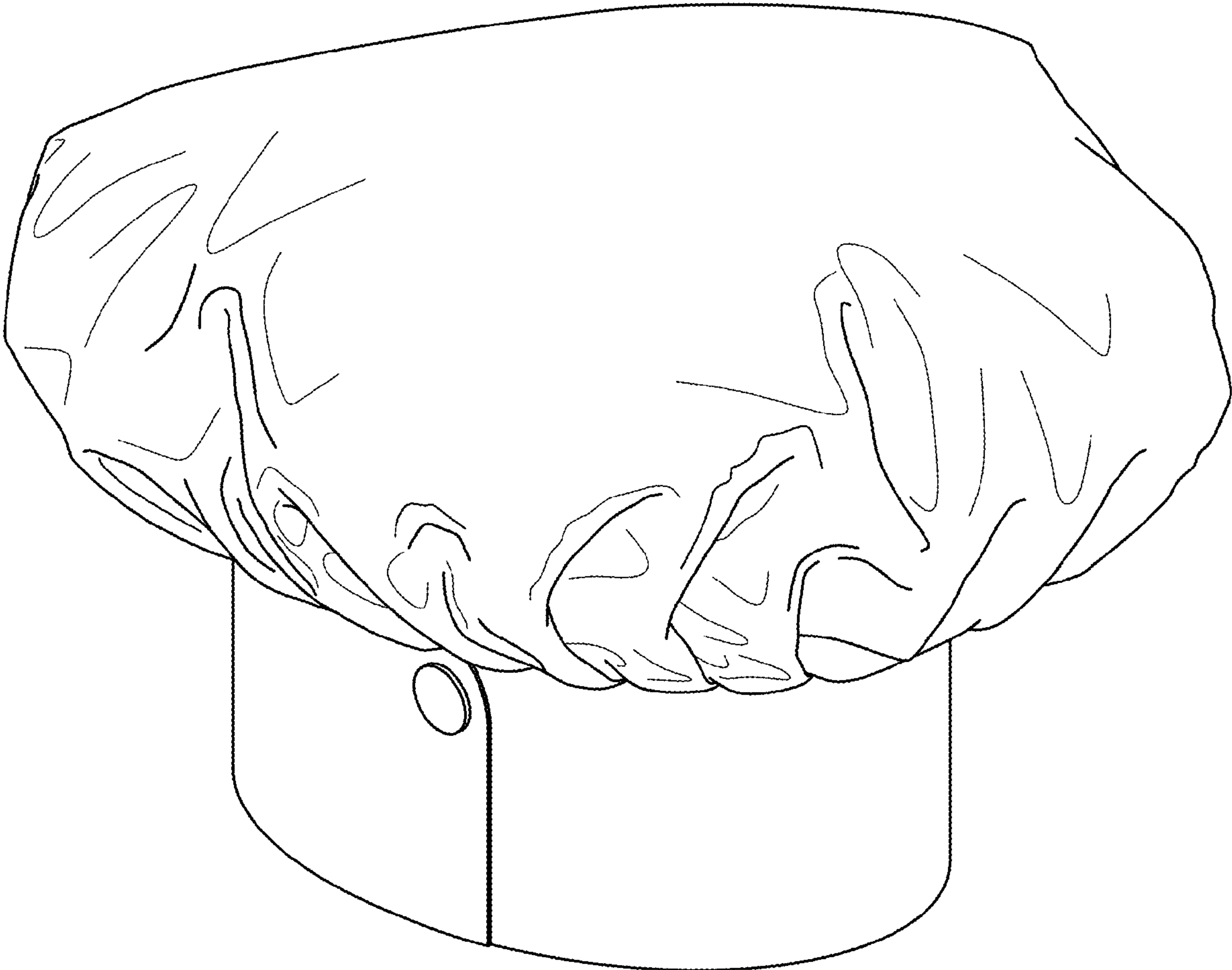
