The ornamental design for a culinary tool, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a culinary tool showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a first side perspective view thereof;
FIG. 4 is a second side perspective view thereof;
FIG. 5 is an enlarged bottom view of the distal end thereof; and,
FIG. 6 is an enlarged top view of the proximate end thereof.
The broken lines form no part of the claimed design.

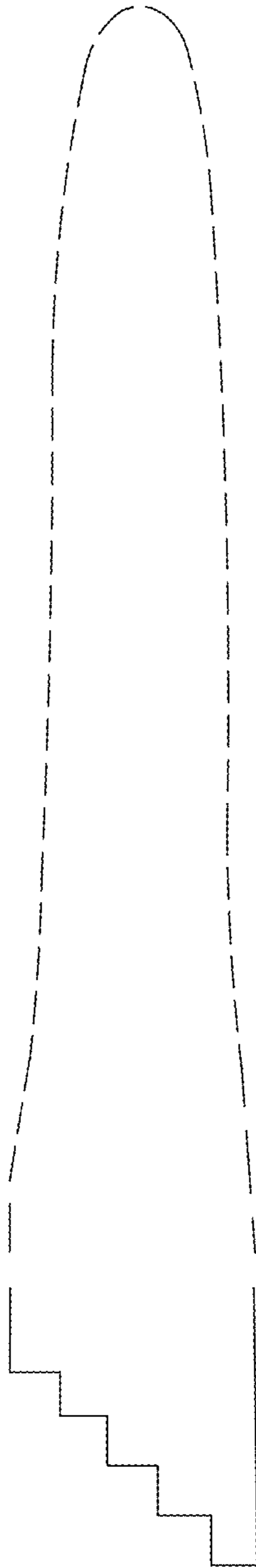

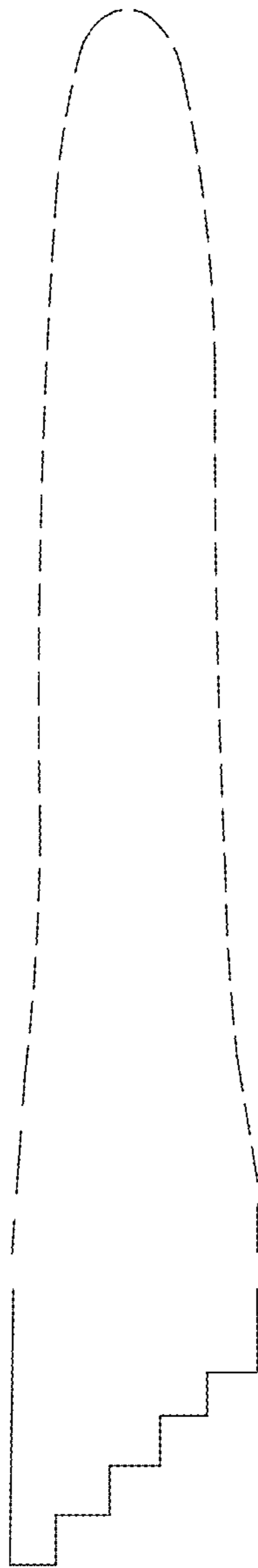

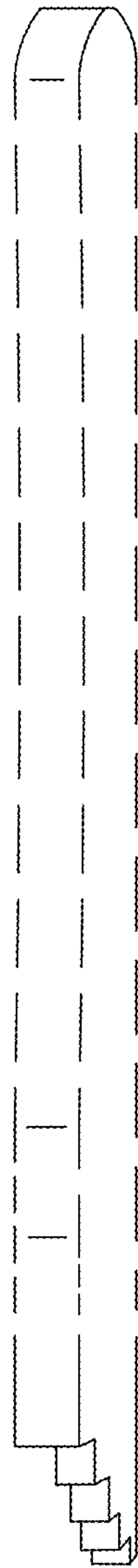

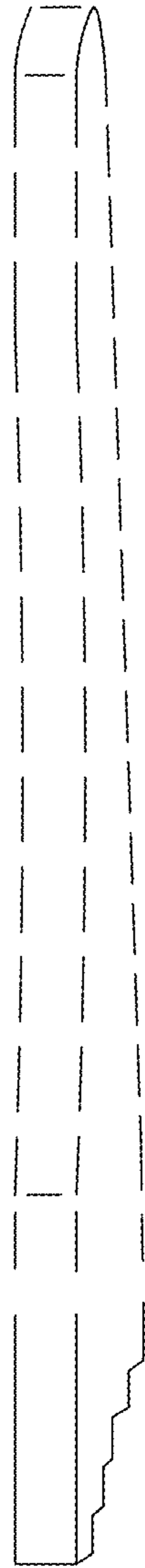

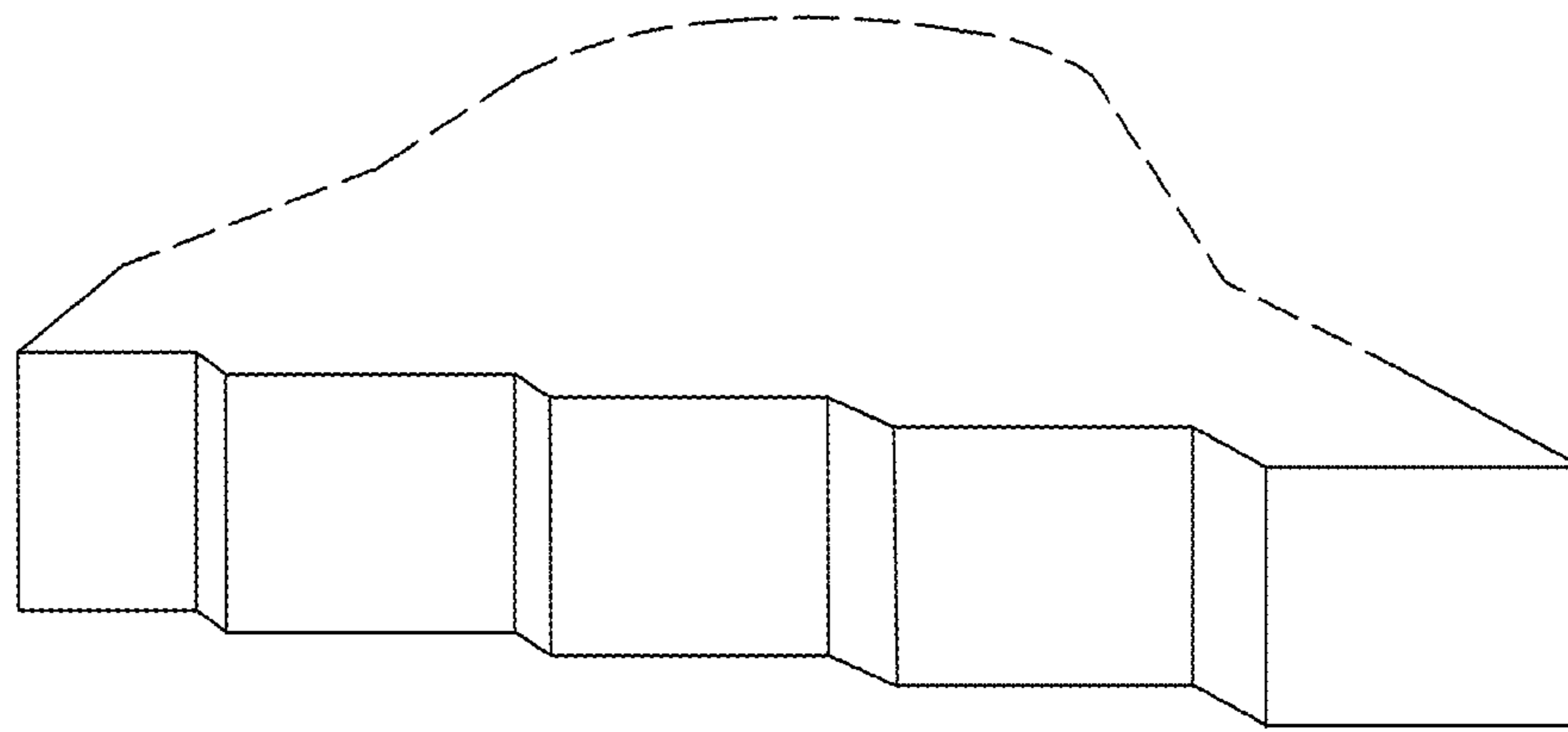

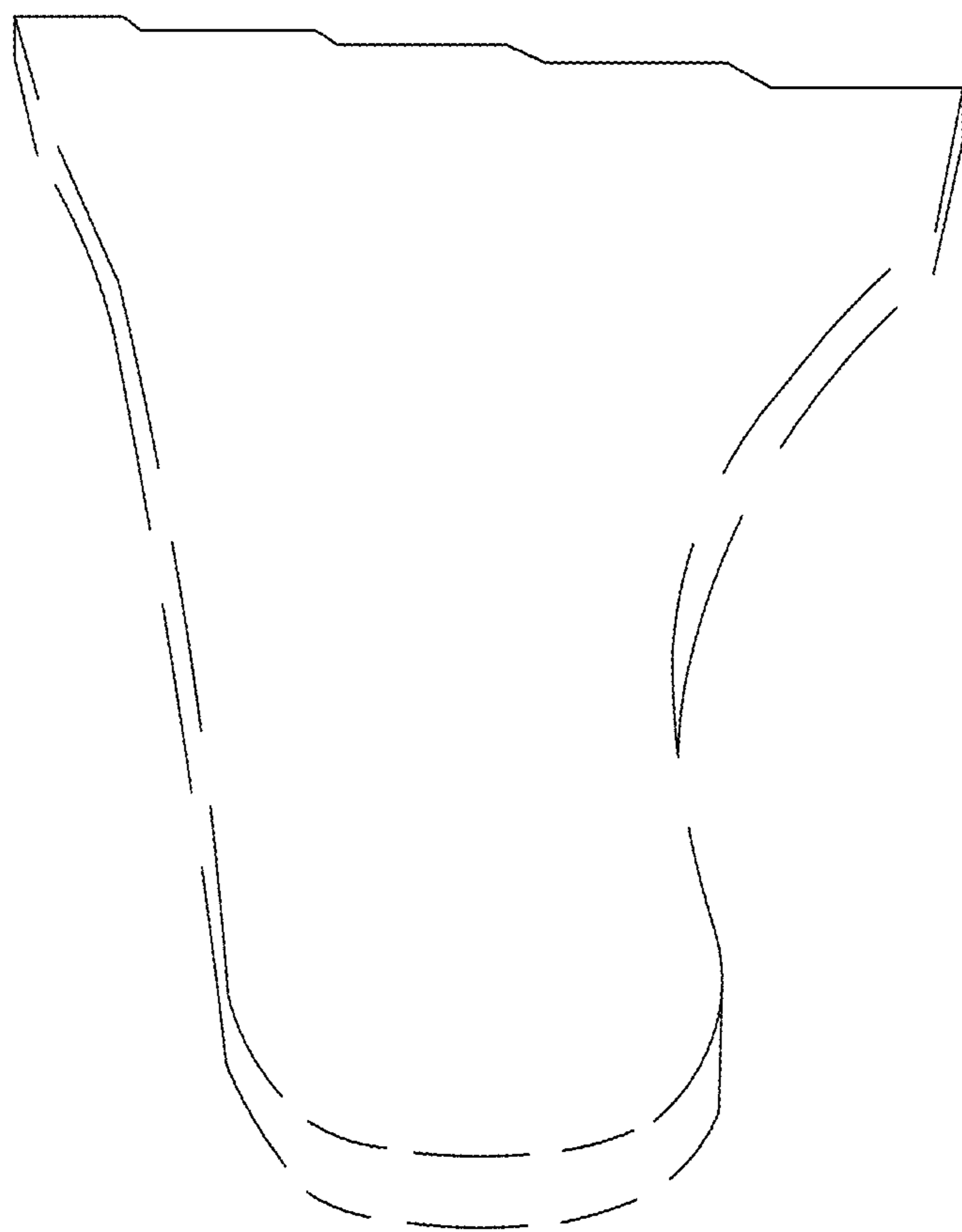
