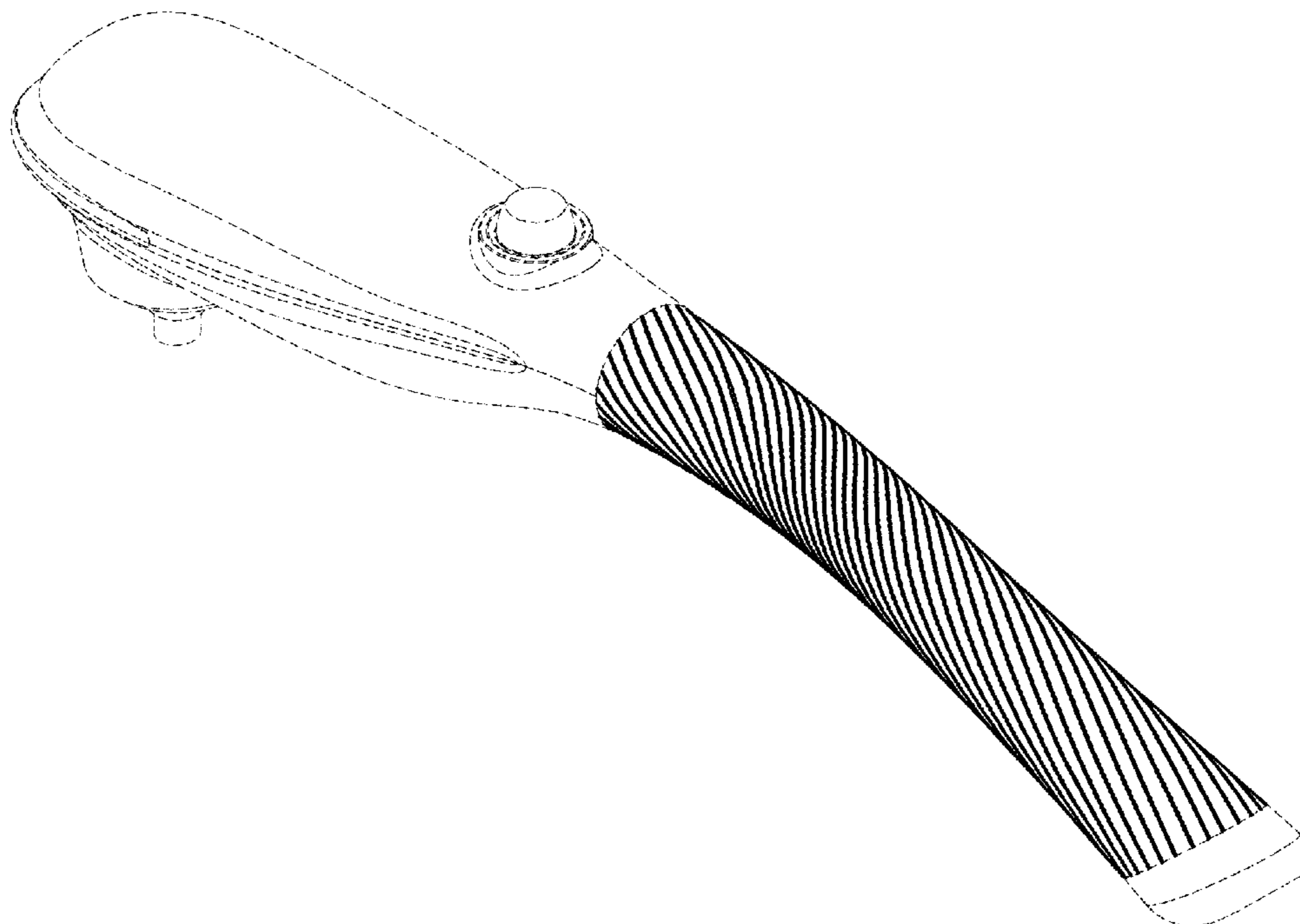

DESCRIPTION
FIG. 1 is a perspective view of a handle, showing our new design;
FIG. 2 is a left elevational view of the handle of FIG. 1.
FIG. 3 is a right elevational view of the handle of FIG. 1.
FIG. 4 is a front elevational view of the handle of FIG. 1.
FIG. 5 is a rear elevational view of the handle of FIG. 1.
FIG. 6 is a top plan view of the handle of FIG. 1; and,
FIG. 7 is a bottom plan view of the handle of FIG. 1.

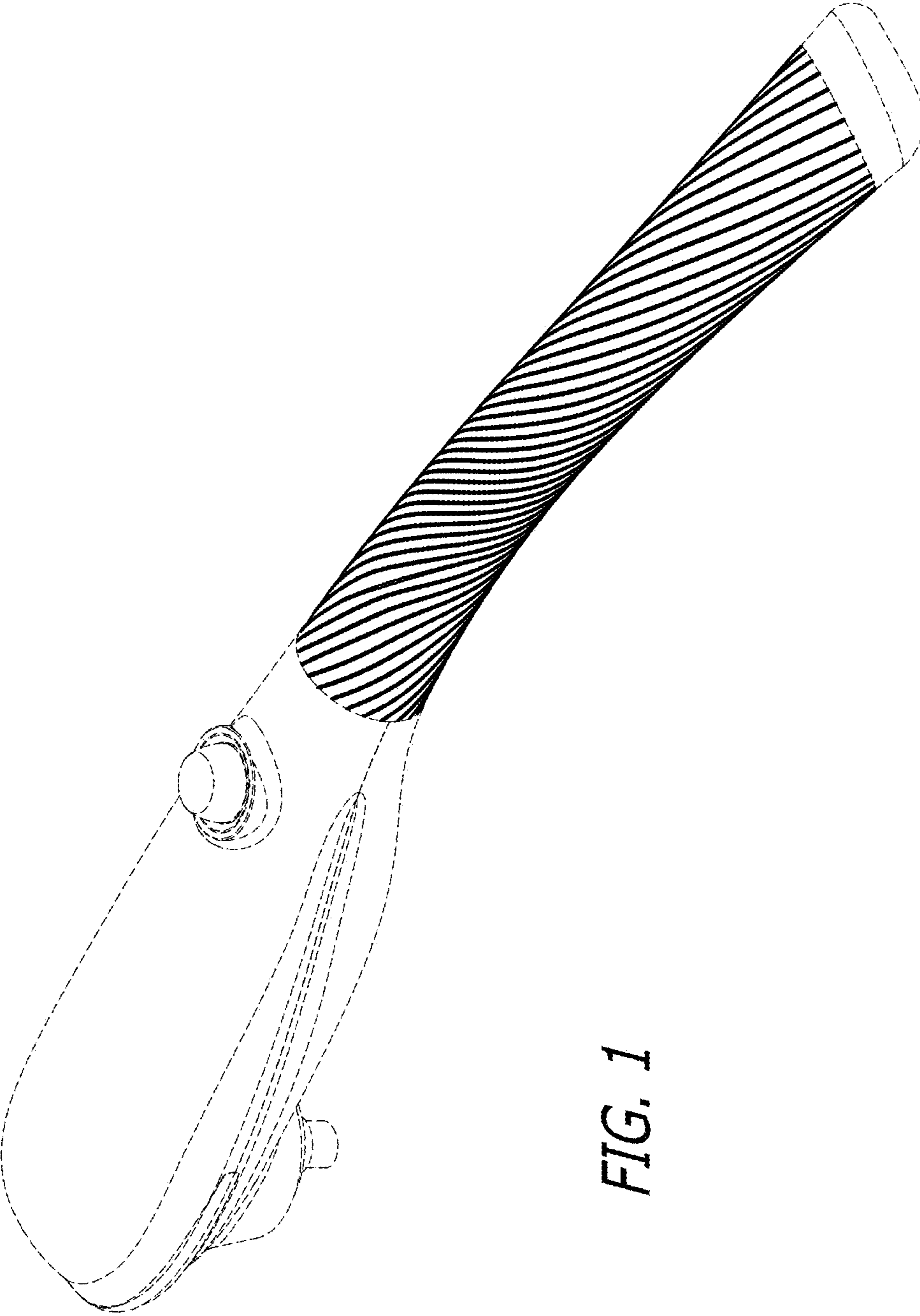

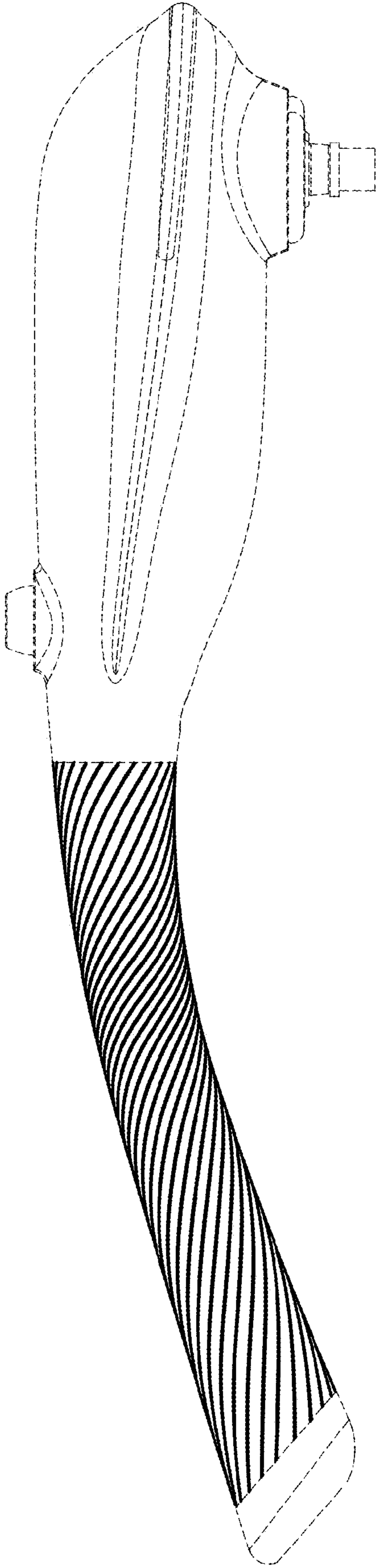

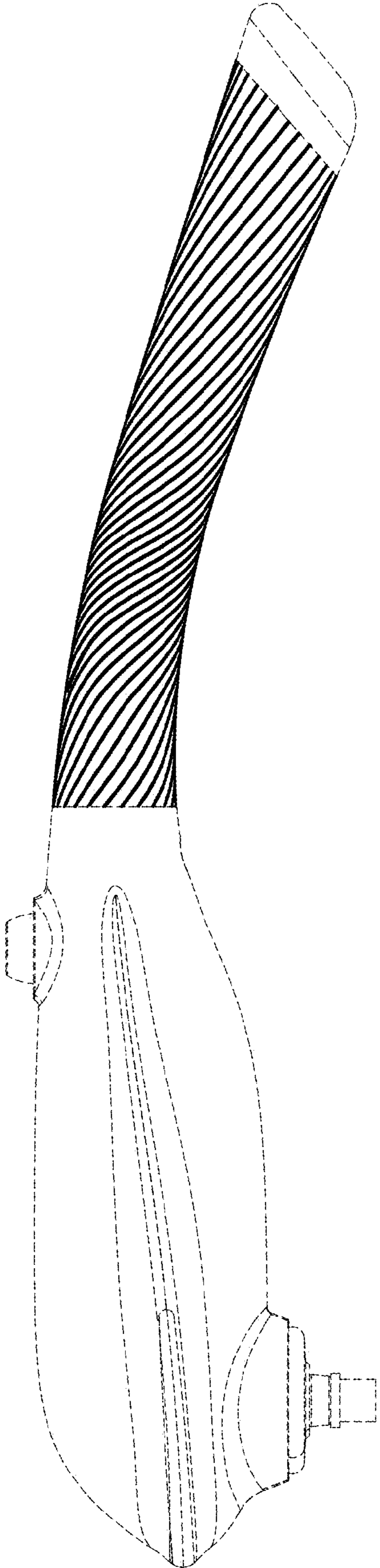

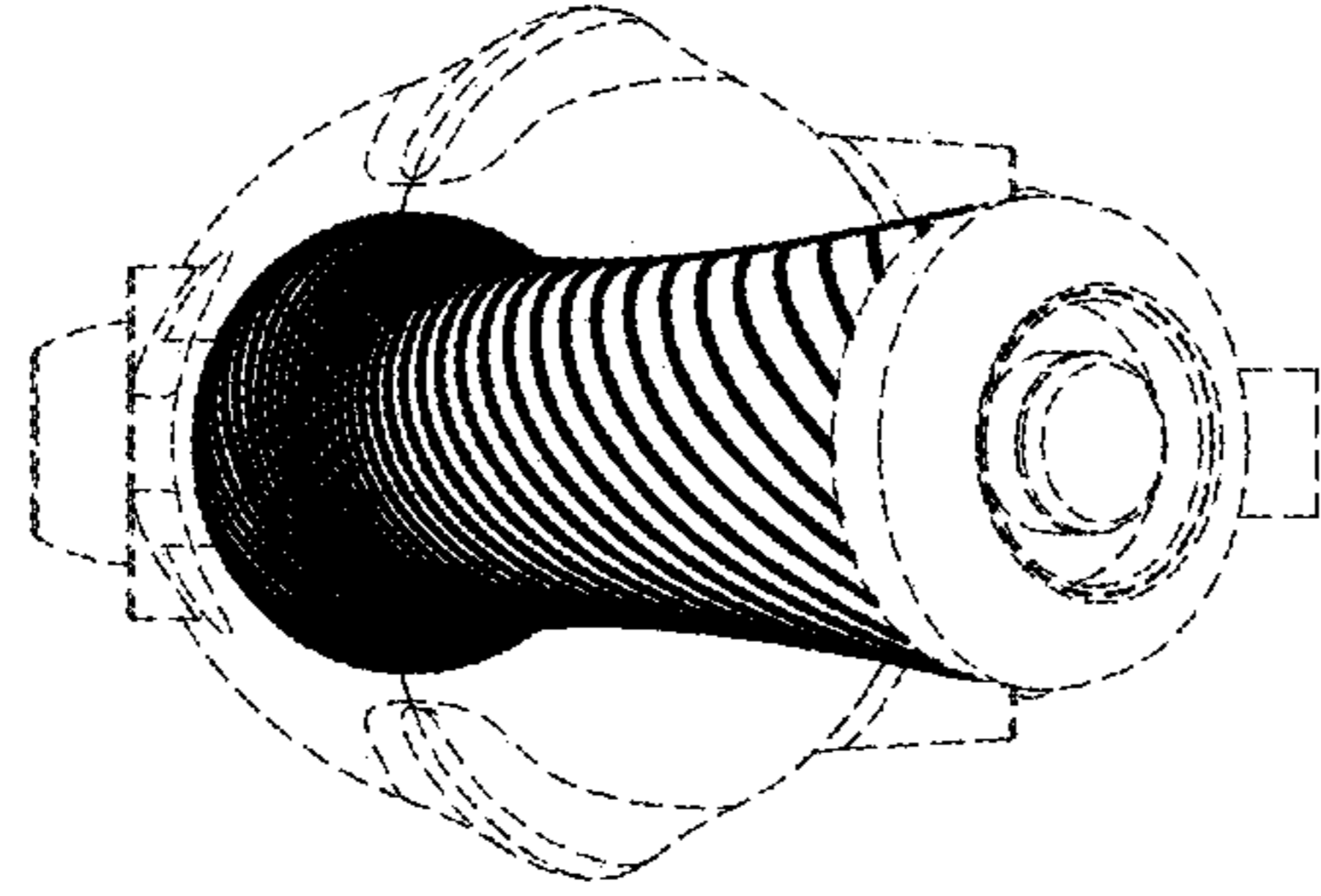

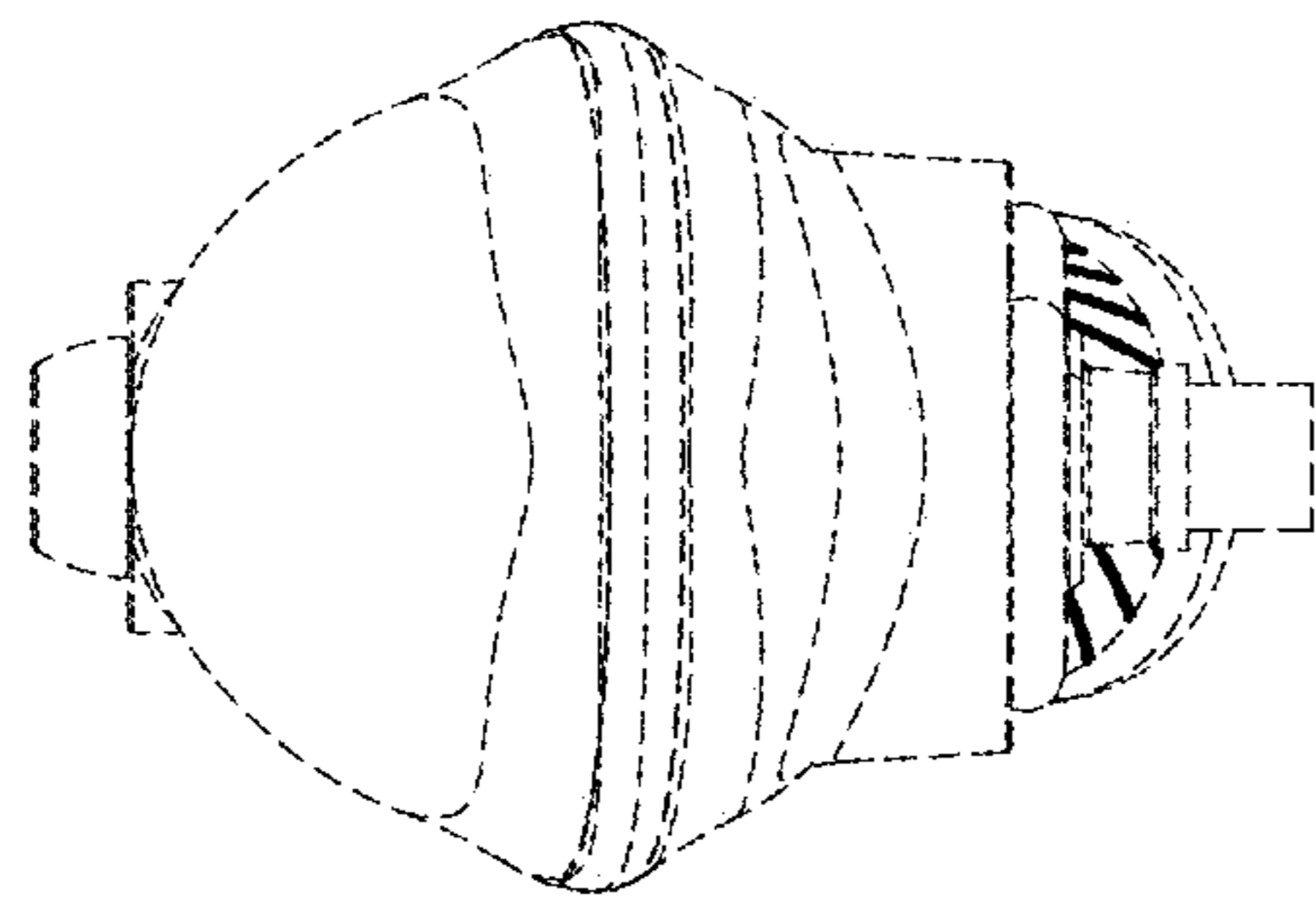

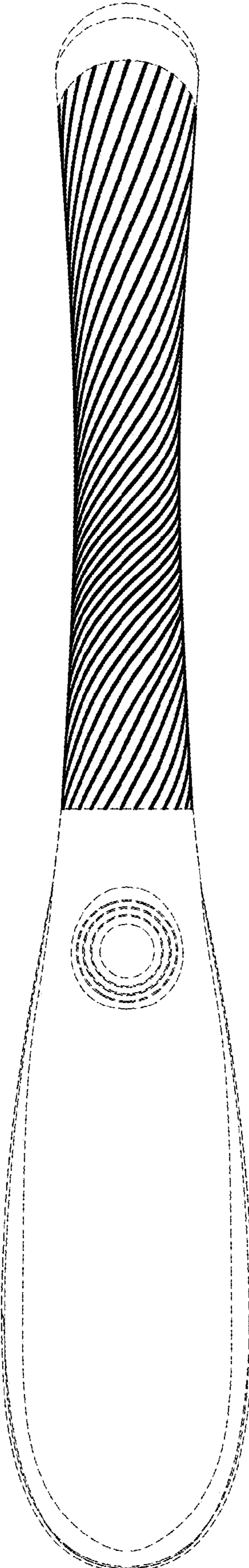

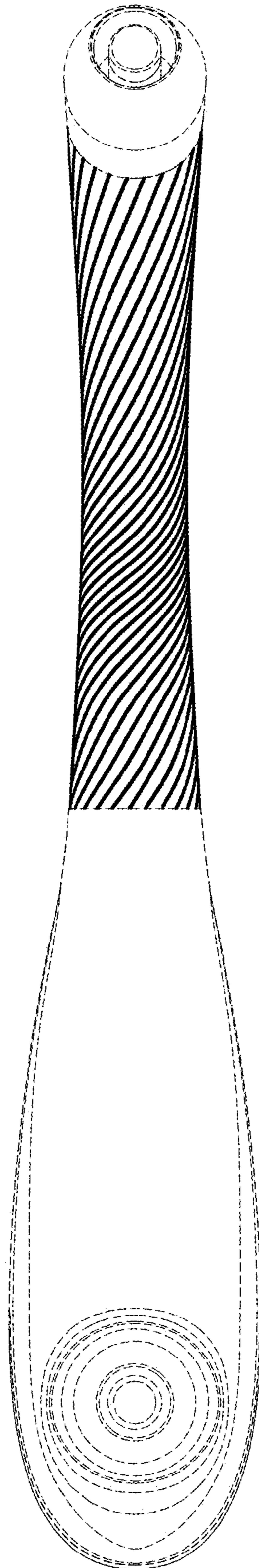
