FIG. 6 is a right side elevation view thereof.

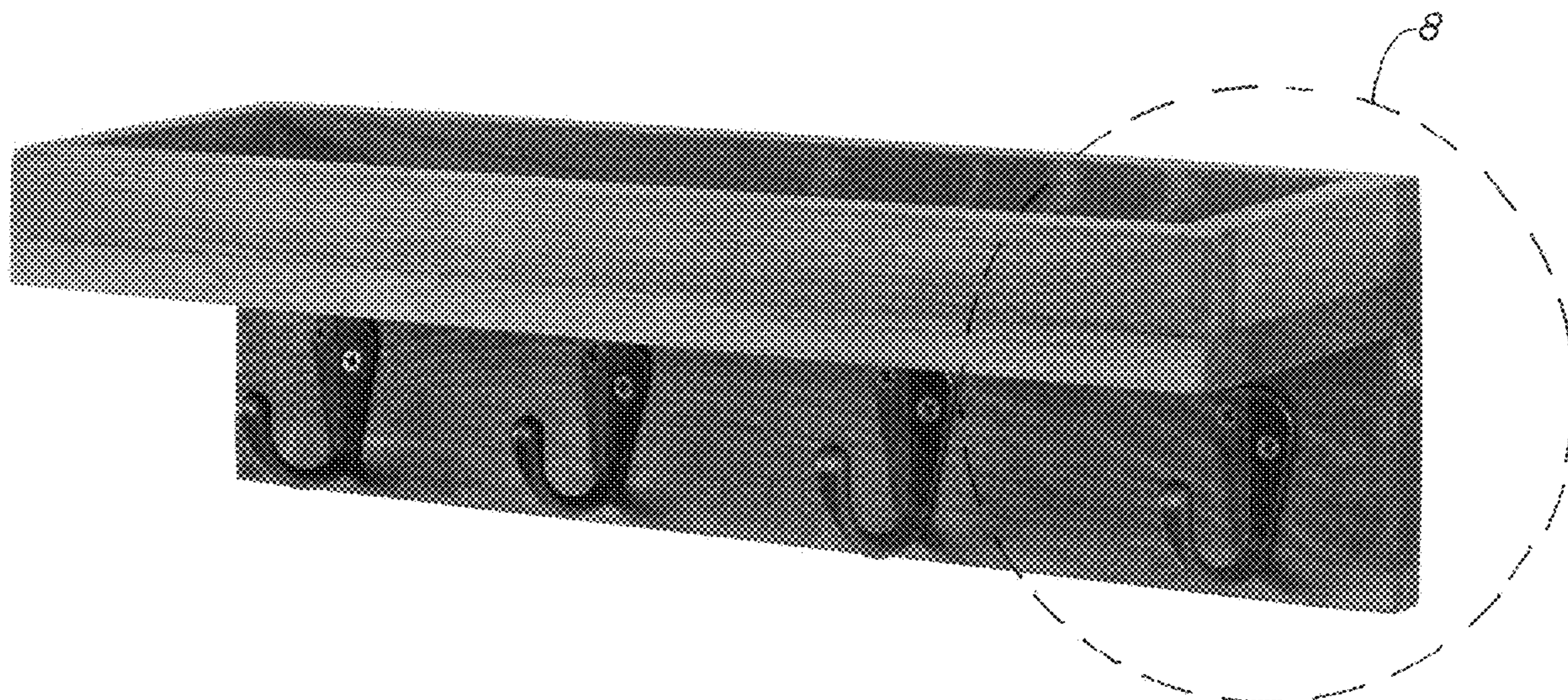
FIG. 7 is a left side elevational view thereof; and,

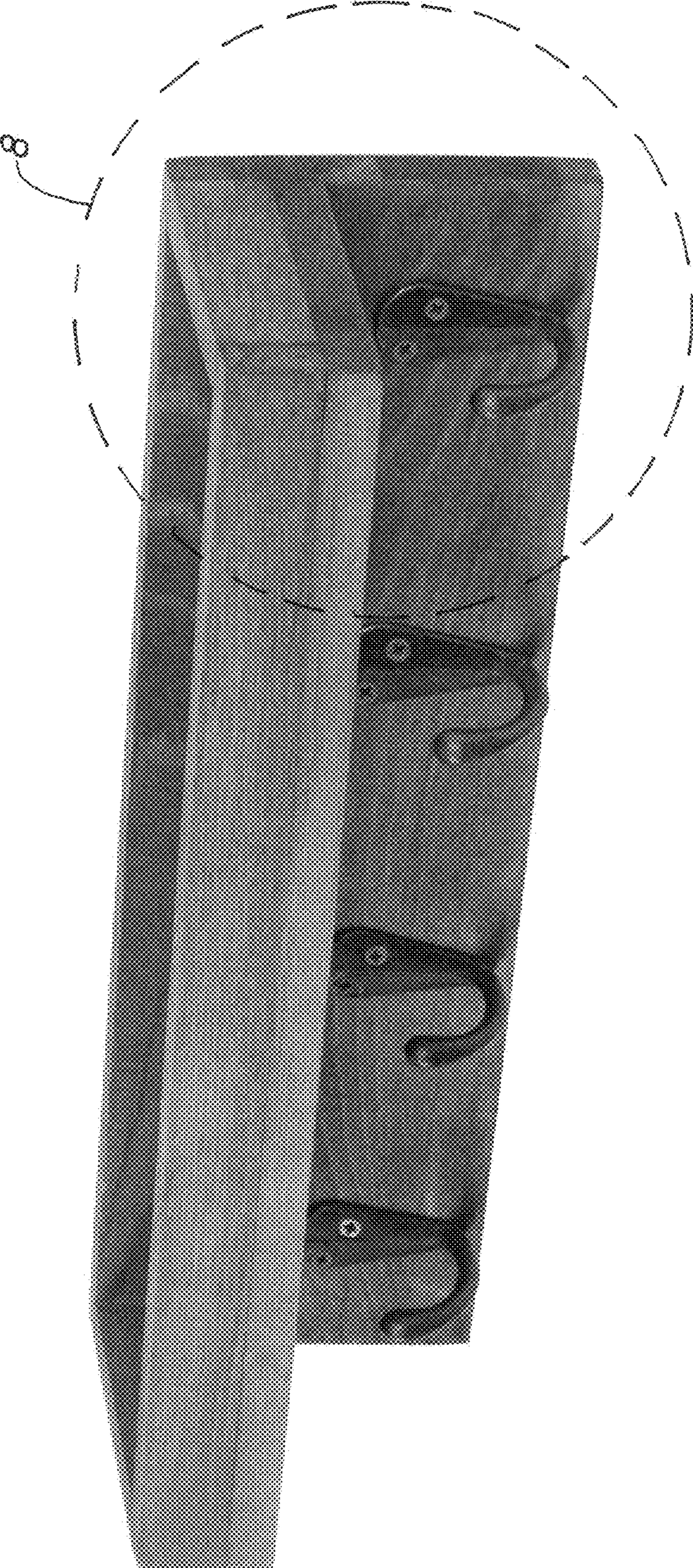

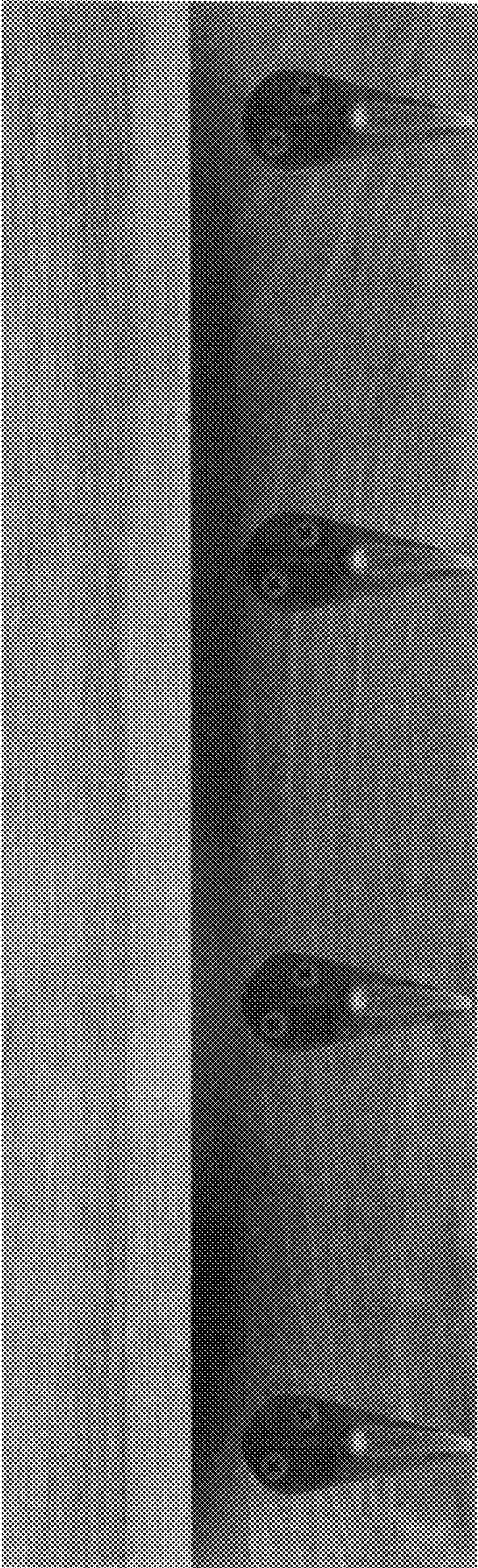

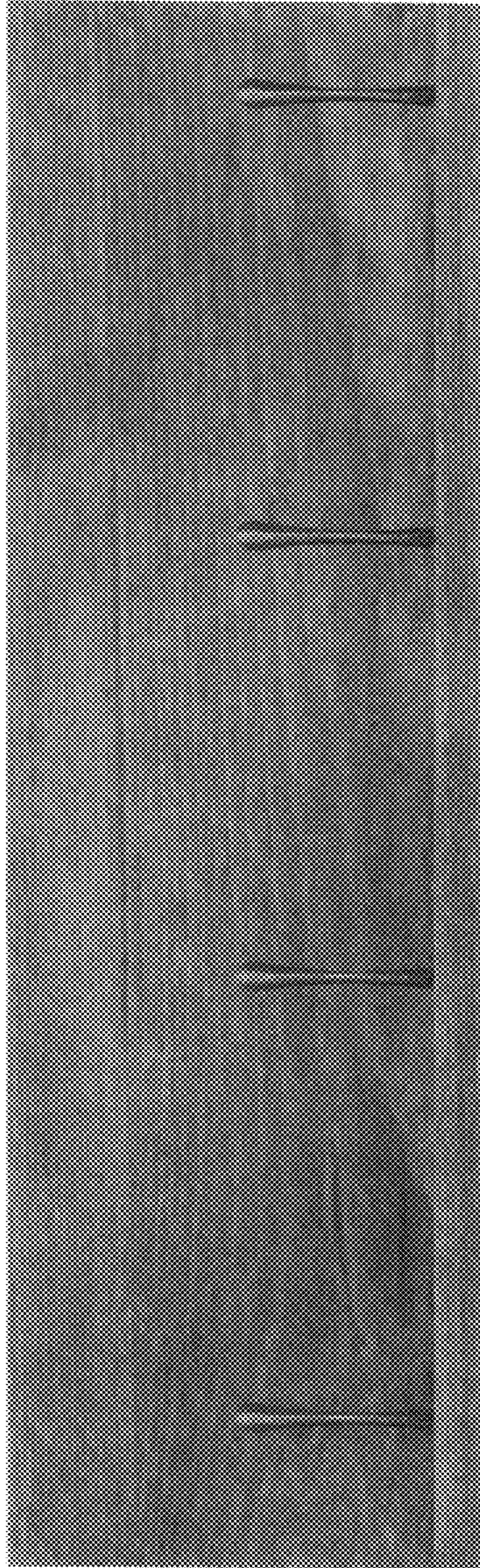

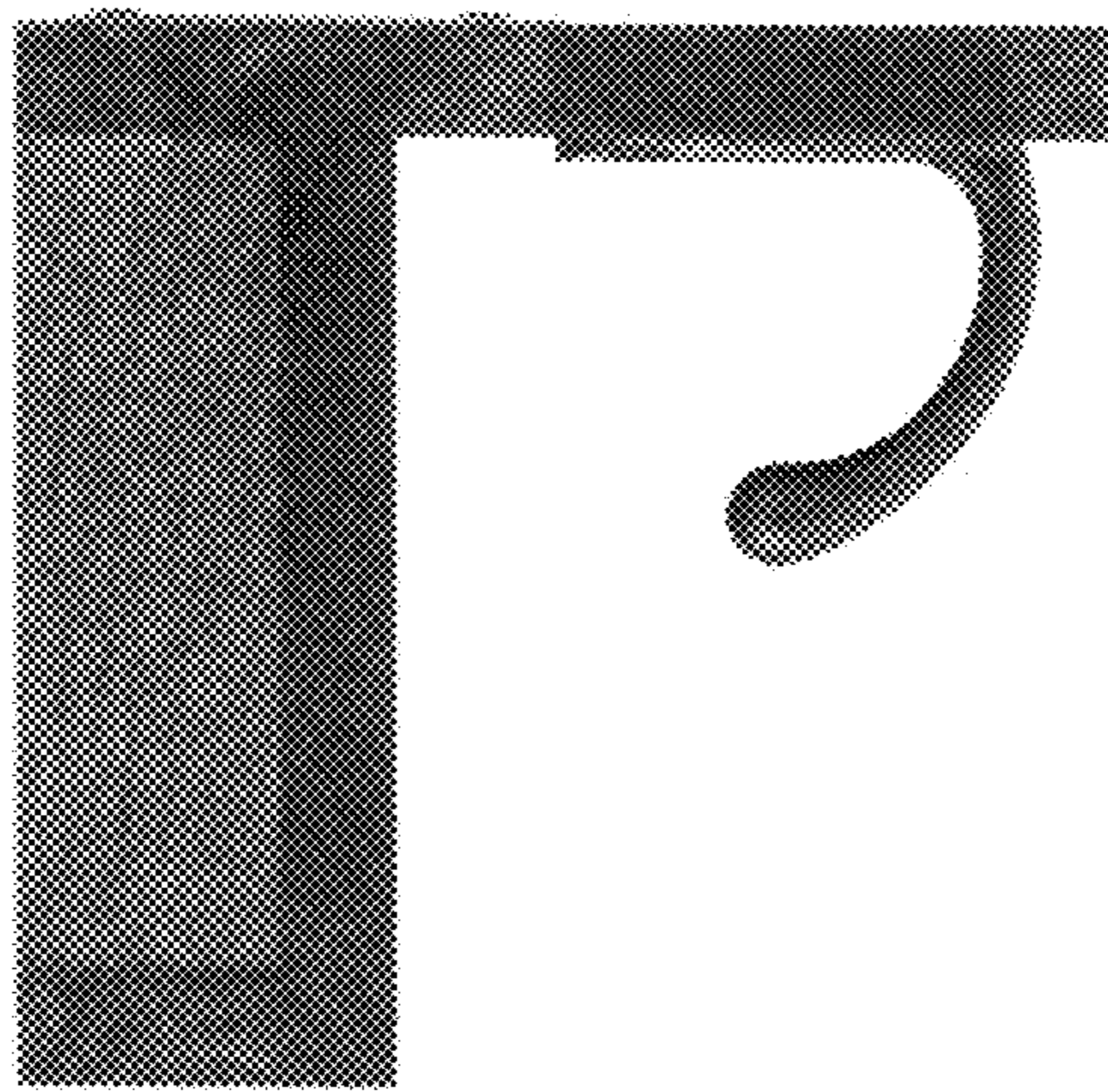

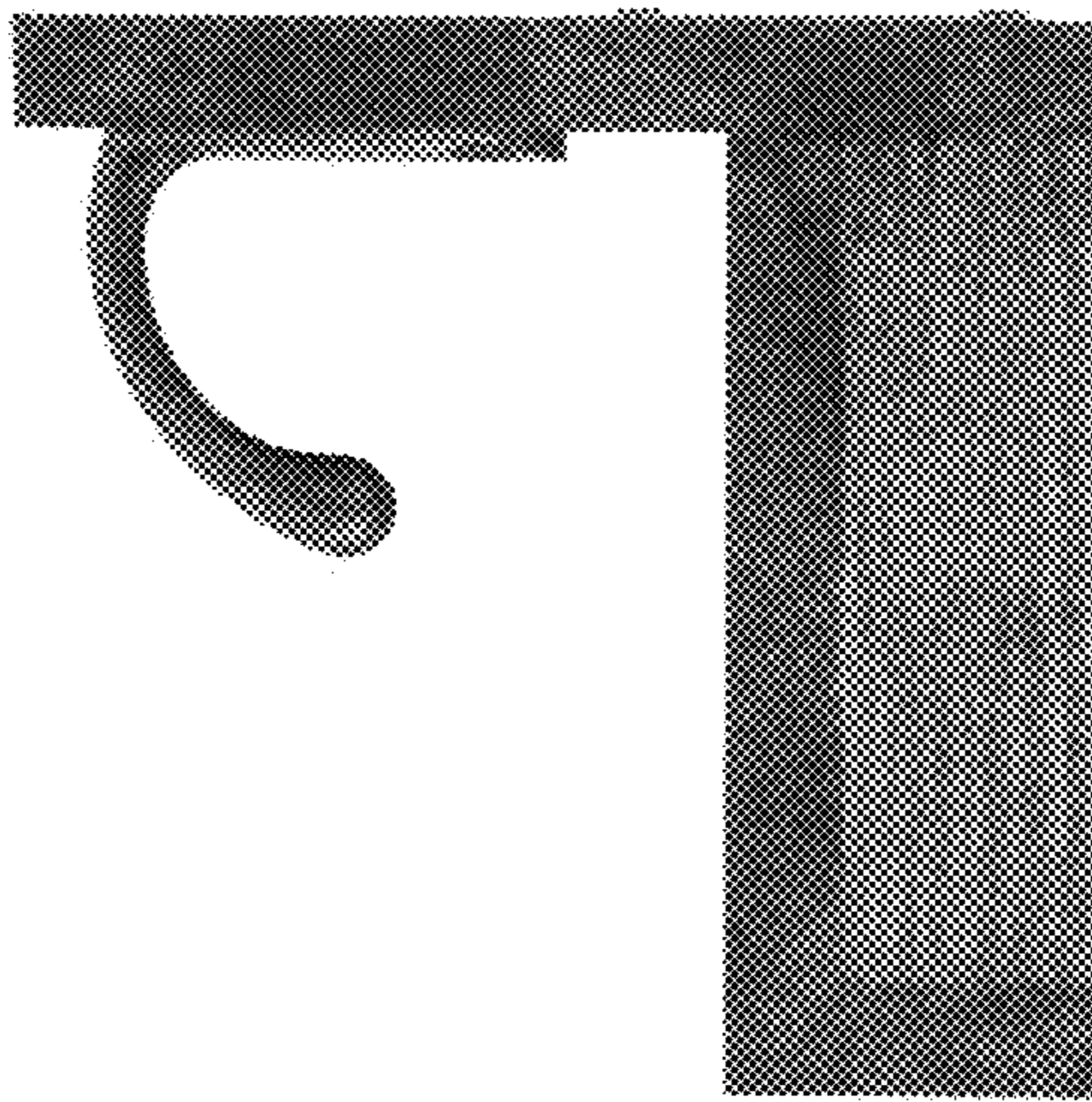

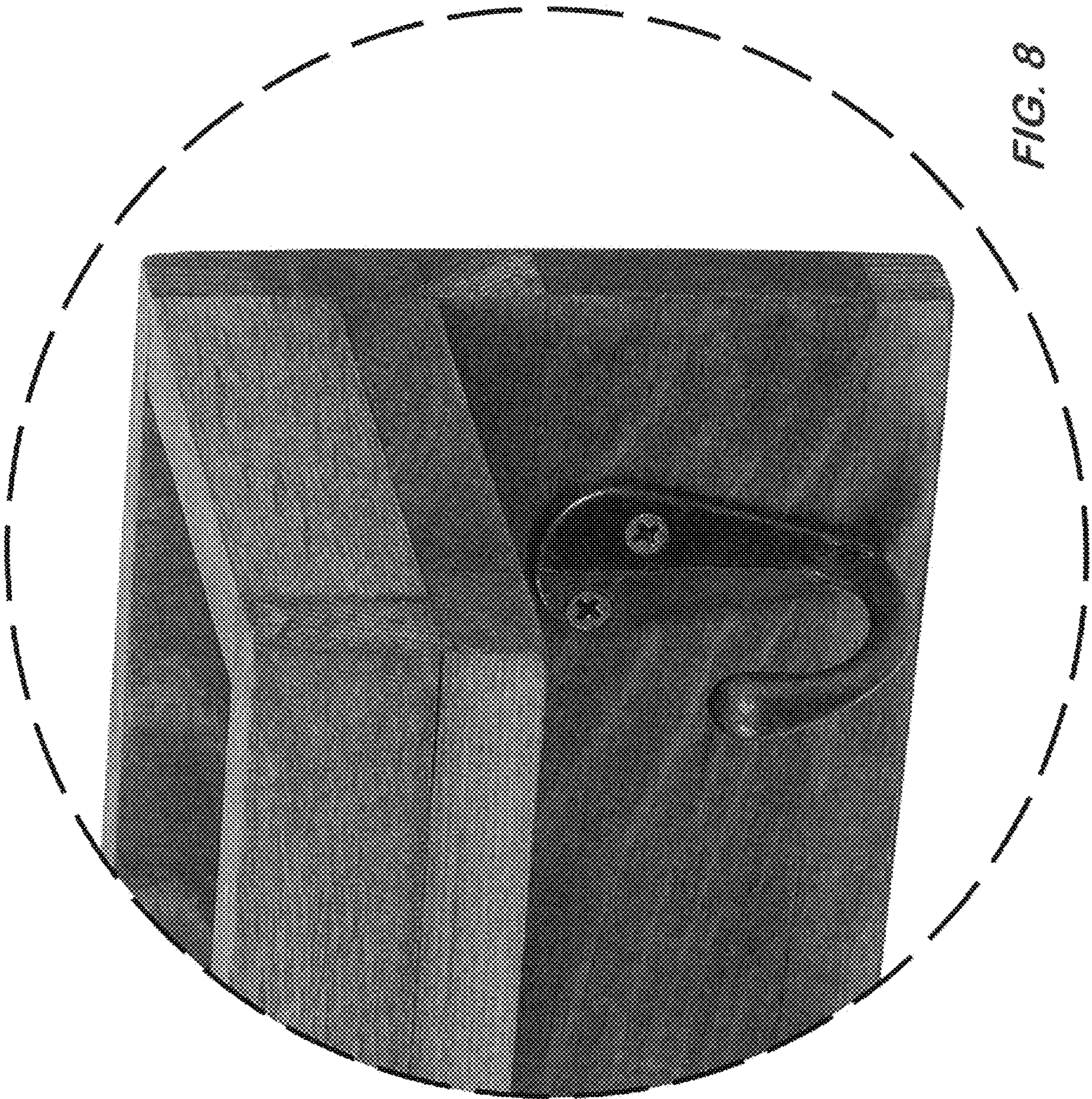
