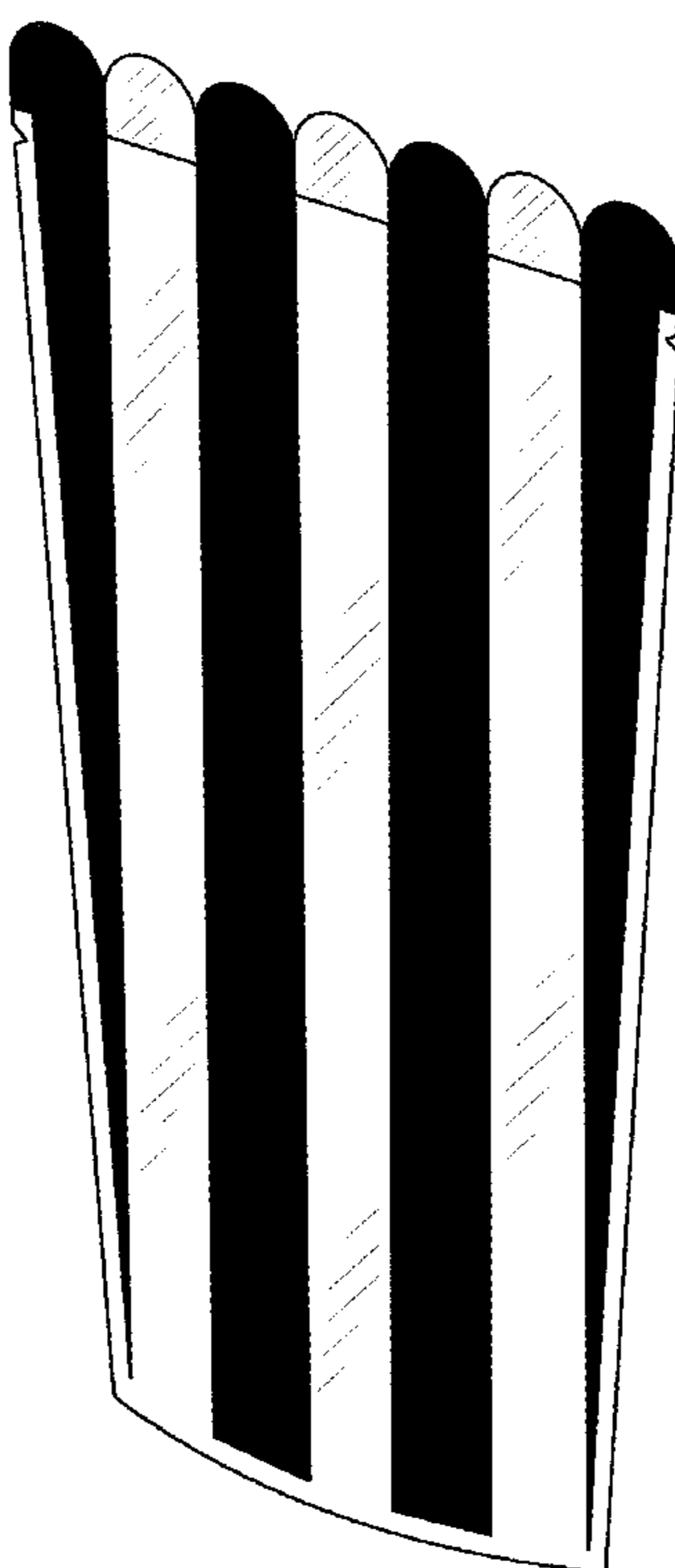

DESCRIPTION

FIG. 1 is a front perspective view of a flexible pouch, showing contrasting regions, embodying our new design; FIG. 2 is a front view thereof showing contrasting regions; FIG. 3 is a rear view thereof showing contrasting regions; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

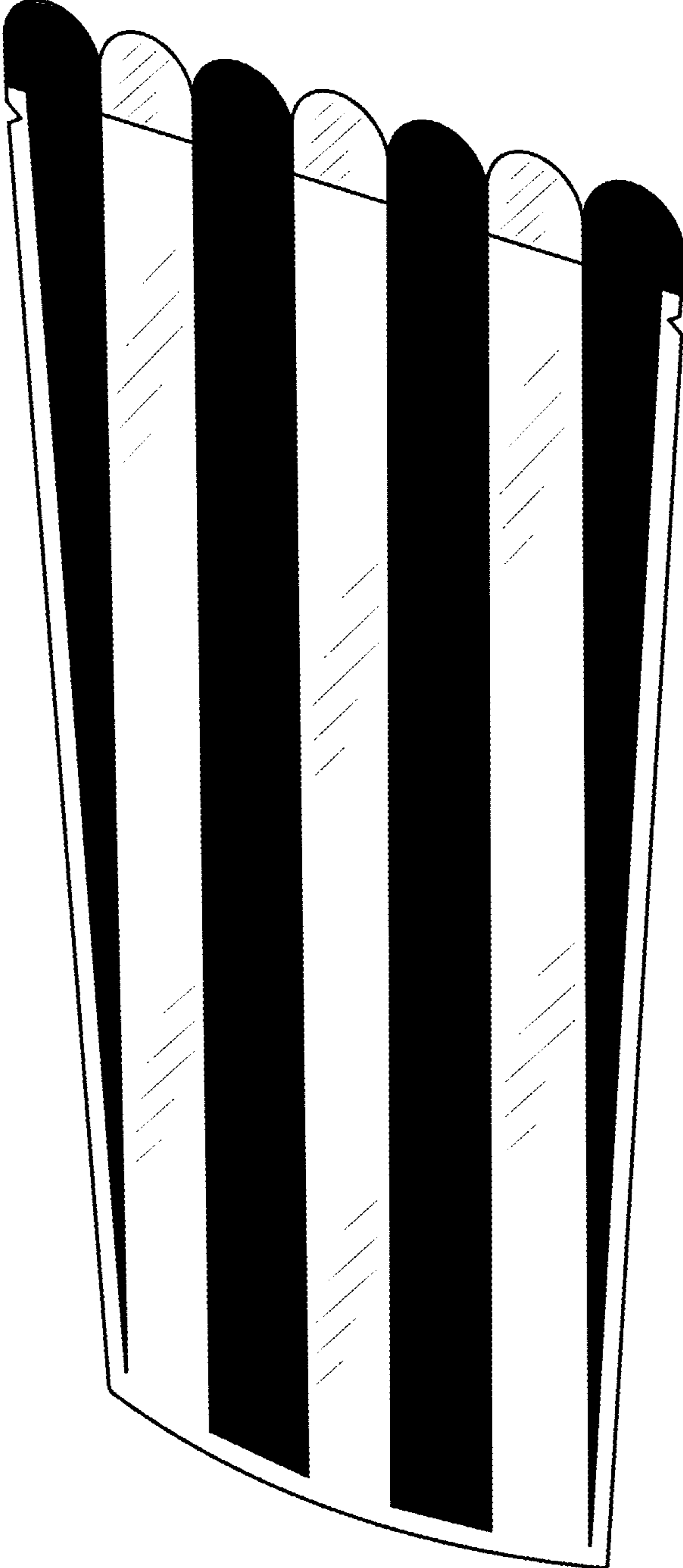

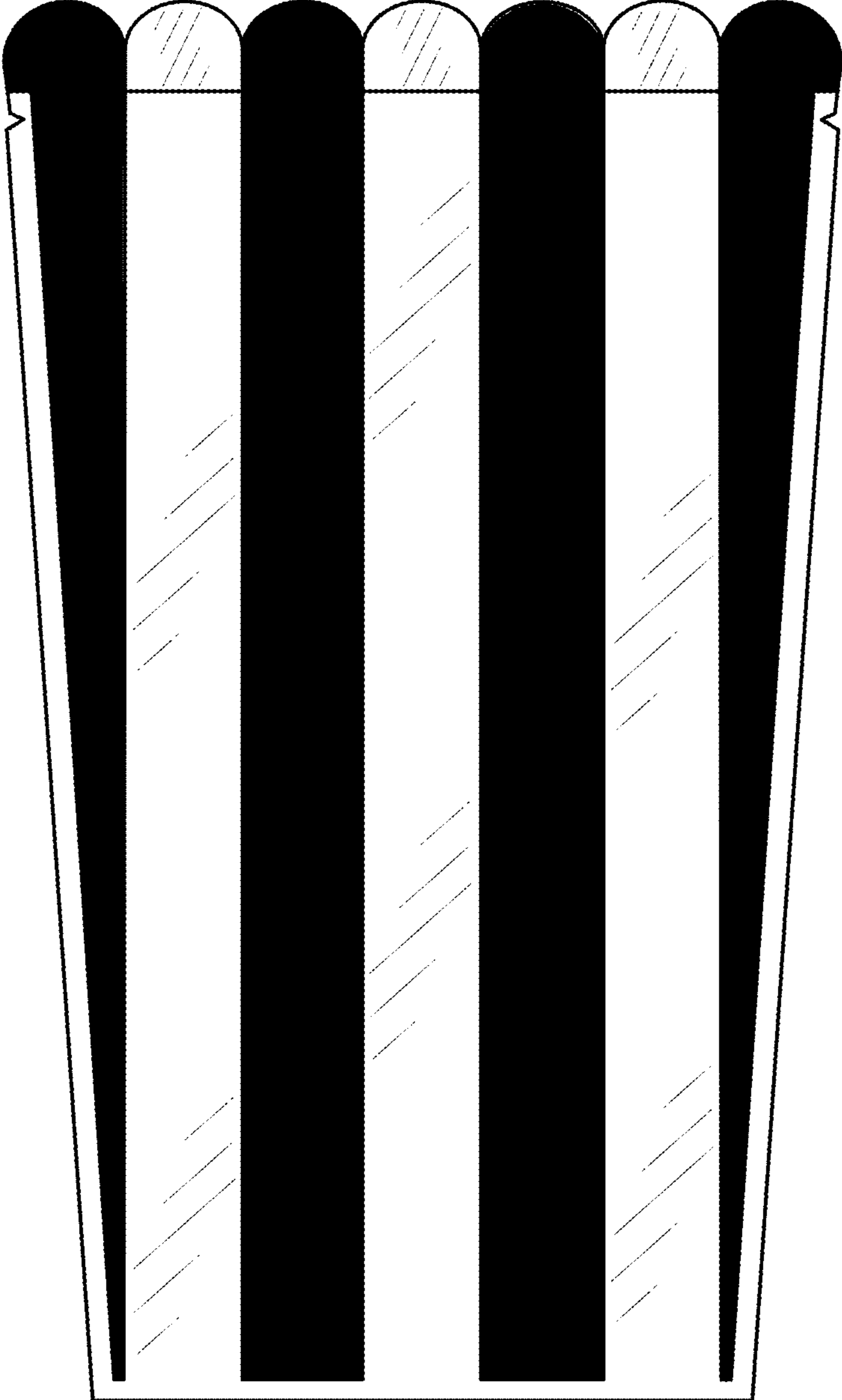

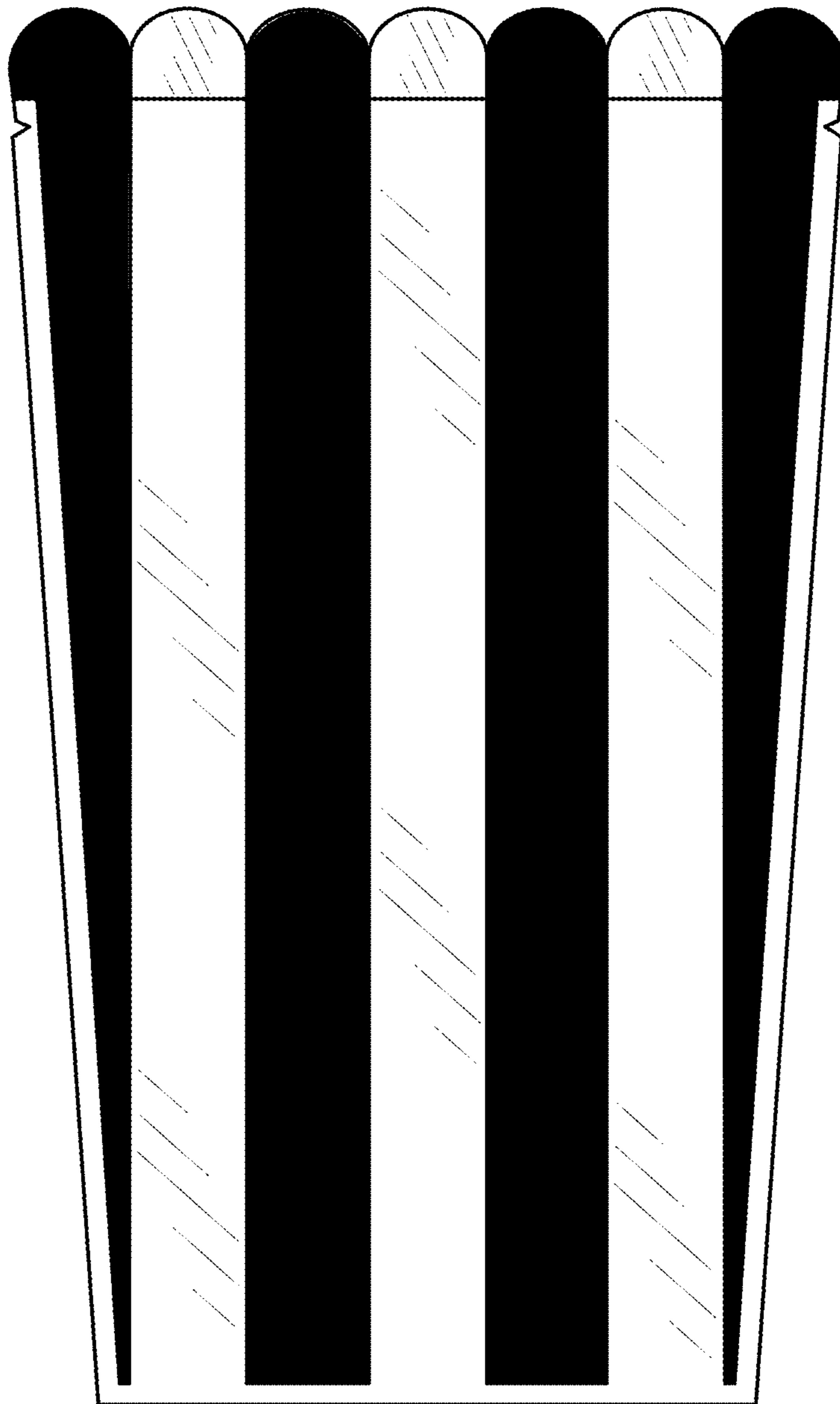

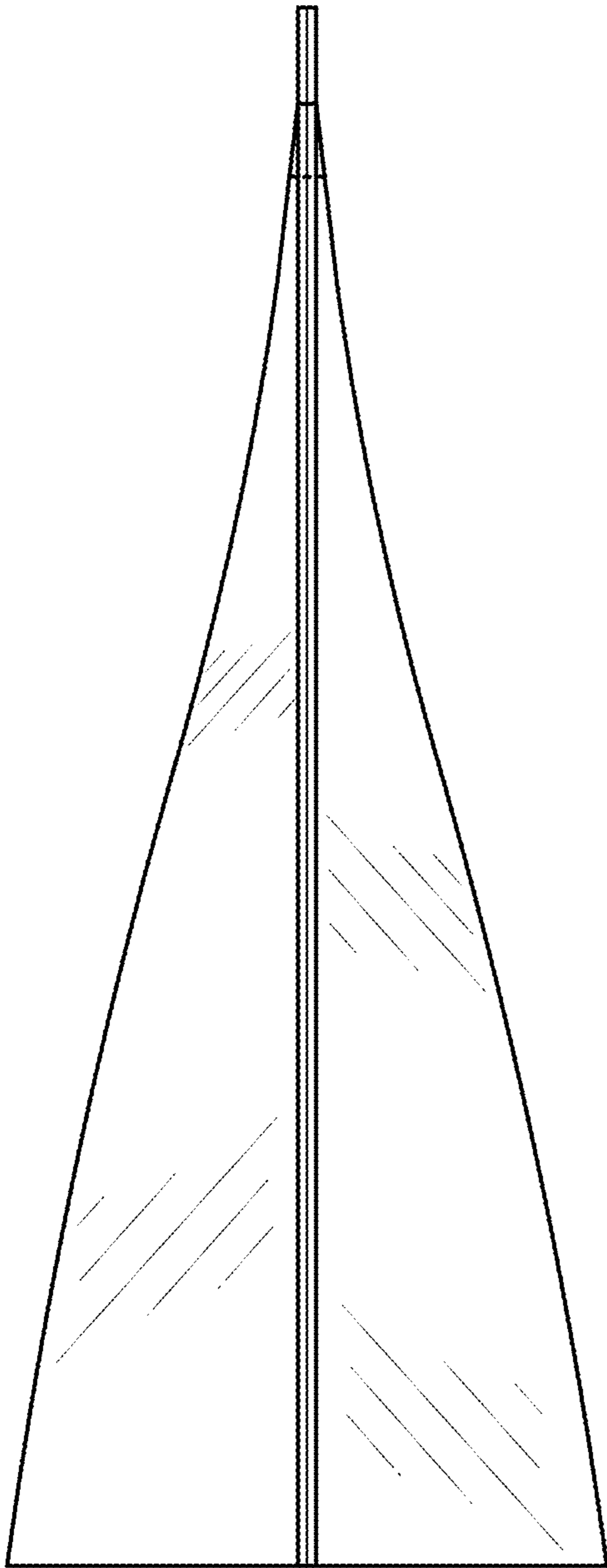

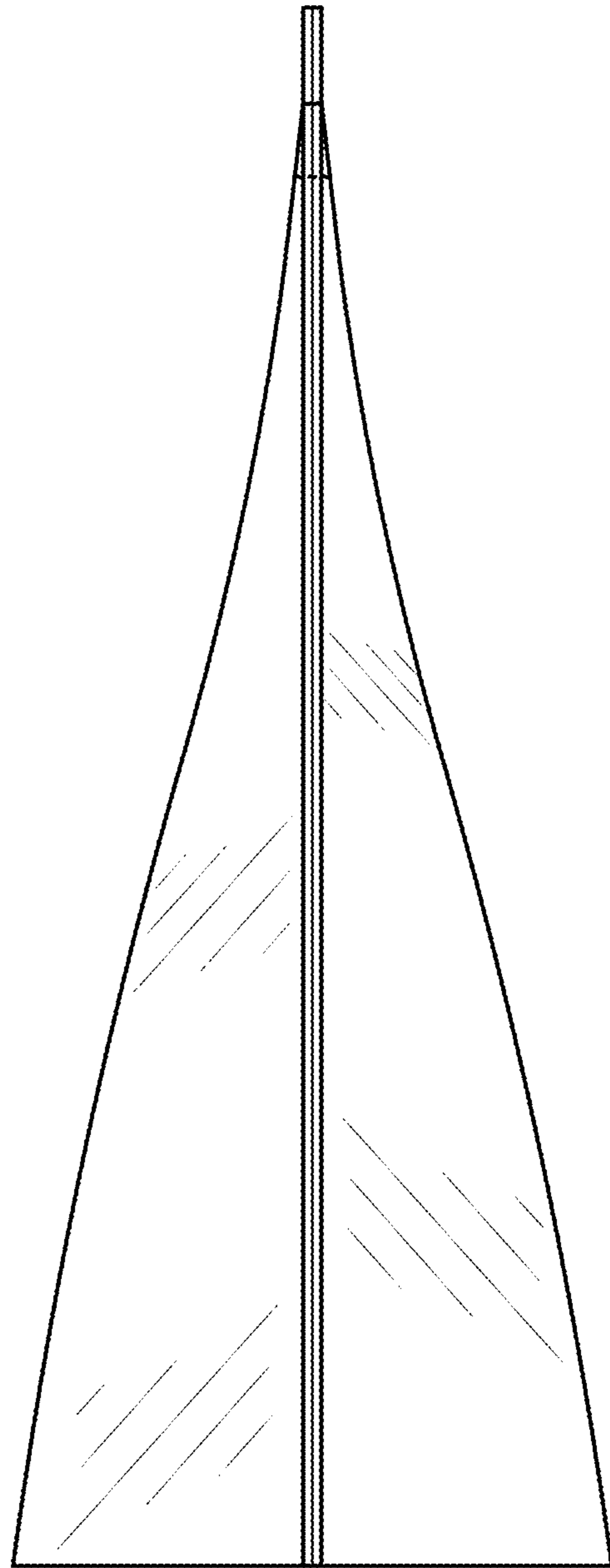

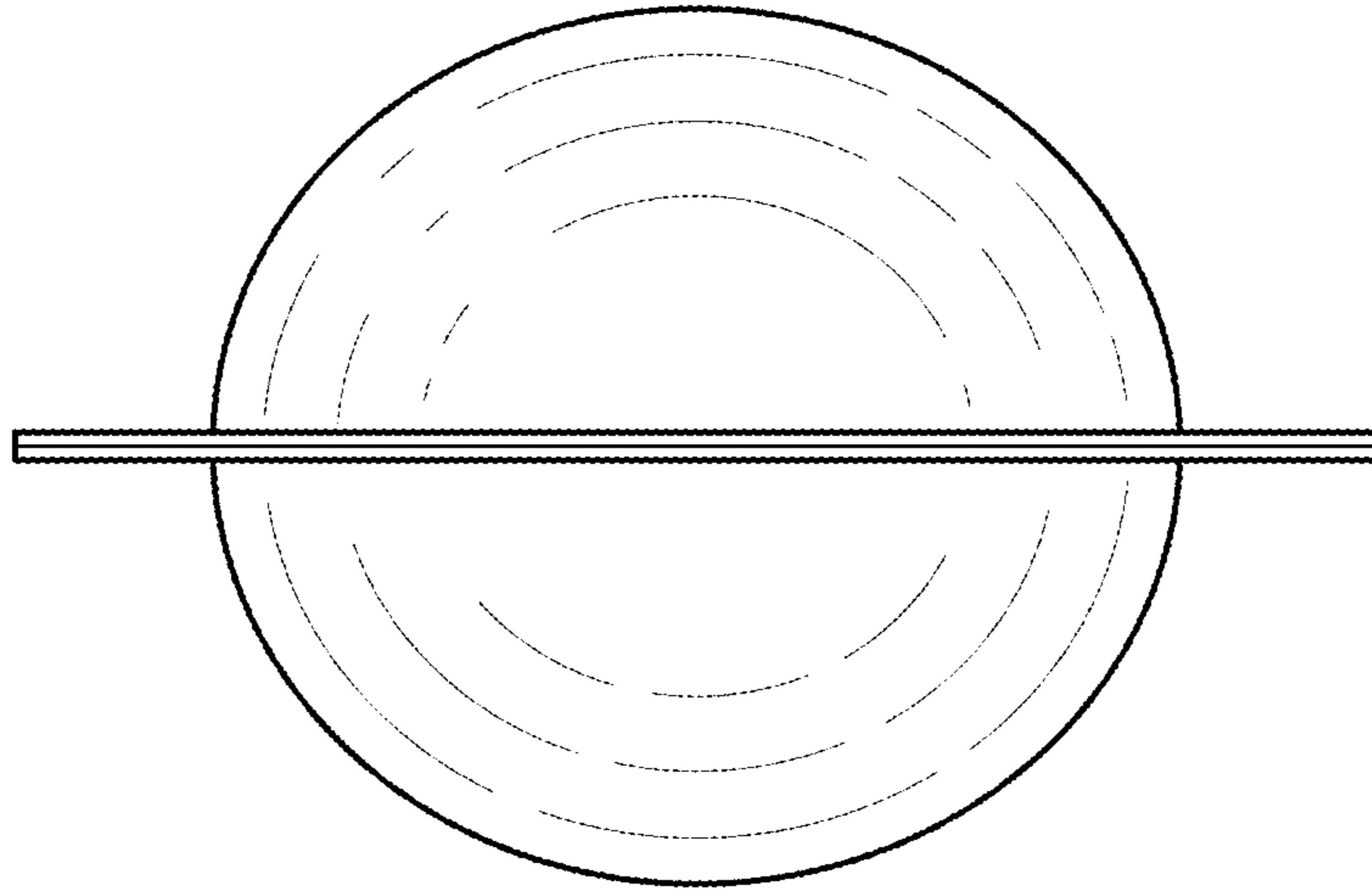

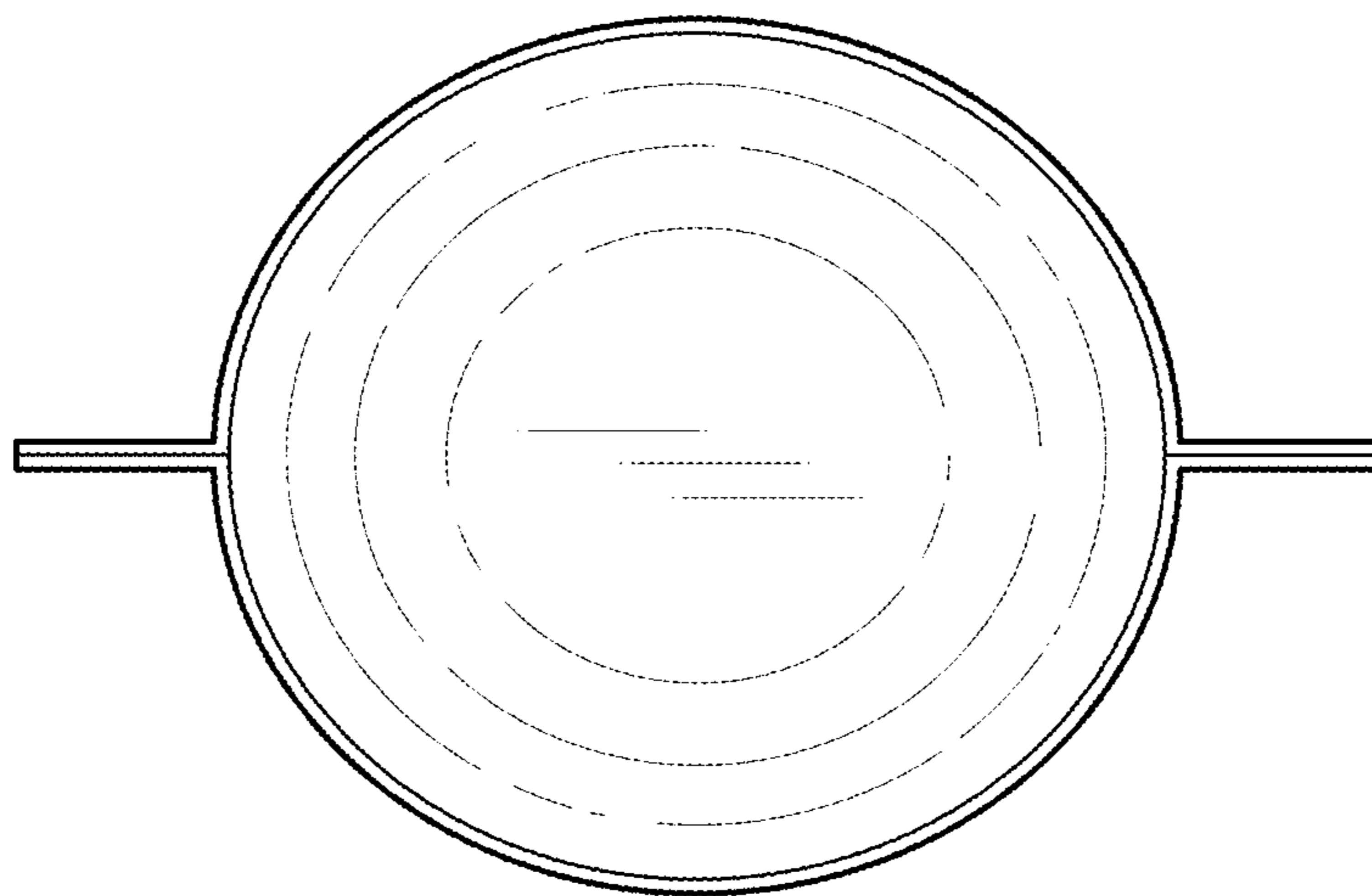
