(57) **CLAIM**

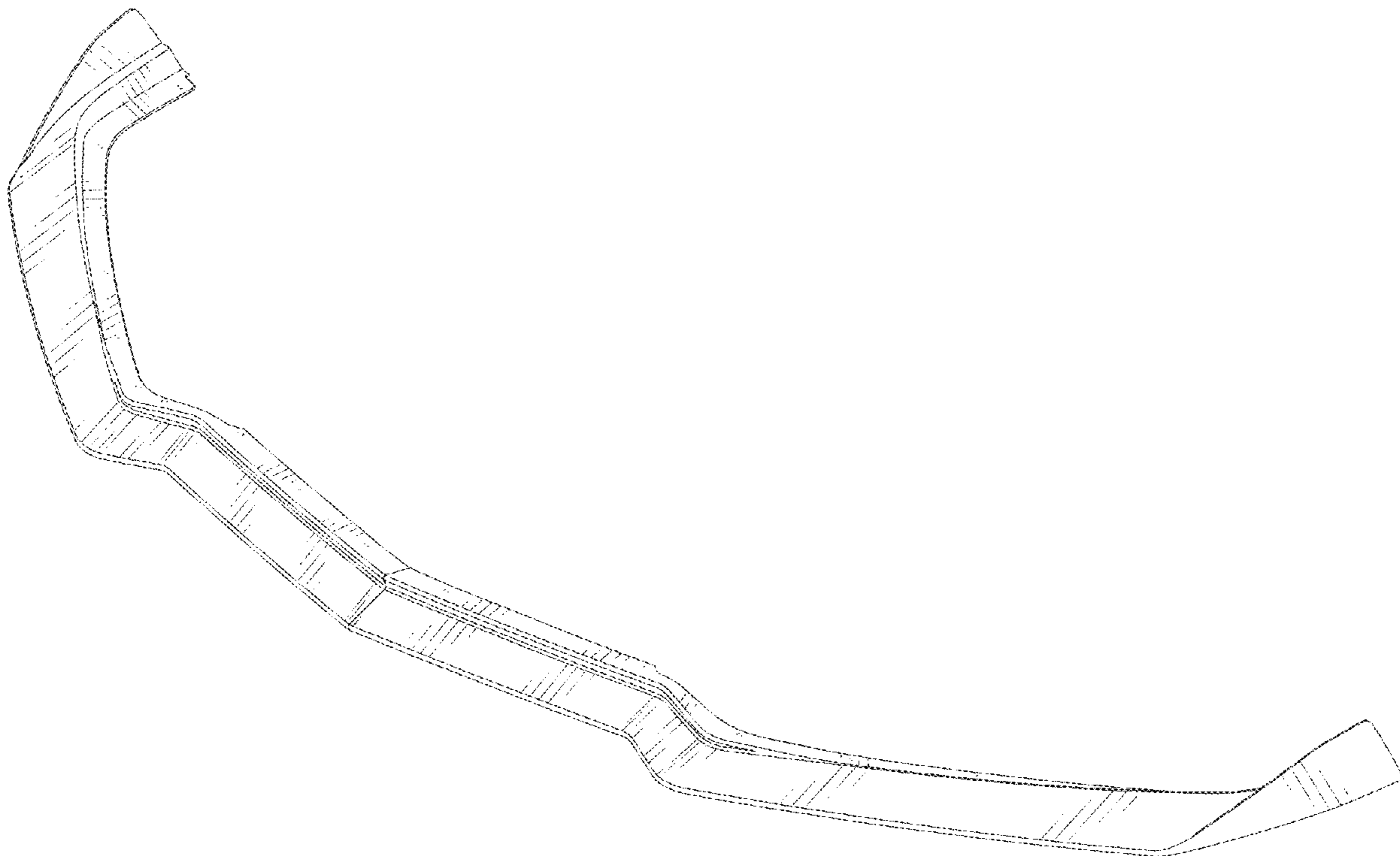
The ornamental design for a front lip splitter, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a front lip splitter showing my new design;
 FIG. 2 is a bottom-front-left perspective view thereof;
 FIG. 3 is a top-rear-right perspective view thereof;
 FIG. 4 is a bottom-rear-right perspective view thereof;
 FIG. 5 is a front elevated view thereof;
 FIG. 6 is a rear elevated view thereof;

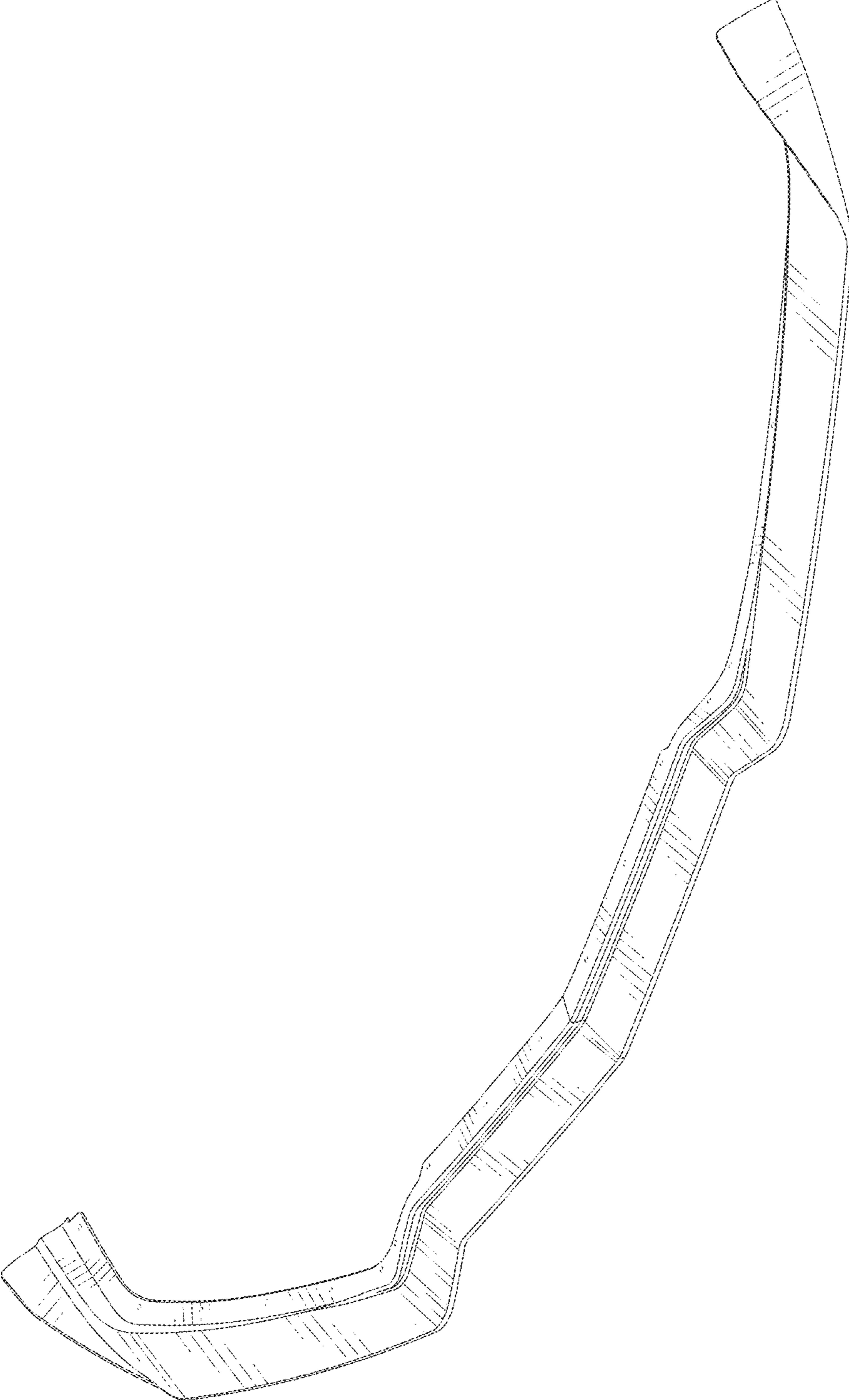

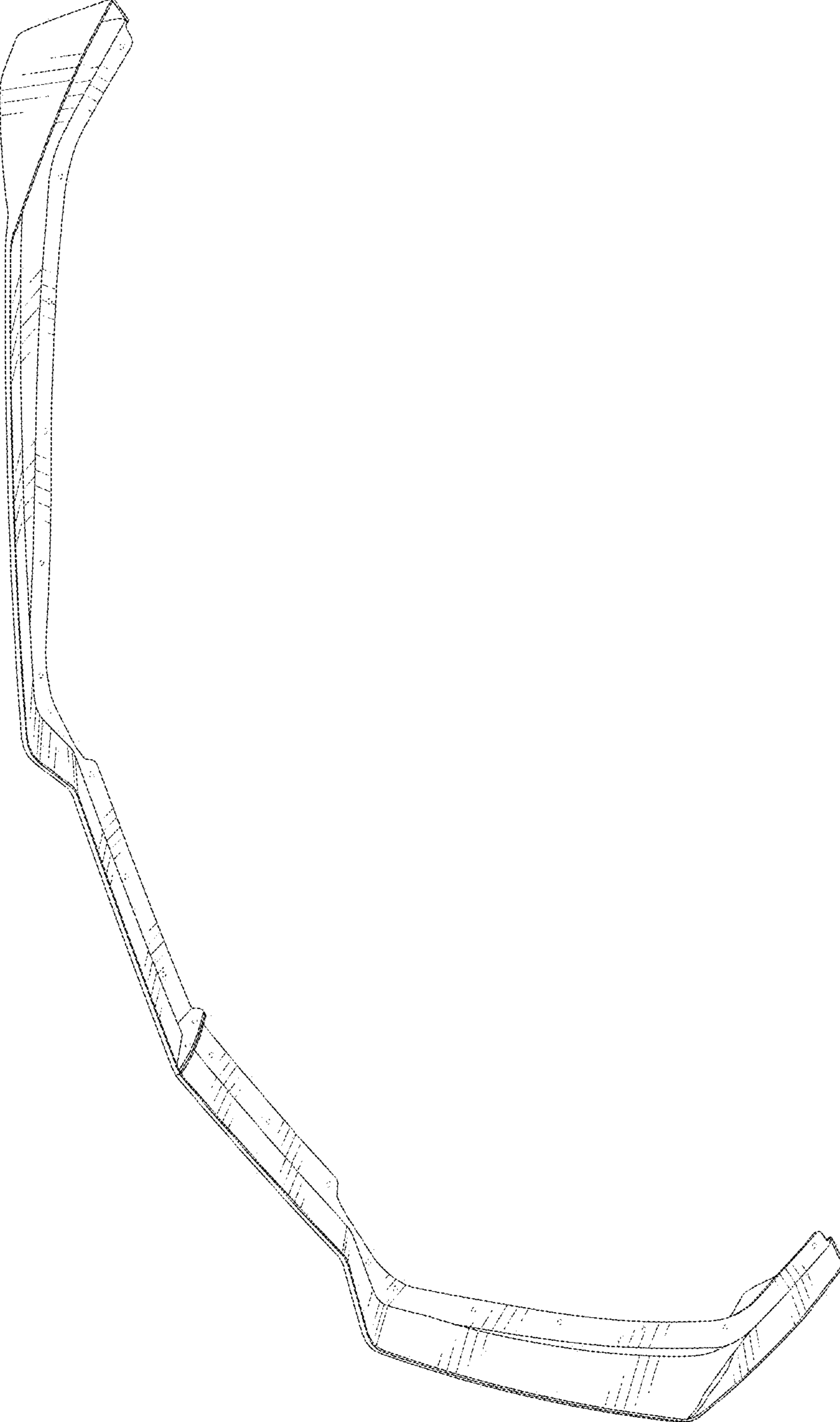

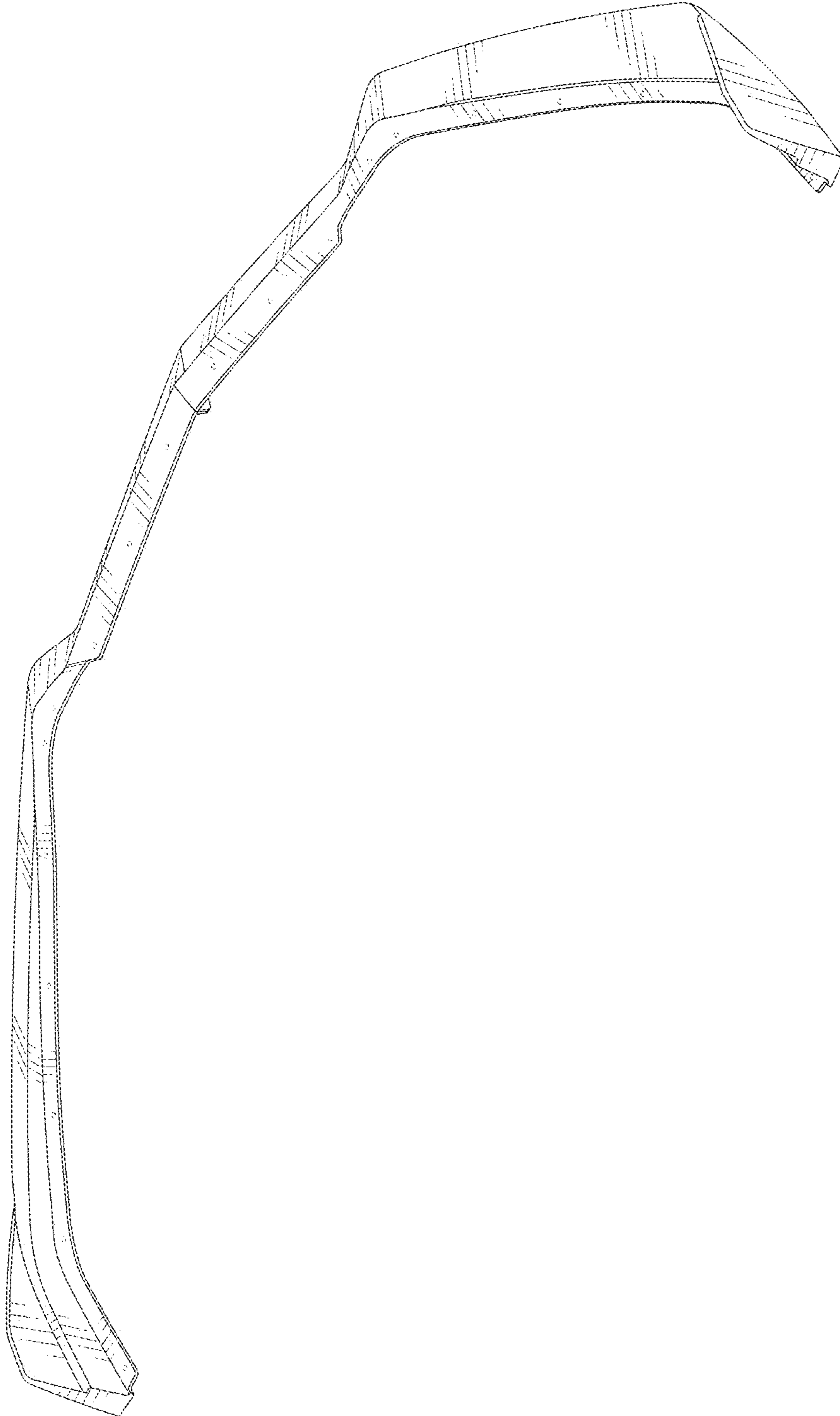

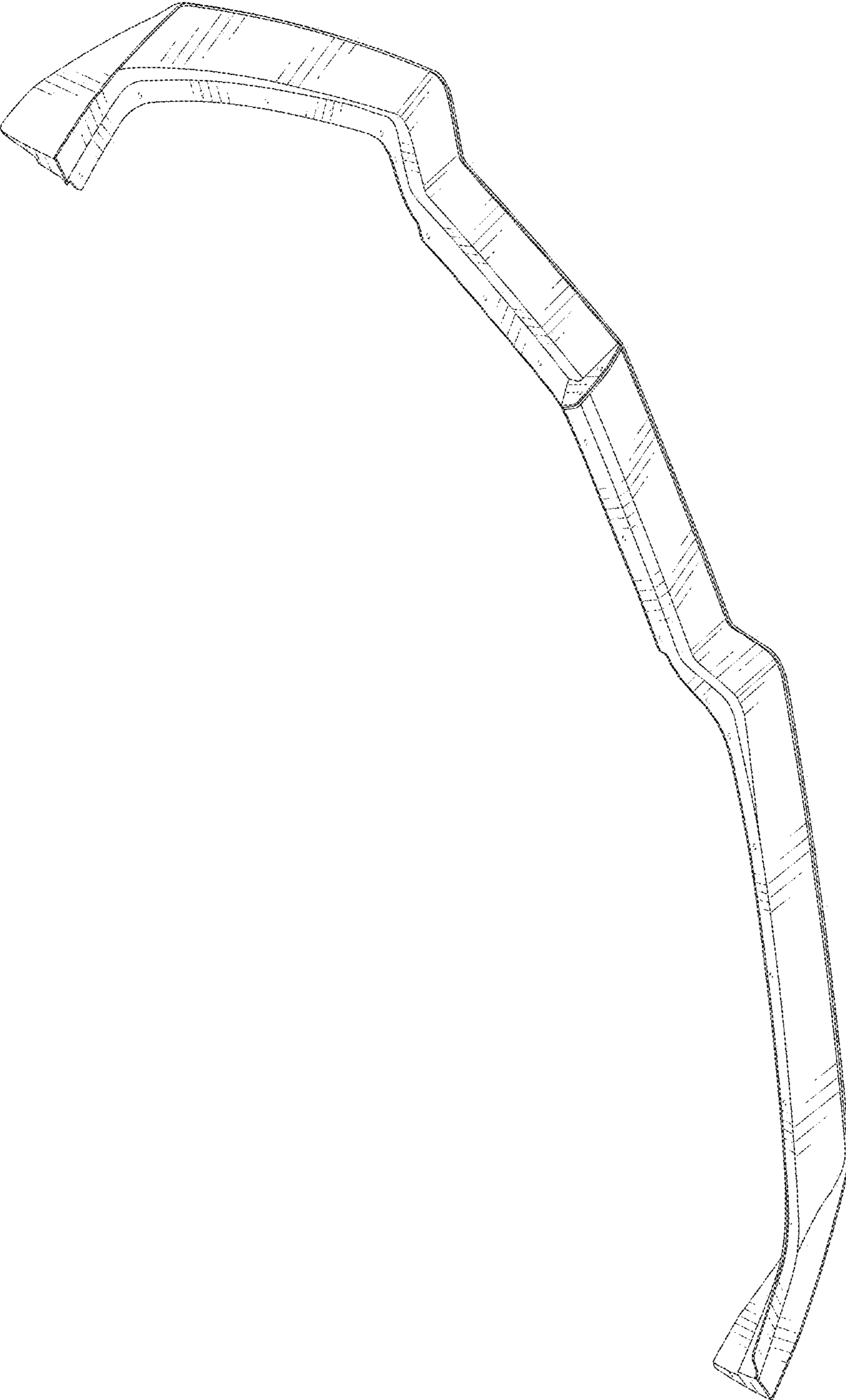

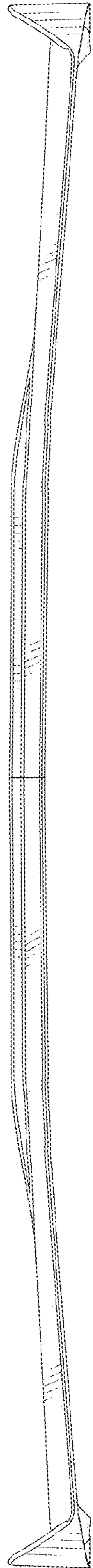

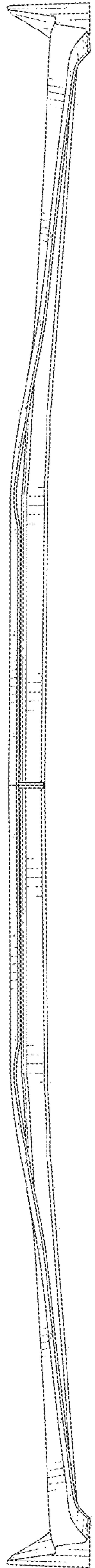

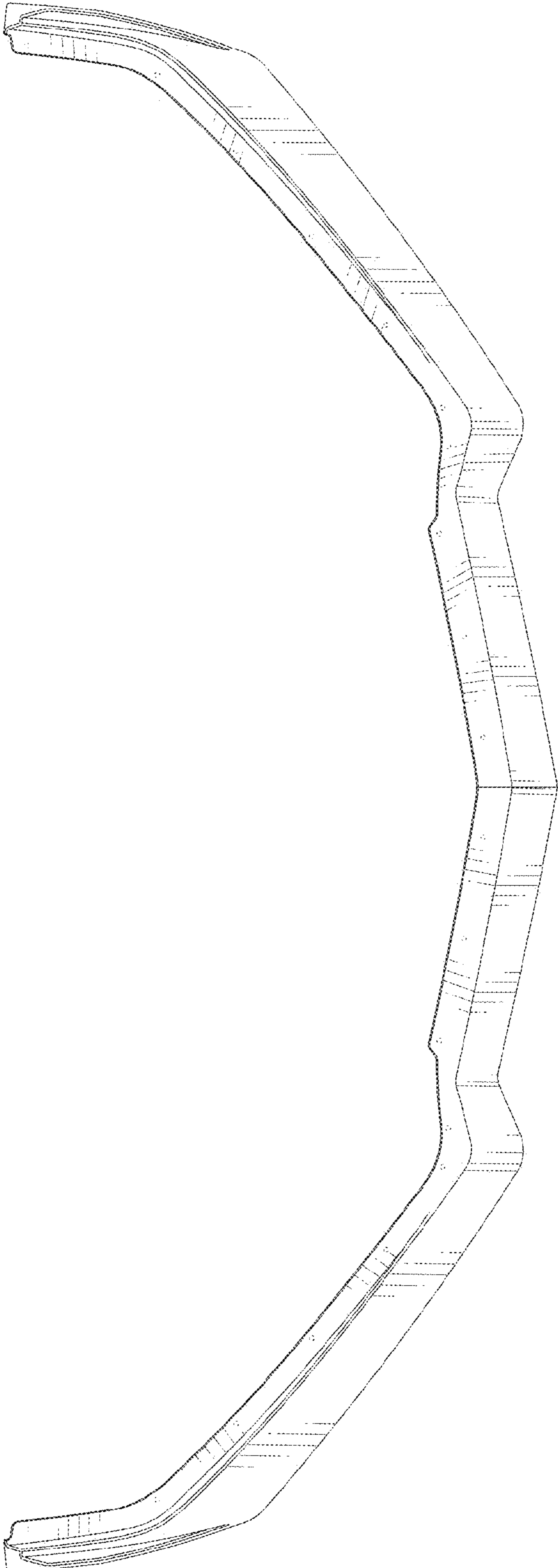

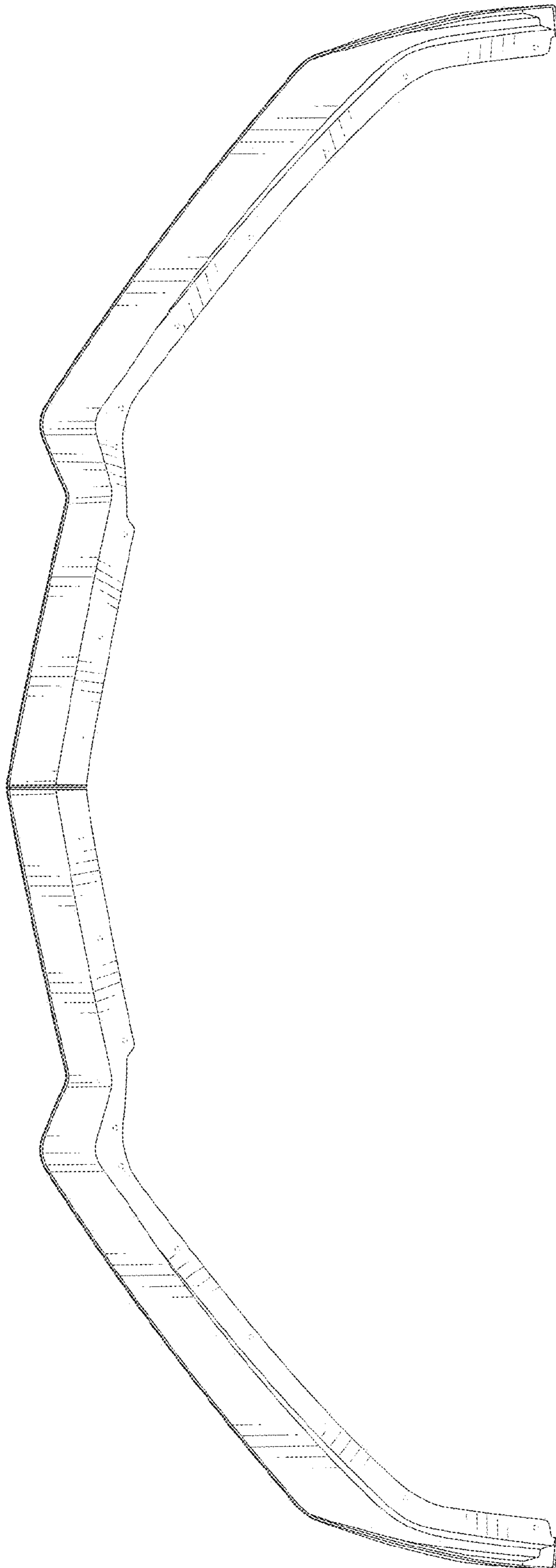

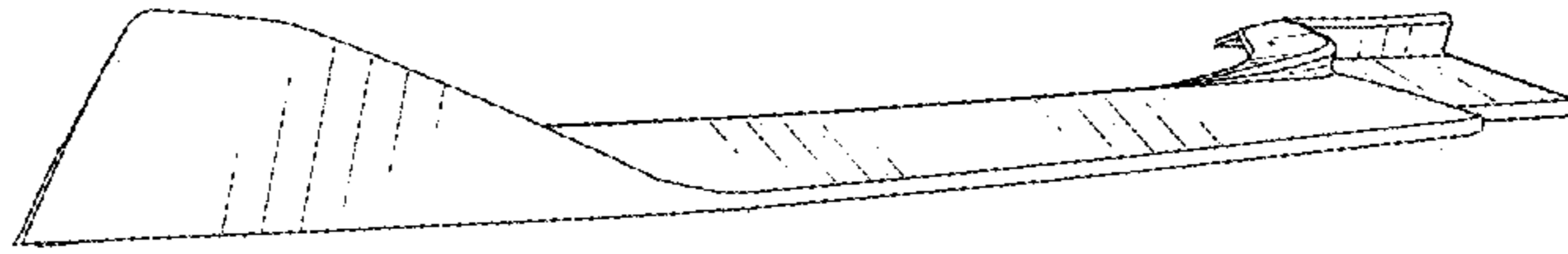

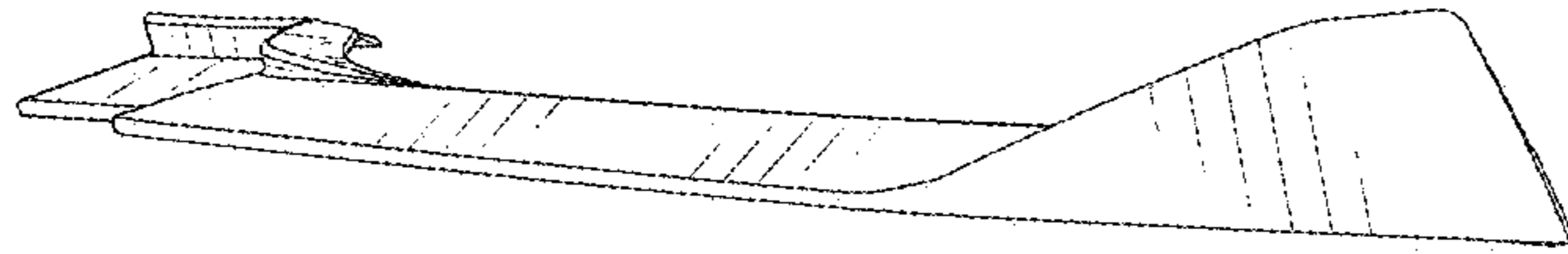
