The ornamental design for a vehicle grille cover, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a vehicle grille cover, showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 4 is a right side elevational view thereof.

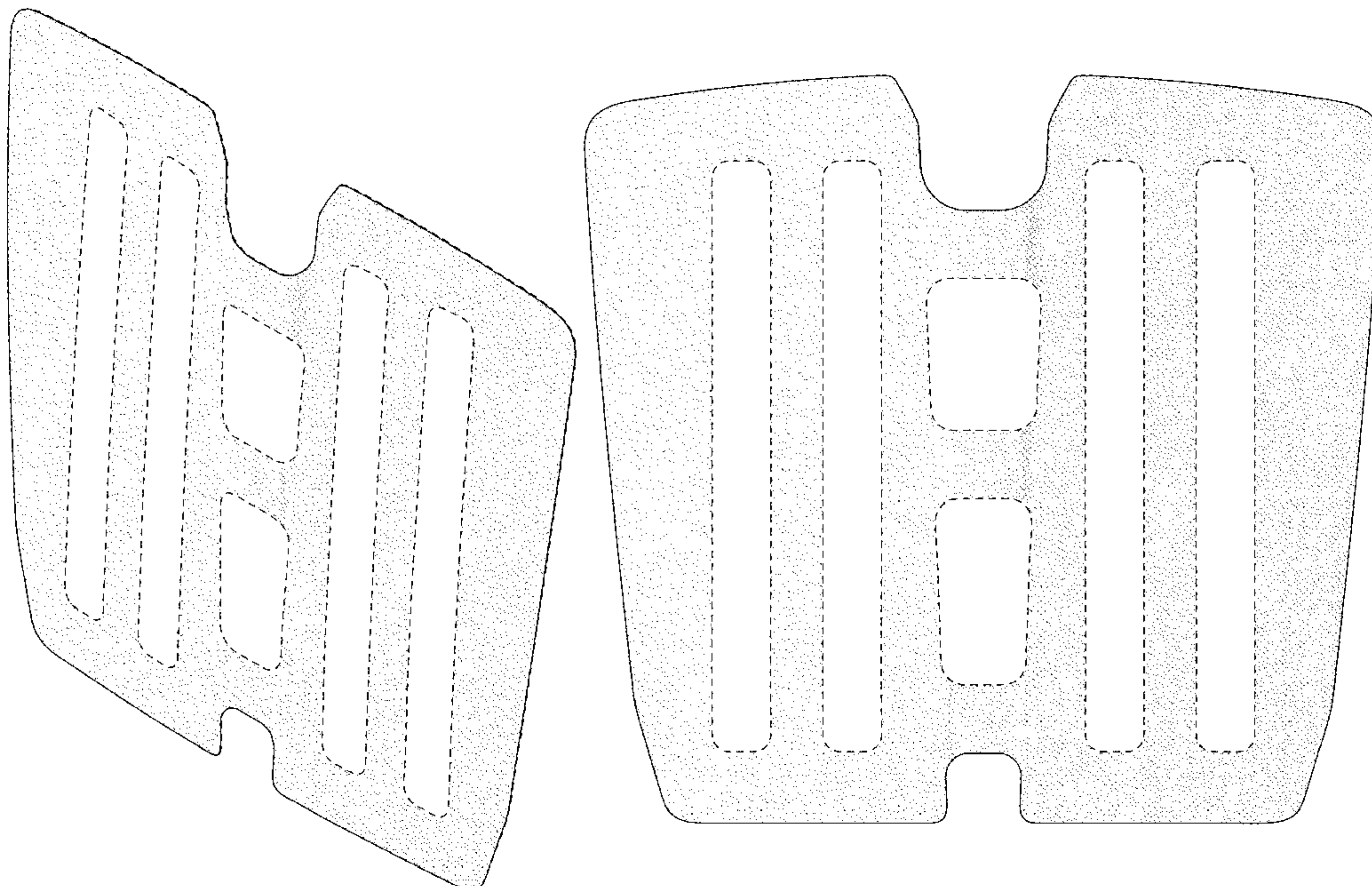
FIG. 5 is a left side elevational view thereof.

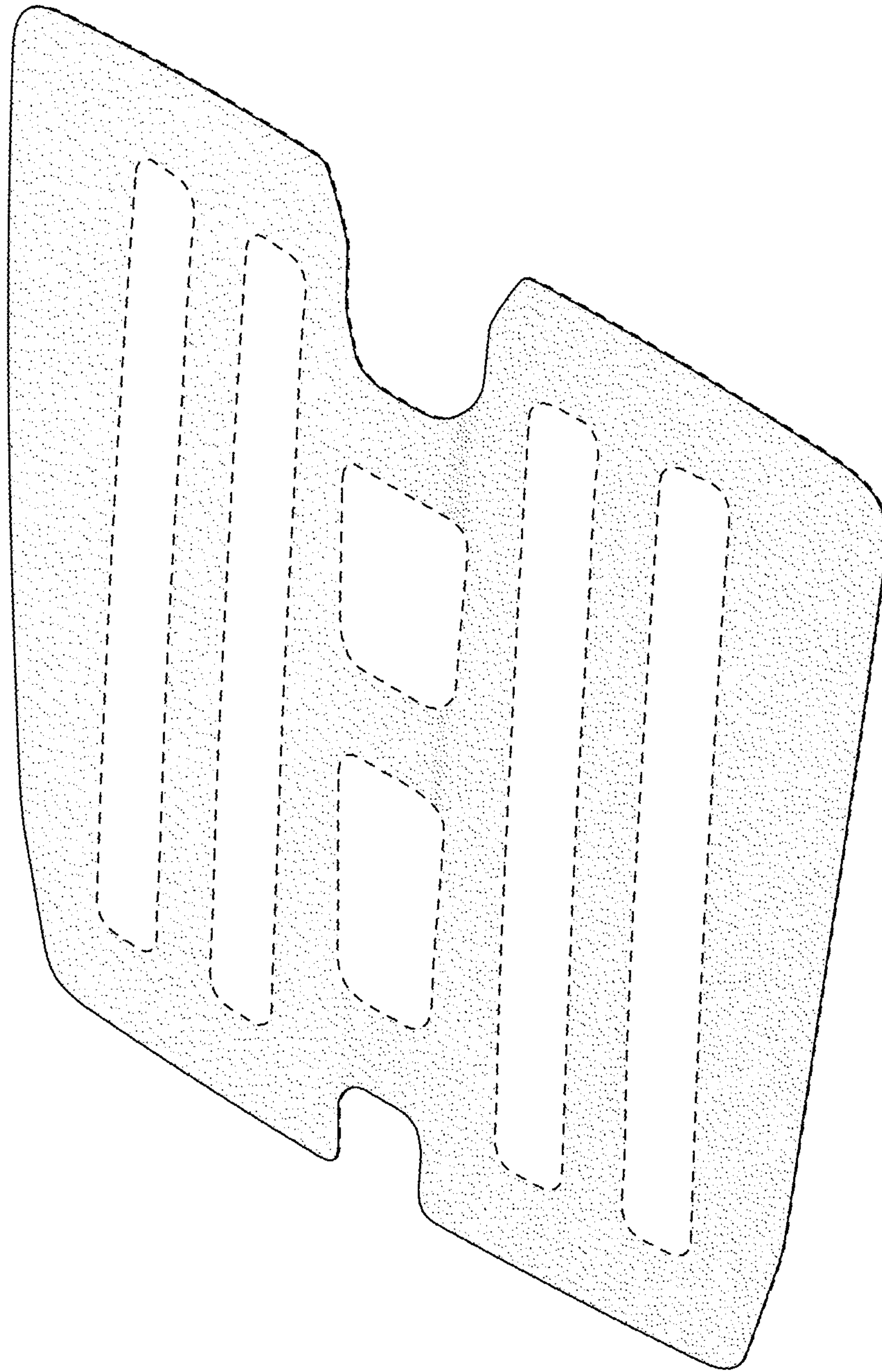

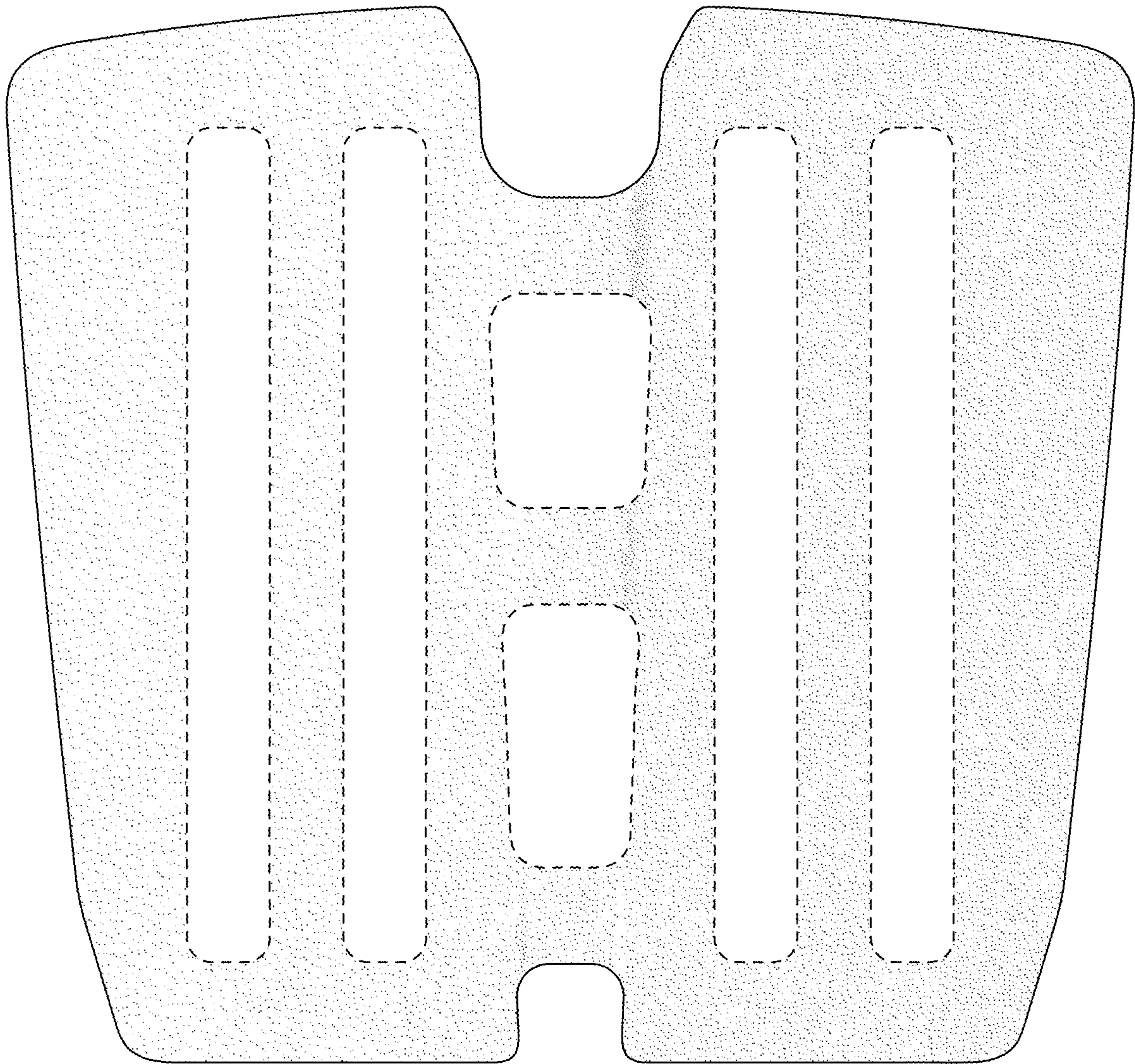

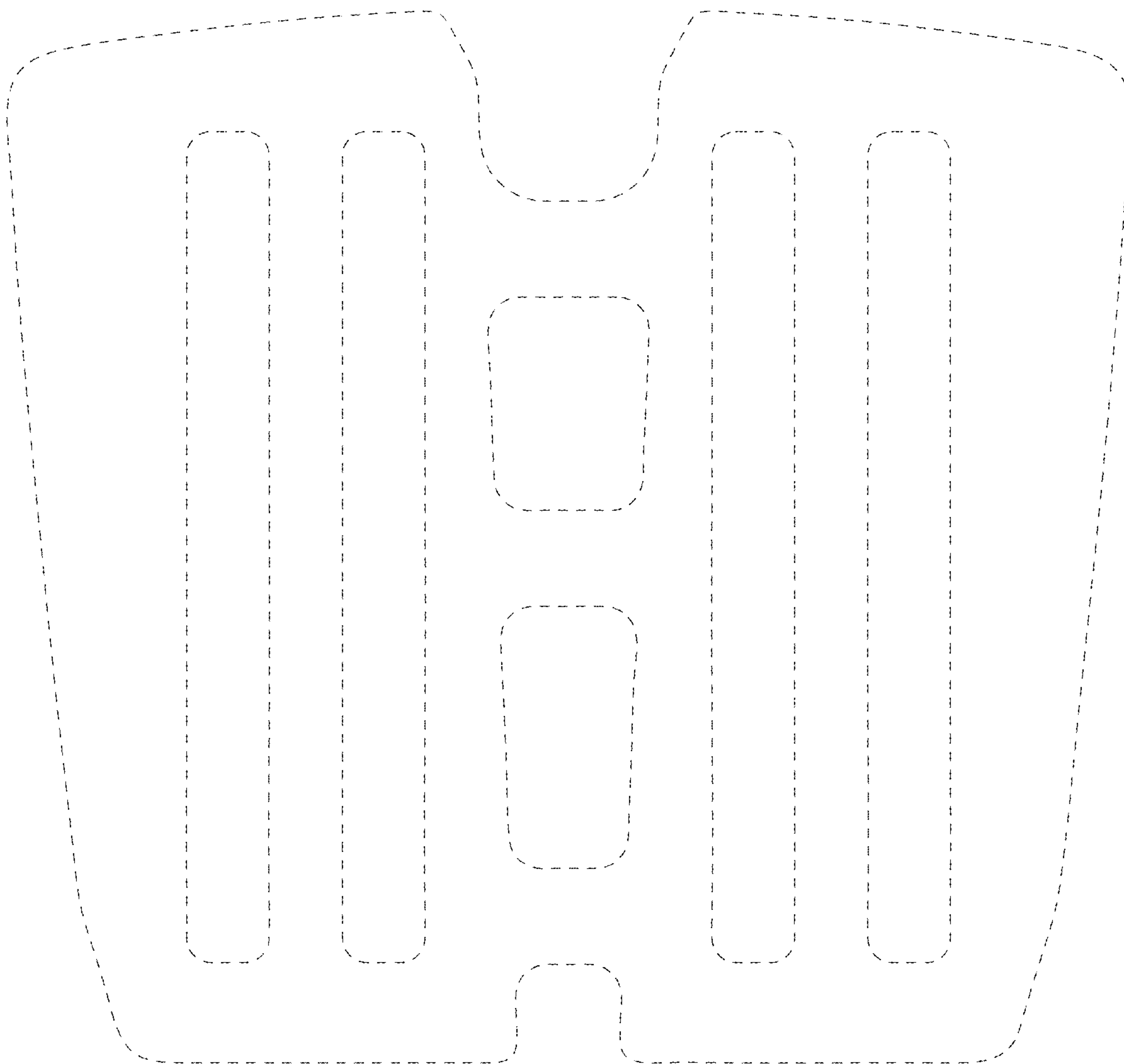

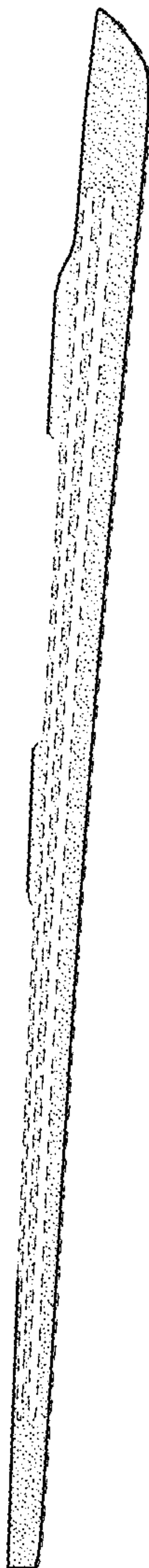

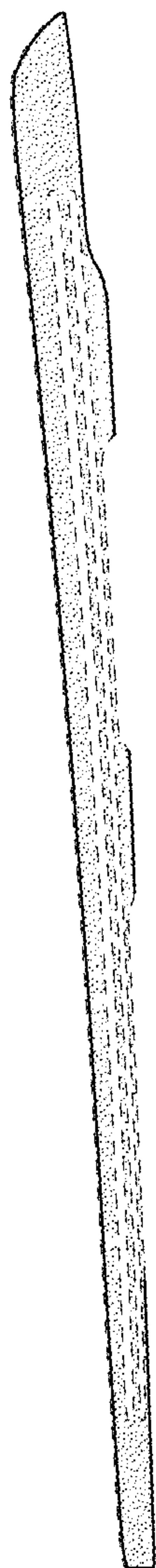

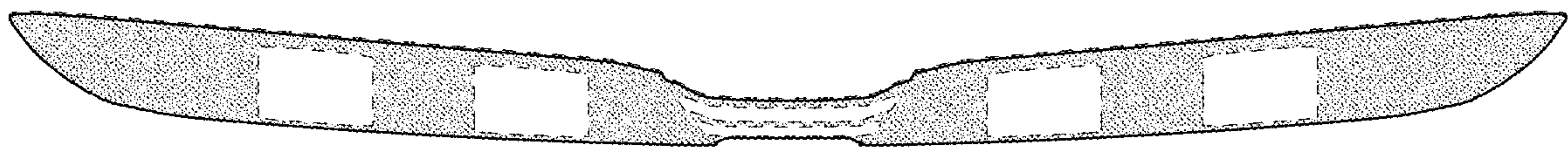

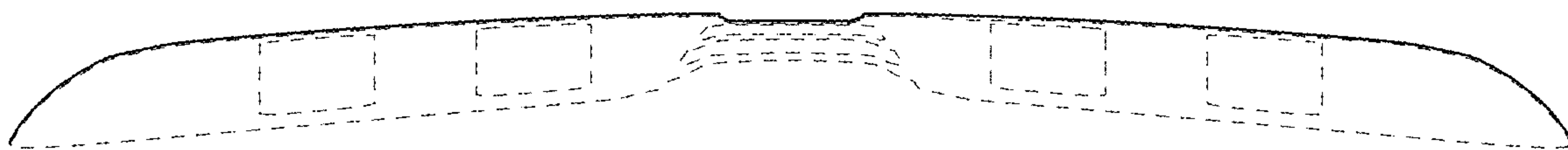
