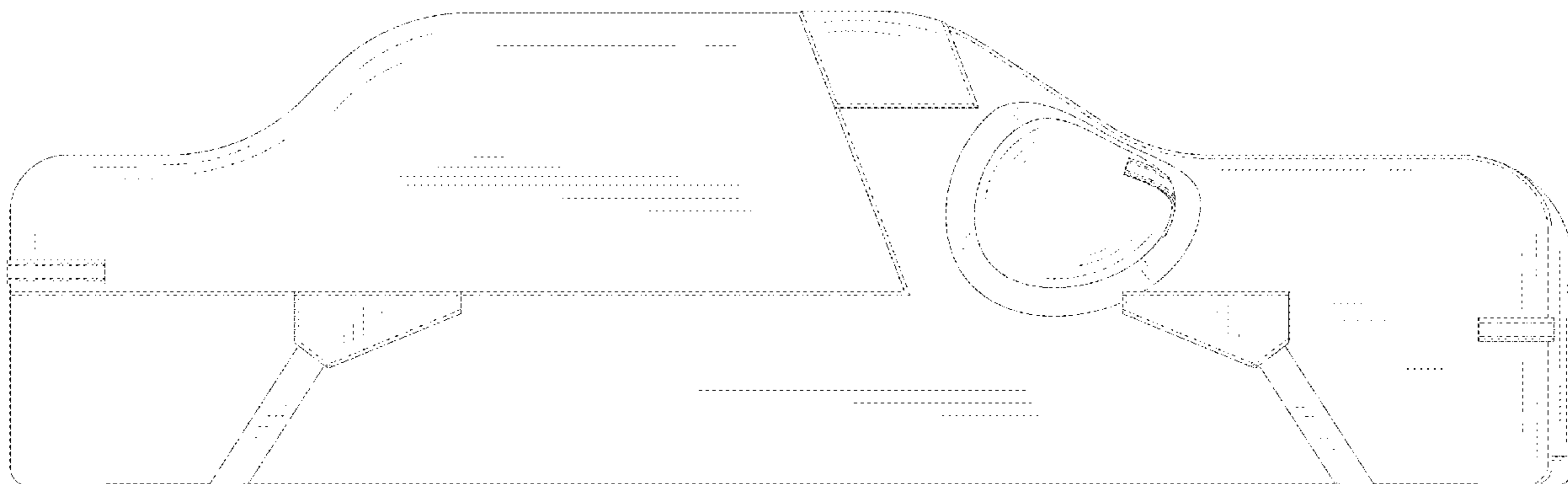
The ornamental design for a coop car cover, as shown and described.

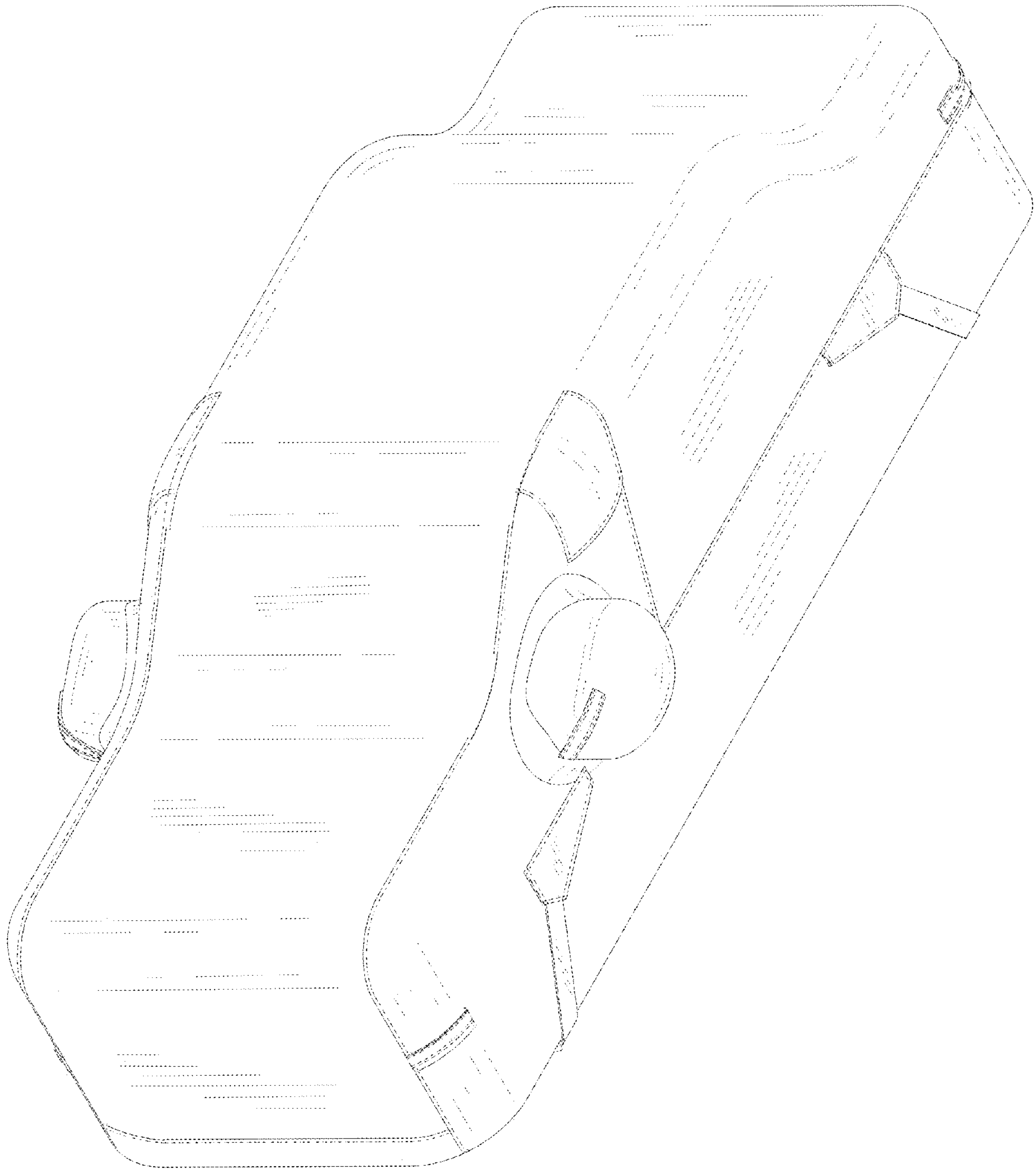

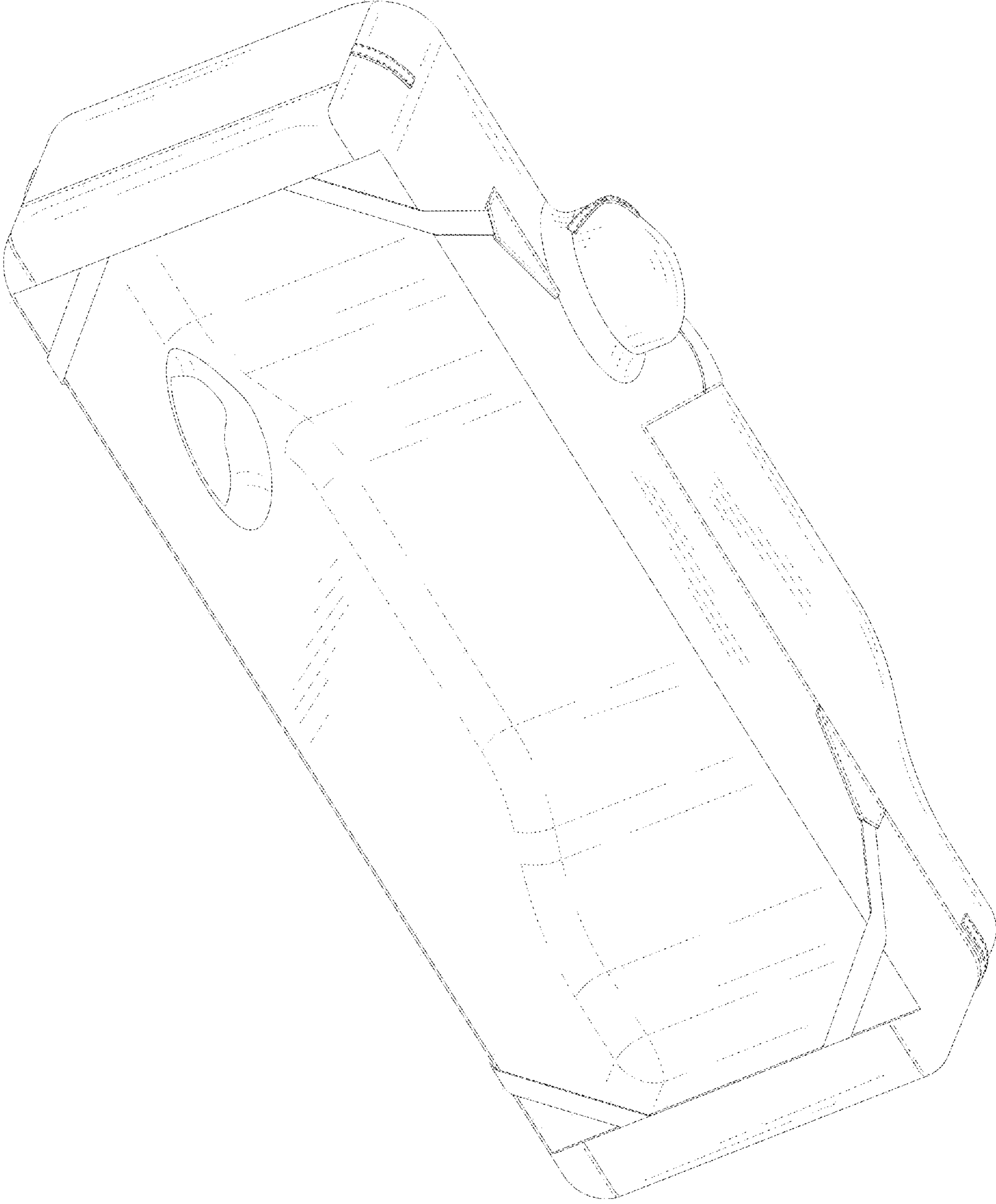

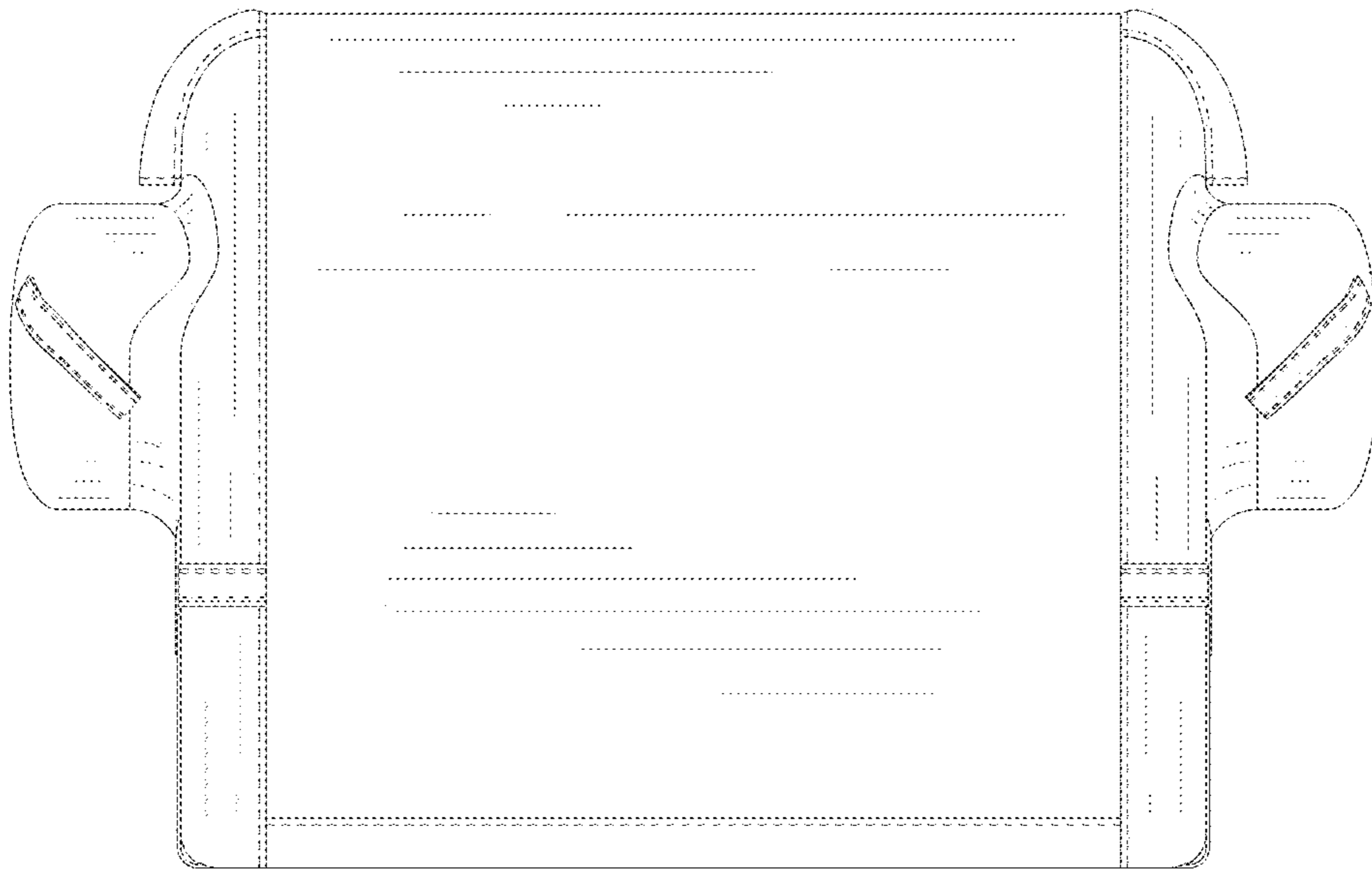

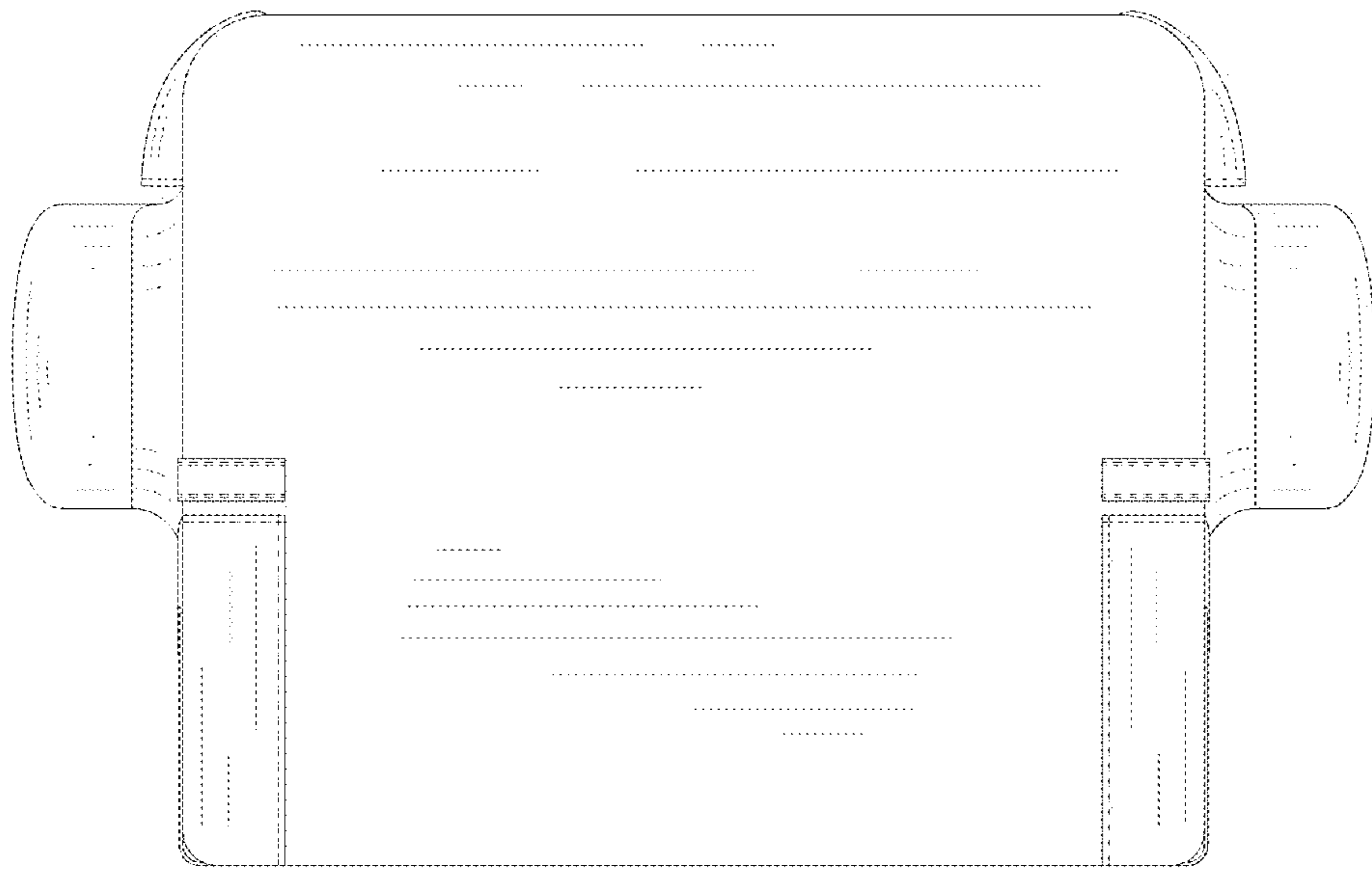

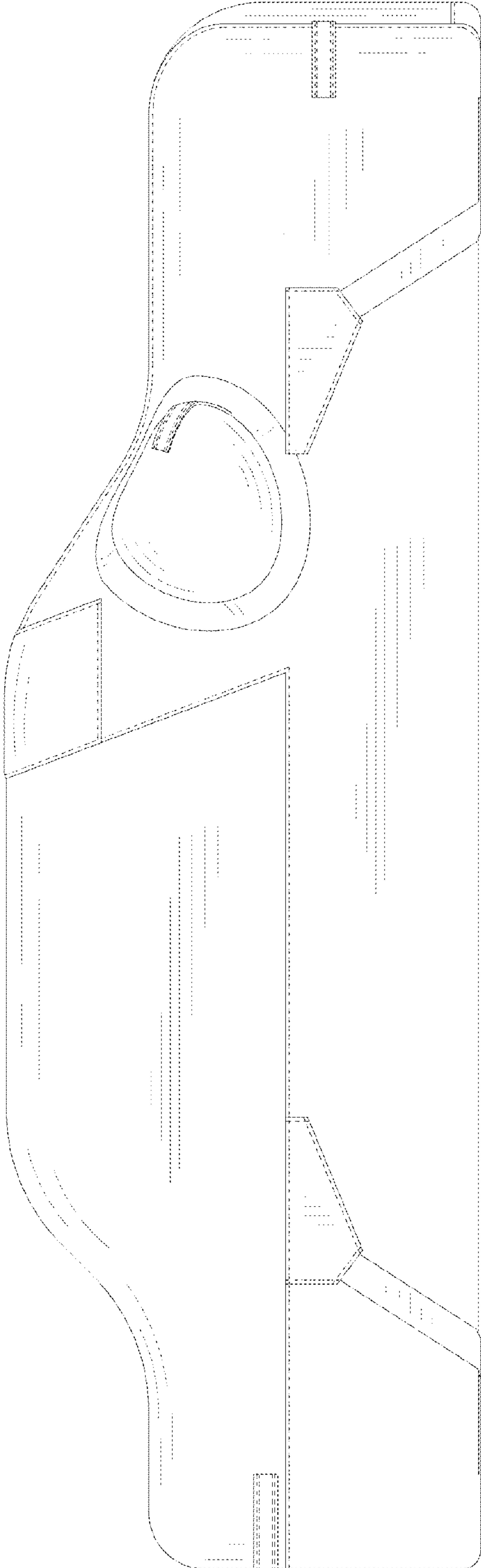

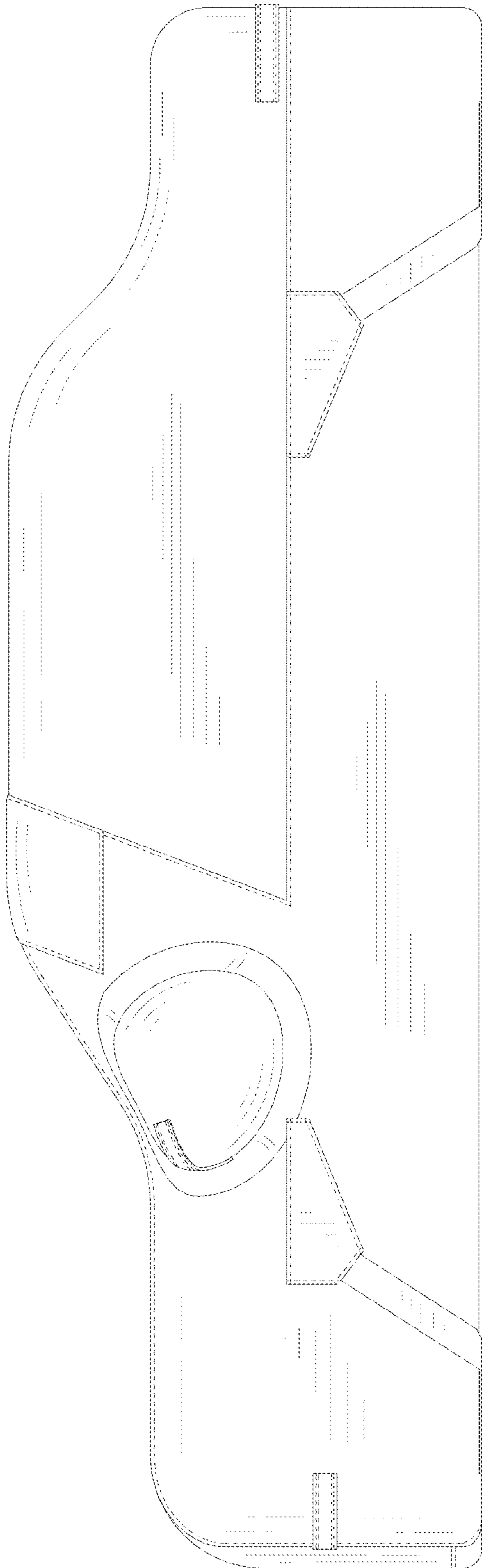

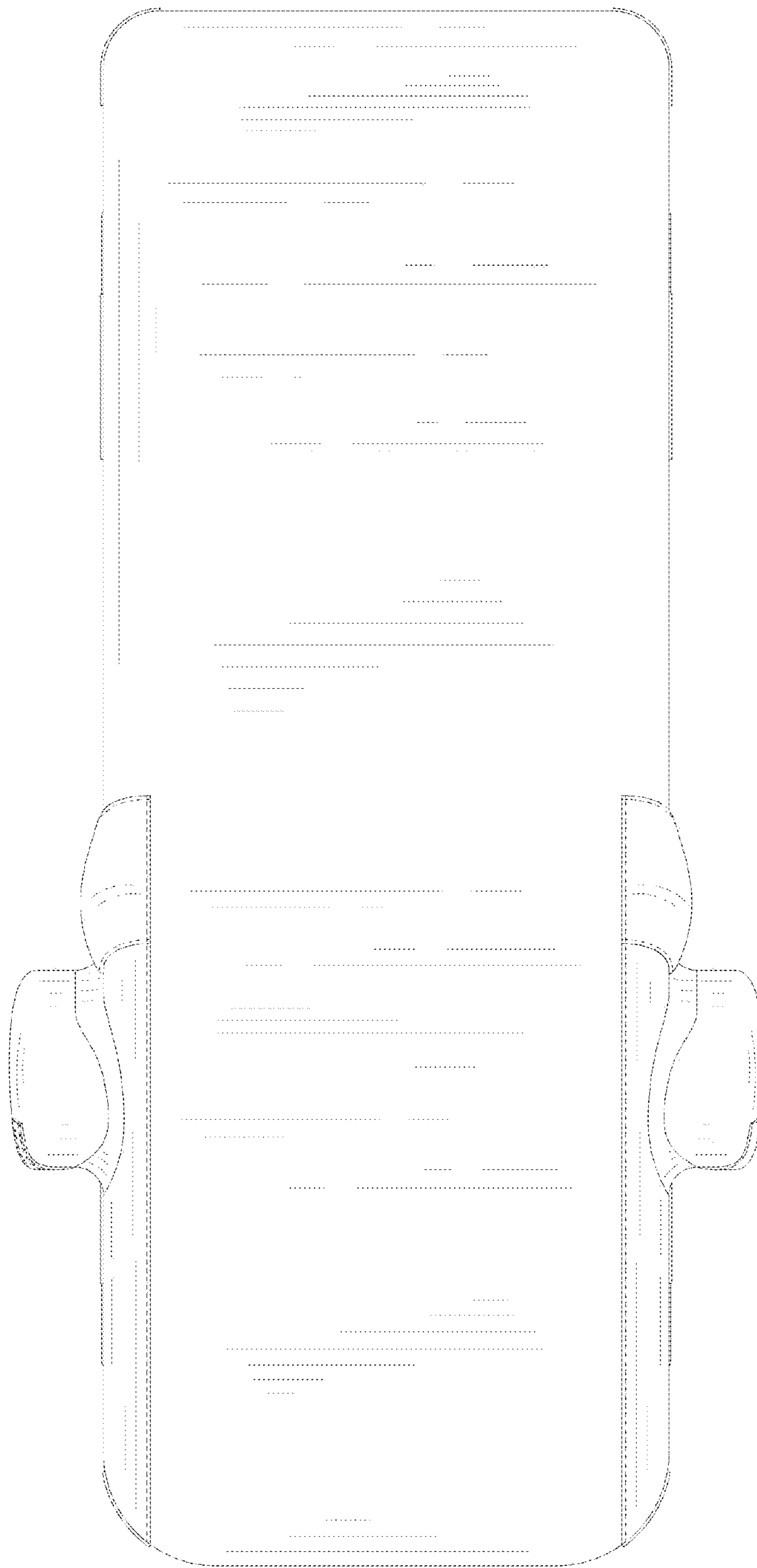

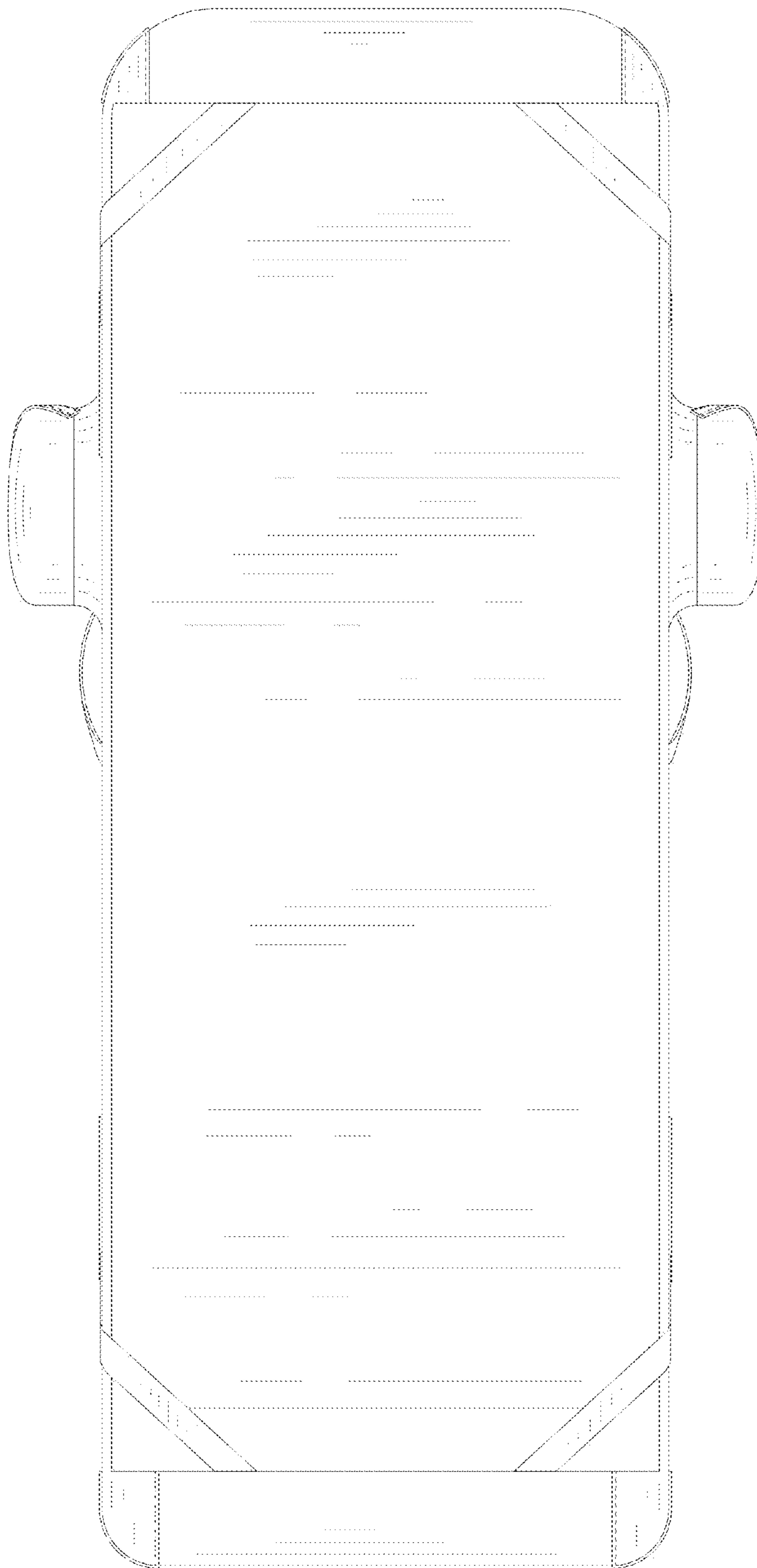
