(57) **CLAIM**

The ornamental design for a rectifier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a rectifier showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top view thereof, the bottom view being a mirror image;  
FIG. 5 is a right side view thereof, the left side view being a mirror image; and,  
FIG. 6 is a cross-sectional view thereof taken along a section line A-A of FIG. 3.  
The broken lines shown represent the portions of the rectifier that form no part of the claimed design.

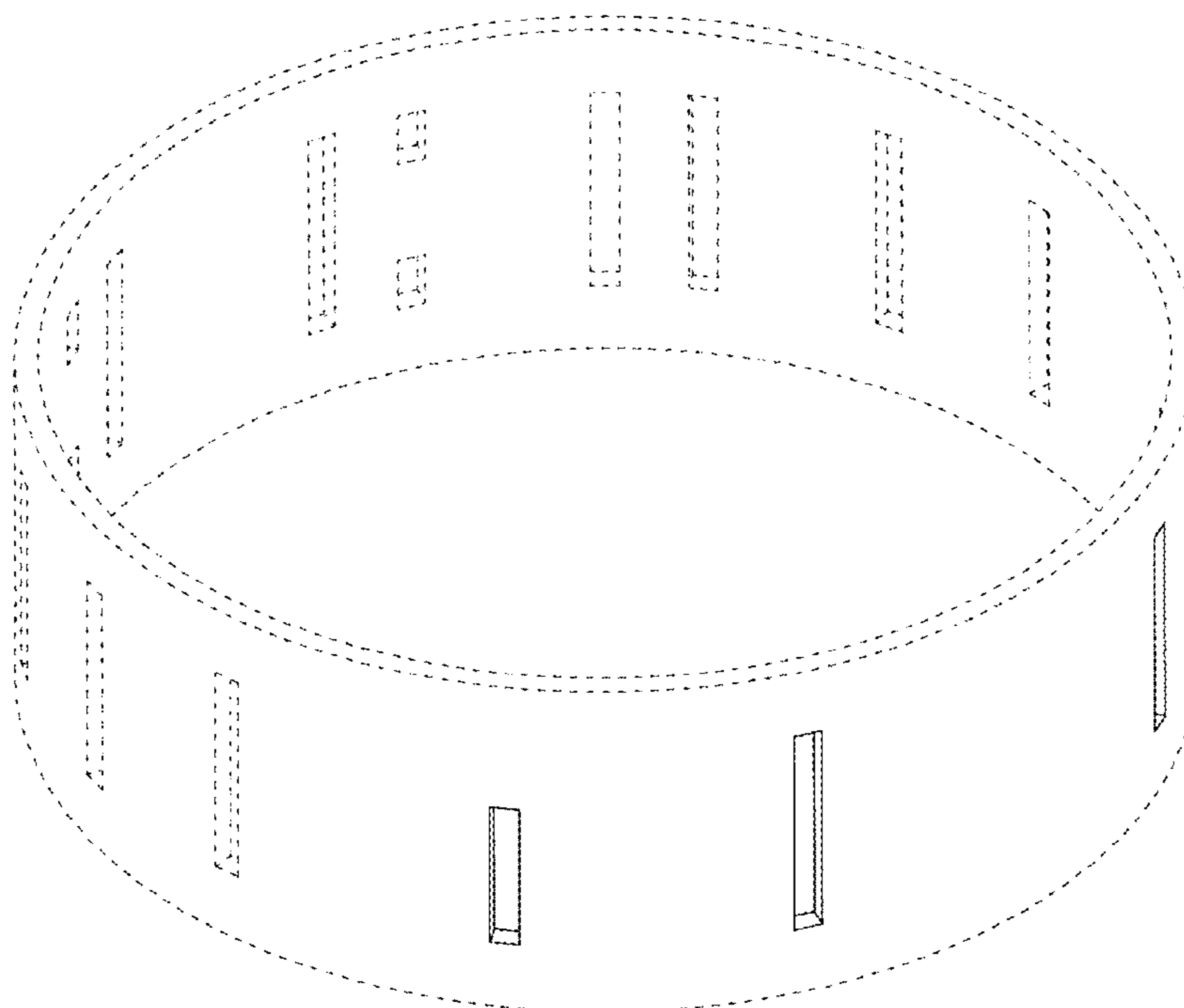

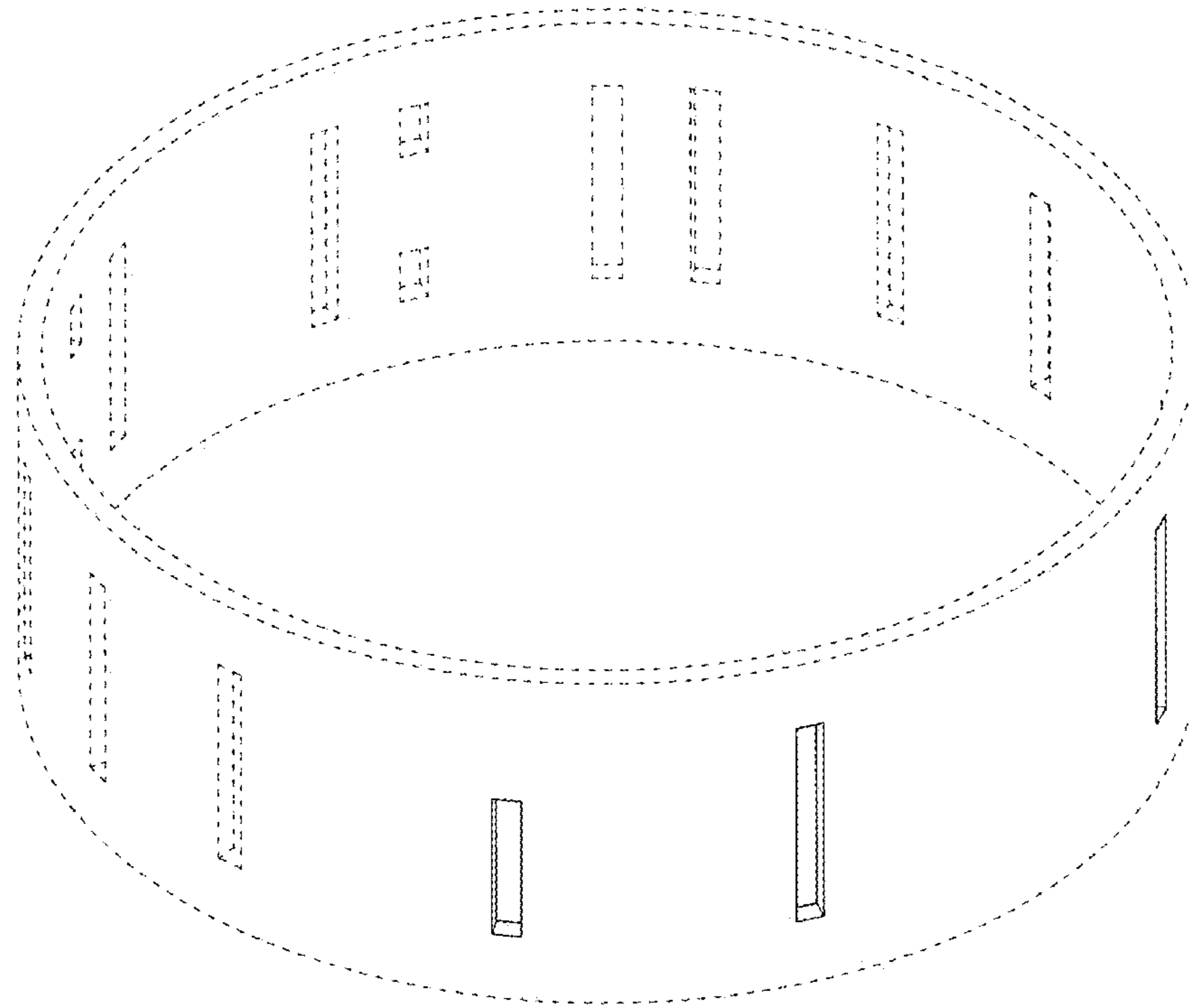

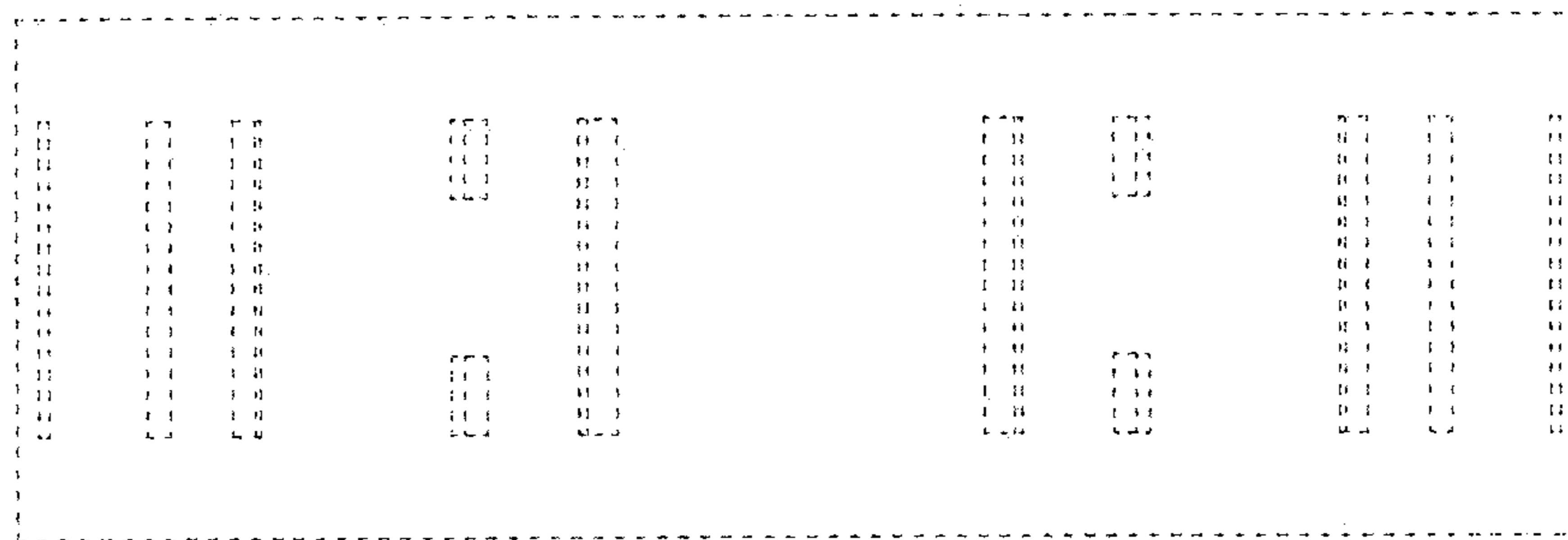

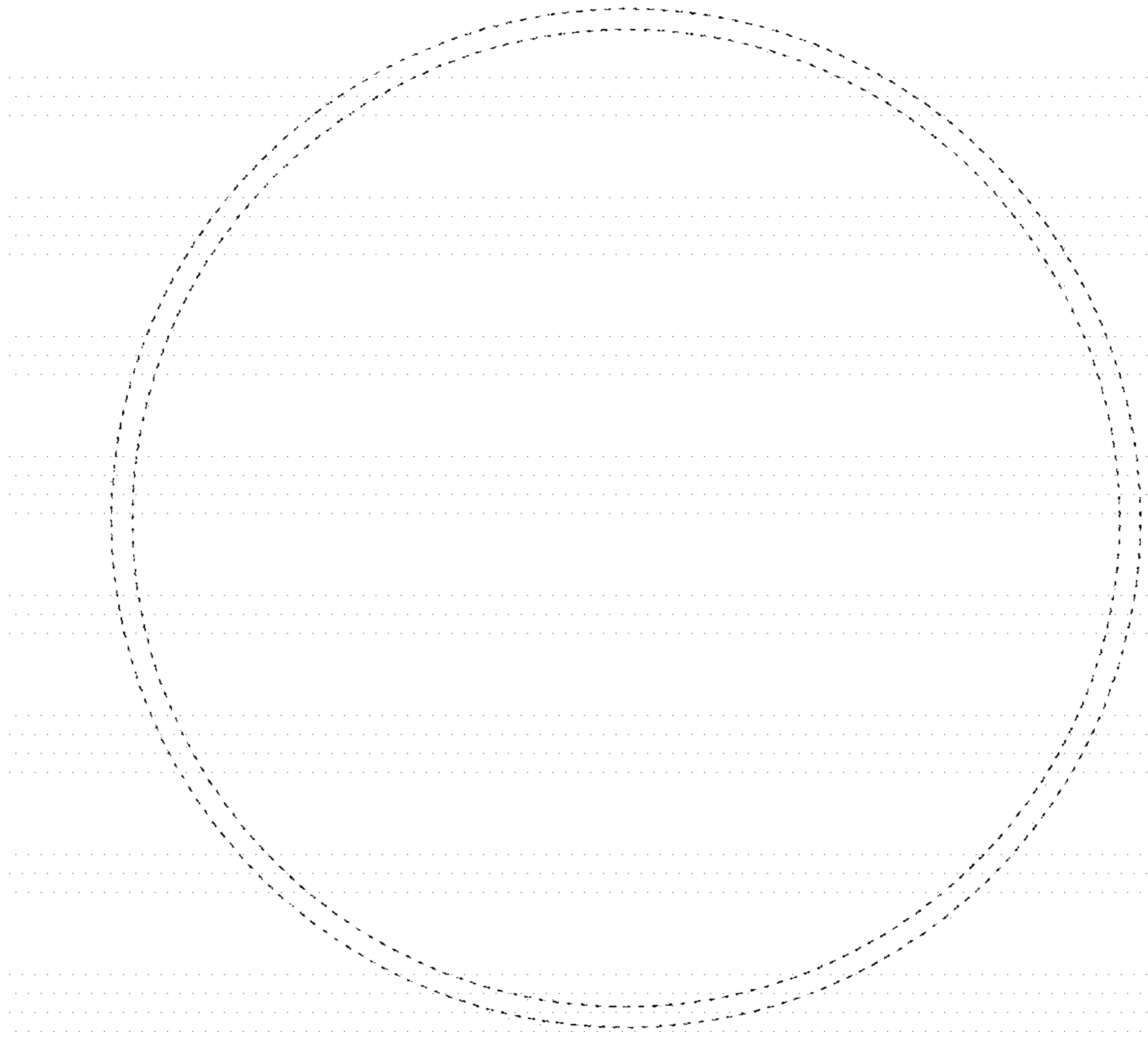

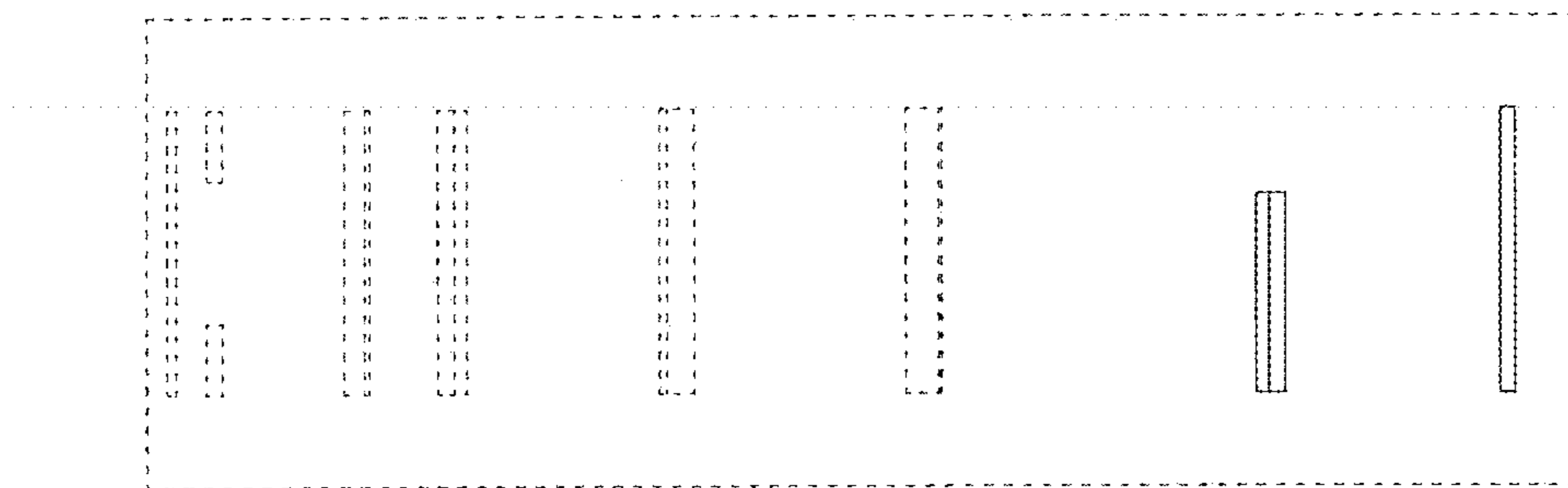
