FIG. 3 is a back view of the toy keyboard of FIG. 1.

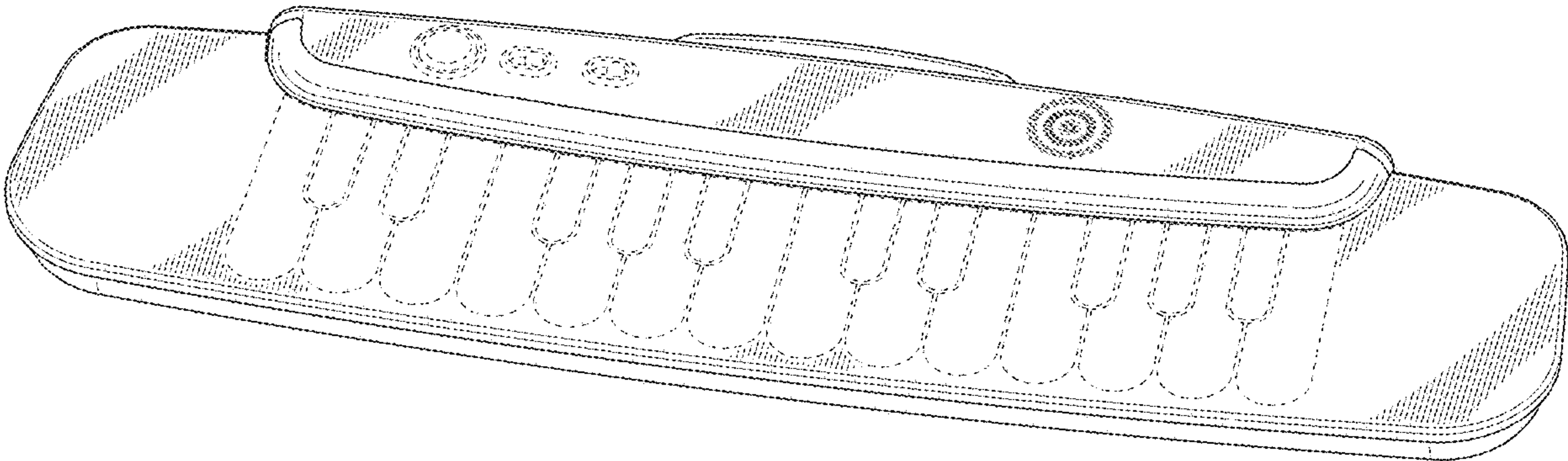
FIG. 4 is a first end view of the toy keyboard of FIG. 1.

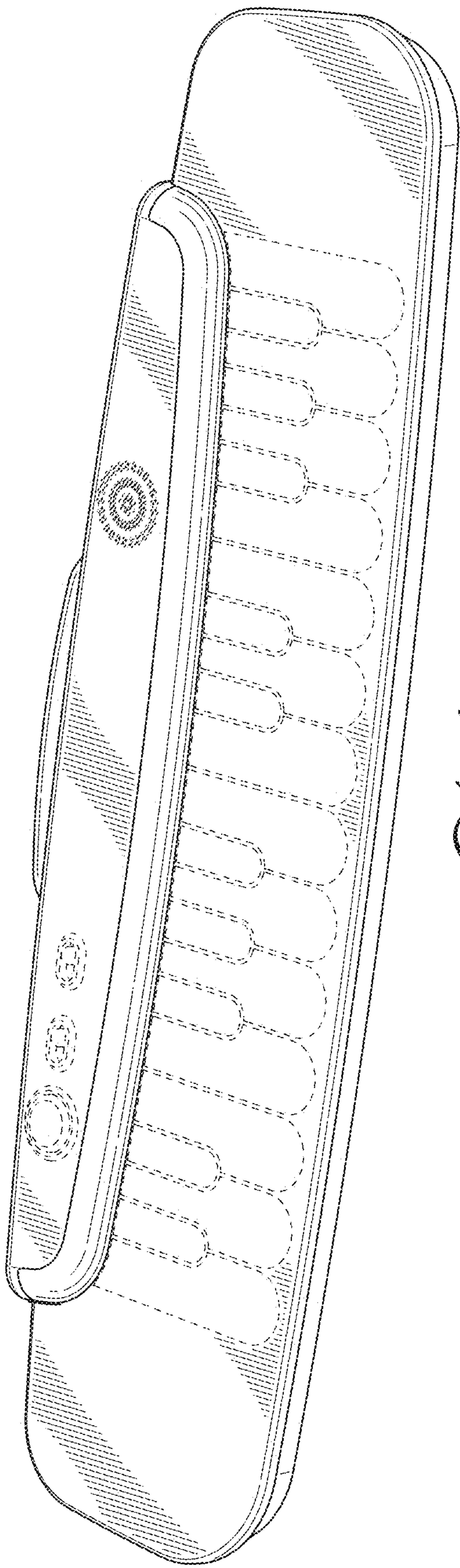

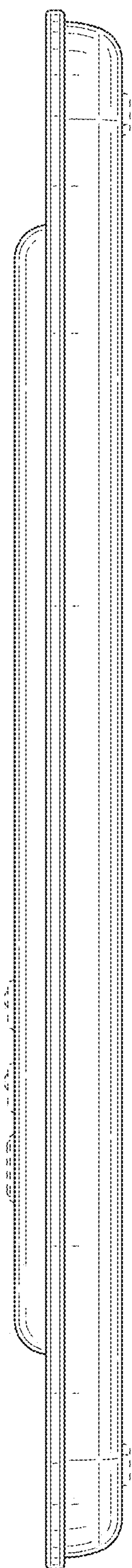

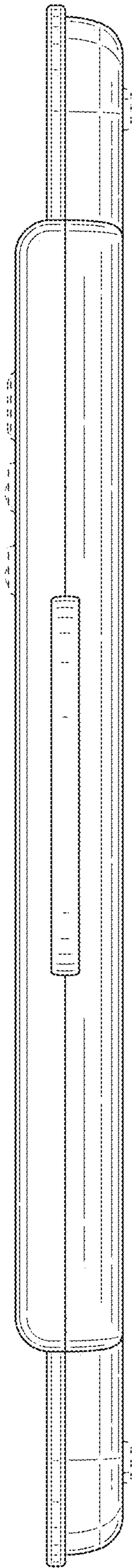

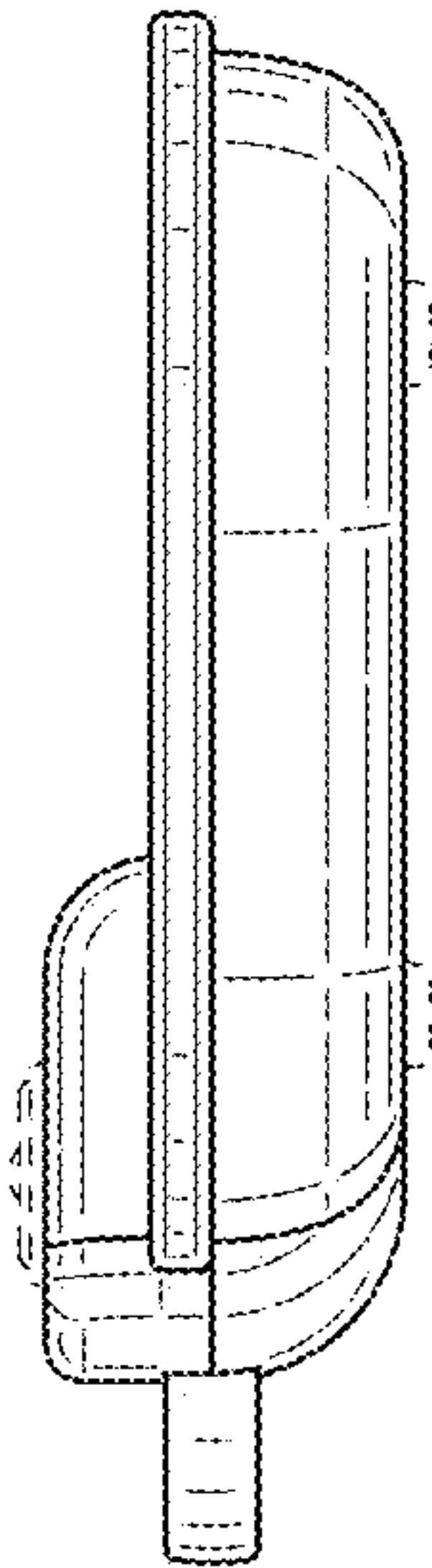

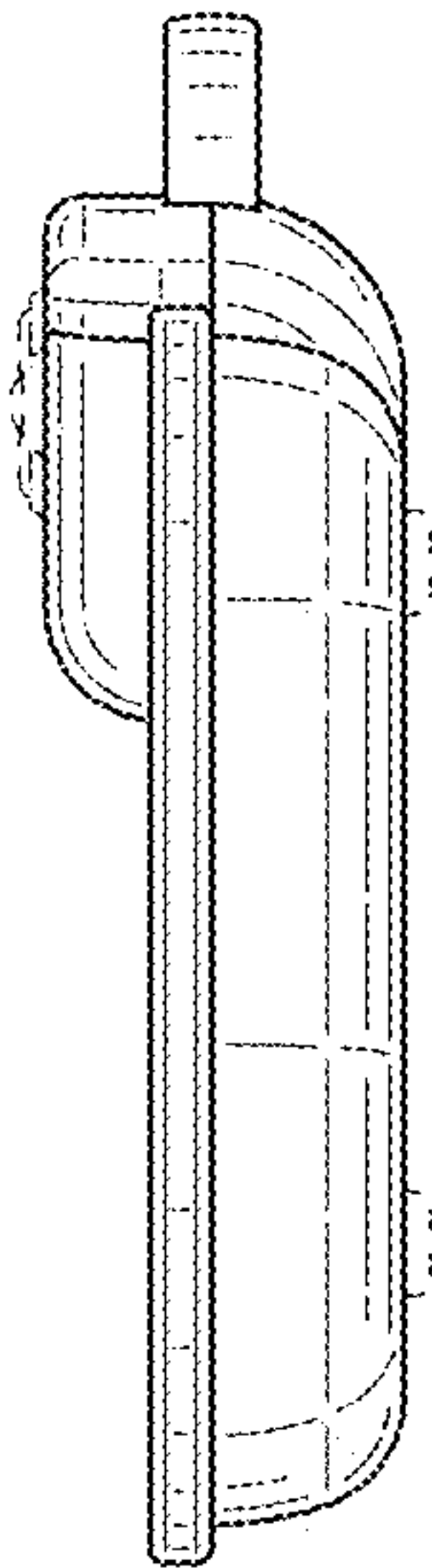

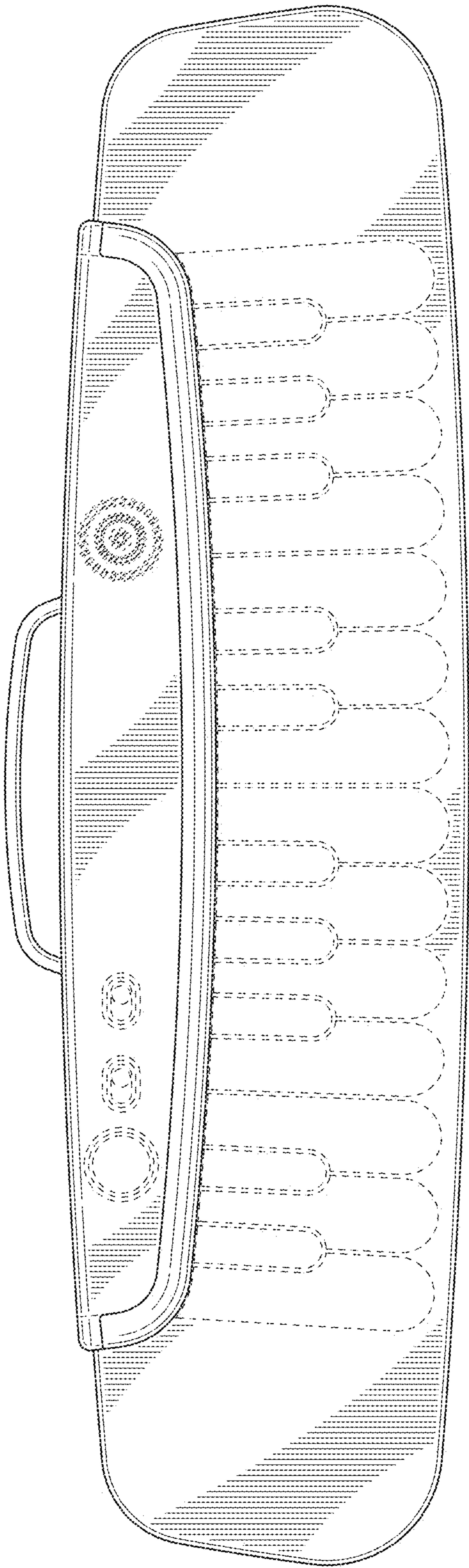

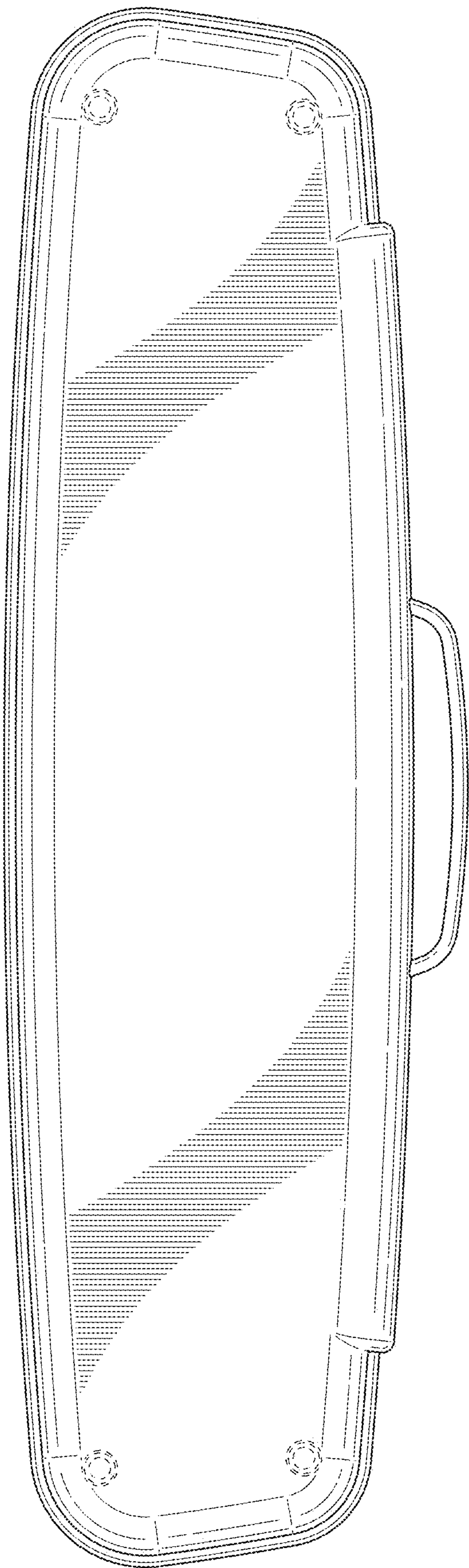
