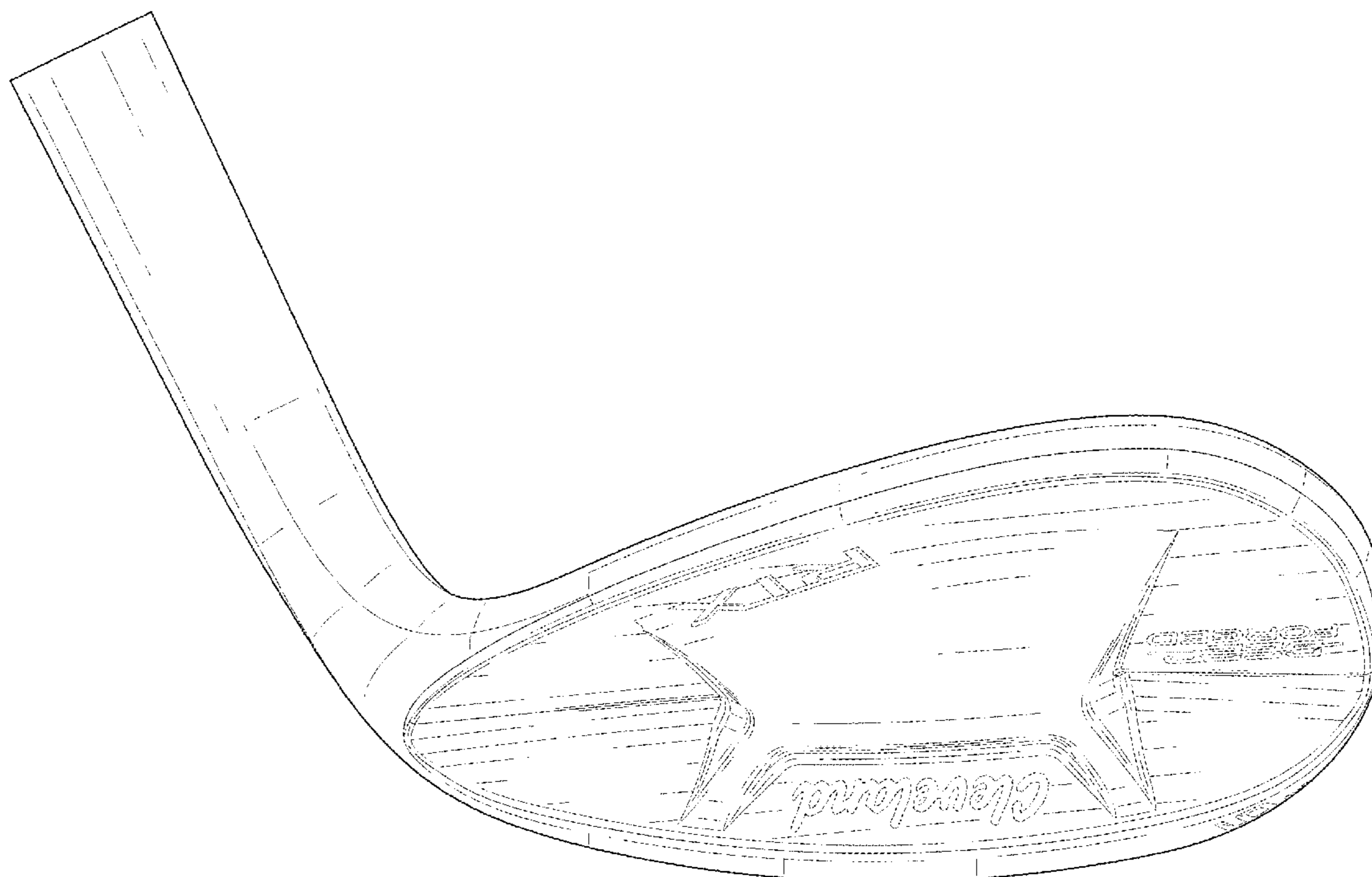
FIG. 1 is a rear, heel-side perspective view of the golf club head, showing the new design;

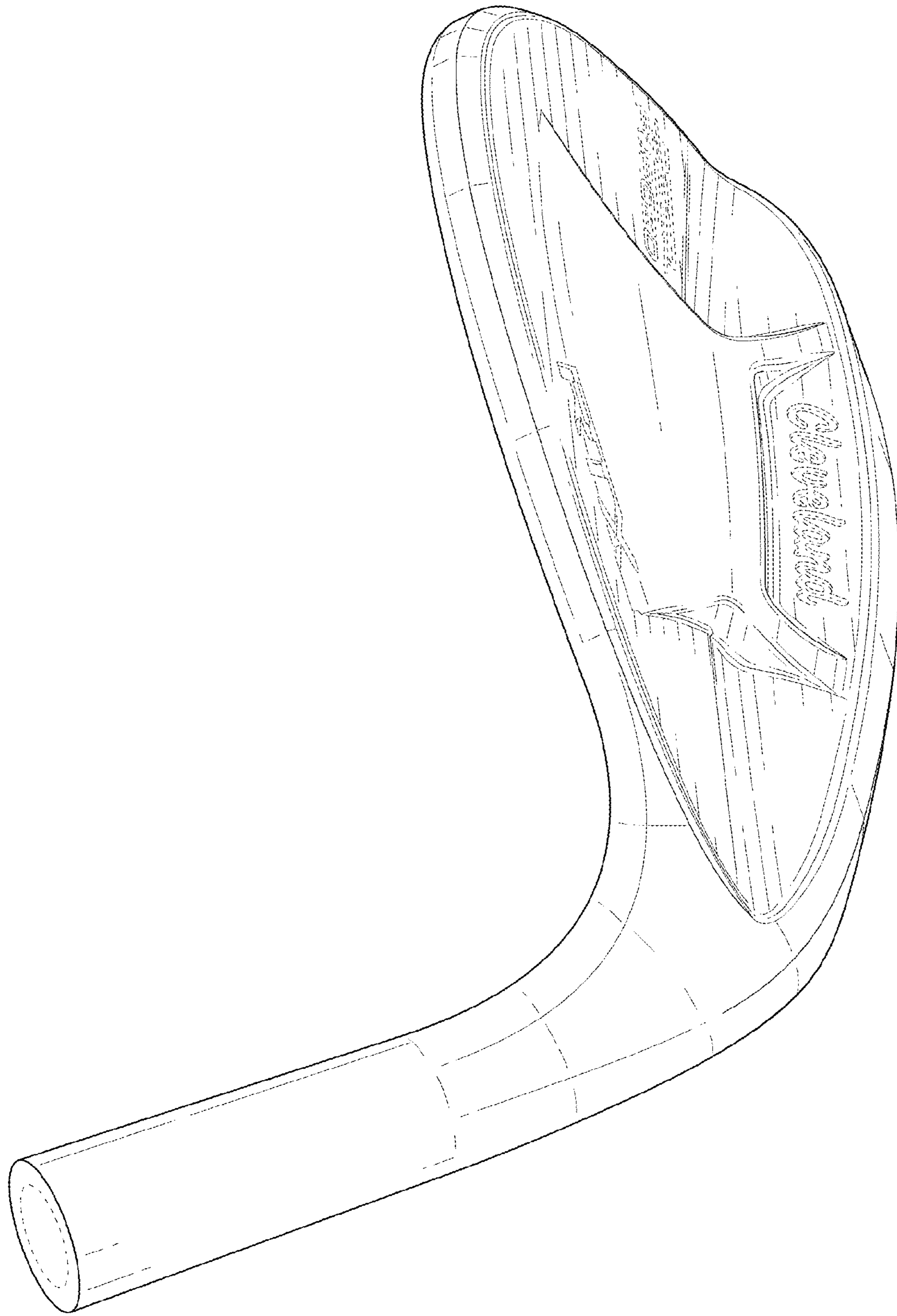

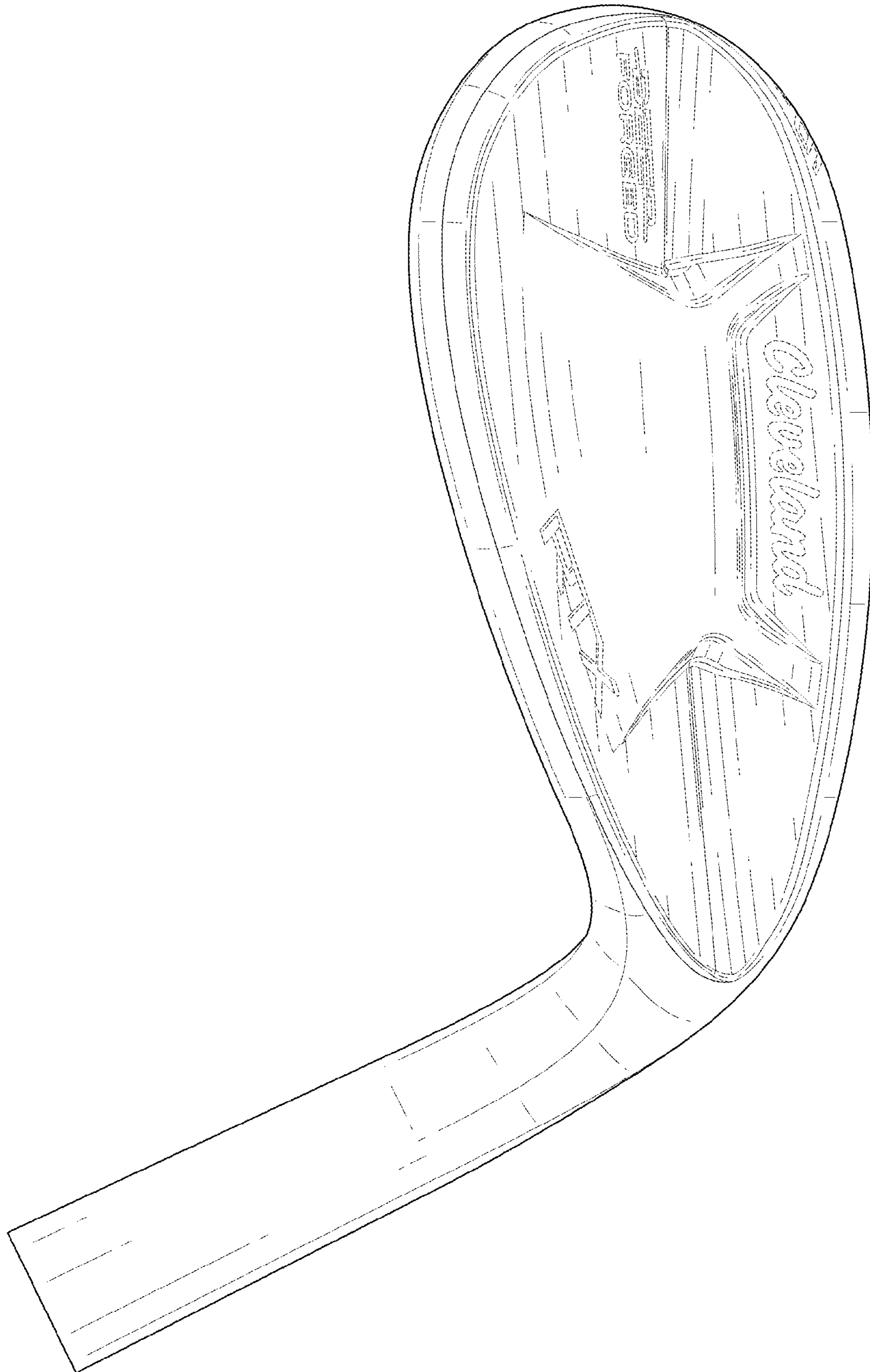

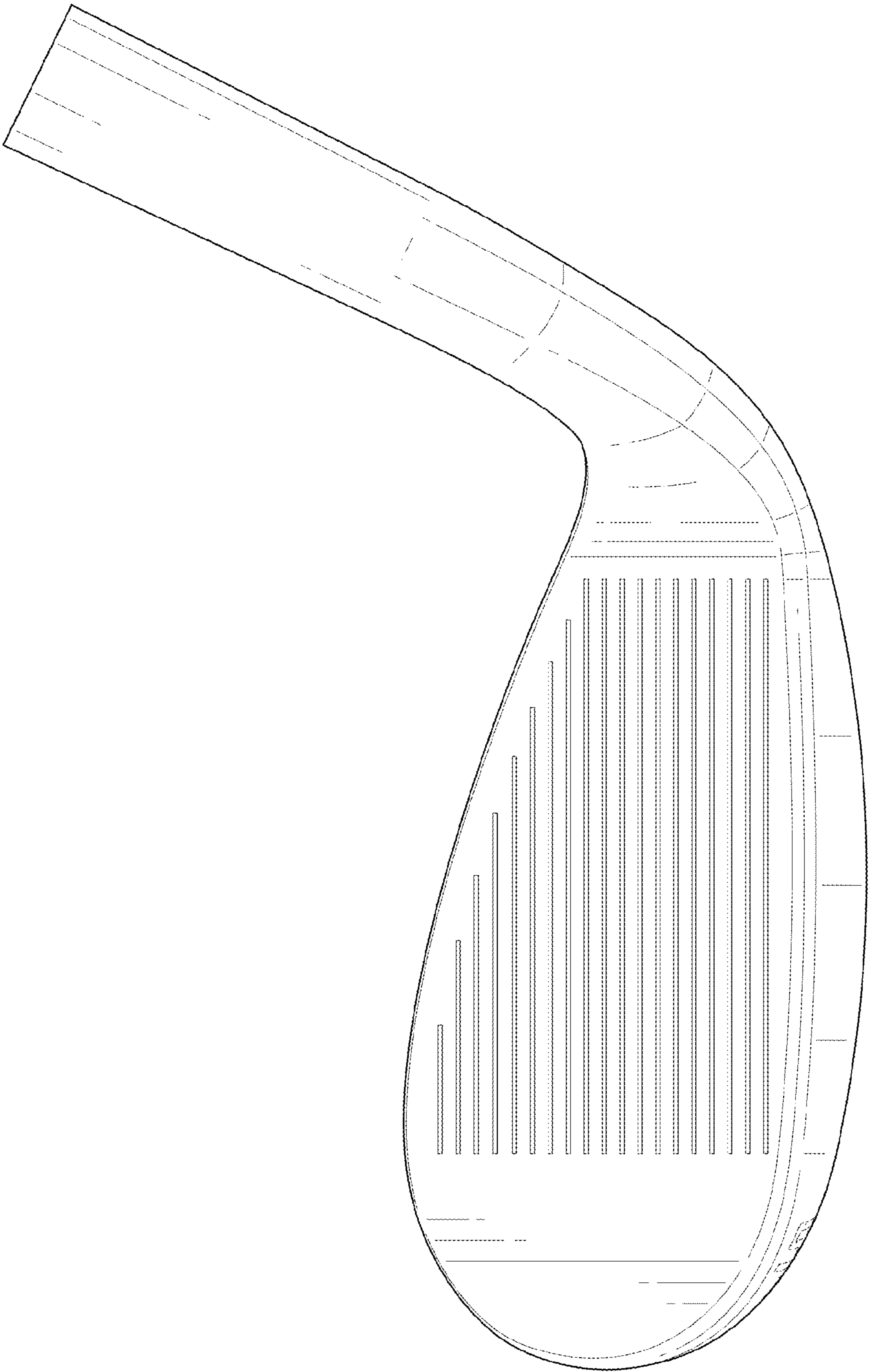

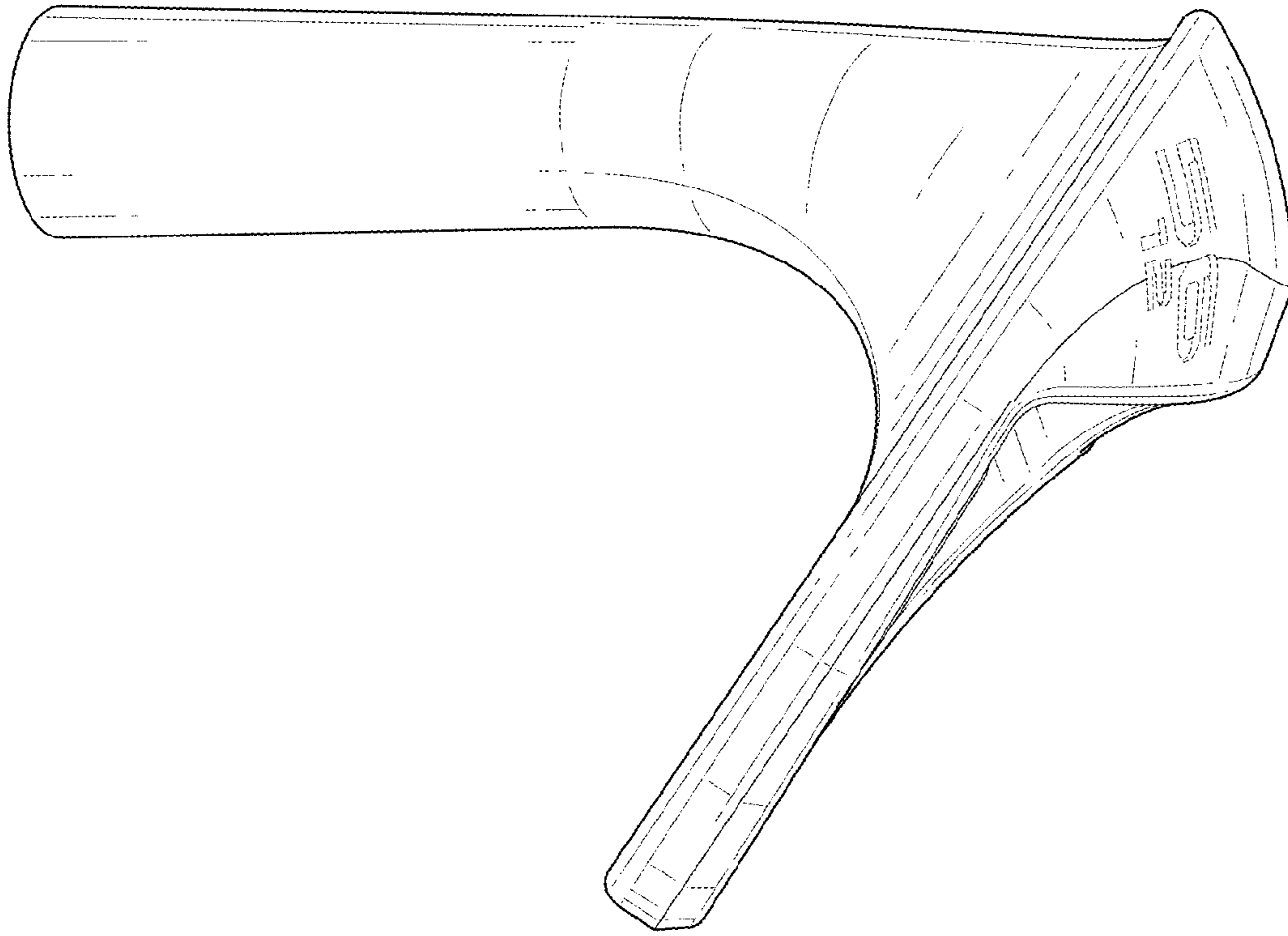

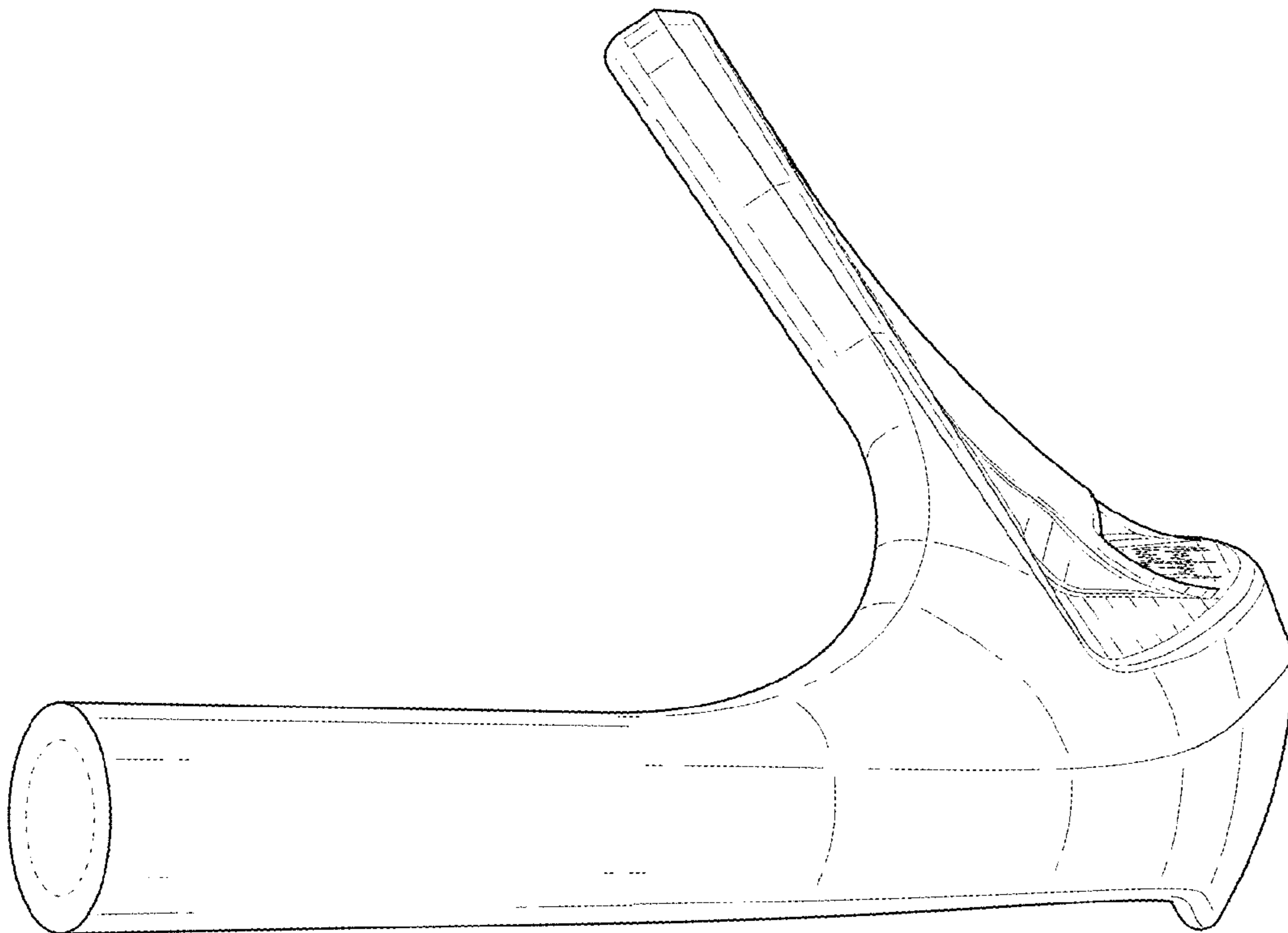

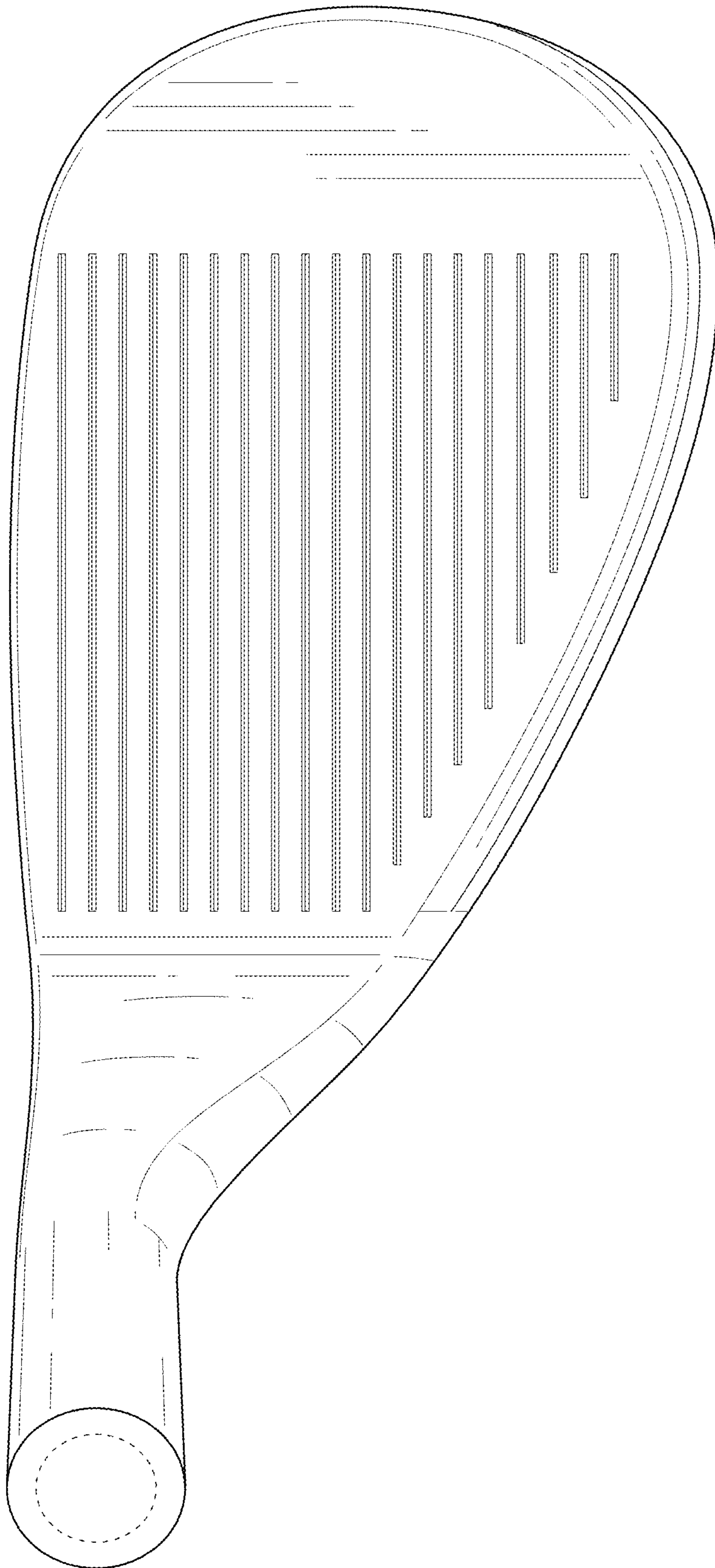

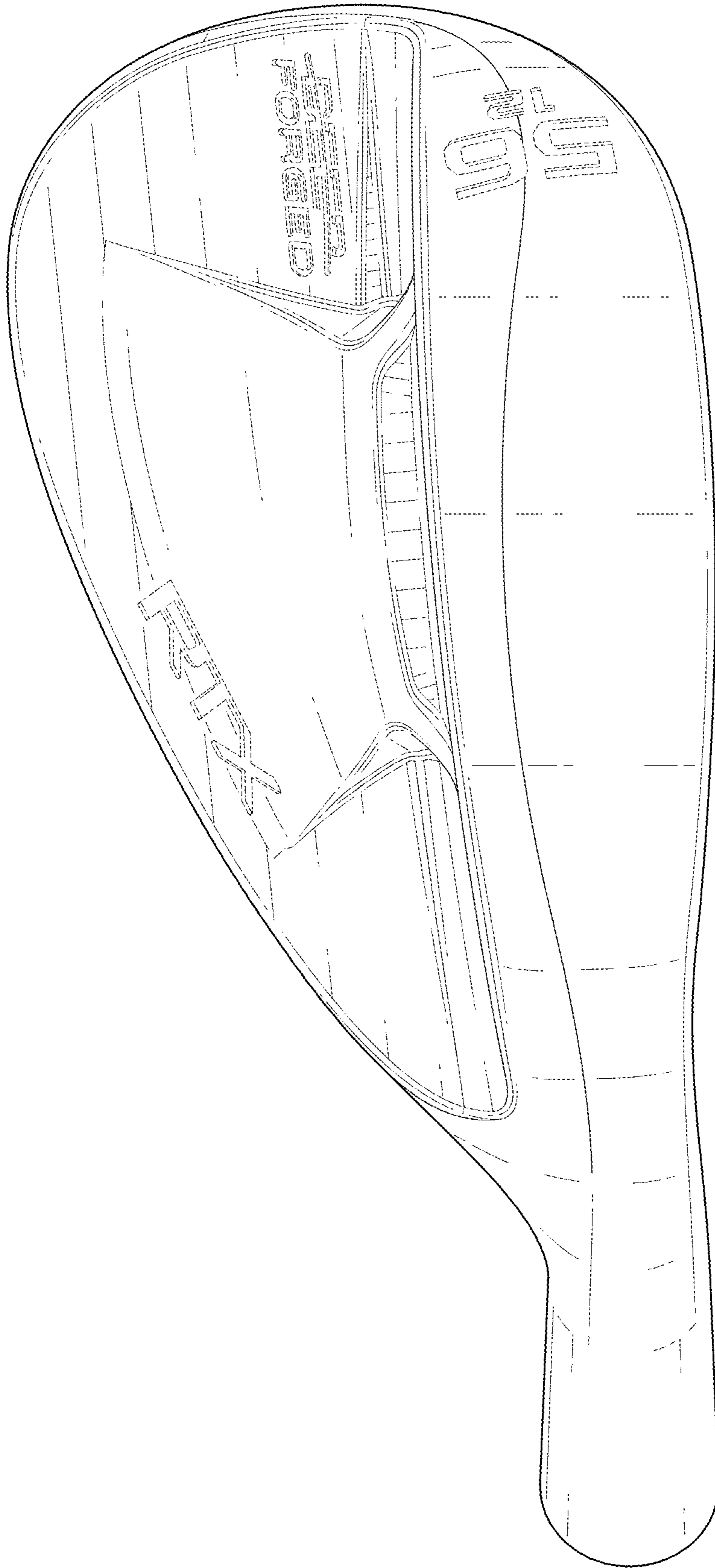

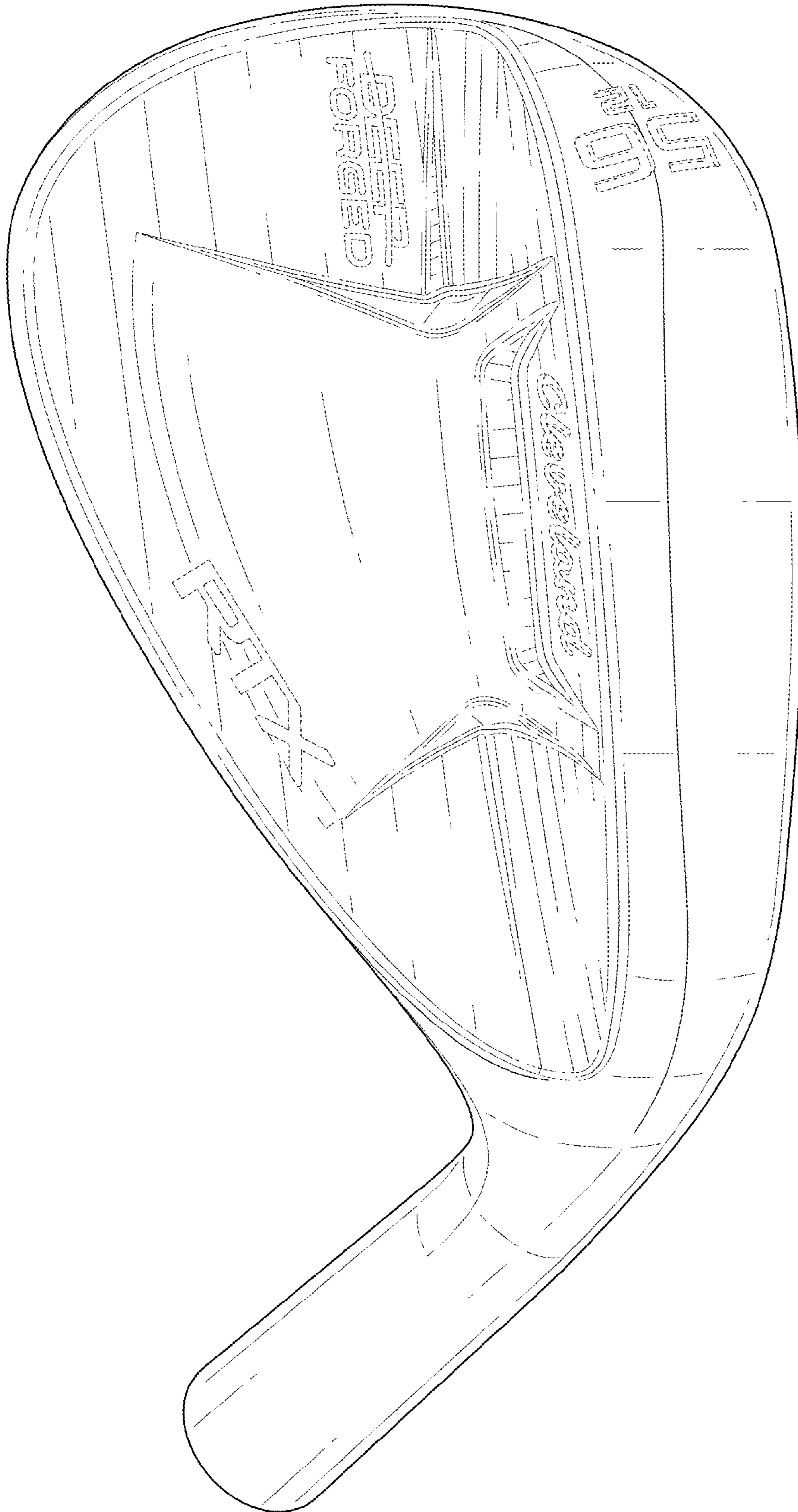

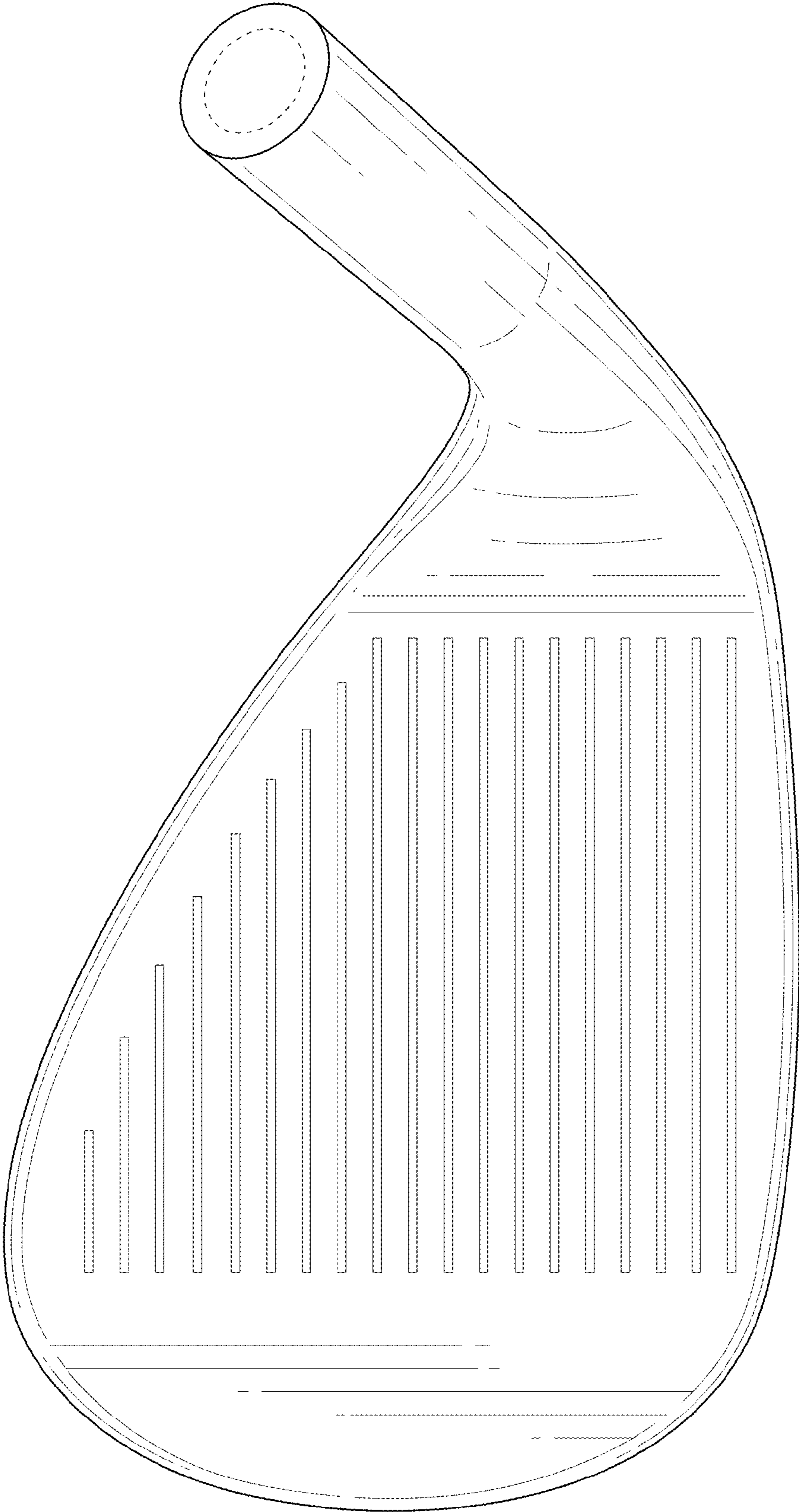

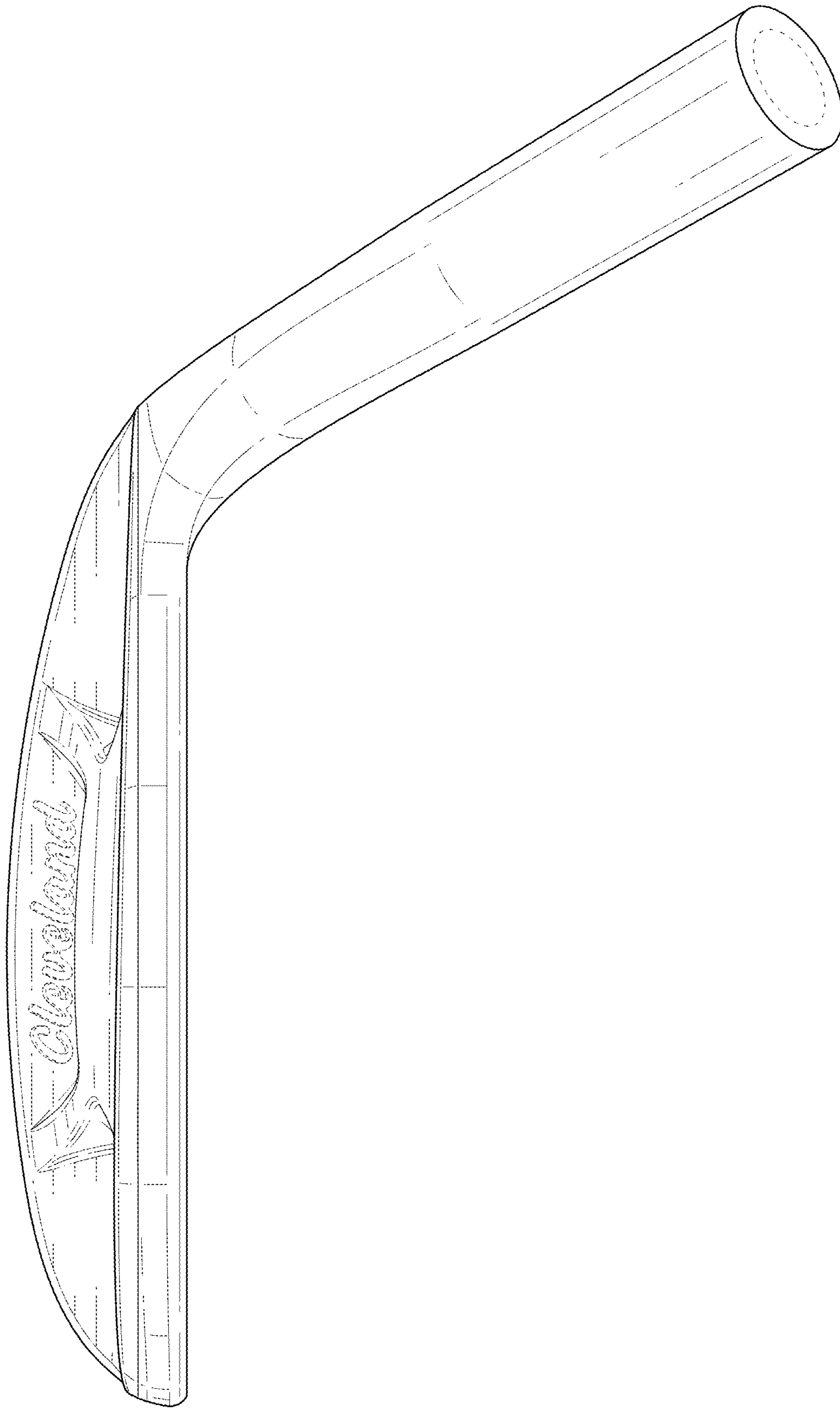

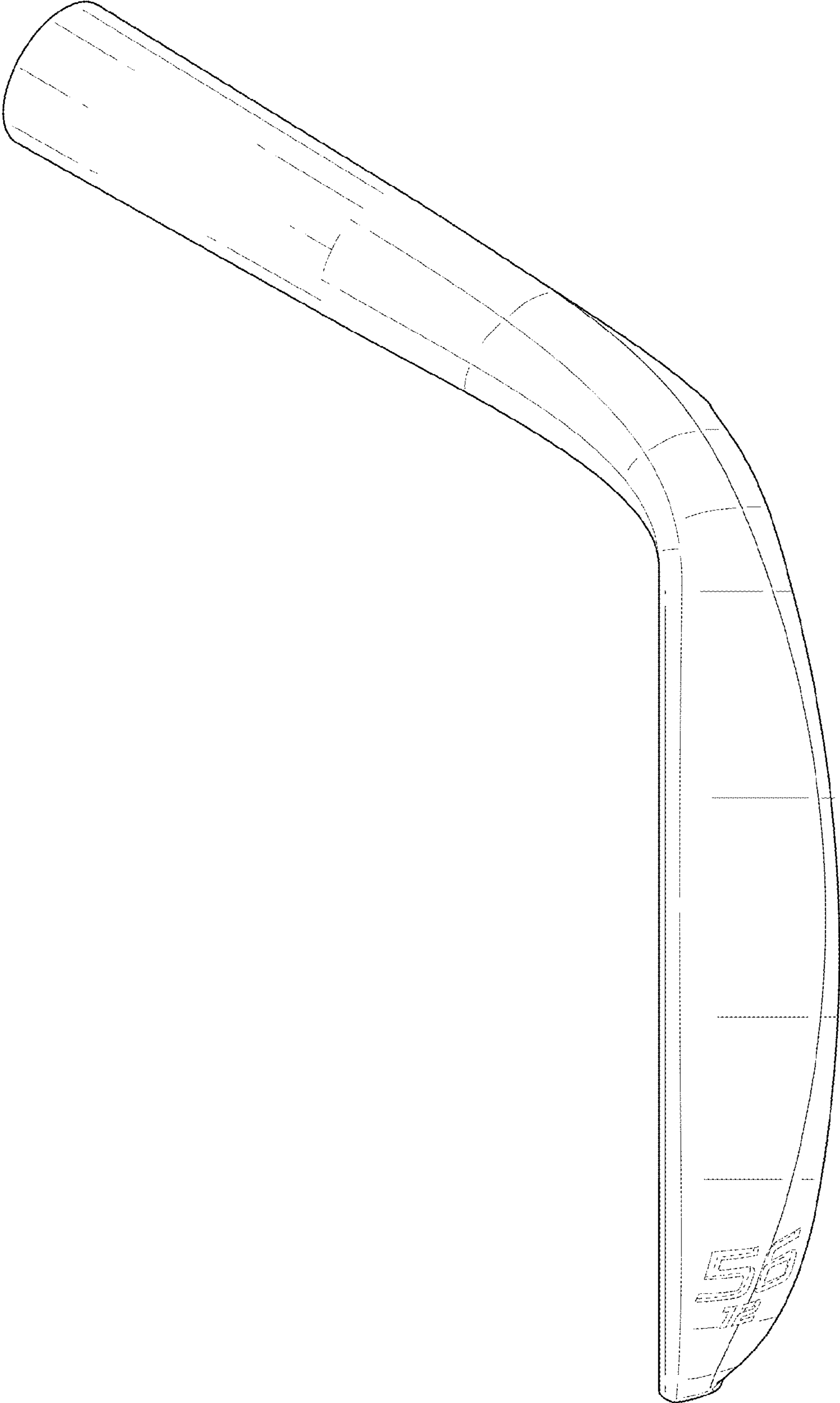

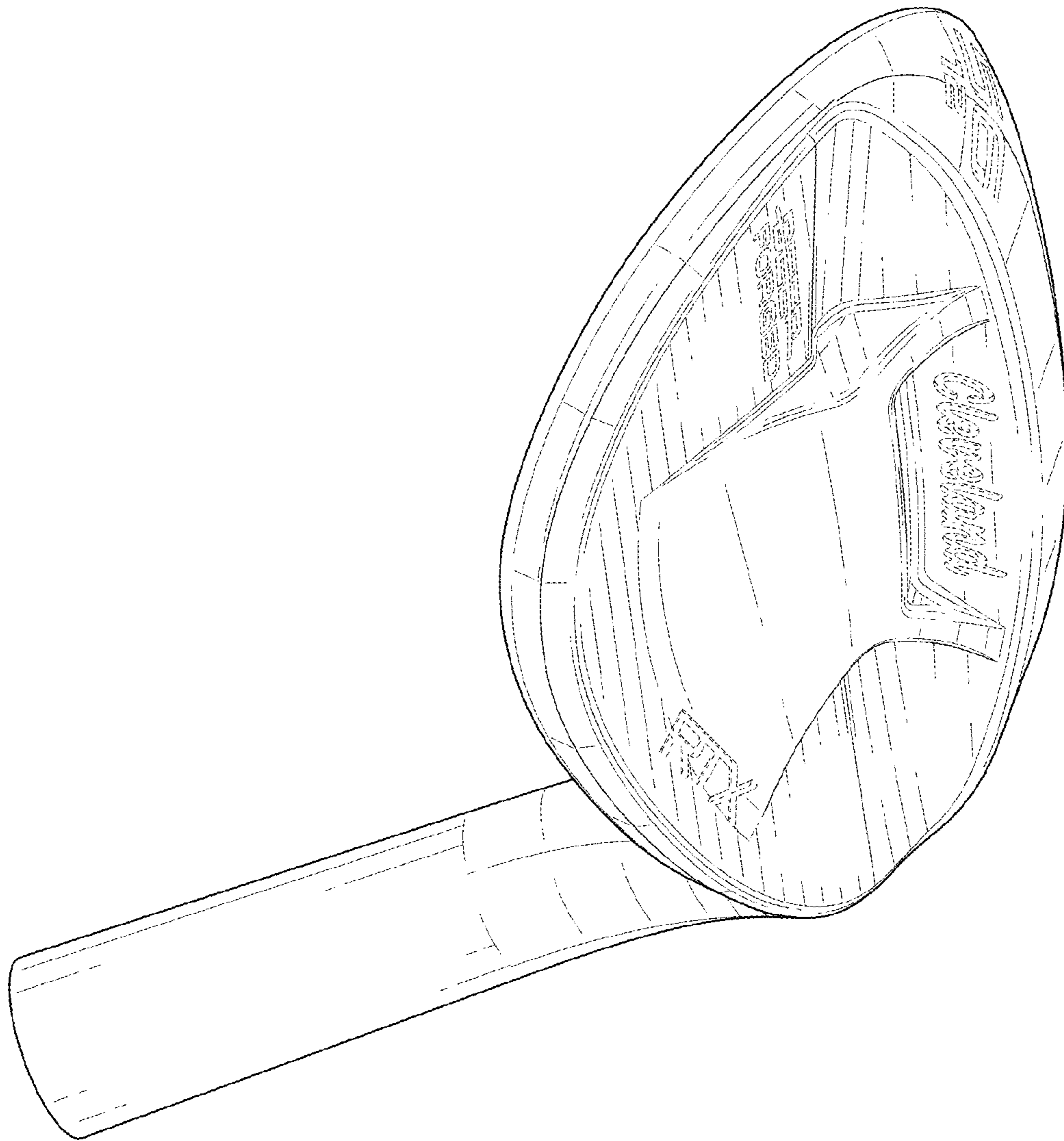
