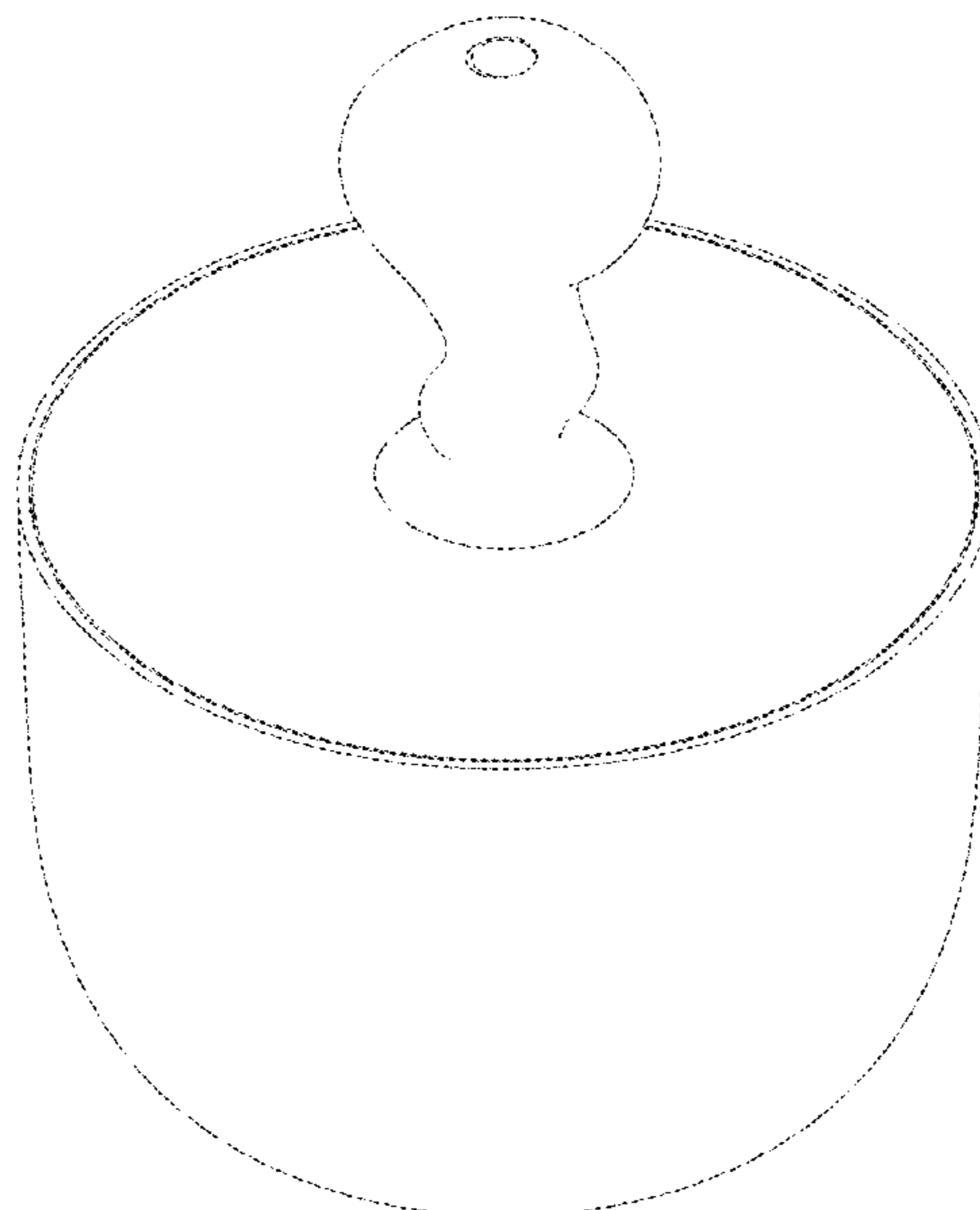
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front perspective view of the air humidifier of the present invention.  
FIG. 2 is a front view of the air humidifier shown in FIG. 1.  
FIG. 3 is a rear view of the air humidifier shown in FIG. 1.

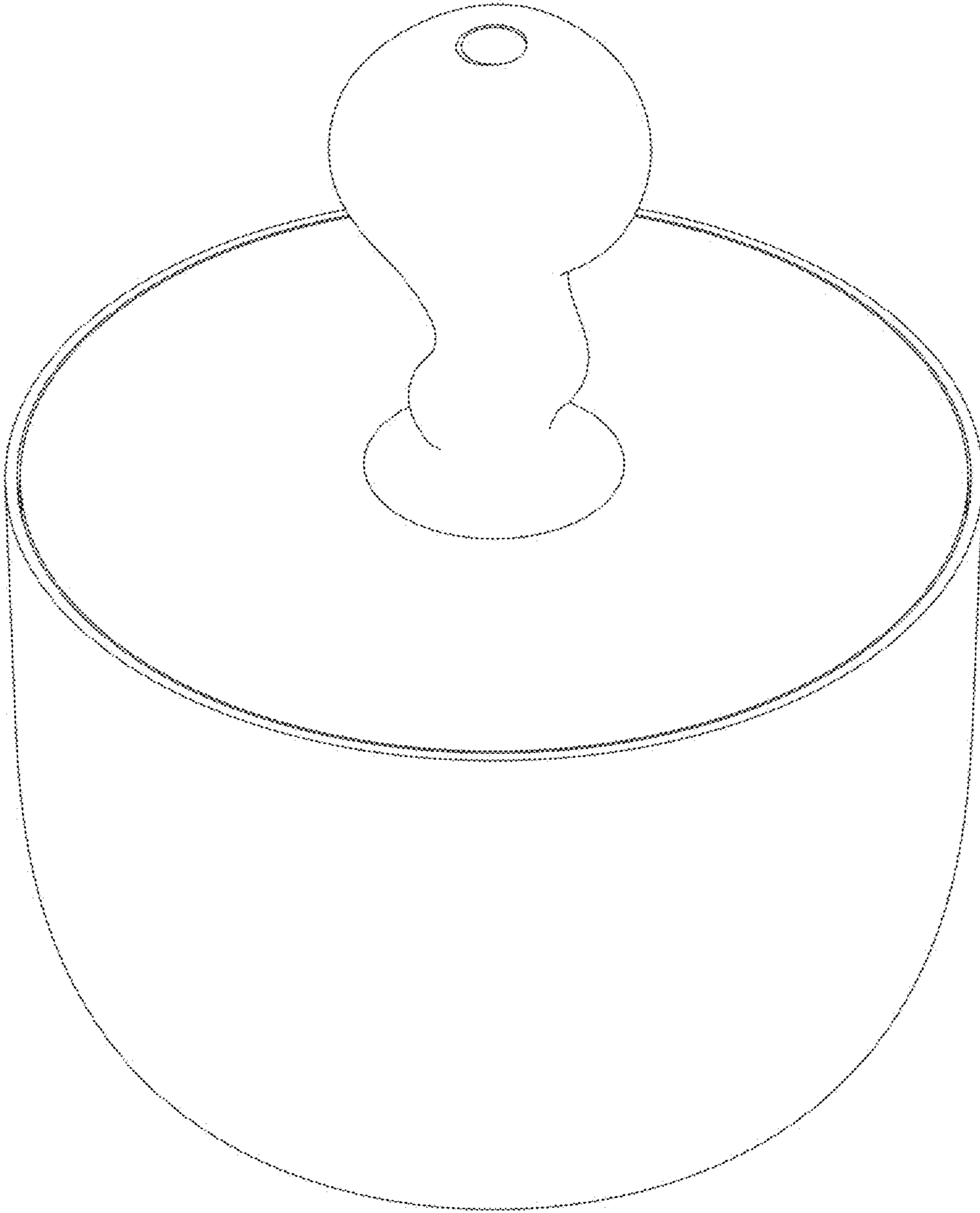

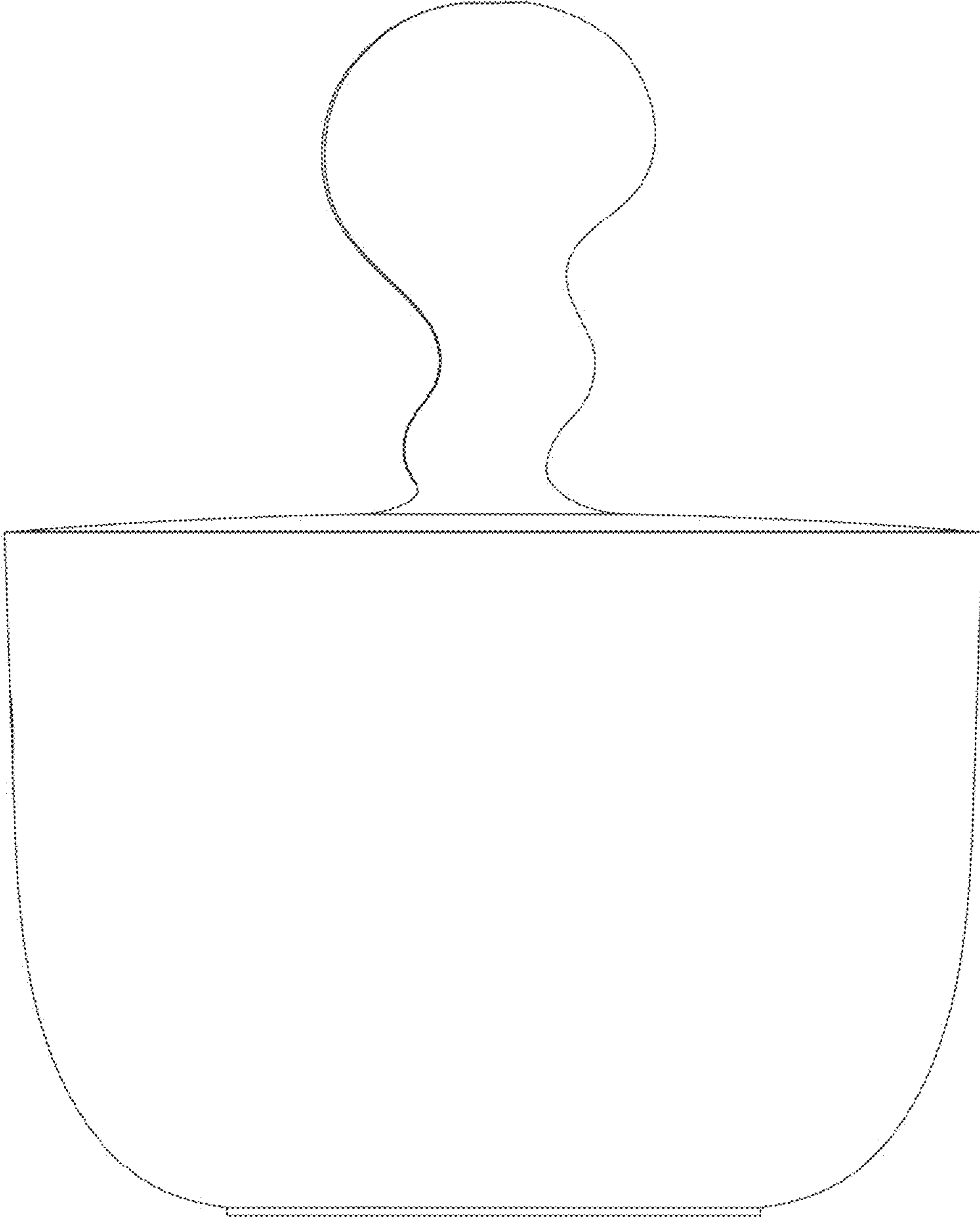

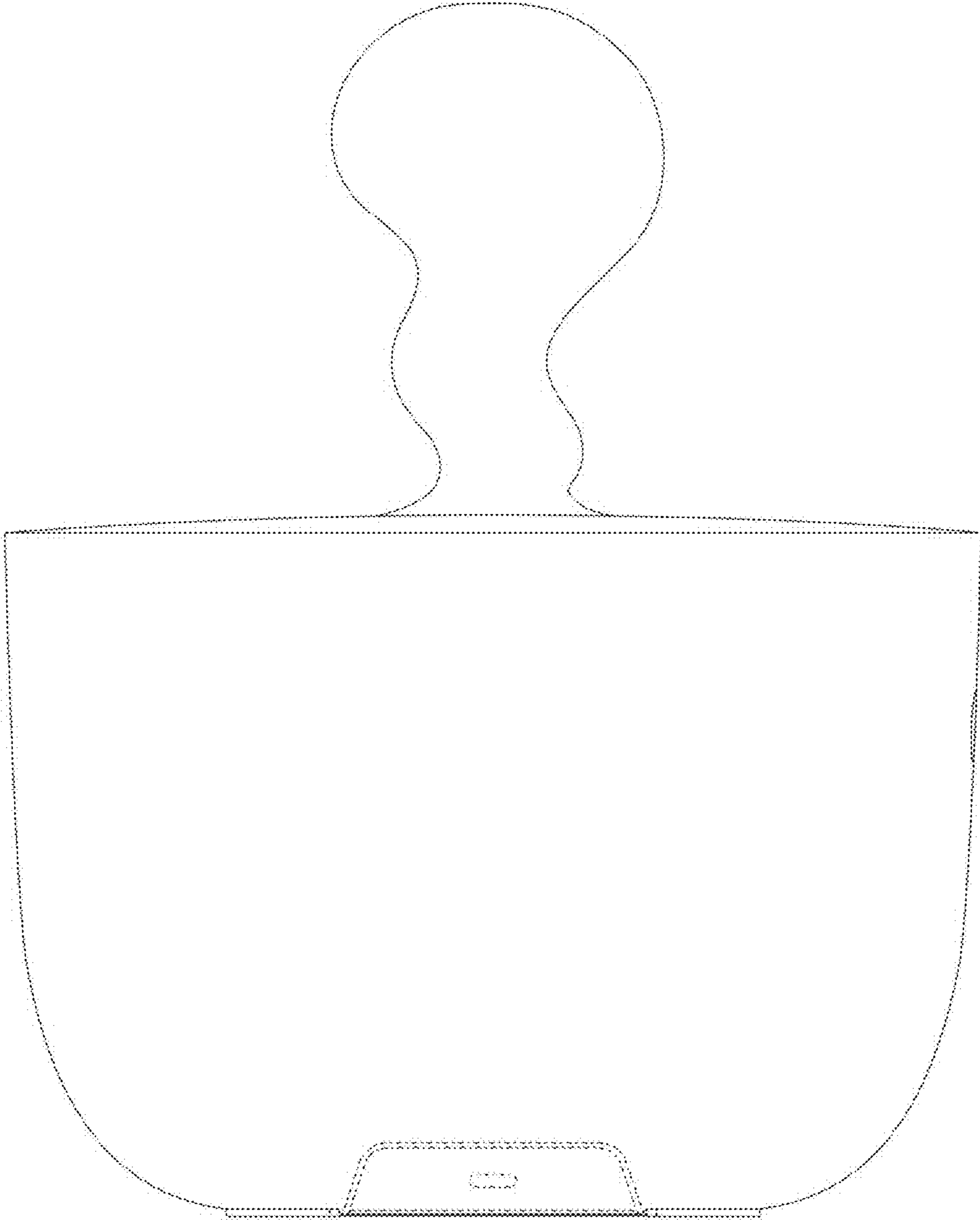

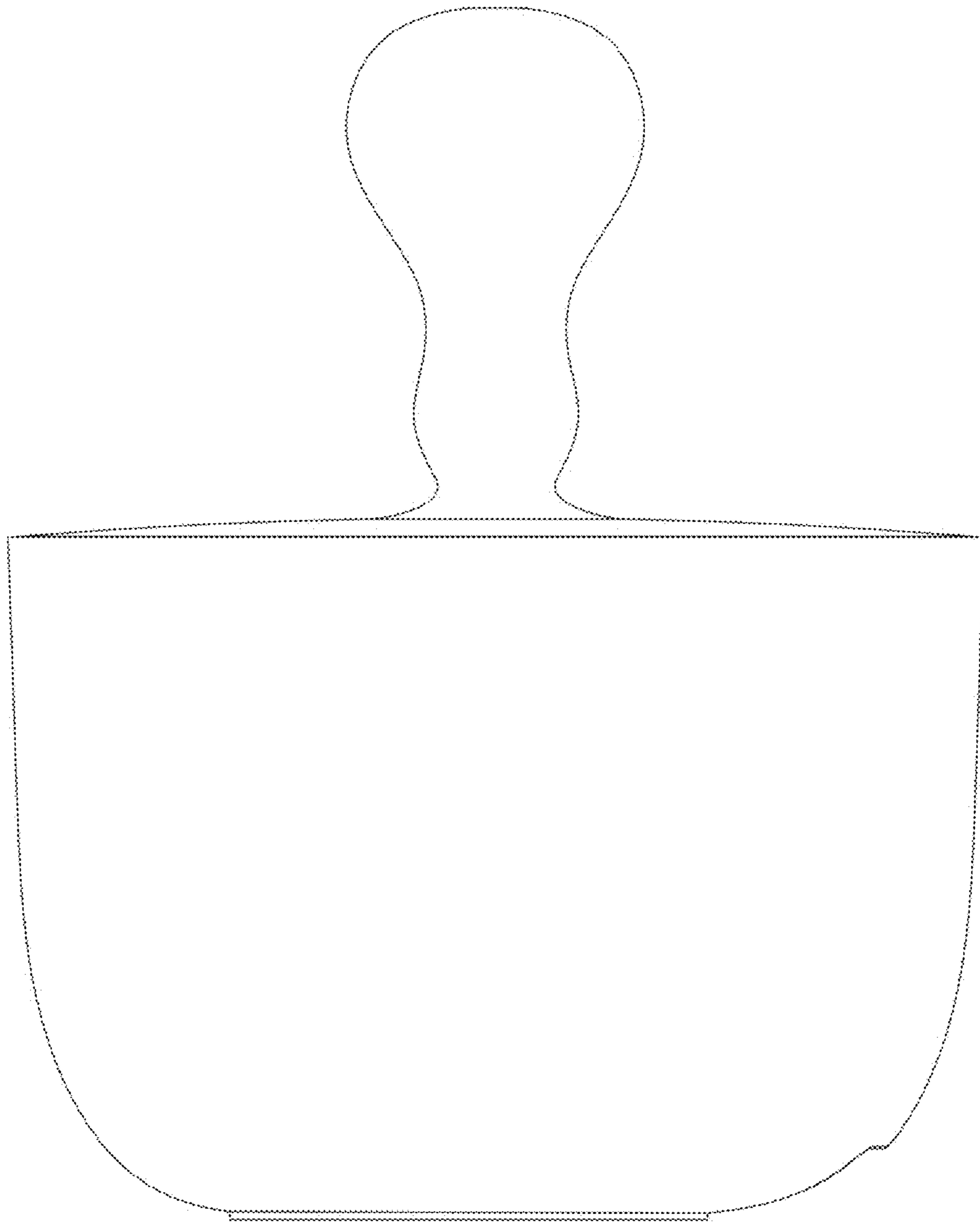

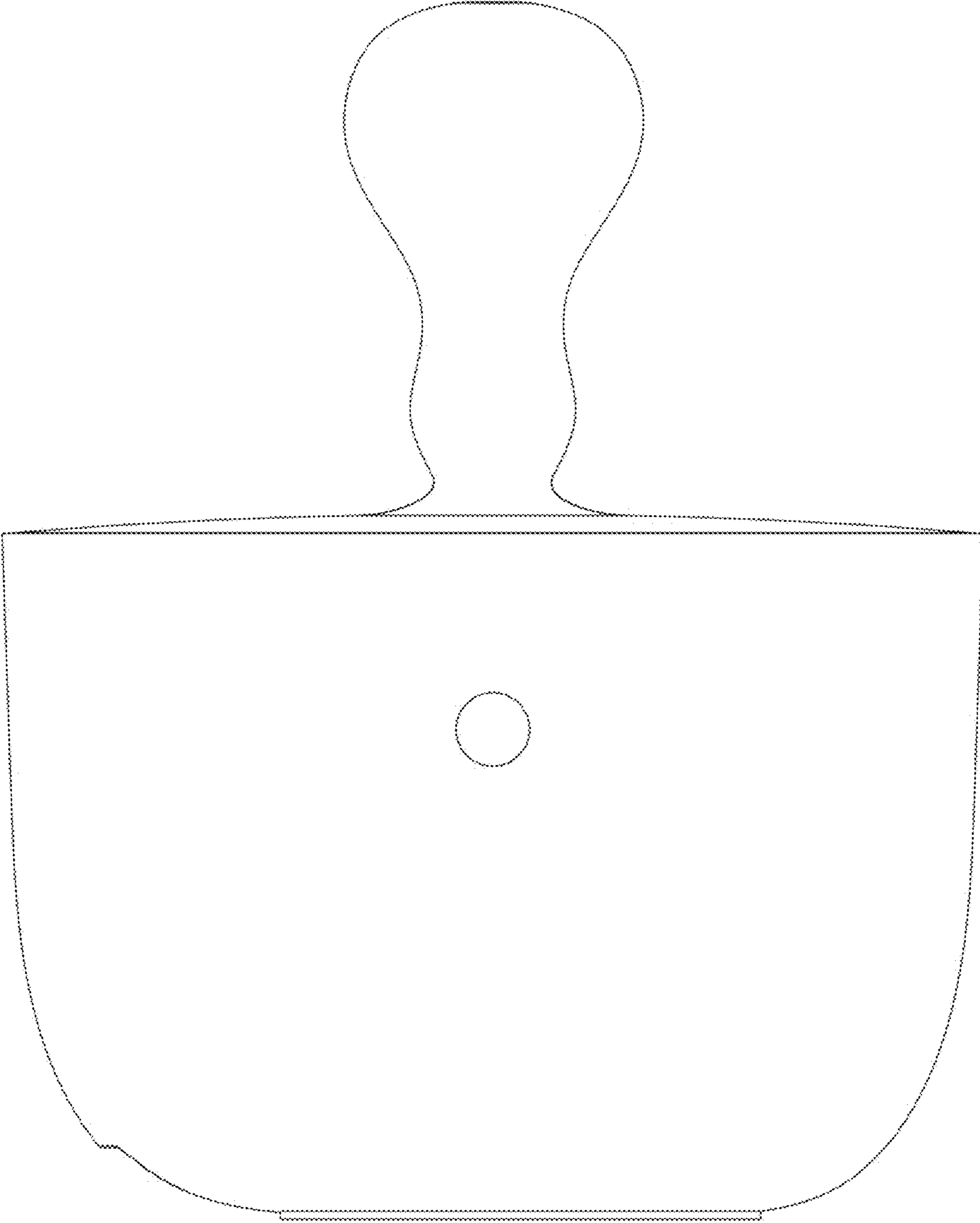

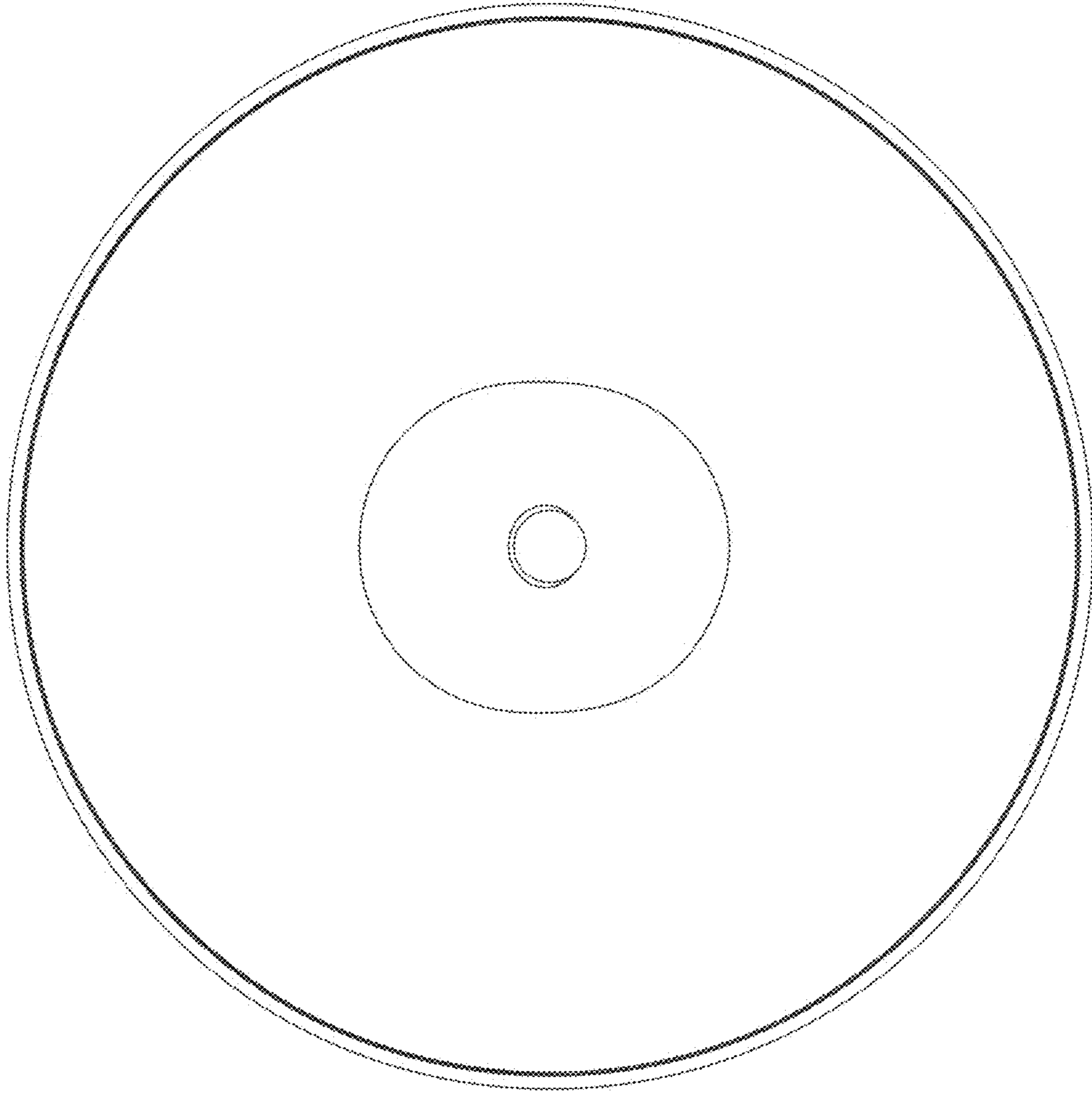

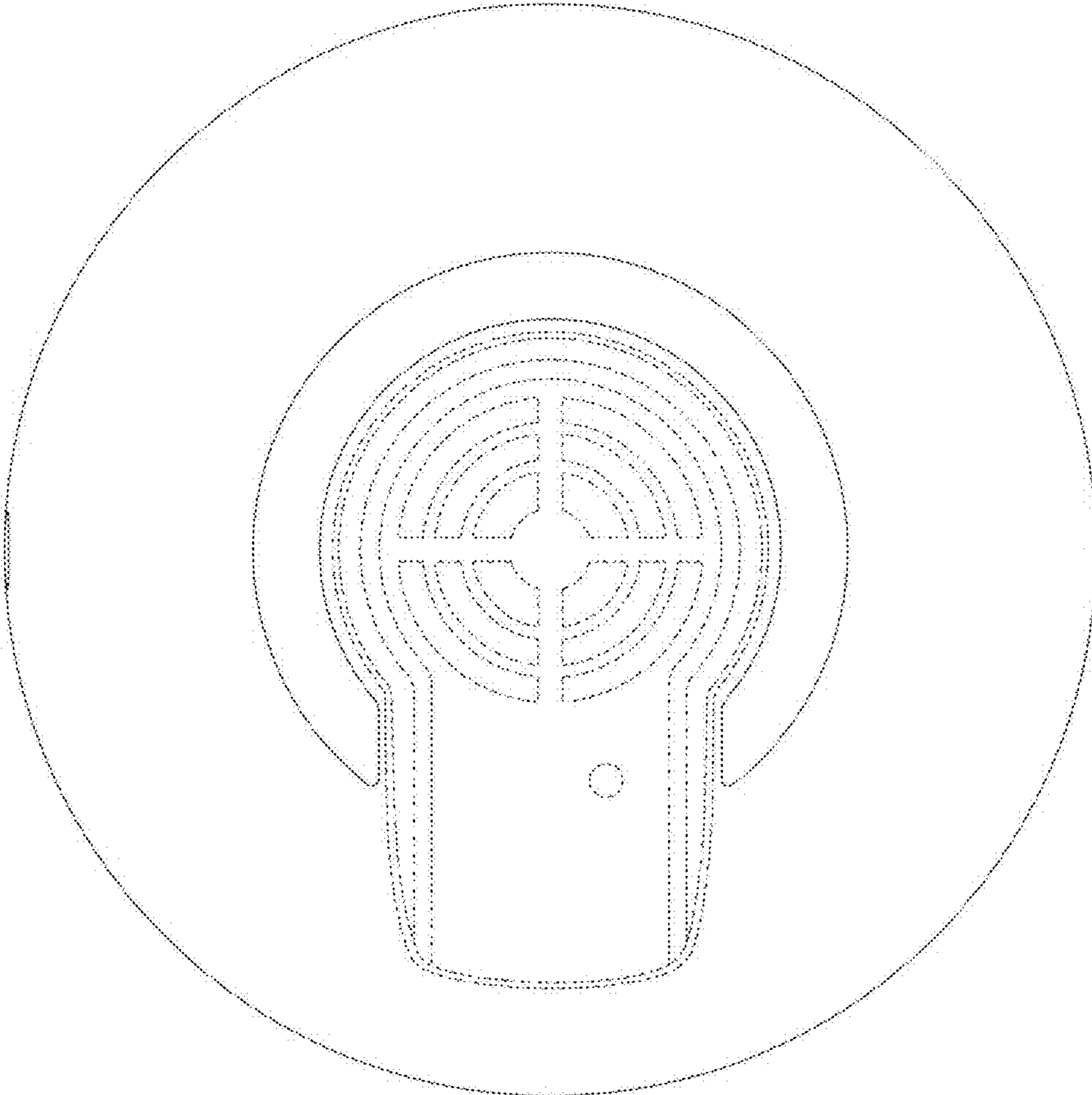
