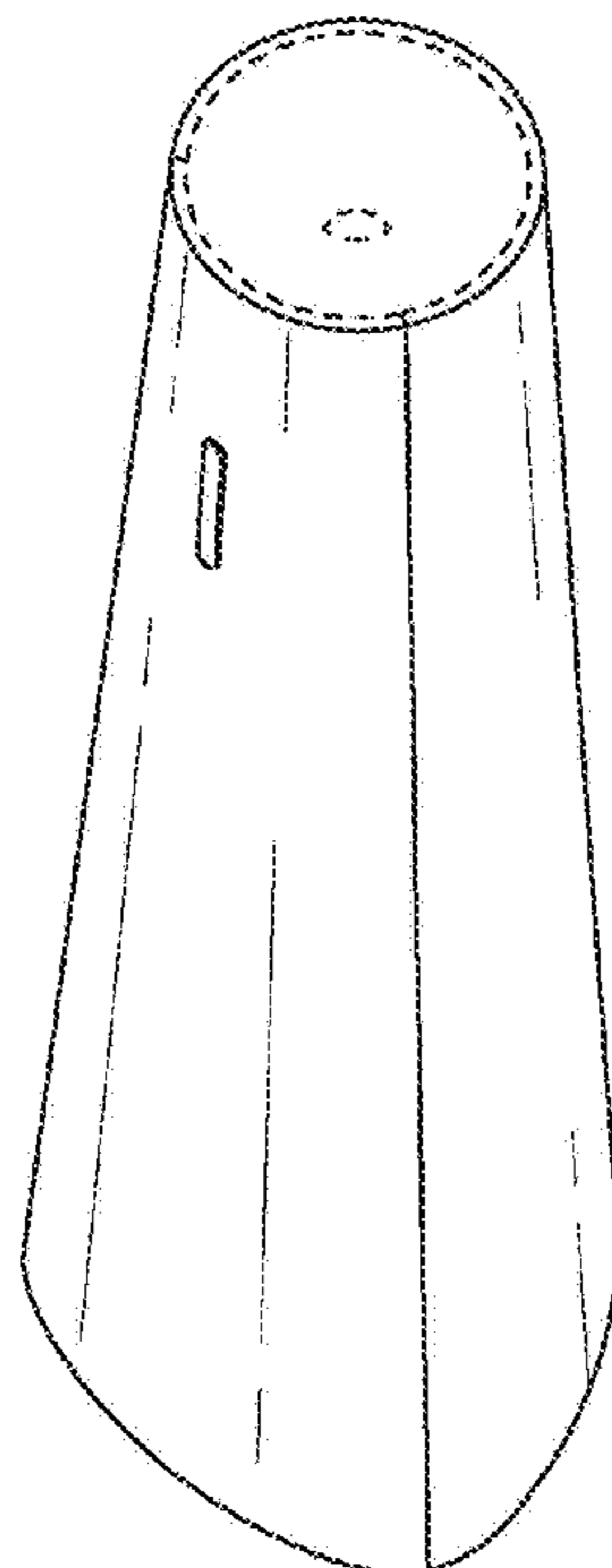
(57) **CLAIM**

The ornamental design for a portable diffuser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a portable diffuser showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top, front and right side perspective view thereof; and,
FIG. 8 is a bottom, rear and right side perspective view thereof.
The broken lines in FIGS. 5 and 7 illustrate portions of the portable diffuser which form no part of the claimed design.

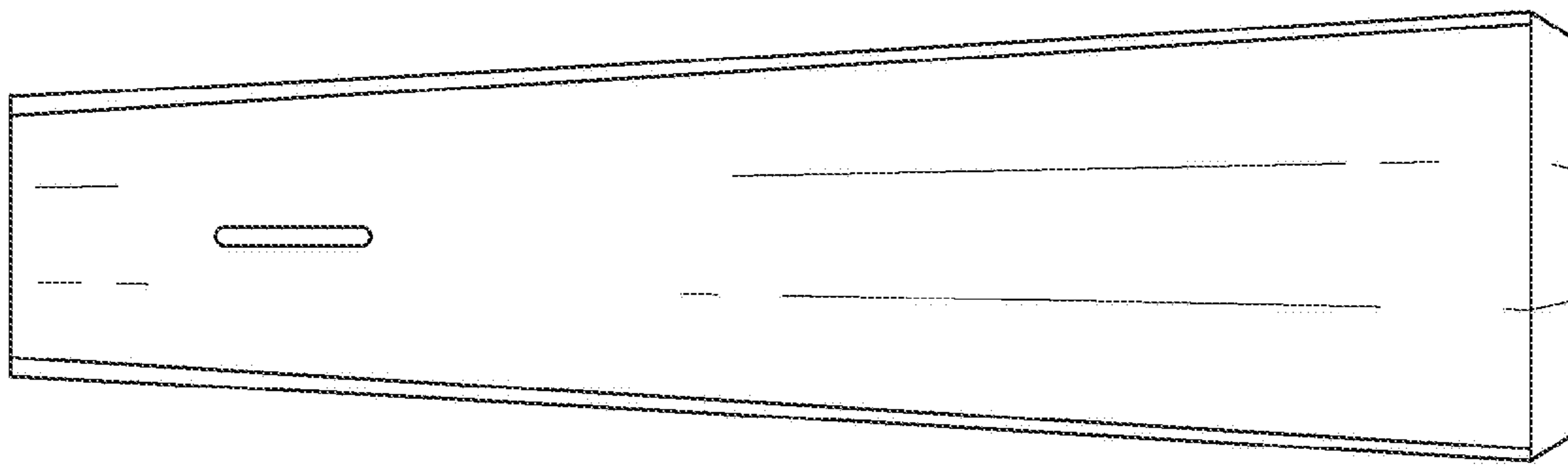

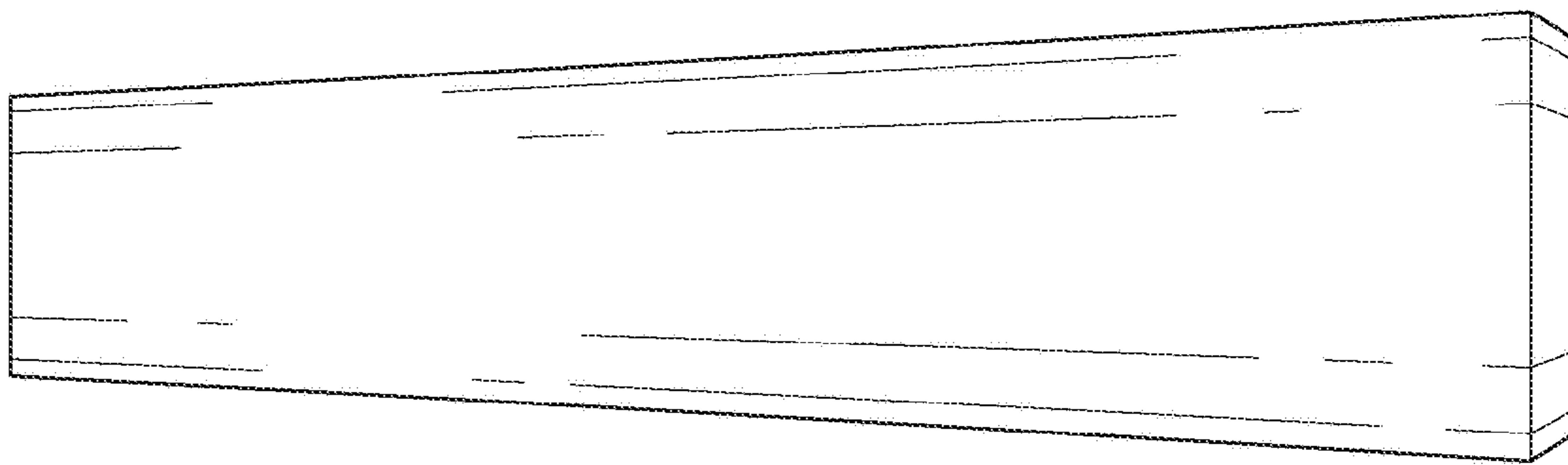

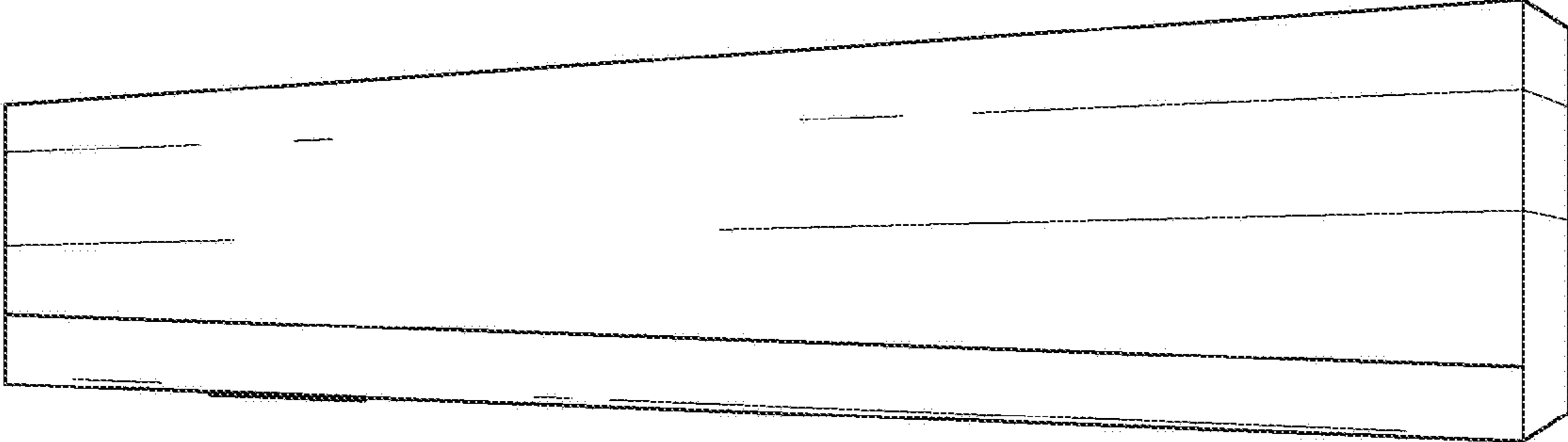

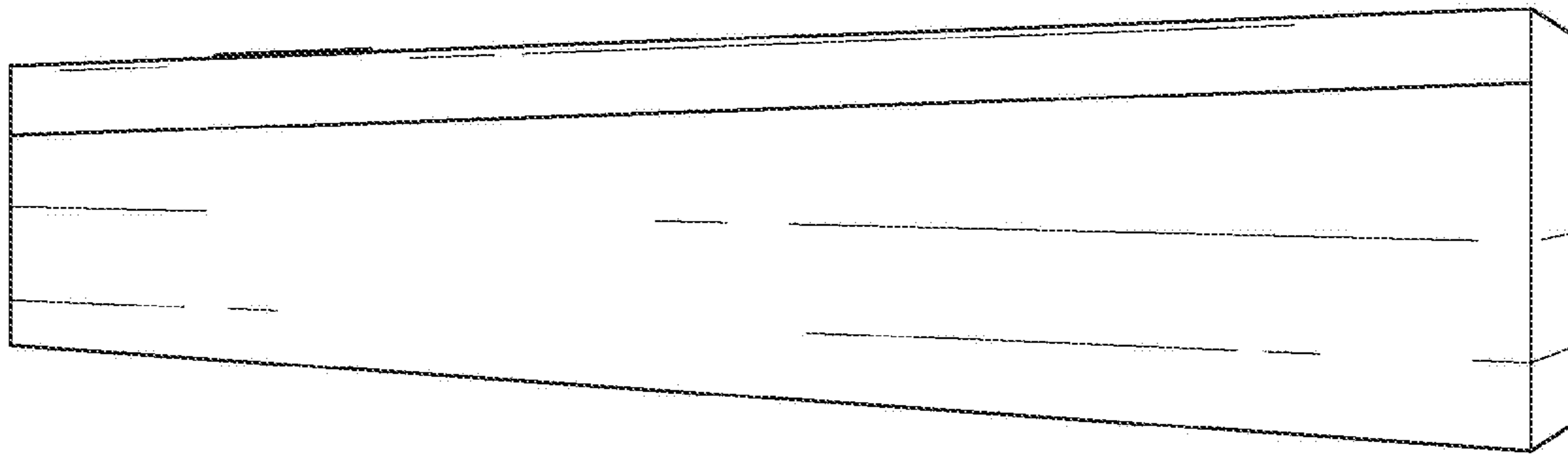

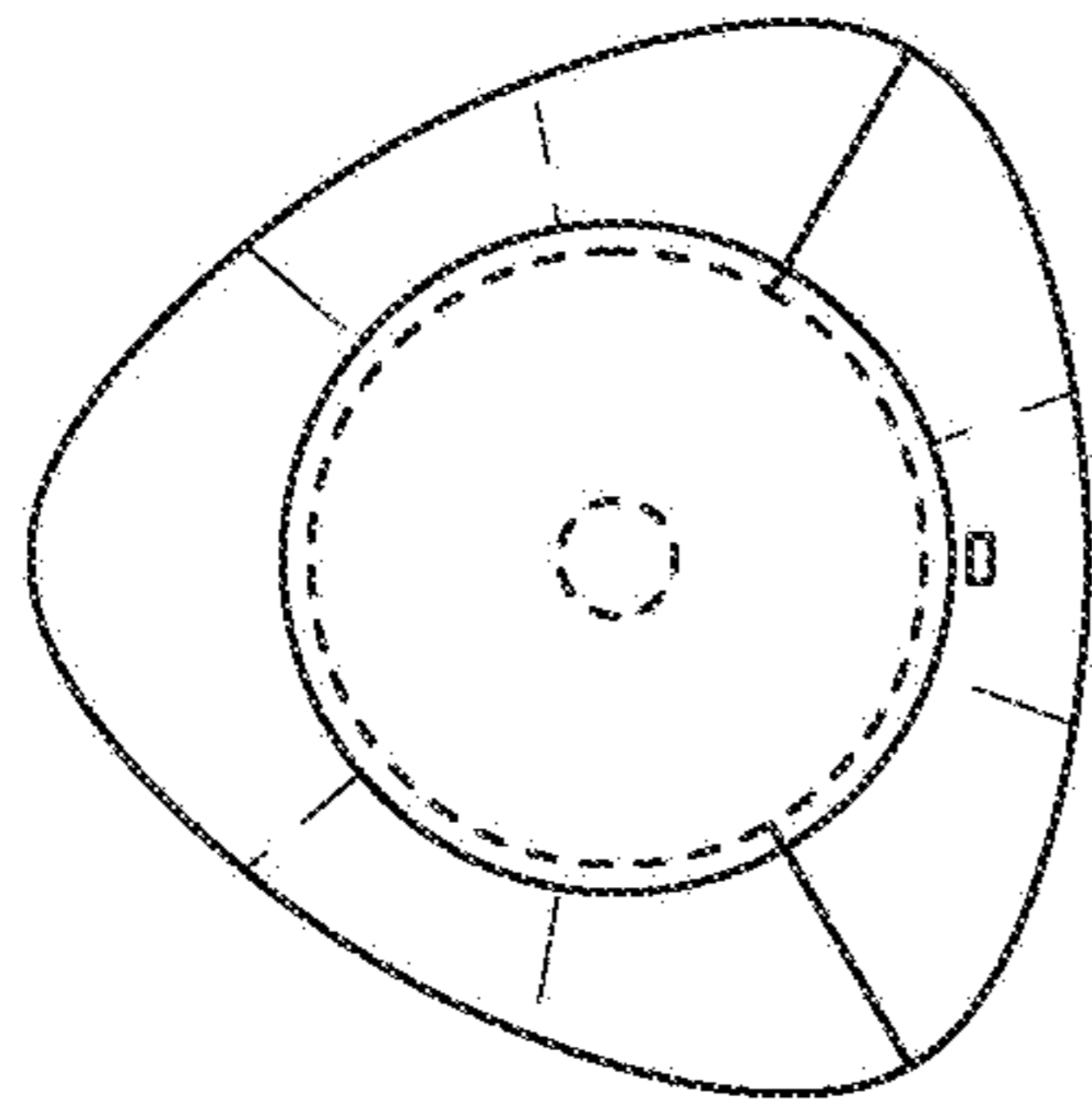

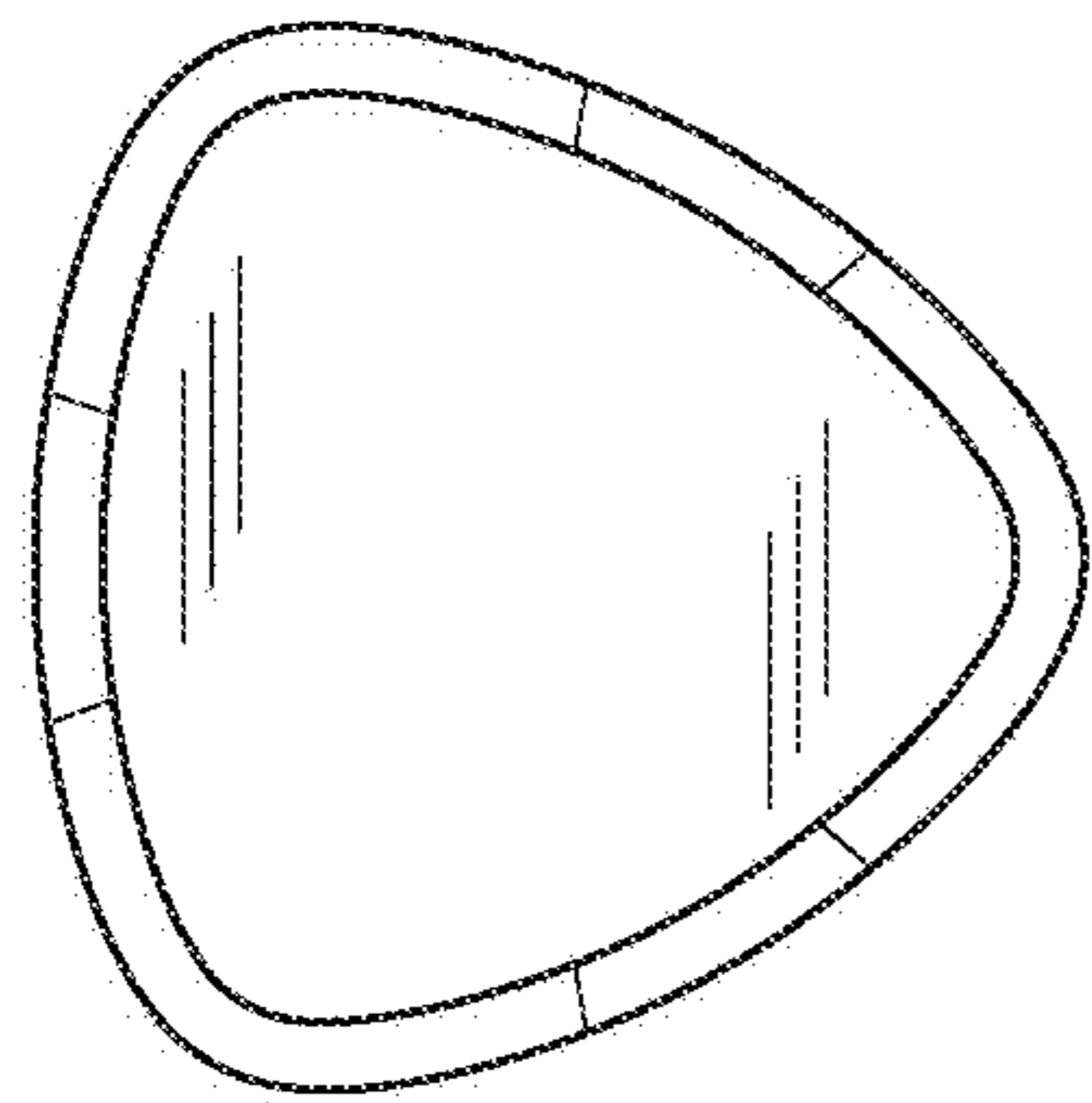

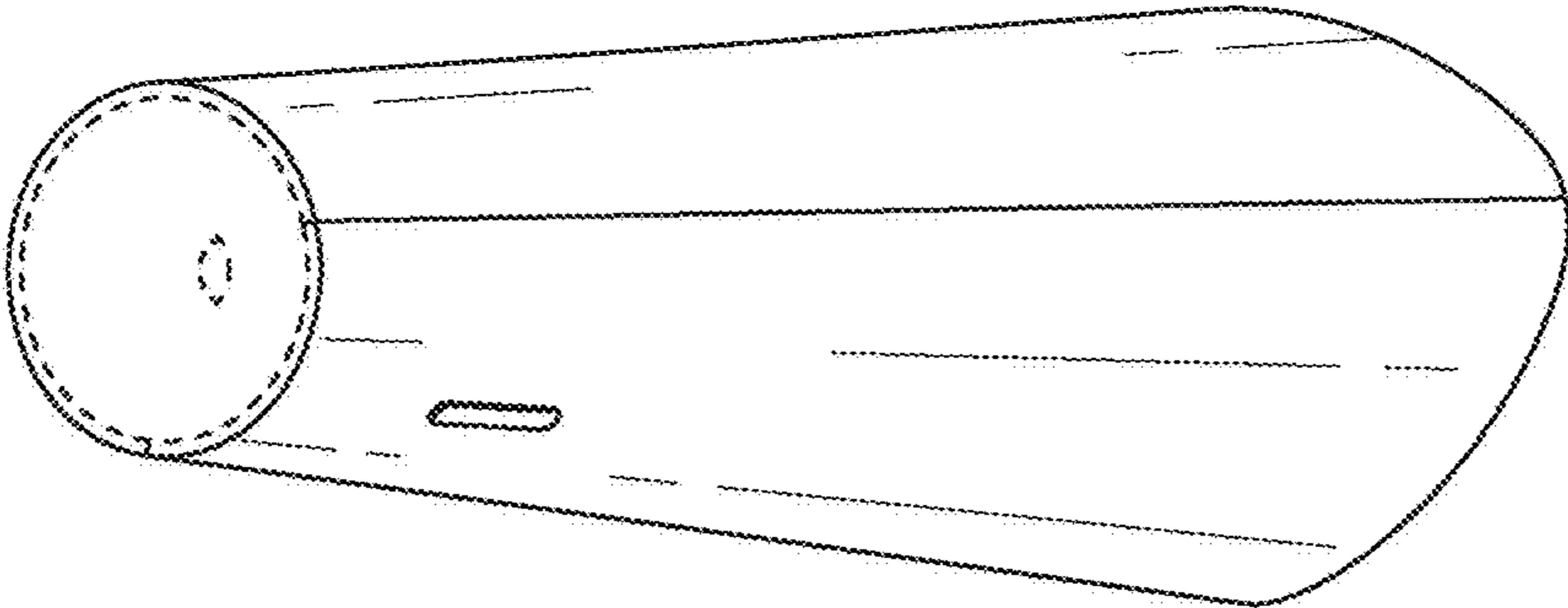

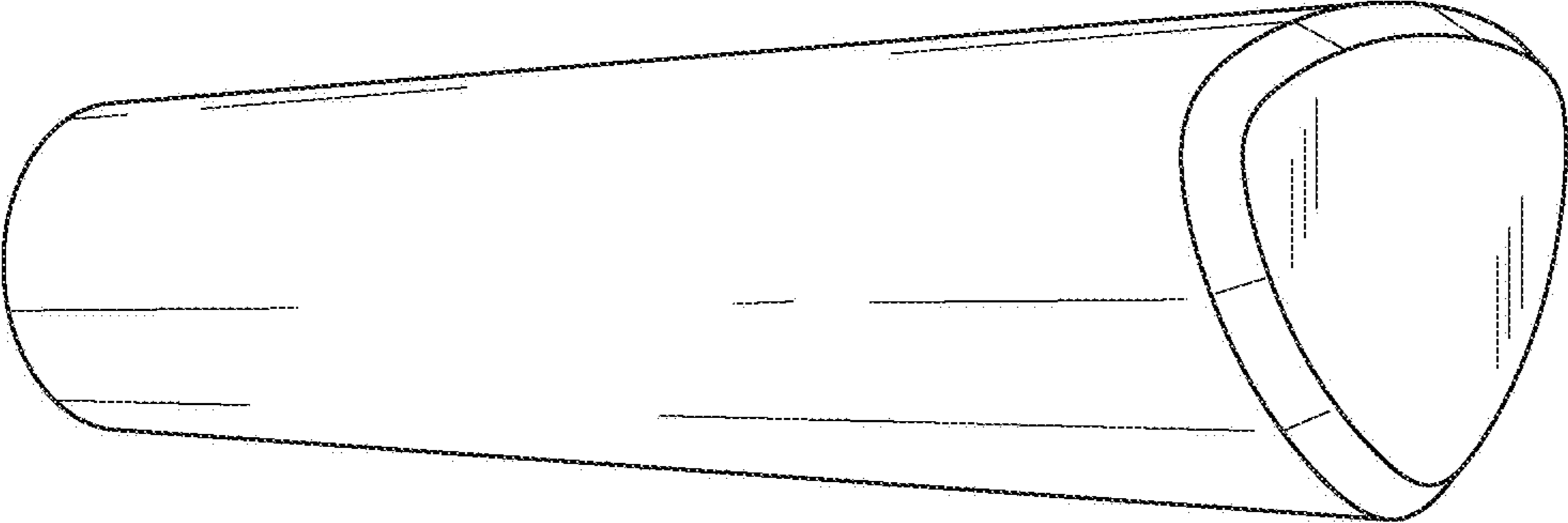
