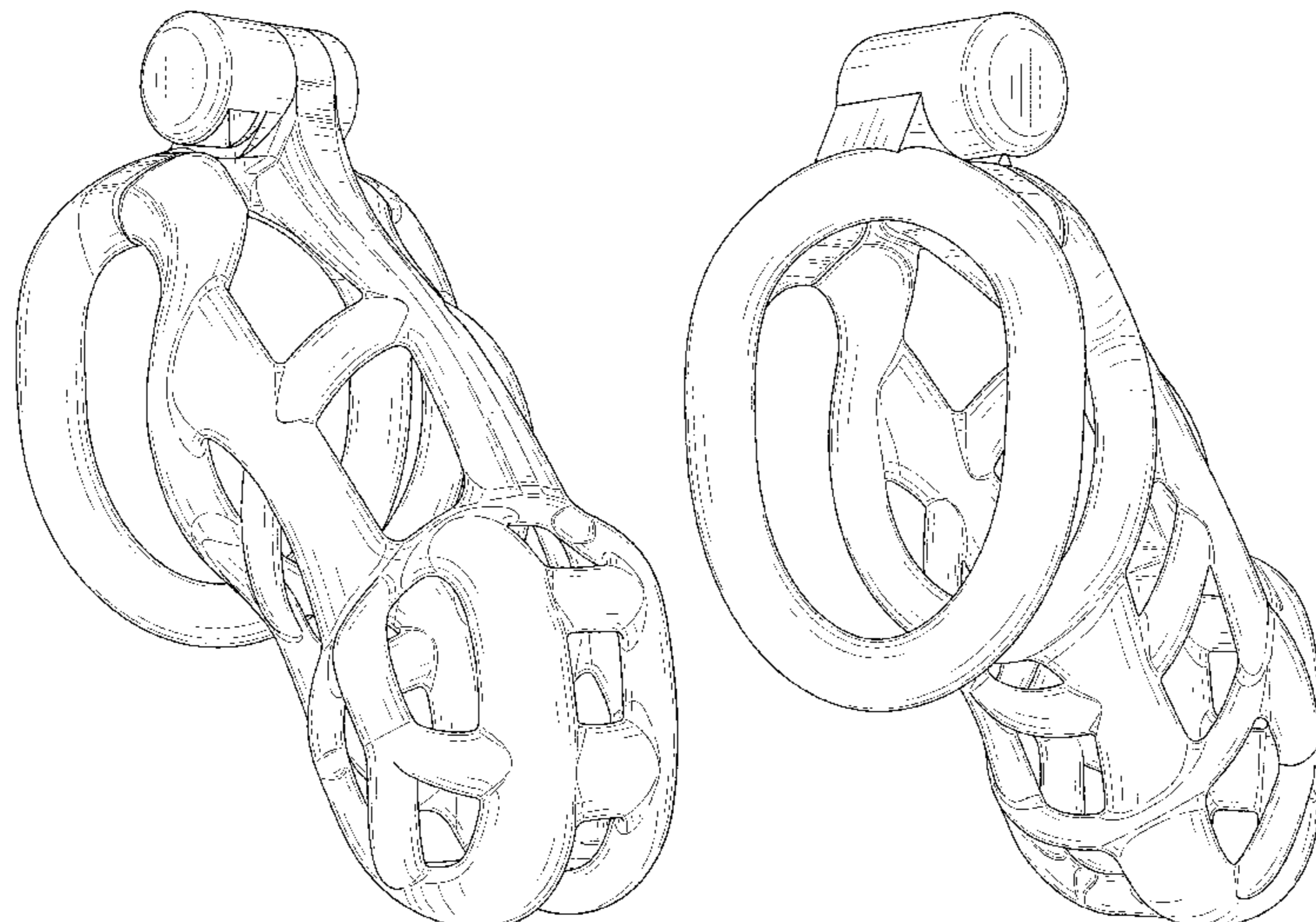
(57) **CLAIM**

I claim the ornamental design for a male chastity apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front perspective view of a male chastity apparatus showing my new design in a fully assembled state. FIG. 2 is a right side view thereof. FIG. 3 is a right back perspective view thereof. FIG. 4 is a back view thereof. FIG. 5 is a left back perspective view thereof. FIG. 6 is a left side view thereof. FIG. 7 is a left front perspective view thereof. FIG. 8 is a front view thereof. FIG. 9 is a right front perspective view of the shaft cage of the male chastity apparatus of FIG. 1. FIG. 10 is a right side view thereof. FIG. 11 is a right back perspective view thereof. FIG. 12 is a front view thereof. FIG. 13 is a bottom back perspective view thereof. FIG. 14 is a front view of the base ring of the male chastity apparatus of FIG. 1. FIG. 15 is a left front perspective view thereof; and, FIG. 16 is a left side view thereof.

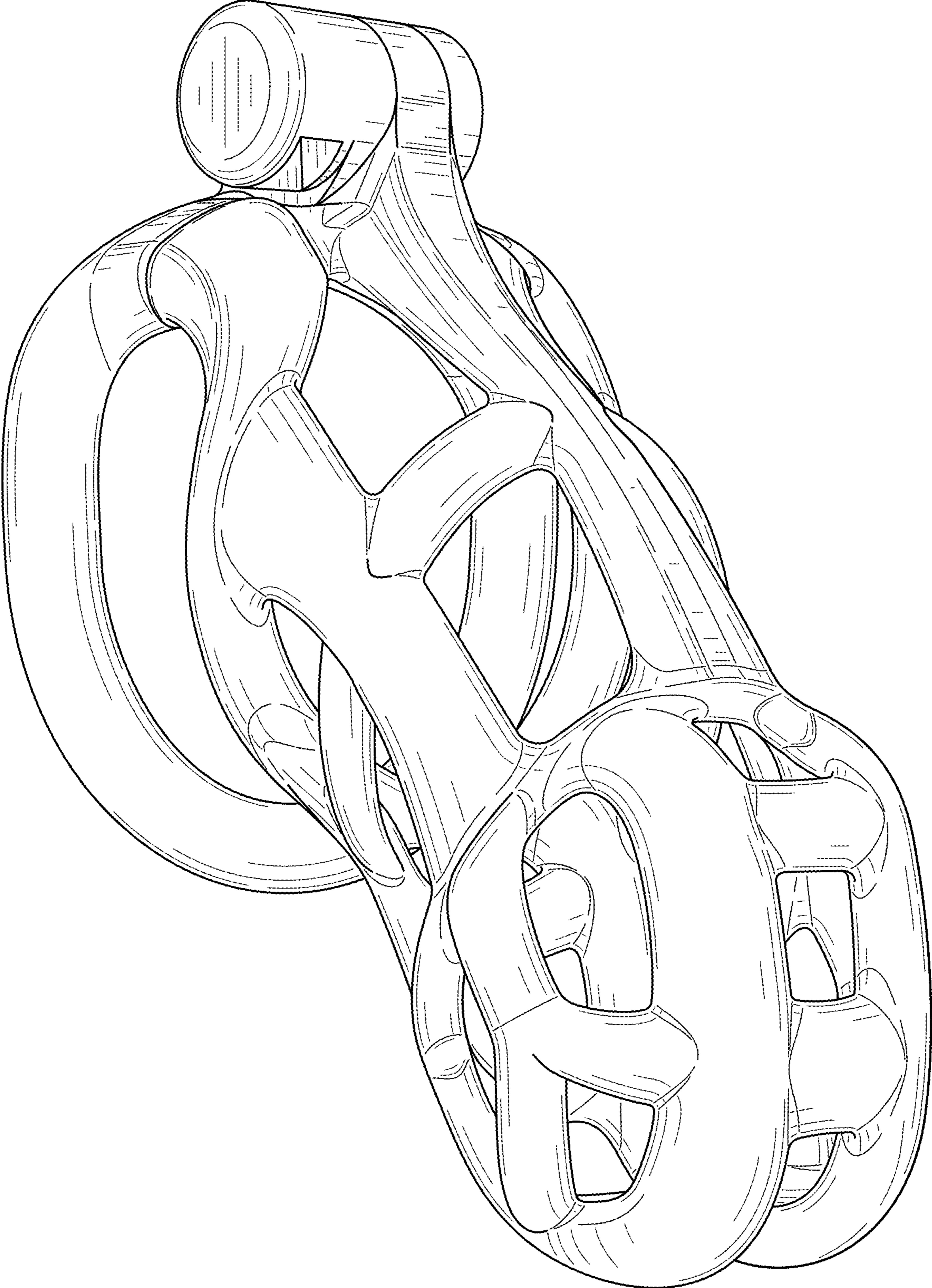

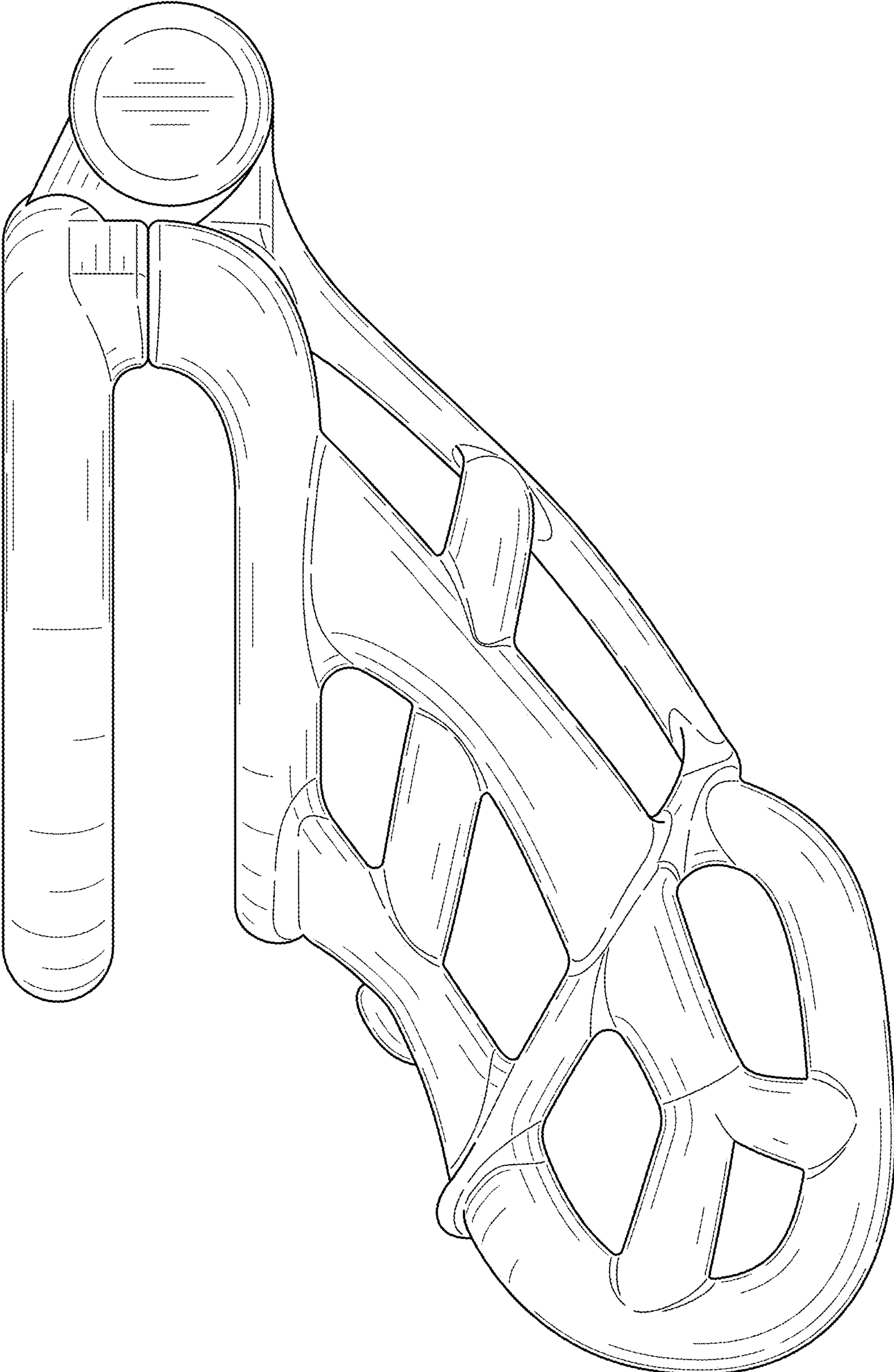

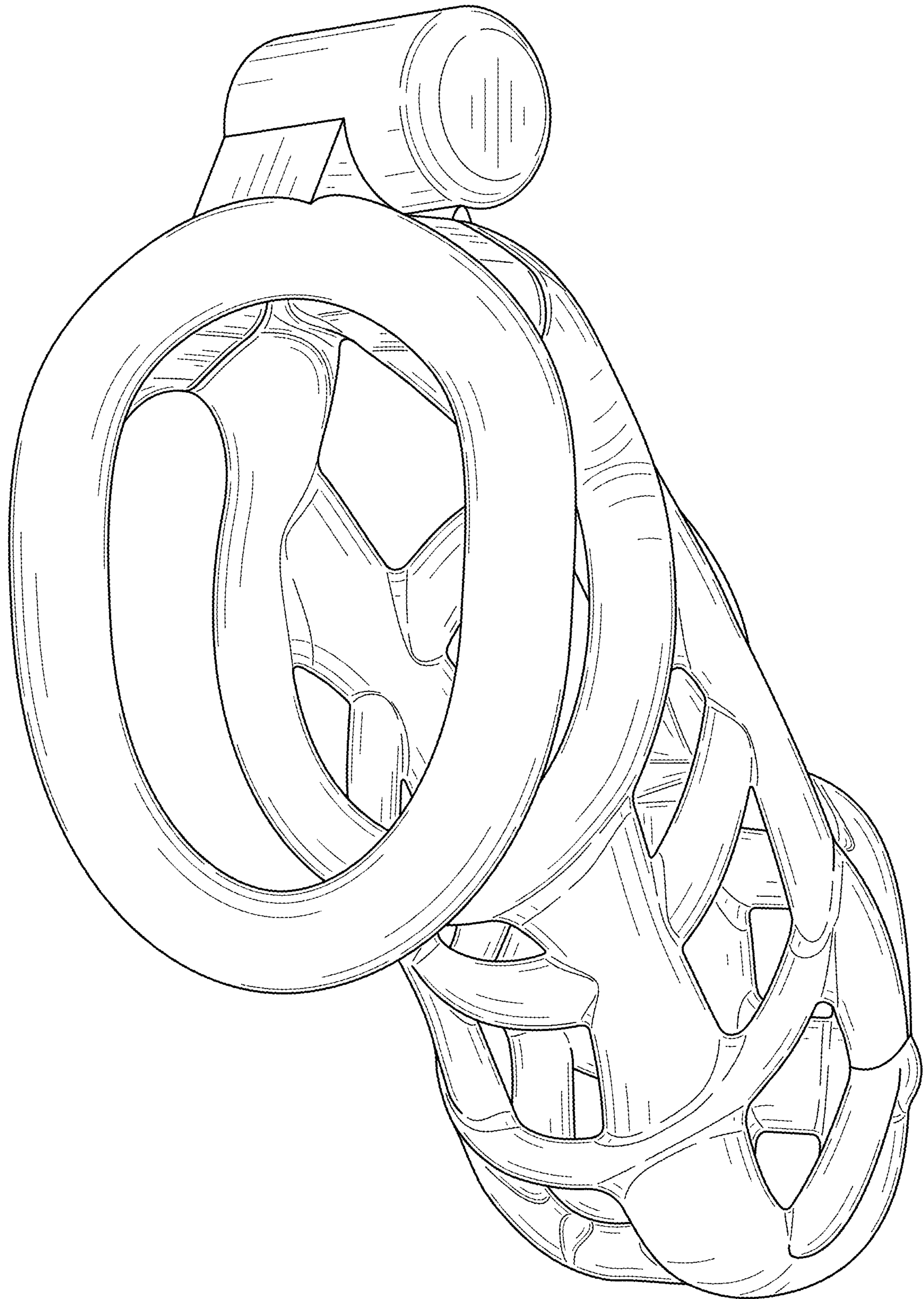

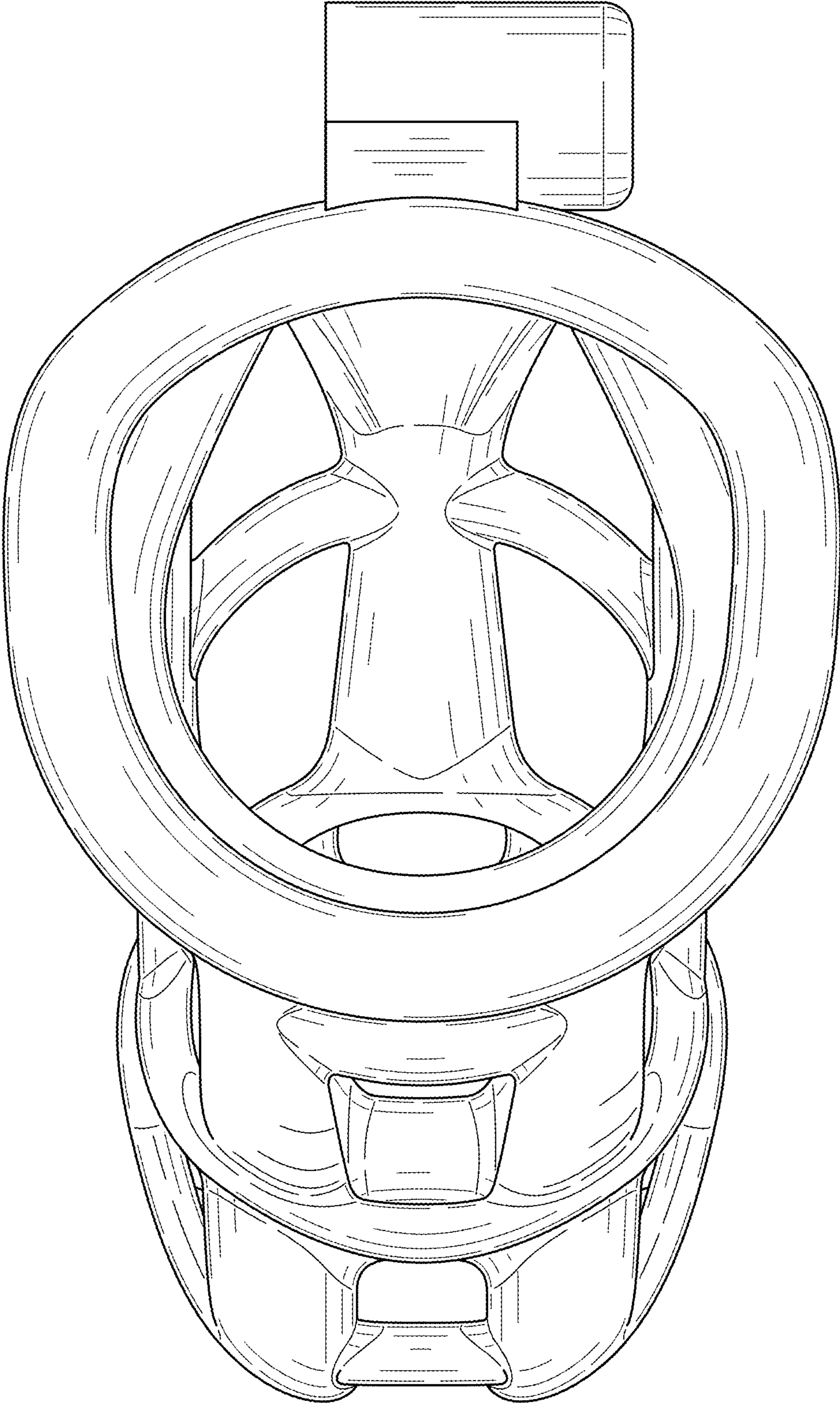

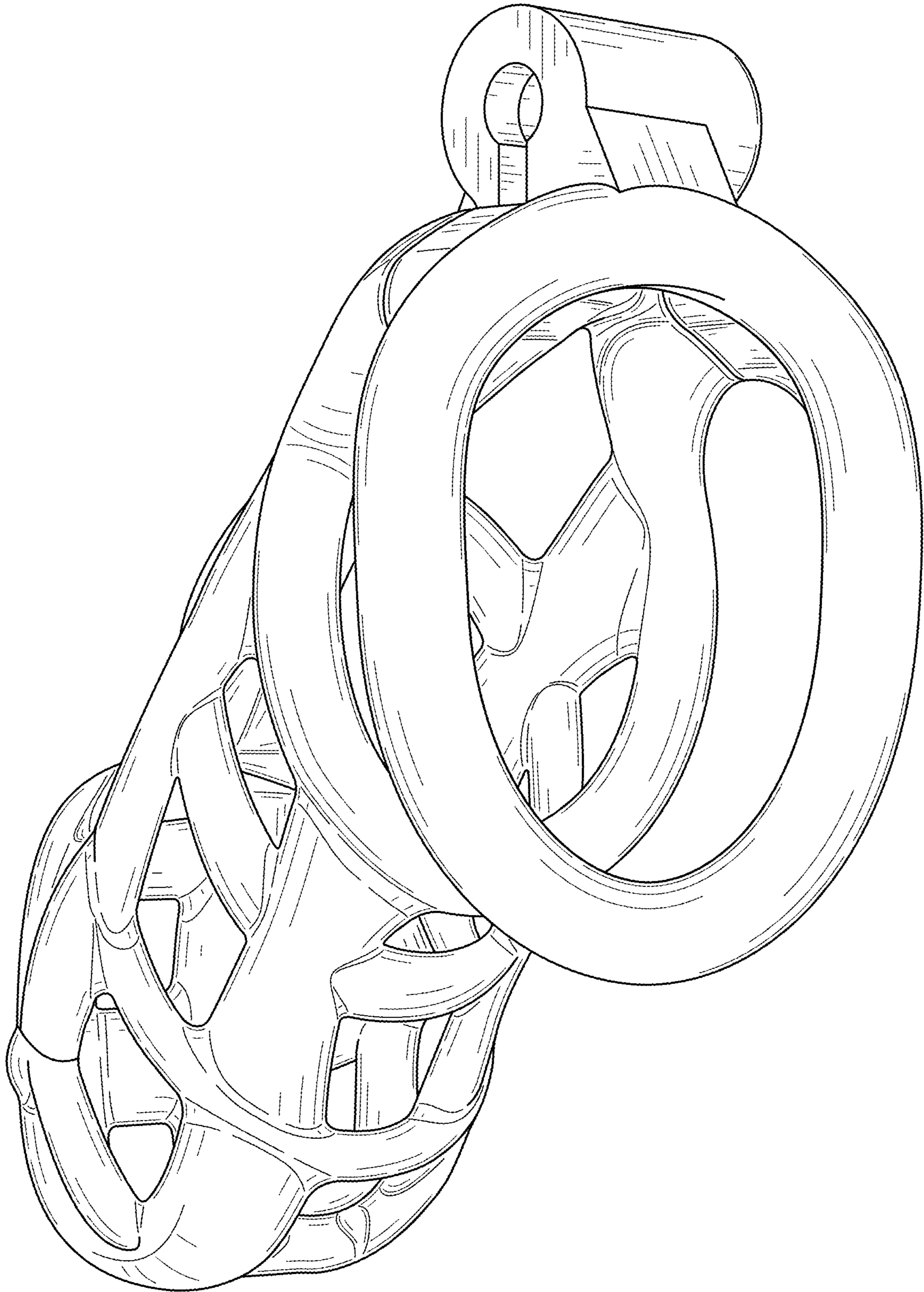

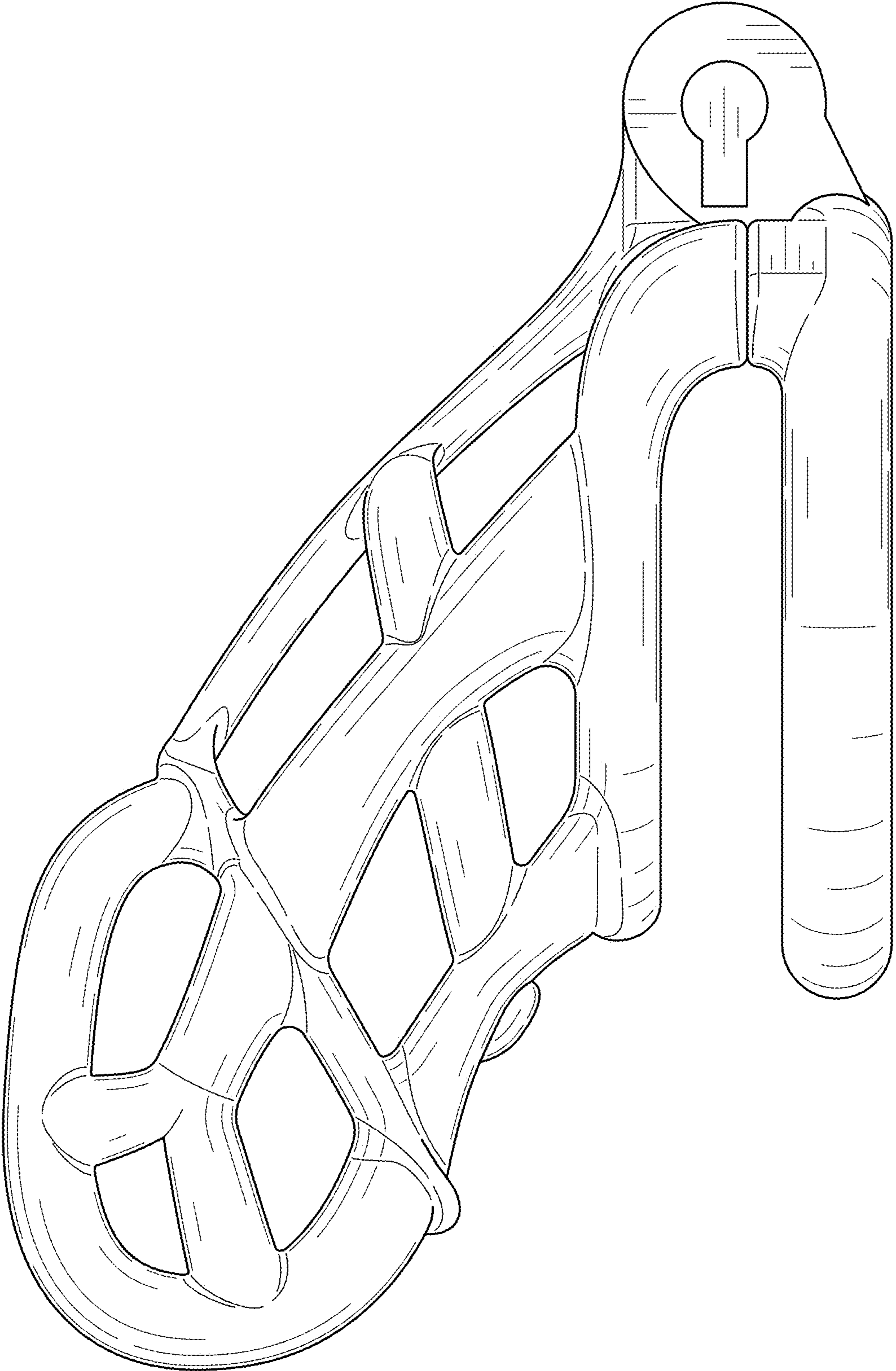

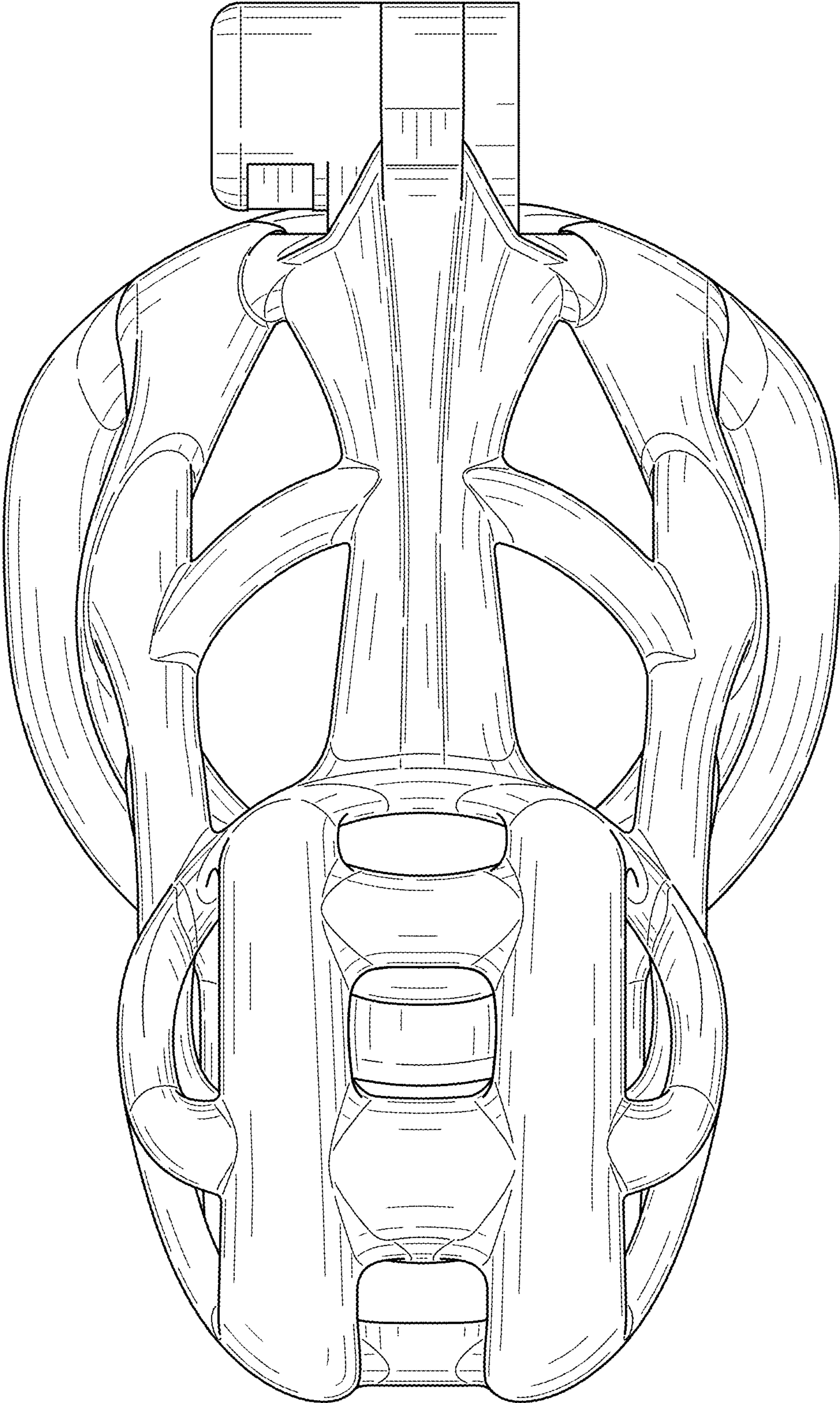

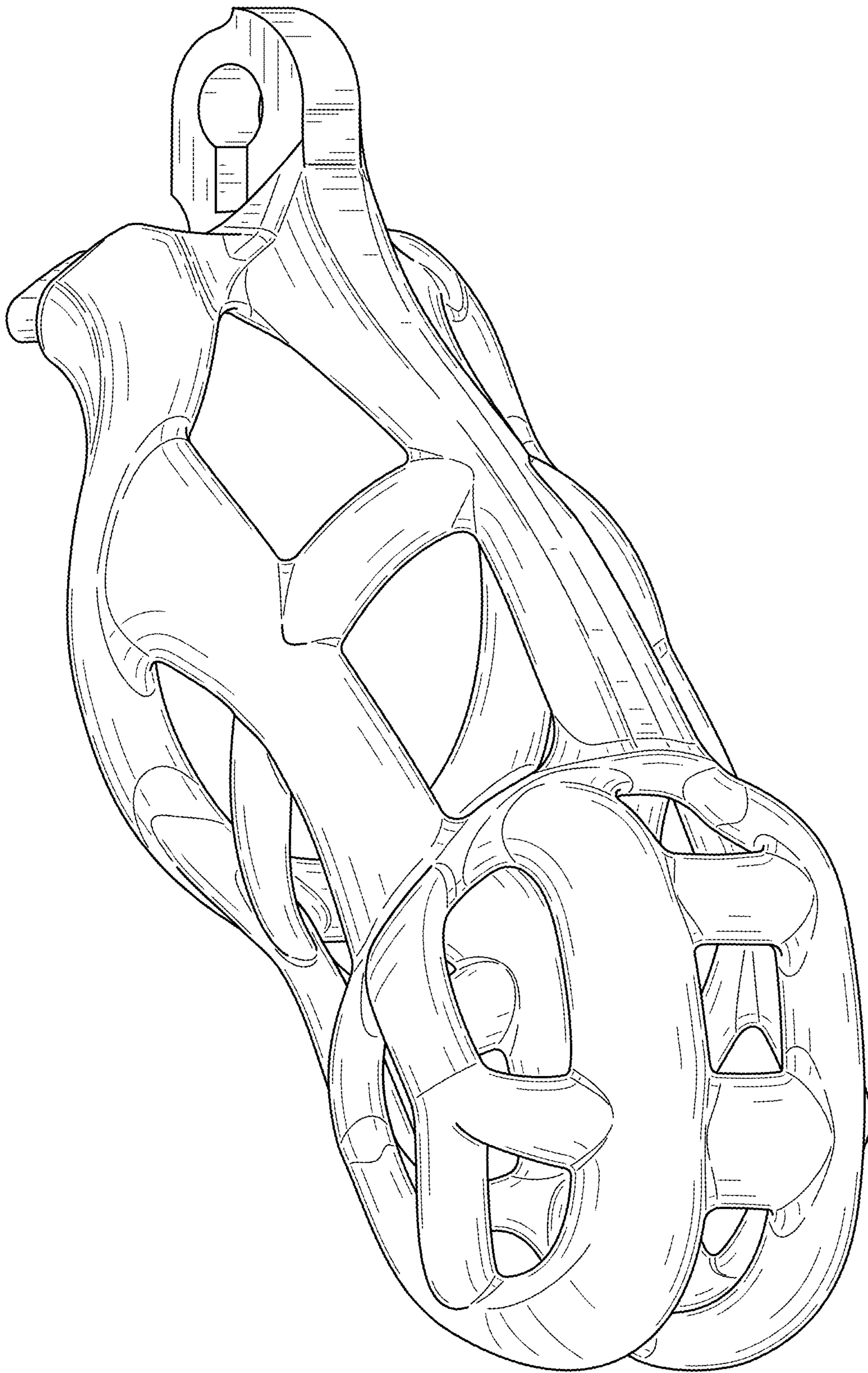

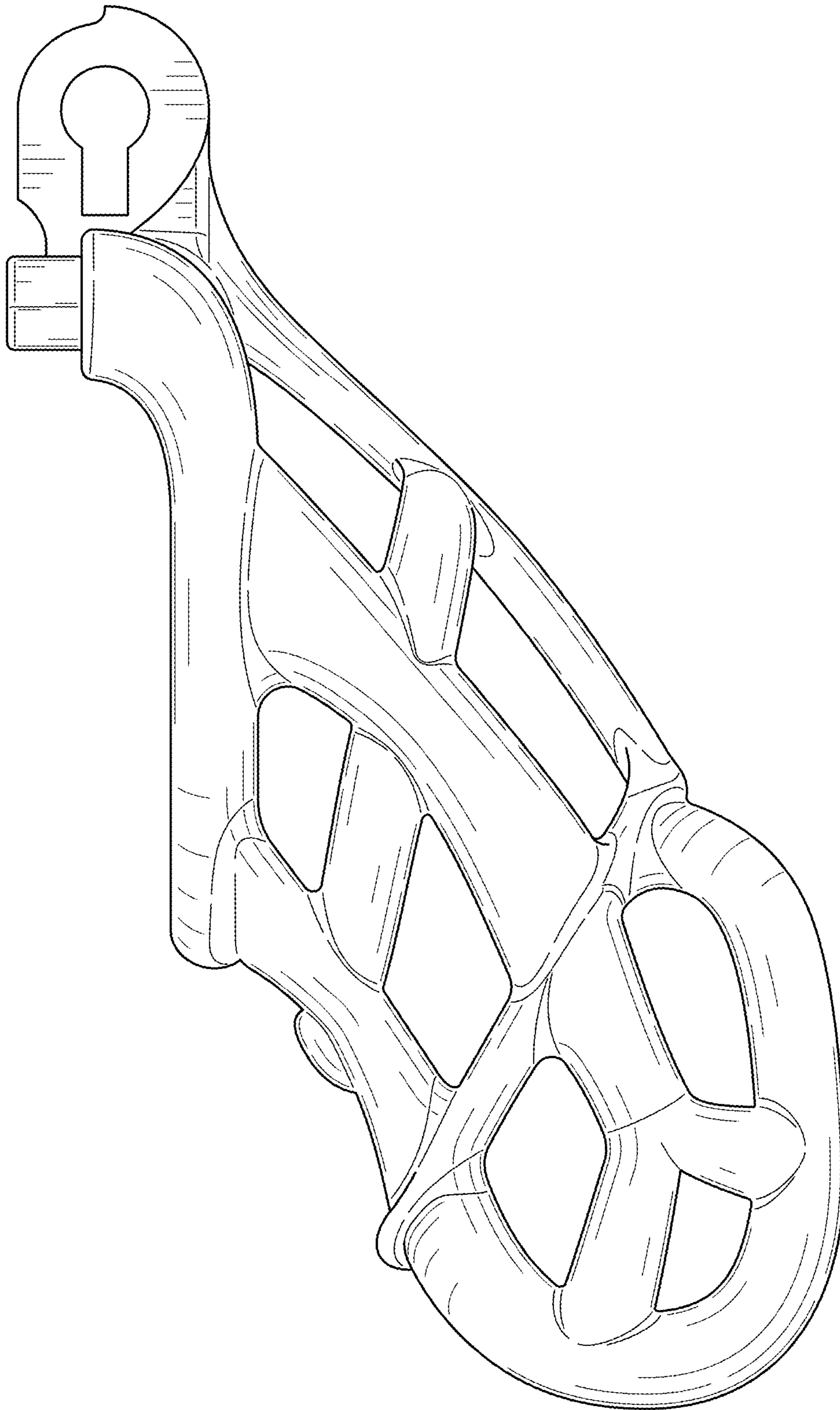

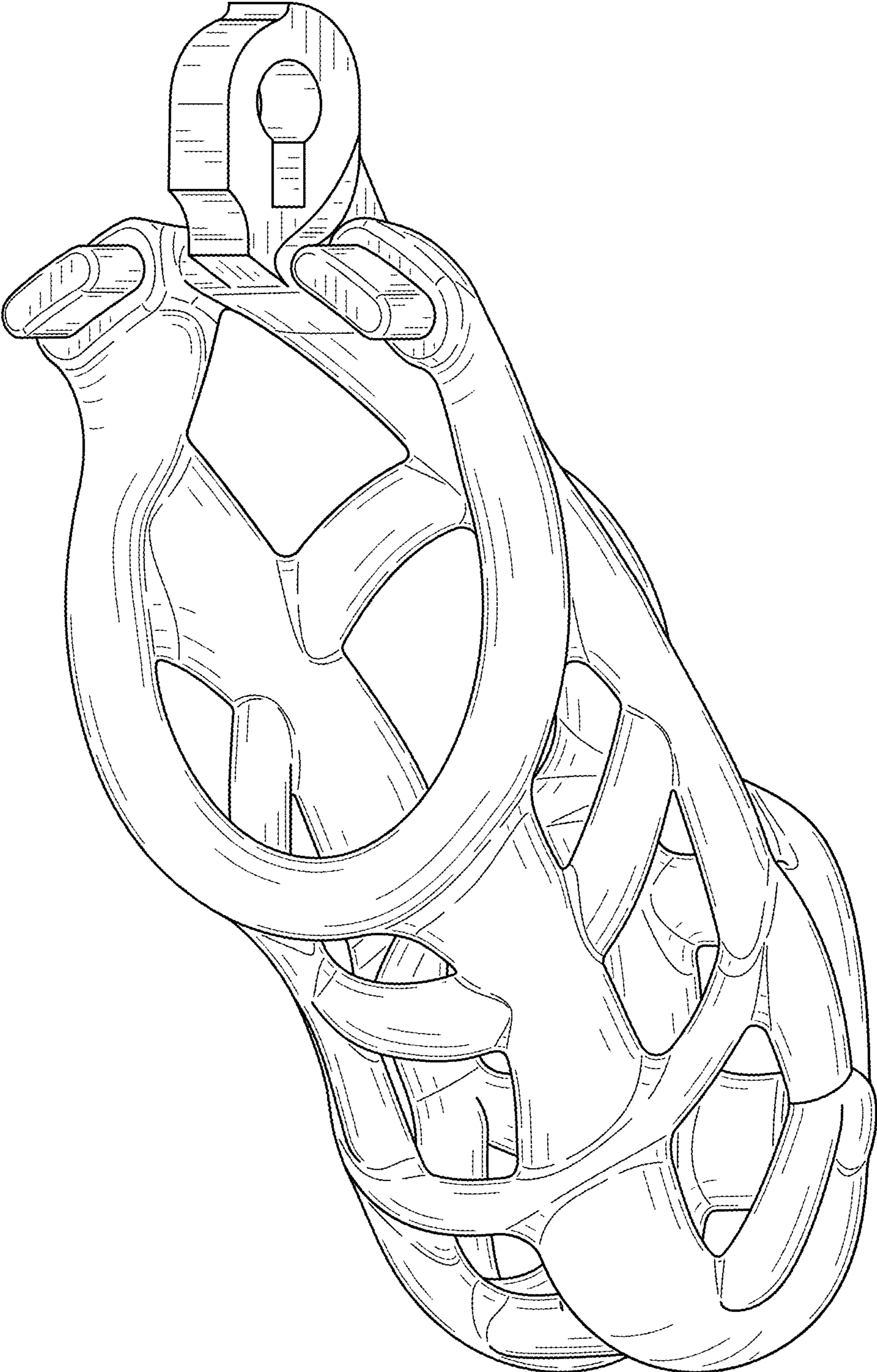

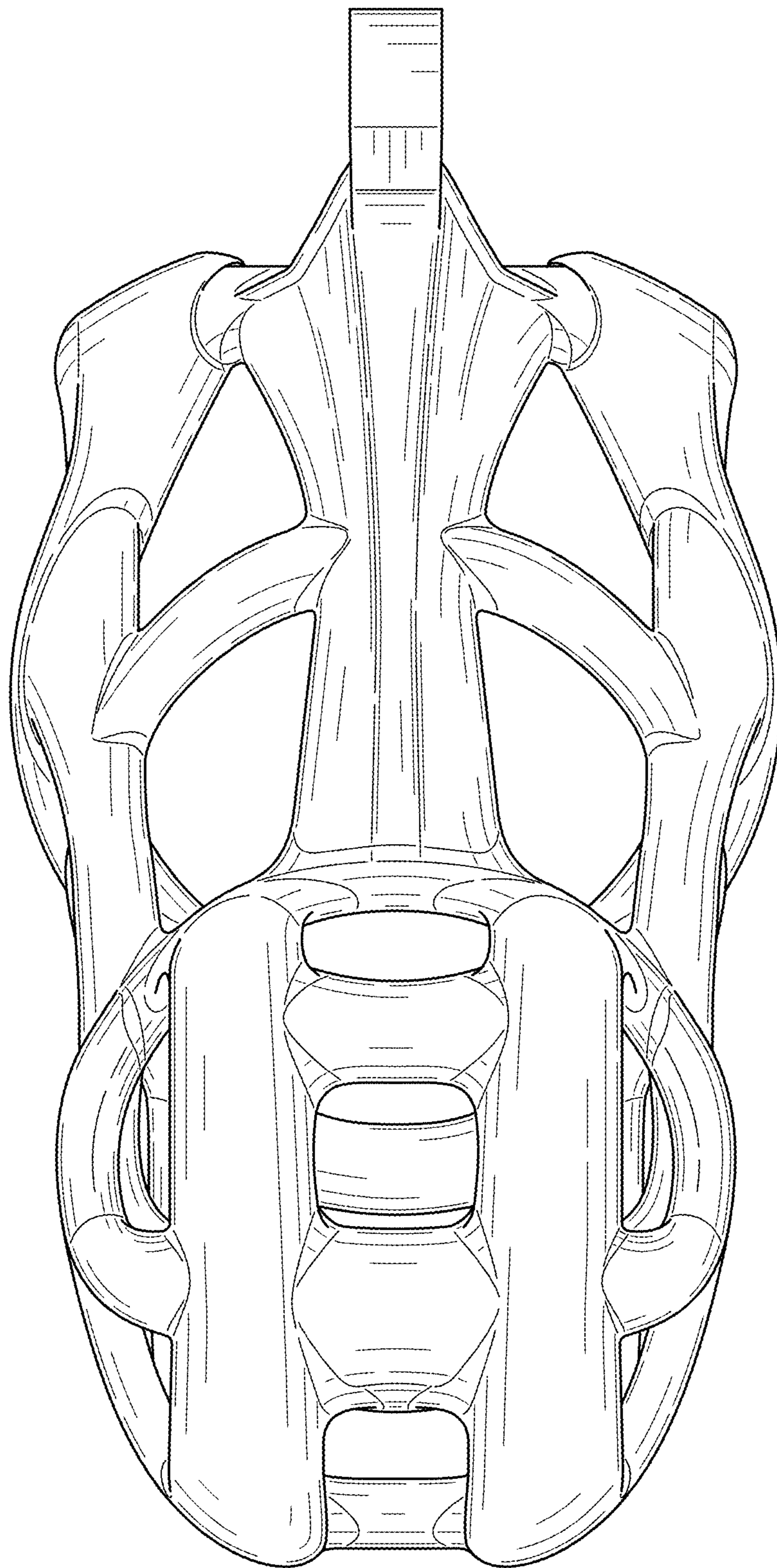

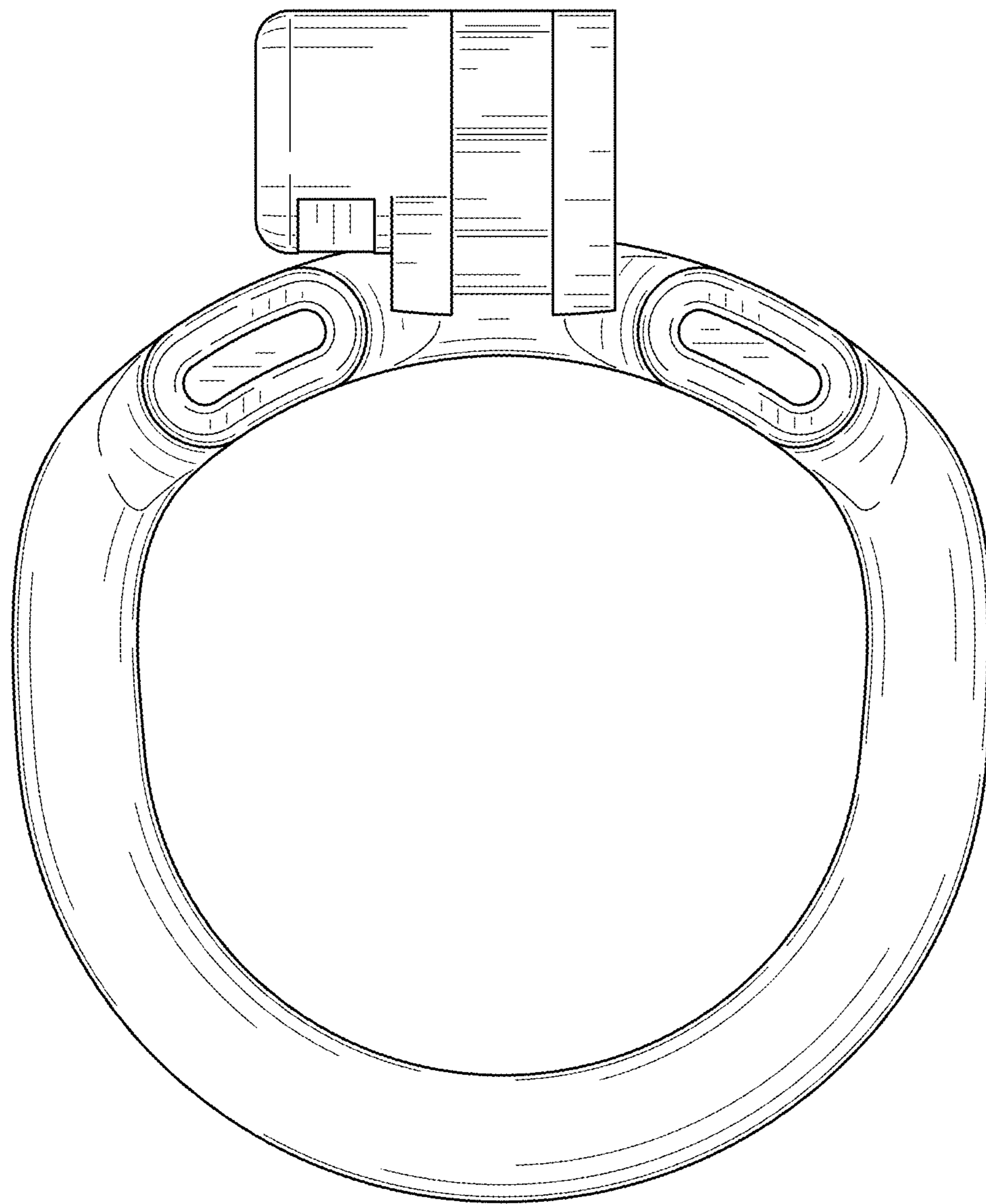

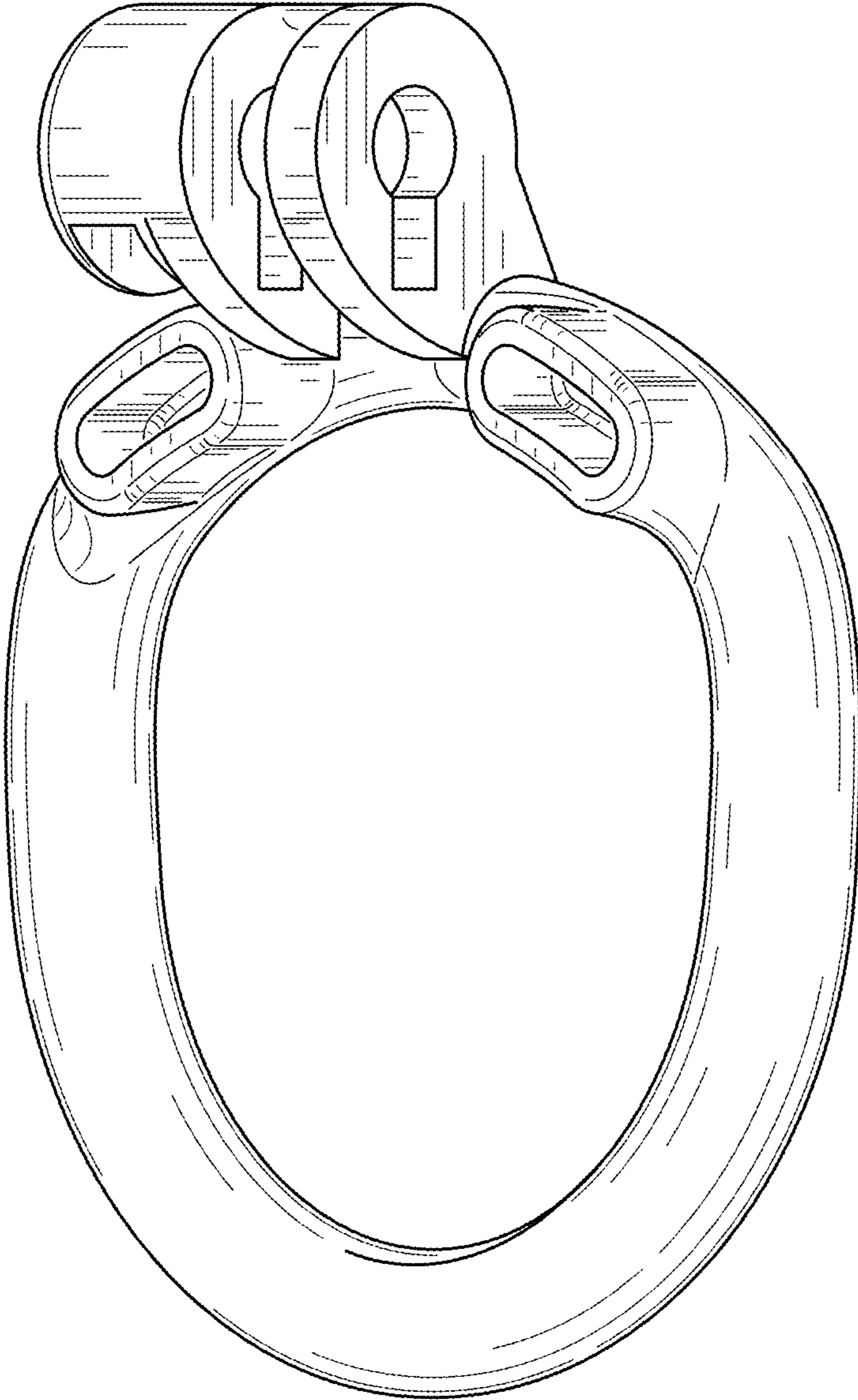

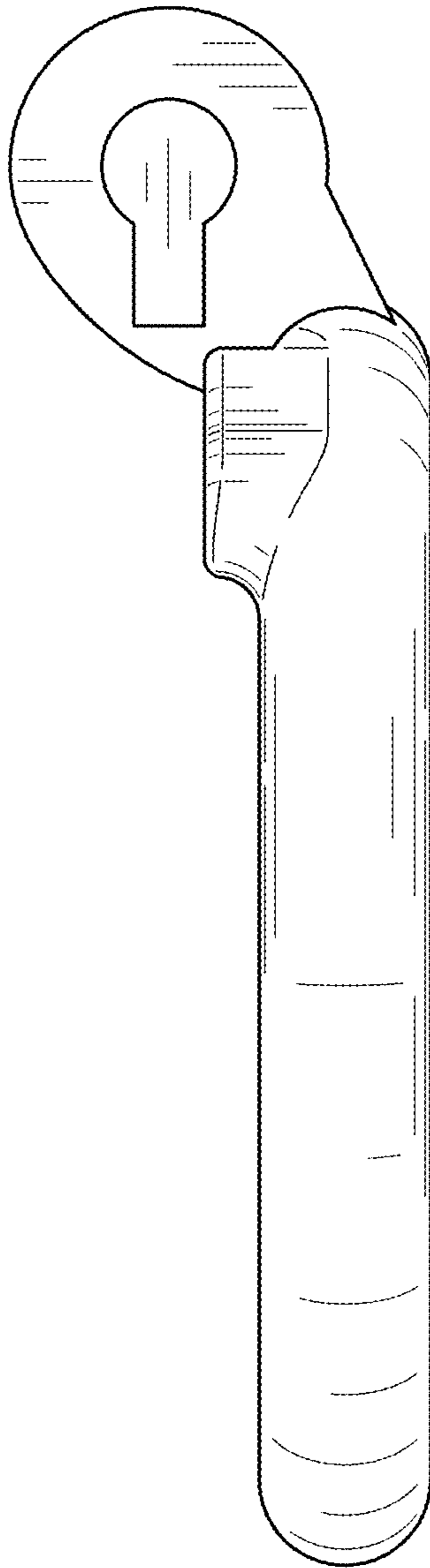
