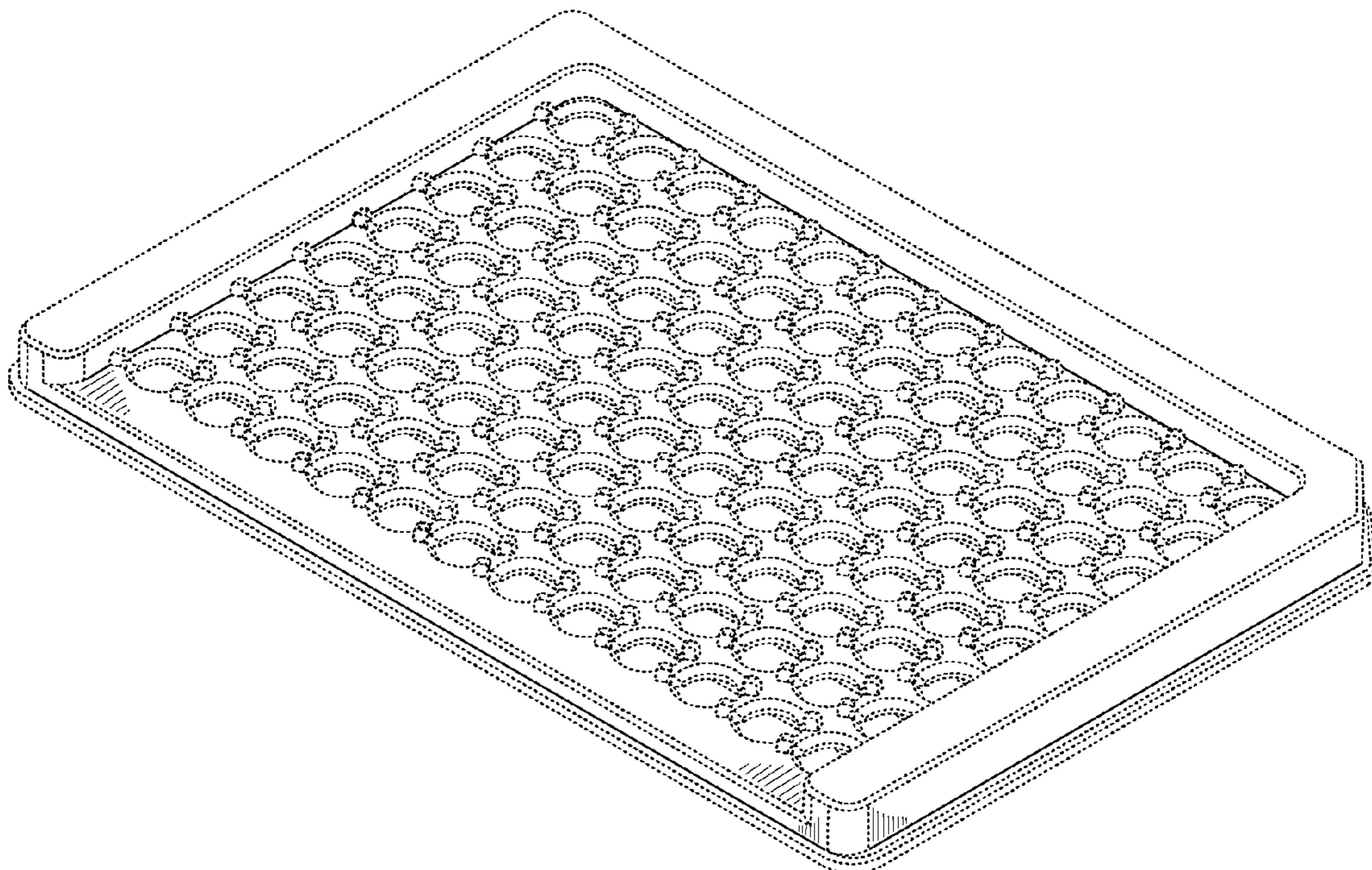
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a tube frame of the present invention;
FIG. 2 is a bottom perspective view thereof;

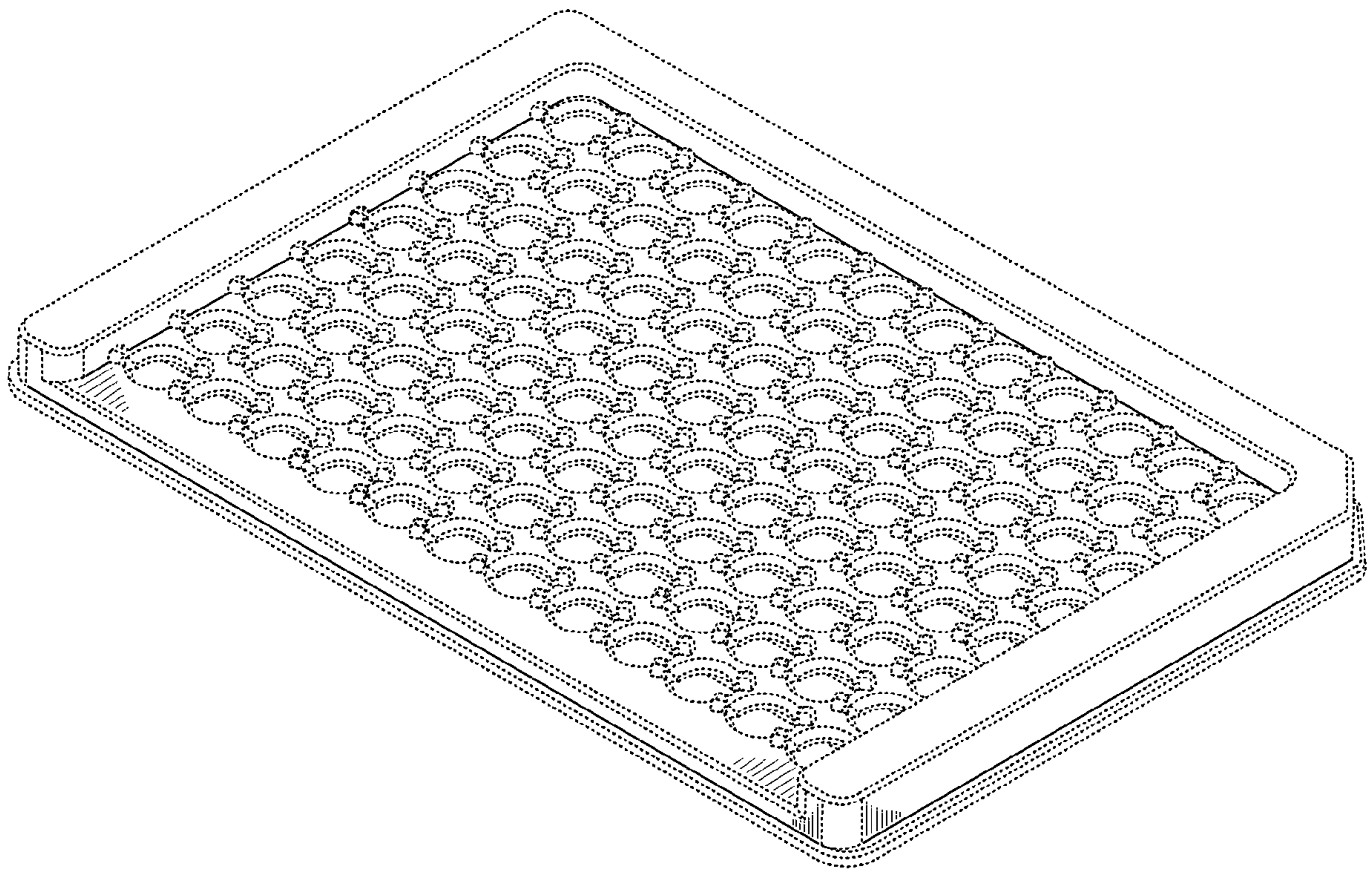

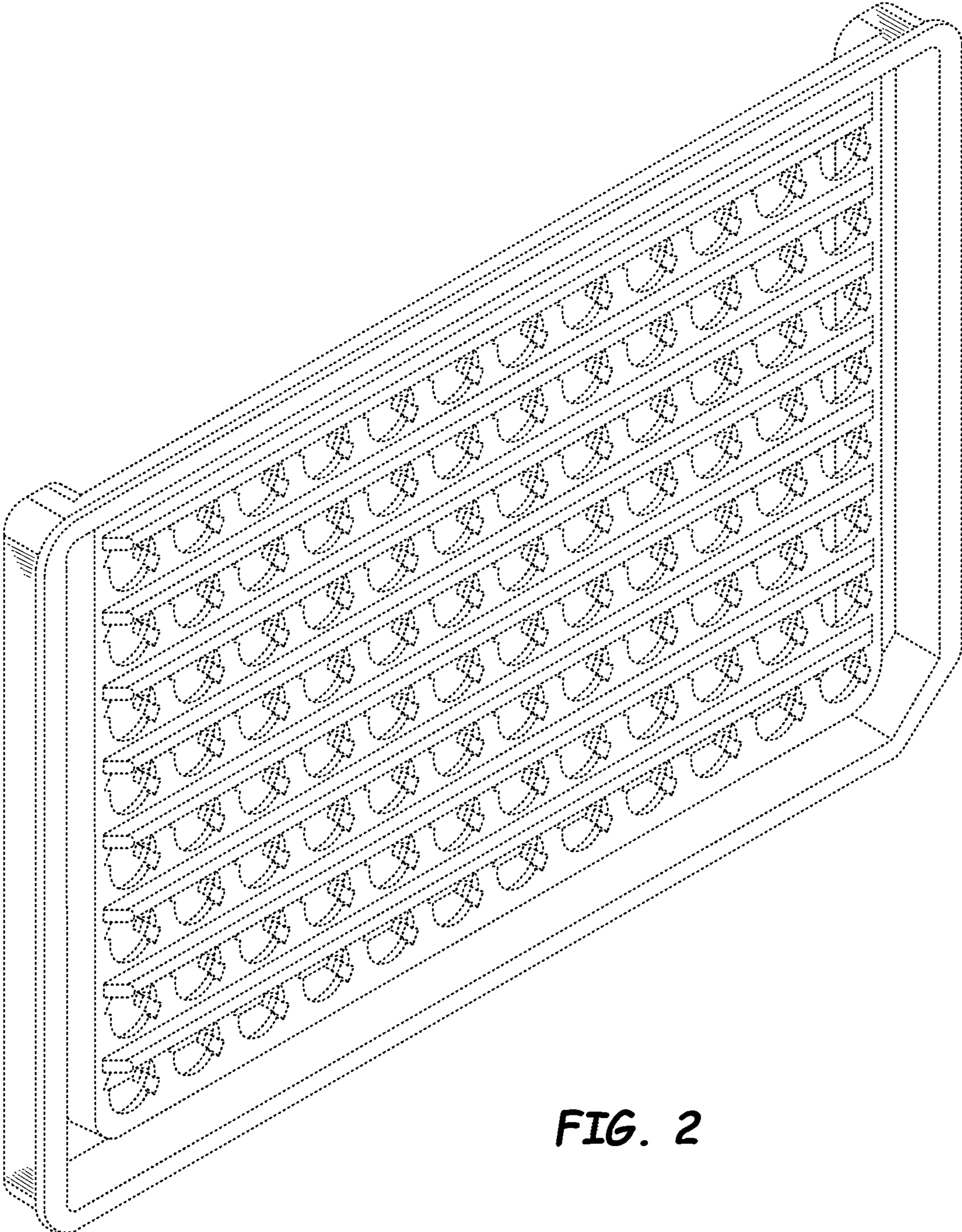

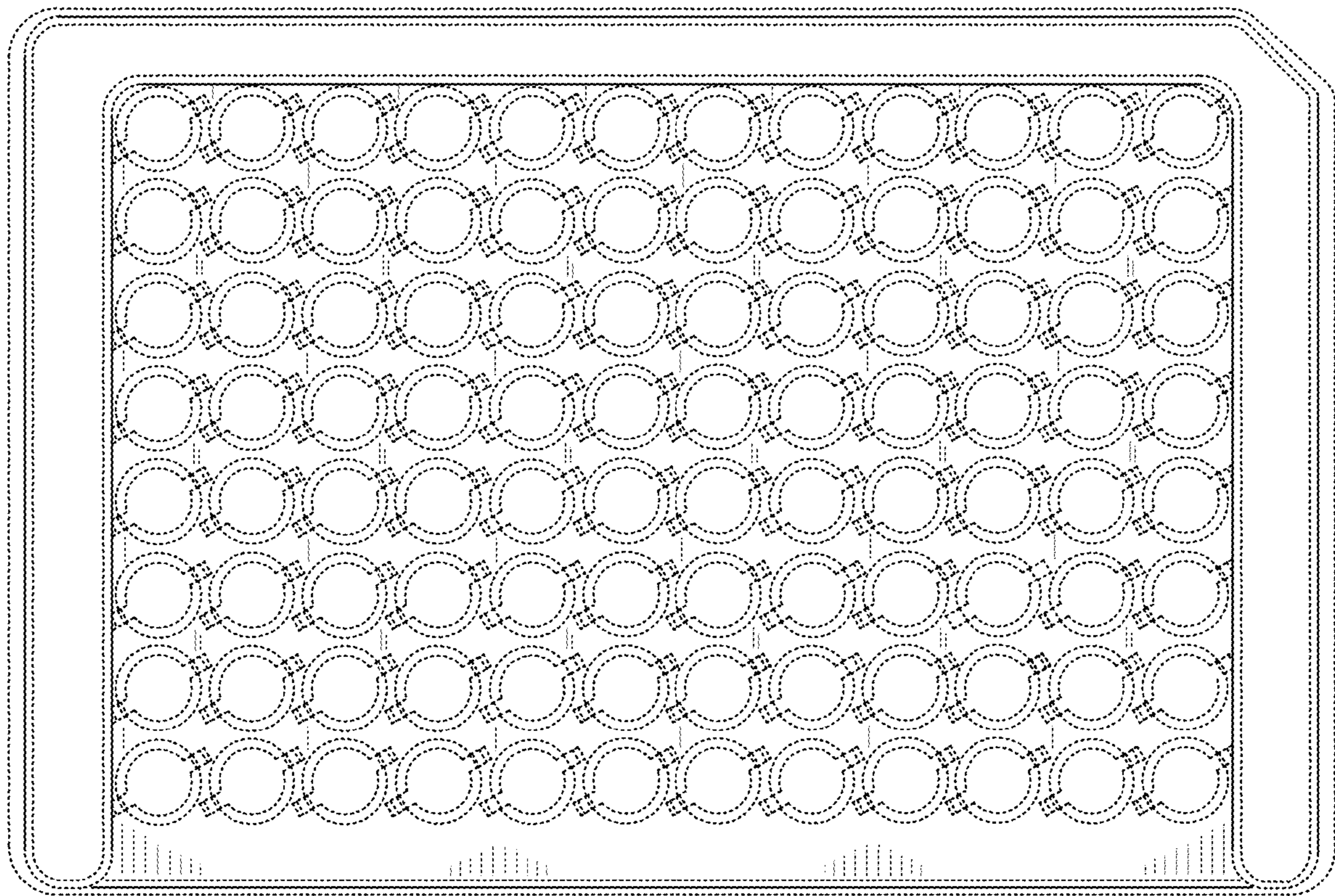

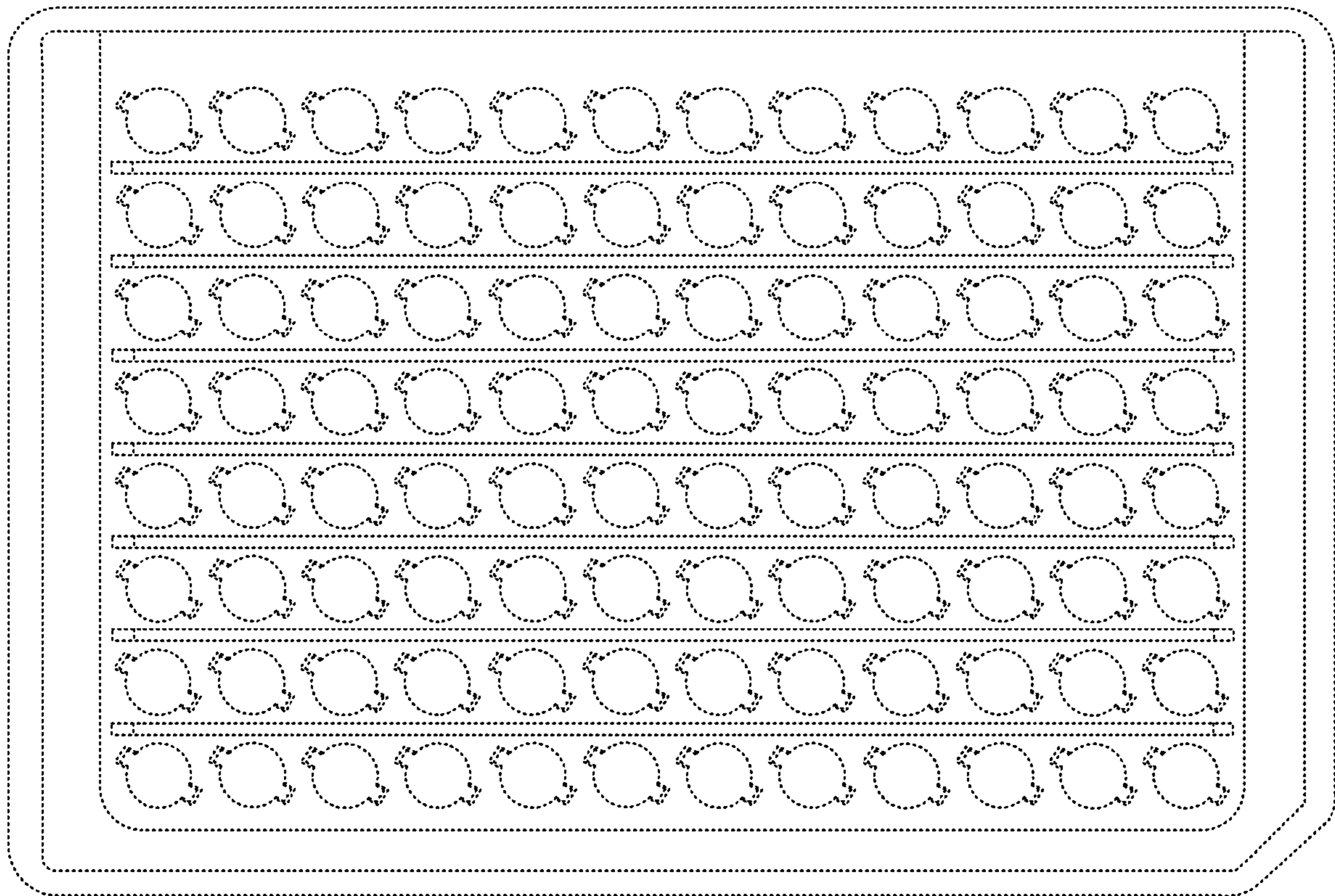

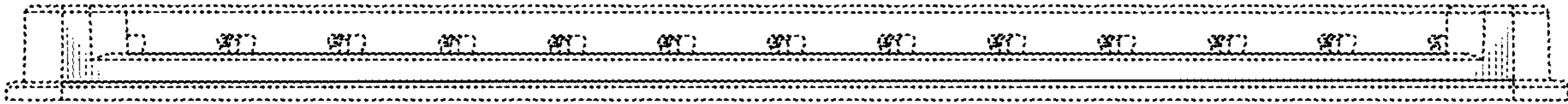

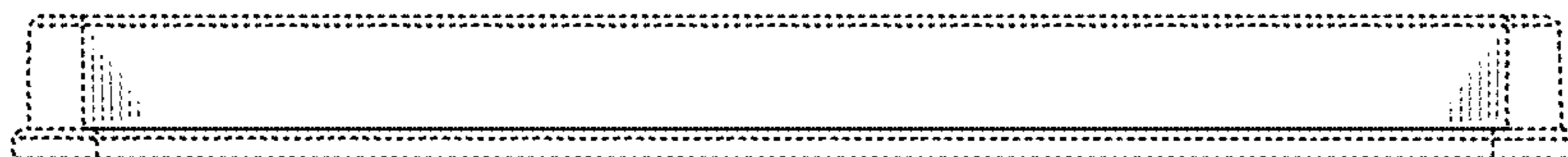

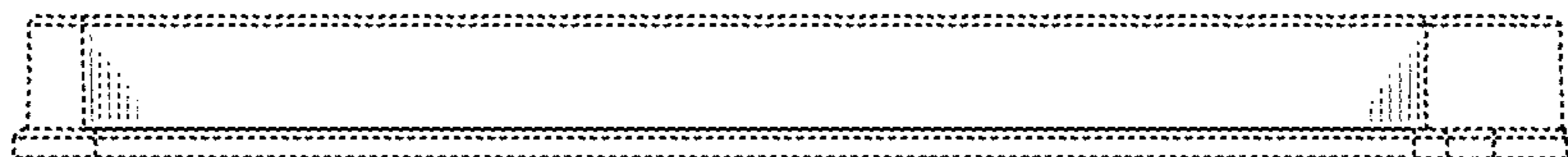
