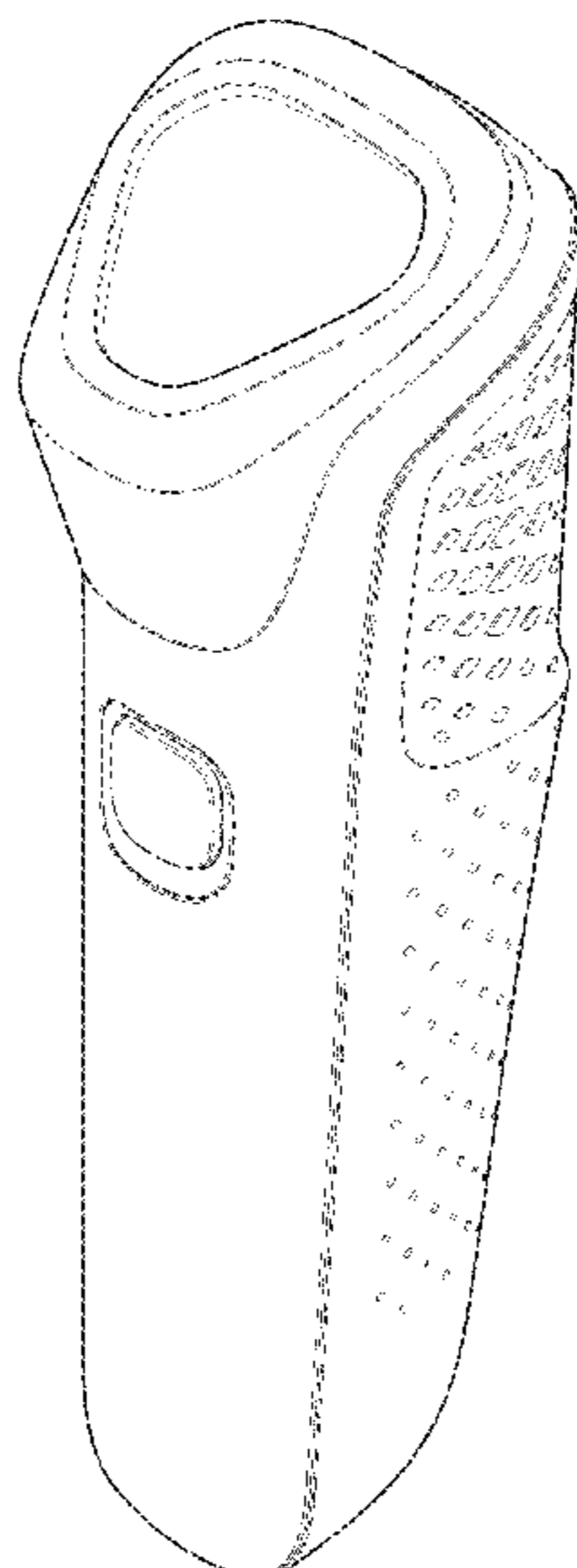
FIG. 1 is a perspective view showing the first embodiment of a handle for shaver;

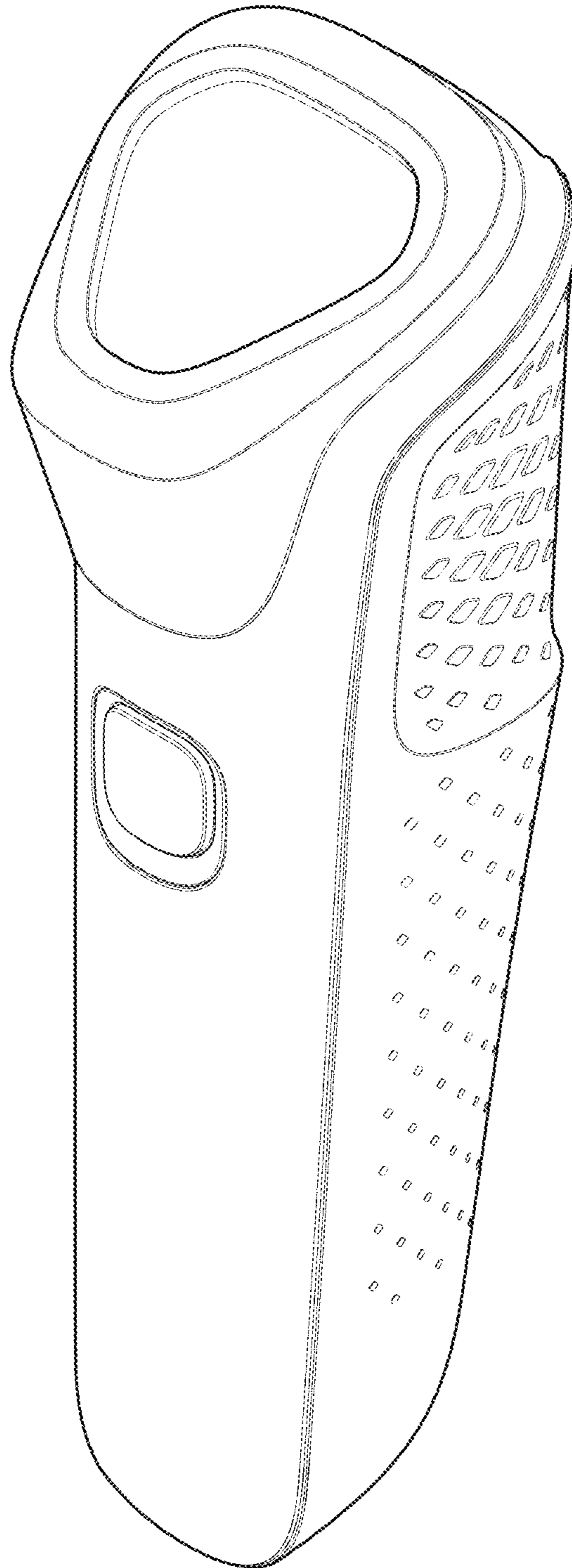

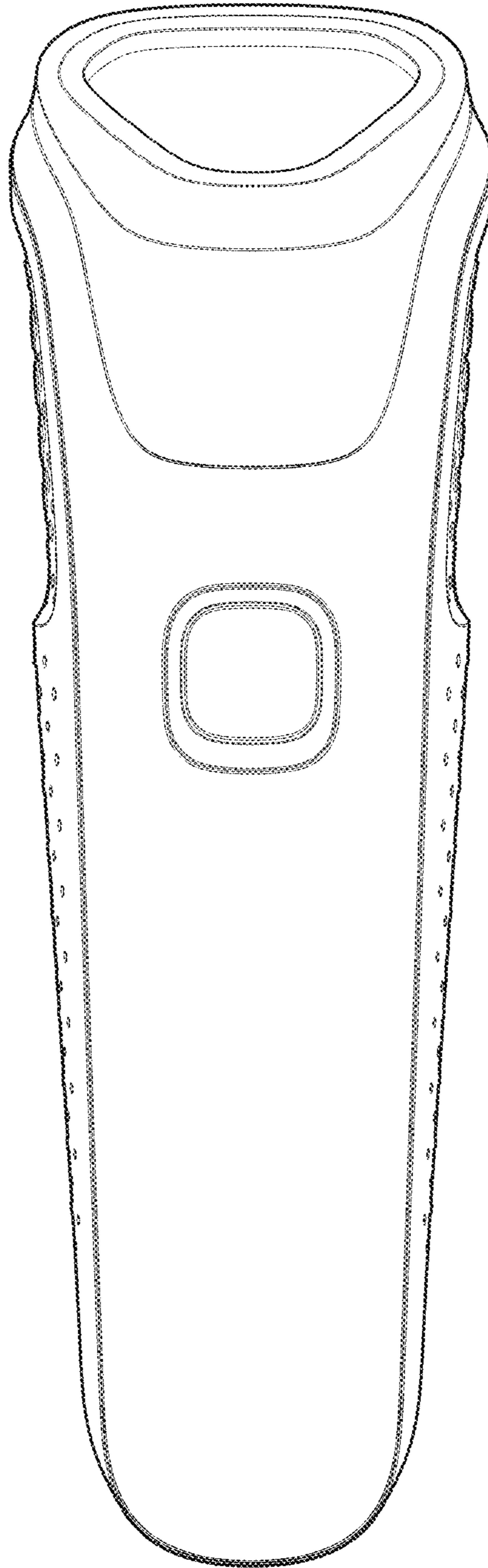

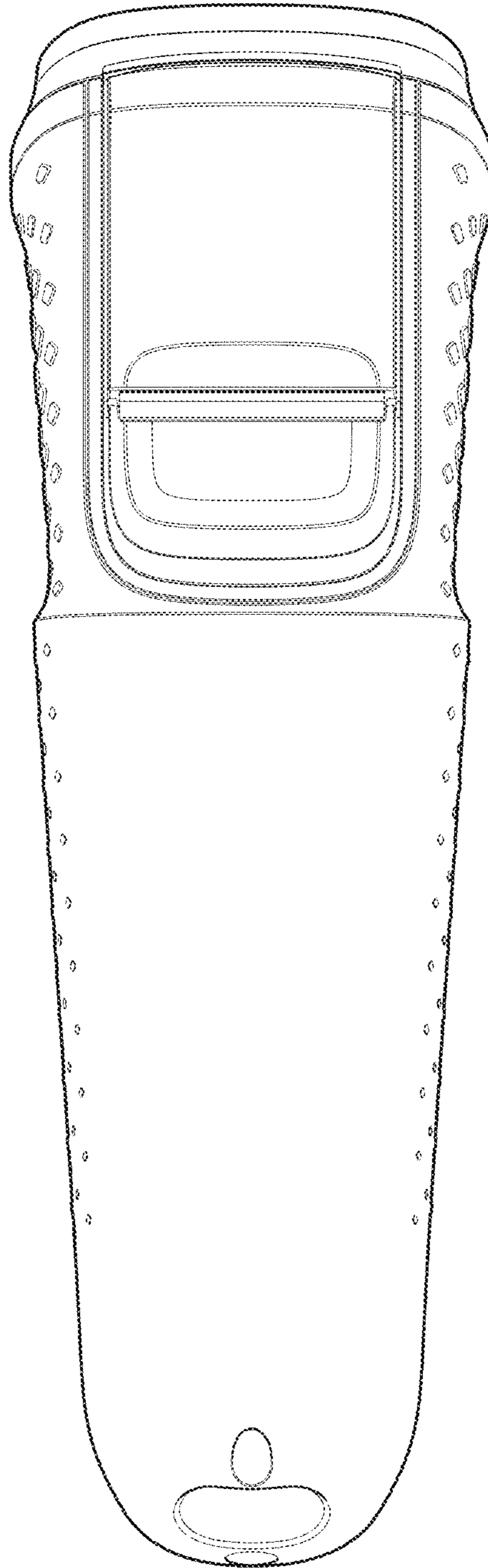

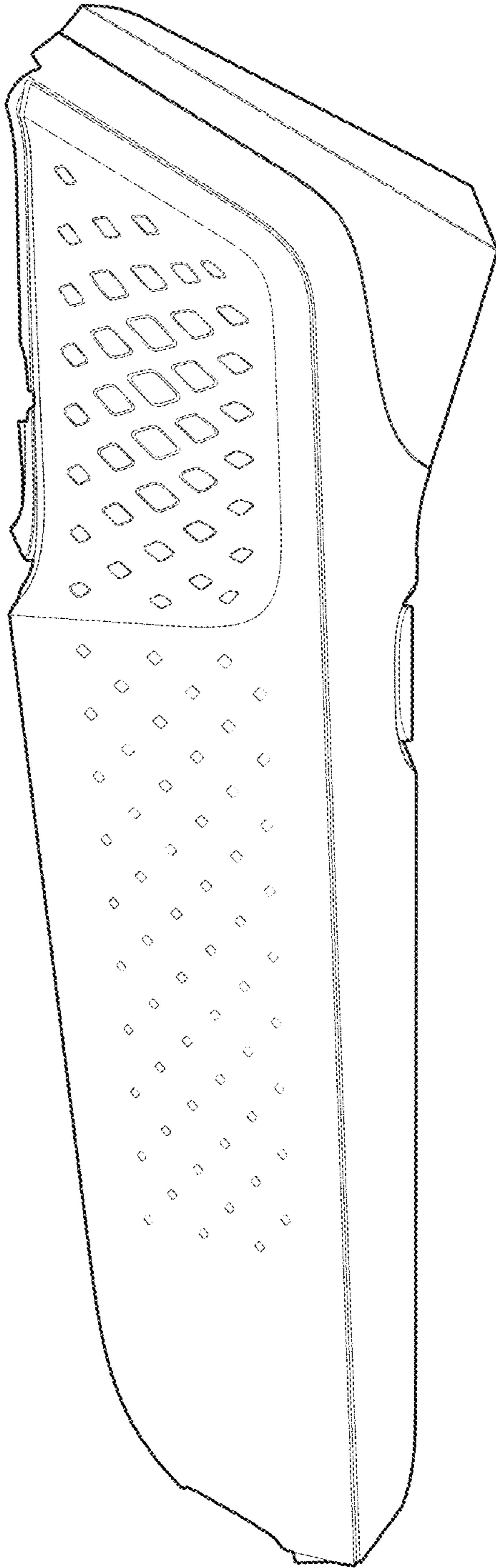

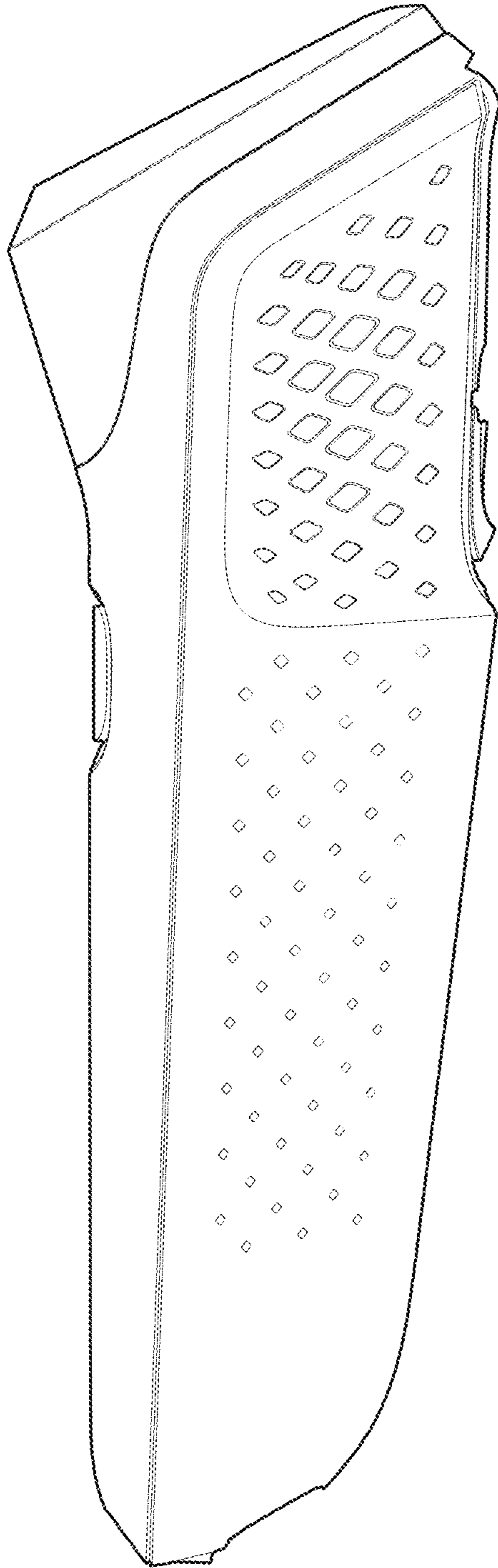

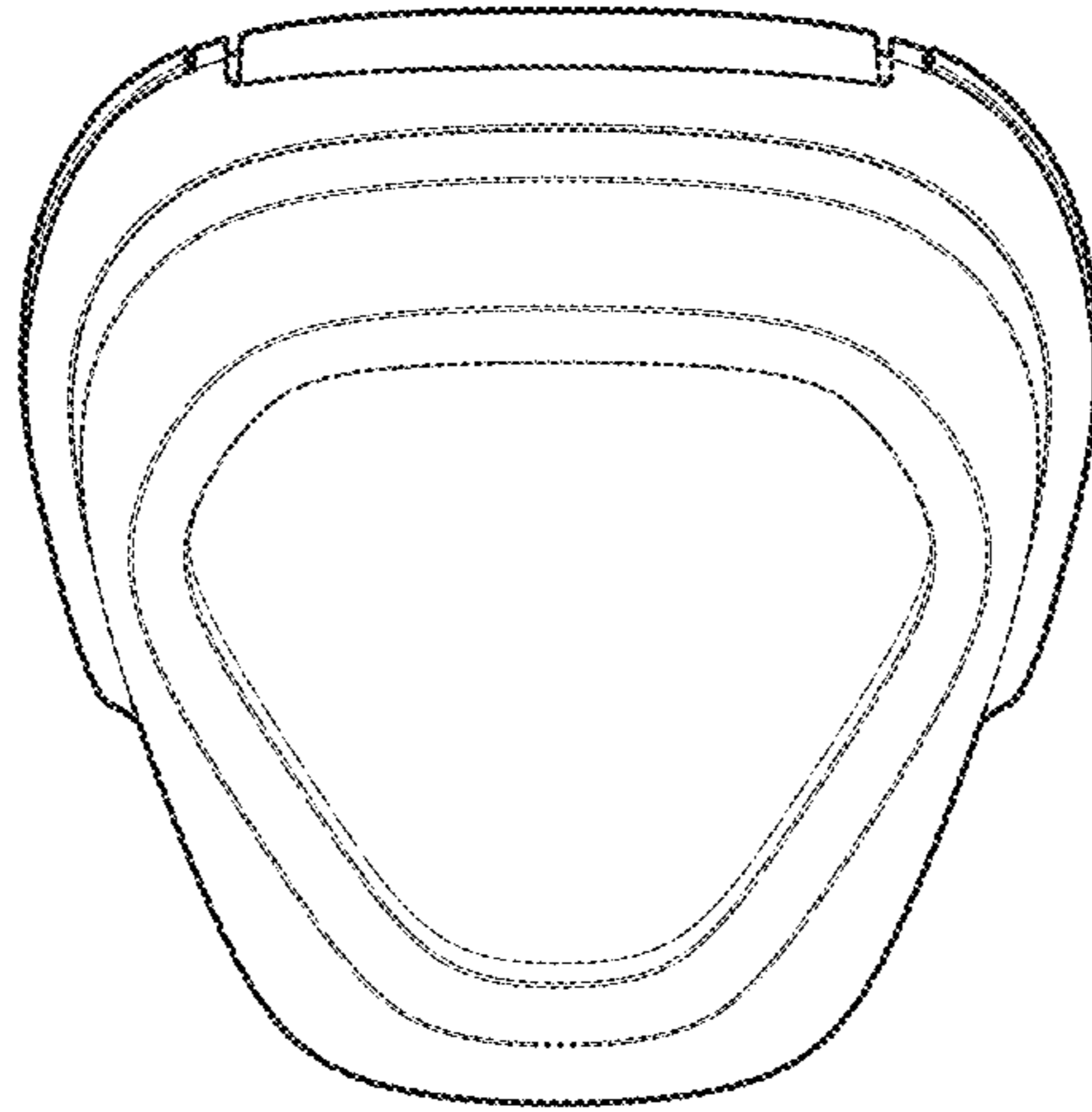

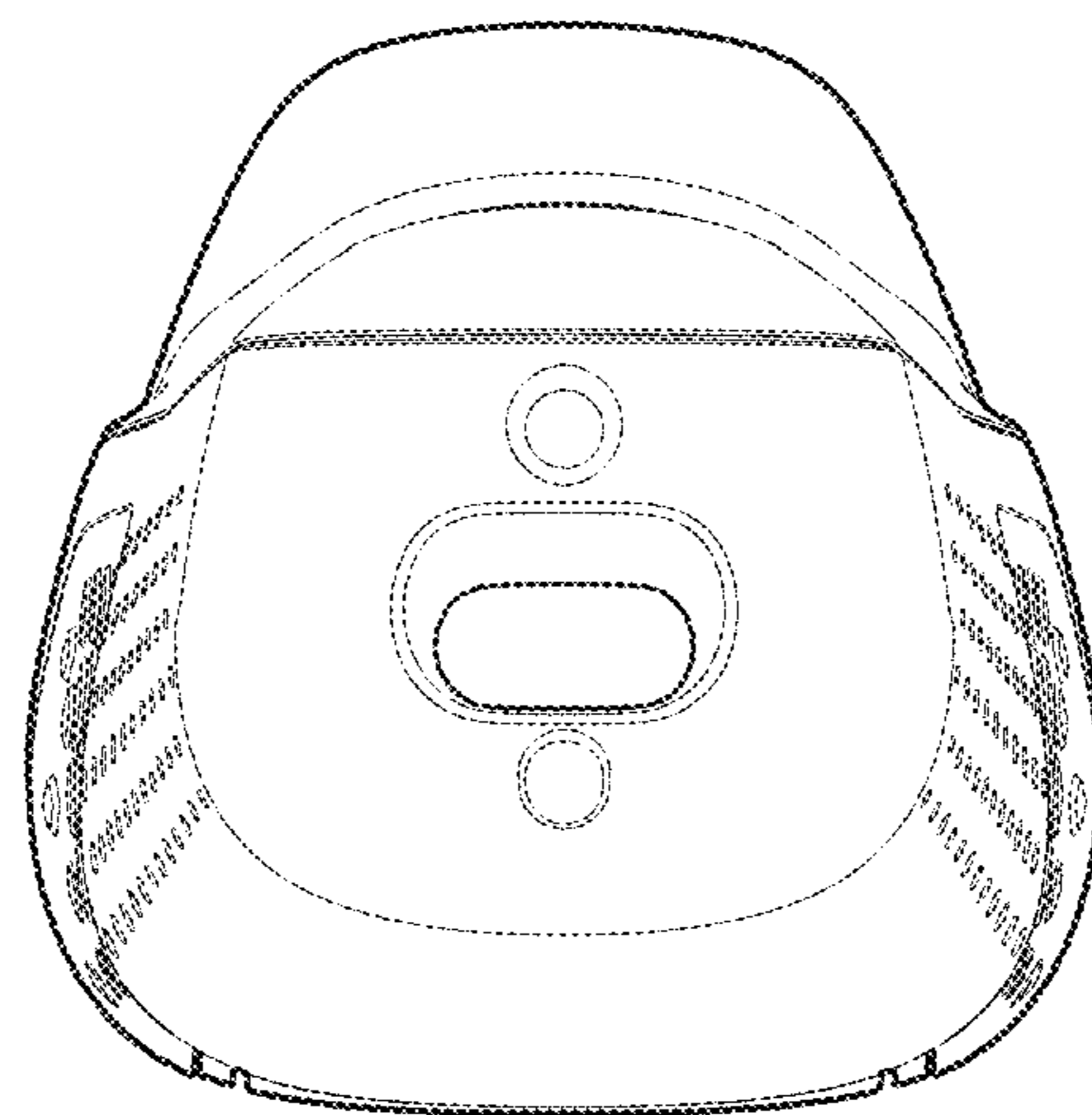

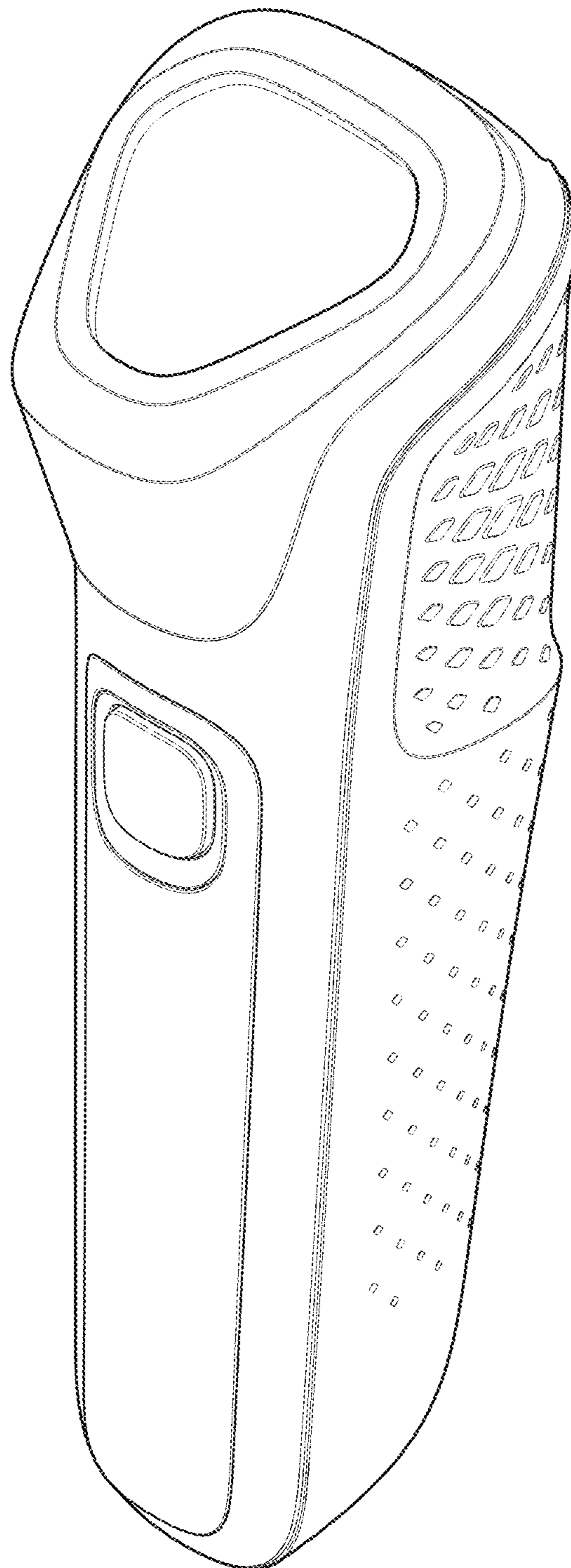

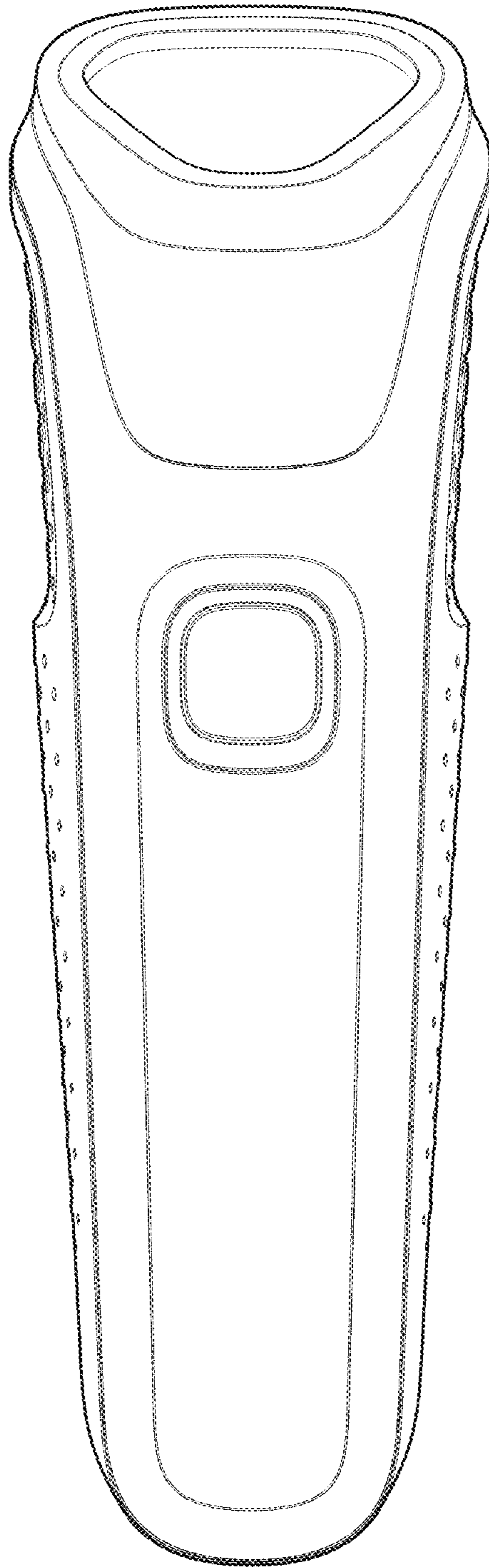

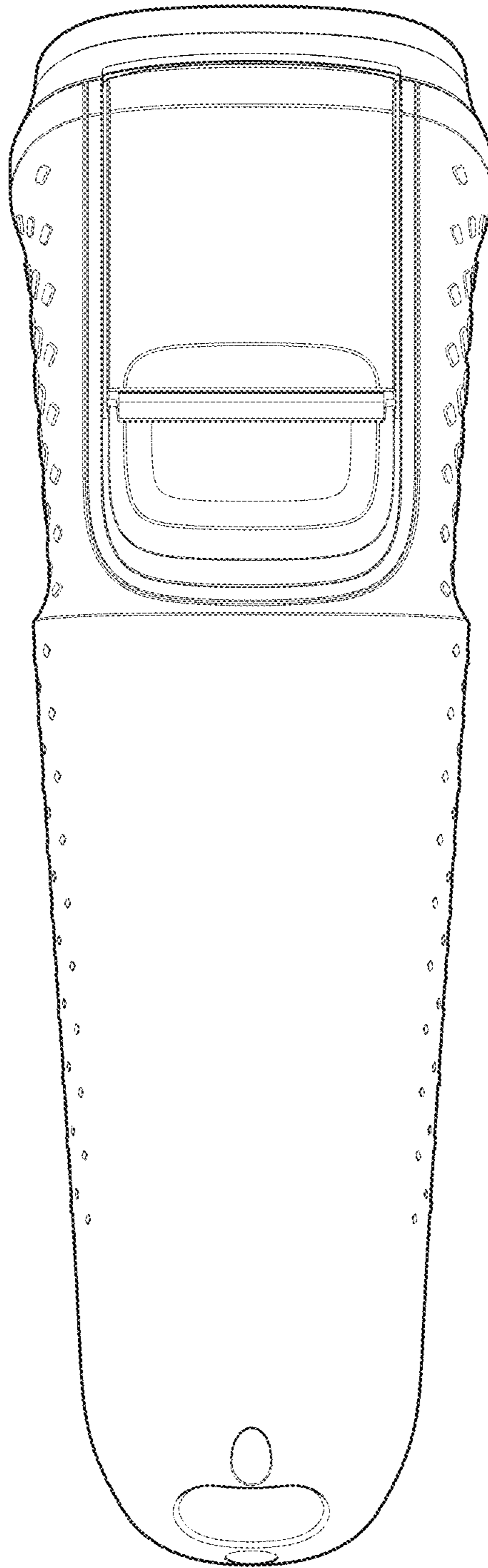

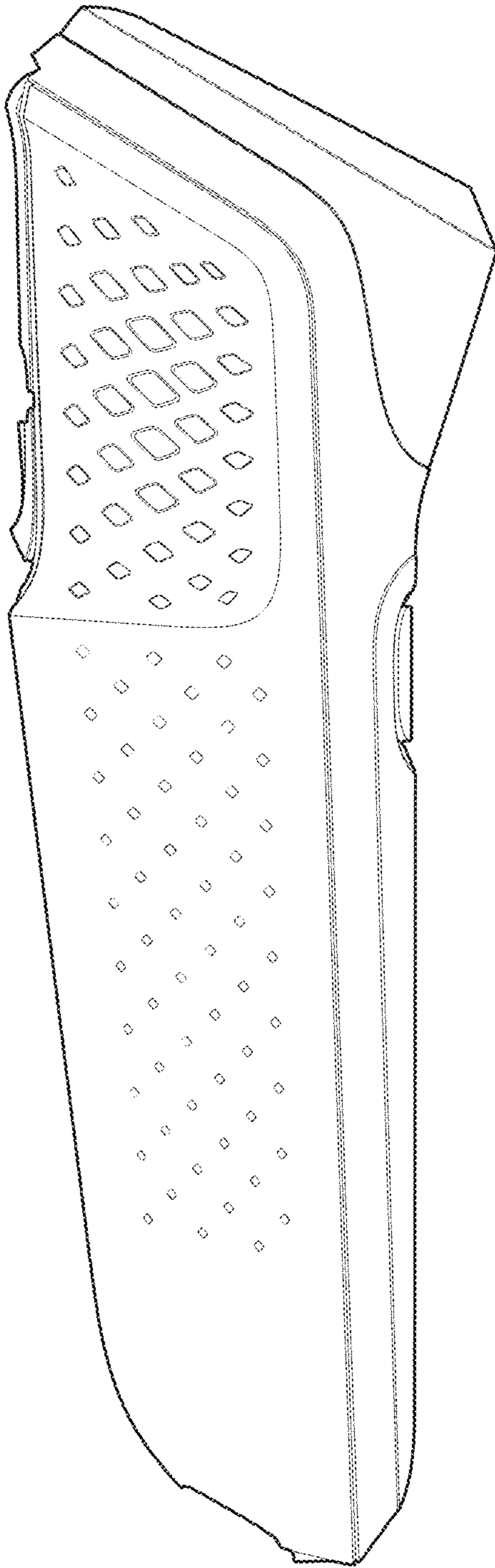

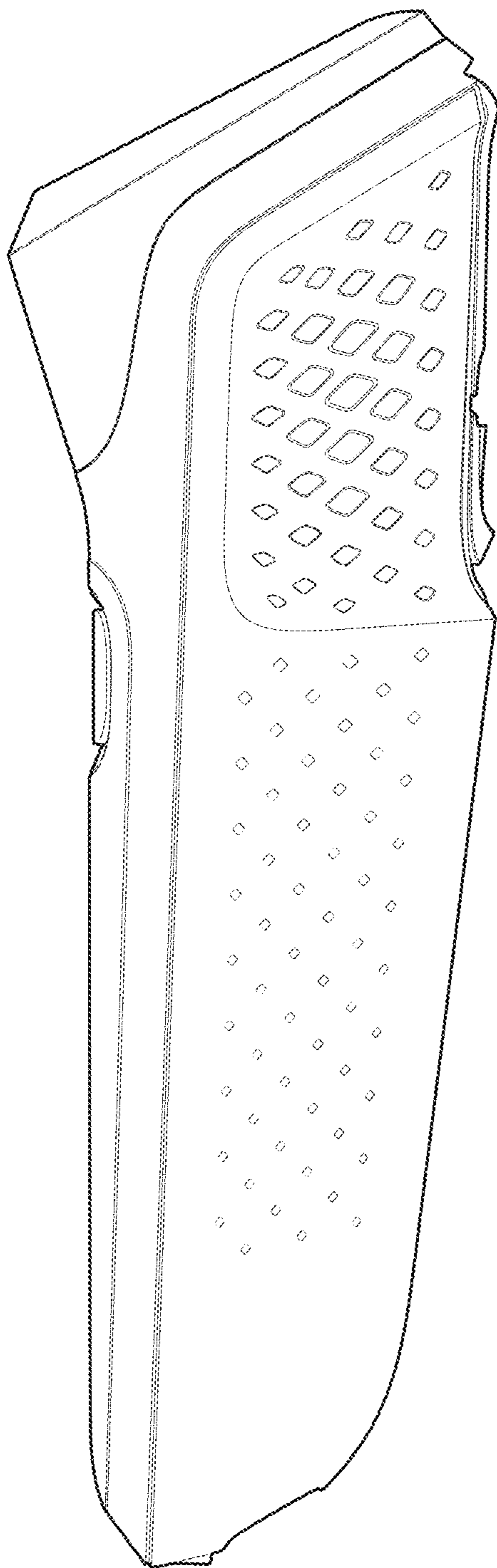

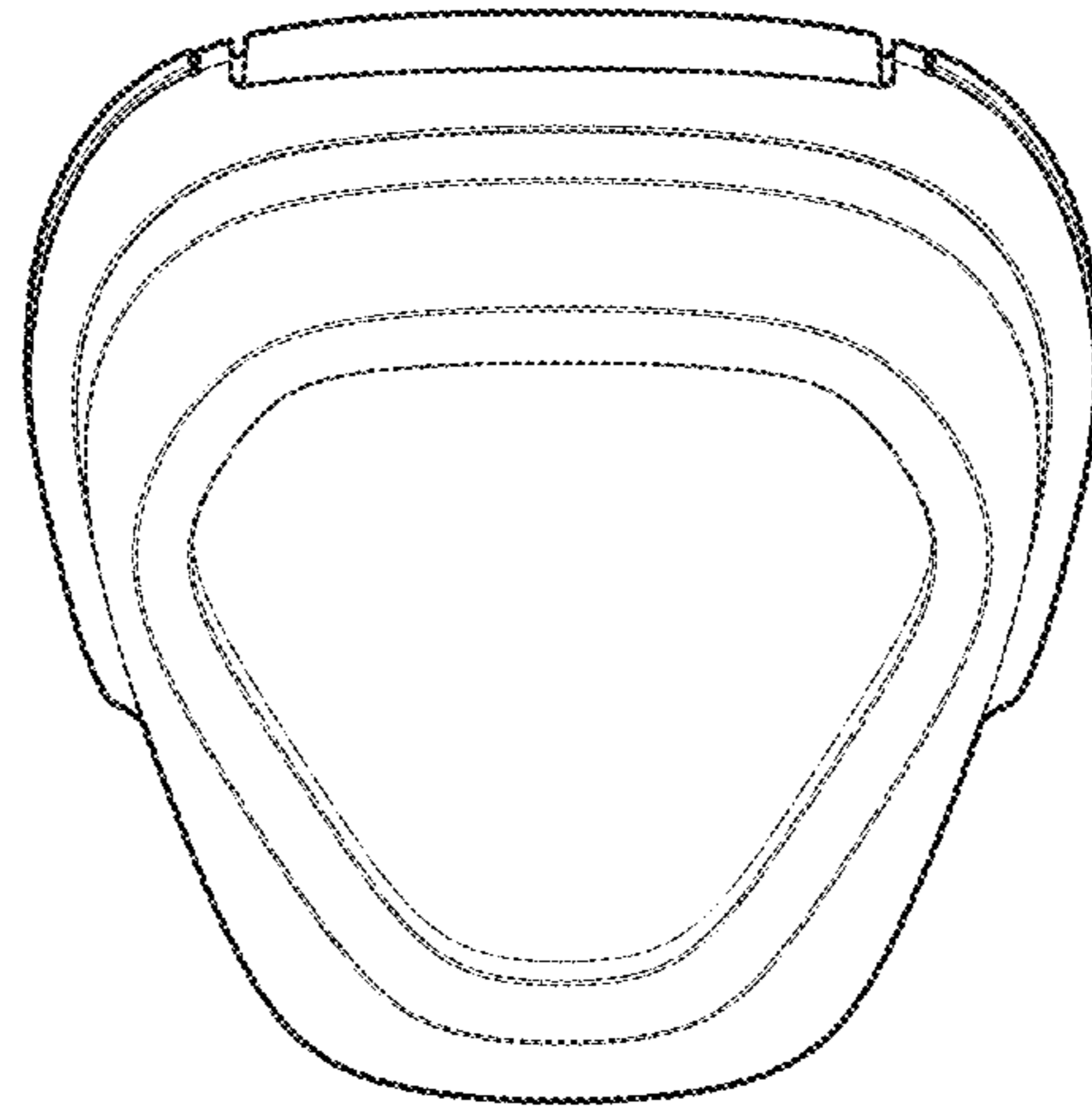

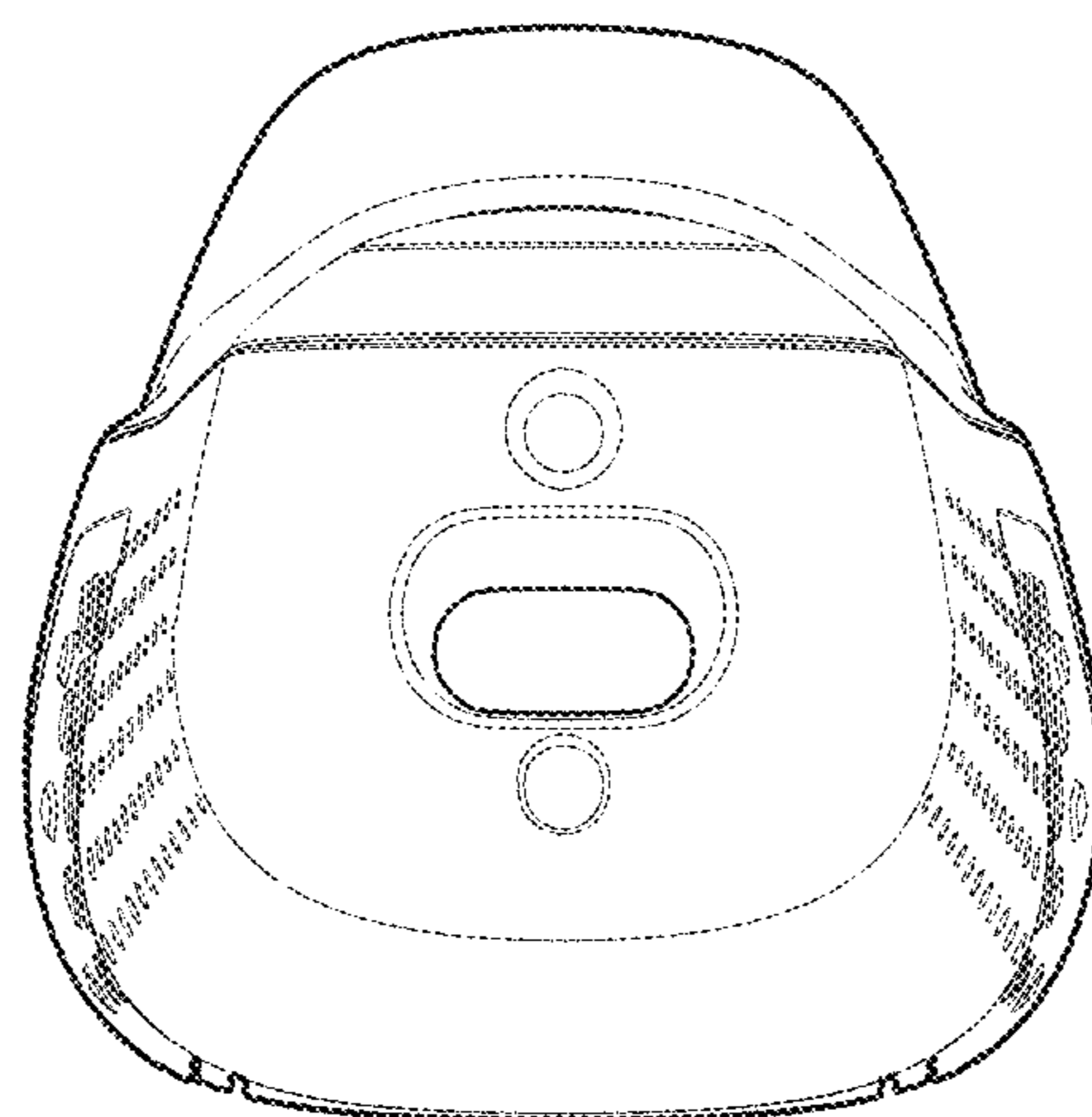
