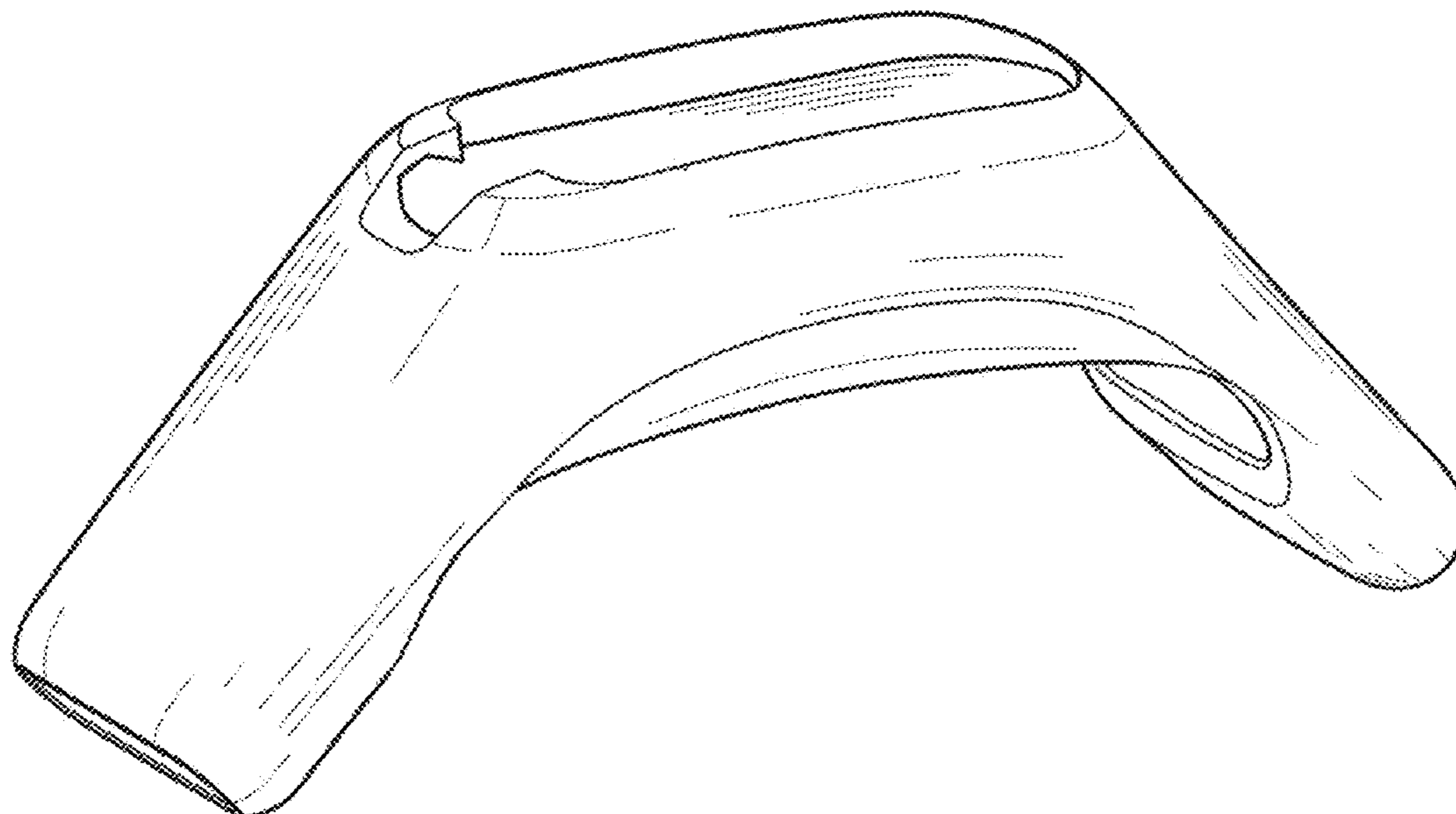
(57) **CLAIM**

I claim the ornamental design for a collar sensor holder, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right-side perspective view of a collar sensor holder, showing my new design; FIG. 2 is a bottom, rear, right-side perspective view thereof; FIG. 3 is a front plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a left side view thereof.

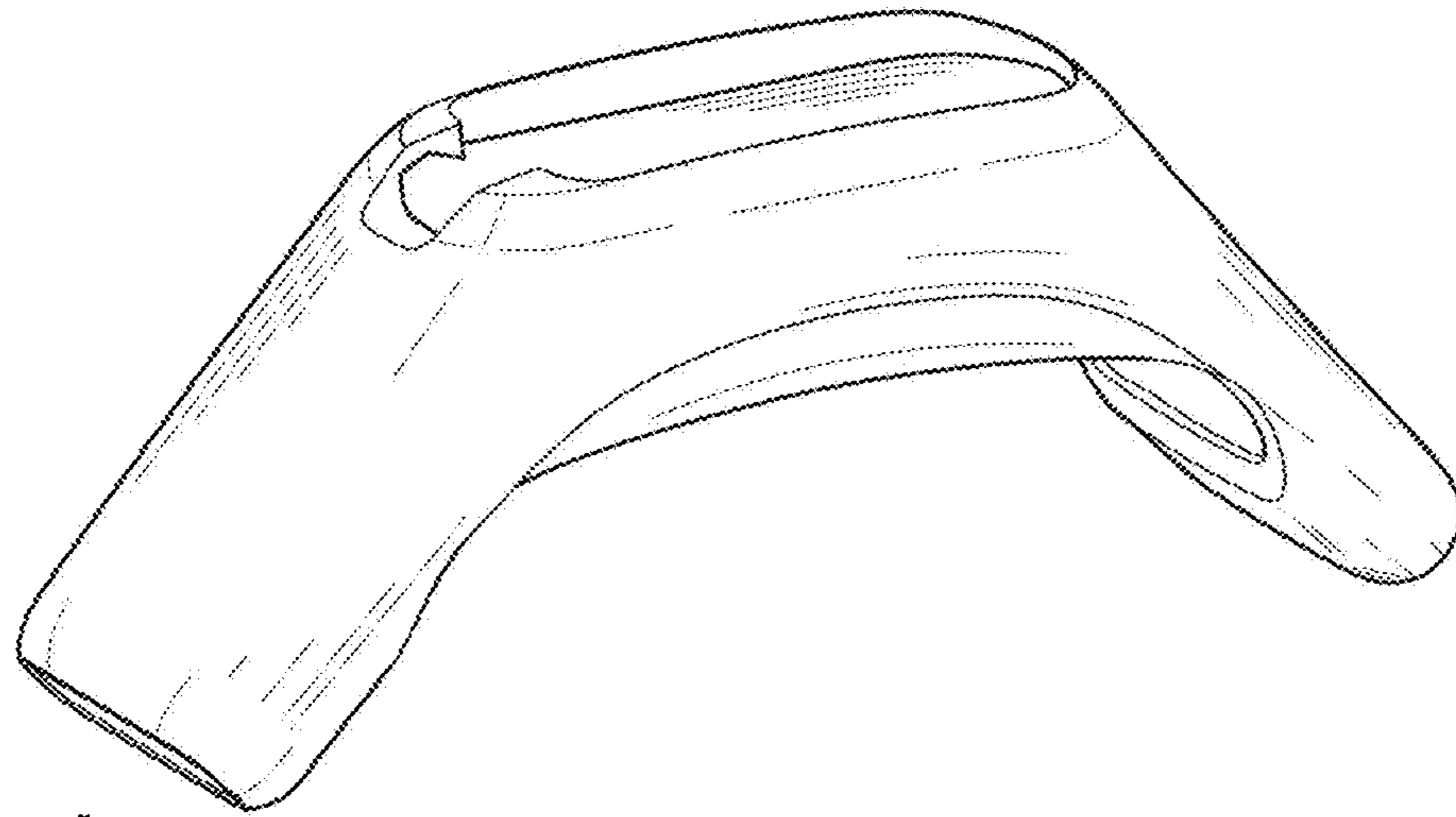

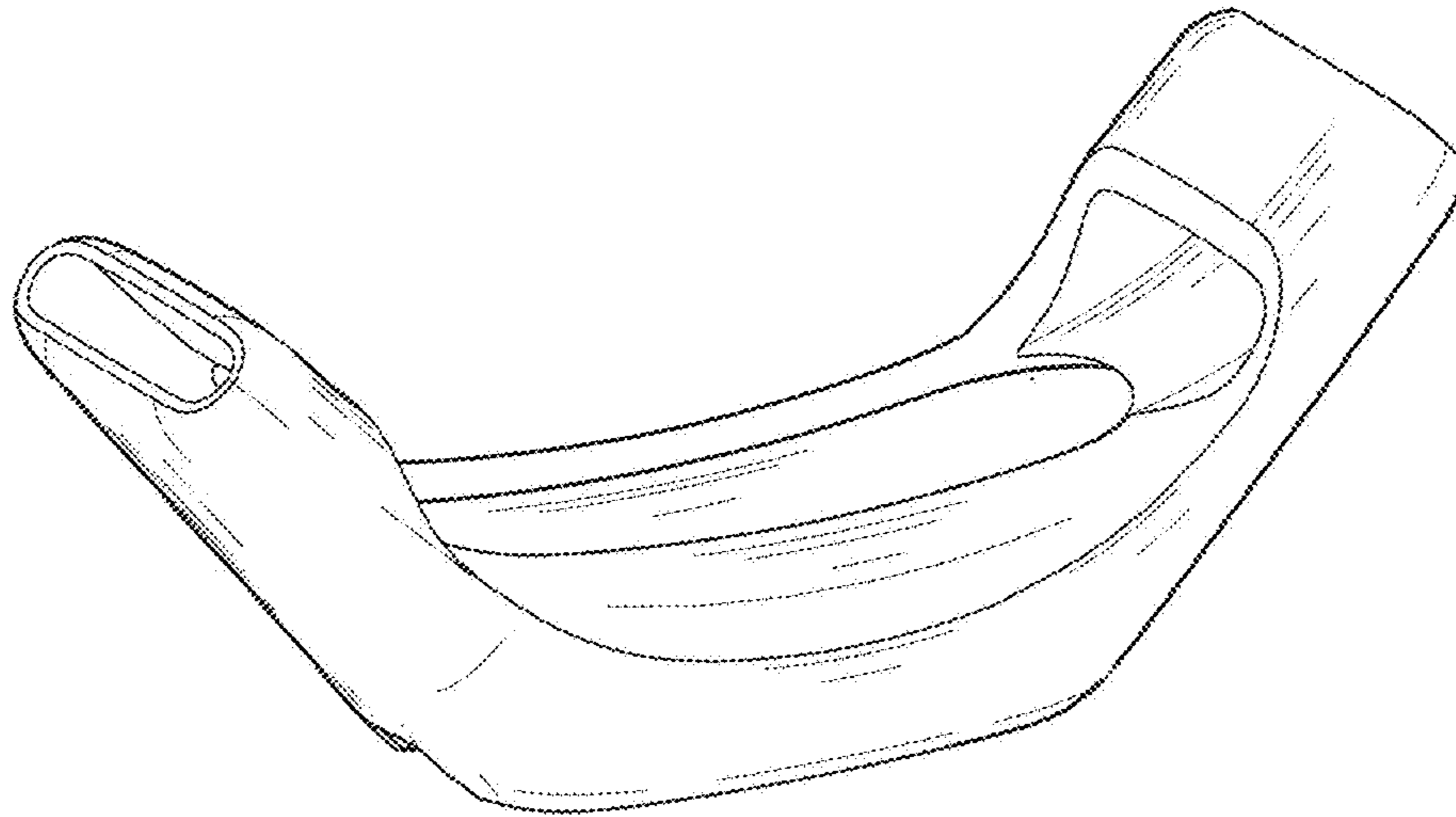

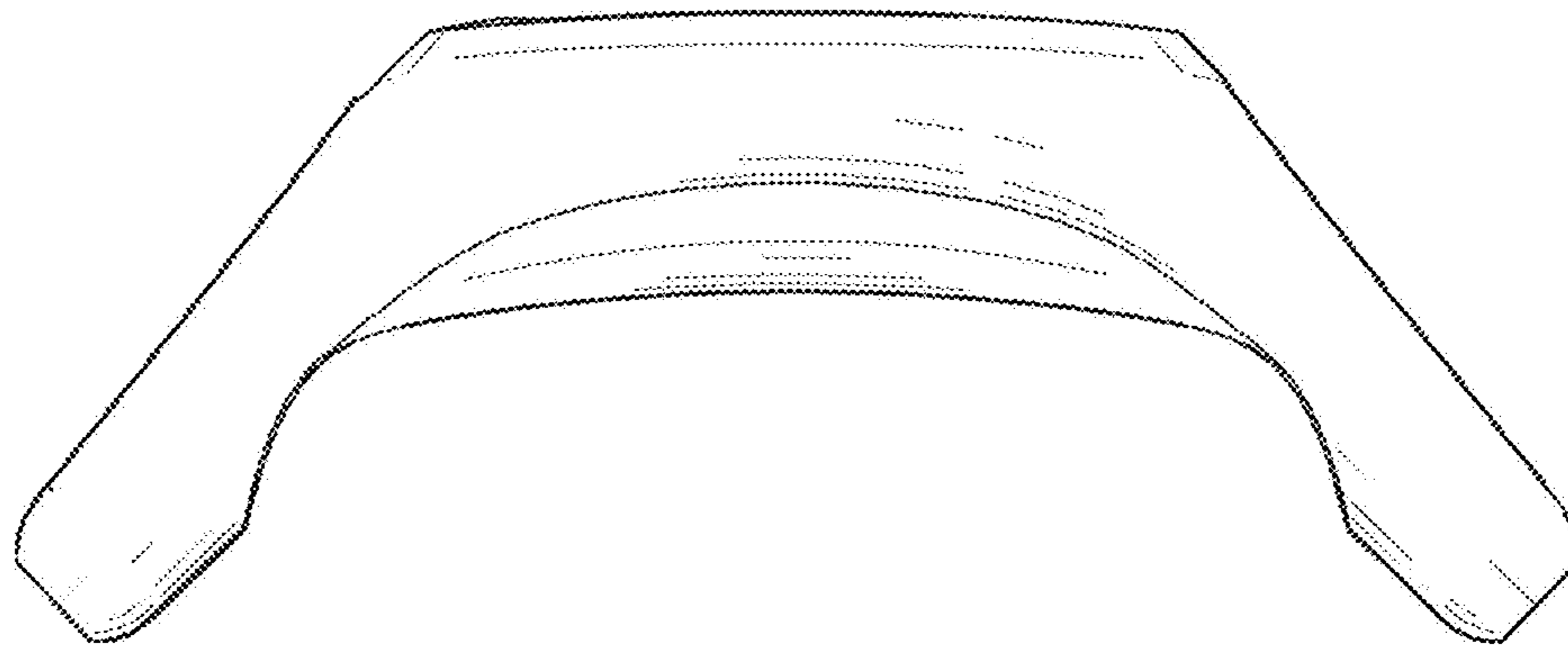

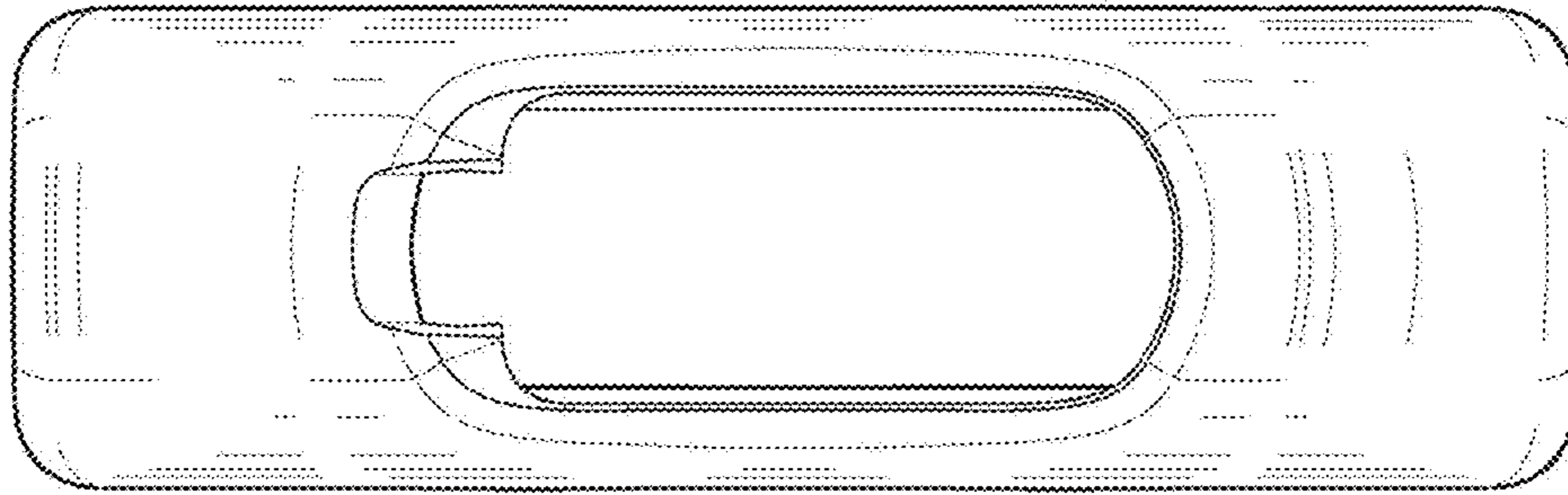

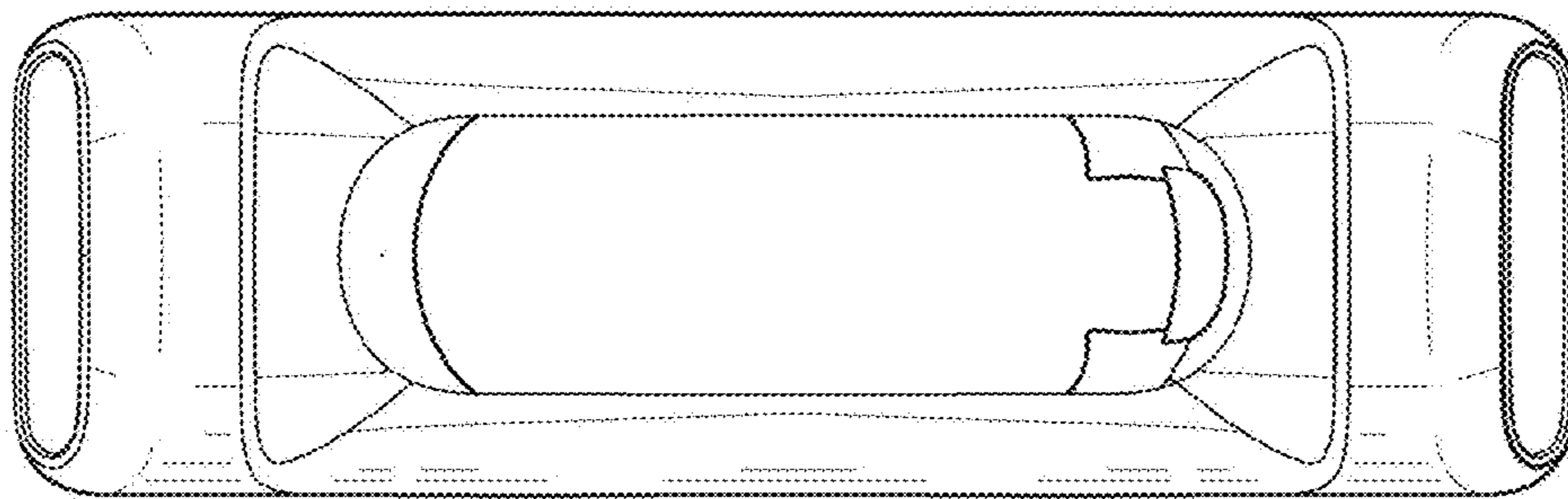

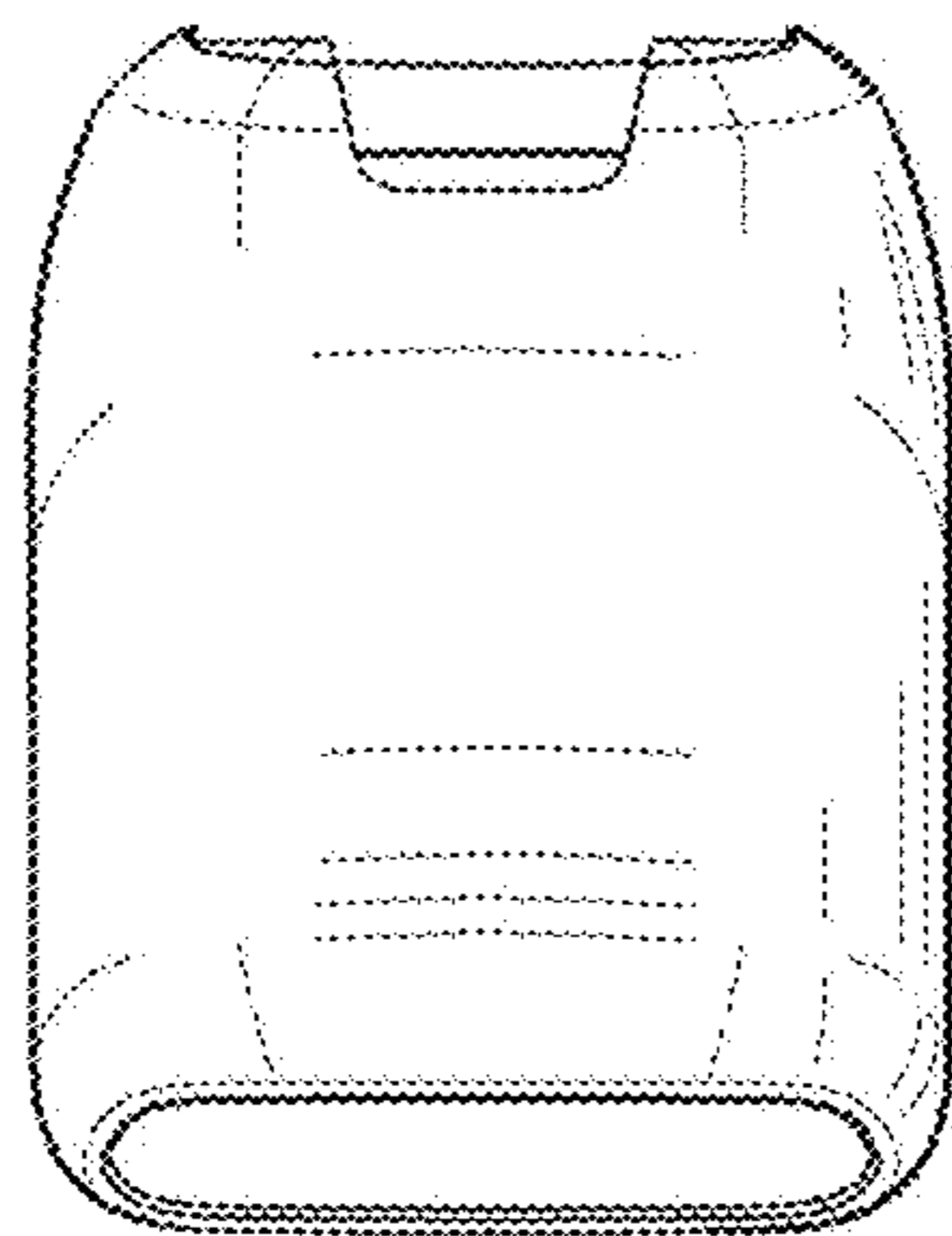

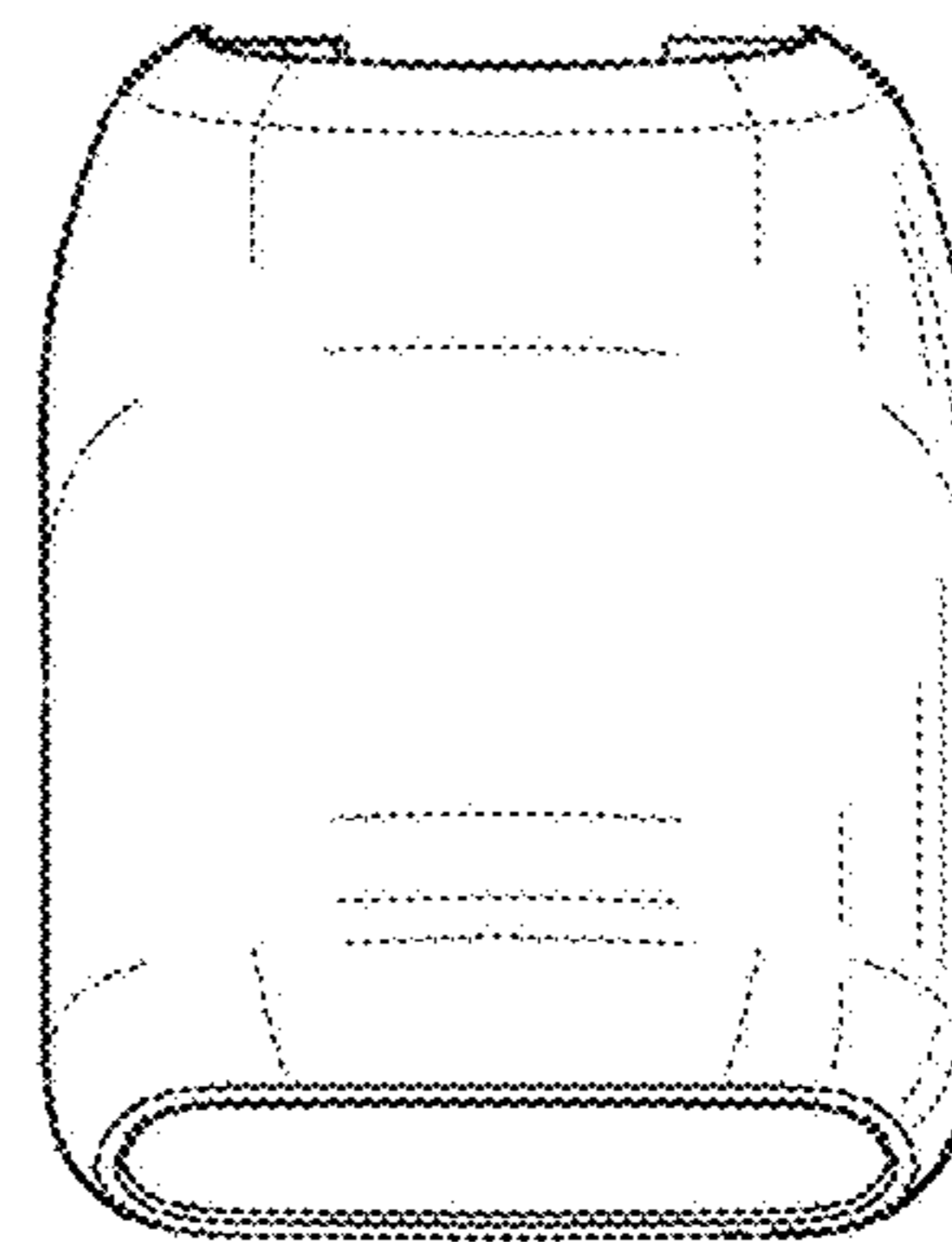
