(57) **CLAIM**

The ornamental design for an upper torso garment, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an upper torso garment with front pockets on a front surface of the upper torso garment, showing our new design.

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a front view thereof.

FIG. 4 is a rear view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a left side view thereof.

FIG. 7 is a top view thereof.

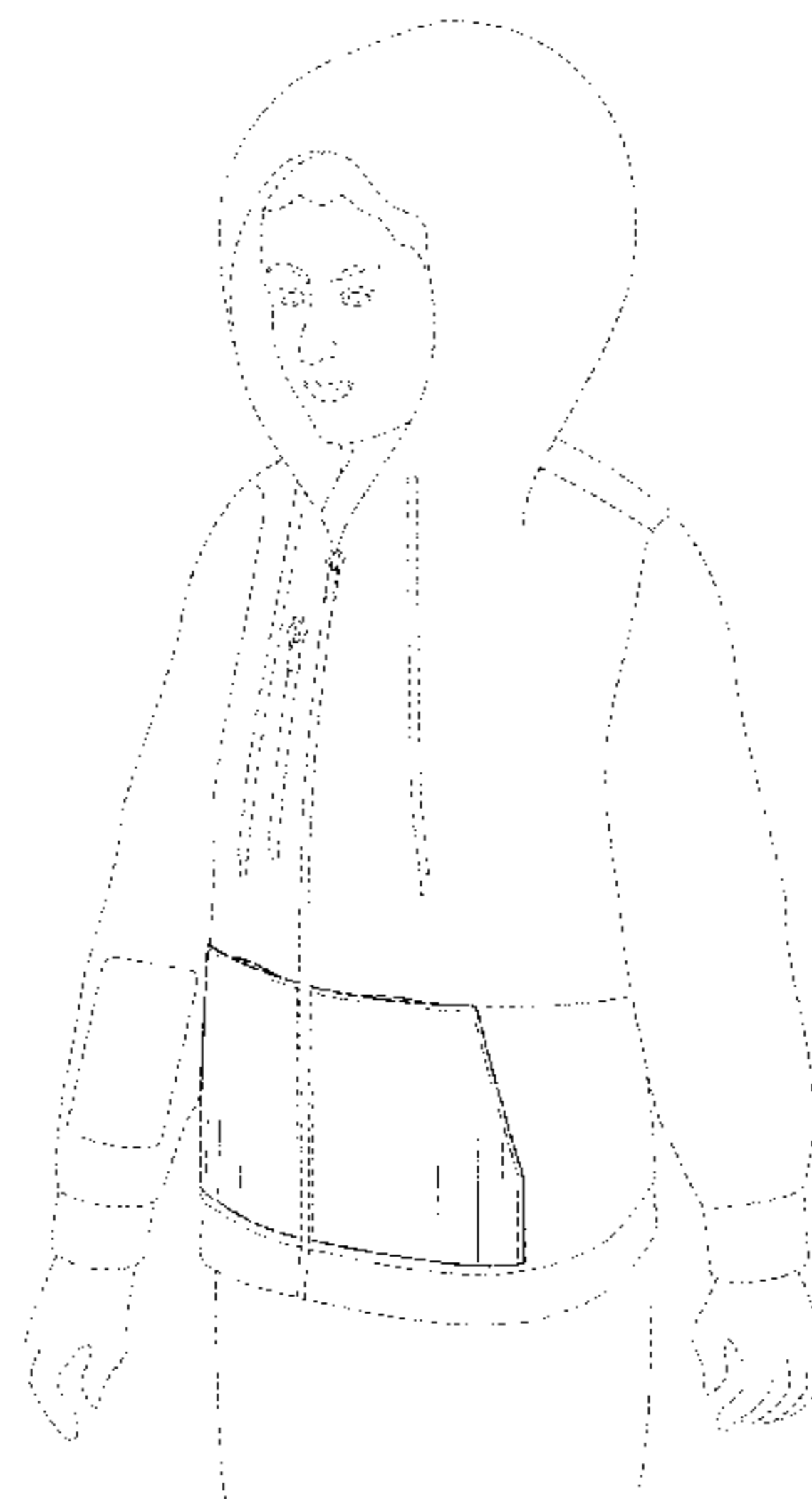
FIG. 8 is a bottom view thereof.

FIG. 9 is a front view thereof with a wearer reaching a hand into one of the front pockets; and,

FIG. 10 is a rear view thereof with a wearer reaching a hand into one of two rear pockets. The rear pockets illustrated in broken lines form no part of the claimed design.

The broken lines are shown for the purpose of illustrating environmental subject matter on an exemplary upper torso garment, and form no part of the claimed design. The surface shading and contour lines shown in the drawings represent the three-dimensional character and contour of the article, and are not intended to illustrate material, surface ornamentation, or surface decoration.

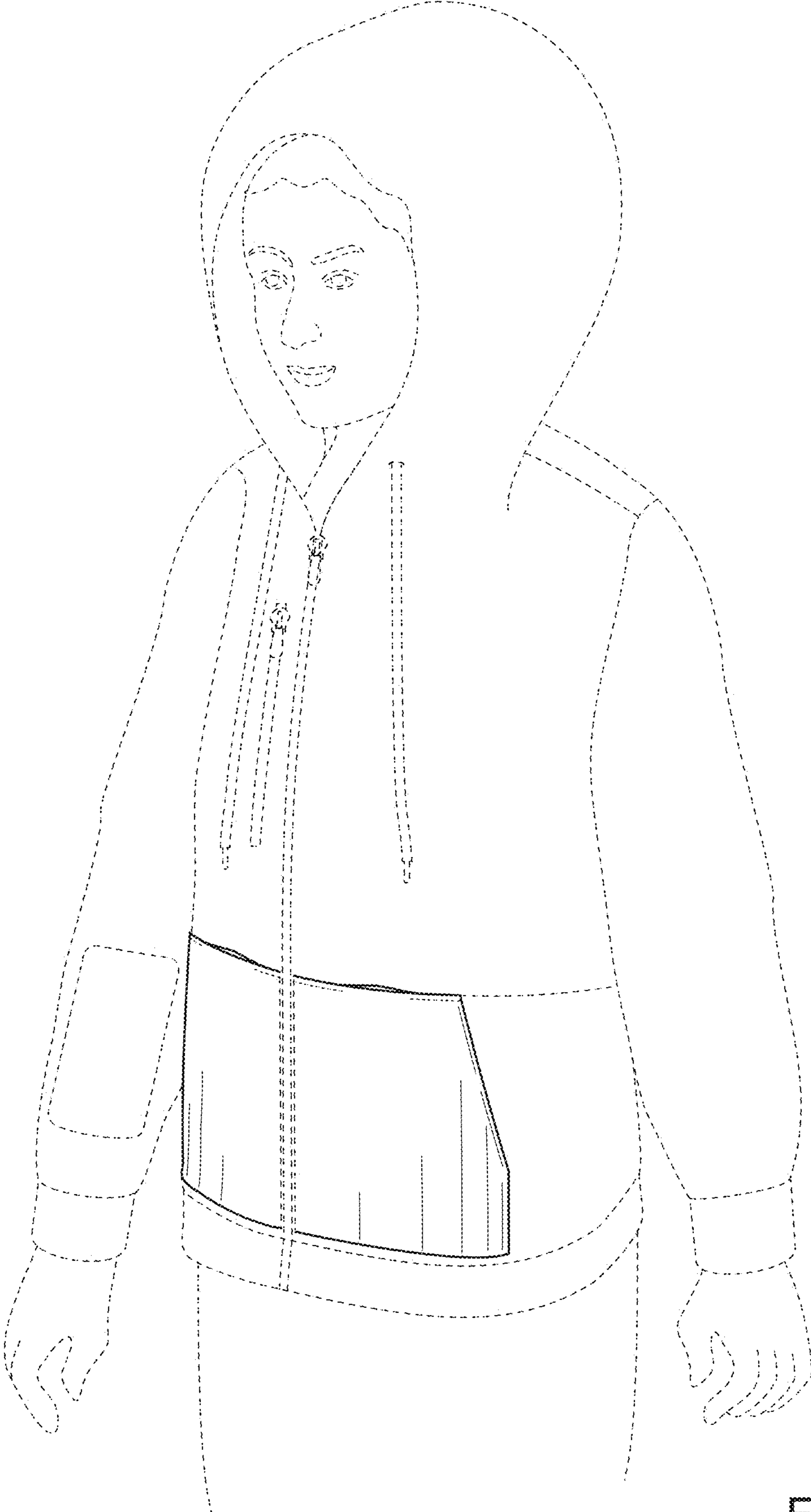

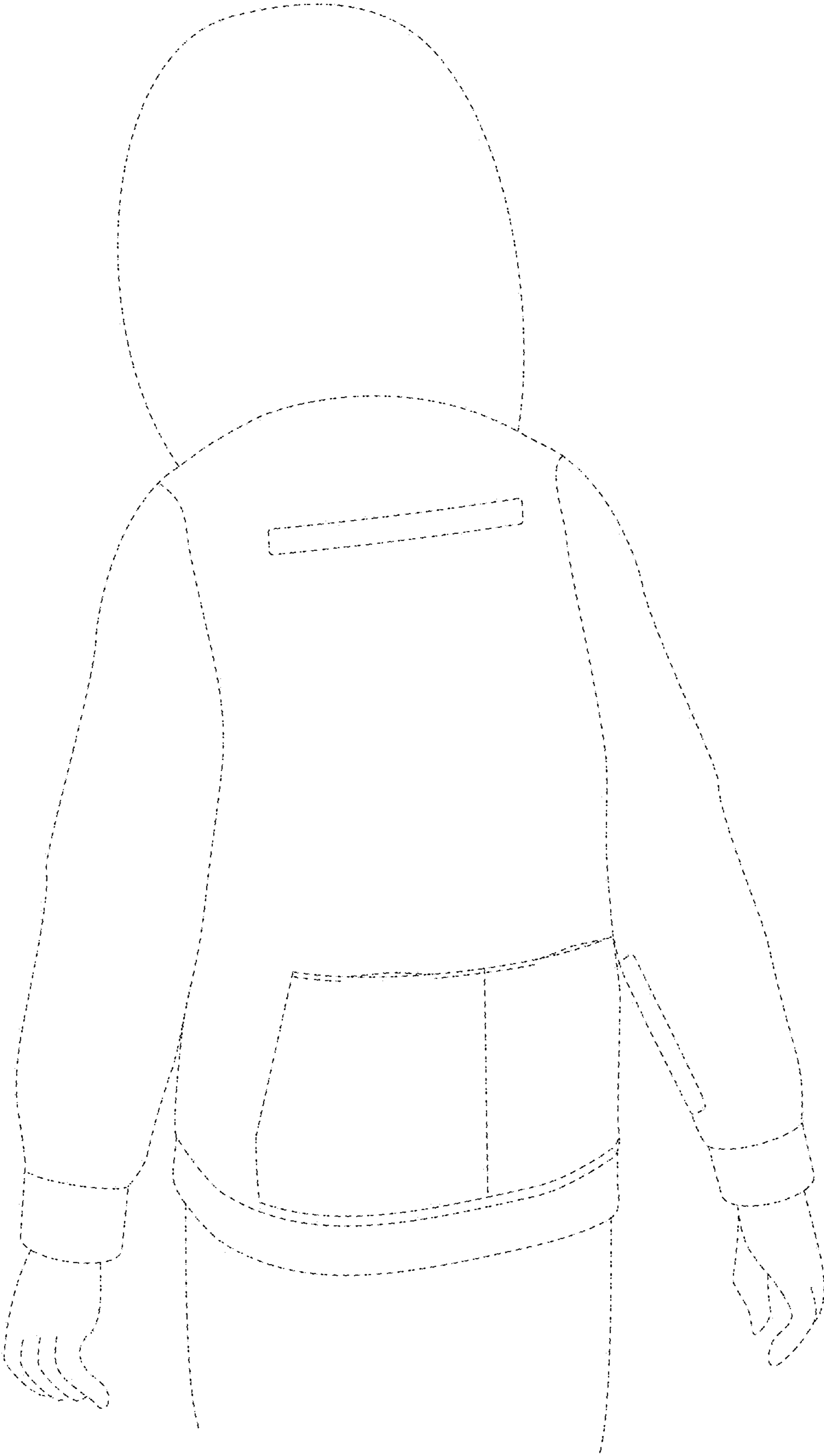

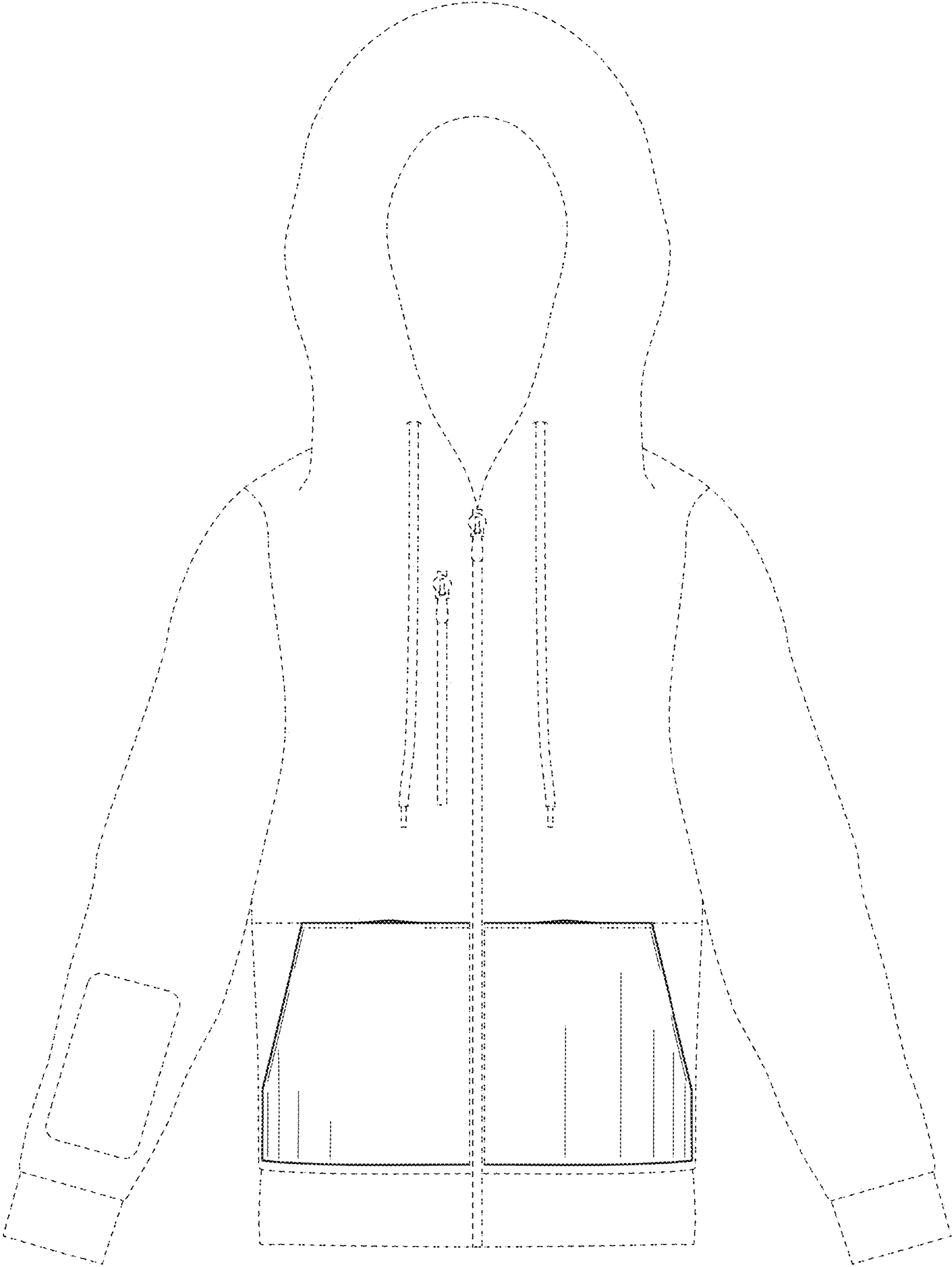

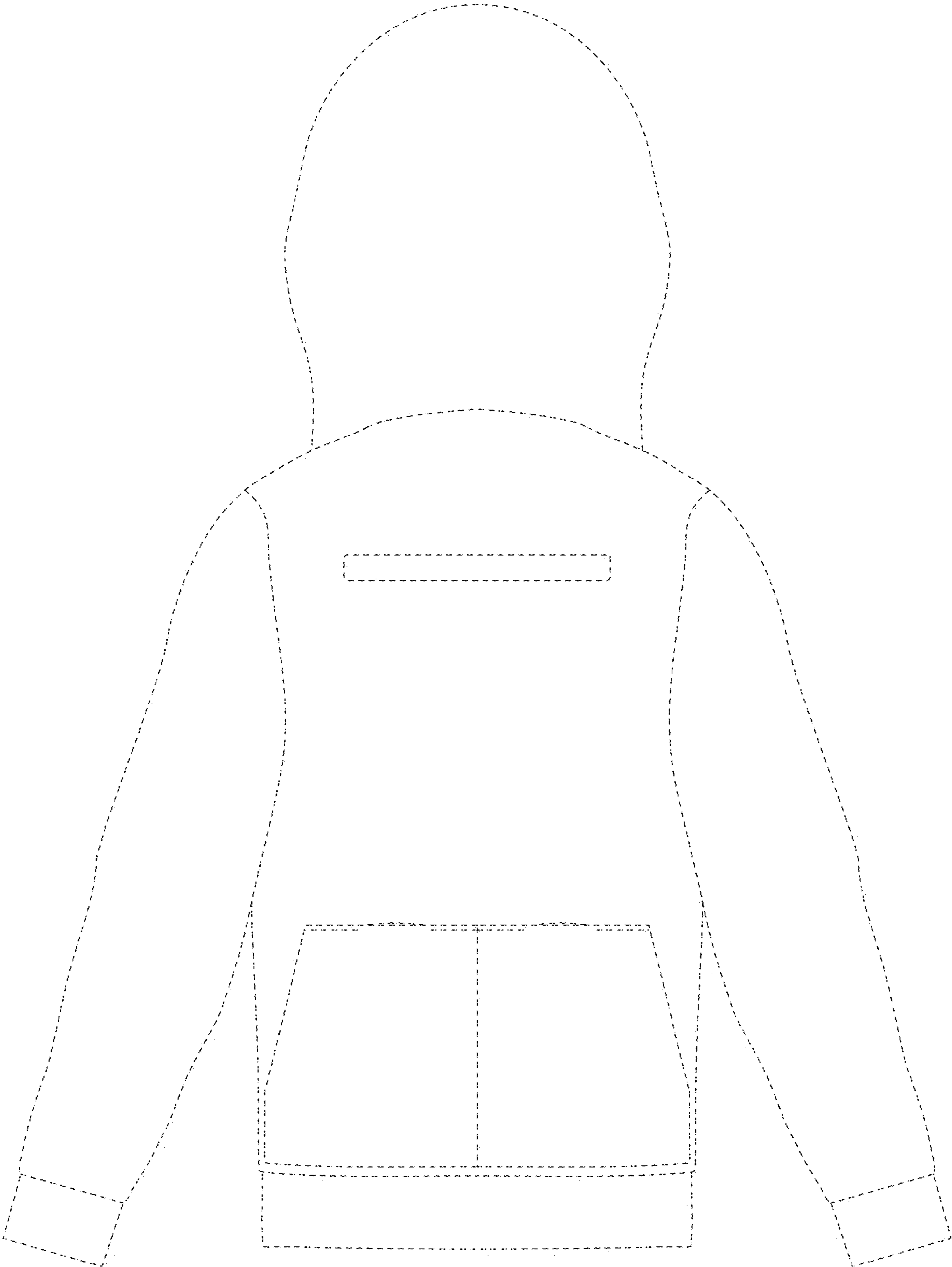

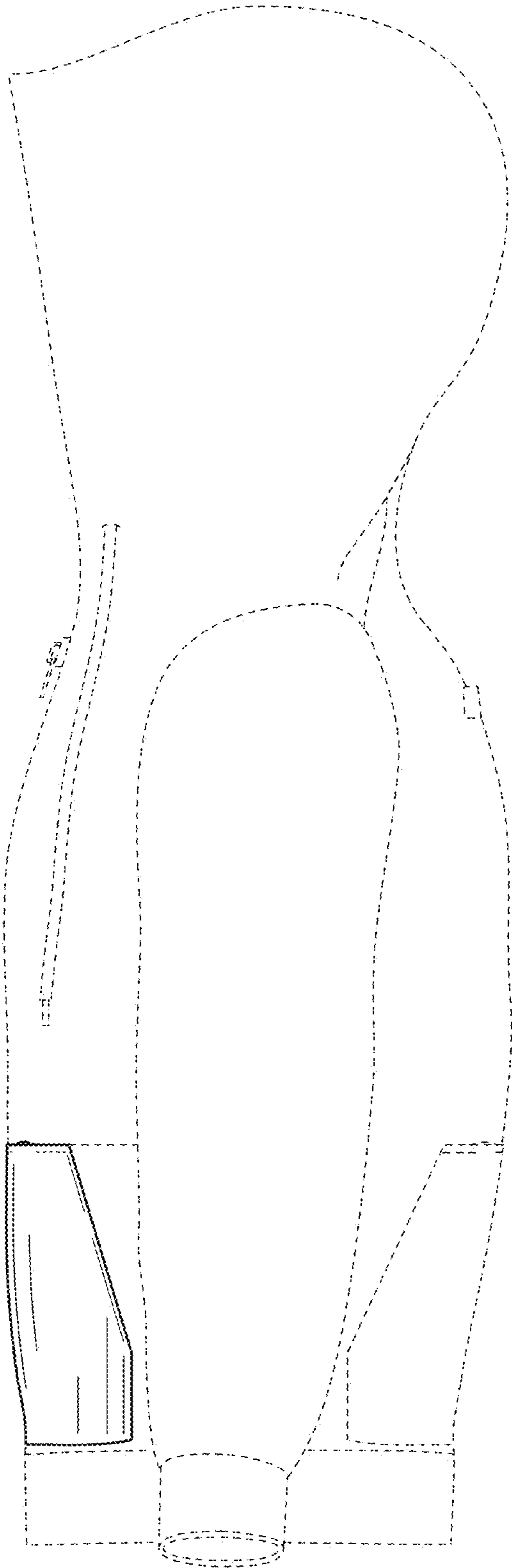

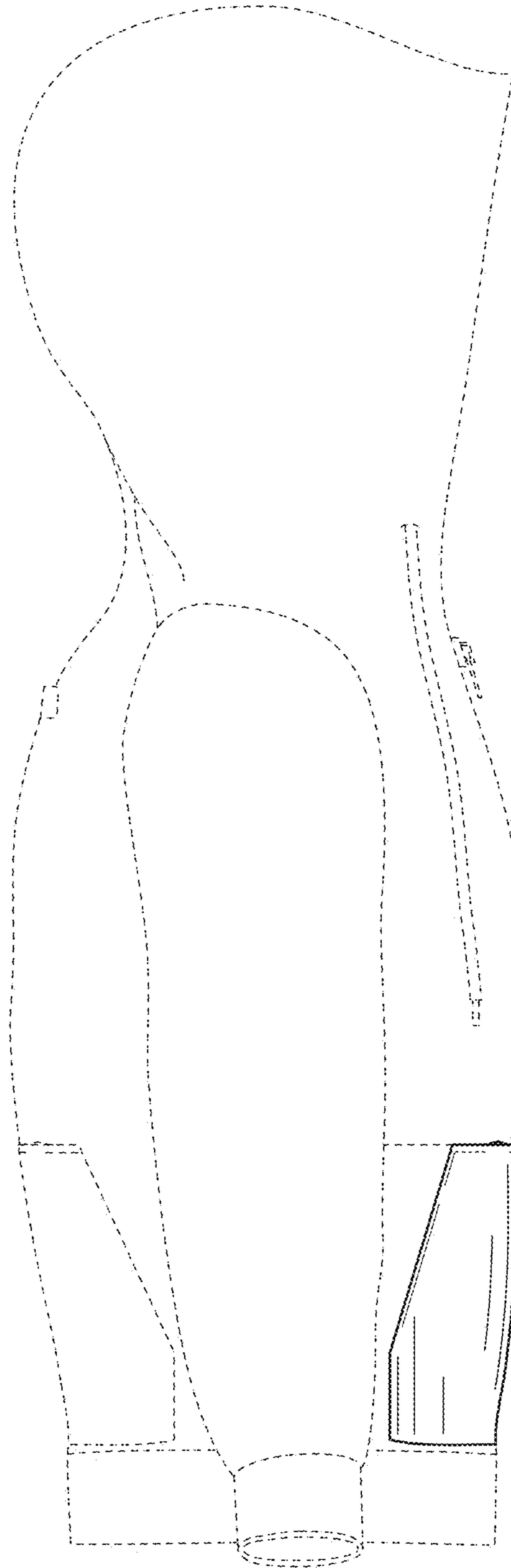

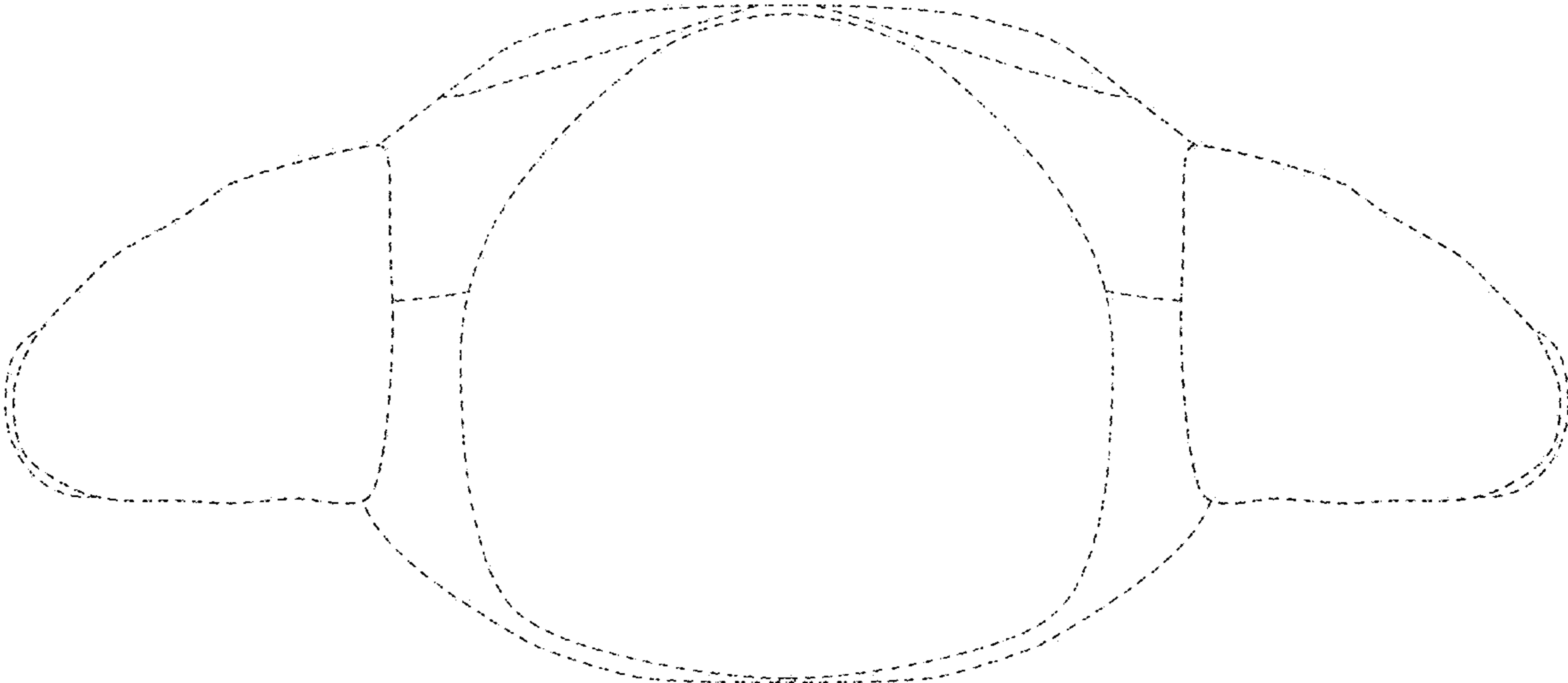

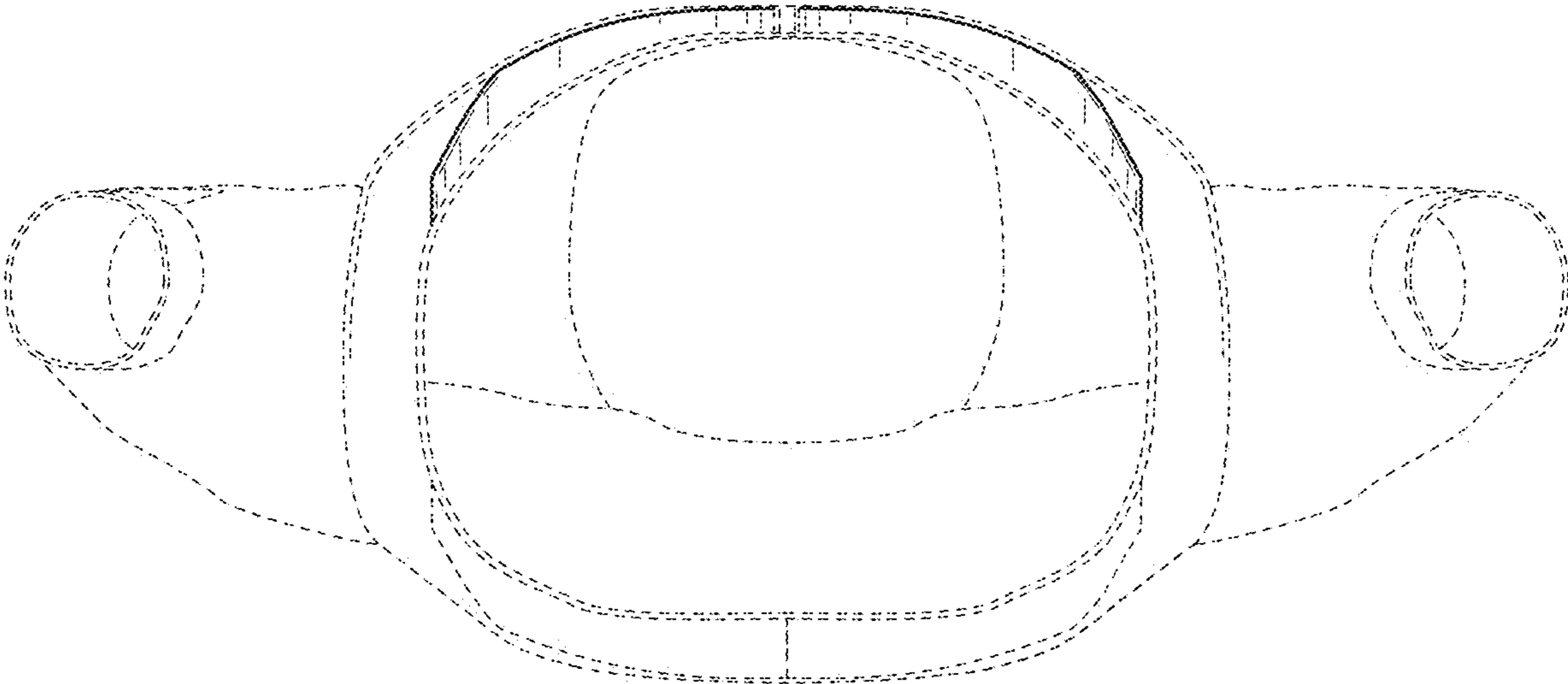

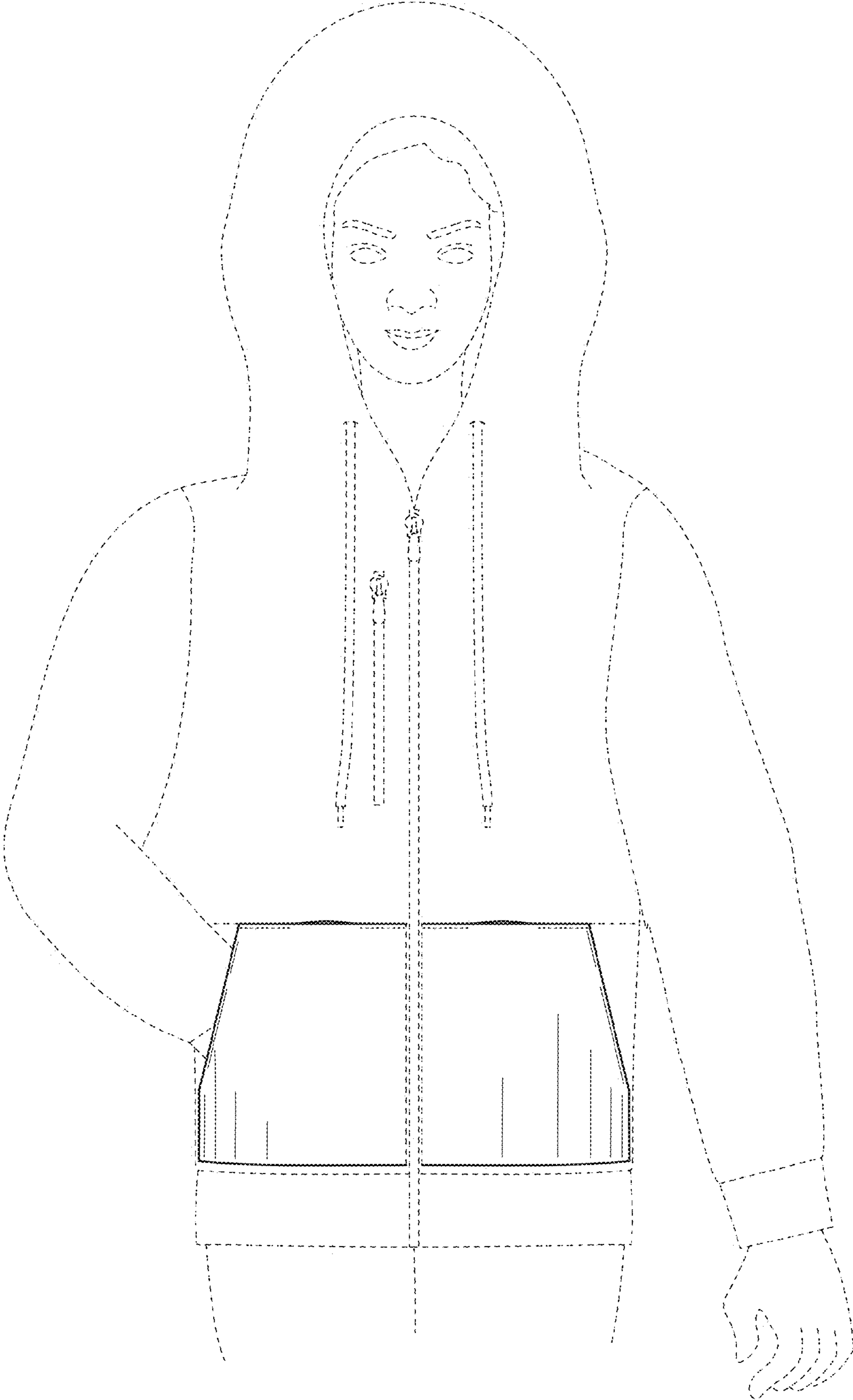

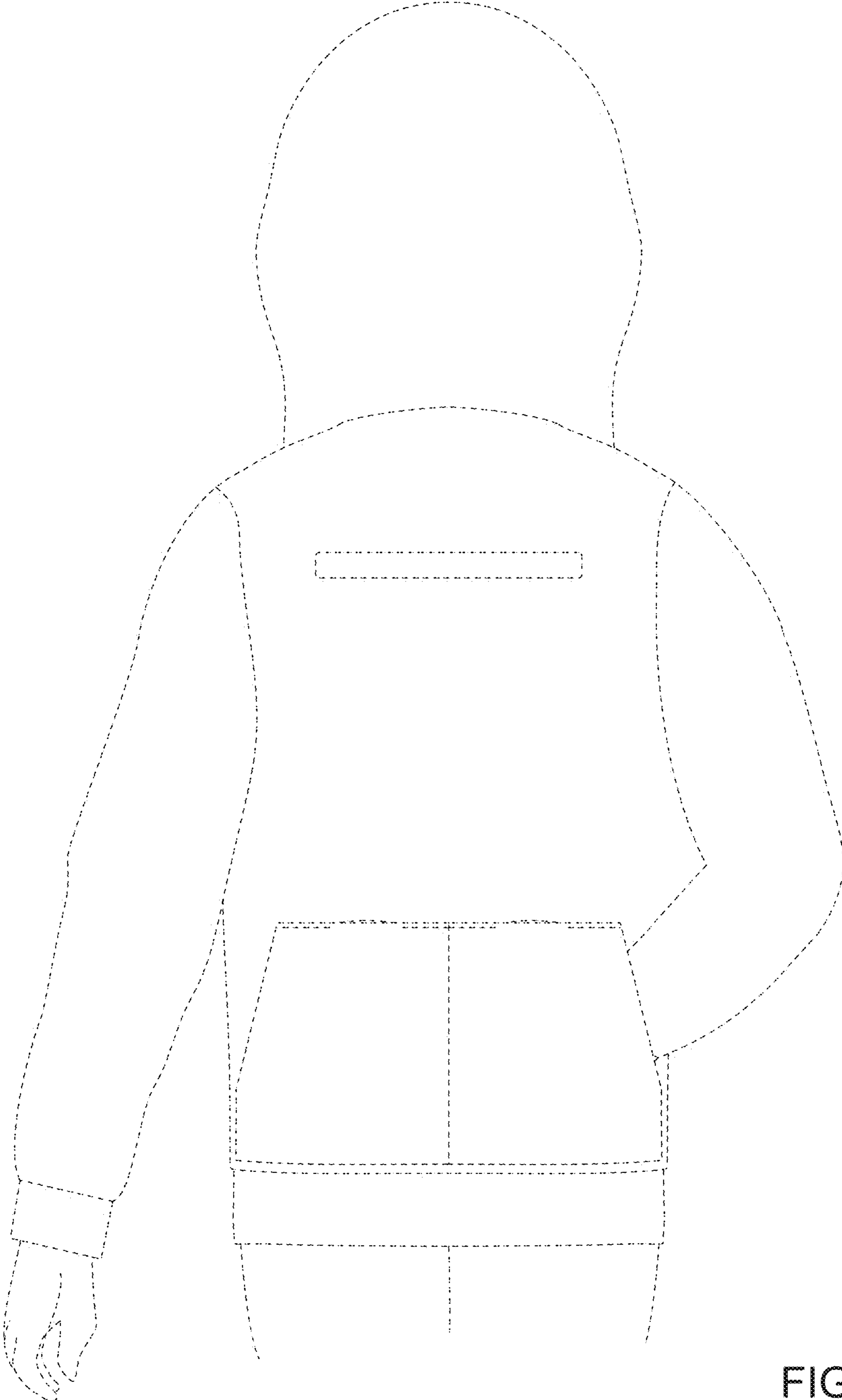
