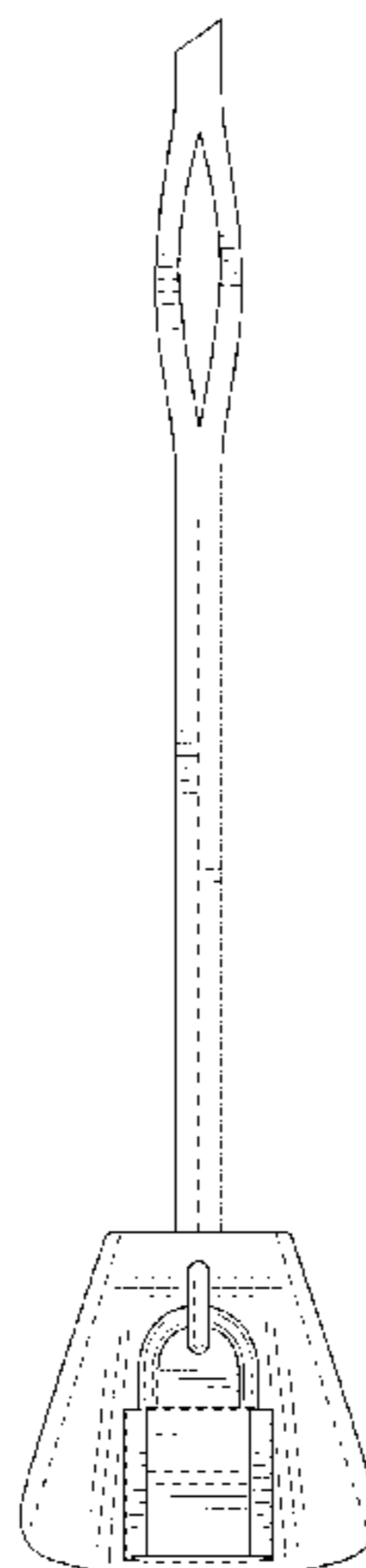
(57) **CLAIM**

The ornamental design for a charm, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a charm showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The evenly spaced broken lines shown in FIGS. 1-6 illustrate stitching that is claimed.  
The broken lines on the bottom side of the article visible in FIGS. 4, 5, and 7 depict portions of the charm that form no part of the claimed design.

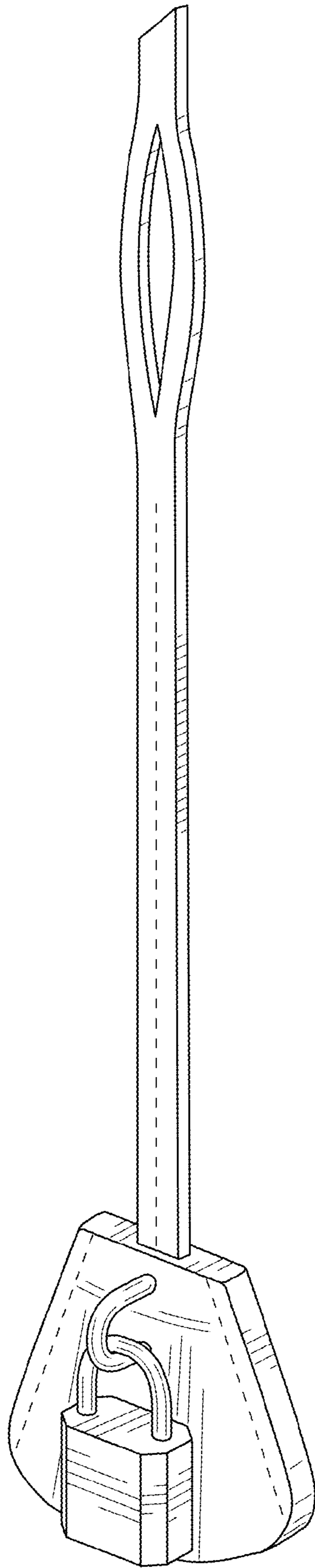

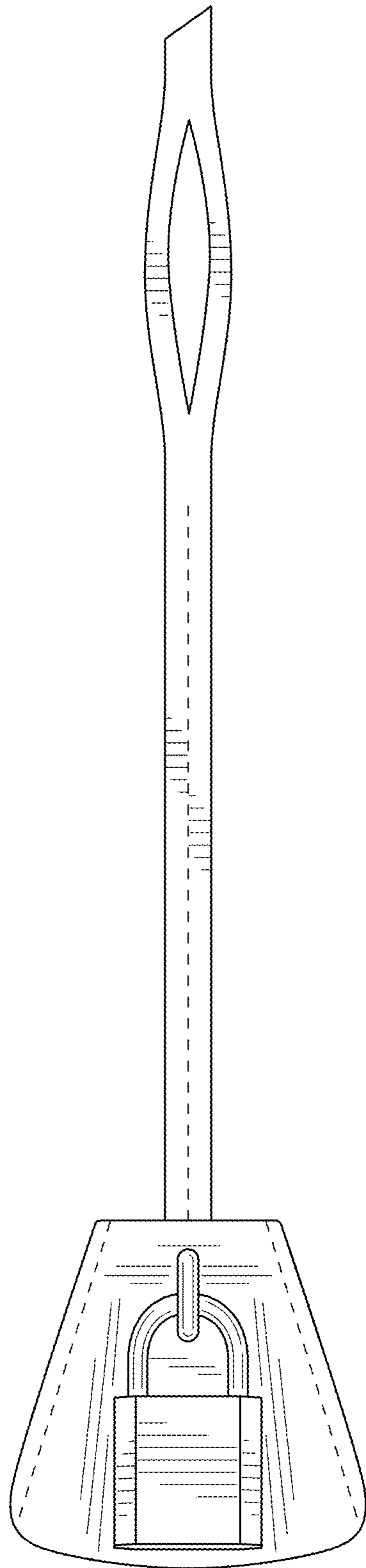

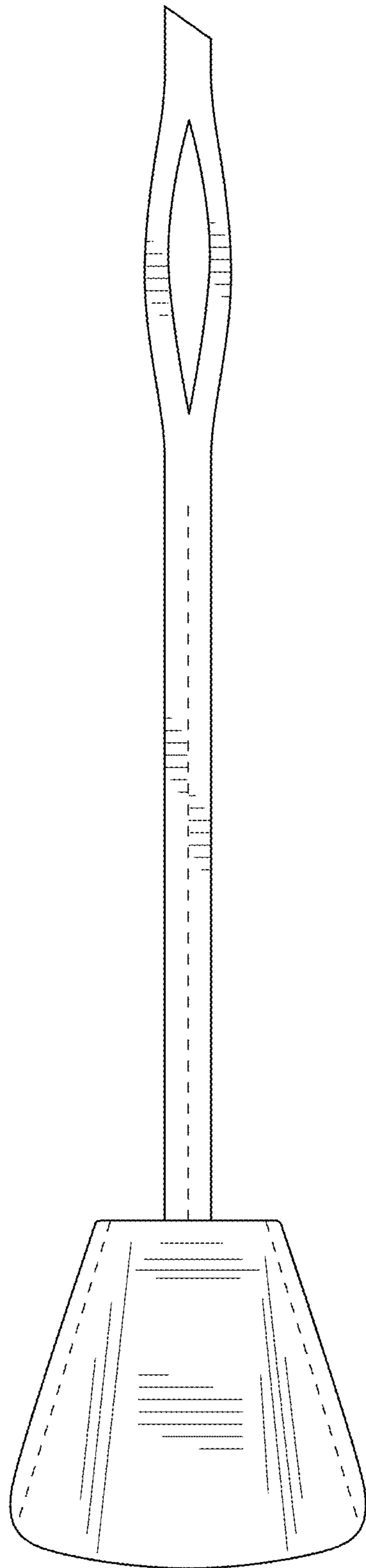

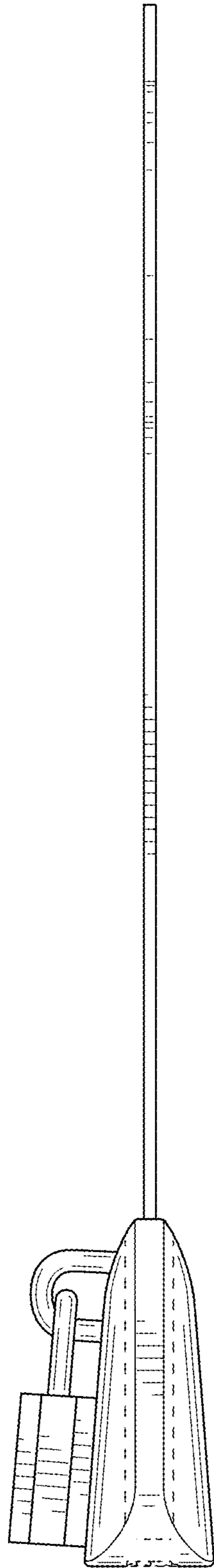

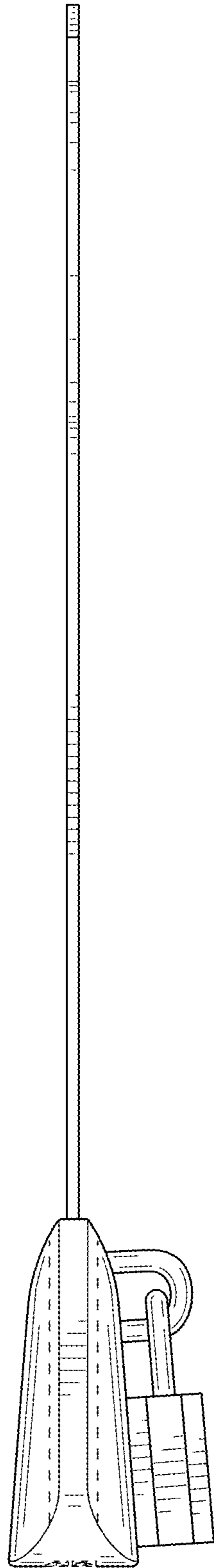

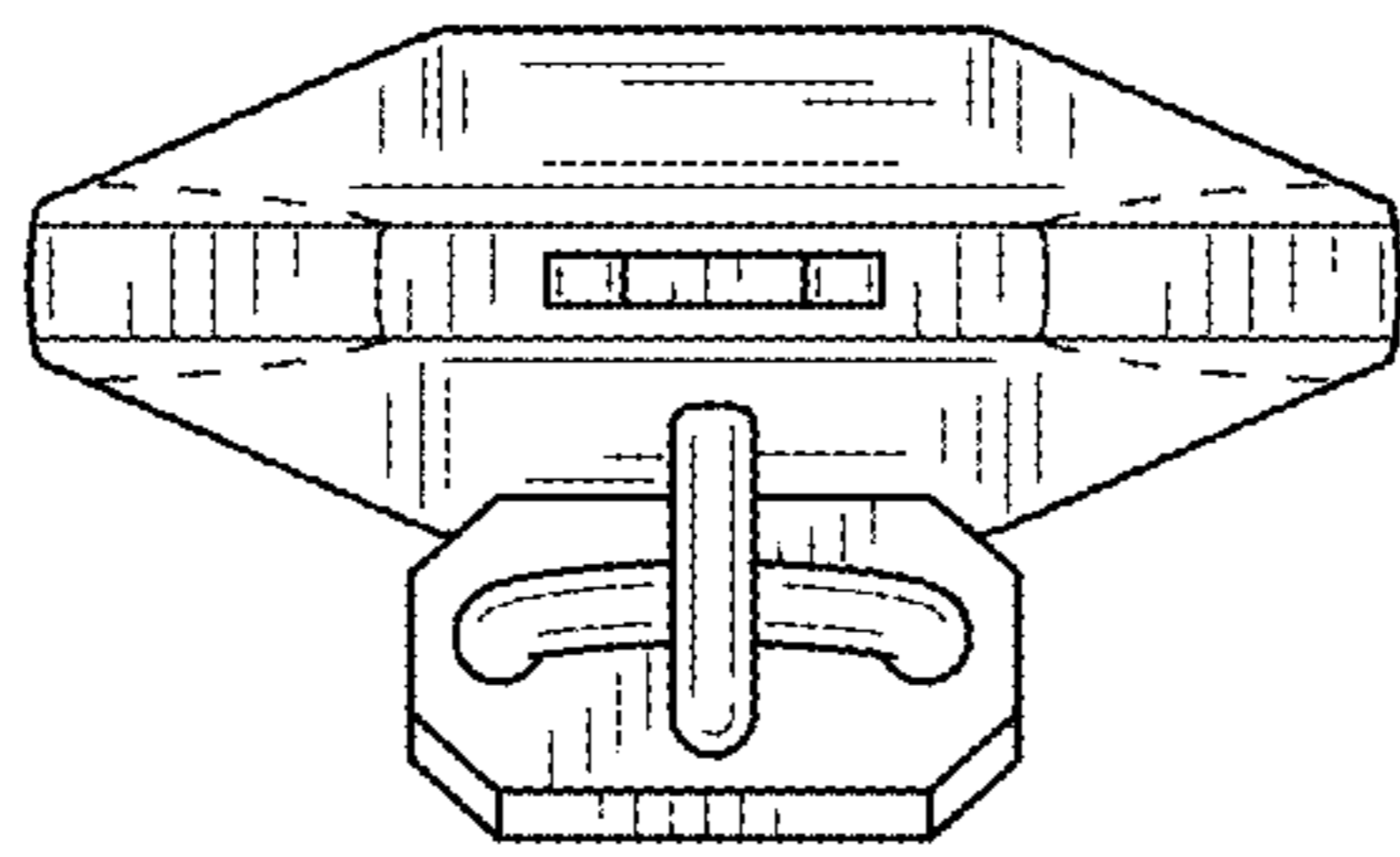
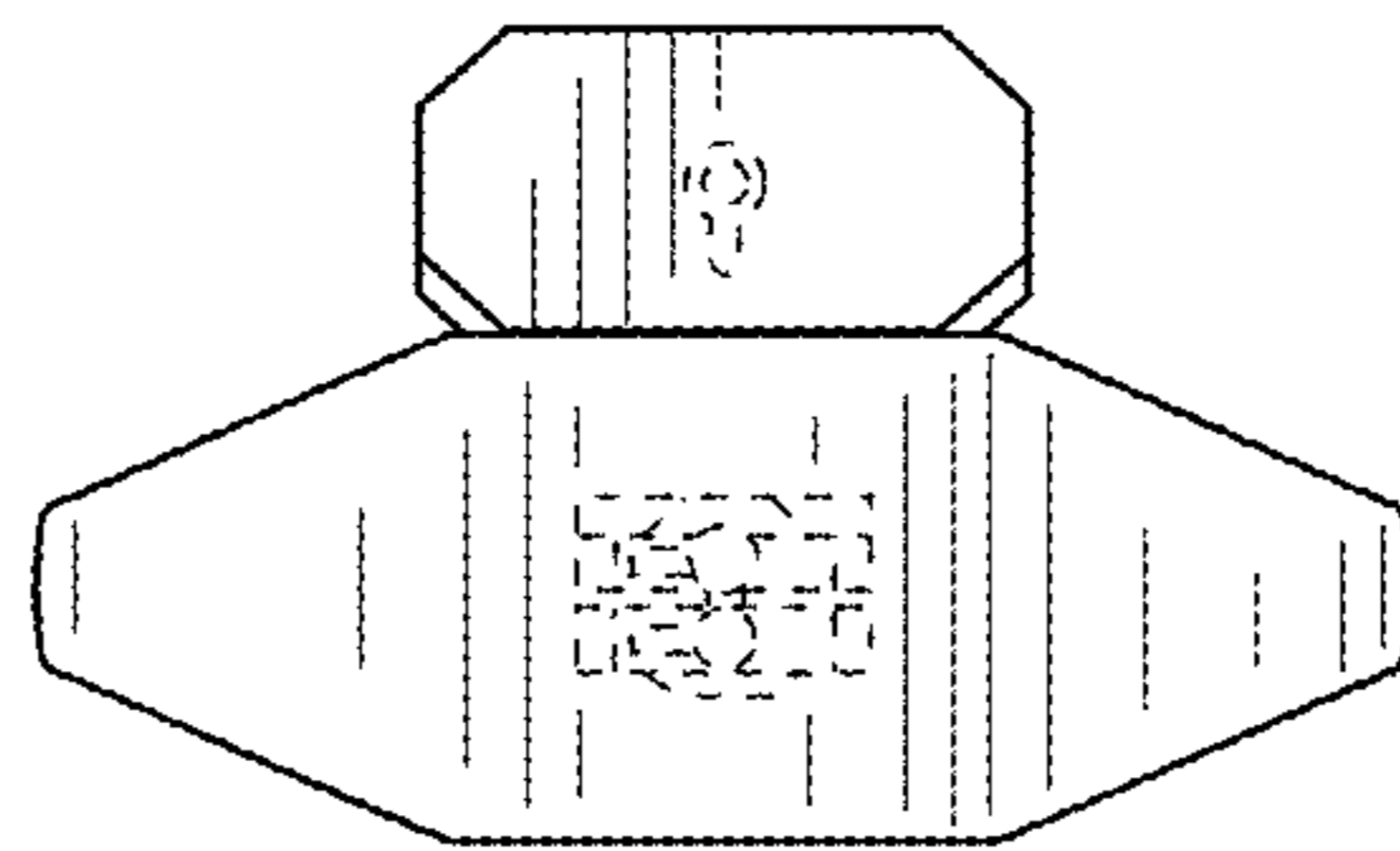
