FIG. 8 is a top right perspective thereof.

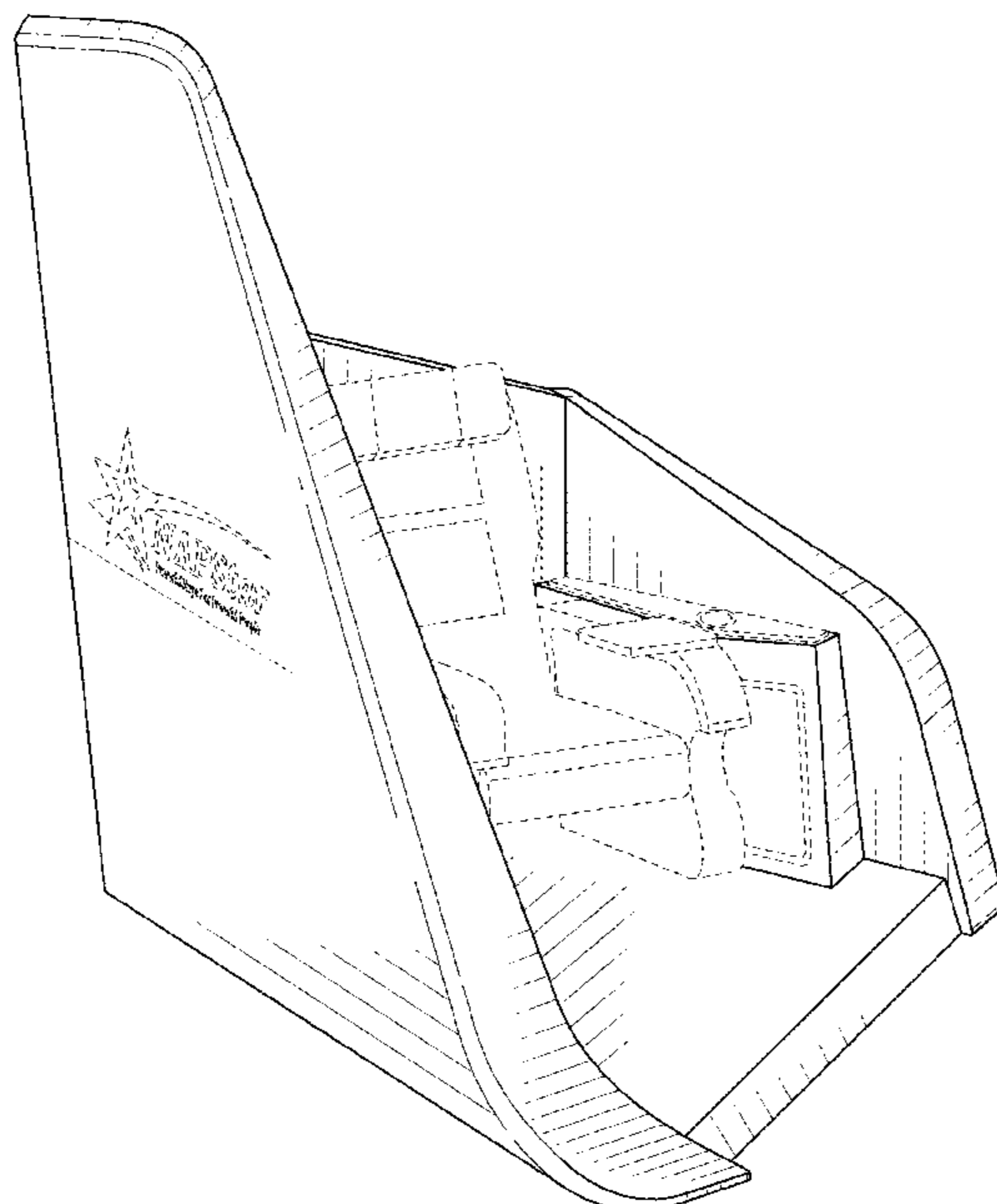

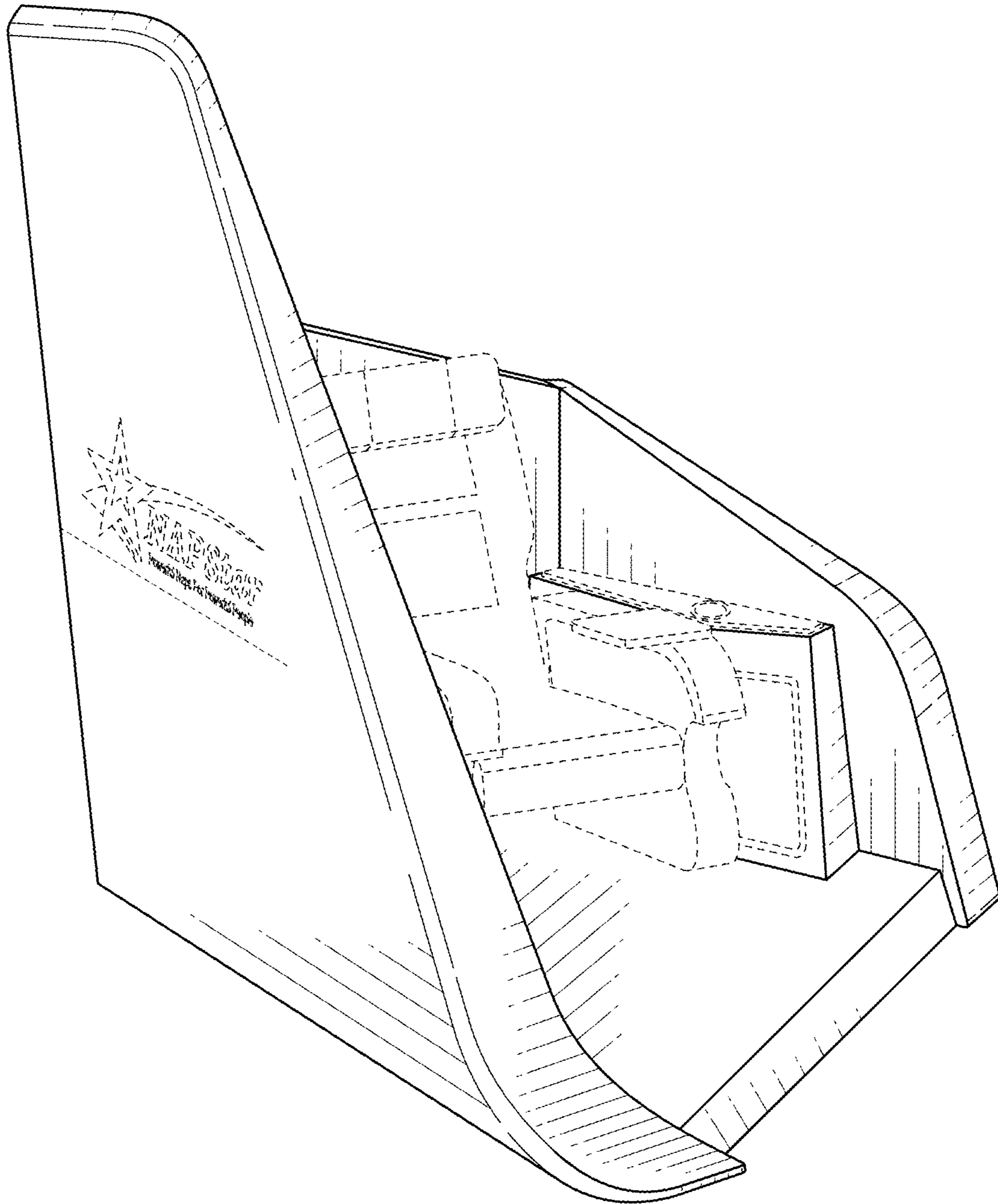

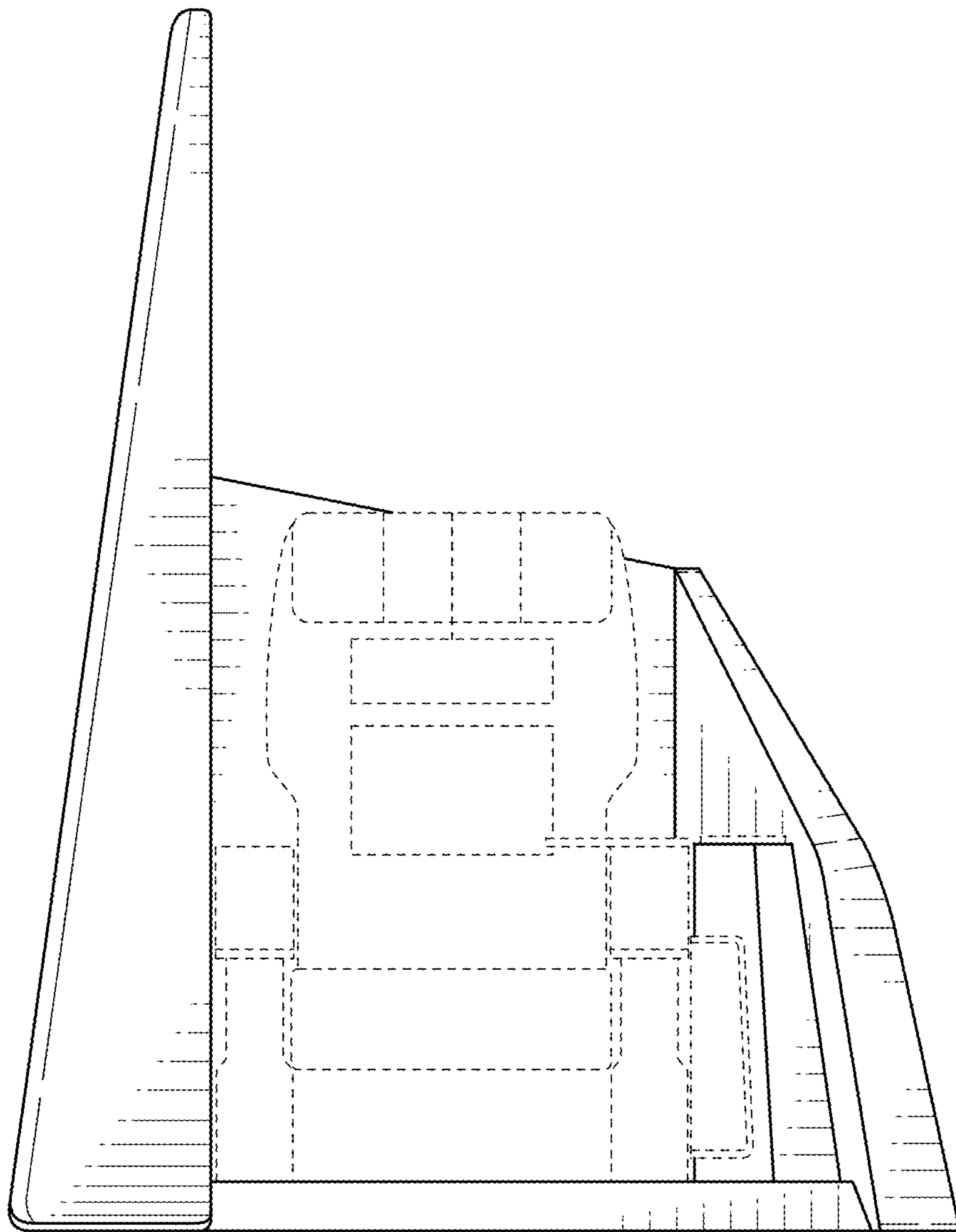

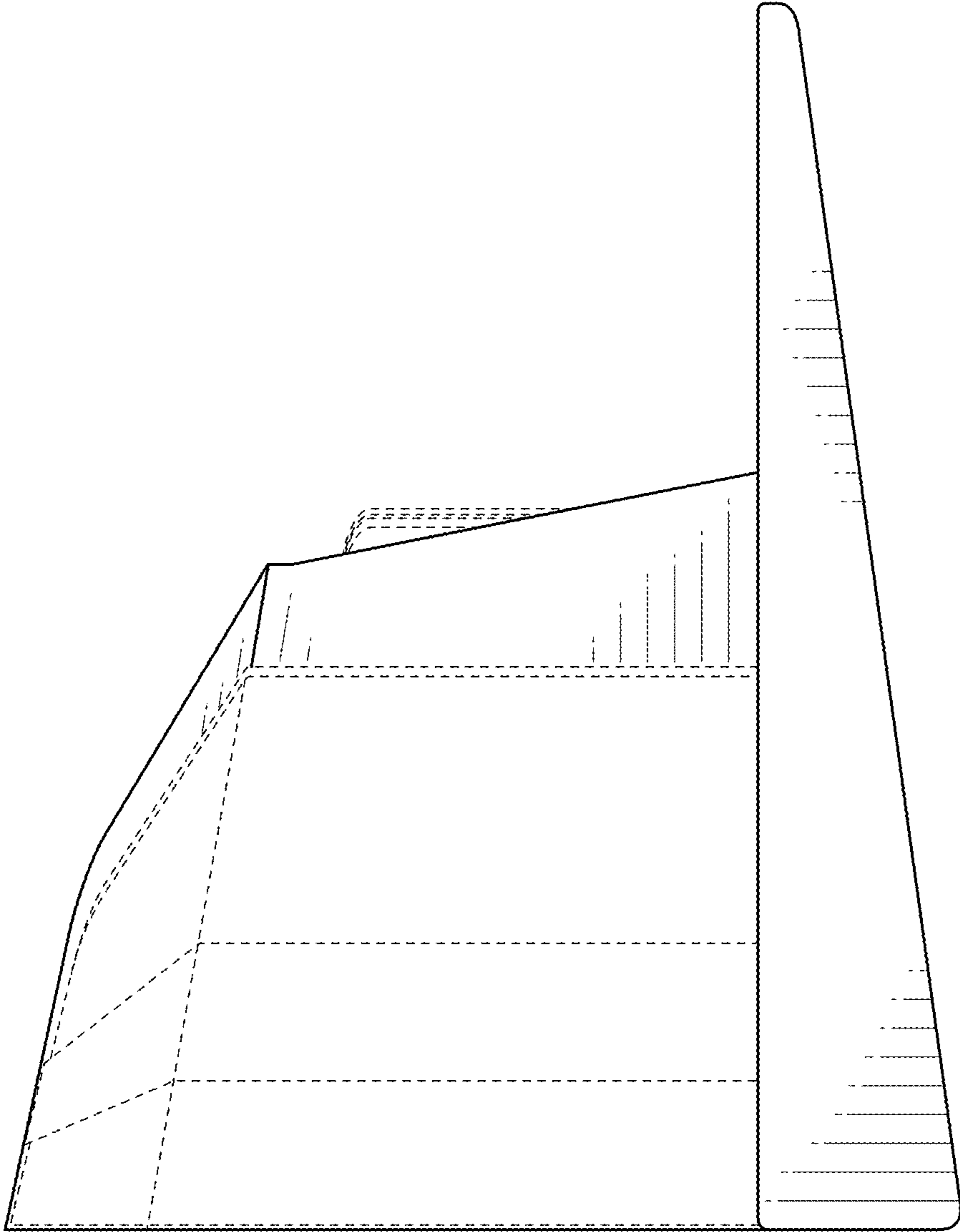

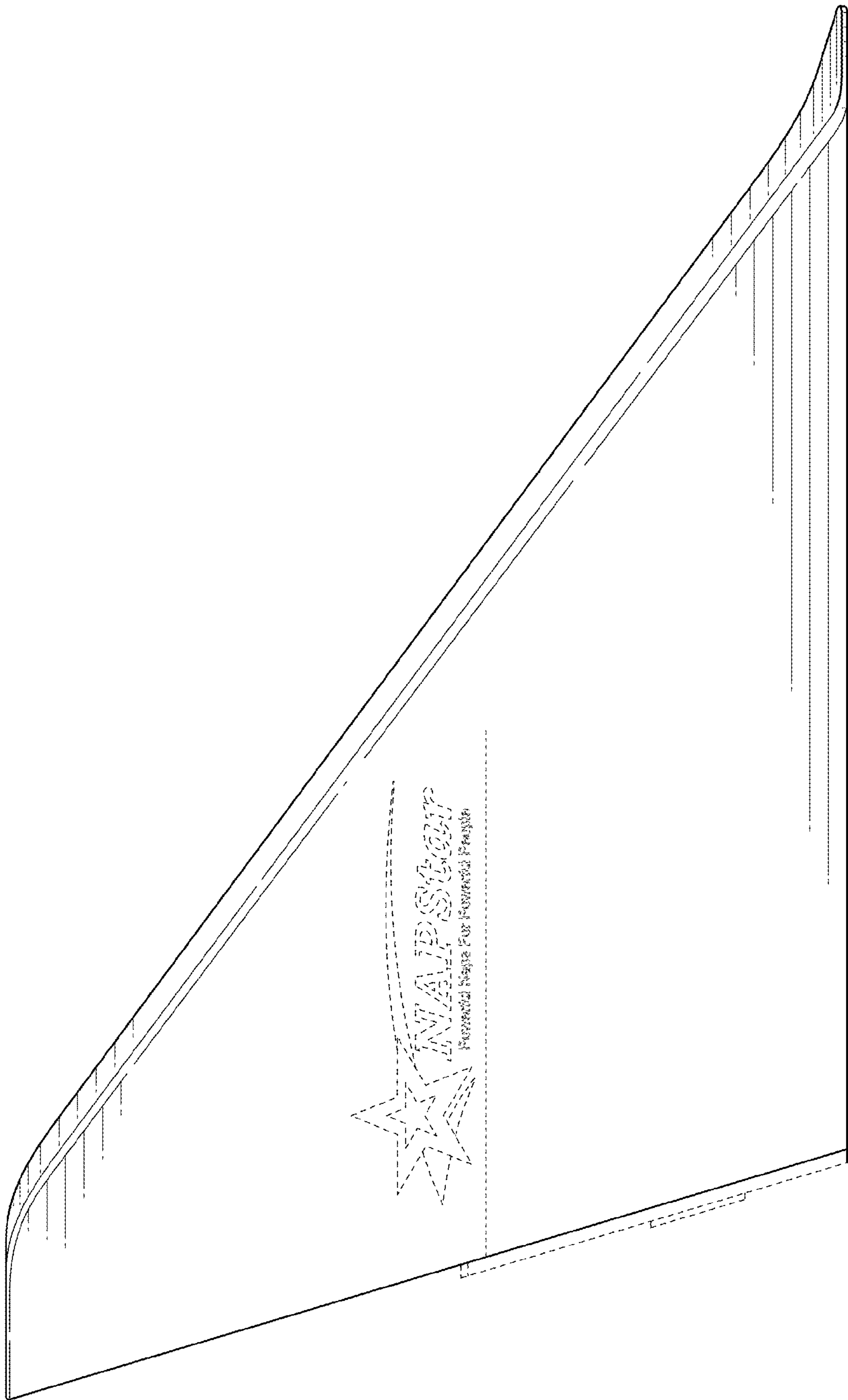

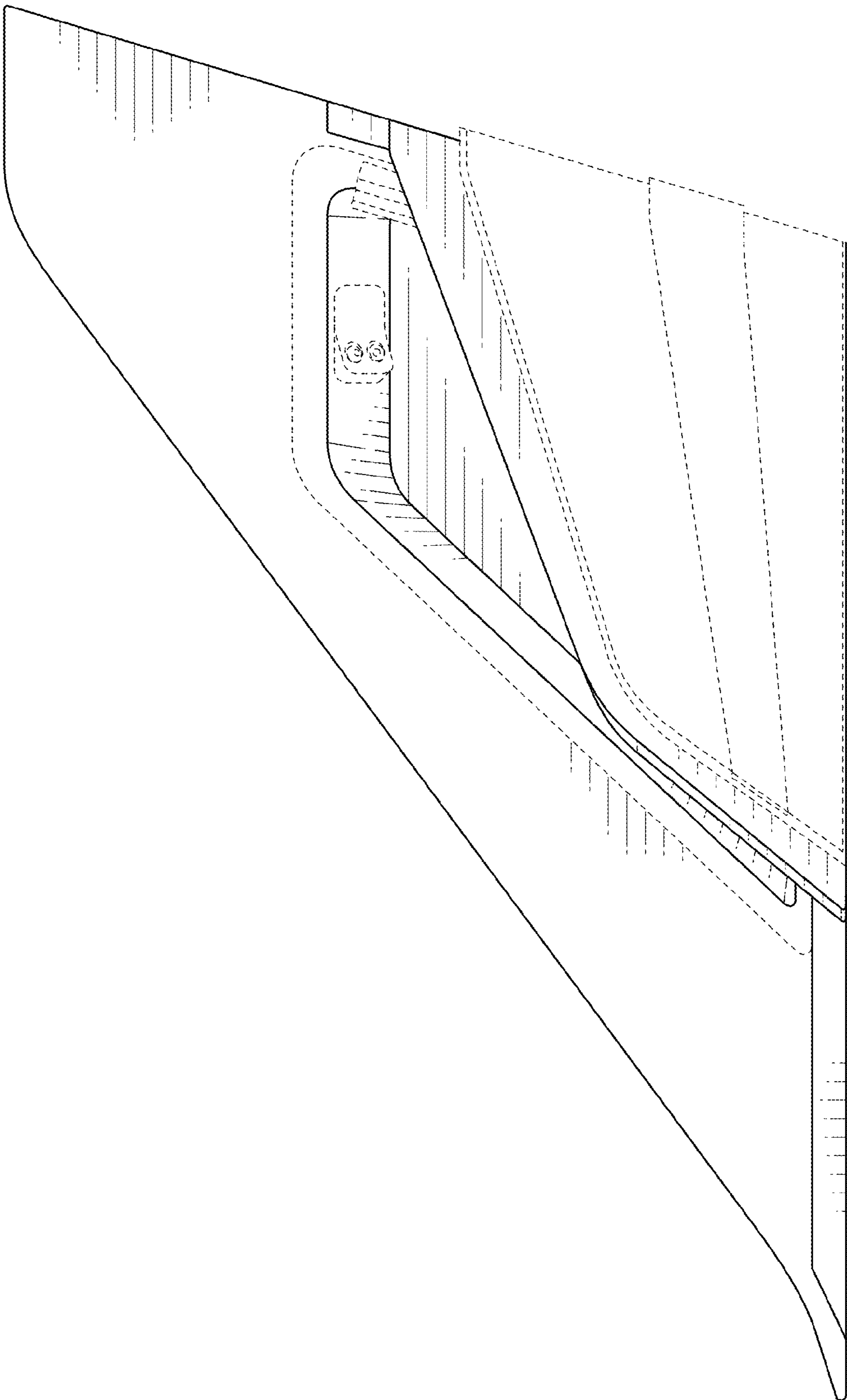

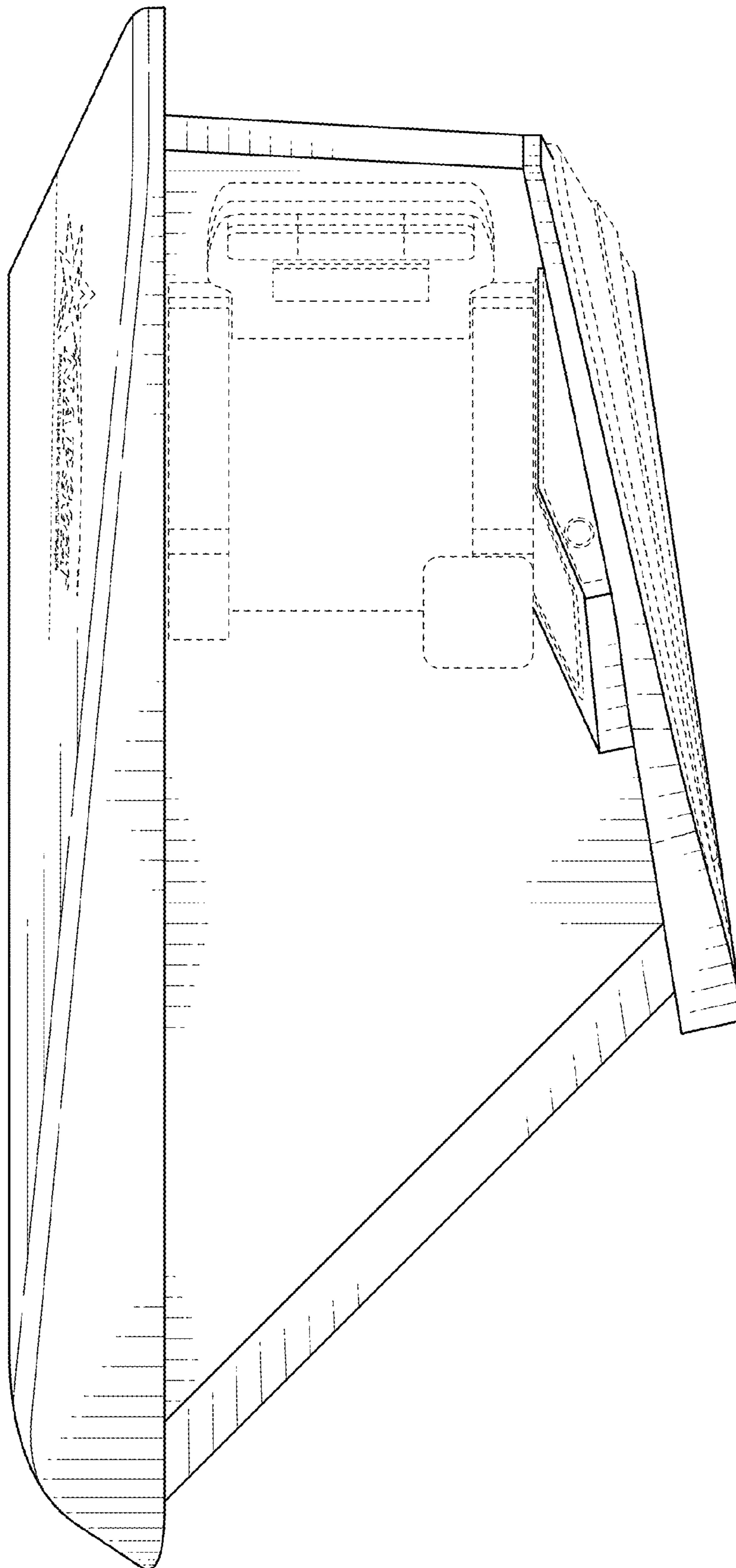

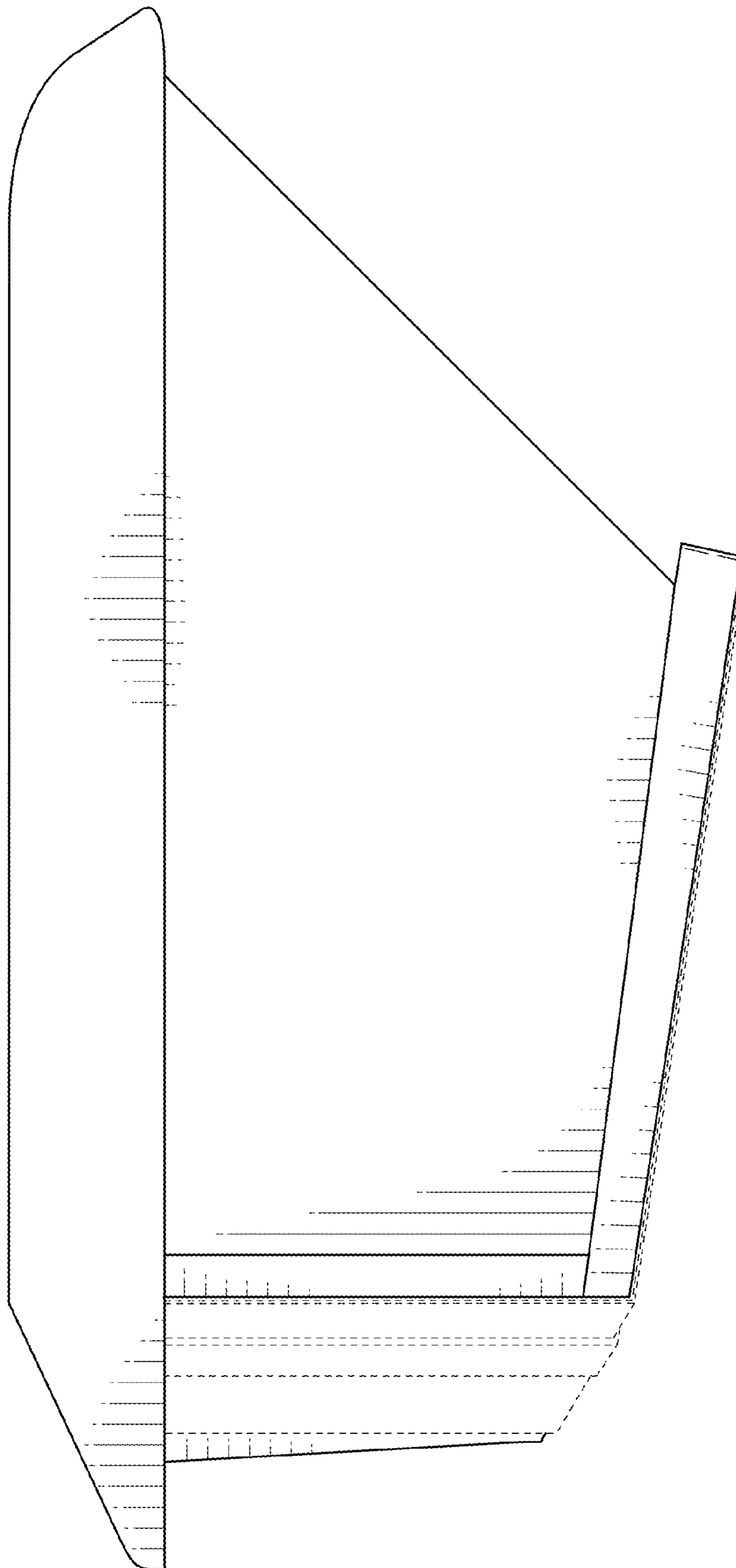

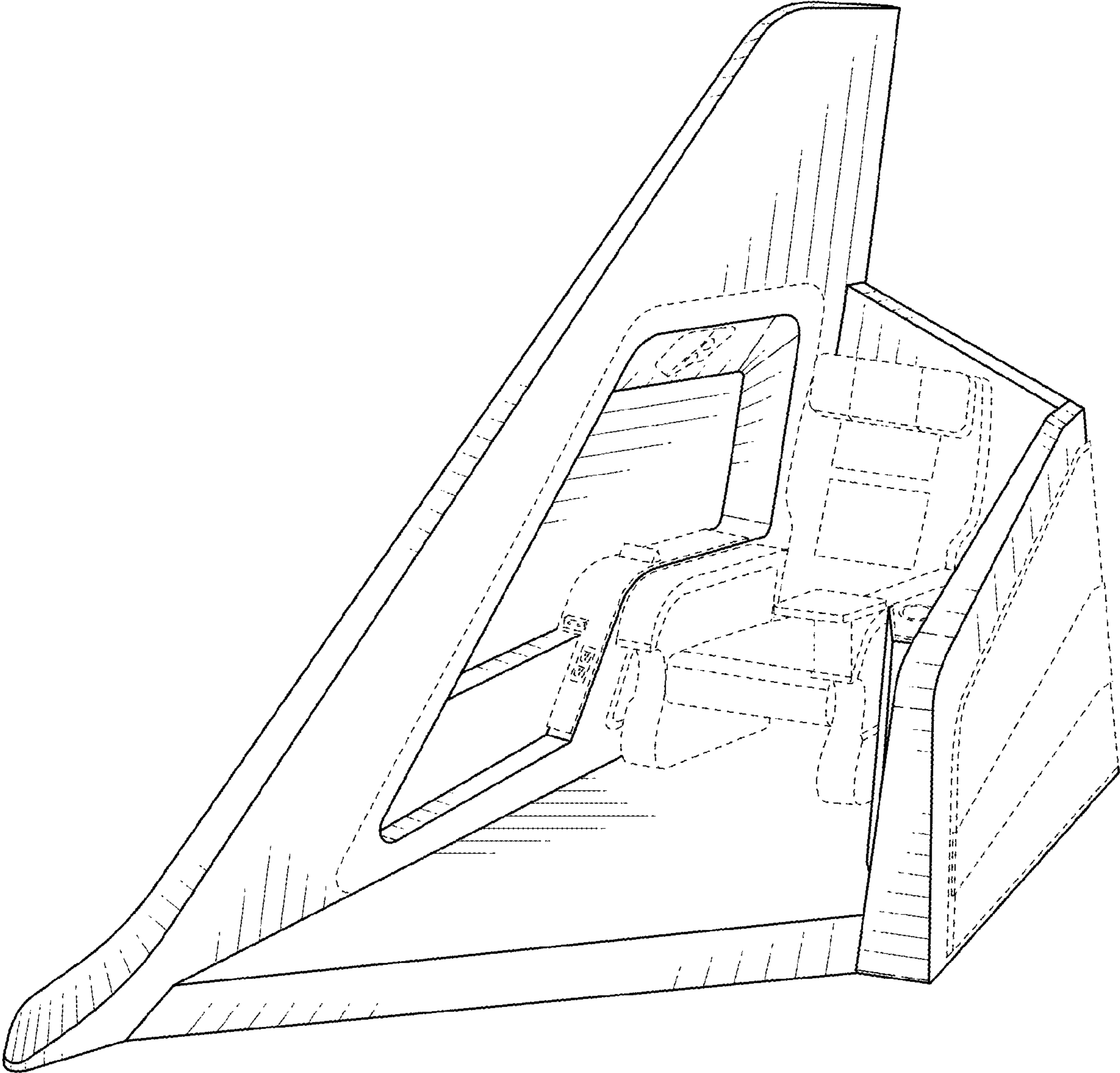
