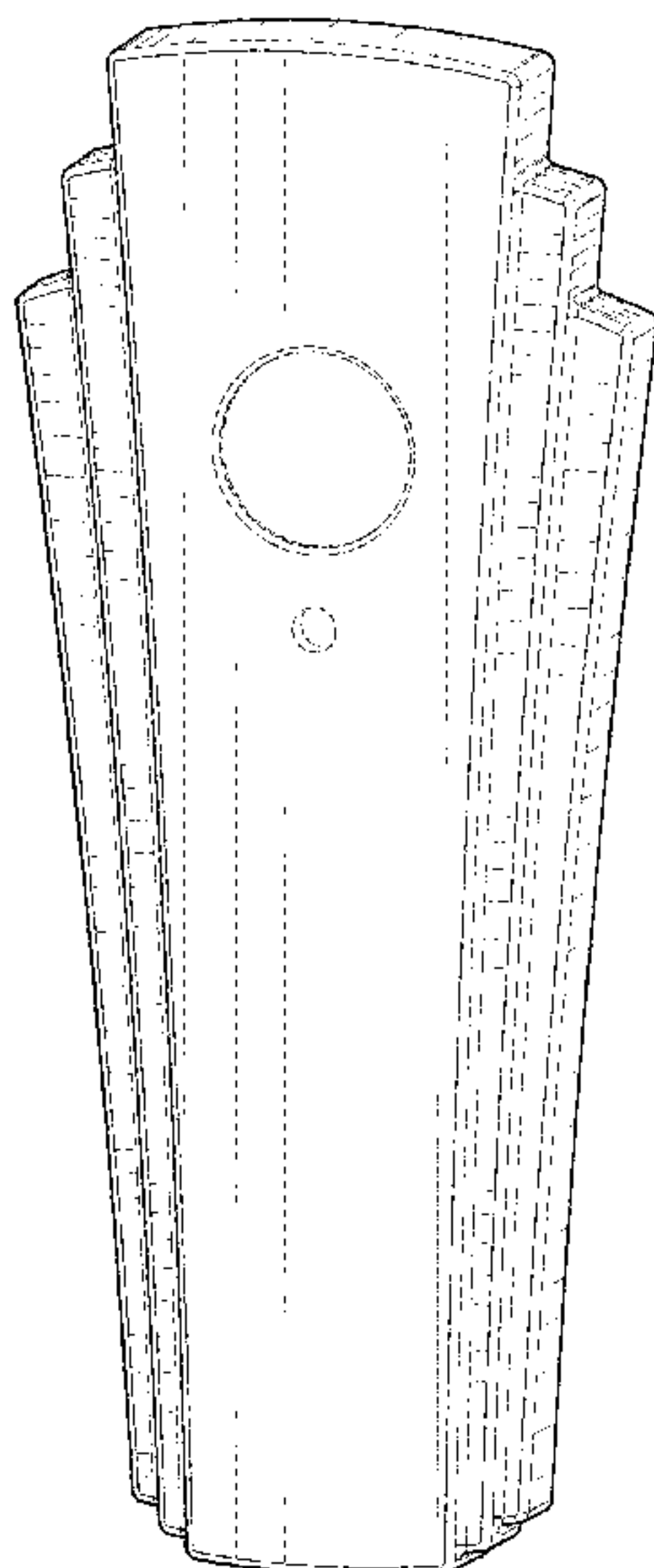
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top, right side perspective view of door trim showing our new design;
FIG. 2 is a front elevational view thereof;

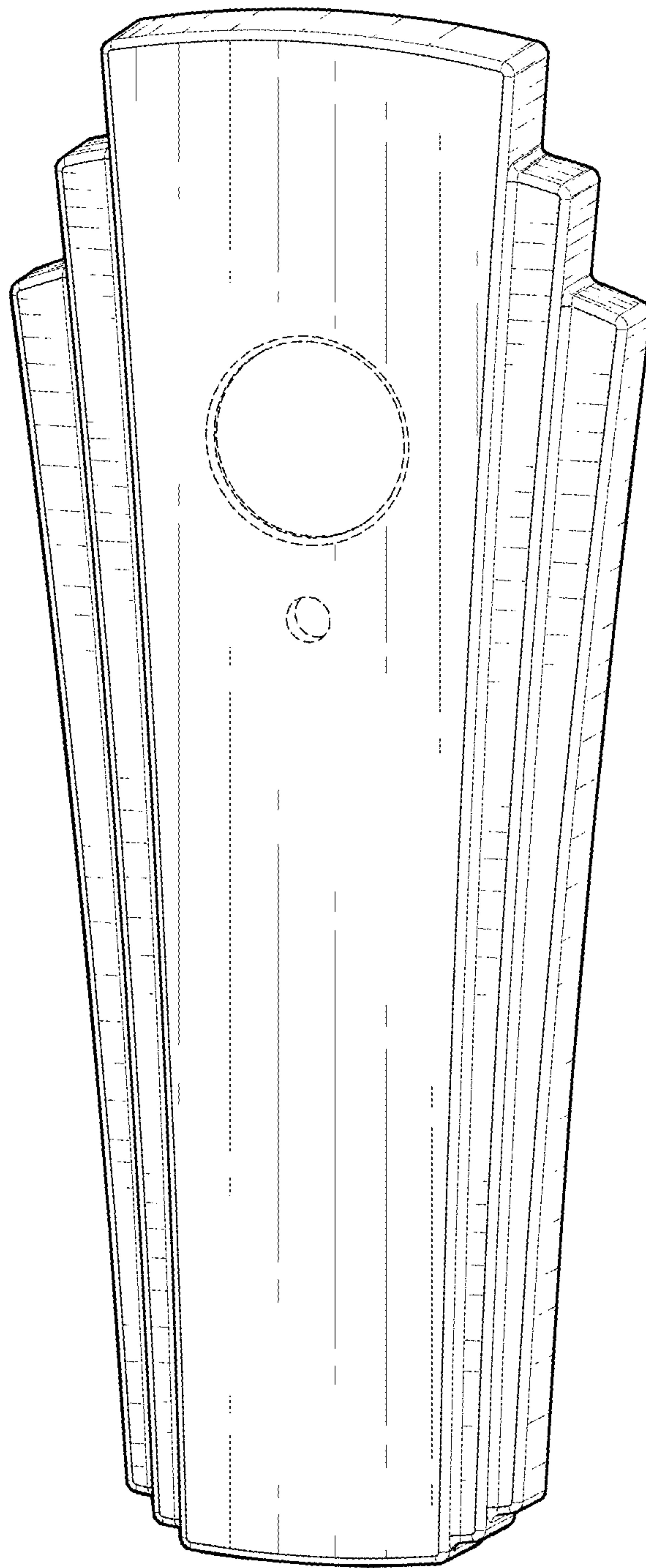

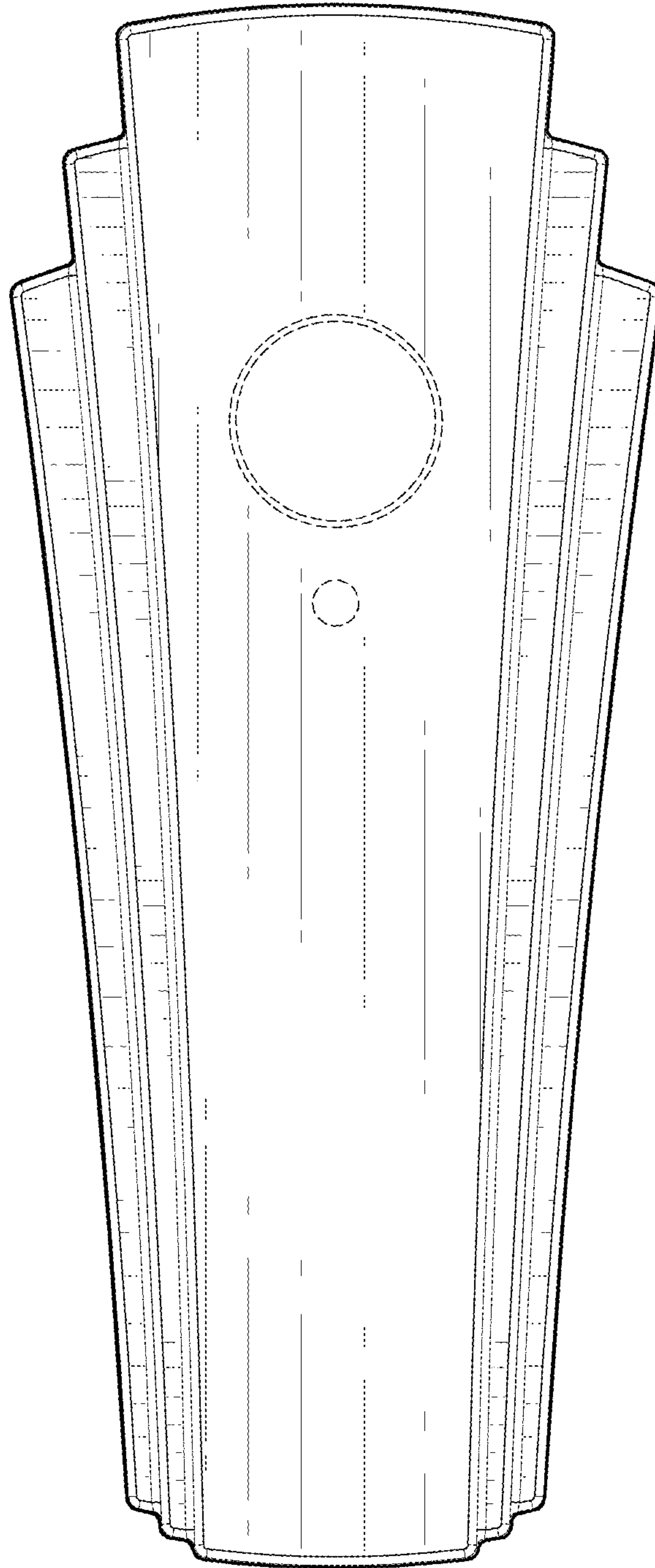

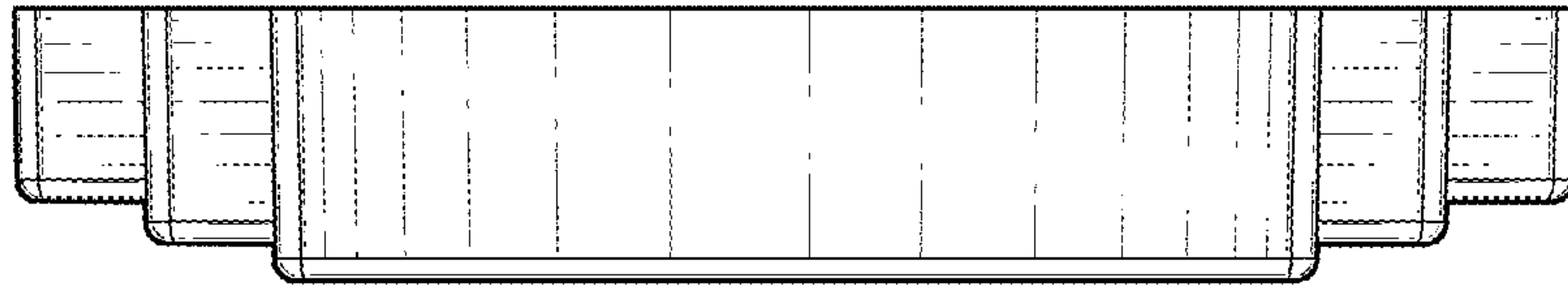

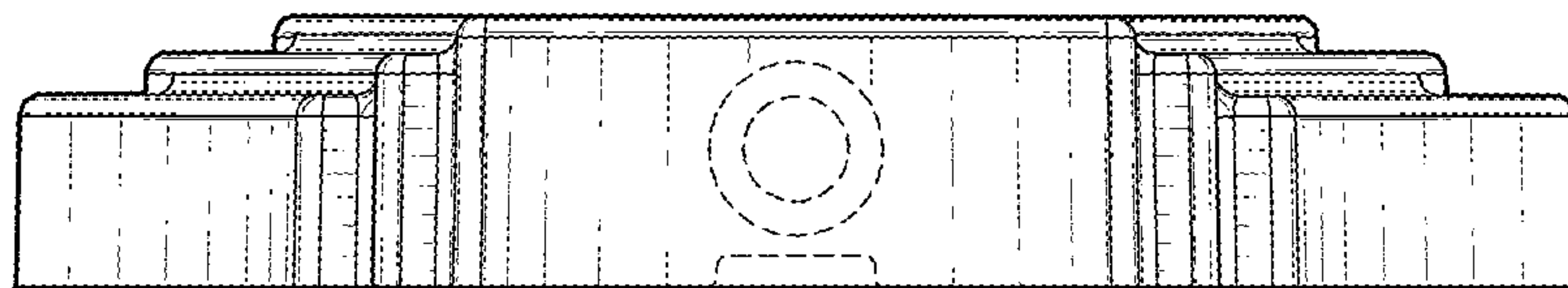

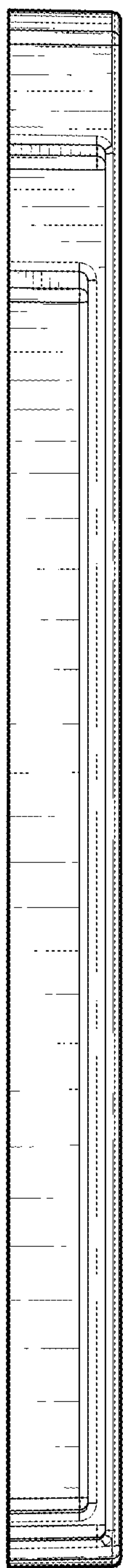

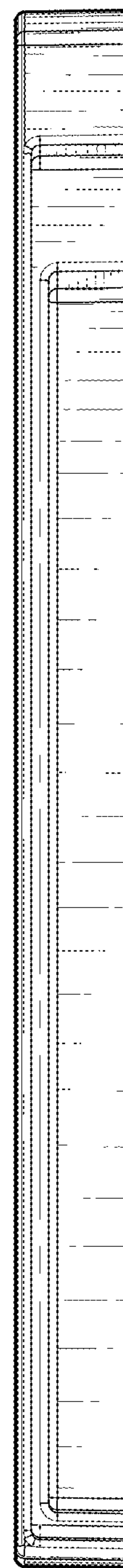
