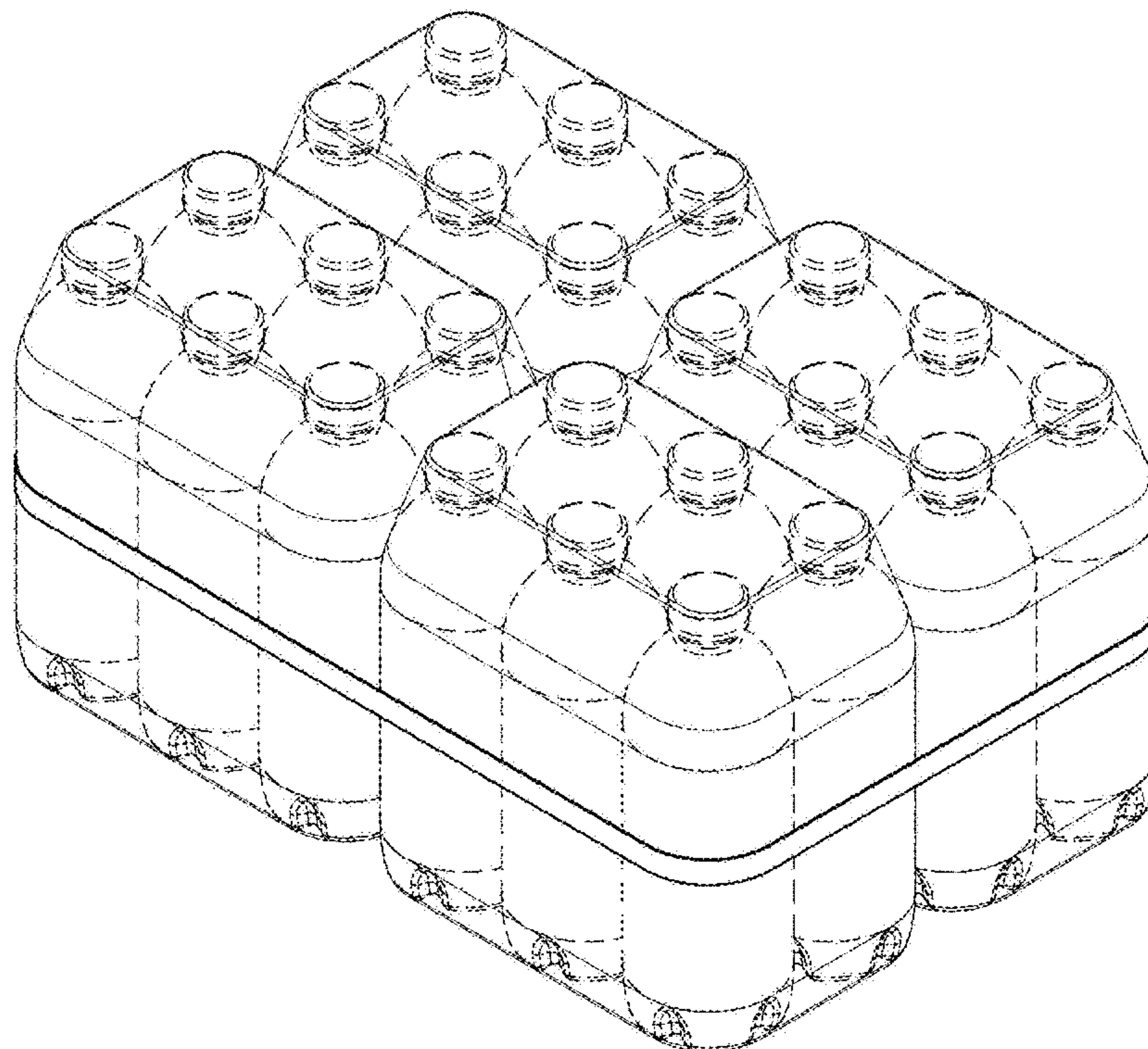
The ornamental design for a strap arrangement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a strap arrangement showing my new design;
FIG. 2 is a front elevational view thereof;

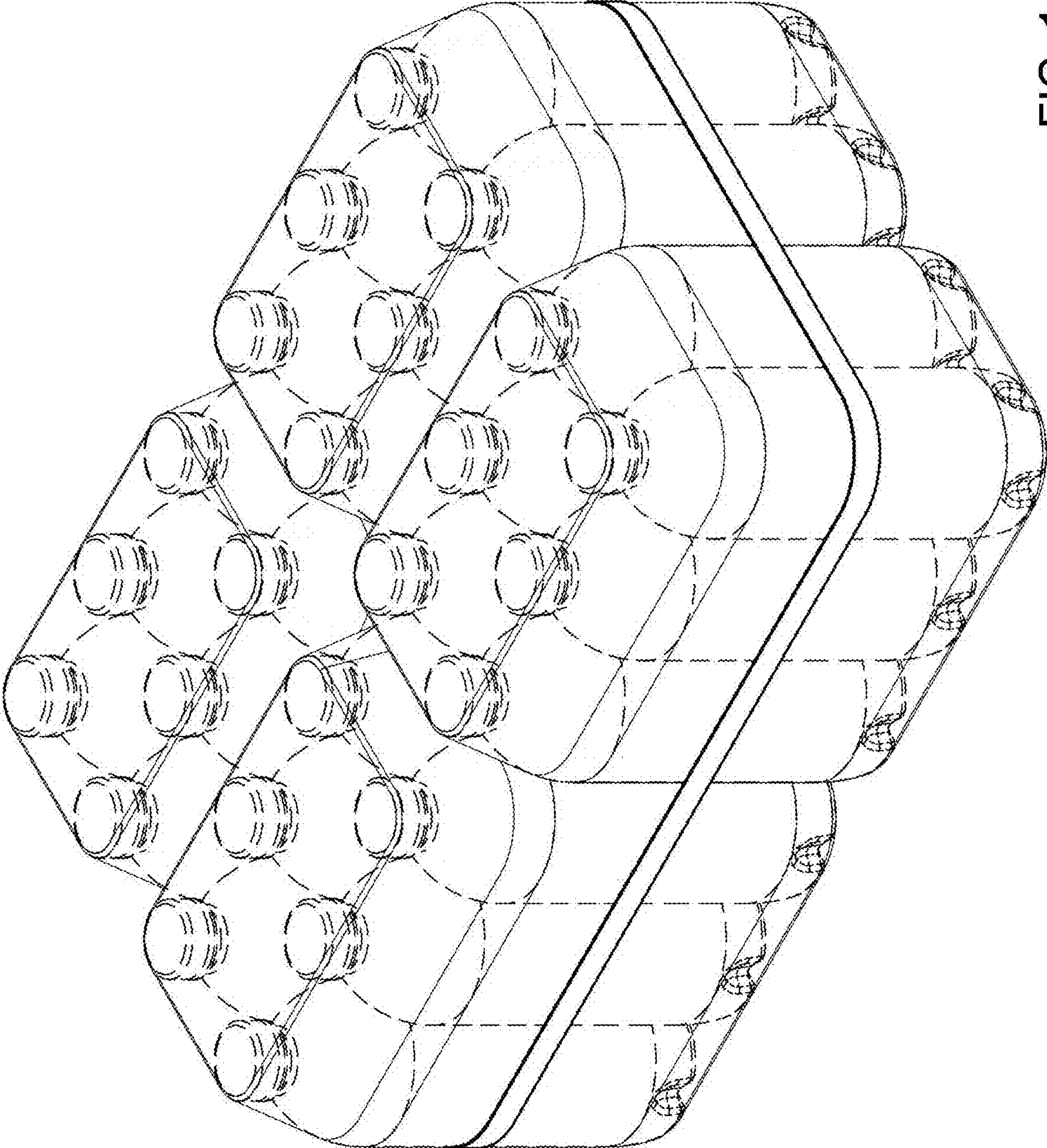

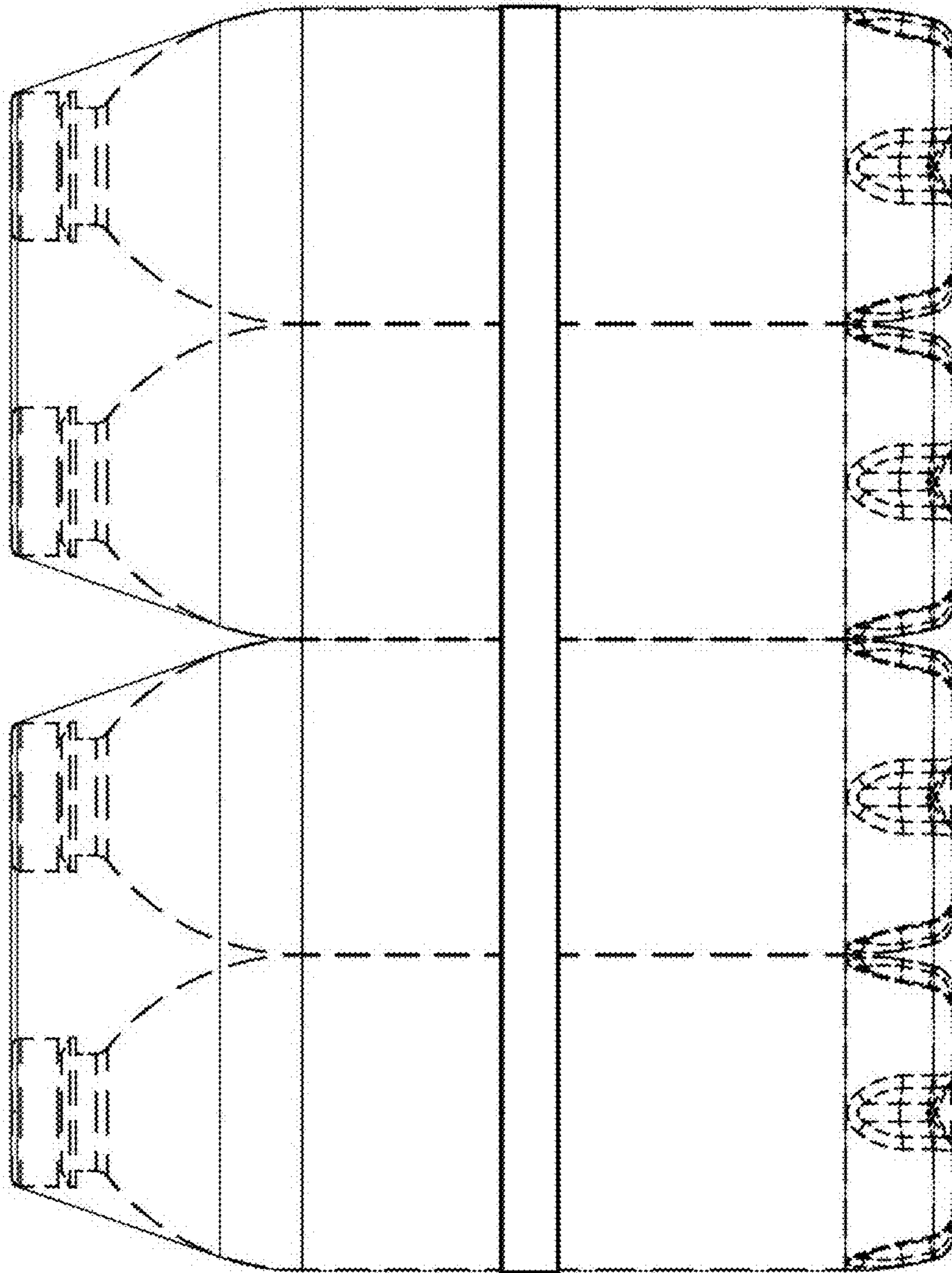

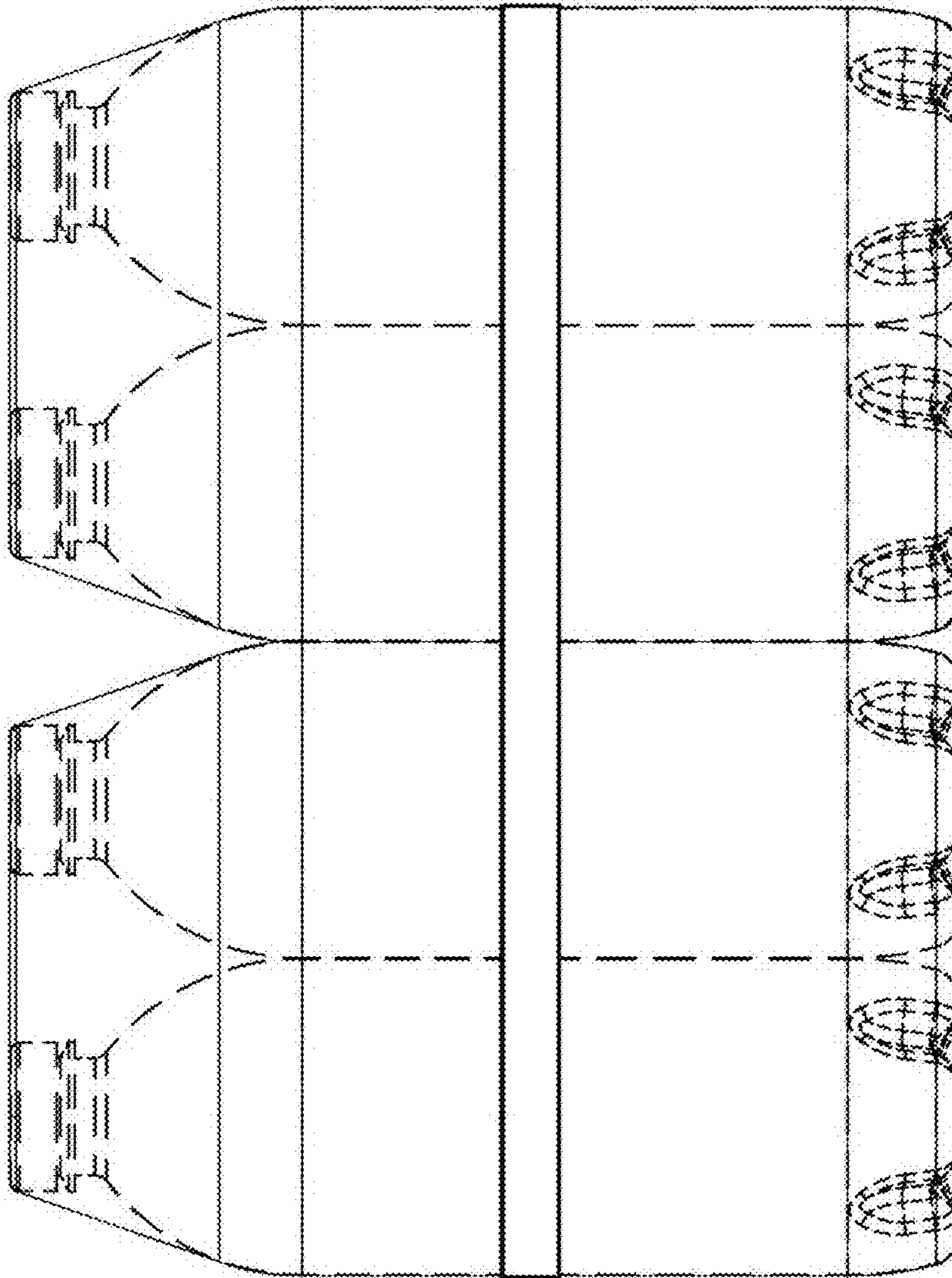

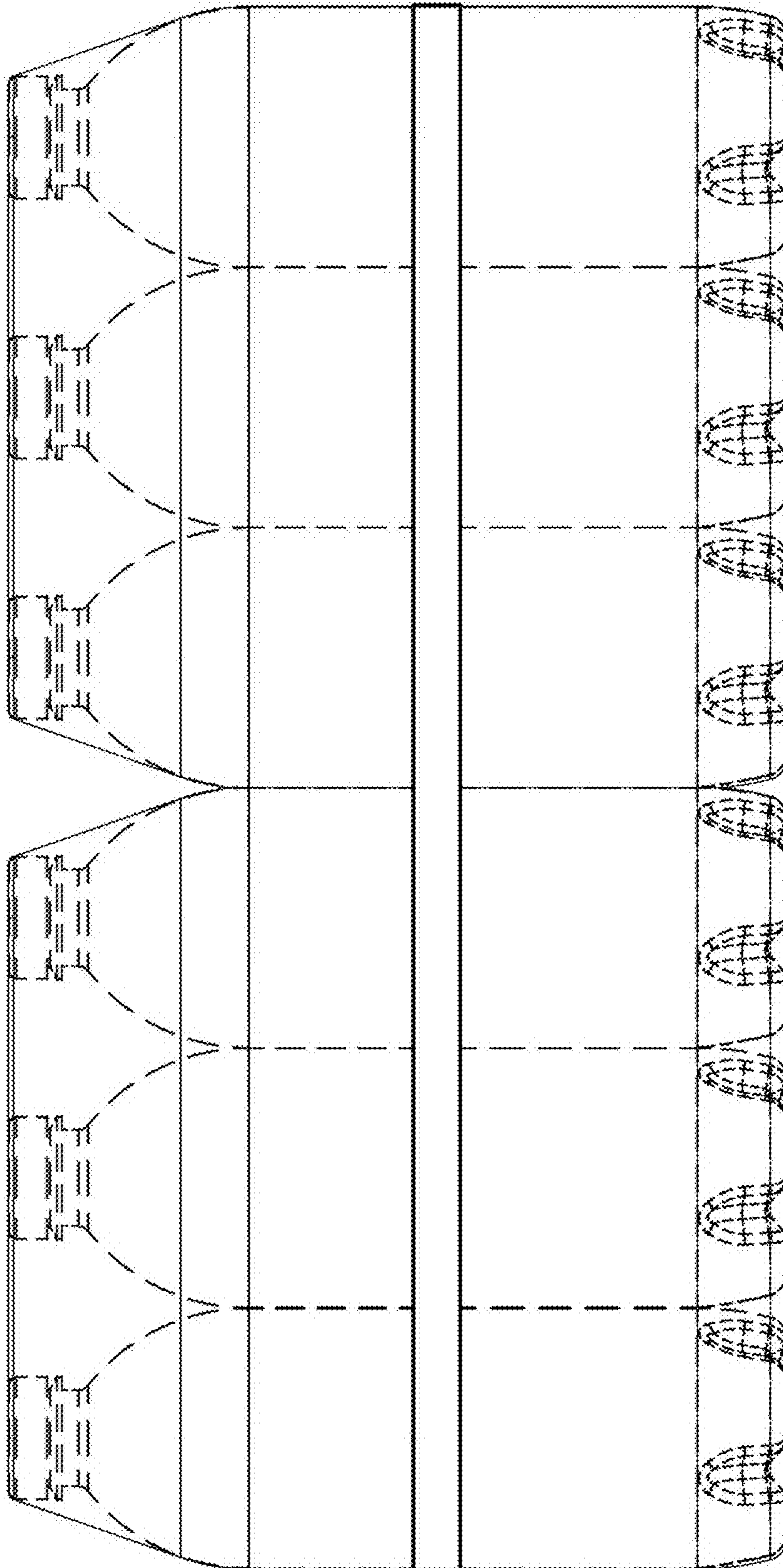

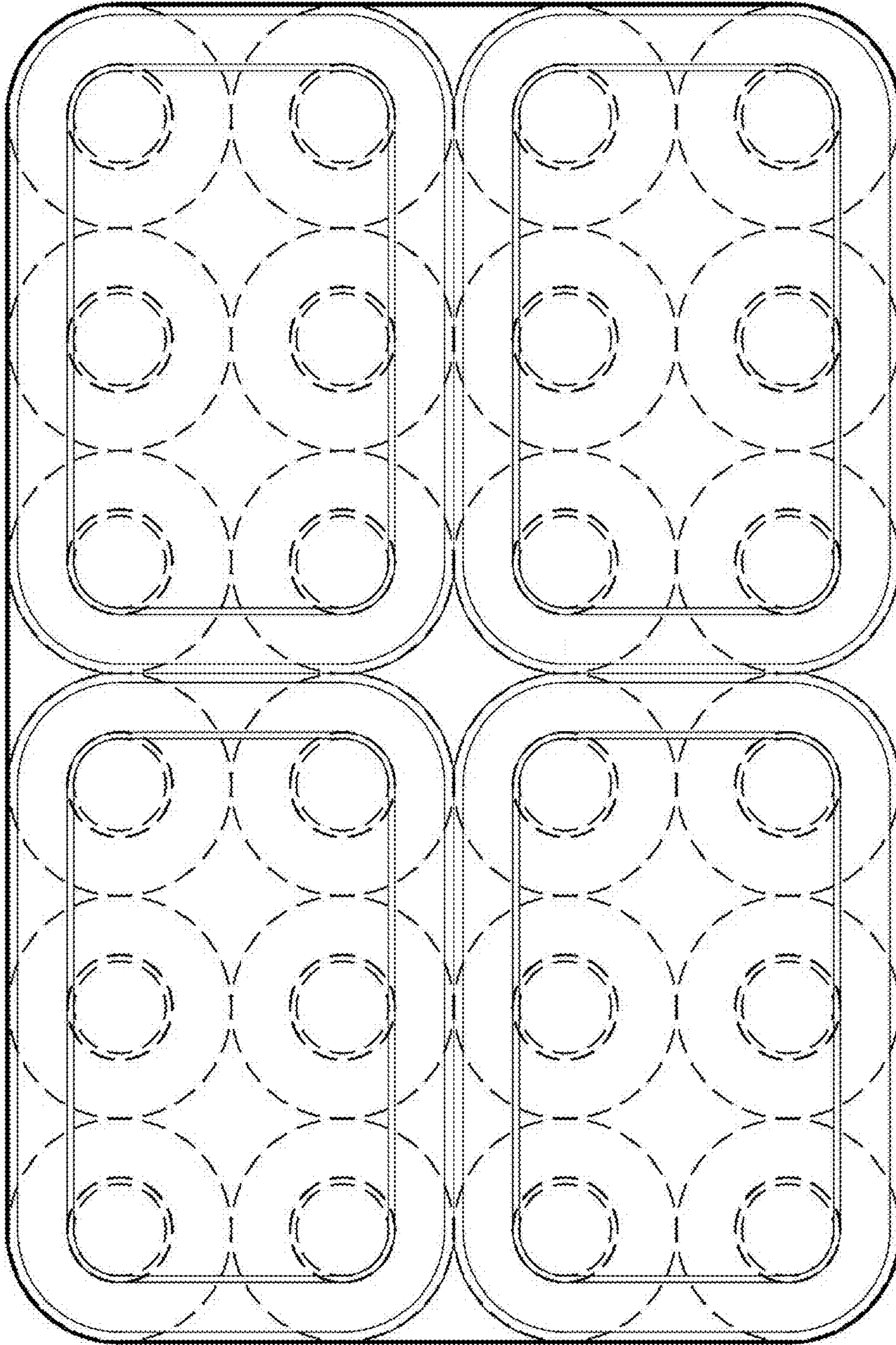
