**DESCRIPTION**

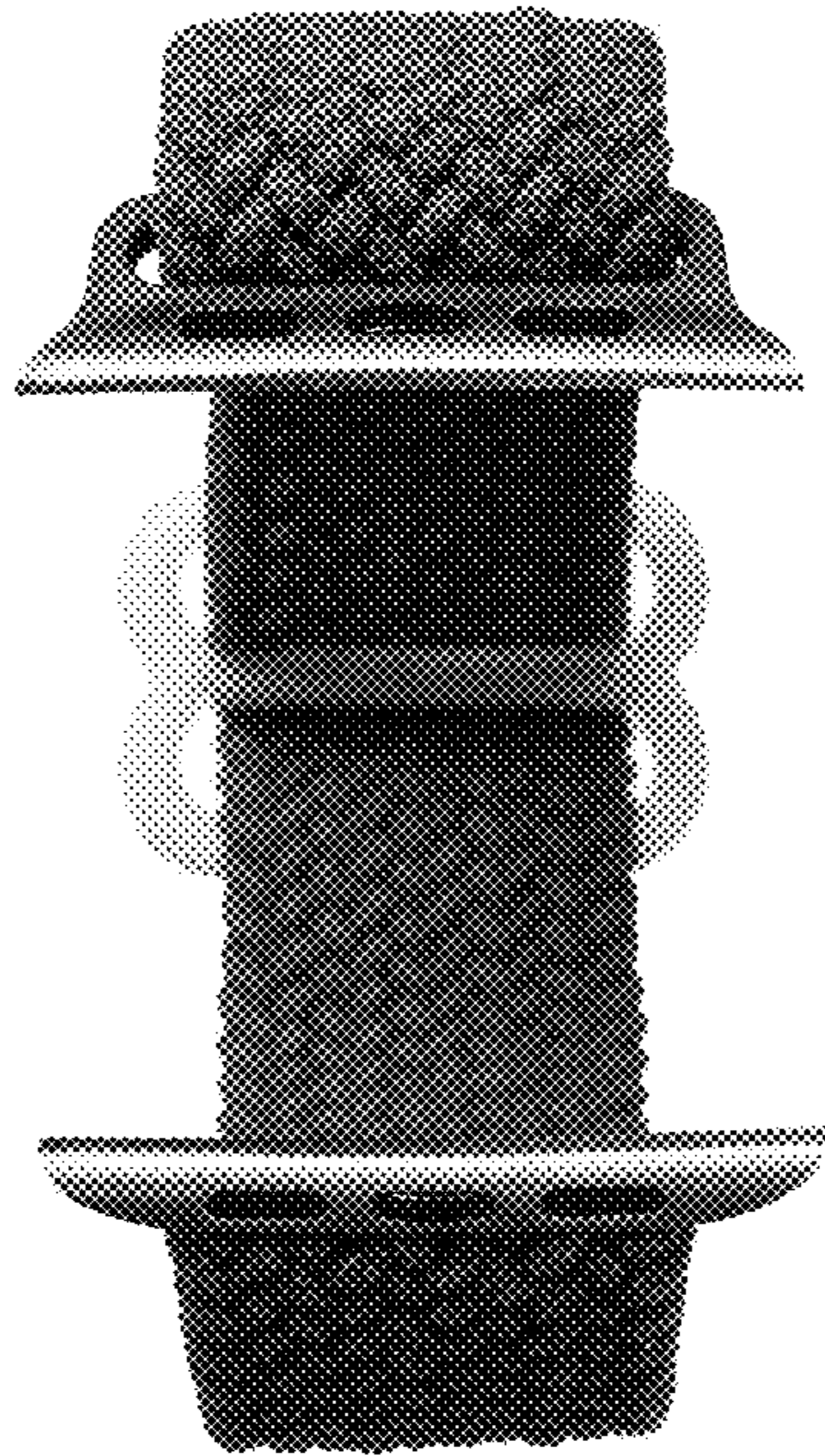

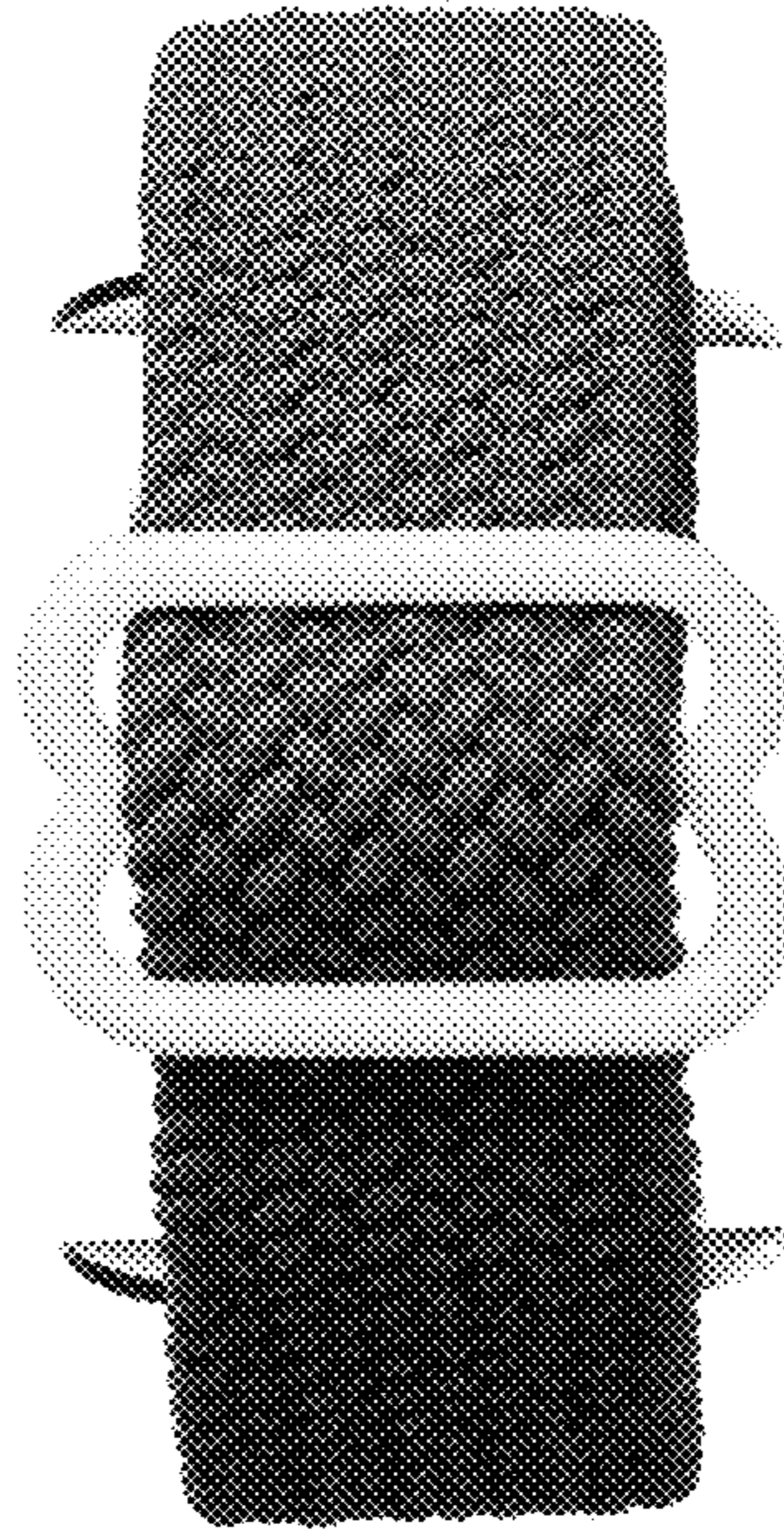

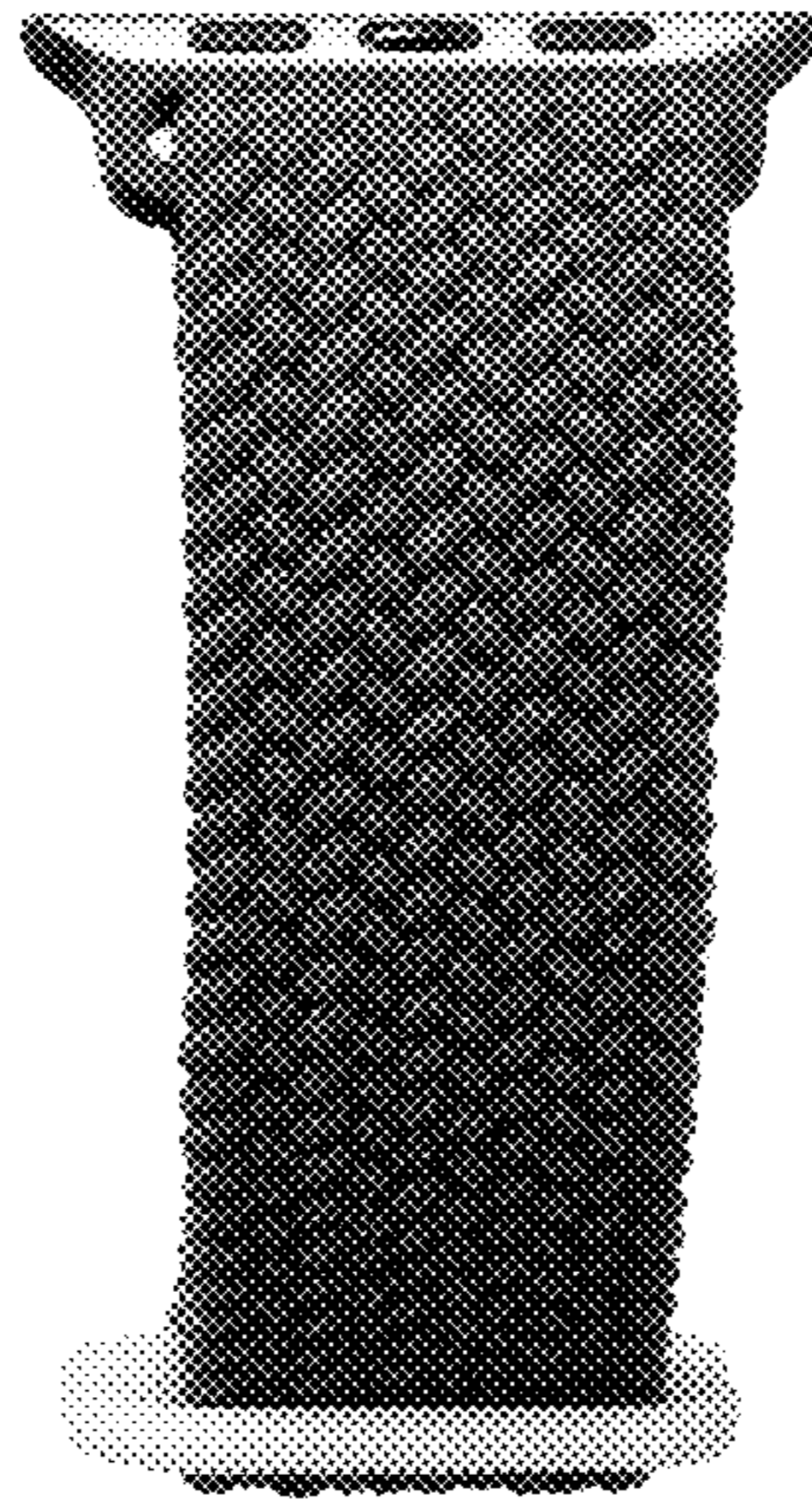

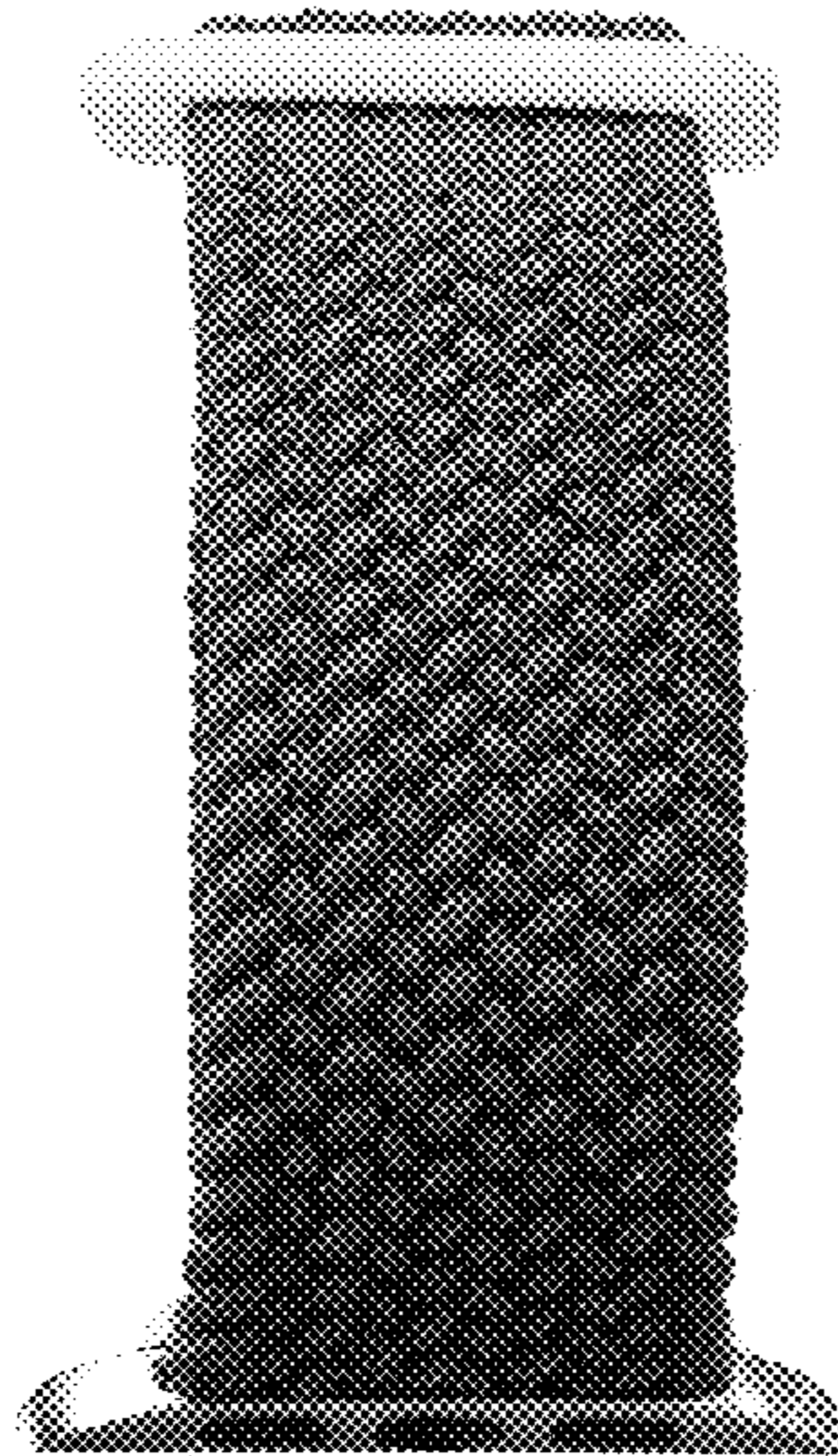

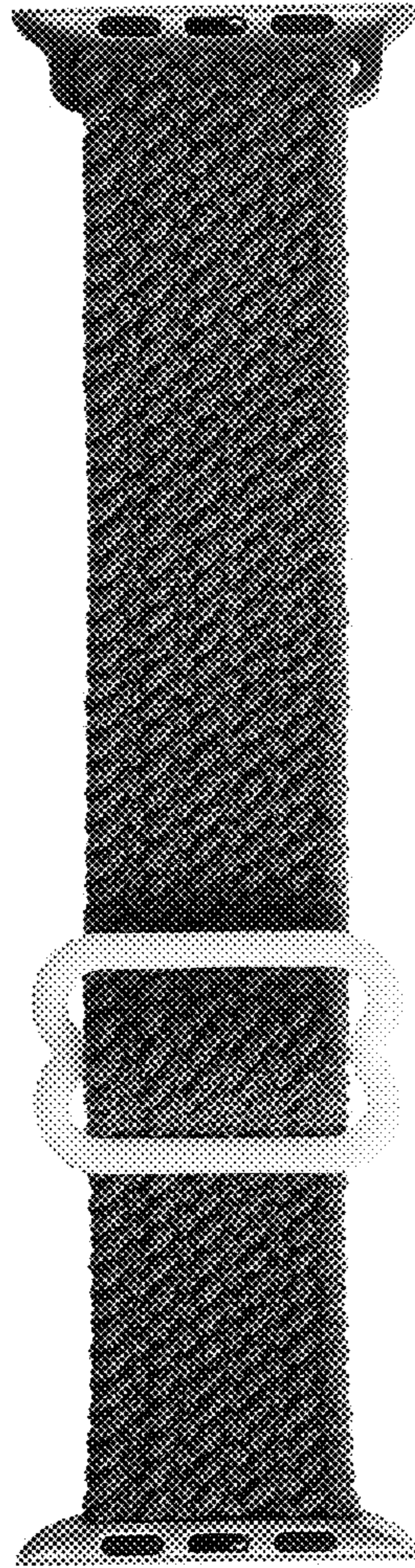

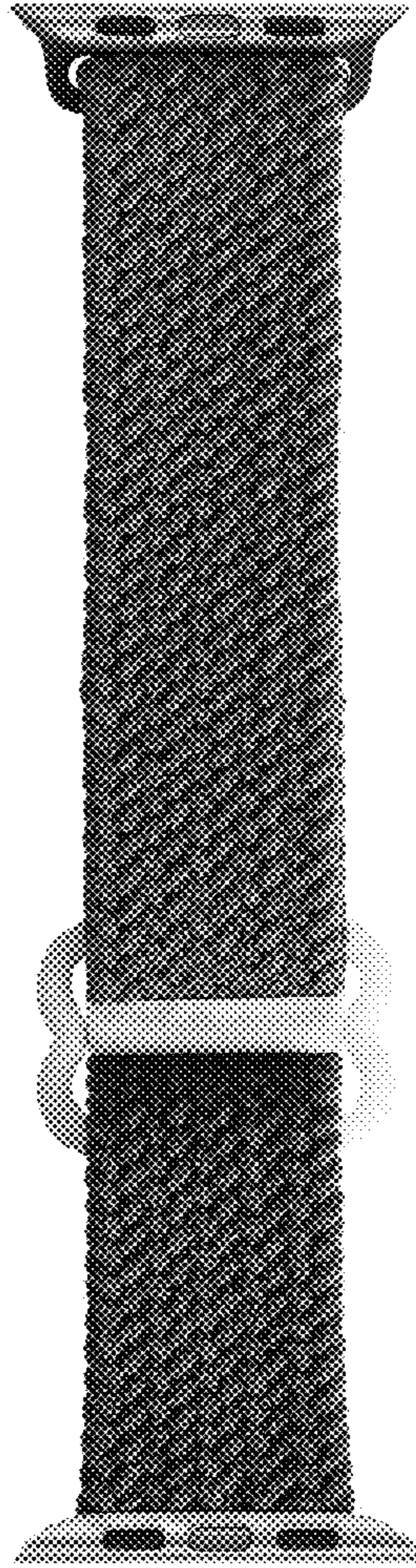

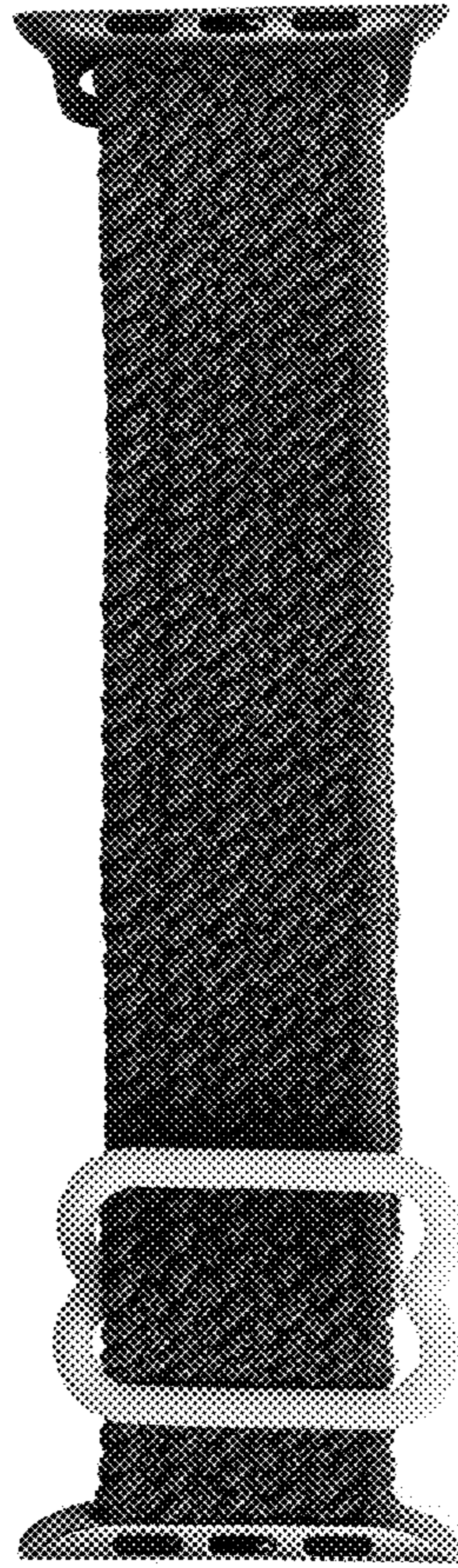

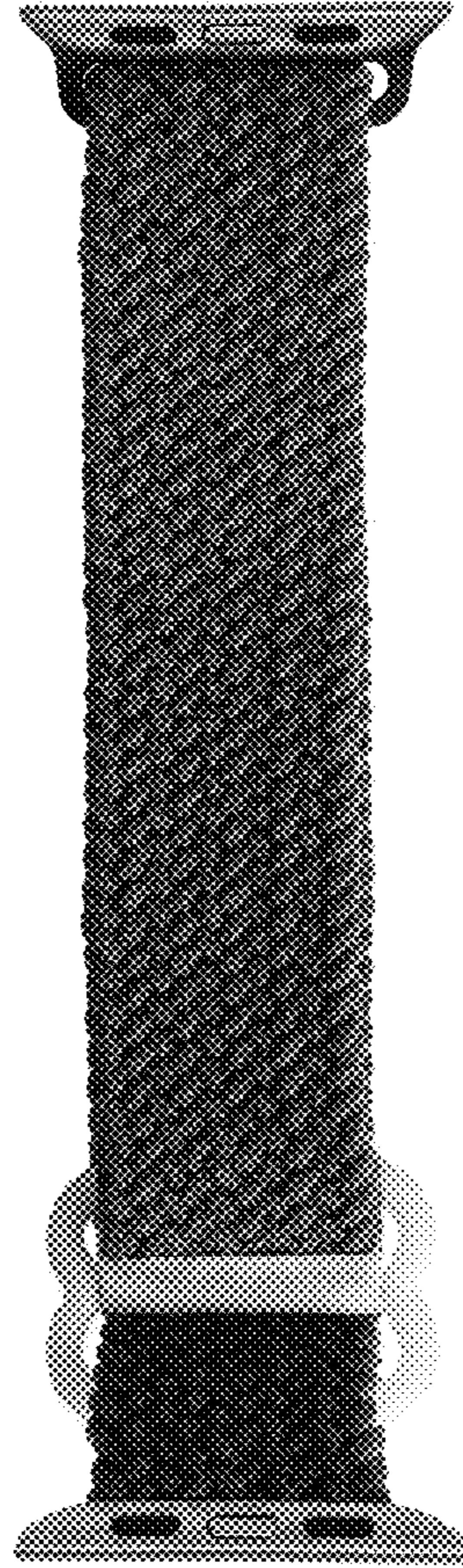
