DESCRIPTION

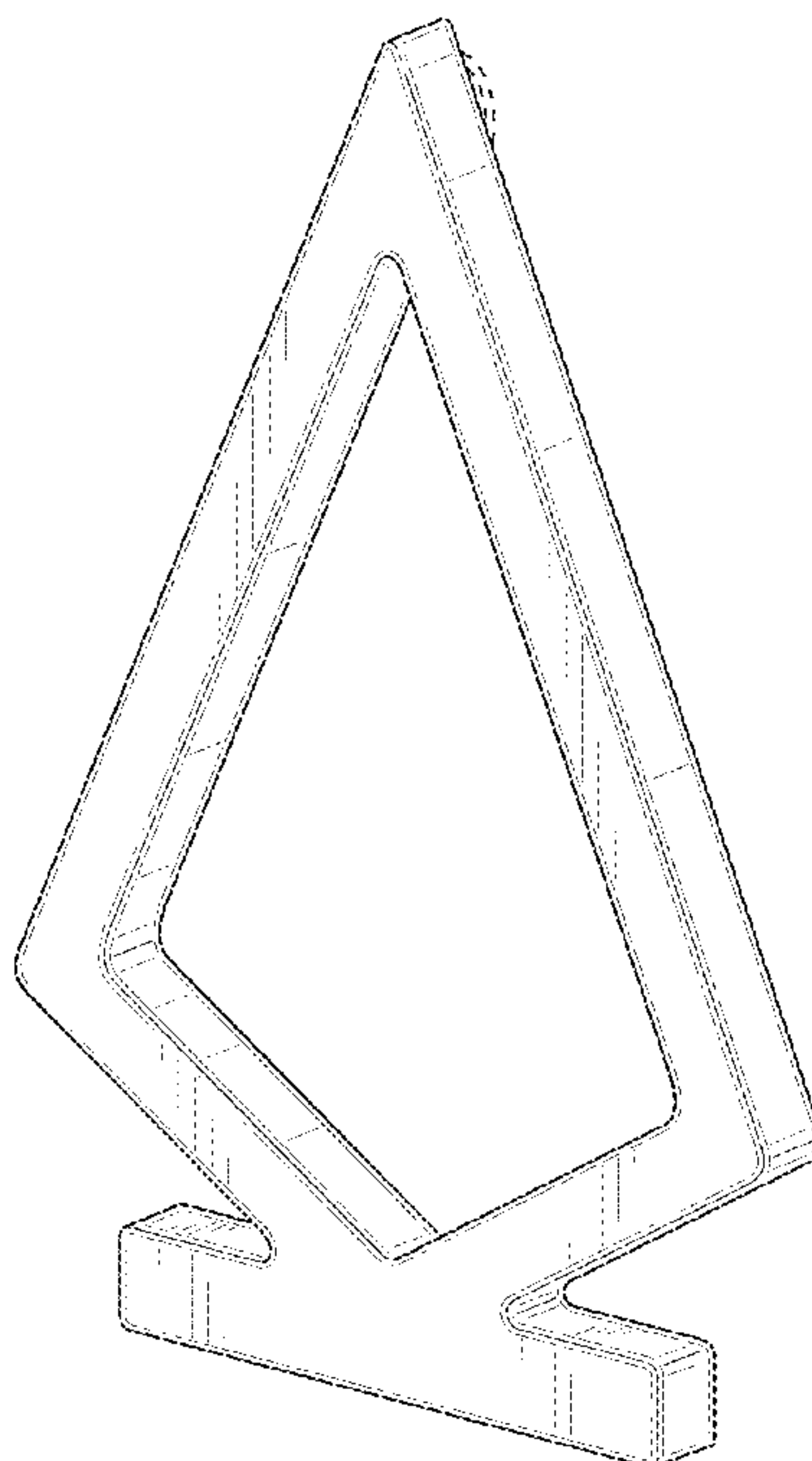
FIG. 1 is a front perspective view of an article of jewelry showing my new design;

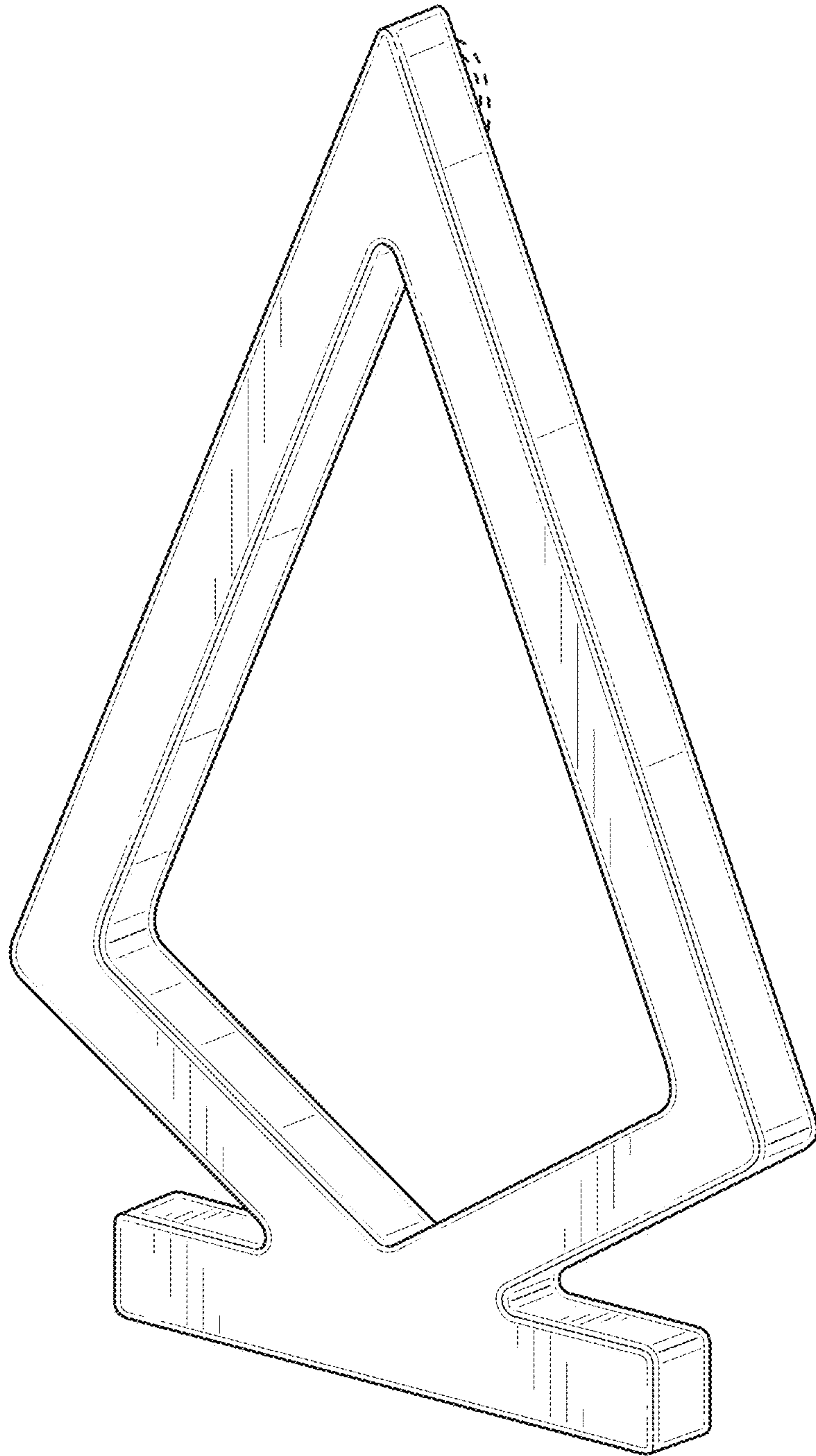

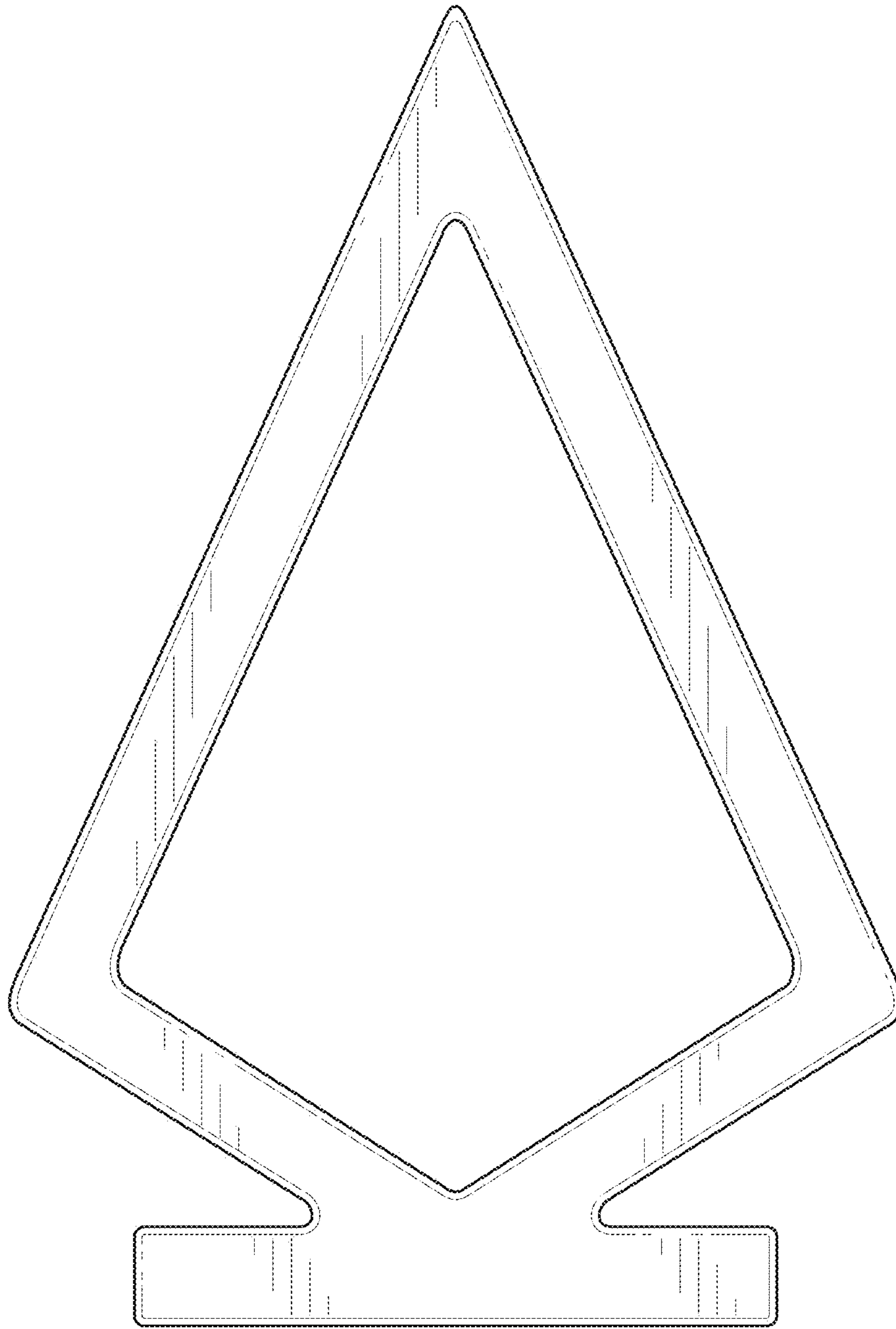

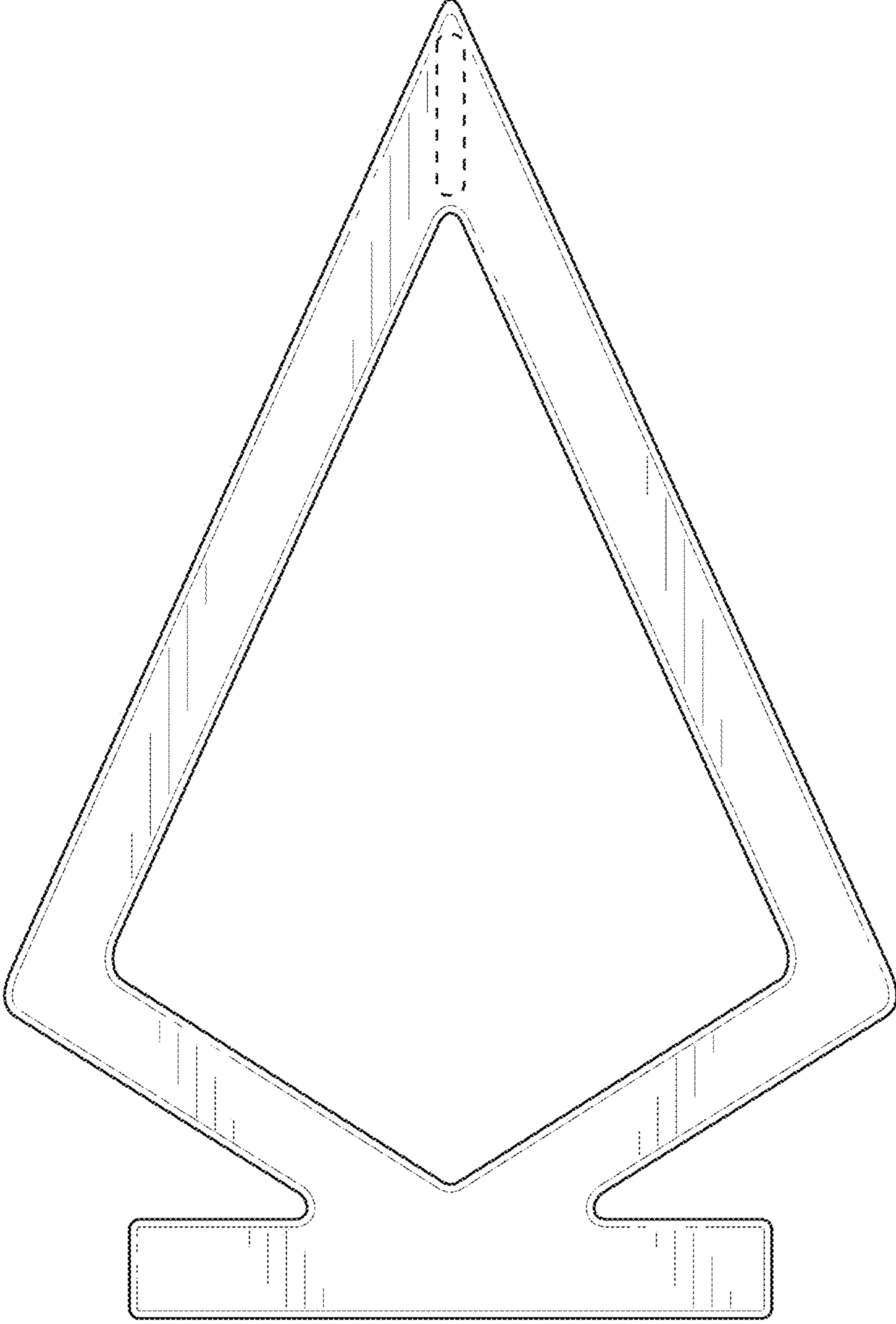

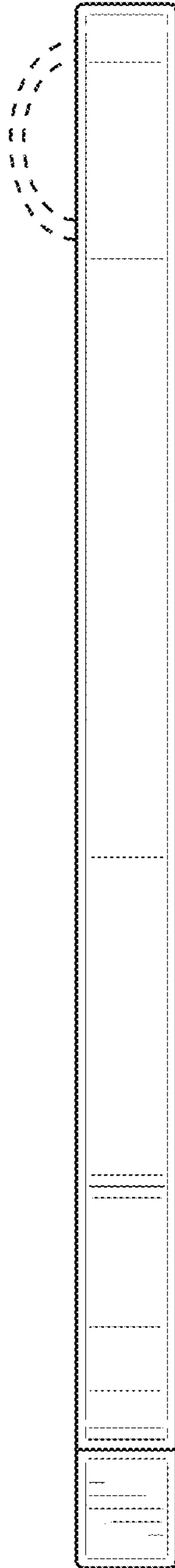

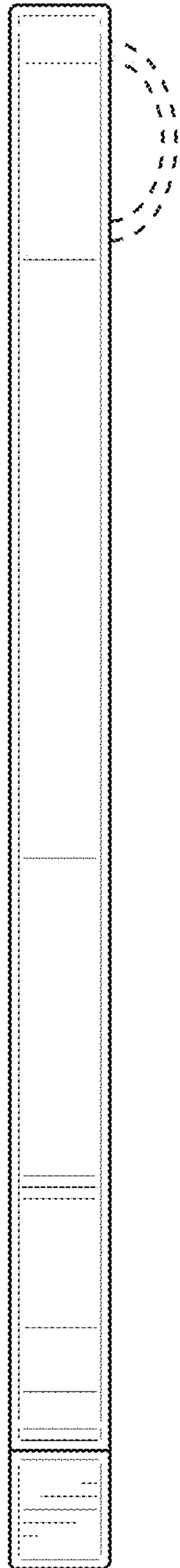

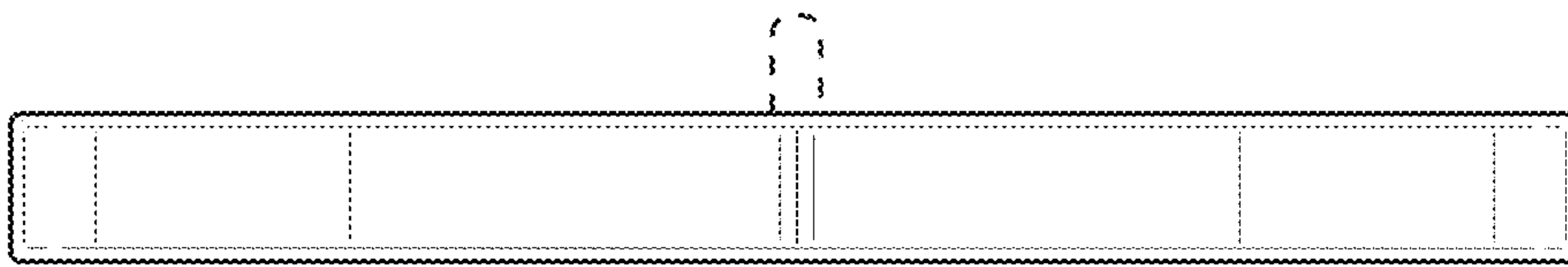
