FIG. 1 is a perspective view of a pendant, showing my new design;

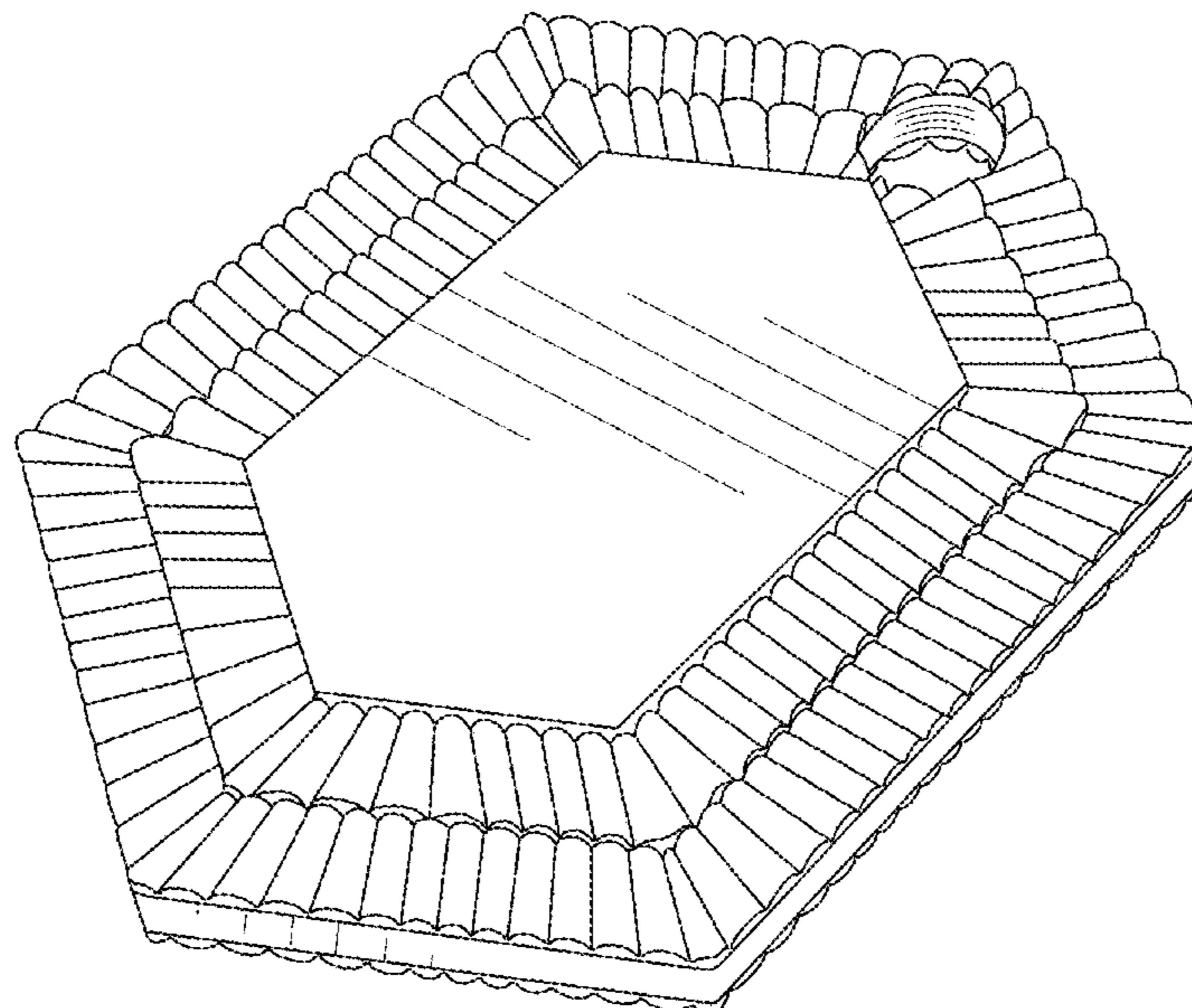
FIG. 2 is a front elevation view thereof; the rear elevation view being the same;

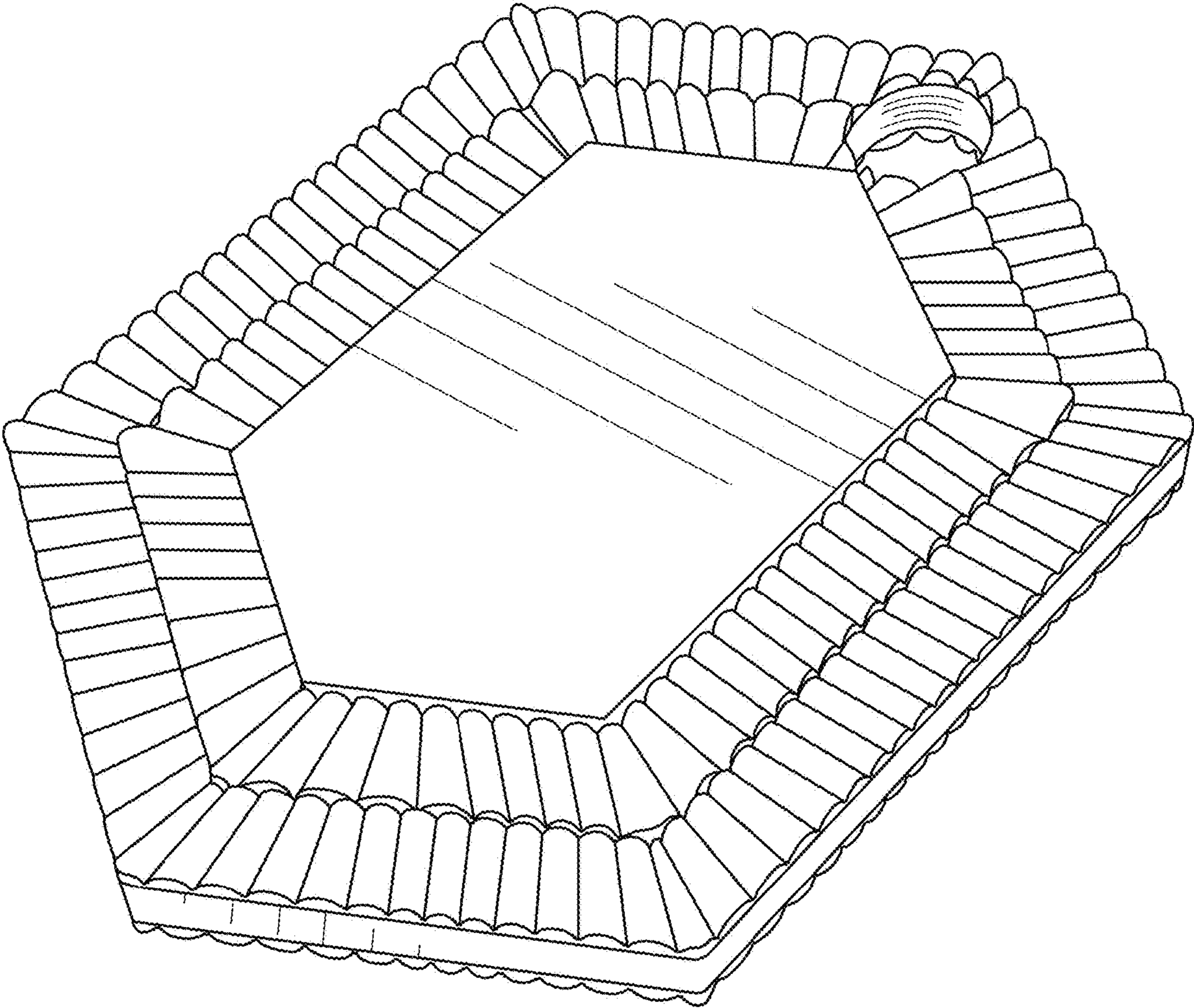

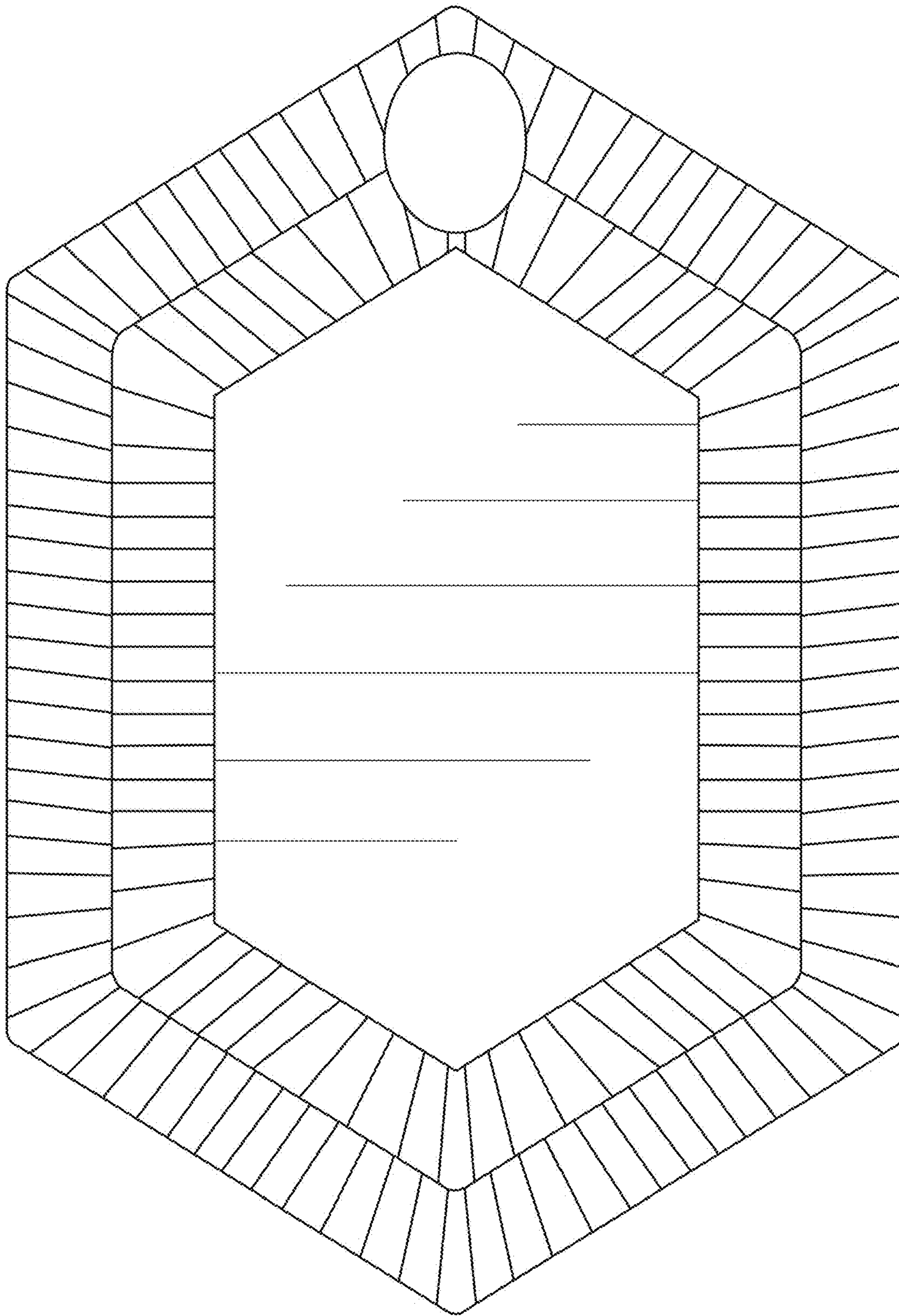

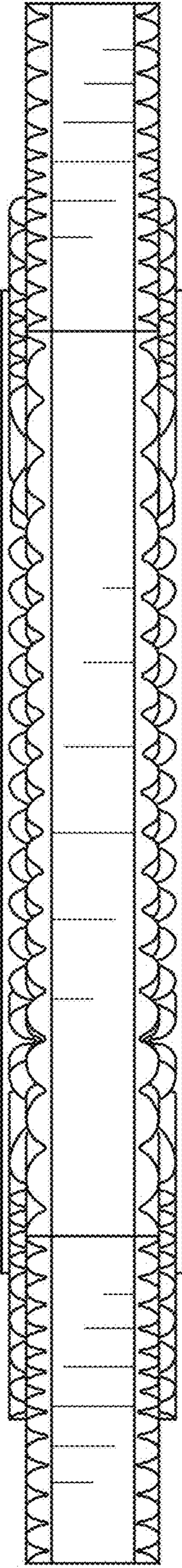

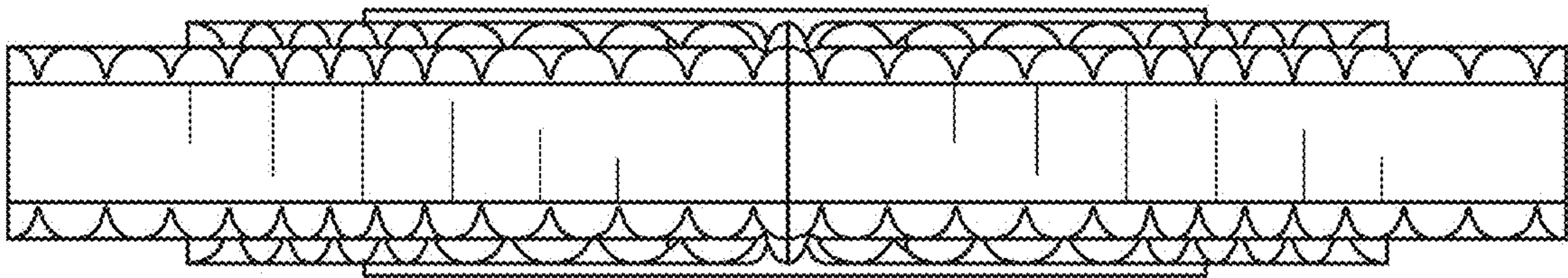

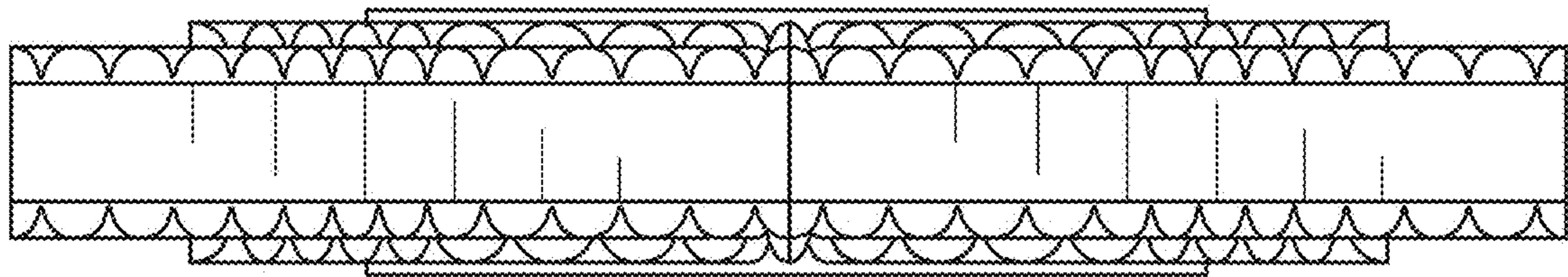
