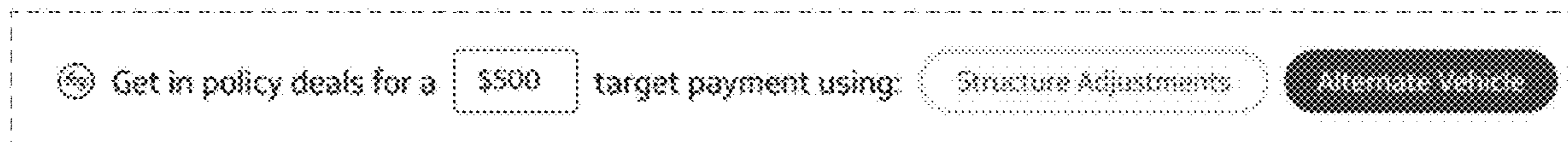
FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing the claimed design; and,

FIG. 2 is a front view of a display screen or portion thereof with graphical user interface showing the claimed design.

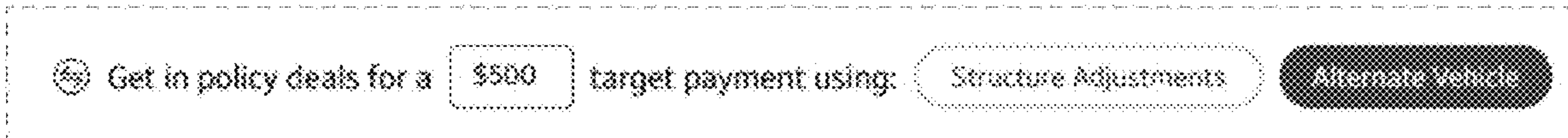
The outermost broken lines in the figures show a display screen or portion thereof, and form no part of the claimed design.
