The ornamental design of a display screen or portion thereof with animated graphical user interface, as shown and described.

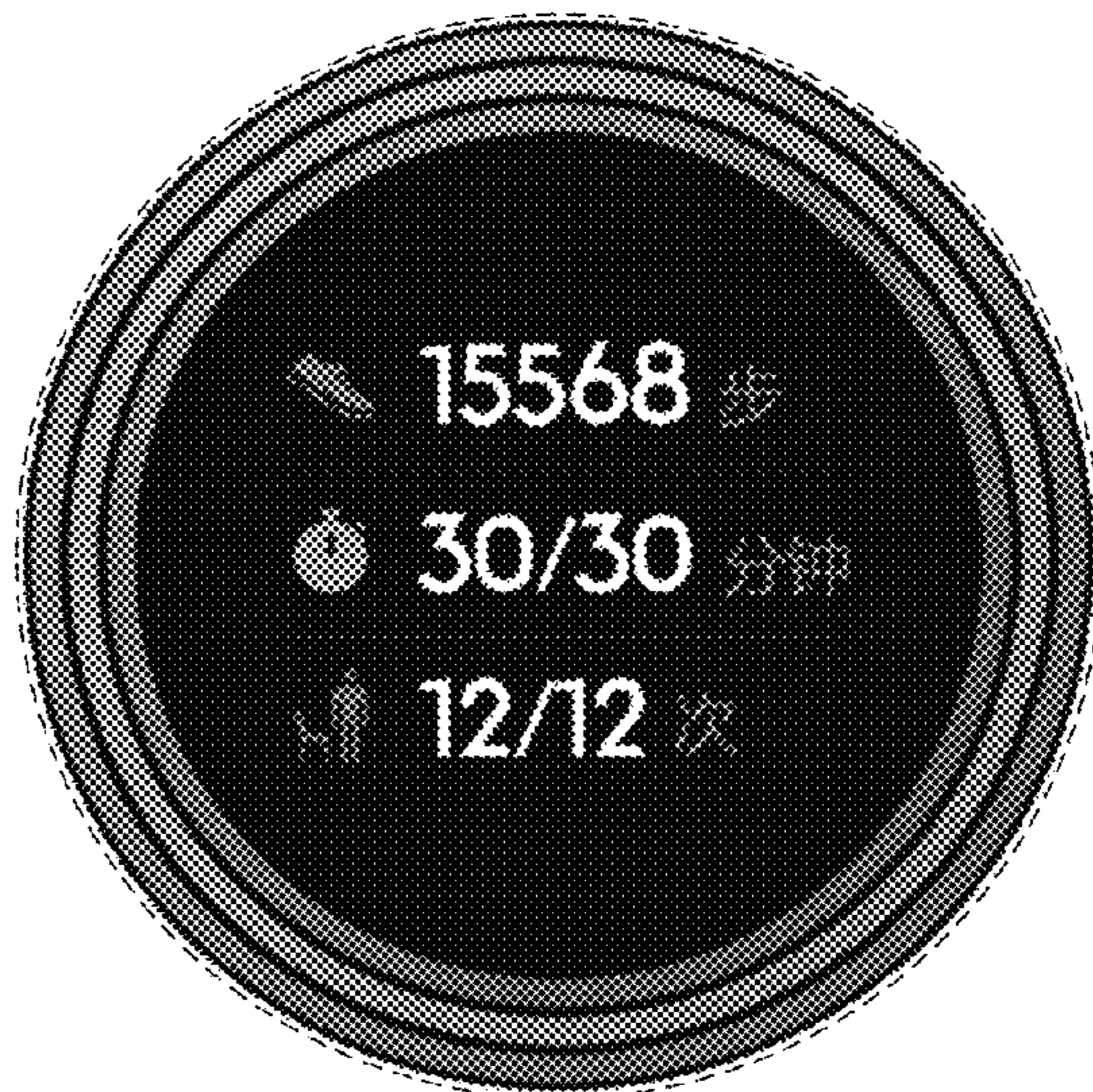
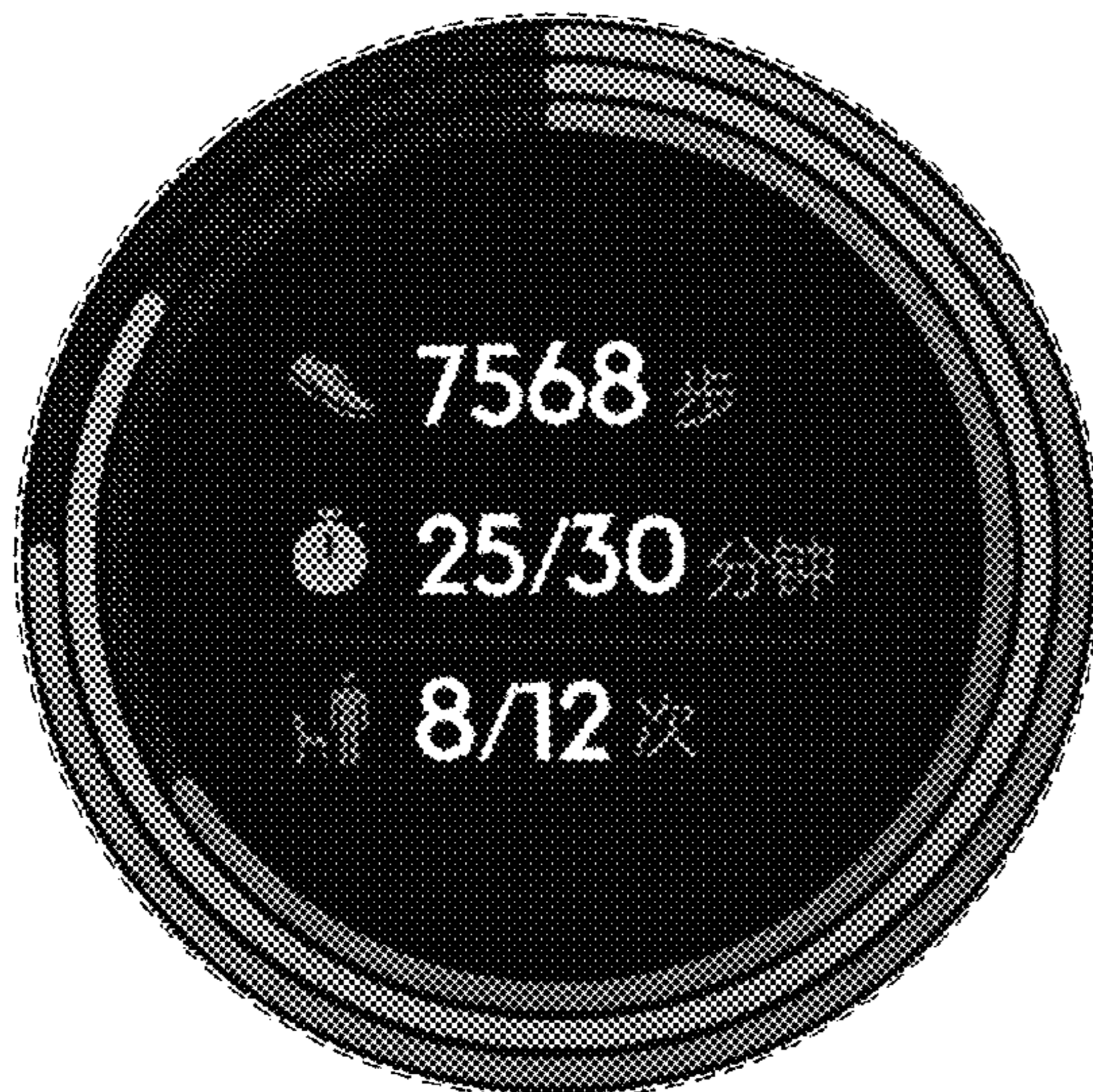
DESCRIPTION
