(57) **CLAIM**

The ornamental design for a bath toy having accessory holders, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view a bath toy having accessory holders showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a back elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan side view thereof; and,  
FIG. 8 is a bottom perspective view thereof.  
The broken lines of FIGS. 1-8 depict portions of the bath toy having accessory holders that form no part of the claimed design.

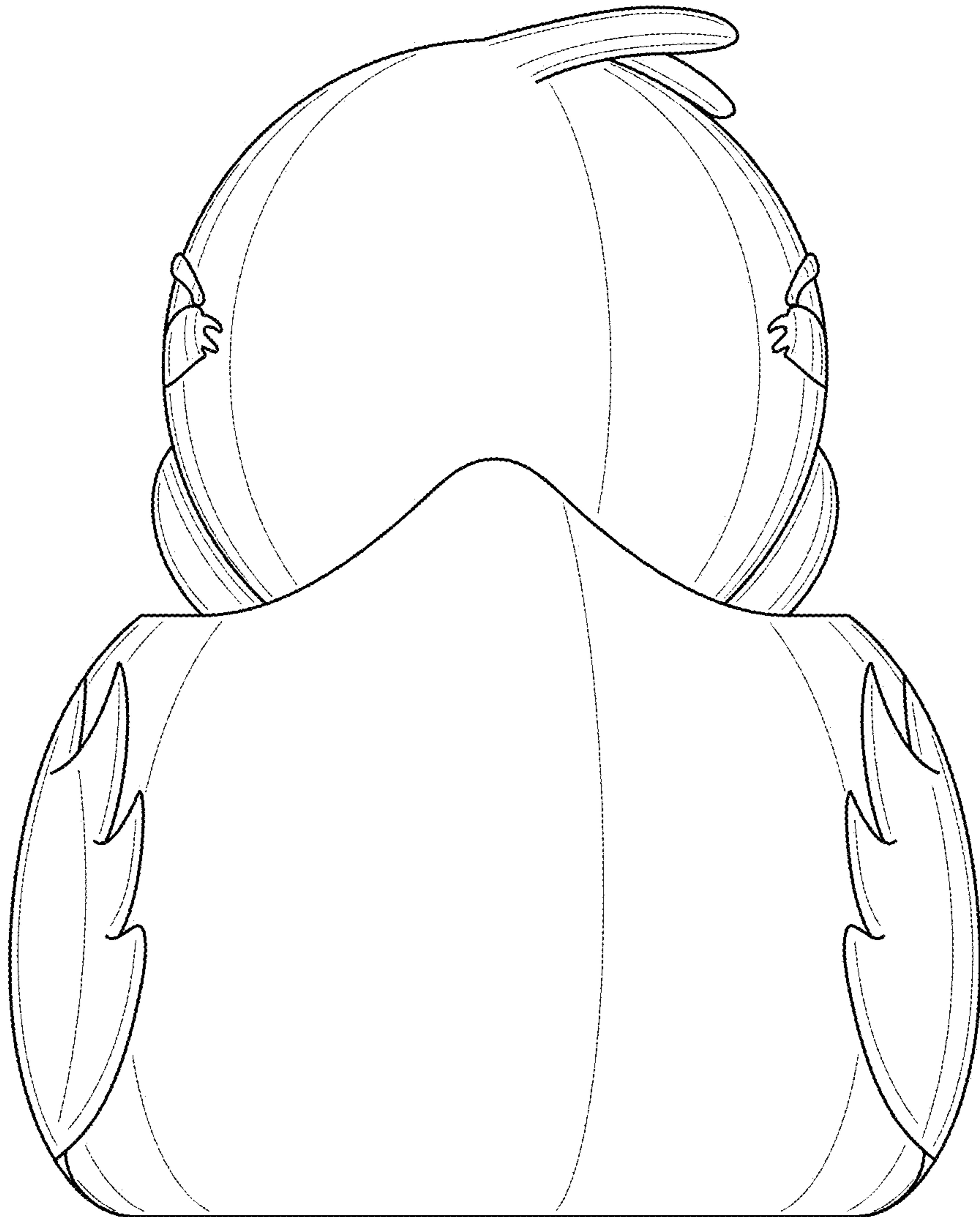

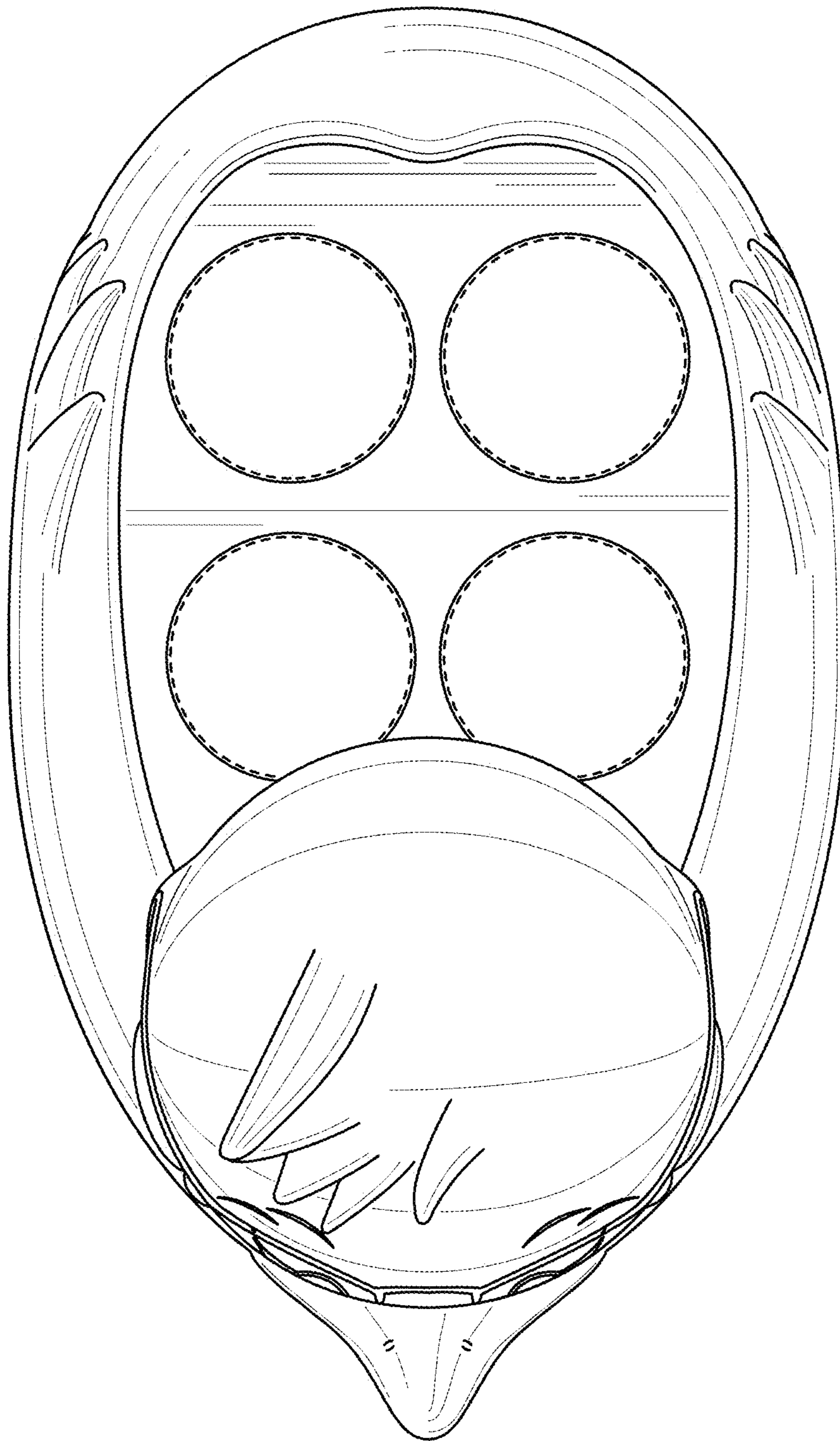

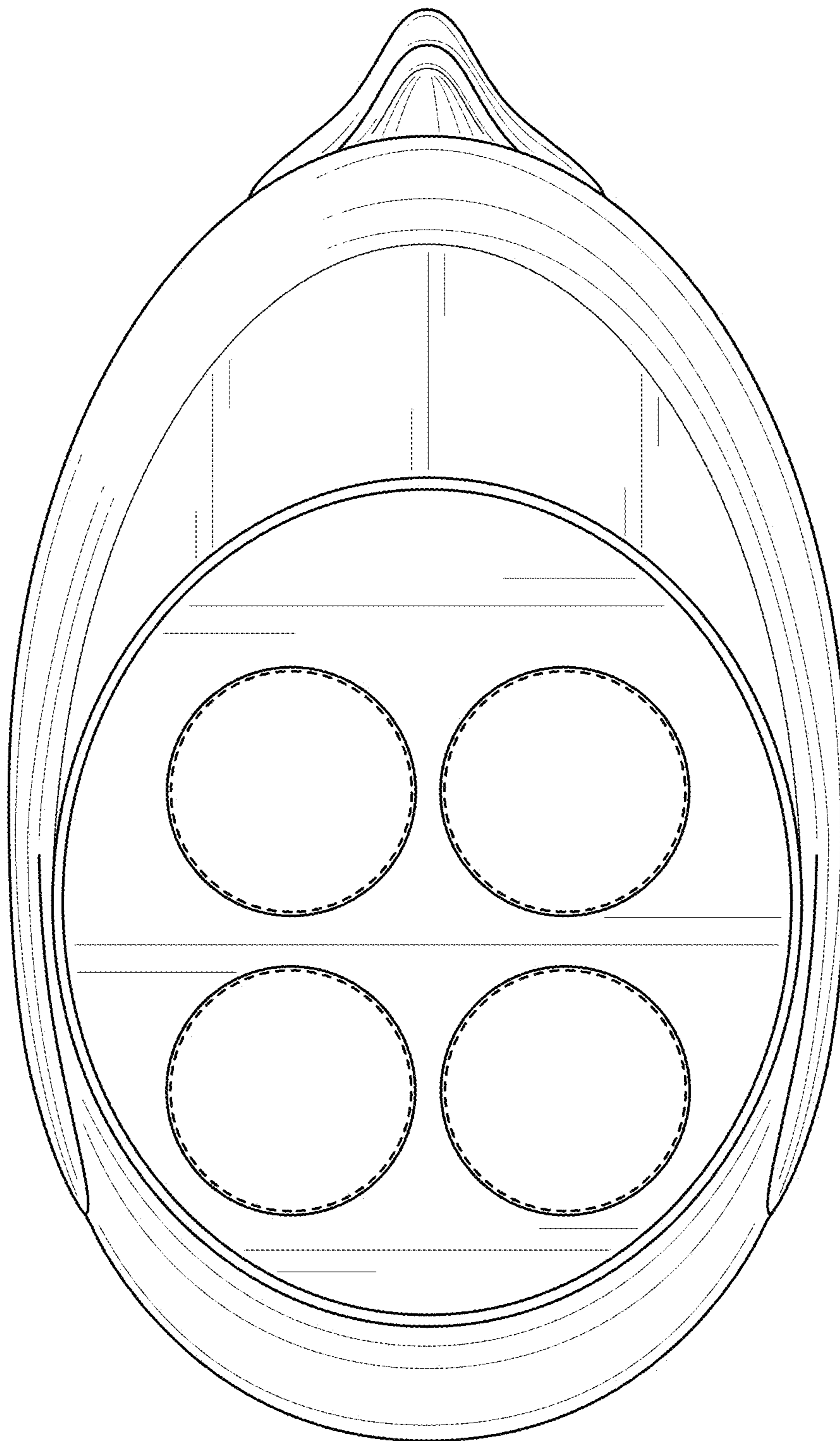

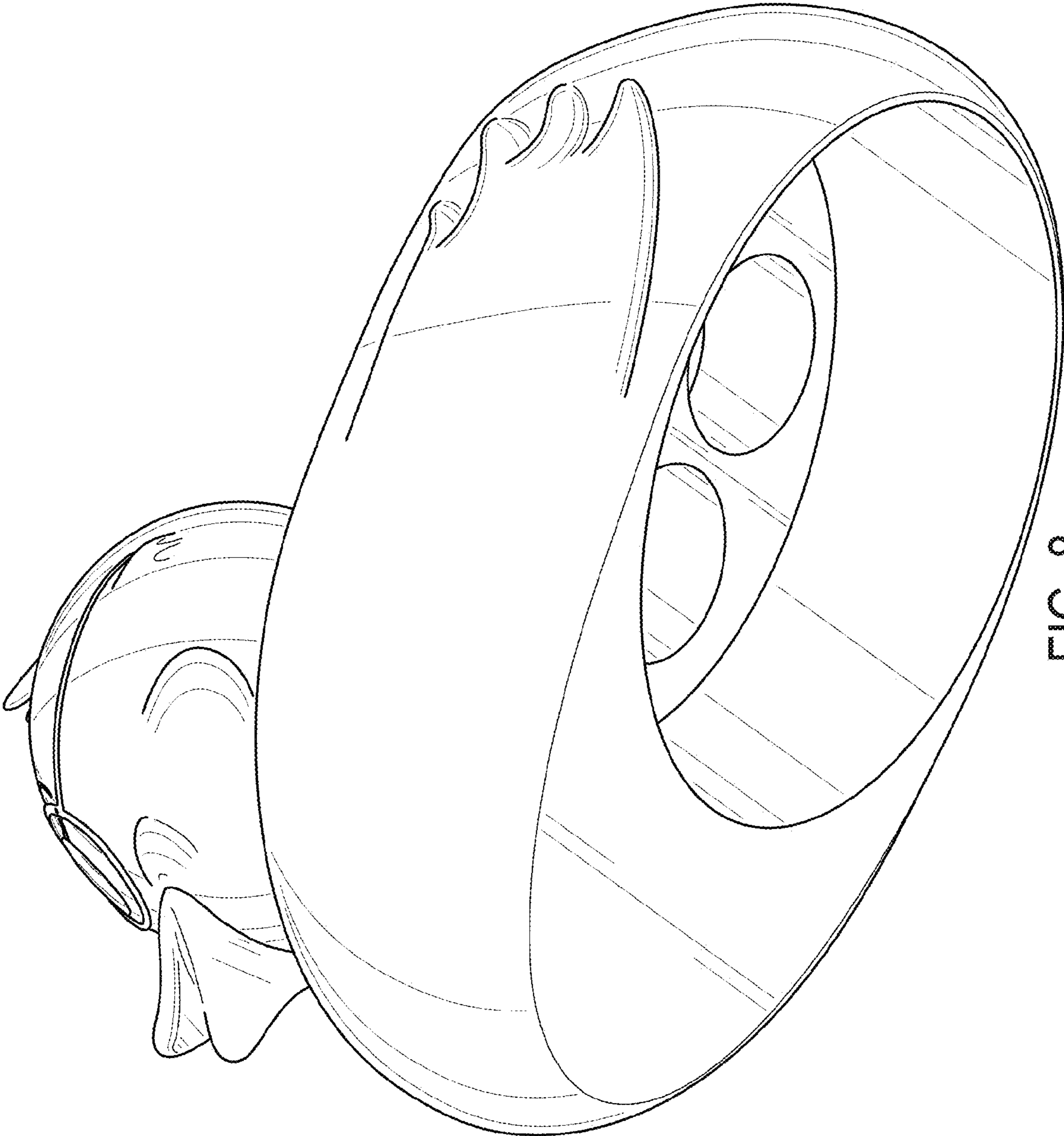
