**DESCRIPTION**

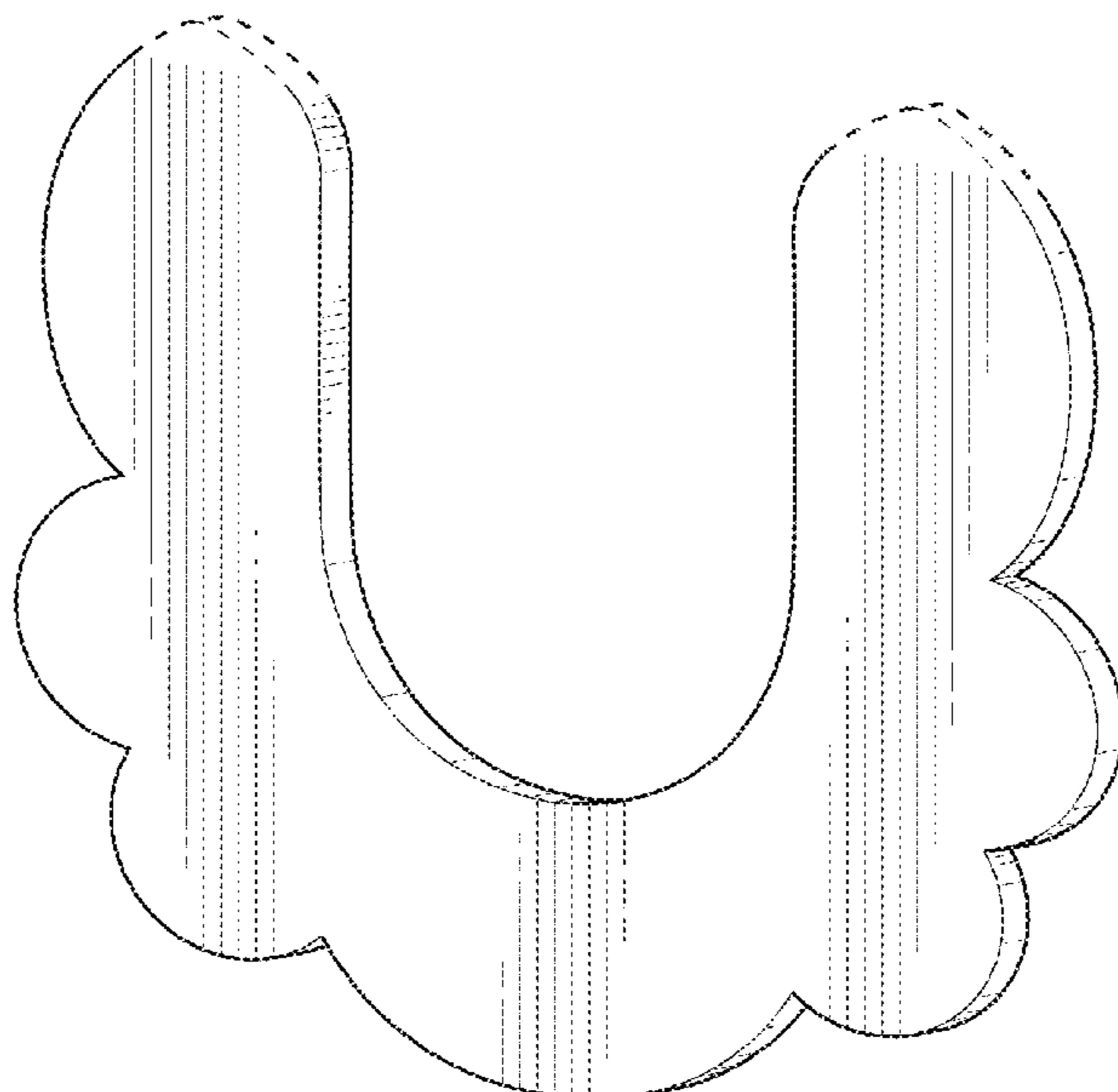
FIG. 1 shows a perspective view of a body adhesive showing my new design;

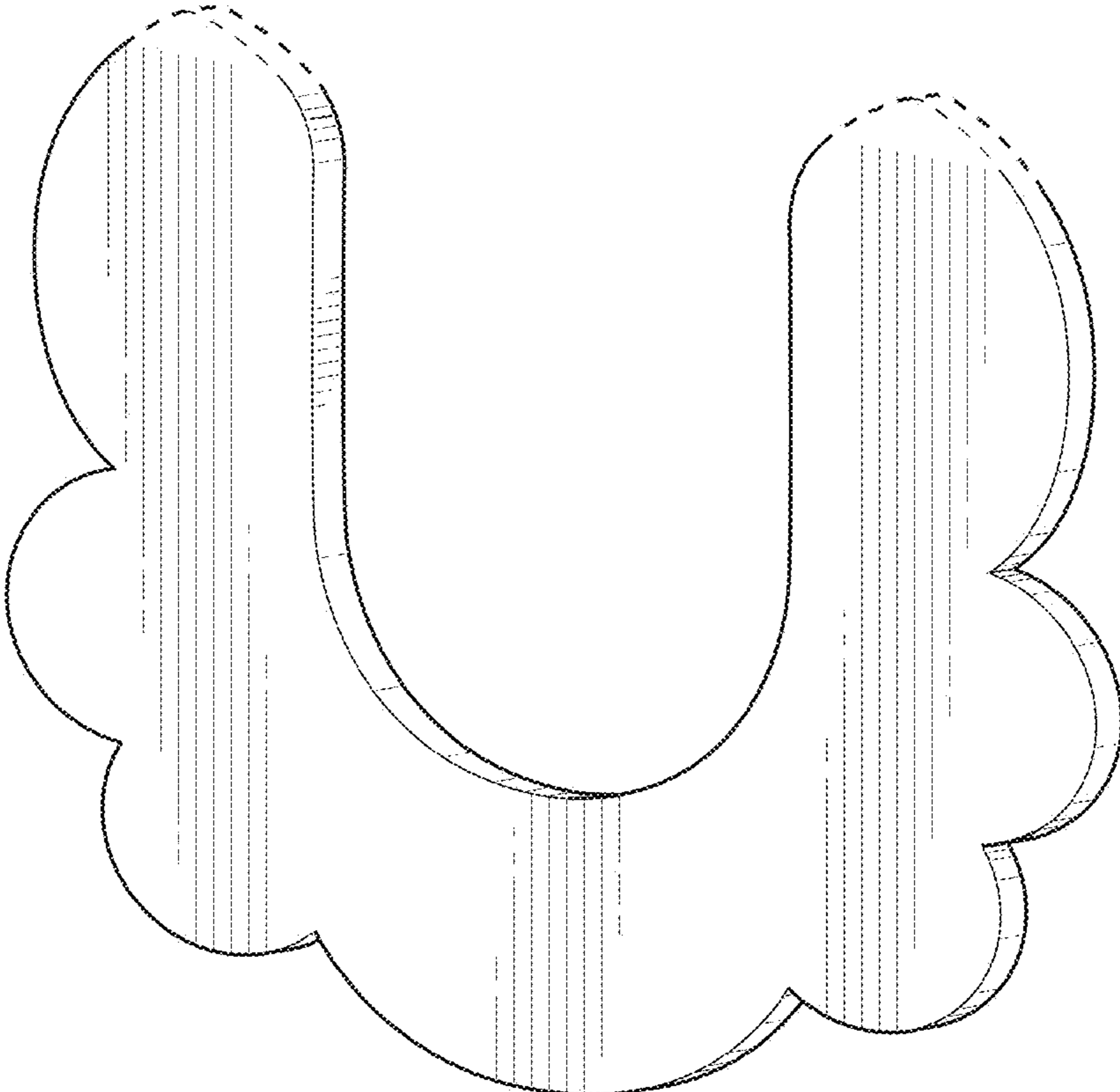

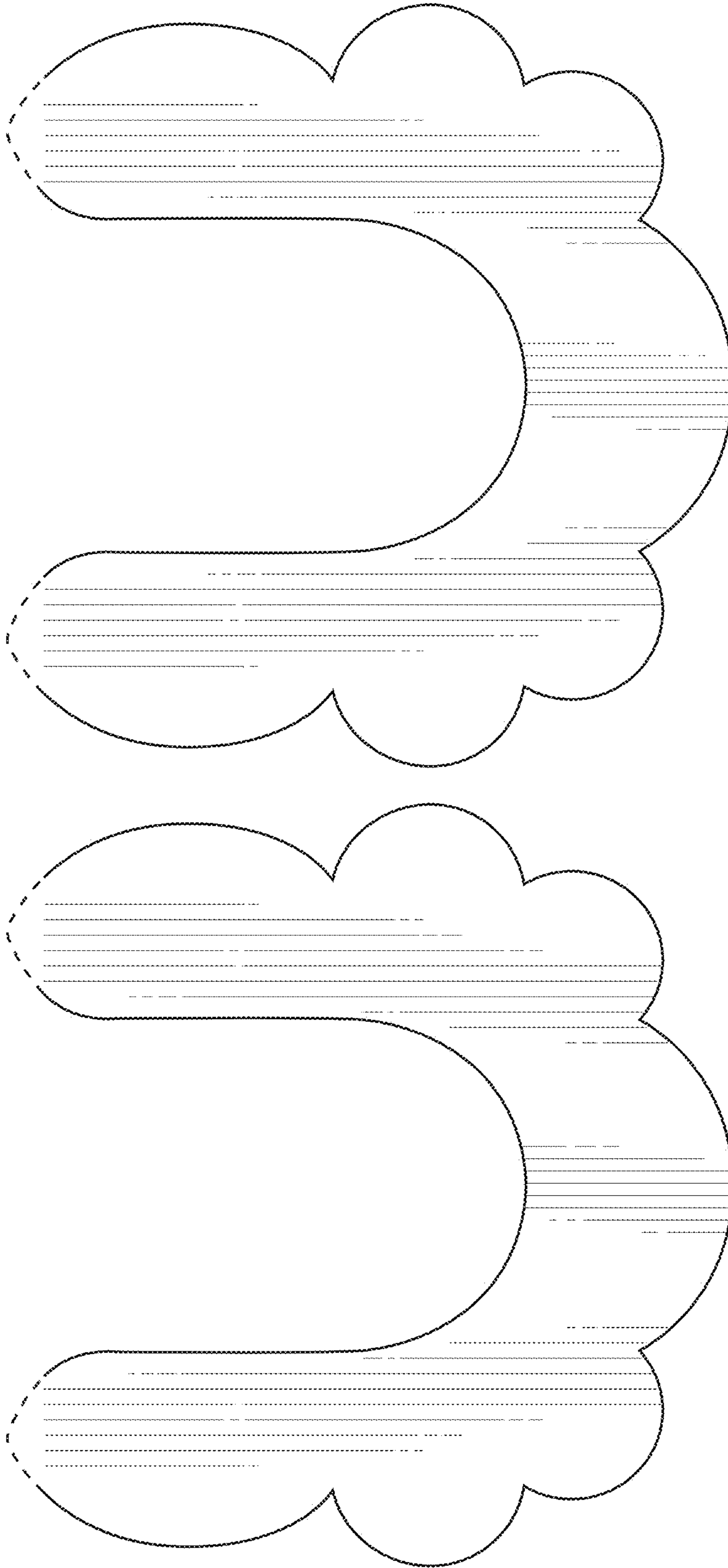

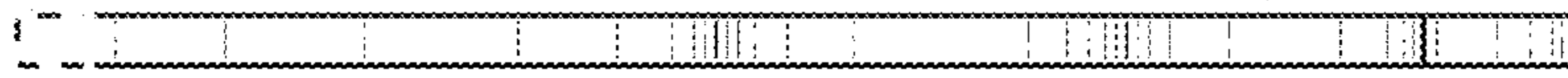

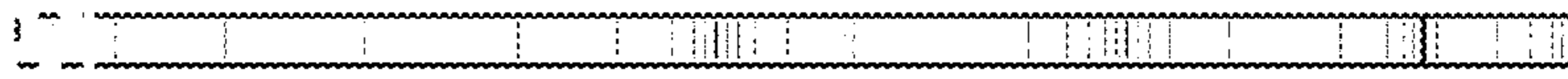
