(57) **CLAIM**

The ornamental design for a set of peel away glass covers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a set of peel away glass covers attached to a window of a door, showing my new design.

FIG. 2 is a front, perspective view of the set of peel away glass covers of FIG. 1.

FIG. 3 is an exploded, front perspective view of the set of peel away glass covers thereof.

FIG. 4 is a front elevation view of the set of peel away glass covers thereof.

FIG. 5 is an enlarged view of a pull tab of one of the set of peel away glass covers appearing in the circle portion of FIG. 4.

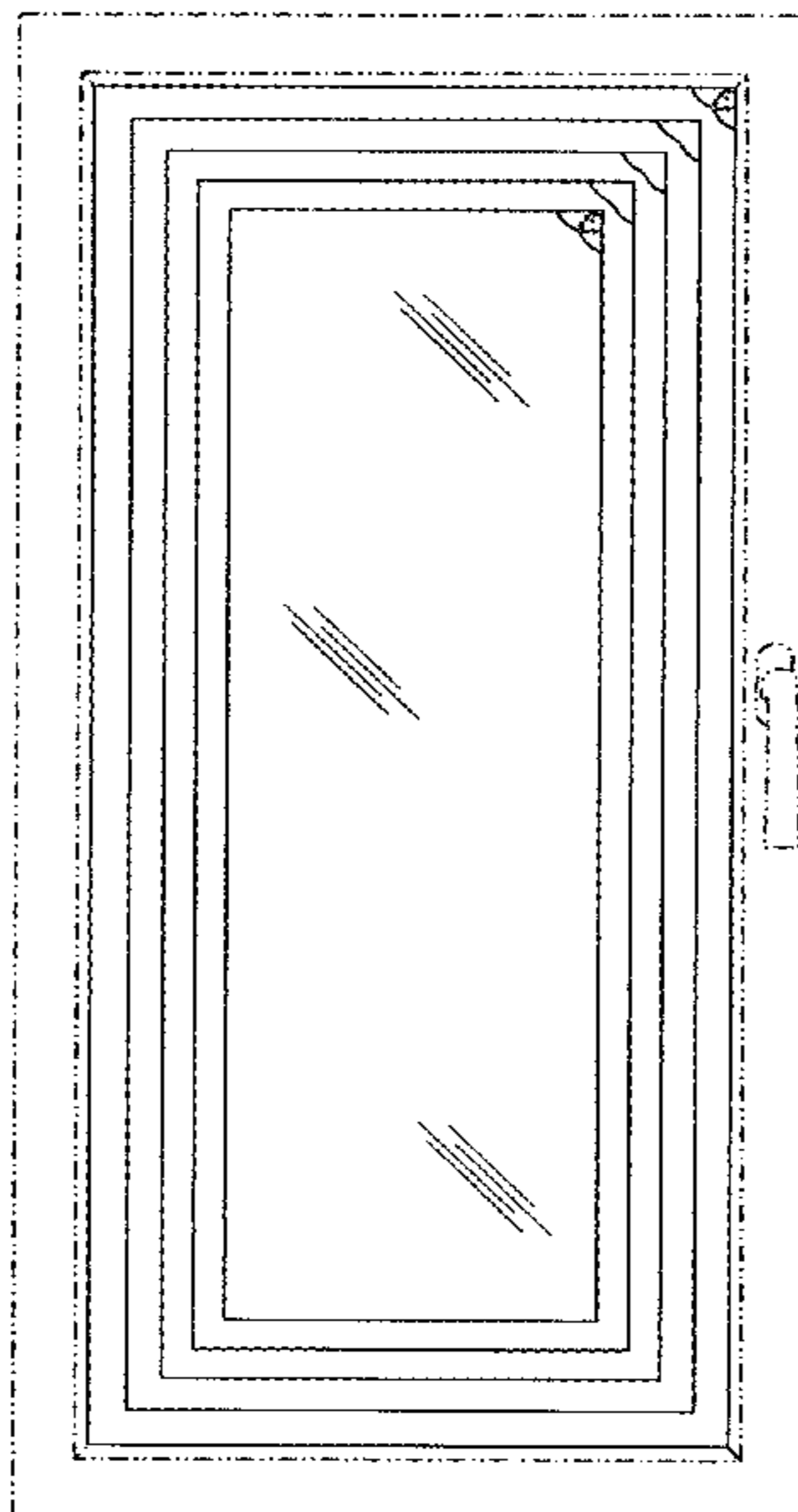
FIG. 6 is a front, perspective view of the set of peel away glass covers of FIG. 4; and,

FIG. 7 is an enlarged view of a pull tab of one of the set of peel away glass covers in the circle portion of FIG. 6, showing the pull tab being pulled away.

The broken lines showing a door in the figures illustrate environmental structure that forms no part of the claimed design.

The broken line circles in FIGS. 4-7 depict the limits of the enlarged views and form no part of the claimed design.

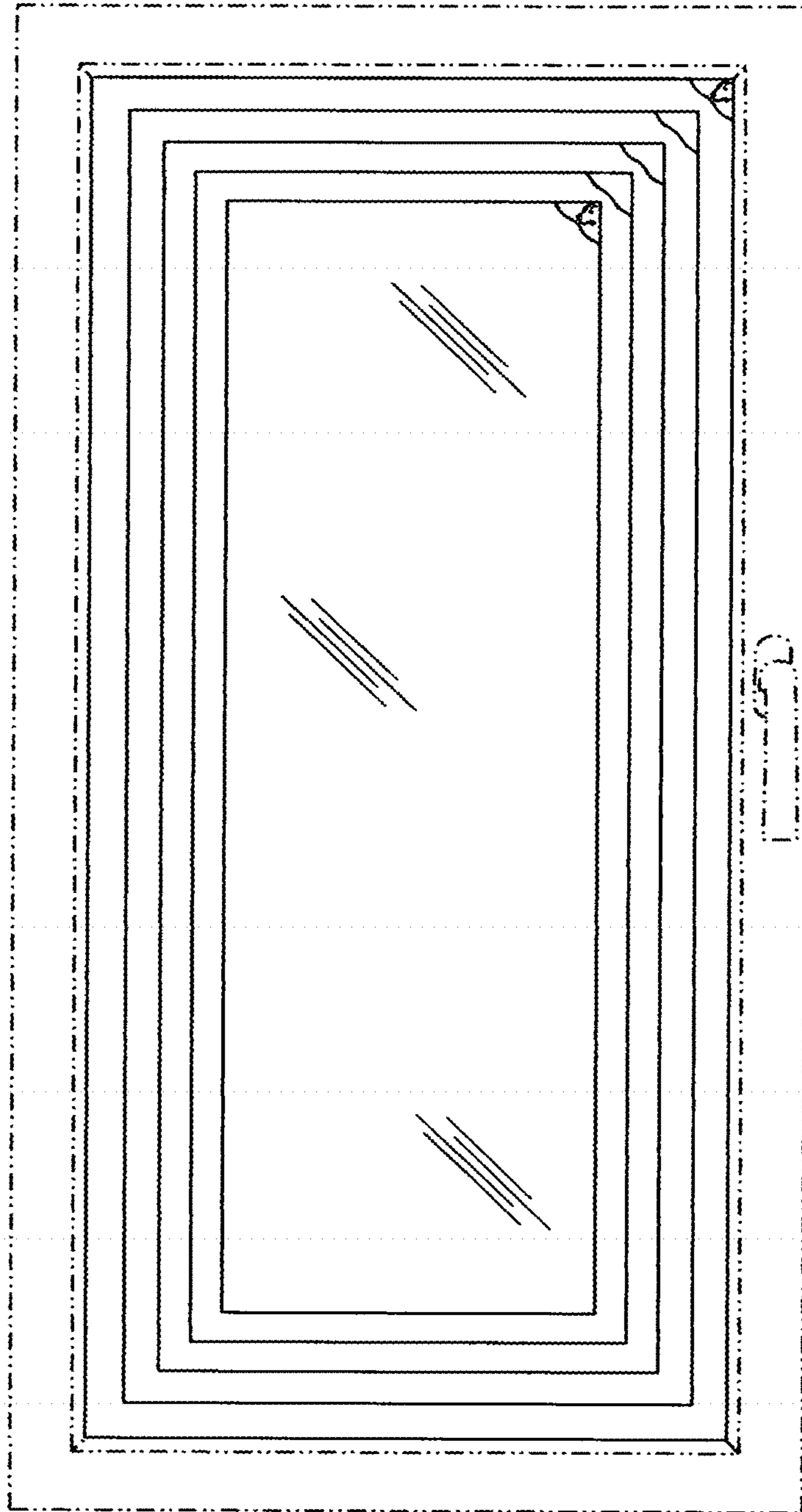

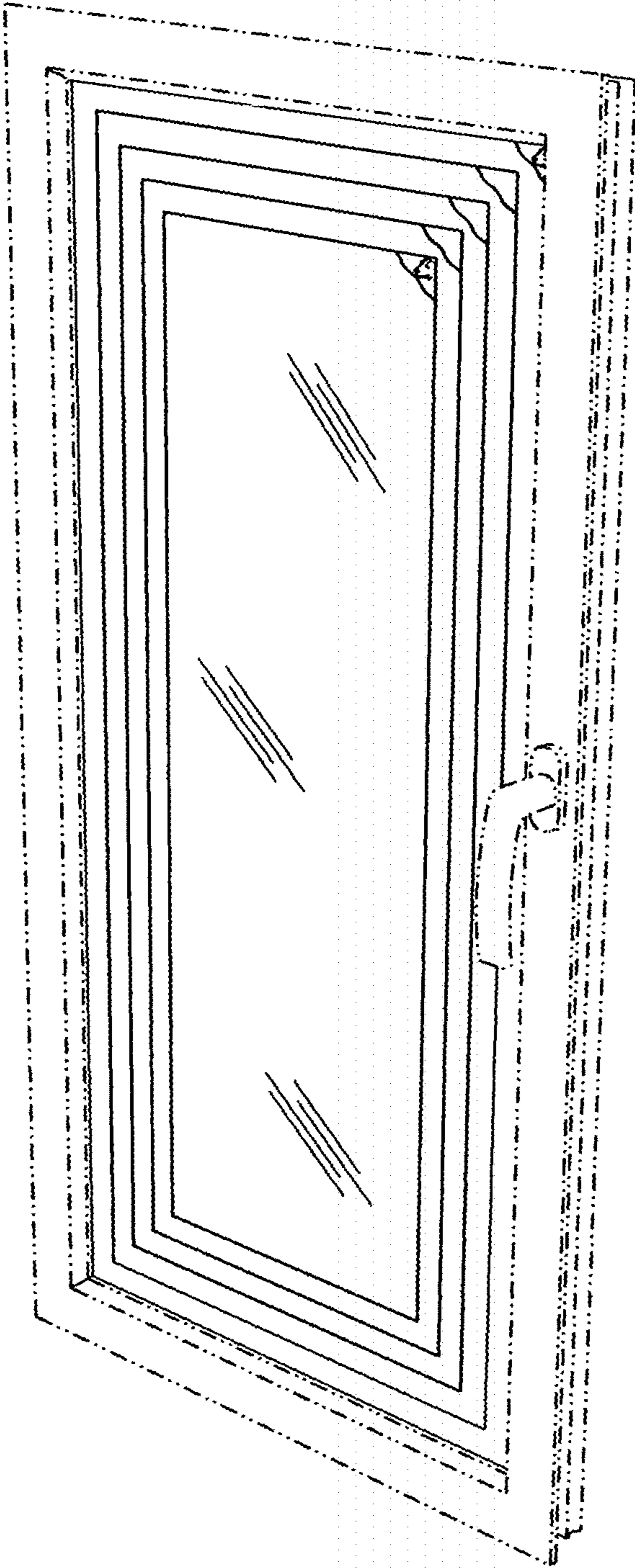

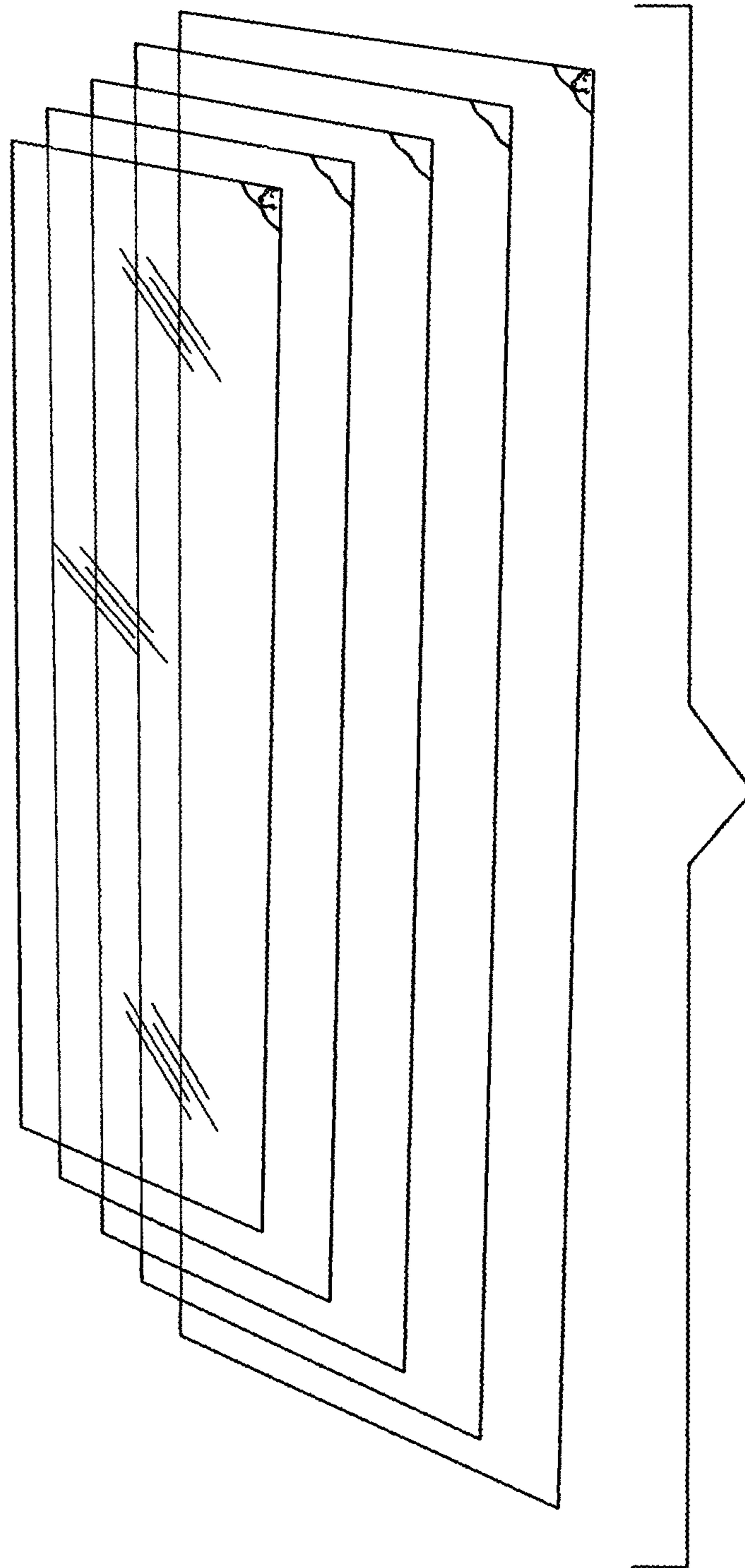
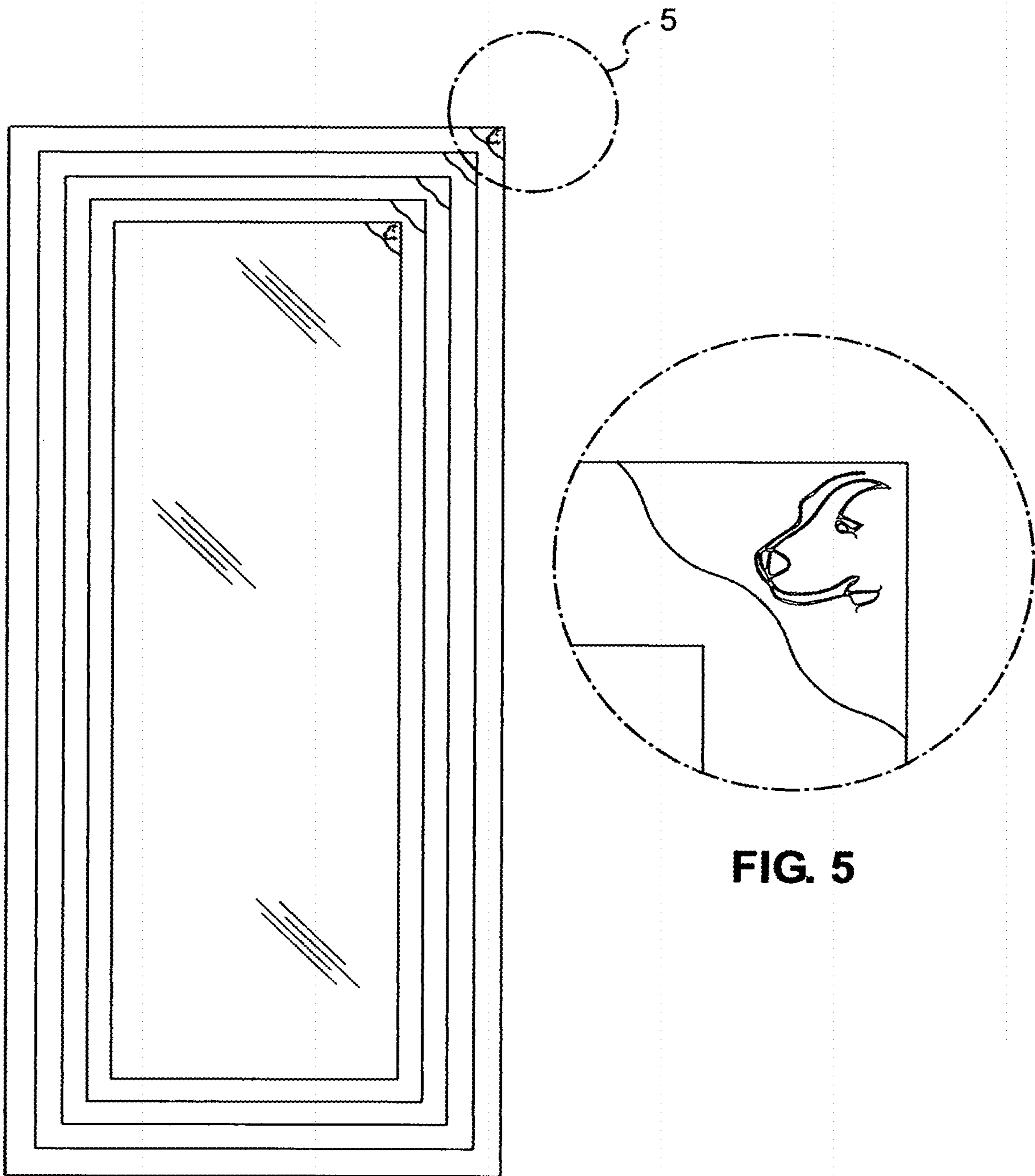
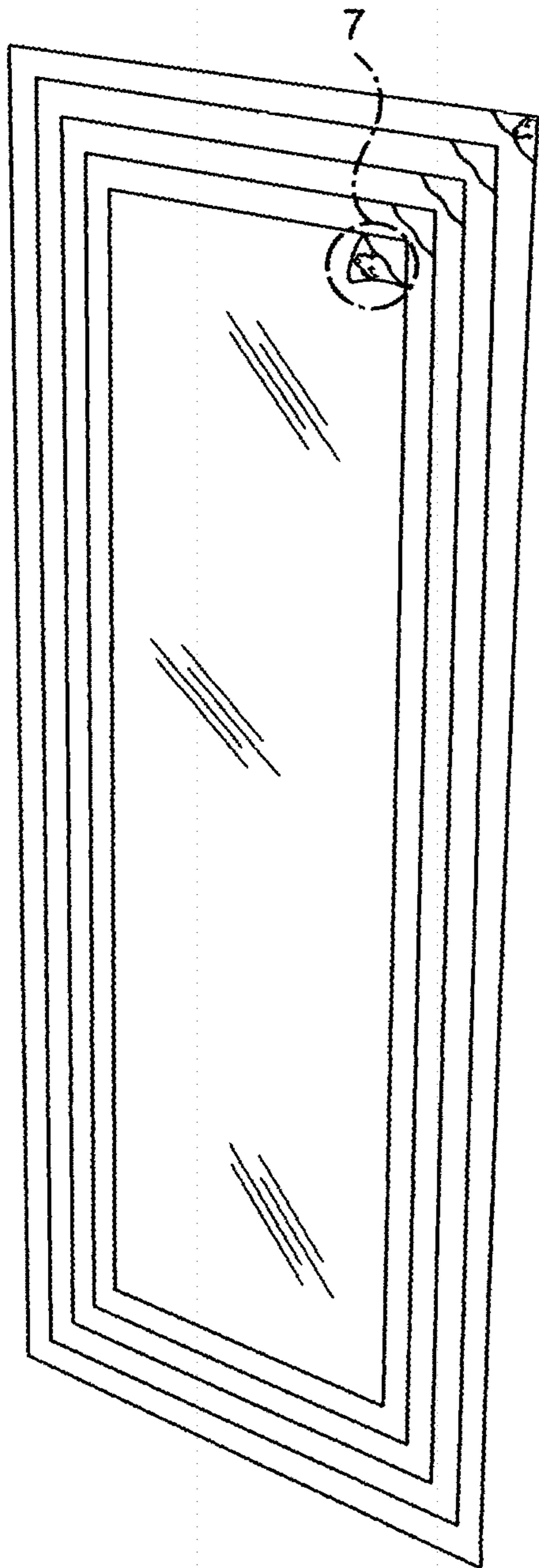

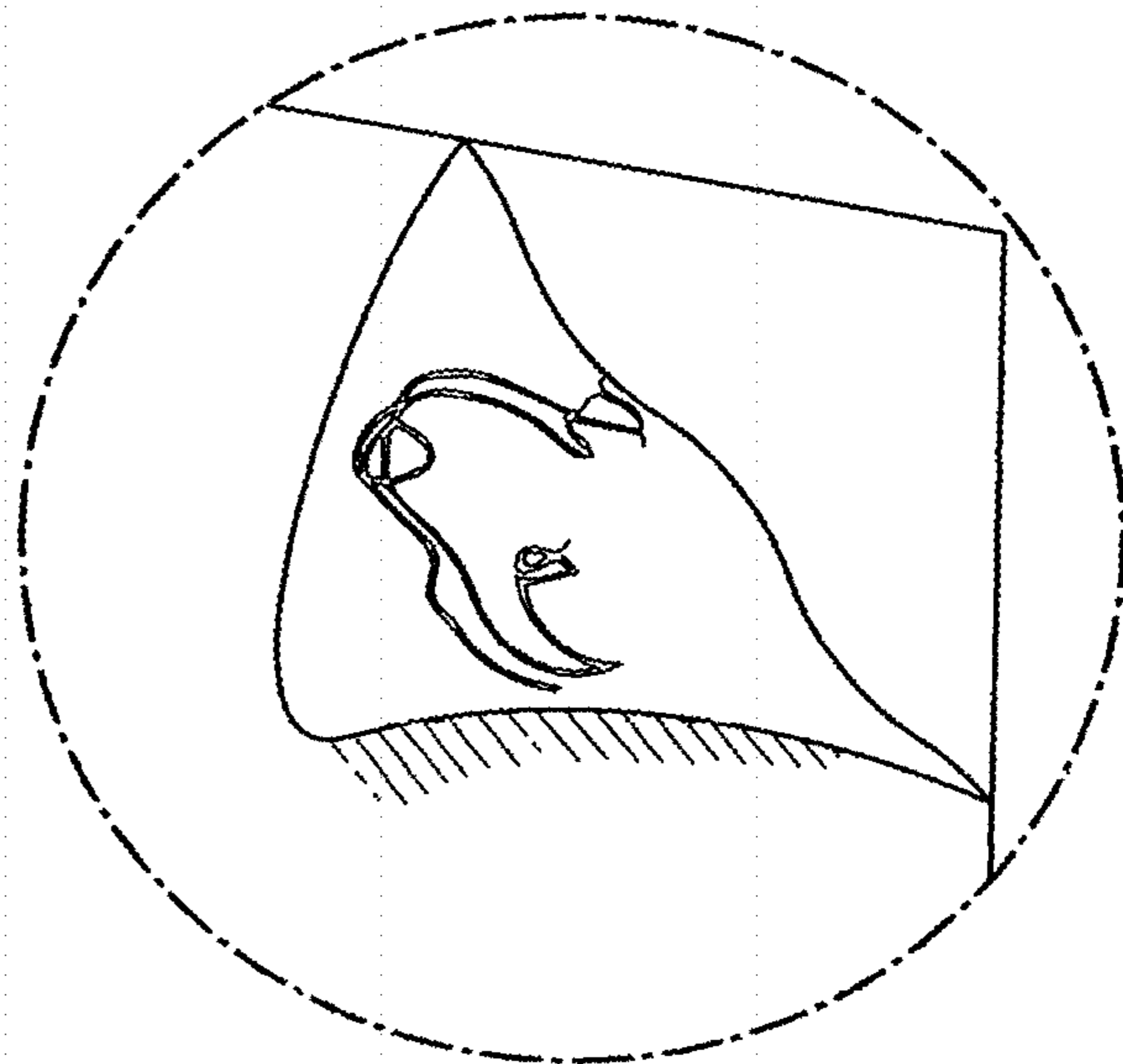
